The event was organized by Greg Kuritz, a self-described "big fan of the Carpenters to the point of almost being an obsession." Kuritz attended the 25th anniversary in 1994, which was also held in Downey.

"It was there that I met Randy Schmidt who was the organizer of the event. I had such a fantastic time, that I thought if there was going to be another similar event, I would like to help organize it," said Kuritz.

Randy, who by that time had become a friend, and asked him if he was planning to do something to celebrate the 50th. He informed me that he had so much on his plate that he would not be able to be one of the organizers, but if I was still interested in doing it, he knew two people who might want to get involved. Those two people were Robert Ingves and Peter Dawe, both of whom happened to live in Canada.

"So after thousands of emails and phone calls, our event was launched in April of 2019 in Thousand Oaks, California."

Dawe, an event planner, says he was brought on board for his "Carpenter's knowledge."

## Plan to replace church with townhomes draws skepticism

Residents are raising questions about a developer's plan to replace Lord's Grace Assembly Church with 33 townhomes.

**DOWNEY** - Residents living near a controversial townhome project expressing their frustration as

The project, located at Commemorating the 55th 7360 Foster Bridge Rd. and developed by Olson Homes, will see the demolition of the Lord's Grace Assembly Church and the construction of a new 33-unit condominium project.

Each home will range from 1,188 to 1,792 square feet, located within four separate Headquartered from the buildings. It includes three

> Residents living on The Island neighborhood where the project is located and in the surrounding neighborhoods have expressed concerns with the project, fearing the area will be too densely populated and cause increased traffic to have enough space for cars congestion.

Brian Chambers lives on the west side of Horley Avenue. He explained that the area already suffers from traffic struggles.

"My main concern is the increase in traffic, of course," said Chambers. "The traffic on Suva, especially in the hightraffic times, they're just really bad. I think the main part is in my proximity to the stop sign on Horley - and maybe the lack of traffic on Horley - that the line of cars that roll through the stop sign leaves exactly the perfect little gap that prevents me from getting out of my

The Planning Commission scheduled to review the project at its meeting Wednesday but it continued to a future date, potentially as early as March 6. The item had previously been slated for discussion and potential approval on Feb. 7.

Adrienne Osezuera, resident of The Island who has attended previous Planning Commission meetings speak out against the project, described the delays as "very frustrating."

"It's frustrating very "There's literally 20, 30 cars because we want answers; we want to be updated with the plan with the city," Osezuera. We're frustrated. A lot of the neighbors are frustrated."

> Chambers believes the meeting delays are intentional.

"I personally feel that they're changing it and rescheduling it and rescheduling it to confuse when the meeting is actually going to be so not a lot of people show up to protest it," said Chambers.

Anderson said that she feels Planning Commission playing around with homeowners.'

"They want to push it back and frustrate us to the point that we don't show up, and then they just push through what they want to do," said Anderson.

She also believes the project will be approved regardless of residents' concerns.

## Downey man accused in string of massage parlor robberies

DOWNEY - Two Los Angeles County men were charged Wednesday in a federal criminal complaint alleging they committed more than a dozen armed robberies of massage parlors in Los Angeles and Orange counties.

Andy Cuellar, 28, of Hawthorne, and Arturo Morales, 27, of Downey, were arrested last Friday and were scheduled to make their initial Thursday appearances

We had over 650 5th grade students enjoy Science Camp again this year. What an experience! Thanks to the parents and Downey Unified staff who helped make this another successful year.





## Regulators find Los Padrinos unsuitable to house youth

■ L.A. County was given who have 60 days to remedy issues at the Downey facility or Los Padrinos could be closed again.

DOWNEY - A state regulatory board Thursday deemed two Los Angeles County juvenile detention centers "unsuitable" to house youth detainees, beginning a 60-day clock for the county to rectify issues of noncompliance, after which the board could order the facilities to close.

The California Board of State and Community meeting Corrections, unanimously Sacramento, approve "unsuitable" designation for the recently opened Los Padrinos Juvenile Hall in Downey and the Barry I. Nidorf Secure Youth Treatment Facility in Sylmar.

Los Padrinos houses predisposition youth detainees awaiting resolution of their court cases, while the Nidorf SYTF facility holds postdisposition youth offenders



already convicted.

hastily The county reopened Los Padrinos Juvenile Hall last year and transferred all pre-disposition youth to the facility, moving them away from Nidorf Hall in Sylmar and Central Juvenile Hall in Lincoln Heights, which were both declared unsuitable and ordered to close by the BSCC.

Thursday's decision by the BSCC leaves the future of youth detention in the county in question, although county Probation Department officials tried to convince the board that it is already in substantial compliance with state regulations, despite have significantly more issues, the findings of recent board

The Probation Department has been under fire for years over the operation of juvenile detention facilities. County Supervisor Janice Hahn issued a statement following Thursday's board meeting questioning whether agency can be trusted to make last year, Los Padrinos was needed changes.

"It is unfortunate that the Probation Department made excuses at today's BSCC meeting instead of owning up to the unacceptable conditions at two of our probation

BSCC wants to see real change The Los Angeles Times and I expect the same. Multiple reported that the officers stood probation chiefs have been idly by while a teen detainee unable to fix the problems facing the department. I am concerned about the future of the Probation Department and whether they are capable of the reform that we all know needs to happen."

The BSCC's decision found the Nidorf SYTF out of compliance with state regulations pertaining staffing levels, training, use of force training, disciplinary procedures and youth access to programs and recreation.

Los Padrinos was found to with noncompliance found in staffing levels, fire safety plans, safety checks, room confinement procedures, use of force training, searches, education programs, youth access to programs and recreation and disciplinary

Not long after it opened quickly plagued with problems. The facility experienced a pair of escapes, although both detainees were quickly reapprehended. In January, eight probation officers were placed on leave for a "significant

been facilities," Hahn said. "The incident" involving detainees. was beaten by a group of other youths.

Several community members who spoke at Thursday's BSCC meetings alleged that probation officers would stage "gladiator fights" among youth detainees.

"Every day a young person is in the facility, they are in danger," one speaker told the board.

Another speaker representing the Youth Justice Coalition added, "It is upon you all to find these facilities unsuitable for youth. If this was your children in there, you would find it unsuitable."

One probation officer, however, decried suggestions that the staff is responsible for issues at the facilities, nothing that some of the youth "are in there for some heinous crimes," including murder. She said probation officers in the facilities are the ones "being spit on and getting feces thrown at us."

"I'm sick and tired of everyone coming after us when it's our management that's the problem," she said.

I feel privileged to work in health care, and one reason is because I find the human body endlessly complex and fascinating. Here are some surprising facts that I'll bet you didn't know:



number of bones in our body drops from about 300 bones at birth to 206. and about half of those

bones are in the hands and

Astronauts can be up to two inches taller in space. Just think about what gravity does to us! In fact, we are taller when we wake up in the morning than we are at night, because when we stand, our spine compresses.

The only part of our body with no blood supply is the cornea. Our corneas get oxygen directly from the air.

More germs are transferred through a handshake than through a kiss. Think about that!





## What to make of Alabama's embryo ruling

A court ruling declaring embryos to be children has far-reaching implications.

The Alabama Supreme Court's ruling on Friday will transform infertility care across the state, potentially setting the stage for a ruling that a fetus or even an embryo outside the womb holds constitutional rights.

The ruling is a reminder of how important fetal personhood is becoming for both the antiabortion movement and the Republican Party — and of its potentially drastic consequences. In the United States today, recognizing the value of an embryo or fetus sets a precedent that no state can permit access to abortion — and that anyone who chooses abortion may be committing a crime.

The irony in the Alabama court's decision is that more Americans who want to be parents will be unable to achieve that dream. The ruling is extraordinary not only in declaring personhood before birth but also in applying the idea to embryos that haven't been implanted in the uterus. But the ruling is not just bizarre; its consequences may be profound.

If an embryo is a person, it can no longer be destroyed, donated for research or potentially even stored. Some abortion opponents argue that if embryos are persons, each one that is created must be implanted — and that would make even storing embryos for future use impermissible. If any of that comes to pass — and in Alabama, it likely will — that will transform how in vitro fertilization (IVF) works, and will mean a lower rate of success for Americans who already struggle to start a family.

The court's ruling could set a precedent for other conservative states that embrace the idea of personhood before birth, making it harder to pursue IVF across large swaths of the country. The decision will also bolster a broader antiabortion effort to recognize a fetus in the womb or even a frozen embryo as a person under federal constitutional law, helping abortion opponents make the case that if states already sometimes treat an embryo or fetus as a rightsholder, constitutional law should do the same.

The Alabama case began when three couples visited a fertility clinic in Mobile to pursue IVF: a treatment in which

a pregnancy. Across the US annually, about 2% of births involve IVF. The success rate of each IVF cycle can be low given the age and previous medical condition of the patient.

Since many patients who turn to fertility clinics experience trouble getting pregnant, physicians routinely create and store excess embryos so that patients can try again if a first attempt fails. IVF is also expensive — an average cycle can cost anywhere between \$12,000 and \$30,000, even when patients can use embryos they've already created. This means that patients have more embryos than they implant in a given cycle, which they can choose to store, give to other patients or donate for research.

The three Alabama couples elected to store their excess embryos at the Mobile clinic from 2013 to 2016. In December 2020, however, a patient from an attached hospital entered the clinic, handled some of the embryos and injured their hand, given the subzero temperatures at which the embryos are stored. As a result, they dropped the embryos and accidentally destroyed them.

The plaintiffs sued, first alleging that the clinic was negligent in how it monitored the embryos, contending that the clinic breached the contract it signed with the couples. The couples also had a much more controversial claim: that their embryos counted as "children" or "persons" under the state's wrongful death of a minor law.

The Alabama Supreme Court agreed that the embryos were persons. The court pointed to a 2018 ballot measure that recognized fetuses as persons under state law. "The People of this State," the court explained, "have adopted a Constitutional amendment directly aimed at stopping courts from excluding 'unborn life' from legal protection." It did not matter to the court that the embryos were frozen and not yet implanted in the uterus.

In a concurring opinion, Chief Justice Tom Parker suggested that divine law — which, he claimed, had been embraced by the people of Alabama — supported the court's conclusion. "Human life," he stressed, "cannot be wrongfully destroyed without incurring the wrath of a holy God."

The Alabama ruling is a reminder of the importance of personhood politics on the American right — and a warning about how punitive they have become. Since the US Supreme Court overturned Roe v. Wade in 2022, the fight to establish that the word "person" in the 14th Amendment of the US Constitution applies to fetuses has escalated. At the one-year anniversary of the reversal of Roe, leading groups from the Alliance Defending Freedom to Students for Life called for personhood for "preborn children."

States are considering bills recognizing the personhood multiple eggs are harvested, fertilized and implanted to create of fetuses in contexts from wrongful death to tax deductions. The goal is to slowly build the case that a fetus or even an embryo is a person for every purpose and circumstance. For the antiabortion movement, that would mean that no state could allow legal abortion. For some self-proclaimed antiabortion abolitionists, fetal personhood would mean that the criminal law would have to punish women who terminate their pregnancies.

In theory, there should be a way for Americans like the couples in the Alabama case to protect themselves against medical negligence — or even to express their belief that frozen embryos or life in the womb have value — without setting a precedent for criminalizing abortion across the US. There are plenty of examples of people asserting that fetal life matters who are not angling to criminalize reproduction. A pregnant woman tried to drive in the HOV lane, arguing that her unborn child is a person. A prison employee in Texas sued on similar grounds when her child was stillborn after she was not allowed to leave her post.

In the context of reproduction and the law, there are gaps in protections for Americans who experience stillbirth or miscarriage as a result of medical negligence, or who are otherwise denied wanted parenthood. Polls suggest that many Americans believe life in the womb has value while opposing criminal abortion bans: A 2022 Pew Forum poll found that even about a third of Americans who think abortion should be legal believe that "human life begins at conception, so a fetus is a person with rights."

That would not seem so strange if there was a way to recognize the value of embryonic or fetal life that does not inexorably lead to the punishment of physicians who perform abortions, others who aid abortion seekers and even abortion seekers themselves. It is not impossible to imagine how that would look — the Constitutional Court of South Korea took a position like this in recognizing constitutional protection for abortion rights in 2019.

If embryonic or fetal life has value, the state shouldn't start with criminalization. Instead, the government may have a constitutional obligation to advance its interest in protecting that life in ways that don't limit reproductive liberty, by protecting pregnant workers, delivering better prenatal care or safe housing and reducing the rate of maternal mortality.

There is nothing inevitable about equating criminalization with valuing fetal or embryonic life, or providing a remedy for people who want to become parents and are unfairly denied the chance to do it.

The Alabama Supreme Court's ruling is just the start of the push for fetal personhood. And unless something changes, the more fetal personhood is recognized, the more kinds of reproductive decision-making will be a crime.

## A fresh approach to health care reform

As the cost of living continues to be a crucial concern for voters, there's an urgent need for candidates to present viable solutions for making health care both affordable and accessible. Here are five fresh principles for health care reform that can resonate across party lines.

**Address root causes, not just symptoms.** One of the biggest reasons major Washington-led health care reforms have failed to lower health care costs is because they focus on health insurance instead of health care, and very little on health itself.

ObamaCare and the Inflation Reduction Act are perfect examples. Every year, these programs give more money to health insurance companies to offset the costs of higher premiums for people with larger incomes. A better approach is to fund American patients, not health insurance companies, by giving them direct control over the subsidy they qualify for and let them use it to buy the care and coverage that works best for

To further stop this doom loop, lawmakers must shift their focus from merely subsidizing insurance premiums to addressing the underlying issues of high health care prices and excessive demand. Lower prices and lower demand will lead to lower premiums.

**Localize health care.** The challenge for Washington in focusing on health and health care is that they are both local

issues, not national. Health care is delivered in a local setting, and the quality of care you receive is largely linked to what is available locally. Meanwhile, population health is much more influenced by local conditions than national ones.

This means a command-and-control approach from Washington to improve the health of our people and the quality of care they receive is doomed to fail. Instead, the Centers for Medicare and Medicaid Services should leverage its position to be a facilitator of change at the local level rather than an imposer of change.

One example of how this could be done is block grants and waivers in Medicaid, which would empower states and local communities to best cover and improve the health of vulnerable populations.

**Eliminate the middleman**. The current health insurance, big government-dominated system is your old cable bundle. The health care system of the future is streaming on demand. We need reforms to move us toward on demand, and that means enabling patients to cut out the middleman.

Direct care clinics allow patients to cut out the insurance middleman and pay doctors a monthly fee that gives them on demand access to their services. This arrangement is better for patients and doctors. By eliminating insurance company paperwork and getting doctors off the revenue cycle roller coaster, doctors can have smaller patient panels and spend more time with patients.

Washington can support the growth of direct care by allowing Direct Primary Care memberships to be paid for with Health Savings Accounts funds. We should also make them available to Medicaid, Medicare and ObamaCare patients using their benefit dollars.

**Demand transparency**. We are conservatives committed to free market principles, but we also recognize that a successful market for health care needs very strong rules in place to protect patients.

This is because health care is not your prototypical, Adam Smith-style marketplace. The asymmetry of information between patients and doctors is enormous, and the presence of the third-party payer means patients have no concept of the value of the care they receive.

Transparency can help even the playing field, bringing much needed accountability to the health care system. This means strengthening price and quality transparency for providers, so patients and self-insuring companies can find the best value for their health care dollars.

It also means transparency into the business practices of the health care middlemen like managed care companies, wholesalers and pharmacy benefit managers. For instance, self-insured companies must have the right to see their claims data so they can audit their expenses. Drug manufacturer rebates to pharmacy benefit managers must be exposed and the savings should be passed on to patients at the pharmacy counter.

We also need visibility into provider network contracts to see if hospitals are leveraging their size or position to force coverage of low value procedures (such as in-hospital imaging) and shut out competition.

#### Health care is a moral issue first, economic second. Finally, candidates must remember that as much as voters are demanding solutions to make health care more affordable,

these solutions cannot come at the expense of patients getting the care they need. Americans view health care primarily as a moral issue, and an economic one second. Rationing from the government or private sector is not an acceptable solution. By treating the underlying issues of high costs and

inefficiencies, localizing health care solutions, eliminating the middleman when possible, demanding transparency, and recognizing health care as a moral imperative, we can create a system that truly serves the needs of all Americans.

This is an approach to health care reform that could transcend party lines and genuinely serve the American people.
