Ricky Galvez defendant ordered back to juvenile hall

Abel Diaz, who pleaded guilty for his role in the murder of Downey police officer Ricky Galvez, was remanded to juvenile detention, where he will serve a maximum 5 years.

DOWNEY - A Los Angeles Superior Court judge closed the book on the fate of one of the Ricky Galvez murder defendants on Friday, electing to have him held in juvenile detention.

Defendant Abel Diaz entered a plea deal with prosecutors in December of last year, admitting to his role in a botched robbery attempt that resulted in the fatal shooting of Downey Police Officer Ricardo "Ricky" Galvez on Nov. 18,

In exchange for his confession, prosecutors agreed to not pursue the matter in criminal court, instead resolving it in the juvenile justice system.

The Los Angeles County Probation Department appealed to the court, asking LA Superior Court Judge Fumiko Hachiya Wasserman to allow Diaz to be transferred to county jail.

Wasserman denied the appeal, however, opting to let Diaz be held in juvenile hall and ultimately transferred to the Department of

juvenile justice system past the

than five years for his crimes.

This comes as a blow to the Galvez family and the Downey Police Department.

According to Chief of Police Dean Milligan, who was present at the time of the ruling, he was "not surprised" by the judge's decision and felt that Wasserman had "her mind made up already as to what she was going to do.'

"As the attorney said in court and more-so afterwards - we all had the opinion that this had been decided before we actually got in there. We don't think that we were given a fair chance," said Milligan. "It's just sad; it's very sad that it's come down to this.'

top of Wasserman's decision, Milligan also has reason to believe that a prior decision had been discussed higher up the probation ladder as well.

"In the courtroom, I overheard one of the defense attornevs comment that they had already been in contact with higher ups within the probation department, and that this had already been decided that he wouldn't be transferred," said Milligan. "There's obviously some contacts going up and above the officer who was in there requesting the transfer to take place.

Visibly frustrated inside the court room and as he left, Milligan said that he and the officers of DPD believe Diaz to be "complicit in Ricky's murder.'

"We feel that he should - in Due to laws which prohibit being found guilty of that, in a person to be kept within the admitting to his role in it - that he should have the same period age of 25, Diaz, 20, will see no more of incarceration than anyone else

who would be tried for murder and Alvarez. because of the circumstances,' said Milligan. "Unfortunately, the juvenile court system did not think that was going to be the case."

"We don't feel that justice was done to the fullest extent in this case, but at this point there's nothing we can do with regards to this case."

With Diaz's case now concluded, the two remaining men associated with the murder, reputed gang members Steven Knott and his half-brother Jeremy Anthony Alvarez, will have their turn to stand trial.

Despite his disappointment in Friday's outcome, Milligan said he remains hopeful to see a quick and decisive trial in the case of Knott

"We're hopeful that in the next case, the circumstances will be brought forth in court, the evidence will be presented and that they'll all be found guilty of their roles in Ricky's murder, and held accountable accordingly."

"I feel as the District Attorney's office does; we feel that we have a strong case with the information that we have, but it's up to the courts, it's up to the jury," said Milligan.

Milligan said that the two remaining defendants have been scheduled a court date for early

Vacant lot eyed for temporary fire station

A temporary fire house is needed while Downey's four stations are renovated.

DOWNEY -With major looming, upgrades Council voted to solicit bids for construction of a temporary fire station located on a parcel of land near the Downey Promenade.

As part of the Measure S tax increase, all four of Downey's fire stations will be undergoing significant upgrades to the tune of around \$16 million.

In the meantime, Downey Fire Department will transfer nearly all its operations to the temporary station for six months at a time for around 18

The temporary station will cost around \$375,000.

There were several concerns from council members - most notably Alex Saab - on how the location of the temporary fire station will affect the fire department's ability to operate

However, staff are confident that the temporary shift will not detrimentally affect service by an unacceptable margin.

Council considers resolution against SB 1437

City officials blame legislation for light sentence afforded Ricky Galvez defendant.

DOWNEY After disappointing outcome in the trial of one of the defendants in the Officer Ricky Galvez murder trial, the City Council is strongly considering taking a strong stance against Senate Bill 1437.

A somber Mayor Rick Rodriguez opened up his public comments at Tuesday's meeting by reading a letter that was recently sent to State Representatives by Pedro

Galvez, the brother of the Downey officer who was slain back in November of 2015.

The letter read in part:

"On Nov. 18, 2015 my brother Ricardo "Ricky" Galvez was murdered in the line of duty. Ricky was a dedicated Downey Police Officer, and also a United States Marine veteran who served two separate tours of duty while serving our country. He believed in our judicial system and risked his life daily to protect the innocent

Legislation would enhance oversight of children detention centers

California must intervene on behalf of children's rights, says Assemblymember.

DOWNEY -Legislation that would require additional oversight and mandates children's immigration detention facilities located in California introduced Monday by Assemblywoman Cristina Garcia (D-Downey).

At least three facilities exist in California. Nationally, 4,000 children have been taken from their families and the federal government has lost track of an additional 6,000 or more children.

AB 163 is a reintroduction of language amended into AB 1663 (Garcia) in 2018.

"We are only given one said childhood," Garcia. 'California must demand standards of decency for children and families where the Trump Administration has beyond failed. None of us want to fathom the emotional, life-long trauma we know this practice has caused.

California must intervene on behalf of children's rights."

Recent immigration enforcement policies have the need highlighted for adequate resources in detention facilities for undocumented minors who have been separated from their families, as well as those undocumented minors that arrive in the United States unaccompanied, Garcia said.

In light of the incidents where children have died or been abused while under the care of ICE or U.S. Customs and Border Protection, "it's apparent our current systems are not designed to safely detain children," Garcia added.

However, because they are minors, California has a unique avenue to ensure these kids get the resources they need through its facility licensing oversight. Current law already provides for the licensure and regulation of the facilities housing undocumented minors, through the California Community Care Facilities Act.

The bill would leverage existing state licensing authority

and encourage other states to join California's efforts to create similar immigration detention facility standards for children

Data collection standards will be set, mental health counseling will be required and quarterly facility inspections would be California would scheduled. further work to reunite children with their families and identify legal services to assist families with the immigration process.

The legislation would apply to both children who have already

been or will be separated and unaccompanied minors.

"All of these children endure multiple traumatic experiences over the course of their journey," said Garcia. "They are vulnerable, they need to be protected and their legal rights, ensured.

The three known facilities licensed in California include Casa San Diego, Casa Lemon Grove and Casa El Cajon operated by Southwest Key Enterprises.

Can the President alone build a border wall?

When Donald Trump was looking for a catchy phrase during his 2016 presidential campaign to address the issue of immigrants entering the United States unlawfully — a line that would resonate with his supporters — he came up with the phrase "build the wall." The reference, of course, is to what Trump advertised would be a 30-foot-tall, thousand-mile-long Mexico-financed physical wall along our border with Mexico.

At first, most folks seemed to dismiss this a pie in the sky. Why would the government of a foreign country pay for a wall in the United States built so as to keep its own citizens and residents from entering the United States? The answer: It wouldn't.

So President Trump changed his argument that Mexico would pay directly for his wall by arguing instead that the \$5.7 billion down payment he wants — on a \$25 billion to \$30 billion project — would indirectly pay for itself in reduced government welfare and law enforcement expenses. The idea of the wall never took hold during the first two years of his presidency, when the Republicans controlled both houses of Congress.

Even Republicans were leery of the cost and the imagery. The federal government is running about \$1 trillion a year in the red, and Republicans are looking to offer comfort in their party to Hispanics. Adding to that debt to build a wall that would affront other Hispanics did not rest well with them. Until now.

Now that the Democrats control the House of Representatives, where the idea of a wall is dead on arrival, it is easier for House Republicans to argue in favor of it. Because the Democrats numerically outnumber them, the House Republicans won't be forced to vote on it. The president is probably kicking himself for not calling in a few favors and addressing the wall before the Democrats took control of the House.

So, faced with intractable opposition in the House and only lukewarm, mainly symbolic support in the Senate, Trump has threatened to bypass Congress, declare a national state of emergency and build the wall on his own. Can he legally do this? In a word: No

Here is the back story.

The Constitution is the supreme law of the land. Everyone who works in government takes a public oath of fidelity to the Constitution; that means to its very words and to the values that those words represent. All federal powers come from the Constitution — and from no other source. The states formed the federal government and limited its powers when they ratified the

Constitution. These are all basic truisms of American government, yet we have veered so far from them that they bear repeating.

Now, back to the president's wall. President Trump has no power to build a wall or a fence or a doghouse on private property without an express or implied congressional authorization to do so. The vast majority of the property in Texas on which he wants to build is private, according to Rep. Will Hurd, R-Texas, whose district contains a longer stretch of the border than anyone else's.

Thus, the federal government must use eminent domain, which gives each landowner the right to a trial to challenge the government as to the worth of the property the government wants. Rep. Hurd, a former CIA agent and conservative Republican who opposes the wall, has articulated the views of most of his 800,000 constituents: Not in my backyard.

We know from the plain wording of the Constitution and from history that all expenditures of money from the federal

treasury and all federal use of private property must first be approved by Congress. In 1952, the Supreme Court ruled on this when President Harry Truman seized American steel mills during a labor strike and directed the secretary of commerce to hire folks to operate the mills, pursuant to his own emergency declaration that steel was vital to the war effort in Korea. The court held that only Congress could authorize the seizure or adverse government occupancy of private property and the expenditure of money needed to operate the mills.

Then, in 1976, Congress provided a definition — which, shortly thereafter, the courts refined — of a national emergency: the existence of events truly beyond the ordinary, wherein there is a palpable and immediate threat to lives, safety or property that cannot be addressed by the employment of ordinary government assets or the exercise of ordinary governmental powers. That is hardly the case today with the former Central American caravan in Mexico now settled in and housed by the Mexican government away from the border.

Nevertheless, the 1976 law requires that all ordinary assets — our president prefers the military — be determined useless before a lawful emergency can come into effect. The military useless in an



emergency? And if this is such an emergency, why did the president wait until it abated before addressing it?

Perhaps the answer is that his frustration with the Democratic House has reached a boiling point, but that boiling point cannot be a basis for a declaration of a national emergency. A valid emergency declaration streamlines the government to address the emergency, but it cannot authorize anything that the Constitution prohibits, nor can it authorize the president to avoid anything that the Constitution requires.

The president has sworn not only fidelity to the Constitution but also to take care that federal laws be enforced. If he could disregard that oath, if he could ignore those laws, if he could spend money not authorized by Congress, if he could occupy private property not subject to eminent domain against the will of the owners — in short, if he could make the laws, as well as enforce them, then he would not be a president. He'd be a monarch.

Of course not.

which his own LDS church has now withdrawn support?

Does he believe attacking Trump is more important than the dramatic decline of religion in American life? He is, after all, a religious man.

Does he believe attacking Trump is more important than preventing the left from dominating the country's federal courts, including the U.S. Supreme Court?

If he does, he may be more than a fool. And that something more may involve character defects. I try to avoid directing comments at the character of those I differ with, but since Mitt Romney deems it of national significance to publicly attack the character of the president of the United States, and given that he considers character more important than policies that affect the nation and the world, he has invited consideration of his character.

Given his attack on the president, rather than on the nationand civilization-destroying policies of the left and the Democratic Party, character issues may explain his Washington Post column. While we have every reason to assume Mitt Romney is personally honest and faithful in marriage, a public figure's character is far more than his or her personal honesty and marital fidelity. Plenty of honest men and women and plenty of faithful husbands and wives have helped ruin societies. And in those more important areas of character, Mitt Romney is apparently quite lacking.

One character issue is lack of courage. In today's environment, it takes no courage to attack Donald Trump, especially in the Washington Post. Sen. Moon landing

Dear Editor:

In response to Mike Sandoval's recent letter ("Moon Landing Denier," 12/26/18) and his yearly July letter denying the moon landing, there is plenty of evidence that proves that it really did happen.

There are two main concrete pieces of evidence: pictures of the moon landing sites and the moon rocks brought back.

To begin with, the Lunar Reconnaissance Orbiter that launched in 2009 has taken pictures of the Apollo landing sites and other countries' space agencies (China, India, Japan) have spotted that same sites with their own satellites.

The second solid evidence comes from the 382 kilograms of moon rocks and that was brought back from the Apollo 11 mission and given to 135 other countries. Multiple tests were performed that confirmed they were of lunar origin.

There is other evidence of the Apollo 11 mission: such as explaining the more common topics of the pictures, such as why the US flag appears to be waving, why no stars appear in the background and the shadows, but I figured the best evidence to prove the Apollo 11 moon landing was through the concrete evidence I explained: the pictures of the landing sites from other independent space agencies and the moon rocks.

All the facts are there, but I am interested to hear Mr. Sandoval's theories regarding the independent space agencies' pictures and the moon rocks.



Paging Dr. Frischer...

"Doctor, I feel tired all of the time." I can't tell you how frequently I hear those words. This complaint raises so many possible underlying issues, including lack of sleep, poor diet, sedentary habits, poor lifestyle choices, stress, and quite a few medical

conditions.



What are the consequences? About 100,000 car accidents, 44,000 injuries, and 6,000 fatal crashes each year are likely attributable to fatigued drivers. Other consequences include obesity, hypertension, depression, heart disease, stroke, and poor performance at work and in

What are some key causes of fatigue? The first and most obvious is a lack of quality sleep. Which of these recommendations might make a difference for you? Maintain a consistent sleep routine. Get up if you lay awake for more than 10 minutes. Keep your bedroom dark, quiet, and at a comfortable temperature. Limit caffeinated drinks, and avoid tobacco, alcohol, and bright computer screens before bed. Note that sleeping during the day (whether for work or by choice) can disrupt circadian rhythms and lead to fatigue.

Eating a balanced and healthful **diet** can have an enormous impact on reducing fatigue. Try these strategies: Consume a planned number of calories, and make half of them fruits and vegetables. Add beans and nuts to the diet. Limit sugar and other processed carbohydrates. Eat at least three meals a day, and consume a variety of foods.

it. Coffee and a donut are (sorry!) a terrible choice; sugar and salty snacks are usually empty calories with a high glycemic index. Simple

carbohydrates lead to a rapid rise in the blood sugar, which is followed by a sugar crash.

Have you considered food sensitivities as a possible cause of fatigue? If you suspect that certain foods may be making you tired, such as gluten, dairy, eggs, soy, nuts, or corn, consider working with an allergist or dietician.

Dehydration can be directly linked to fatigue. Dehydration occurs when we don't drink enough liquid to replace what is lost in urine, stool, sweat, breath and the body's many biochemical reactions. Even a small fluid loss can reduce blood volume and cause our heart to pump blood less efficiently, which restricts the circulation of oxygen and nutrients to our muscles and vital organs.

Exercise lessens fatigue. While resting may seem like an appropriate response to fatigue, getting up and moving is actually far more effective. Lack of exercise over time will turn muscle into fat, and promote more fatigue.

Excessive anxiety/stress can be physically and emotionally exhausting. Our lives are filled with sources of stress, including rork, finances, relationships, moving, and loss. Some stress can be motivating and healthy, making us more alert and better able to perform tasks. However, this is not true for excessive or prolonged stress. Your body may signal that you are experiencing excessive stress with tense shoulders, headaches, poor sleep, or fatigue.

Identify and try to eliminate the source of stress. Learn to say no to new commitments. Avoid those who cause your stress. Learn to express your feelings rather than bottling them up, and learn to forgive. Remember that physical activity is not only good for your health, but a great stress reducer.

Depression is a frequent cause of debilitating fatigue, and may well require therapy and medication.

Consider your personal **environment**. Living in clutter, either And yes, breakfast is indeed the most important meal of the at home or at work can be mentally exhausting. The mere sight of day. The body has gone many hours without any food to sustain disorder can be stressful. Give some consideration as to how you might keep your world better organized on a regular basis.

Many of my patients consume **alcohol** before bed, thinking that it will help them sleep. Note that while a drink may help to unwind, and even put you to sleep, it interferes with REM sleep, and results in a more wakeful night.

Most of us have become addicted to our electronic devices. Unfortunately, the act of checking our emails, text messages, or social media accounts just before bed can be stressful and stimulating, making it more difficult to relax and fall asleep. In addition, the bright computer screen can fool our brain into thinking that it is daytime, and not time for sleep. Let's try to keep our electronic devices out of our bedrooms.

A number of **medical conditions** can cause fatigue. Many of these problems may be treatable, including anemia, thyroid conditions, infections, heart disease, diabetes, uncontrolled hypertension, vitamin and mineral deficiencies, anxiety and depression. One disease that currently has no effective treatment is Chronic Fatigue

There are more than 30 million diagnosed diabetics and many more prediabetics in the United States. Fatigue results from poor regulation of blood sugar levels; high levels make the blood "sludgy," and affect circulation, which leads to a lack of oxygen and nutrients

Those suffering from sleep apnea feel tired no matter how many hours of sleep they get. The condition causes the upper airway to collapse or close, which in turn alerts the brain to wake up and begin breathing again. People with sleep apnea may never enter into deep, restful, healing REM sleep.

There are so many possible causes for feeling tired. Treatment of fatigue requires that we focus on both medical and lifestyle issues. Let's work on diet, exercise, sleep routines, and other life choices so that we can improve our energy levels and our overall quality of life.

Homeless at the Post Office: Part III

Lorine Parks attempts to follow up with Julie, a recognizable figure outside Downey's main post office.

Downey Patriot's about stories homeless Julie brought outpouring bittersweet remarks on Facebook from people who felt they knew her already: "So saddd;" "I bought her a slice of pie;" "a bottle of water;" "I gave her some sunscreen because she had a severe sunburn," "Some change," "a few dollars," "all the money I had."

People offered prayers and

sympathy and some gave practical has gotten the money. advice: "Go to the Barbara Riley Senior Center. Lunch is served Monday through Friday, no one is turned away because they cannot pay." But the comments all went onto Facebook, not to Julie.

On the likely chance that no one nor any agency had yet come forward to help her in a more permanent way, I wanted to give Julie something to keep up her spirits during the holidays. So I cut and pasted those Facebook squibs and stapled together a little booklet with about 40 cheery names and faces.

Although she can't see to read because of macular degeneration, her sometimes landlady could read them to her. I was told there is a friendly Huntington Park motel where she goes by bus, when she

But when I got to the post office, her place by the gray cinder brick wall was taken. Julie had been displaced by a man from the Salvation Army in a red vest who was ringing a bell and standing by a big black donation kettle.

Ironically, the Salvation Army, faith-based organization, has a shelter right up the riverbed from Downey. Their Bell, Calif., shelter is the largest homeless shelter west of the Mississippi and offers transitional care for up to 350 homeless men and women.

But the program, like everything worthwhile, has a the long waiting list. The Salvation Army does a remarkable job in offering shelter for three months up to a year, and training to get the

homeless back into the job force. The program tries to make people independent and self-sufficient

But currently the facility in Bell operates as a rehab center for substance abusers, for abused women and for homeless vets. Julie does not qualify.

I went to the other places where Julie has been sighted, in front of Marie Callender's, and at Stater Brothers. Dollar Tree and CVS Pharmacy. Safe places, family-frequented. But no Julie

I had hoped to hear from Julie that something good had come from the exposure in the Patriot, to stop this downward spiral. And during the intense rain we just had, I kept imagining how that

Julie is a familiar face at the post office, where she routinely panhandles.

must have made it impossible for her to stand outdoors and wait for charity and the kindness of strangers.

As one of her Facebook wellwishers said, "We all have a story, even the rude selfish people who

find Julie annoying and of poor taste. The heart is deeper than we know, the fight is longer than we know, the ignorance is bigger than we know. We only know that we know better than to judge.'

An interview with Downey composer Lars Clutterham

The talented composer from Downey will premiere new music Jan. 19 at the Downey Theatre.

ow does one imagine one's own life before birth? "The first melodic instruments to appear In The Arc of My Life," says Lars Clutterham, "are two flutes, since I am a twin."

"They are playing very high in their range," Lars says. "They slowly descend, as I imagine them floating down towards birth, and are replaced by two oboes just before the strings enter, with a dissonant rhythmic pulse, representing labor and childbirth."

"That builds to the whole orchestra, and after a quiet peaceful harmony from woodwinds, representing that beautiful moment after birth where the now peaceful mother holds her children, the twins, this section concludes with a very brief oboe duet."

Concert-goers will be able to hear this transformation when the Downey Symphony performs the premiere of Lars's piece, on Saturday, Jan. 19, at 8 pm at the Downey Theatre.

"Downey, you are blessed to have him." Attendees at the December Cathedral Production of "Christmas in Downey" will remember Lars's imaginative arrangement of Dr. Seuss's "How the Grinch Stole Christmas" for a basso opera singer-narrator. Director Chad Berlingheiri praised Lars from the stage, "What a treasure!"

As for his first memory of himself as a musician, Lars shows that with a songlike melody, "Actually the first melody I remember writing down, as a junior in high school," he says. That melody, aside from a couple of brief interruptions, defines the rest of the piece. "The timing elements from that point on are really dictated by the musical phrases of the song form, rather than by any specific biographical details."

"The 'jazz' interlude," says Lars, "is actually a brief nod to a period in my life when I first became interested in jazz. In a similar way, I was also involved in a very abstruse style of music called "dodecaphonic" or "twelve-tone," which is also briefly presented. In my score, I call the jazz interlude "Recreation," and the word I used for twelve-tone is "Dissonance."

For Lars, "Music is my life." A professional musician, it means a lot to him to hear his work performed by the Downey Symphony Orchestra. "First," he says, "no matter how well one 'reads' music, there's a tangible perception of the real sounds when hearing it live. And second, that produces a genuine emotive impact, as one hears other musicians adding emotional content through how they perform the music."

"And third," says Lars,
"there's simply the pride
that, for whatever reason, a
full orchestra of musicians is
realizing one's own creative
ideas."

Lars has always promoted physical fitness, and for years rode his bicycle on weekends to the studio in Santa Monica where he worked. How does that show up in the music?

"These days I'm not riding," Lars said, "nor currently involved in environmental advocacy, as much as I used to be. I do yearn to get a regular ride on my schedule down the Rio Hondo-L.A. Riverbed from northwest Downey to the Long Beach Lighthouse. In this piece, both strings and woodwinds have some fast ascending passages that are designed to show energy and vitality."

Lars is bringing some young people to the concert. "Through the Downey Federation for Educational Opportunities, now in its third year, I am conducting and writing for a new string ensemble, whose two dozen members are mostly elementary school kids taking after-school violin classes through the DFEO program.

"Our long-term goal," said Lars, "is a youth orchestra in Downey, and meanwhile they are showing great enthusiasm for orchestral music, so a group of parents, students, and teaching faculty from that ensemble are planning to attend the concert.

Since piano was his first instrument, what other instruments does Lars bring in to show "experience?" "Actually," said Lars, "piano never comes into play. I promised Sharon Lavery, the Downey Symphonic Society's Music Director, I would orchestrate using the only instrumentation of the Prokofief Peter and the Wolf, and Mozart's Great Symphony in G Minor, the other pieces in the program. So my musical choices," Lars said, "were designed mostly to build momentum before the peaceful ending.

Since Lars is by no means at the end of his own Arc, how does he end the piece? "Great question," Lars says. "Since that first song melody has by now become the primary theme of the piece, the rest of the composition simply expands on the main theme, using the broad terms



'Felicity,' 'Exuberance,' and finally coming to a quiet ending: 'Peace' and 'Rest.'"

"The only thing I would like to say," said Lars, "is that it's been a great honor that Sharon Lavery, the Downey Symphony's conductor, has invited me to write a new piece for the DSO for three consecutive years."

In twenty more years, Lars will have that many years of accomplishments to add, and more themes may emerge, to the peace and balance he has now achieved. Perhaps before then a new piece, without the constraint of this commission, will let the piano emerge in concert with the full orchestra. Not only for the piano's brilliance and its range but because it can express modulation. In a way the other instruments can't.



Demystifying Mozart

On Jan. 20, the Downey Symphony will perform one of Mozart's most celebrated works.

Mozart lovers get two winter treats. One of Mozart's late great symphonies, the Great G Minor #40, is being offered by the Downey Symphony Orchestra at the Downey Theatre on January 20.

First, however, comes the whispered pianissimo notes, very fast and agitated, of Mozart's Overture to the Marriage of Figaro. "Fun, exciting, the perfect way to shoot out of the gate to start a concert" Maestro Sharon Lavery

The presto tempo adds to the feeling of intrigue and secrecy anticipated in the comic opera to come. Effervescent melodies bubble up throughout the piece, creating a feeling of wit, anticipation, and buoyant good

Fans will listen for the long, extended, controlled crescendo which ends the piece. This is the famous "Mannheim crescendo," a sudden dynamic process where the whole orchestra transitions from pianissimo to fortissimo within an incredibly short time.

For his Great Symphony #40 in G Minor, Mozart wrote not one but two versions, and the second one differs because in it he added - and no one knows why - a part for the newest member of the woodwind family, the clarinet. This made for a bigger woodwind section, and a bigger orchestra.

The clarinet had begun life as a shepherd's pipe or chalmeau, but recently a new register key had been added, which increased its range by over two octaves, and Mozart wanted to include it. If purists want to hear the first version that came into Mozart's fertile mind, today's Symphony

Orchestras can perform either, with or without the clarinets.

We asked Musical Director Lavery which version we would be hearing, and how she made her choice. "I'd never be able to look our principal clarinetist in the eye," she answered, "if I didn't chose the version with the clarinets."

'But seriously," the conductor went on, "the wind section, to my ear, sounds much more complete with the clarinets. So I guess the short answer is, yes, the fact that I am a clarinet did influence my decision."

In the "Great" G Minor Symphony, the listener can make the connection as Mozart uses the Mannheim School of Special Effects again, to give a strong emotional quality as a sense of tragedy and grief climaxes the Fourth Movement. Although the Symphony is not scored for timpani, or the kettle drums, vet to our surprise, thunder crashes around us and waterfalls roar. It is the Mannheim Rocket effect, achieved with a passage that rises swiftly through several octaves in a series of rising notes, an arpeggio, and that dynamite crescendo.

Music of the Sturm und Dram (Storm and Stress) period often uses a minor key, to suggest passion and indecision. This is one of only 2 minor key symphonies Mozart wrote, that sunny man from Salzburg. Calling it "Great" distinguishes it from the 'Little" #25, also in G minor, but written in Mozart's early years.

"Personally," Lavery said, "I love this symphony because of all of the harmonic twists and turns that Mozart takes us through. When you think he's going one way with the harmonic progression, he leads us into a completely different

"This type pf genius composing keeps things dramatic and curious at all times," said Lavery. "Just when you think a typical cadence will end with a soft dynamic of piano, you get a loud forte ending that brings us into a new key. What should be a calming slow movement is agitating.'

"The traditional sunny minuet is again in a G minor," said Downey's conductor, "and heavily chromatic. It's sort of like ending a typical sentence of a story in a certain way, but then somehow the story shifts in an instant with a shocking new twist. "

"When we perform it," Lavery said, "I will ask the orchestra to bring out these twists and turns. I will ask them to emphasize these harmonic turns by perhaps accenting the first notes of these surprising new keys or surprising new chords. I might ask them to emphasize these dramatic harmonic surprises with the overall dynamics."

"This whole symphony is filled with drama and agitation," said Lavery. "It is an absolute gem that takes you on a very satisfying musical journey." Written during the Viennese years, this Great G Minor Symphony is recognized as one of the gateway pieces to the Romantic era.

Lavery as Music Director chose to continue the evening's concert with Sergei Prokofiev's Peter and the Wolf, a playful story with a narration that provides an interactive component for the audience.

The dark "Into the Woods" theme is introduced when, as in all good fairy tales, the hero gets in trouble when he enters forbidden territory. For a little boy, that means going beyond the farm fence into the meadow that leads to the forest. Even though it is broad daylight, it is off limits. But surprise, Peter's breaking boundaries pays off and music lovers from 9 to 90 plus love to hear Peter as represented by a cheerful string quartet when he skips into the meadow.

Prokofiev's piece has introduced generations to the instruments of the Orchestra, from the Cat, as played by the clarinet "in the lower register," (the chalmeau again, now an alto clarinet), to Grandfather's grumbling bassoon. The oboe is the Duck, quacking. Flute followers listen just to hear the Bird trilling, cajoling, fluttering and fretting, and finally saying 'I told you so.' Audiences cheer (spoiler alert) when the boisterous kettle drums blaze on the scene as the Hunters rescue Peter from the snarling French horns of the villainous Wolf.

For Prokofiev writing in 1937, Peter represented the valor of the younger generation of Bolshevik youths, and Grandfather the overly conservative and stubborn older generation. No matter what your politics, everyone is happy when the wolf is captured and a Mozart-like balance is achieved again.

Peter and the Wolf showcased some of the great voices and orchestras of the 20th century. In the days before television, families would sit and listen to records together, and a 1939 recording such as RCA Victor made with Serge Koussevitzky and the Boston Symphony was a family treasure. In 1946 Disney featured included Peter as an animated short in Make Mine Music, and Deems Taylor did an unforgettable voice-over commentary.

Celebrity narrators have included Eleanor Roosevelt, Sean Connery and Ronald Reagan, Sophia Loren and Sting. Downey audiences will be treated to Antony Moreno who charmed us in the Love Letters portion of the Red Violin program several winters ago.

True to Downey Symphonic Society tradition, there will be a world premiere on the program, local composer Lars Clutterhams' short Instrumental Suite for Orchestra, The Arc of My Life.

"I asked Lars to use the same instrumentation as Prokofiv did in Peter," said Sharon. "Lars's music, while brand new and unfamiliar to the audience, will make that important connection to our listeners."

"The piano was my first instrument," said Lars, "so

that's how 'The Arc of My Life' begins, with a note struck on the piano. And out of that fragment, my life develops." A later interview with Lars will show how he composed his "Arc of My Life.'

with a Bachelor of Science degree.

The couple moved to Seattle, Washington, where they started a family and where Milt's career involved working for the Boeing Company on the design of the B-52 bomber. Upon completion of his Master of Science degree from the University of Washington, the Hammonds relocated to Southern California, where Milt continued his aerospace career at North American Aviation, subsequently Rockwell International, for 15 years.

At Rockwell, he worked on various missile programs while attending graduate school at the University of Southern California where he earned his PhD in Mechanical Engineering. Subsequently, Milt worked on the U.S. Space Program, with the Apollo Program Saturn V rocket that put men on the moon. He also worked on preliminary rocket designs for the Space Shuttle Program.

In the mid-1970s, Milt left the aerospace industry and started his second career as a management consultant which he continued well into his 80s. He specialized in company team-building, leadership, and talent selection through techniques pioneered by the Success Motivation Institute.

In his boyhood years in Pennsylvania, Milt began a lifelong association with the Boy Scouts of America and attained the rank of Eagle Scout. As an adult, he volunteered for 35 years with Cub Pack 805C and Troop 441 in Downey. He also led a backpacking Explorer Post on monthly hikes. He was Committee Chairman for the cub pack for about 10 years, and also served as president of the Old River Men's Club, the sponsoring institution for the cub pack and the troop. In 1981, he was honored with a Silver Beaver award by the Boy Scouts for meritorious volunteer service.

He was an active associate and Bible teacher with The Word of Truth Ministry in Los Angeles for over 50 years. As a "senior scholar," he recorded numerous Sunday morning Bible study lessons and authored More Seed & Bread Bible study leaflets.

Milt told lots of silly jokes and stories to anyone who was willing to listen. A gentleman and all-around "nice guy" to those who knew him, Milt will be missed by many.

DOWNEY – With Los Angeles Unified School District teachers poised to strike as early as Monday, Downey Unified superintendent Dr. John Garcia sent a message to parents Sunday, assuring them that the Downey school district's relationship with teachers remains "wonderful

More than 30,000 LAUSD teachers may form picket lines Monday after two years of failed negotiations on a new contract.

"As we are not part of Los Angeles Unified, I'm reaching out tonight to let you know that we in Downey Unified are fortunate to have a wonderful relationship with our teachers' union and all of our DUSD staff will be welcoming your students everyday regardless of what happens with our neighbors next door," Garcia wrote.

Downey public schools reopened Monday after a two-week winter break.

The United Teachers Los Angeles union announced Wednesday that the start date for a potential teachers strike has been postponed to Jan. 14.

The initial date for the possible strike was supposed to be Thursday, Jan. 10. UTLA said the reason for pushing the date to next Monday is to provide "clarity and to allow members, parents and our communities to plan."

There are also some legal issues to be resolved, as the district has gone to court to claim the union did not provide enough advance notice for them to go on strike now. The union says it gave adequate notice on Dec. 19.

The two sides were in court and at the bargaining table - on Wednesday, but the legal issue and the overall contract talks remain unresolved.

The government shutdown is also causing delays in loan endorsements as the FHA operates with limited staff.

The effects of the federal government shutdown on the housing market are wide-ranging and personal -- unpaid workers still have to pay their mortgage or rent, while aspiring homeowners might see their loans in limbo.

About 800,000 workers aren't being paid (about 380,000 are furloughed and another 420,000 are working without pay), and still must find ways to pay for their housing as the shutdown heads into its third week.




