Man accused of killing godson



Tyler D'Shaun Martin Brand, 23, accused of fatally beating his 6-year-old godson.

DOWNEY -A 23-yearold Downey man was arrested and charged with murder after he allegedly beat to death his 6-year-old godson last week.

Police said the boy, identified as Dayvon T., was taken to St. Mary Medical Center in Long Beach on Dec. 26 with lifethreatening injuries.

The boy died the same day. His death was ruled a homicide by the L.A. County Coroner's

Police arrested Tyler D'Shaun Martin Brand and booked him for murder.

Family members said Dayvon attended Normandie Avenue Elementary School in South Los Angeles and was staying with Brand at his Downey apartment over the winter break.

"This case is a serious and investigation and complex investigators are still in the process of gathering information, interviewing witnesses and processing evidence," police said in a statement. "As a result, no other details will be released at this time."

Brand was arraigned Monday at the Downey courthouse. He faces one count each of murder and assault on a child causing

Bail was set at \$2 million. If convicted as charged, Brand faces a maximum sentence of 25 years to life in prison.

"I'm just trying to stand tall right now and be prepared for the worst day, and that's laying my baby down to rest," the boy's father, David Nicholson, told KTLA.

Police pursuit ends with crash

The chase ended when the suspect crashed the Chevy Avalanche into an apartment building on Florence Avenue and Wiley Burke Avenue.

At least one person was hospitalized. His condition was not believed to be lifethreatening.

Downey broke ground on the most expansive and robust infrastructure improvement project in its 63-year history, with work nearing completion on four new fire stations, seven renovated parks, and a revamped civic center plaza. The Downey City Library has been completely hollowed out in preparation for a 21st-century modernization that is expected to wrap up next summer.

Open enrollment now underway at Downey schools

Parents who want their child Unified district boundaries. to attend a school outside their boundary should apply now.

DOWNEY - Downey Unified will be conducting its annual intra-district open enrollment (formerly School of Choice) starting in January for the upcoming 2020-21 school year.

Downey parents who reside within the district boundaries and wish to have their student(s) attend a Downey Unified school outside of their attendance area may apply.

This enrollment period does not apply for parents of students who reside outside of the Downey

From Jan. 1, 2020 through Jan. 31, 2020, open enrollment applications will be available to pick up at any of the 20 Downey Unified schools, the district office or can be filled out and submitted online at www.dusd.

New students (including kindergartners) entering Downey Unified school for the first time and wishing to apply, must also register at their school of residence. This will guarantee registration within Downey Unified for the new school year.

Hand written applications, those not submitted online, must be submitted in person to

the Student Services office at the Downey Unified School District by the closing deadline of Jan. 31, 2020, at 4 p.m.

Applications are processed on a first-come basis. A random, unbiased lottery will be held to place students on an intra-district open enrollment permit waiting list for the 2020-21 school year.

Schools may accept students from the established waiting lists according to priority, only if space is available.



No, it's not that I want there to be no news at all so it's easier for me and Eric.


But, in an era where it seems there is some sort of tragedy or scandal in the news every other week, let's hope that none of that befalls our beloved Downey.

Why on earth did the Red Sox sell Babe Ruth to the Yankees?

One hundred years ago on Christmas Day, typically the slowest news day of the year, George Herman Ruth Jr. knew there would be a news hole to fill. He excelled at filling space, with his girth, his personality, his grand and unprecedented home runs, and his sense of himself. By the end of the 1919 season, during which his 29 home runs had reinvented the game of baseball, he had concluded that the three-year contract he had signed that March with the Boston Red Sox for \$10,000 a year was not commensurate with his largess.

Decamping for the West Coast for two months of "pastiming," as one newspaper put it, Ruth let it be known that he expected the Red Sox owner, Harry Frazee, to double his salary. Answering reporters, Frazee demurred but assured them that Ruth would be "taken care of," commending him as a good businessman who knew his own worth and wanted to be paid for it.

For the next two months, in a daily blitzkrieg of published fulmination, a ballplayer's only recourse in the era before free agency, Ruth issued daily bulletins rejecting his contract as "a scrap of paper" and declaring his intention to return it unsigned, which in a previous interview he said he had already done.

In between, Ruth found time in his hectic schedule of fetes, soirees, photo shoots and exhibition games (which paid \$500 each) to bask in studio lights while hitting imaginary home runs and declaring that he'd reached an agreement to appear in movies "indefinitely," only to swear off the greasepaint a week later when he didn't get his price. He mused about barnstorming in Australia or touring in vaudeville with the heavyweight champion Jack Dempsey and a professional wrestler to be named later. Or, better yet, he'd take on a trainer and challenge the champ — all of which was subsequently denied by his new personal secretary, Johnny Igoe.

Neither his rhetoric nor the Dec. 23 publication of the official 1919 American League statistics moved Frazee to action. In 130 games, Ruth batted .322, led the league with 284 total bases, 113 R.B.I., 103 runs and those 29 home runs (not to mention several, more modern metrics not yet invented). He also posted a 9-5 record as a pitcher with a 2.97 E.R.A. Nonetheless, the Red Sox had finished in sixth

On Christmas Eve, Ruth sent a telegram to Igoe in Boston with instructions to up the verbal ante. Igoe dutifully announced that Ruth would play for the Red Sox or not at all, and again threatened to return unsigned his phantom contract. This led to Christmas Day headlines across the continent, from Ruth's hometown, Baltimore; to Montreal; to Little Rock, Ark.; to Spokane, Wash., and a hundred other cities in between: "Babe Balks," "Babe Spurns," "Babe Through with Baseball." Writing the next day in The Boston Globe, the columnist known as "Sportsman" chided the Babe for his bad manners: "'Babe' Ruth's Christmas greeting to Pres Harry Frazee was not exactly an offering befitting the day.

What Ruth didn't know was that he was already the property of the New York Yankees. The papers were signed on Dec. 26, and cash had already changed hands.

The Times, using one of its home team's previous nicknames, announced the transaction on Jan. 6: "Ruth Bought by New York Americans for \$125,000/Highest Price in Baseball Annals

An upstart tabloid in New York, then known simply as The News, filled the top half of its back page, newly dedicated to daily sporting news, with three Ruthian photographs: The Babe finishing his perfect uppercut swing; getting off a train with his wife, Helen, in Seattle; and posing glumly in his Red Sox uniform. The static quality of the images was less important than their placement and the space allotted to them. The paper's managing editor, Arthur Clarke, didn't have the city's new sports superstar in mind when he created the back page, which had debuted on Nov. 3 with photos from the Boston Terrier Club championship at the Waldorf-Astoria, but he might as well have. Ruth would occupy it for 15 years: selling newspapers and himself in unprecedented fashion.

It was a transformational moment, not just for two baseball franchises but also for the cities they inhabited. Boston became the capital of grievance and curse; New York became the locus of power and stardom, and not just in sports. "If Boston was the cultural capital of 19th century America, New York City became the cultural capital of 20th century America when Babe Ruth arrived," said John Thorn, the official historian of Major League Baseball.

Blame it on H. Harrison Frazee. A high school dropout and Broadway producer who dabbled in baseball, real estate and boxing promotion, he had purchased the Red Sox from Joseph Lannin in 1916 for about \$1 million, plunking down \$400,000 in cash, issuing a three-year note for \$262,000 and assuming the rest in team debt. He was flush then — one of Broadway's most successful producers, who had built the Cort Theatre in Chicago and the Longacre Theatre on West 48th Street in Manhattan. Though he kept a residence in Boston, he lived in what The Times called Manhattan's "largest and most expensively decorated apartment house," the Hotel Marguery, at 270 Park Avenue. He palled around with George Gershwin; Mayor Jimmy Walker (who would be with him at his deathbed); and the Yankees' owners, Col. Jacob Ruppert and Col. Tillinghast L'Hommedieu Huston. "He said the best thing about Boston was the train ride home to New York," Frazee's great-grandson once said.

By the fall of 1919, Frazee's fortunes had changed. He was asset rich

and cash poor. Yes, Ruth had helped him win the 1918 World Series, but the Great War had disrupted the public appetite for amusements. The 1918 and 1919 baseball seasons had been shortened, diminishing gate receipts. Frazee's spring production of "A Good Bad Woman" nad opened and closed in a month.

Frazee kept wheeling and dealing, selling the Longacre and negotiating the purchase of another house. His newest production, "My Lady Friends," was scheduled to open on Dec. 3. It would run for more than 200 performances, closing after the leading man jumped from his fifth story hotel room, and return to Broadway in 1925 as the hit musical "No, No Nanette," produced and directed by Frazee. But it wasn't enough — Joe Lannin had called in his note on the Red Sox

Ruppert, a wealthy brewmeister and former congressman from the Silk Stocking District on the Upper East Side of Manhattan, was also in need of a new revenue stream. The Knickerbocker Brewery taps would go dry on Jan. 17 when the Volstead Act went into effect. Five years after purchasing the Yankees, he and Huston had only financial and competitive losses to show for their efforts. When Ruppert asked the team's manager, Miller Huggins, what he needed to win a pennant, Huggins had replied, "Get me Ruth."

Ruppert saw the future in the trajectory of Ruth's record-breaking 28th home run, an epochal clout that he hit against the Yankees; it sailed over the roof of the Polo Grounds' right field grandstand, coming to ground among weeds in an adjacent lot. No doubt The Times's account would have caught Ruppert's attention if only for its unaccustomed hyperbole: "Ruth stood firmly on his sturdy legs, like the Colossus of Rhodes, and, taking a mighty swing at the second ball pitched to him, catapulted the pill for a new altitude and distance

Ruth had scrapped and squabbled all season with Ed Barrow, the Red Sox manager. Barrow had resisted moving Ruth to the outfield, and then resented Ruth's refusal to pitch when needed, which was hardly Ruth's only act of insubordination. But when Frazee informed him of the sale, Barrow replied: "I thought as much. I felt it in my bones. But you ought to know you're making a mistake."

The full dimension of the error would not become clear until long after Ruth was done wreaking havoc on baseballs. In 2000, the economist Michael Haupert discovered the Yankee accounting books and ledgers from Ruppert's ownership languishing in unopened boxes at the Hall of Fame. A professor of economics at the University of Wisconsin-La Crosse, Haupert has since become the go-to guy on the economic underpinnings of the Evil Empire.

Frazee received a record sum of \$100,000 for Ruth — not \$125,000 as reported in The Times and The News — to be paid in four \$25,000 installments, the first in cash, and three promissory notes at 6 percent interest due every subsequent November. But Frazee never actually received the full purchase price. He was so hard up for cash, he sold the notes at discount — to Huston's bank.

On those terms alone, the sale would have been historic; the price was twice the record amount paid for Eddie Collins five years earlier. What made it "the greatest financial swindle since the purchase of the Louisiana Territory," Haupert said, was Ruppert's willingness to gamble \$300,000 of his own money in the form of a personal loan to Harry Frazee, who in return put up Fenway Park as collateral.

"Ruppert paid \$108,750 with interest," Haupert said. "Frazee borrowed \$300,000 at 7 percent a year, or \$21,000 annually. After five years, he had paid more than \$115,000 in interest out of his own pocket. And Ruppert had the deed for Fenway! He was a genius and Frazee was desperate. Bottom line: The Red Sox actually paid the Yankees to take Babe Ruth."

What's more: Ruppert got Frazee to pay half of the raise Ruth had demanded when, as an inducement, the Yankees promised to double his salary on the two remaining years of his Red Sox contract. Miller Huggins, who had been dispatched to California to woo the Big Fella, delivered the sweet news of fiscal suasion.

Even Ruppert could not have envisioned how much — or how quickly — his investment would pay off. "In 1920, Ruppert made back the entire purchase price and more," Haupert said. "Then Ruth continued to pay off for fourteen more years.'

The Babe generated unequaled public enthusiasm, and, Haupert calculated, \$137,975.52 - 17 percent of the Yankees revenues - as he made his way around the bases 54 times in 1920. The Yankees rewarded him with a bonus in his 1921 contract: \$50 for each home run. That was the year he hit 59, which added \$2,950 to his salary. Yankees management never made that mistake again.

In defending his decision, Frazee noted that Ruth had become a temperamental diva — "simply impossible," he said. The Atlanta Constitution sympathized, saluting Frazee for tolerating his star for as long as he had, a facility attributed to his experience in the theater. Frazee argued it would be "an injustice" to keep Ruth, called his home runs "more spectacular than useful" and lamented that the Red Sox were "fast becoming a one-man team."

In that sense, Frazee's judgment was acute. The sale of the century inaugurated a new business model in baseball: a big money star-system in which management made a capital investment in the mythology and marketing of a savior, whose personality and deeds provided the economic engine of success. "It marked the beginning of the age of the hero in baseball," Thorn said, "the idea of building a team around a single guy who belonged to somebody else." (That idea still holds sway, he added. To wit: Gerrit Cole, the Yankees' new \$324 million pitcher.)

Unlike Lannin, Ruppert did not call in his note, for \$300,000, when it came due in 1925, perhaps because the interest on it was better and because it was safer than any similar investment. "To give you an idea how this investment stacks up," Haupert said, "if Ruppert had put his \$100,000 in the stock market on the day he bought Babe Ruth, he would have made only \$17,000 thanks to the crash. Had he purchased \$100,000 of low-risk bonds he would have doubled his money by the end of 1934. Instead he invested in Ruth and doubled his money in two years, even after paying Ruth's salary and 6 percent interest.'

The loan would not be repaid in full until July 1933, four years after Frazee's death. By then, Ruth had worn out his body and his welcome with Barrow, now the Yankees club secretary. In a letter to F.C. Lane, the influential editor of Baseball Magazine, Barrow grumped: "He has always been, to my mind, greatly over-paid. I only hope the Colonel will stand pat on his offer of \$50,000 and call the big fellow's bluff about retiring.

The Big Fella did not retire, returning, increasingly debilitated, for two more seasons, before being released in February 1935. Over the course of Ruth's 15 seasons in pinstripes, the Yankees accrued \$3.4 million in profits, nearly 40 percent of which was directly attributable to the Babe. "That's a 1, 000 percent rate of return on Ruppert's investment," Haupert said. "A return so gaudy it's embarrassing."

If Cole offers the same results over his first nine years that Ruth did in his, Haupert added, Yankee profits will increase by \$2.1 billion. Gaudy indeed.

Letters to the Editor: HR 763

I agree that we must fight climate change in a way that benefits the economy and makes prudent use of taxpayers' funds; unfortunately, Bob Rodriguez's letter misstates several facts about the Energy Innovation and Carbon Dividend Act, HR 763, thus obscuring features of the bill he might find attractive. ("Bait and Switch," Letters to the Editor, 12/19/19)

Allow me to set the record straight:

HR 763 is proposed national legislation which will put a steadilyfamilies equally via a monthly dividend. In addition, it includes provision for border adjustments (tariffs) to protect American businesses and workers from unfair foreign competition.

HR 763 is a bill in Congress, not the California Assembly; Governor Newsom will have nothing to do with it and comparisons with SB 1

The bill will create, not destroy jobs: it is modeled on Carbon Fee and Dividend, a proposal from the nonpartisan volunteer group, Citizens' Climate Lobby. A study by the respected forecasting firm, Regional Economic Models, Inc. showed that a rising fee on carbon combined with a 100% dividend of funds raised would increase employment by 2.1 million jobs after 10 years and 2.8 million after 20, compared with projected job growth without the policy. The same study projected a cumulative increase in GDP of over \$1.375 trillion over 20 years, again against a baseline.

Mr. Rodriguez asks, "Do you honestly think you will get a dividend check from the government?" The answer is "yes," since the only use of carbon fees raised under the bill is to pay dividends and administrative expenses which are limited to less than 2.6% except for a five-year startup period when the limit is 8.6%.

Because all net funds raised will be paid out monthly to American families, they will not accumulate as they do in the Social Security Trust Fund: fewer funds means less incentive for the government to

The Energy Innovation Act will support American families as they transition to a clean energy economy by paying the full dividend to all adults with an SSN or TIN; those aged less than nineteen receive half shares. HR 763 does not redefine legal definitions of adulthood; taxpayers already report their number of dependents on Form 1040, so procedures to audit this and prevent fraud already exist.

The US has a precedent for an energy-based dividend: The State of Alaska, through its extremely popular Permanent Fund, has paid over \$20 billion to state residents; the big difference is that HR 763's dividends will reward American families for reducing fossil-fuel usage, not increasing it.

HR 763 is a market-friendly, nonpartisan proposal that has the support of prominent conservatives such as former Reagan Secretary of State George P. Shultz, republicEn.org founder Bob Inglis, and groups such as the Alliance for Market Solutions and Conservatives for Responsible Stewardship. The act will reduce carbon emissions by 40% over the next twelve years with greater reductions thereafter, in line with the rate of decrease that climate scientists regard as essential if we are to mitigate the worst impacts of climate change.

Seven in 10 Americans think global warming is real; six in ten understand that it is mostly human-caused, and 65% feel that it will

harm people in the US. In addition, 52% of Republican millennials feel that the government is doing too little to reduce the effects of climate change, a figure that will grow as climate change becomes more serious and its effects more visible.

Inaction with regards to climate change is not an option. I am grateful that my Congresswoman, Lucille Roybal-Allard, has joined seventy-five other representatives, including twenty-three Californians, to co-sponsor this important legislation.

Citizens' Climate Lobby seeks to engage in constructive dialogue rising price on carbon and return the funds raised to American with anyone who is concerned about climate change, liberal, conservative, or in-between. In this spirit, I hope that my explanation of selected features of the Energy Innovation Act responds to concerns expressed in the letter. In addition, I would respectfully ask Mr. Rodriguez: If you disagree with the Energy Innovation Act's approach, what solution do you propose to deal with the climate
