# Rives Mansion for sale again

Downey's most historic home hits the market for \$2.9 million, four months after the property was approved for a coffee shop.

**DOWNEY** - The sad saga surrounding Downey's most historic property has followed it into 2020, with the Rives Mansion having once again been listed for sale.

The mansion was listed in early December by Hudson Partners Investment Brokerage for what was described as an "aggressive" \$2.9 million.

This comes after a rocky year for the property in 2019, in which plans to refurbish and convert the site into office space were given the thumbs up, including the approval of a controversial 1,200 square foot retail café building that was to be developed in front of the mansion.

Despite significant pushback from residents, owners Arturo Concha and Erika De La Teja were able to persuade both Downey's Planning Commission and City Council to approve the café but with over 100 separate conditions.

Property records show the mansion was purchased in 2017 for \$1.25 million.

According to Jay Martinez of Hudson Partners, the mansion has been listed as "ready-toissue," which would likely mean that whoever purchased the property would pursue plans in accordance with what is currently permitted, including the retail café.

Martinez listed medical and executive type offices as among the viable options for the

Still, residents should not anticipate anything in the immediate future.

According to Martinez, the mansion has garnered sporadic interest since being listed, and he estimates that it could be anywhere from four to six months before any sale is finalized.

## Downey rental prices rise slightly

**DOWNEY** - Downey rents have increased 0.1% over the past month, and are up marginally by 0.6% in comparison to the same time last year, according to a study of rental prices released Tuesday by ApartmentList.com.

Currently, median rents in Downey stand at \$1,573 for a one-bedroom apartment and \$2,022 for a two-bedroom.

year-over-year Downey's rent growth lags the state average of 1.1%, as well as the national average of 1.4%.

Throughout the past year, increases have been occurring not just in the city of Downey, but across the entire metro. Of the largest 10 cities that Apartment List has data for in the Los Angeles metro, nine of them have seen prices rise.

# Downey doesn't know what it lost in Harold Tseklenis

Harold Tseklenis was an outspoken advocate for art and culture in Downey, even if his efforts were not always appreciated.


**DOWNEY** - It's impossible to write about Harold Tseklenis, who died on December 29, without writing about the city of Downey as well. They were as bound together and cinched as the loops in a Windsor knot.

Downey, once an orange grove and then a long-time pioneer outpost for adventurous flyboys, was full of vitality when Tseklenis, a recent MIT grad, arrived in 1959 with his young wife Anna to find it at the resurgent forefront of aeronautical science and technology, as it had been during WWII.

There are generations now that have no memory of the Cold War and the Soviet Union, of Premier Nikita Khrushchev banging his shoe on his desk at a United Nations assembly and yelling, "We will bury you!" and a binary planet in which East and West glowered at each other across a metaphoric Iron Curtain, their cautious geopolitical chess moves underscored by the very real fear of nuclear annihilation.

After the Soviet launch of the spacecraft Sputnik in 1957, however, the U.S. went into scramble mode, not just to dominate the space race, but to develop missiles and aircraft lethal enough to pose as military deterrents.

That was the backdrop but not the complete reality of sunny Southern California, whose Mediterranean climate was like the nectar of the gods to Tseklenis, who was born in

# Harold Tseklenis was an advocate for culture

For most of his adult life Tseklenis worked for the Fluor Corporation, traveling the world as a combined project manager, civil engineer and specialist in liquid natural gas technology. But his earlier life in Boston, with its abundance of universities, museums, art galleries and music groups like the Boston Symphony and Boston Popsand its New England root in philosophy American literature—deeply informed his cultural sensibility. His Greek origin had already shaped him as a man of the polis, the classically idealized city state, whose every citizen is morally obliged to try to perfect.

These are the unique qualities he brought to Downey, where he easily gained social and cultural prominence. He was an ardent supporter of the Downey Symphony, and served on its board. He vigorously supported the Downey Museum of Art. He was instrumental in the creation of the Art in Public Places program, in which developers of new projects were obliged to devote a small portion of their profits to the funding of public art. We became friends, attending city council sessions, meeting at Mimi's for lunch to compare notes. With the gradual loss of the aerospace industry culminating in the '90s, Downey started to drift away from its core identity. So did its unimaginative civic leadership, which began to parcel out its lands in ad hoc deals with franchise outfits

and developers. The scruffy old Vultee airfield, eventual home of the X-15 and the Apollo spacecraft, not to mention the test center for a hefty potion of the American aviation industry, was converted into a couple of shopping malls.

The Downey Art Museum, the oldest of its kind in Los Angeles County, was shuttered over a hissy fit between a publicist and the woman who ran it and lost her home trying to save it. Guerra, a uniquely vindictive public figure, insured that it would never reopen, even after a letter from then-state attorney general Kamala Harris found that there was no legal reason for it to remain closed.

The Art in Public Places program was raided for projects that have nothing to do with public art, like the absurd and embarrassing marquee sign on the Avenue Theatre, which will now house a pizza joint and midlevel restaurant and pub the avenue doesn't need. ## How I will remember Harold Tseklenis

Not since John Hume, has one individual had such a significant impact on the arts in Downey. That gentleman was Harold Tseklenis, who passed away on December 29.

From the birth of the public non- profit arts movement across America, and then for the next six decades he unceasingly championed public access to the arts in Downey. He was knowledgeable about the arts, and he knew successful models that other cities were implementing.

He devoted himself to civic causes too. But it was his leadership, vision, passion, for the arts, and art organizations that is imprinted forever on this city. The Downey Symphony, Downey Museum of Art, Downey Civic Theatre, Downey Arts Coalition, Arts In Public Places, are just a few.

He dreamed of a citizen's Downey Arts Commission. An intimate public access theatre for contemporary plays. Converting the city-owned Avenue Theatre into an independent and foreign film theatre. An art's cafe as a community hub. And more. To Harold, the possibilities were endless.

I last met him at a physical therapy session. He was very tired. But his eyes lit up when he saw me. His impression was that he had been labeled anti-city by the forces that be. Nothing could be further from the truth. But Harold was known to speak out. He didn't flinch. He took on local and state bureaucrats. And he challenged anyone who said it couldn't be done. In the melodrama of local politics it's easy to get labeled.

But that day, as we talked about the future of the arts in Downey, there was a twinkle in his eyes. That is the Harold Tseklenis that will be in my heart forever.

Downey Unified has had 14 receive this honor, these schools include: Warren High School (2013); Alameda, Price, Unsworth and Ward elementary schools (2010); Carpenter, Rio Hondo and Unsworth elementary schools (formerly Stauffer West) Middle School (2005); Old River, Pace and Rio San Gabriel elementary schools (2004); Doty (formerly East) and Griffiths middle schools (2001).

Distinguished School awardees represent examples of not just excellent teaching, learning, and collaboration, but also highly successful school climate efforts ranging from real-time conflict resolution to positive behavior intervention.

Schools Program took a hiatus from 2015 to 2017 due to the and accountability systems.

During this time, the California Gold Ribbon Schools Award was created to have a program focused on honoring schools while the designation of Distinguished School was unavailable. Over this three-year break, Downey Unified had at least one school selected for this award each year. These schools include: Doty Middle School and Warren High School (2015), Old River Elementary (2016) and Griffiths Middle School (2017).

# Joe Biden's flawed foreign policy resume

Joe Biden is picking up speed in Iowa and New Hampshire polls as the clear Democratic primary front-runner, yet President Donald Trump just threw a wrench — or a drone — at his foreign policy record. The president's assassination of Iran's top military commander in Iraq cracked open a messy egg in the Middle East, even as he awaits a Senate impeachment trial.

Trump's New Year's resolution for 2020 seems to be: Make tomorrow worse than today. He did not even consult with Congress on striking Gen. Qassem Soleimani. Iraq now wants all Americans out of the ravaged country. This would constitute a "lost war" — just like Vietnam, only longer. All in a day's work from Mar-a-Lago.

The crisis raises questions about who in the Democratic field can quell the fury and anxiety Trump causes in our enemies and allies. At 77, Biden is perceived as a steady, experienced hand, a line he is pressing hard.

"These events put into greater relief that we need a commander-in-chief who can, from the moment they're sworn in — and without needing on the job training — start repairing the severe damage that Donald Trump has done," a campaign spokesperson told The Daily Beast.

That's malarkey.

Biden's rusty foreign policy resume is a mile long, but it's not what you'd expect from someone who passes as a statesman with 35 years of senatorial experience. In a word, it's amateur. As vice president, Biden advised President Barack Obama against the successful Pakistan raid on Osama bin Laden.

Biden's old, but he was never wise — just an average Joe, truthfully. A good fellow folks like, especially in small town Delaware.

Most central to the fix we're in now, Biden voted for the Iraq War in 2002, after the Sept. 11 terrorist attacks, based on the falsehood that Iraq was hiding weapons of mass destruction. Nancy Pelosi, D-Calif., later House Speaker, did not fall for that George W. Bush claim. It took courage and foresight to vote against that war of aggression. Only 23 out of 100 senators possessed that wisdom. Few are in office now.

That chain of events set the whole century off on a dark note. If the 21st century had been a Broadway show, it would have closed by now. The Iraq War was a tragedy costing trillions of dollars, hurting our good will and place in the world. It depleted the Army on a mission that soldiers came to question.


Like it or not, Biden bears a brunt of the blame for the Obama administration's failure to bring the wars in Afghanistan and Iraq to a swift, clean close as promised. These conflicts were left hopelessly undone for over eight years.

Note the genial, garrulous Biden was the Senate Foreign Relations committee chairman and traveled the globe for years, living the high life with world leaders. As vice president, no doubt he was an affable emissary.

Yet he failed to tell his son Hunter that taking a plum place on a Ukraine gas company board was poor judgment — for both of them. That may be an Achilles' heel if he becomes the nominee. Trump will gnaw at that issue, which Biden has been loath to confront.

I covered Senate Democrats as a rookie reporter and found Biden talked the longest but said little of substance in floor speeches. As a freshman senator, Obama felt trapped in a committee hearing during an endless Biden soliloquy and wrote a private note: "Shoot. Me. Now."

Yet rising star Obama picked Biden as his running mate in 2008.



Sen. John Kerry, who, as secretary of state, negotiated the Iran nuclear deal, would have been the best pick for his eloquence, expertise and work ethic.

Don't just take my word for Biden's weak, even inept, grasp of complex foreign policy. Take it from a man who sat in the Situation Room and the Cabinet Room, side-by-side with the vice president.

Obama's secretary of defense, Robert Gates, declared publicly in his memoir that Biden has "been wrong on nearly every major foreign policy and national security issue over the past four decades."

Boom. Biden's a nice guy, but he's already done his dance with

During the President Trump impeachment "testimony," legislators tried to score points. At least five times, Rep. Adam Schiff, D-Calif., shut down criticism by shouting, "Gentleman is not recognized!"

I get that politicians are eager for "face time" in front of a larger audience, but I assumed they would at least try to learn things. Nope.

Maybe they don't want to ask real questions because they fear looking as dumb as then-Sen. Orrin Hatch, R-Utah, did at a hearing on Facebook. He asked Mark Zuckerberg, "How do you sustain a business model in which users don't pay for your service?"

"We run ads," smirked Zuckerberg. "I see," said Hatch.

What's obvious to most people somehow eludes the oblivious "experts" in Congress.

At another Facebook hearing, Congress grilled Zuckerberg about his plan to launch an electronic currency called Libra. Zuckerberg said, "I actually don't know if Libra is going to work, but I believe it's important to try new things."

He was right. But instead of asking about technological or economic implications of the idea, Rep. Al Green, D-Texas, asked Zuckerberg, of the companies partnering with him, "how many are headed by women?"

One of the louder Rep. Alexandria Ocas

"Congressman, I do not know the answer," replied Zuckerberg

"How many of them are minorities?" asked Green. "Are there any

members of the LGBTQ+ community?"

Green doesn't want to learn anything. He wants to sneer and score points.

Politicians' sloppy ignorance is extraordinary. Rep. Steve King, R-Iowa, grilled Google CEO Sundar Pichai about iPhones, citing a story about his granddaughter using one, leading Pichai to explain, "Congressman, iPhone is made by a different company."

Today's posturing is not what the founders had in mind when they invented hearings in 1789.

George Mason said members of Congress "possess inquisitorial powers" to "inspect the Conduct of public offices."

Yes! Investigate government.

But today, they are more likely to threaten CEOs and bully opponents.

"Are you stupid?" then-Rep. Darrell Issa, R-Calif., said to one witness. They want to showboat, not learn. Often, they ask questions even when they know the answers.

"Ms. DeVos, have you ever taken out a student loan?" asked Sen. Elizabeth Warren, D-Mass., of Education Secretary Betsy DeVos. "Have any of your children had to borrow money?"

Warren knows that DeVos is a billionaire, but she wanted to score points with her fans.

One of the louder showboaters today is self-proclaimed socialist Rep. Alexandria Ocasio-Cortez, D-N.Y. She asked Wells Fargo boss Tim Sloan, "Why was the bank involved in the caging of children?"

"We weren't," replied Sloan.

Some of today's hearings are useful in that we get to see how absurd and ignorant our representatives can be.

During a hearing on military personnel being stationed on the island of Guam, Rep. Hank Johnson, D-Georgia, said, "My fear is that the whole island will become so overly populated that it would tip over and capsize." Really. He said that.

## Police plan bicycle and pedestrian safety operation

DOWNEY - The Downey Police Department will take part in a bicycle and pedestrian safety enforcement operation aimed at educating bicyclists, drivers and pedestrians on traffic laws, rules and responsibilities.

Throughout the month of January, officers will be looking for violations made by bicyclists, drivers and pedestrians that put roadway users at risk. These violations include drivers speeding, making illegal turns, failing to yield to pedestrians in crosswalks, failing to stop for signs and signals or any other dangerous violation.

Officers will also look for pedestrians who cross the street illegally or fail to yield to drivers who have the right of way. Bike riders will be stopped when riding on the wrong side of the road, not complying with stop signs and signals, or other violations of the same traffic laws that apply to them as drivers.

"Whether you are on foot, behind the wheel or on a bike, you play a part in roadway safety," Chief Dean Milligan said. "Understanding the rules of the road using all modes of transportation helps ensure we all get to our destination safely.'

In 2016, 138 bicyclists and 867 pedestrians were killed on California roads. Pedestrian fatalities are up nearly 33 percent from 2012, and the number of bicyclists killed is up nearly 25 percent over the past five years.

In 2018, the Downey Police Department investigated three fatal and 70 injury collisions involving bicyclists and pedestrians.

People walking should only cross the street using crosswalks or intersections, preferably with a stop sign or signal. People on foot should also look for cars backing up and avoid darting between parked cars, make eye contact with drivers and wear bright clothing during the day and reflective materials or use a flashlight at night.

All bike riders are reminded to always wear a helmet; helmets are required by law for those under 18. Bicyclists must travel in the same direction of traffic and have the same requirements as any slow moving vehicle.



Bipolar disorder can be devastating. Previously known as manic depression, it is a mental health condition that causes extreme mood swings.

Bipolar disorder almost six million adult Americans, or about 2.6% of adults in the United States, and roughly 60

million people worldwide. It most typically starts at around the age of 25, although it can begin in early childhood or as late as the 40's and 50's. It affects both men and women, and crosses all races, ethnic groups and social classes.

There are three major symptoms: depression, mania, and hypomania.

When the mood shifts to mania, they experience an emotional high. They can feel excited, impulsive, and euphoric, have rapid pressured speech, difficulty focusing, and be full of energy. Due to this high energy, they will sleep little. They will likely be irritable and impulsive, and use poor judgment. Behaviors may include spending sprees, unprotected and frequent sex, and drug and alcohol use.

Hypomania is generally associated with bipolar II disorder. It is similar to mania, but not as

Episodes of mood swings may occur rarely, or happen multiple times a year. Depression tends to last at least two weeks. Mania can last for several days or weeks. It is possible to feel normal in between episodes. Those with bipolar disorder may very likely have trouble managing everyday

While the condition is seen in equal numbers between men and women, the symptoms may differ. Women tend to be diagnosed later in life, have milder episodes of mania, experience more depressive episodes than manic episodes, experience other conditions at the same time (such as thyroid disease, obesity, anxiety disorder and migraines), and have a higher lifetime risk of alcohol

Men with bipolar disorder are often diagnosed earlier in life, experience more severe episodes (especially mania), act out during manic episodes, have substance abuse issues, and seek medical attention less often. They are more likely to attempt suicide.

Bipolar disorder is a lifelong condition, but a treatment plan of medication and counseling can help to manage mood swings and other symptoms. Mood stabilizers, antipsychotics, antidepressants, and anxiety medications may all be used for treatment.

Bipolar disorder is common, but what causes some people to develop it and not others is still a mystery. There is a strong genetic link; those with a family history of bipolar disorder are four to six times more likely than others to develop it. Stress, traumatic experiences, and physical illness may trigger it.

If you think that you're experiencing symptoms of bipolar disorder, I urge you to see your doctor. If you feel that a friend, relative, or loved one may be suffering from it, your support and understanding are crucial. Encourage them to see a doctor to discuss any symptoms they're experiencing.

# How Downey plans to celebrate Beethoven's 250th birthday

An interview with Downey Symphony conductor Sharon Lavery ahead of its Jan. 18 concert at the Downey Theatre.

**DOWNEY** - "I won't be surprised when our audience members leap out of their seats for a standing ovation," said Music Director Sharon Lavery. "The Emperor Concerto of Beethoven belongs as the musical climax of the evening. For pianist Sung Chang, and for the composition itself and our orchestra's performance."

All the world is enthused that the year 2020 marks the 250th birthday of one of classical music's giants. The Downey Symphonic Society is presenting a concert that shows its own take on Beethoven's genius, and Music Director Lavery is concentrating on the interplay between the man's works and the orchestra that performs them.

"No composer labors so hard to stave off boredom, to occupy the mind of one who might be hearing or playing a particular piece for the tenth or the hundredth time," said Alex Ross in the New Yorker. "It was

Called the most difficult of all existing concertos, the Emperor's piano soloist in the Vienna premiere in 1812 was Beethoven's protégé, Carl Czerny. Yes, that Czerny.

Today's concert-goers who studied piano as beginners and intermediates will remember Czerny's yellow-covered book of exercises for practicing scales and arpeggios.

The Emperor is the concerto that Lavery predicts will lift the audience right out of their seats. A showpiece for the piano, it also tests and lifts the orchestra's response, because with the Emperor, Beethoven created a truly symphonic concerto. The first movement opens with a grand E-flat chord for the full orchestra, interrupted by a series of equally commanding arpeggios for the piano.

After a dreamy adagio second movement, the third and final note B drops a semitone, with a sudden change of color, to B.

After a glorious orchestral rondo with the piano showing off its virtuosity, the piano then performs a passage of arpeggios, or broken chords. But rather than finishing with a strong entrance from the orchestra, the trill ending the cadenza dies away. The piece ends with a short cadenza, or improvisation, by the

his mouth was twisted, distorted like the subject in Munch's painting, The Scream. His face was white and pasty like of Elmer's glue.


She almost felt sorry for him until she saw the black wallet on the grass beside him. The Slime tried to speak again before his face turned green and puked the same color.




