Summer Olympics pushed to 2021

Japan's Prime Minister Shinzo Abe and International Olympic Committee (IOC) president Thomas Bach agreed Tuesday to postpone the Olympics by about one year.

Abe put the suggestion to Bach, who agreed that the latest date the Olympics will be held is summer 2021.


The IOC has been facing mounting pressure to delay the Games, which were originally scheduled to take place from July 24 to August 9, amid the novel coronavirus outbreak.

The Olympics have never been rescheduled in peacetime. In 1916, 1940 and 1944, the Games were canceled because of world wars.

On March 17, Japan's Olympic minister Seiko Hashimoto said the country was planning for a "complete" hosting of the Games, which she went on to explain meant an Olympics which "started on time and with spectators in attendance."

Then late last week, the IOC said that it was considering a number of different options including a postponement or modifying the Games so they could still take place as scheduled in July.

There had been growing opposition to hosting the Games as planned as countries attempt to spread the limit of the coronavirus, which has infected more than 381,000 people

Australia and Canada both announced they would not be sending athletes to Tokyo this year, and — along with the likes of USA, Germany and Poland called for the Games to be postponed until 2021.

Sporting bodies, including USA Track and Field and USA Swimming, also called for a postponement.

Meanwhile, athletes who have been unable to train due to closed facilities and restricted access to coaches and training partners have also voiced opposition to the Games proceeding as planned.

Sporting events across the globe have been suspended amid the virus, with Euro 2020 being moved to next year.

The financial implications of postponing the Olympics could be huge.

The cost of hosting, organizers said in December, was some 1.35 trillion yen (\$12.35 billion) but, according to Reuters, that figure did not include the cost of moving the marathon and walking events from Tokyo to Sapporo to avoid the summer heat.

Although an exact one-year postponement to July 23-Aug. 8 is possible, the Tokyo Games don't have to open in July.

Coronavirus proves we need Medicare for all

For decades, critics of single-payer health care have raised the menace of rationed care, long waits, and "death panels."

Now, in our collective national effort to "flatten the curve" to slow the spread of coronavirus to prevent hospitals from being overwhelmed — we are seeing all three of these rumored pitfalls of "socialized medicine" in our for-profit system.

After all, the entire point of "social distancing" is to ration available care. Meanwhile hospitals are postponing elective surgeries, and hard-hit places like Washington State are discussing plans to determine who gets critical care at ICUs and who will be turned away.

officials spread false information, claimed they had contained the virus to a few individuals, and refused World Health Organization offers to help the U.S. develop its own COVID-19 test.

Since then it's taken more aggressive steps. But in the long term, it would be better to put in place a system to prevent and address crises before they threaten to end life as we know it.

It is too early to say which countries will prove most successful in containing the virus, but there are indications that those with single-payer systems have the advantage.

As Helen Buckingham of the Nuffield Trust told the Washington continue to receive bills for a 50-minute preventative care check-up. Post, the U.K.'s National Health Service is well-positioned to cope. It has a clear and comprehensive emergency planning structure with the ability to optimize resource use, even after years of government budget cuts.

Federalized health care means centralized patient information. As Kelsey Piper reported for Vox, Taiwan's ability to get information quickly from citizens' medical files, combined with proactive containment, enabled testing for the virus as early as December. Despite high traffic with mainland China, Taiwan only had 45 confirmed cases of the disease and one death in early March.

Similarly, South Korea's aggressive testing and universal coverage At first the federal response to the pandemic was slow, as public helped the country "flatten the curve" more effectively than any other so far

> Importantly, single-payer health systems are far less costly. At over \$10,000 per person each year, Americans spend far more on health care than any other wealthy country, yet our life expectancy is lower. Because of these out of control costs, many of us avoid going to the doctor altogether — another form of rationing.

> For example, my last trip to the gynecologist was so expensive, due to both improper coding and an in-network test sent to an outof-network lab, that I have yet to go back. A year and a half later, I

Avoiding the doctor for fear of the cost is bad in the best of times, disastrous in a crisis like COVID-19, and unheard of in places with single-payer care.

Certainly, single-payer is not a magical solution: Italy has a federalized national health insurance system similar to Canada's, and its northern regions are overwhelmed by the outbreak. But Italy's leadership was slow to recognize the pandemic and communicate that reality to its citizens.

Yet the rapid response in other European and Asian countries shows that, though single-payer systems are not a cure-all, they are able to better prepare these countries with clear emergency protocols, efficient information collection, and free access to care.

Rationing care, long wait lines, and "death panels" aren't what awaits us in a socialized system. They're hallmarks of our failed forprofit system, which is simply not up to the task of providing for our public health.

If we continue to put our political and economic ideologies ahead of our health, we stand to lose everything.

What 9/11 can teach us about today's crisis

On the morning of September 11, 2001, my colleagues and I handed out water on Lower Broadway. We were lawyers who served some of the poorest communities in New York, but quenching the thirst of stunned victims proved to be the best thing we could do at the time.

In the ensuing months, we learned a lot about emergency response and the ways a city's civic infrastructure should respond to a crisis. We used our legal expertise to assist thousands of New Yorkers get back on their feet.

In the process, we learned lessons about what the community's needs were and how to pull different sectors together to meet them. These lessons could not be more important as the Covid-19 pandemic spreads.

First, a lot of people will need help — a lot of it.

Aside from a looming public health crisis, the toll on the economy will be devastating. People will lose their jobs, get their hours slashed, and businesses will close their doors forever. This will have ripple effects throughout the economy.

People who never imagined they would file for unemployment or other benefits will find themselves forced to navigate an alien bureaucracy. Existing systems will be pushed to the breaking point, and will not be adequate to address the need. We will need to find

new resources and new means and avenues of support.x

Second, we must be generous. Benefits and assistance must be easy to access and navigate, and existing programs - not just unemployment — will need to be expanded.

In the wake of 9/11, millions of generous Americans supported the September 11th Fund, which was administered by the New York Community Trust and the United Way of New York City. Not only did that fund assist families who had lost loved ones, but also individuals who were left in economic ruin that day.

A similar philanthropic effort, coordinated by charities across the country, will be needed in the current pandemic, and we should get a fundraising initiative underway immediately. Prominent philanthropies like the Ford and Rockefeller Foundations could provide critical infrastructure support to local foundations that are closer to the need.

Third, nonprofits are going to get hammered, twice. They are going to face increased need for their services, while losing support from donors precisely when those services are needed most. Across the country, nonprofits are already having to cancel and postpone fundraising events.

Emergency relief for frontline non-profit organizations responding to community needs must begin to flow immediately,

before it is too late. Anyone making regular gifts to nonprofits should continue for as long as possible. And any philanthropic effort to support the direct victims of the virus should also provide financial support to the non-profits that will serve them.

Finally, we need to cooperate across sectors. One of the most important successes of the 9/11 response was that the government, non-profit, philanthropic, and private sectors all worked together.

Survivors were able to go to centers to meet with a wide range of service providers from public and nonprofit entities. Volunteers from private sector businesses provided critical assistance as well, and foundations supported such efforts. This kind of cooperation will again be critical, though such "centers" will have to be virtual.

The full impacts of the pandemic can't be known yet — but we've been here before in some ways.

How Americans came together after 9/11, with the generous support of each other and concerned citizens around the world, can help chart a course forward through these unsteady and terrifying times.

My local health food store is sold out of colloidal silver but you can order it online. The stock in the store will be replenished within the week. Chewable Vitamin C and chewable zinc are also gone. Many people your pocket or purse when you venture out. And please venture out. Fresh air and sunlight kill germs and revive the spirit. And walking will keep your body vital. Plus, for most people, any time away from their family is healing

I spray my face and throat with colloidal silver and suck the chewables while I am in public. But if you don't need groceries and such, just walk around the block.

If the hospital is overwhelmed, if whatever treatment they will use for this is in short supply, and you find yourself in need, be logical not hysterical. Instead of hoarding toilet paper (which actually would be good for spitting up the mucous from your lungs or blowing the mucous from your sinuses), keep a package of Benadryl on hand. Keep a package of Musinex on hand.

There is no need to hoard Benadryl, this is just a tool to prevent you from declining quickly. The recovery rate from this virus is far greater than the death rate. It is not unreasonable to compare it to the flu -which you have survived before -- though the rates are higher. Do not think this is a death sentence.

Alkalyze. I have been preaching this forever, especially during cold and flu season. Germs don't live easily in an alkaline environment. One plain Alka Seltzer (Gold, not Cold) or baking soda in hot water (pour slowly) should be taken throughout the day. Add one Airborne tablet and an inch of lemon juice if you are feeling down or alkaline-challenged (stressed). Add honey for a sore throat. Add whiskey for hope.

Hysteria and ignorance -- the mainstay diet of America -- will not help anything. Get out of both.

Our parents survived restrictions greater than what we are now under during the great wars, and they did it for years. How long has the quarantine been? Twelve days? And people are already thinking it's the end of the world.

This is our time to grow up. Grow up. Make some homemade soup and we will survive this together.







How are businesses coping with COVID-19? Depends on the business

Downey businesses try to adjust as coronavirus wreaks havoc on the local economy.

DOWNEY - For many of Downey's businesses, the fallout of COVID-19 has proved to be less black and white, closer resembling the good, bad, and the ugly.

Businesses are being forced to make serious decisions as to their future in the wake of the coronavirus.

"This is essentially what we find is the best way to create value for our members, and not have them - if they're struggling, if they're not working - I don't want anybody to have to pay their memberships if they are unable to receive the resources."

In the meantime, each of the Academy's members have had their accounts suspended, meaning they will not be billed and will be credited the time that the studio remains shuttered.

For Carlos Galvan Jr. and the Amapola Market, however, COVID-19 has been a completely also seen an uptick in sales.

"The volume has been very heavy," said Galvan, SVP/CFO of the family-owned market. "We haven't had the long lines to get into the store...but we do have lines for specific products. The water and the toilet paper, obviously, that the first stuff that

flew off the shelf." "Now we're starting to see other staple items for us tortillas, fresh meat - we're having a hard time keeping the inventory going, but we're finding a way."

Stocking is getting tricky now, however, as Galvan says that many of the vendors and distributors he works with are "working overtime," and certain things are beginning to be back ordered.

"Water for example, that's kind of at a premium right now,' said Galvan.

Amapola's hot foods have

"That's something that has increased our sales, but you need supplies," said Galvan. "We have to have the produce – tomatoes, onions - all those things to make the food and the meat. You know, it's kind of a dual-pronged challenge."

Like many other markets nationwide, Amapola has been forced to start to limit the number of certain items that customers can purchase.

'On the essential items like milk and eggs, we have limited that. In our other stores where we sell bulk rice and beans, we've had to limit to 3 pounds per customer just to make sure we have enough," said Galvan. "Obviously if we get water, it'll be one case per customer."

Amapola has also adjusted its hours to help accommodate senior-aged shoppers, for however, are also trying to limit the number of individuals in the store at once.

"Now that we've adjusted our hours, especially during those early hours where we're allowing seniors in, to only bring in one person to accompany them because we don't want the store full of people during a time where we're trying to accommodate our seniors."

COVID-19 has been particularly brutal on the foodservice sector, as government mandates whittled down restaurants from full-operation, to limited occupancy, to take-out only in seemingly no time at all.

"We're not that style of place; into the future. we're not Chick-fil-a," said

Shelton. "We're in everybody's head as far as 'let's go over there and have a good time, relax, and let loose a little bit. We're not the 'let's take this home because I don't want to be here' type thing. That's a thing for us that makes it kind of hard, is that we can no longer create an experience for our guests."

Alcohol service is also at a complete standstill for Lock and Key.



While many restaurants have tried to take this blow in stride, one prominent Downey Avenue staple is struggling to maintain momentum.

According to Marc Shelton, owner of Lock and Key Social Drinkery, his restaurant saw a rapid decline over the weekend.

"Thursday last week, we were busy. Friday, it wasn't what we normally were - instead of being an hour and a half, two hour wait, we had a 45 minute wait - but we still did good numbers and we were staying alive. Saturday came around, not a problem," said Shelton. "Come Monday though, there's a big hit. Sunday night we were still viable, we were still a business that could continue to stay alive, but once they started making these mandates of no dine-in and no everything else... there's still no writing on the wall to see really what's going to happen."

Shelton believes that many businesses in the city will be forced to close forever, and he fears that Lock and Key might be in that number if the situation doesn't change soon.

"Restaurants pay their bills, basically we're a month behind always," said Shelton. "We pay January's bills with February's dollars, and February's bills with March dollars. We don't have those dollars coming in right now."

Shelton has even gone as far as to provide his staff with important links – such as unemployment – just in case the worst-case scenario occurs.

He added that curbside only service is not necessarily conducive to his establishment, as Lock and Key – known for things such as their tomahawk steak that went viral and their "fyre burger" which they set on fire – is a "destination restaurant."

Shelton does have a license to sell beer and wine to go, and he is even considering venturing into the sale of unprepared frozen protein. Yet, there is still an element of uncertainty heading





DOWNEY — The Downey City Council on Tuesday gave the goahead for Verizon Wireless to place a cell tower at the city's public works maintenance yard.

Hailing from Downey and starting their careers playing on the Santa Monica Pier, Liliac has made waves as some of the brightest up-and-coming bands in hard rock.




