After-school music and sports classes drop by 95%

■ Enrollment in afterschool classes offered by the Downey Foundation for Educational peaked last year before the pandemic struck.

DOWNEY — The popular after-school music and activity programs for Downey elementary school students are another casualty of the coronavirus pandemic.

Participation in the extracurricular classes, which had grown to over 2,000 students in just three years, plummeted this fall to only 115 attendees according to Laura Hurtado, Director of Programs for the Downey Foundation of Educational Opportunities (DFEO).

"We went from 13 elementary schools having possibly four to five classes each, to one class [in some subjects] for the entire district," Says Hurtado. "So, it's been a very significant cut for

DFEO, known for its smallgroup violin and guitar lessons, was founded in 2017 by PTA parent Linda Saldana, current Executive Director, as a way to make weekly, affordable music lessons available to all students even first-graders.

"I am passionate about music and the arts," says Saldana, whose three children all play an instrument. "I wanted all children to have this opportunity."

Parents pay a weekly fee for the small group lessons that include child-size violins. Classes are held at school sites, music instructors are college students who follow a set curriculum, and community organizations provide additional financial support.

The response from area parents was so positive that the program expanded to include visual arts and classes for soccer and basketball skills.

The ninety-five percent drop in student participation this fall is not surprising given that Downey Unified School District campuses remain closed for in-person instruction until the health crisis abates.

Rather than suspend its program completely during the pandemic, DFEO chose to resume classes this September in an online format similar to that of the District's.

Aided by a grant from LA County Department of Arts and Education, the nonprofit actually added classes designed to meet the needs of families struggling from the circumstances presented by the pandemic.

Hurtado describes a fitness class created with smaller students in mind for parents who "wanted their children to be able to move and exercise while being quarantined and distance learning at home." A ukulele class was also added to the early music program. And instead of SAT classes, DFEO offers tutoring for small groups of three to five students (elementary through high school).

Altogether, there are currently twelve classes covering a wide range of activities listed on the DFEO website. In addition to music and sports, online programs via Zoom include theater, dance, and visual arts.

Saldana, whose eight-yearold participates in a basketball skills class, encourages families to consider some of the afterschool classes in their new format.

"It gives them [the students] one more thing to do and look forward to. It's not sitting on your bottom writing," she explains. "We were able to pilot this during the summer," says Hurtado, "and we received over a hundred students and that has been consistent now in the fall."

Given that DUSD students are currently receiving all of their school instruction via distance-learning, DFEO incorporated some beneficial design changes into its programs.

Smaller Class Sizes

"We were able to cut the classes in half so that the quality of the class remains the same," explains Hurtado, "and all of the students still have an opportunity to ask their questions, talk to the teacher, as well as each other."

Downey sixth-grader Deven Anderson re-enrolled for DFEO's soccer skills class this school year, even though it is now on Zoom. Deven says his goal is to play soccer for Doty Middle School when DUSD campuses reopen.

During school hours, Deven alternates time spent video-conferencing with his teacher and asynchronous learning activities which he does at his own pace. After school, the DFEO soccer program involves more computer time, but Deven is physically moving and he can see other participating students in real time as well as his coach.

"I have to give the kids credit," says his mother Paula Paz, who works at home while also keeping an eye on the distance-learning regimen of her four children. "As adults, we may not always realize that they're doing as much as we are. They are little people with big emotions."

All DFEO programs are operating, says Hurtado, with at least one class for each subject. Some of the older programs such as violin and guitar, which are now entering their fourth year, have multiple classes.

Fees remain the same, but Hurtado says, "We still have limited financial aid for those families who want to participate and could not afford it for any reason."

Hurtado says it is not too late for interested families to register their students. Additional students who sign up are added to a wait-list, and new classes will continue to open when a wait-list reaches a minimum number.

Zooming

Despite widespread business closures and people out of work, Hurtado and Saldana attribute multiple causes to the striking drop in attendance, and not all are related to financial concerns.

Many parents have various questions about the Zoom format. Is it effective? Are the children spending too much total time on the computer already?

Saldana reports conversations with parents who tell her classes are not the same on Zoom; children miss being with their friends, and some parents themselves feel unable to help their child.

Saldana understands their frustration. "I know I'm overwhelmed as a parent of three, trying to coordinate their classes and their Zoom meetings, and did they do their homework, and which programs are they using?"

Nonetheless, Saldana feels the after-school classes which focus on sports and movement are especially valuable to younger children during this time. She said the activities are designed to be done in a variety of spaces, whether it's a backyard or a park, with a minimum of equipment, and she shares the experience of her eight-year-old son.

"Isaac was in the patio,"
Saldana describes. "We put my
laptop there, we plugged into
Zoom, with the coach and about
seven other kids. And the coach
was so engaging! 'Okay, Isaac,
let's see you dribble that ball.

Wow, that's great! Okay, now it's Mario's turn. Mario, let's see you!"

Watching her son from inside, Saldana recounts, "He's bouncing and looking at the computer screen. And you know, he's having a good time. He loved it! He was like, 'I can't wait for next week!'"

Another challenge to rebuilding enrollment in the DFEO programs is the limited connection that the non-profit now has with parents because the campuses are temporarily closed to in-person instruction.

"We are not able to promote directly on school sites," says Hurtado, "so those families who don't have social media, or are not on our newsletter, who are new families to us or to the school district, no longer sign up."

"We've asked the principals to send out messages through their social media or their emails," says Saldana, "but honestly, parents are really inundated with information right

Additional Closures

In addition to restricting DFEO's after-school programs, the pandemic also brought a sudden halt to two other programs that were both firsts for Downey students.

Recognizing the deep interest and support among Downey families for music lessons, DFEO organized the first ever Downey Youth String Ensemble that met for additional practice on Monday nights at the Warren High School music room.

"Our Monday night strings program had about twenty-five violinists and three cellos," recounts Saldana. Downey musician and composer Lars Clutterham was the conductor and arranger. The Ensemble first performed publicly in December 2018 at Downey High School.

"There's just no way we can meet in person like that right now," says Saldana. "It's just been put on hold, and it will take a while to rebuild when we do come back."

Also canceled this school year was the first ever science camp trip for all DUSD fifthgraders to local mountains. Science camp is a culminating event for elementary students in many other districts, and it was Saldana's vision that Downey students would have this opportunity as well.

DFEO had successfully piloted the fifth-grade science camp program with some of the schools last year. Cost to each student for the three-day, two-night trip was fixed at \$235. Students would receive information towards

the end of fourth grade so their families could plan; fundraising opportunities and savings accounts would be set up for families who might have trouble meeting the cost.

This school year, 2020-2021, was to be the first year that all DUSD fifth-graders would be able to go, and dates were confirmed for this coming January/February.

But when the pandemic shuttered schools and businesses in March, DFEO was not able to share with parents the description of the science camp, its schedule, and the opportunity for savings accounts.

"Even if schools and businesses reopened by January," Saldana laments, "there's no way we could possibly be ready to go and the kids have saved money, so we just had to completely put everything on the shelf this year."

Lunch Program

While DFEO's efforts have been mainly focused on learning opportunities for students, its mission statement is broadly stated as support for the District.

"Our umbrella is pretty big," more says Saldana. "We can say, 'What do you need? How do you need us to pivot or shift?"

Saldana goes on to explain

that she feels DFEO may help in addressing a serious, unexpected consequence of school closures.

Now that the new school year has started and distance learning is systematically implemented, District personnel are puzzled that eligible families are not signing up for the free and reduced lunch program. If too many families drop out of the program, the District is in danger of losing its eligibility for certain grants from the federal government. This impacts District employees as well as students, and could result in furloughs or layoffs.

Lunches are still available for students, even though students are not on campus. Given the difficult circumstances of distance learning, it may be that no one in the family is available to pick up the food.

"So, families are just opting to not sign up," muses Saldana. She ponders a raffle for a bike or two as a way to promote signing up for the lunch program.

"I just know that they [the District] need our help."

It's been six months since the beginning of the pandemic lockdown. Yes, we are indeed

getting smarter and more knowledgeable about the virus that caused this upheaval.



anytime soon. Whenever restrictions are relaxed, a bump in cases occurs. Are you aware that here in California, August was the virus's deadliest month yet?

Facts tend to get muddled by politics, and clear messages can be hard to come by. Let's look at the science behind wearing

Here is the bottom line, so feel free to stop reading after this: The science shows that face masks work. The Centers for Disease Control (CDC) is clear that masks are one of the most important weapons for fighting the coronavirus pandemic. Masks absolutely reduce the transmission of respiratory droplets; an unmasked cough can send droplets some eight feet, and as much as 12 feet.

Most of us have been using six feet as a guideline for physical distancing. Unmasked, that is simply not far enough.

Research does show that some masks are more effective than others. N95 masks appear to be best, but are still in short supply and needed by healthcare workers. Transmission can still be successfully reduced with simple and affordable alternatives. A recent study found that a three-ply surgical mask made of nonwoven material noticeably reduced droplets dispersed while speaking, coughing, and sneezing. As we might expect, a three-ply mask was more effective than one with two layers, and was far more effective than one layer. Homemade masks should ideally be made with three layers.

I am often asked about face

shields. Studies have found that shields can significantly reduce the exposure to larger aerosol particles but are less effective against smaller particles, which tend to remain airborne longer. Therefore, the CDC does not recommend face shields for everyday activities or as a substi-

tute for masks. What about a neck gaiter (or buff), a stretchy cloth that extends below the chin? One preliminary study out of Duke University tested it and found that it did very little, and even worse, found that it dispersed large droplets into many smaller droplets, consequently increasing the droplet count and potential spread. More research is underway.

The CDC does not recommend facemasks with one-way valves or vents. These masks

do filter incoming air, but allow potentially infected droplets to escape. These masks were not designed for the needs of a pandemic, where every single one of us needs protection.

The good news is that far more Americans are now wearing masks. Studies show that almost everyone, even those with chronic lung disease, is able to wear a non-N95 mask safely, without significant impact on their oxygen or carbon dioxide

It's helpful to know that contracting COVID-19 is dosedependent; that is, exposure to a smaller dose can prevent the disease or lessen its severity. Facemasks greatly reduce the quantity of virus spread to others, and they do protect the wearer of the mask as well. However, all masks are not

equal in their ability to prevent coronavirus spread. I urge vou to wear surgical masks and/or well-fitting homemade triplelayer (or at least double-layer) masks. Of course, any mask is better than nothing.

The data is clear that this virus is very easily transmitted. Infected people without a mask can infect those around them, even those who are wearing a proper mask. Getting through this pandemic is going to require ALL of us to wear a mask. Let's be team players and get through

What is binge eating disorder?



Crime Report



Dementia patients deserve right to die

The recent shooting death in Bell of a dementia victim, killed by her grieving husband, illustrates the urgent need for broadening California's End of Life Options Act, often referred to as the "Death with Dignity" law.

Danny Harber, 76, was arrested and charged with the murder of his wife, Donna, 81, on September 1. Harber, a former Bell city councilman, is in jail, unable to post the \$2 million bail set by the court when he entered a plea of not guilty.

While Harber has not made a public statement, close associates who served with him on the council spoke of his wife's long-term battle with dementia, a ruthless brain disease that cripples the mind and leaves patients unable to care for themselves or to act rationally or, eventually, to recognize family members.

With nearly 700,000 Californians afflicted with some form of dementia, it's not surprising that there have been several instances where murder, manslaughter or assisted suicide have been charged against a husband who killed his wife to end her suffering from dementia or other terminal diseases. In San Diego county, a man was arrested for holding his wife's hand while she took the lethal pills.

I faced a similar situation some years ago when my wife had

Law and patients had to live with the pain when the opioids no longer gave relief. She carefully hoarded the pain killers so that when the time came she would have enough to end her life. I would have helped her, if only to hold her hand while she took the pills. Before that time die. came, she went into a coma and died peacefully in a hospice. I didn't have to face a charge of assisted suicide.

Had the "Death with Dignity" law been in effect and had it covered dementia, these "crimes" would never have occurred. Harber's wife would have joined the nearly one thousand patients who utilize the existing law each year. But dementia is not covered by "Death with Dignity.

That law, enacted in 2015. allows patients with a life expectancy of six months or less to ingest a self-administered, life-ending drug if they are mentally competent at that time. While that gives cancer patients and those with several other diseases the right to die without enduring a lengthy period of pain and costly medical care, those restrictions prevent people suffering from various forms of dementia, particularly Alzheimer's Disease, from taking advantage

terminal cancer. At that time, California had no End of Life Options for patients with dementia and a few other ailments, such as Parkinson's and Lou Gehrig's disease. The six month life expectancy rule eliminates dementia patients, for the disease works its awful devastation to the brain long before the rest of the body is ready to

> Dementia patients are also excluded from the current law by the requirement that they must be mentally capable at the time of ingestion of the life-ending drug. The rule should be that they are mentally alert when they tell their doctor that they wish to take the drug when they are no longer mentally competent.

> The third factor that excludes them from using the current law is the requirement that they self-administer the drug, which at that time they will he unable to do. While still mentally alert they wish to enjoy their families as long as possible. An advance directive could designate one or more people who could assist the ingestion process.

> Let the Harber case be a call to action! It should arouse California legislators to broaden the current law to cover those now excluded, particularly dementia's helpless victims.

Proposed healthcare reforms fall short

Joe Biden is officially the Democratic presidential nominee, all thanks to his moderate reputation.

It is now perplexing that Biden is embracing many of his defeated opponents' ideas, which Democrat base voters rejected just a few months ago. He established a "unity" task force populated by the most vocal supporters of Bernie Sanders. This advisory group recently recommended two far-left measures that could inadvertently disrupt many working-class Americans' access to health care.

The first measure could weaken patent protections, which prevent generic drug manufacturers from copying and selling brandname medicines developed by rival companies. Inventing a single new treatment costs around \$2.6 billion, according to a 2014 Tufts University study. In 2019 alone, the world's ten largest pharmaceutical companies spent \$82 billion on research and development.

If American entrepreneurship, ingenuity and innovation are to stay at the forefront of the global economy, there must be strong patent and IP protections in place.

Before firms invest billions of dollars into developing new medications -- the vast majority of which fail in clinical trials -- they need assurances that rivals will not be able to reverse-engineer their formulas and produce copycat versions. Otherwise, manufacturers the high cost of prescriptions. The newest, most advanced drugs are would have little incentive to spend enormous sums on research.

research and development spending, and ultimately fewer new drugs for patients. Without patent protections, researchers may not have the right environment to explore new areas of medical innovation and unearth the findings that will lead to much needed treatments

Latinx Americans are more likely to suffer from hypertension, obesity, and diabetes than white Americans. The Latinx community relies on prescriptions to manage their conditions. Vice President Biden and his advisers are not wrong to worry about only useful if patients can afford them. But instead of arbitrarily

Weakening patent protections would result in less medical setting prices and weakening patents, Vice President Biden should continue to improve upon what's already been shown to work.

> Consider copay assistance programs, through which drug manufacturers offer steep discounts on prescription medication for eligible patients in the form of coupons. These discounts saved patients a whopping \$13 billion in 2018 alone. If elected, Biden could resist efforts that seek to block patients from using such coupons.

> In attempting to bring down the cost of drugs, a Biden administration would be well-served to ensure that its proposed solutions work for patients -- not against them. Any plan that jeopardizes access to new cures should be a non-starter.

> Voters are craving pragmatic, competent leadership. Vice President Biden should not embrace impractical proposals that would impede development of lifesaving medicines his supporters, especially his Latinx supporters, need.



OG Collectibles fills gaming void in Downey

■ Oscar and Carlos Gonzales opened the video game and collectibles store last weekend and business is already booming.

DOWNEY — Two brothers have recently opened up shop, looking to bring Downey into the gaming world.

It's no secret -Oscar and Carlos Gonzales know their video games.

Carlos, 23, said that he and his brother loved video games from a young age.

"We always had a fascination about it growing up in a lower middle-class household with a single mother," said Carlos. "She had to entertain us one way or another. She got us a lot of video games back in the day."

According to Oscar, also 23, the gaming passion became lucrative in high school.

"Ever since I was a kid, I was into gaming," said Oscar. "For the last five years, we've been [selling] nonstop, or full-time."

The St. John Bosco alumni began selling online and through other outlets. "I would go to school in the day, and when I got home, I would go put things for sale online, or find stuff," said Carlos.

Oscar says he got his entrepreneurial spirit from his mother

"My mom, she's been selling at a swap meet for 25 years," said Oscar. "She always taught me a lot... She has her own business, she's been doing it for over 30 years, and she's raised three kids by herself. She always just finds a way to make ends meet, and I always wanted to be like her."

According to Carlos, the business has been a combination of both brothers' skills.

"He was more the entrepreneur," said Carlos. "I was more the person who'd be in the analytics...basically run some data, like what works, what doesn't work."

Now, the brothers have moved from virtual sales into a storefront.

Located at the former site of Art's Camera on Firestone Blvd, OG Collectibles opened its doors on Labor Day Weekend.

"It has a little bit of everything," said Oscar. "Old video games, modern video games, Funko Pops, toys, plushes...anything really collectible." Both brothers agreed that prior to their opening, there really wasn't a dedicated "game store" in the city of Downey, save for the usual retail chain suspects which just aren't the same.

"When we were younger, my mom used to always go to Gamestop," said Oscar. "Our store is kind of modeled by it, but it's independent."

"I definitely felt there was a need and a demand for it," added Carlos. "One mantra I live in is if 'someone else can't do it do it yourself."

"Since it's family-run, we can tailor our sales and everything to our audience. The difference between a GameStop and something like a mom-and-pop shop is its more specific to the people; it's more formulaic at Gamestop, where you go to one, you go to all."

Oscar says that OG Collectibles brings a nostalgia factor to the city.

"There are some parents who say, 'Hey, we had this when we were a kid,' when they're buying things for their sons or daughters, their kids," said Oscar. "They're buying things for them so that they could know what their parents played. They're trying to show how [gaming] has gone a long way."



Though they moved from Downey several years ago, the shop gives Carlos and Oscar an opportunity for a homecoming to a city that they have always admired.

"I always just loved the city of Downey," said Oscar. "There was a little bit of everything here, but there wasn't a shop like this. So, I was like, 'Hey, Downey needs this, and I'm going to be the one that brings a shop like this to the city of Downey."

Who's minding the 401(k)?

With the majority of working Americans behind in retirement savings, managing and growing money reserves is a concern in many households.

While 401(k) plans offered through employers remain popular investment vehicles toward retirement, experts note that several factors are out of the employee's control.

Perhaps the biggest questions regard the human factors: who is calling the shots for your company 401(k) plan, and are they making good choices with your money, says Brian Allen, author of "Rewarding Retirement: How Fiduciary Committees Can Elevate Workers, Companies, And Communities," and founder of Pension Consultants, Inc.

"Workers are not being put on track to retire on time with dignity, and this issue must be addressed," says Allen. "Plan committee members often lack training and knowledge, and committees usually judge the efficacy of their advisers on personality or brand, not objective performance.

"Fund selection decisions often amount to getting in high, pulling out low, and repeating. That's common among retirement plan advisers and the fiduciary committees that hire them. It's not exactly an effective way to enhance the performance for the plan participants. Most advisers simply aren't very good at fund selection."

Allen says that for 401(k) plans to prepare workers to retire on time, company retirement plan committees need to get up to speed in these areas:

Know how to judge the investment lineup and advisers. "The return made on an investment compounds powerfully over time, and helping the participants accumulate enough money for a secure retirement is the ultimate objective of the plan," Allen says. "Investment performance must be addressed. You can be confident that your plan's investment menu is performing well when it outperforms an all-index lineup. Knowing this empowers committees to judge the performance of those who advise in this important area."

Select a fund for each asset class. An asset class is a grouping of investments like equities, bonds, commodities, real estate, etc. "After selecting the asset classes, you need a benchmark for each in order to provide a basis to judge their performance," Allen says. "The committee selects a manager – not a person, but rather, a fund – that will outperform the benchmark over time. When selecting a fund manager, the committee should choose a company with these

characteristics: a deep research staff, a concentration of portfolio holdings, and relatively low expenses. They will rely heavily on the plan adviser, who should use various metrics, attributes and experience."

Track the performance of all funds ever in the plan. Poor performance can be concealed by a newly added fund with stronger results. Allen says that when the plan adviser changes one of the funds in the lineup, or suggests

a change, it's often the result of poor fund performance relative to its benchmark. "The old fund's performance cannot simply be disregarded," Allen says. "It influenced the performance of the fund lineup for the time it was there. Therefore, you must keep track of how well the fund did during the time that your plan offered it. That's essential information for evaluating how well your plan adviser performed for you."

Candidates talk housing at forum

■ Four city council candidates participated in a forum hosted by the Downey Tenants Union, the controversial group that has protested against evictions.

DOWNEY — The Downey Tenants Union hosted a virtual candidates forum on Wednesday evening, hoping to gain some insight on potential council members' views on housing

Of the nine candidates currently engaged in the city's three electoral races, four participated.

Alexandria Contreras - Mayor Blanca Pacheco's sole opponent represented District 1. Catherine Alvarez – the founder of the Tenants' Union - stood as the lone District 3 candidate during the event. District 5 saw

candidate Juan "Joey" Martinez and Arturo Gonzalez take part.

The event was moderated by Leslie Hernandez and Rodolpho

Candidates were asked three questions before fielding comments from viewers.

Those questions were:

"What their stance was on affordable housing,"

elected, they would do to address the affordable housing issue," and

"Did they support eminent domain."

The subject of affordable housing was almost unilaterally supported by each candidate, Gonzalez never specifically gave a yes or no, instead saying that "there are negatives, there are positives," before falling back on an anecdote of previous council decisions on the issue.

When addressing the matter, Contreras spent time speaking of zoning and land use.

30's the City of LA was zoned to accommodate over 4 million people to live in the city, but instead what happened was with suburbia being built, it was then zoned for what we call single-family housing, which was then used to segregate neighborhoods...Downey being one of them. Downey," said Contreras. "Downey is what I call a suburb city. A lot of times the affordable housing we want to build, we simply can't do it because of how the city is zoned."

"For example, in my district there is a lot of commercial property that is vacant; it's empty, there's nothing happening there's nothing being done with it. But we can't build affordable housing there because it's only zoned for the purpose of commercial property, which then makes it very difficult to bring the kind of affordable multi-family development that we need to the city.'

Martinez's answer took notso-subtle jabs at the City Council, critical in previous months.

"One of the things I need to do if I get elected is do my job, and that's not only listen to the tenants and the renters, and the homeowners here, but work with the Downey Tenants Union and work with organizations that are focusing on ensuring that people aren't losing their homes or aren't struggling to live in their homes."

"With that said, I definitely am for individuals expanding parts of their homes to accommodate for other people to live there. I am definitely on board with that."

"We've got to understand that our families are suffering a lot," said Alvarez. "We cannot build our way out of the housing crisis; we need to use all the tools available to the city to ensure that low-income workers stay in Downey. We cannot make

"I'm weary to use it, because how it has been used and been weaponized against lowerincome communities of color," said Contreras. "For me, I'm not so much of a fan of using eminent domain mainly because it's typically wielded by people who are politically in power, and typically it's not the people who are representing those neighborhoods."

Gonzalez expressed opinions that the city would not have Alvarez said she would work the resources to buy buildings without dipping into reserves, and would therefore allow other individuals looking to be investors in the city to purchase

Hal Singer

Hal Singer, a hit-making jazz saxophonist and R&B performer known for his 1940s No. 1 hit song "Corn Bread," died Aug. 18 at age 100.

Singer played saxophone in various bands in Kansas City and New York City before forming his own band in the late 1940s. His band recorded the fastpaced instrumental song "Corn Bread" for the Savory label in 1948.

The song was popular on the dance floor and reached number one on the R&B charts.

He continued to record music and worked as a session musician playing with Coleman Hawkins and Earl "Fatha"

Singer moved to France in 1965 and continued to record and perform mostly in Europe. He toured and recorded in the early 1980s with "Rocket 88," a swing and boogie-woogie band that featured drummer Charlie Watts and pianist Ian Stewart of the Rolling Stones.

He was born in Tulsa in 1919 and he and his family survived the Tulsa race massacre in 1921.

Shanna Hogan

Shanna Hogan, a New York Times bestselling author of true crime books including "Picture Perfect: The Jodi Arias Story,' died Sept. 1 after drowning at her home in Phoenix. She was 37.

Hogan published her first true crime book in 2011. "Dancing with Death: The True Story of a Glamorous Showgirl, Her Wealthy Husband, and a Horrifying Murder" told the story of the 2004 murder of art dealer Jay Orbin by his wife, Marjorie Orbin.

Hogan's next book, 2013's "Picture Perfect," was a New York Times bestseller, covering the widely publicized case of Travis Alexander's murder by his ex-girlfriend, Jodi Arias.

Hogan went on to publish "The Stranger She Loved" in 2015 and "Secrets of a Marine's Wife" in 2019. She appeared on TV shows including "The View," "Dateline NBC," and "20/20," and she cohosted the podcast "Case Closed."

Hogan was also an adjunct professor at the Walter Cronkite School of Journalism and Mass Communication at Arizona State University.

Lou Brock

Lou Brock, a legendary outfielder for the St. Louis Cardinals known for his base stealing that led the Cardinals to two World Series victories, died Sept. 6 at age 81.

Brock played most of his illustrious career with the Cardinals. His first few years in the Major Leagues were with the Cubs, where he had potential but under-performed.

In June 1964 Chicago famously traded him to St. Louis for pitcher Ernie Broglio. Brock would go on to a 15-season career with the Cardinals.

He had over 3,000 hits, was a six-time All-Star, and won the World Series with the Cardinals in 1964 and 1967.

The speedy Brock, who has the second most career stolen bases behind Ricky Henderson, was elected to the Hall of Fame in 1985.

"First base is useless. And most of the time it is useless to stay there," Brock said in a 1974 interview. "On the other hand, second base is really the safest place on the field. When I steal second, I practically eliminate the double play. And I can score on any ball hit past the infield."

David Gaines

David "Smokey" Gaines, a basketball player with the Harlem Globetrotters before going on to coach at Detroit Mercy, died Sept. 8 of cancer. He was 78.

After attending LeMoyne-Owen College, Gaines was drafted by the Detroit Pistons. But he also had a chance to play for the Harlem Globetrotters, and he took that offer, joining the team in 1963.

Gaines stayed with the Globetrotters until 1967. He later played briefly for the Kentucky Colonels before joining the coaching staff at University of Detroit under head coach Dick Vitale.

When Vitale left the team, Gaines was promoted to head coach, becoming the team's first Black head coach. He went on to become head coach at San Diego State University.

In later years, Gaines became athletic director for Memphis

Kevin Dobson

Kevin Dobson, an actor best known for his roles in "Kojak" and "Knots Landing," died Sept.

Dobson got his start on TV in daytime soap operas - first in a brief role in "One Life to Live" in 1968, and then in a variety of roles in "The Doctors."

He landed his first major role in 1973, playing Detective Bobby Crocker in "Kojak" for the show's entire five-season run.

Later, Dobson joined the cast of "Knots Landing" as Mack MacKenzie. He won five Soap Opera Digest Awards for his performance over 11 years, including Outstanding Hero and Favorite Super Couple, with Michele Lee.

Dobson later had a recurring role in "Days of Our Lives," where he was the fourth and final actor to play Mickey Horton, as well as in "The Bold and the Beautiful."

Dobson frequently guest starred on TV shows including "The Mod Squad," "Touched by an Angel," "Nash Bridges," and "CSI." He appeared in movies including "Midway" (1976), "1408" (2007), and an uncredited appearance in

Tom Seaver

Tom Seaver, a legendary Hall of Fame pitcher who won three Cy Young Awards and led the 1969 "Miracle Mets" to a World Series championship win, died Aug. 31 at age 75 from Lewy body dementia and complications of

Seaver made the Mets as a starting pitcher in 1967, winning 16 games and the National League Rookie of the Year award.

In 1969, he helped lead the underdog "Miracle Mets" to a World Series win over the Baltimore Orioles. In Game 4 of the Series, Seaver pitched a 10-inning complete game win.

After a dispute in contract negotiations before the 1977 season, Seaver was traded to the Cincinnati Reds in a trade called the "Midnight Massacre."

He returned to the Mets in a trade for the 1983 season and then pitched for the White Sox from 1984 until the middle of 1986, finishing the season and his career that year with the Red

Seaver won three Cy Young Awards, 311 games, and had 3,640 strikeouts. He was elected to the Baseball Hall of Fame in 1992 with almost a 100% "yes" vote.

Sue Maciorowski

Sue Nichols Maciorowski, an animation artist who worked on beloved Disney films including "The Lion King," "Mulan," and "Hercules," died Sept. 1 of metastatic breast cancer at the

age of 55.

Maciorowski began her career in animation while she was still in college, working as a model designer for Jim Henson's "Muppet Babies" as part of a team that won an Emmy Award.


She got her start with Disney in 1991 with "Beauty and the Beast," for which she was a visual development artist. Maciorowski went on to work on many of the classics of the 1990s Disney renaissance, and her art and concepts were key influences on the movies' style and character development.

One of her unique talents for Disney was working with a variety of animators to teach them to use the animation style that was chosen for a film.

Maciorowski worked on Disney animated films including "Aladdin" (1992), "The Lion King" (1994), "Hercules" (1997), "Mulan" (1998), "The Emperor's New Groove" (2000), "Lilo & Stitch" (2002), "The Princess and the Frog" (2009), and "Moana" (2016).



Climate change will decimate Palm Springs, Coachella Valley tourism, study says

A new UC Riverside study finds that climate change will have a devastating effect on the greater Palm Springs area's dominant industry — tourism.

Thousands known as "snowbirds" flock to the region annually from elsewhere in the country to escape freezing winters. However, due to climate change, the number of days above 85 degrees between November and April is projected to increase by up to 150% by the end of the century.

These changes are enough to prevent many from patronizing the area's famous outdoor attractions and events such as the annual Coachella Valley Music Festival, according to the study published this week in the journal Climatic Change.

Many businesses in the Palm Springs area already close due to lack of customers during the hot summer months, when daytime high temperatures average up to 108 degrees in July and August. Employment follows these patterns, with regional employment declining by 7.2 percent between April

and October in 2017.

The researchers modeled two different future climate scenarios - one in which heattrapping gases are significantly reduced, resulting in slowed warming, and one in which emissions are not mitigated at

"The two scenarios differed a little by mid-century, but were very different by 2100," said Francesca Hopkins, assistant professor of climate change and sustainability. "In both cases we saw big declines in the number of days suitable for snowbirds, but this was much more pronounced in the scenario with no emissions reductions."

In order to assess future effects of increased heat, the researchers analyzed two key components of the local tourism industry in addition to the winter weather: the number of visitors to The Living Desert, a popular outdoor zoo, and the likelihood of extreme heat at the Coachella music festival.

The Living Desert Zoo and Gardens, established 50 years

ago, is a nonprofit zoo visited by more than 510,000 people last year. The research team found that it stands to lose up to \$1.44 million annually in tourism in today's dollars with 18 percent fewer visitors at the end of the

Similarly, heat is also projected to impact the annual Coachella music festival, which began in 1999, and attracts roughly 250,000 concertgoers. The researchers did not assume that increased heat will necessarily affect attendance. However, they did find that probability of attendee exposure to extreme heat — if it continues to be held in April — could increase six-fold by end of century if climate change goes unmitigated.

"Though other studies have focused on the impact that climate change will have on cold winter destinations popular for sports like skiing, this is one of the first to focus on a warm winter destination, and its impact on such a specific region," Hopkins said.

Places like the Coachella

Valley are especially vulnerable to the impacts of climate change because they cannot shift snowbird season to cooler times of year, since those don't exist, Hopkins explained.

Cindy Yañez, a UCR physics graduate and first author of the study, was born in the Coachella Valley, and has lived there most of her life. Many people in the area have jobs that require

them to work outdoors, either in agriculture or tourism. She wonders whether there will be a climate breaking point that might cause locals like these to move away.

"Weather is a resource that draws in money just like other resources do. If that gets redistributed it could have severe impacts on peoples' lives both physically and

economically," Yañez said. "I am hoping this research will start a conversation in the community. We still have time to avoid the worst of these predictions if we can reduce our greenhouse gas emissions today.'


