30 years later, Downey police officers recall shooting

DOWNEY — In the early morning hours of Oct. 9, 1990, five heavily-armed gunmen broke into the PACE Warehouse store in Downey. Armed with assault rifles and protected by flak jackets, the gunmen stole \$46,000 in cash from a warehouse safe before the robbery was interrupted by Downey Police

Two Downey police officers were shot and wounded in an ensuing gun battle. Officers Randy Ewing and Joel Willis survived their injuries and eventually returned to patrolling

Thirty years after the shooting, Ewing and Willis – along with responding officer Ralph Bruner – shared their memories of the incident.

Ralph Bruner

What was your rank at the time of the shooting?

I was a training officer. I had 10 years on in Downey at the time of the incident.

How old were you at the time?

41.

What are your memories of the incident?

One thing I was always amazed with at Downey PD was the training they give their police officers... When you go out on patrol, talking like the early morning of the incident, you go out almost hoping that you're prepared for almost anything that might happen.

Basically, 5 a.m in the morning, a little before that, two units were assigned the call, a robbery in progress at Pace Warehouse, which was quite common in Downey. Anytime there's a serious call, almost every officer that's out there at this time there were four of us working at 5 a.m. — and the other two officers responded to the location, which to me was one of the great things about Downey PD is we all looked out for each other, especially on potentially serious and dangerous calls.

I felt that we deployed very well tactically when we arrived at the location, and when the suspects sprung the ambush on us I was surprised where the fire was coming from, which was behind us.

I think, again, thanks to the training that I felt that Downey PD gave us, I responded to the situation and the shooting, and did my best to protect myself, the other officers, and the citizens that were at the location.

Obviously, it was very scary and surprising; you didn't really expect something like this to happen. As a matter of fact, I don't think officers had been ambushed in this manner almost forever; people said after the incident that they didn't think anything like this had ever happened, being ambushed by somebody with full automatic weapons like that.

Pretty much it all happened very quickly, I just kind of reacted...The interesting part was you weren't really incredibly scared until after it was over, was when I got a little more scared than when it was going down.

I remember after the incident I was very critical of myself, and I tried to think of what I might have possibly done better. I thought in detail how I responded, and was amazed how much of my reaction was what I had practiced in training.

It was like we had four separate incidents going on; each one of us had our own thing to respond to but it was all happening at the same time.

But it went very well; we got

really lucky that none of our officers were killed, and that none of the citizens that were being held hostage inside the warehouse were injured badly or were killed. I think a lot of that, we have to thank the Downey Fire Department, because when they got there, we had two officers shot multiple times each. The Fire Department - without hesitation - came running in with stretchers and grabbed our two injured officers...knowing that the scene wasn't secure. They retrieved our officers and took them to the hospital, and quite possibly saved their lives.

I think overall - the way all four of us responded - it's probably what saved our lives in the situation; mine and everybody's there.

Did you ever fear for your life?

Of course. I had a large number of full-automatic rounds shot at me at my police car, and rounds were bouncing all around me. Obviously, it would scare anybody. The training is incredibly important. Downey PD was always amazing...It was incredibly scary for all of us, and incredibly scary for 20 plus people that were being held hostage inside the Pace warehouse.

To say I wasn't scared is crazy; I was definitely scared. But I think just responding in a way you've been trained, and having a plan made it a lot easier to deal with

Did the incident affect you at all?

I think right after the incident when I got back to work - this is kind of a humorous way of putting it - I was kind of sneaking up on parked cars to write parking tickets because I was a little nervous that something like that may happen again. It does affect you later on the job; not making me crazy, but making me cautious, and maybe overly so at first. Then I kind of toned down and got back to being myself and really enjoying the job again for a lot of years...I don't think it made me cynical or a bad policeman in any way, I think it just made me a little more careful. I already kind of knew that things like this could happen, but it's still a shock when something of this level happens. This was pretty dramatic.

What are you up to today?

I moved up here to Utah. I've been retired now for 15 years; it's unbelievable. It probably feels like longer than that to my wife. Been married for 46 years now, and just doing my best to keep her happy and enjoy our retirement here.

Joel Willis

What was your rank at the time of the shooting?

I was just a policeman; I had 8 months out of the academy. I was a rookie.

How old were you at the time? 22.

What are your memories of the incident?

I'm sure you've heard the story. It was an ambush. We didn't know if we were looking at an actual robbery in progress inside the store. There were multiple cars parked out in the parking lot. We didn't even have a clue that there would be anybody hiding in cars to shoot at us. I was hit before I knew what was even going on; the first sound or even idea that there was a shooting going on was the

impact of the bullet. It hit my butt, but it came out my knee. That's how I knew I was involved in a shooting, and then it just snowballed from there.

Can you explain what that feels like to be shot? You said it entered your buttock and out your knee.

I didn't feel it go in; the only thing I felt was the exit wound out near my knee there. It felt like somebody hit me with a sledge hammer from behind. Then the second I felt it – the initial sense of being hit with a sledge hammer – it immediately went away; there was zero feeling, zero pain, nothing. I knew I had been shot, but I had zero pain; I couldn't feel a thing. And I was still standing.

You already know that you're injured. Now you realize that you're in a potentially very dire situation. What goes through your mind? What happens at that point? What action do you take?

I turned and I looked...and basically said who the "blank" shot me? I turned, and there's a guy behind me – about 25 feet away, maybe – with a full-auto AK47 just blowing rounds at me. I was just in awe that I wasn't being hit; I didn't think I was, but it turns out I was. I got shot two other times, but I didn't know.

I remember just trying to get to cover, and feeling bullets fly by my head, hitting the ground, hitting the wall behind me, trying to get to the pillar for cover. That was my first objective, was to get out of the line of fire.

Did you ever fear for your life?

I didn't fear the initial barrage, which I really found weird. When I got to safety behind the pillar, then I started getting scared....Everything just went dire, because everything didn't calm down when I was safe...not quite panic, just fear. Then I looked down and I saw in my right hand I had my gun, and when I saw that gun I realized I could fight back. I got extremely angry, like a rage I can't even describe. I just rolled over and started and started engaging the guy again.

He took off running; I hit him once. Kept firing, He got up, and I guess he got into a getaway van, but I never saw the van.

Once I got that rage in, my training kicked in. Then my brain basically took over my body; I had no control over what I did. It was just watching it perform, due to my training; it just went into a reactionary, instinctive mode... my brain just took over. It was weird.

How did the incident affect you? Does it still affect you?

I went back to work five or six months later, and continued seeing a psychology doctor, kind of going through some stuff in my head. I was fine psychologically, just because of that rage that saved me I had some anger issues I had to get through. Got through that, and I was all good; at least I thought I was. Then I left and went to Anaheim PD, and promptly got into another shooting...the combo of them kind of really took a toll on me mentally. But post traumatic stress, you can deal with it. It'll be with me forever, for sure. You just gotta know how to deal with it.

What are you up to today?

I've since retired. Enjoying my retirement...just living life with my family. My kids are all grown up. My youngest is 21, my middle daughter is 23, and my oldest boy is 30. Just kind of hanging with them and my wife.

Randy Ewing

What was your rank at the time of the shooting?

I was just a police officer.

How old were you at the time?

What are your memories of the incident?

We got the call about 5 o'clock in the morning. Possible armed robbery, burglary. The Pace location, we knew they were closed, but there was a gas station there that always had problems with people coming in...We parked underneath the - I think it was the 605 - we parked under there and went in on foot. As we were going on foot, Ralph went by and went to the far side of Pace. We'd just cleared the gas station; it was closed, there was nobody there.

There were lots of cars in the parking lot, nothing really stood out to us. We had been briefed that there was a crew working, pulling these robberies but I don't think we really had time to connect all of that. We turned our radios down...we didn't want the dispatchers jumping on the air on us and giving our position away.

We went through there, started clearing the parking lot. About the time we cleared the parking lot - approaching the vehicles in the parking lot - Ralph pointed out that he had suspects inside Pace...He walked towards the front, because there was lights leading from it; you

could see people inside. At that point, we started scrambling to take cover. Unfortunately, I took cover in front of the suspects getaway vehicle. I was behind a light standard there, Joel was to my north, towards the pillars right at the front. I don't know where Keith was at that point...I could see Joel and Ralph, but I wasn't sure where Keith was.

At that point I crouched down

I had a shotgun - I crouched
down behind the light standard
and I heard the door of the van
open up behind me to my right. I
rose up, and as I started to stand
up to face it and turn, that's
when I got shot. Then all hell
broke loose after that.

I jumped to the other side of the planter to get away from the knucklehead that was shooting at me, hit the ground and tried to move back towards the planter so at least if he did step across when he came out I'd have a little bit of cover.

I dropped the shotgun, then he stepped through his position through the bushes there; we were in a firefight just right there.

He was shooting at Joel; I'm not sure he knew where I was at right away. But when I sat up and shot back at him, he directed his attention to me. Then he turned and ran.

One of the three of us shot him. I'm not sure which one; it's always in contention between the three of us, but it doesn't matter at this point. He did take a bullet, and he went down. He got up, and ran back in the van.

The van was backing up; he had to run around to get into it. I put a bullet through the rear of the van just hoping to get a lucky shot on somebody...then I put one through the driver's door.

Unfortunately, it went to a crossbeam in the door there, and it prevented it from hitting the driver. Pretty much, that's it.

Where were you shot?

I was shot in the buttocks and the hip on the right side, and in the side on the left and the buttock on the left.

What are you up to today?

I'm a wildlife photographer now, North Idaho. I got my kids here, and I remarried about 15 years ago.

Crime Report

Oct. 7:

Detectives are investigating an assault with a deadly weapon that occurred around midnight in the 8000 block of Imperial Hwy. Officers responded to Kaiser Permanente regarding a victim with a wound to the back of his head. The adult male victim advised an unknown male suspect approached him. The suspect demanded money from the victim. When the victim stated he did not have any money, the suspect struck the victim on the back of his head with a handgun. The victim then fled the location on foot.

Oct. 8:

At approximately 7:55 pm, officers responded to 12544 Rives (Apollo Park) regarding an attempted robbery with a firearm. The 20-year-old male victim was at Apollo Park near the restrooms when the suspect, whom he has seen in the area before, approached him. The victim was intoxicated and uncooperative. Detectives are investigating the incident.

At approximately 6 am, officers responded to a domestic violence call in the 8700 block of Imperial Hwy. The victim was awoken in his bedroom when his wife accused him of infidelity. When the

male denied having an affair, the female pointed a firearm at his the manager and take her cellphone from her hand. The suspect the female followed. The victim was not injured in the incident.

The victim moved away from the suspect and the suspect fled with the merchandise.

The suspect picked up the duffle bags and fled on foot. Officers received a call at approximately 1830 hours in the area of Lakewood/Meadow regarding a male jumping fences. Officers detained the subject, who matched the suspect description in the earlier stabbing. An officer was able to positively identify the subject as being the suspect.

Police break up gambling operation

DOWNEY — An illegal gambling ring operating out of a Downey liquor store was shut down last week, authorities said.

On Oct. 16, Downey Police served search warrants at a pair of businesses located within a strip mall on the northeast corner of Paramount Boulevard and Imperial Highway.

Police said they found cash, two gambling machines, and "a large quantity" of pre-paid credit cards at Vikum's 2am Liquor and in a neighboring vacant business.

The owner of the liquor store was arrested and booked for operating an illegal gambling establishment. The owner's name was not released.

Metro may pause freeway expansion plans

■ City officials are pressuring Metro to scale back its 605 Freeway expansion project.

transportation officials may delay plans to pursue an expansion of the 605 Freeway that could have resulted in the demolition of up to 250 Downey homes, city officials said this week.

Metro's Board of Directors was set to consider a motion Thursday to delay a release of its environmental impact report for the freeway expansion "until it includes a more locally supported alternative that will minimize the number of properties that may be taken in Downey as part of the freeway widening," Downey officials said in a news release.

Metro's initial proposal to widen the 605 and 5 freeways would have required up to 250 Downey homes to be purchased by the state and then demolished.

"Our city has been actively pushing for other alternatives that will help minimize negative impacts for our residents," said Mayor Blanca Pacheco.

"We are happy to know Metro's Board of Directors heard our concerns and they agree that we must consider an alternative our community's concerns."

City officials said they have been working closely with Santa Fe Springs, the Gateway Cities Council of Governments and the I-5 Joint Powers Authorities to get Metro and Caltrans to revise its expansion plans.

"We as a city have been very proactive and vocal in opposing Metro's proposed alternatives, which would have impacted hundreds of homes in our community," said Mayor Pro Tem Claudia Frometa.

"Our goal is to continue working with all agencies involved to ensure the best possible outcome for our residents."

Metro downplayed the freeway widening proposal two weeks ago, saying the project was in its preliminary stages.

"Before going any further, we want to be abundantly clear: Metro has made no decisions about this project, which is still in the early planning stages. Nor have any decisions been made about property acquisitions," Metro said in the statement.

"The project's Draft Environmental Impact Statement/Report (DEIS/R) will be released in early 2021 and will provide the communities along this corridor with information about the project's benefits and impacts — as well as ways to potentially avoid or mitigate those impacts."

A proposal under consideration by Metro would add two lanes along a 16-mile stretch of the 605 Freeway, from the 105 to the 10.

The 605 and 5 Freeway interchange near the Rio Hondo River would also be widened, which is where many of the Downey homes would be impacted.

No funding has yet to be approved for the project, including for design, right-of-way acquisition, or construction.

How New Zealand beat Covid-19

New Zealand Prime Minister Jacinda Ardern forced a shutdown so strict that no one was allowed to go fishing or golfing, easy pursuits for social distancing. But her super-tough "go hard, go early" policy has virtually stamped out the coronavirus in this country of 5 million.

Not only can New Zealanders again fish and golf but 30,000 of them just packed a stadium to watch a rugby match. They no longer have to wear masks even on public transportation, though that is encouraged. New Zealand is back in business.

The political results are also in. Ardern and her party just won reelection in a landslide, offering a hint of how Donald Trump's failure to manage the pandemic could produce the direct opposite

The president's weak polling numbers largely reflect his incapacity — whether as a leader or human being — to treat the coronavirus as the health crisis it was and still is. Ardern, meanwhile, has been hailed as "the anti-Trump.'

Some critics of this comparison note that New Zealand is less densely populated than the United States, which makes social distancing easier to do. That sounds plausible, except that North Dakota and South Dakota have far fewer people per square mile than New Zealand, and they are reporting the largest number of new COVID cases per capita in the United States.

Because it contained the virus so rapidly, New Zealand was able to reopen as early as May. Kids were back in class. Office workers returned to their cubicles. Diners filled restaurants. Five months ago!

The one major industry still suffering is tourism. And that's not because tourists fear getting the virus there. It's because New Zealanders fear the tourists will bring it in. Americans are not allowed to enter the country unless they are permanent residents.

How would Americans take to such harsh medicine to combat the virus' spread? Let's just say that governors who instituted serious lockdowns are among the most popular. It happens that Michigan is a swing state Trump won by less than 1 percent in 2016. Michigan Gov. Gretchen Whitmer's approval rating is running well ahead of

Consider that she had to endure both anti-mask goons waving guns on the statehouse steps (and plotting to kidnap her) and Trump's verbal sniping. At a recent rally in Michigan, Trump watched his crowd chant, "Lock her up!" to which he replied, "Lock 'em all

It's time to reopen Cinemark

Dear Editor:

"Will she or will she not?"

"She won't, or...they won't. Not yet."

My dad says they're keeping them closed for some weird political reasons.'

"Who knows."

"I'll bet the price of a ticket that they'll be open by October 1."

"I'll make that bet -- I don't have that much faith." "She'll open it up because she loves movies as much as we do."

"But it's not up to Downey's mayor. It's the governor's decisions, based on the Covid-19 statistics. That's what they say.

Such a conversation might have taken place, until recently, in front of the Cinemark Theater at the Downey Promenade. But months have gone by and many people tend to give up hope and disappear, together with their itchy wallets, intact.

So the Cinemark continues worried. They have reason to be.

The benches that face their front doors are bare of any customers, except a shopper or two seeking a momentary rest from strolling the half-empty mall. ACross the way, Johnny Rockets has been equally anxious, since all this lockdown happened. Every desperate company or business, in the malls or on Downey Avenue, is waiting for relief.

The powers-that-be in Sacramento have offered no such relief to most counties of California. They know that kids and adults alike are already deluged with a multitude of appars, supplying continuous electronic entertainment on phones, tablets and desktops, so they'll

No, the population at large doesn't have it so bad. Yes, the virus is real and it isn't going away, or not fast enough. But even though cases are still high, Covid deaths are way down, including in Downey, and are mostly due to underlying illnesses in the aged, who also happen to test positive, a sorry state of affairs.

Meanwhile, the Cinemark, on its website, and with a large dose of sincerity, has been telling its lost audiences that it has a workable plan for reopening. Beyond maintaining the social distancing in each movie auditorium, by taping off a least half of the seats, and requiring the wearing of masks for all its staff and customers, they will be going the extra mile by spraying and wiping down all seats, the snack bars, the lobby, restrooms, and all doors and railing, as often as required, before and after each showing. These procedures will be checked off by observant supervisors, nearly constantly. This is going way beyond what supermarkets and restaurants like Ralph's and La Barca do, or are required to do.

Churches and restaurants can use their parking lots to accommodate people and schools depend on homeschooling through the internet. Dentist offices and beauty salons struggle to get by. But what do the empty movie theaters have to bring back the people in order to survive? And how will we "kids at heart" be able to check out the new James Bond movie, soon to arrive? Maintaining these closures sounds like the making of a new kind of virus, the "Type-15 Severe Stage Frustration," dragging a lot of poor, out-of-work people in its wake.

Mr. Governor, at least he can see by now how nervous we're getting with this Covid-19 and everything that comes with it. But we will follow Cinemark's guidelines, just like we would whenever and wherever we go out.

We want to be spending money and having some old-fashioned fun again, patronizing whom we wish, before they all go broke -- the ones who are depending on us.


In New Zealand, as here, advance voting hit record levels. In its case, the surge pointed to a desire to reelect. Here, the surge strongly suggests the opposite.







Who are these people?

■ In the City Council race between Carrie Uva and Mario Trujillo, neither inspires confidence.

DOWNEY — The great British playwright and Shakespeare contemporary Ben Jonson was the first of a number of classical British writers to insist, "Speak that I may know thee." Implicit in that request is the idea that the words we choose to speak, the sentences we form, the skill with which we listen and communicate our thoughts and feelings, altogether express us, our sensibility, our general of the mission statements and education and even our level of

mental sophistication.

The Downey City Council Candidates Forum that took place in a Zoom meeting on Oct. 1 revealed that, for the most part, the latter quality is in short supply. A number of the candidates didn't seem to understand that occupying public office, or even running for public office, requires a level of responsibility that precludes slander, which is actionable, or reckless assertions disguised as fact, which is subject to scrutiny and can easily expose the plaintiff

This does not speak well for the future of Downey.

What are we to make therefore claims made by Carrie Uva and

Mario Trujillo to the Patriot's Alex Dominguez in last week's edition? Both are running for the Council seat in District 5. Uva ran against Claudia Frometa in the last election cycle. Trujillo has raised a record-breaking \$135,526 in an effort some claim to buy his way into office. Both have notable endorsements, Mayor Blanca Pacheco and Pro Tem Mayor Claudia Frometa , Councilman Alex Saab, former Downey Mayor Fernando Vasquez and Assembly member Cristina Garcia for Trujillo, all city council members save Saab, former mayors Roger Brossmer, Mario Guerra, Joseph Di Loreto and the Downey Unified School board for Uva, among

The questions the citizens of Downey should have concerning Uva and Trujillo ought to be the same the as they would have for all the other candidates, and may well have had for some time, particularly concerning the city's current moment: who are these people? What makes them uniquely qualified to hold office? Do any of them have

public administration, history or political science? Have any of and prominent reputations in their fields? Are any of them mindful of the developments characteristic of what's been termed The New Urbanism, which deals with the issues of what constitutes the livable city and the institutional foundations of community? How many of them are conversant with the works of Jane Mayer and Lewis Mumford, who famously wrote about architecture and the look of things, and how that look affects the human spirit

These are not frivolous questions. Short Story: Watching the Streetcars Go By

When I think of streetcars, I think of the past, before plastic seats marked with graffiti, aluminum rails; and a time where air conditioning came by opening the windows. Imagine that.

In the summer when my parents and I visited my maternal grandparents in El Paso, Texas, my cousins and I slept out on the little terrace facing Main Street. From our perch we'd see the Red Streetcars pass. It had a sign over the door that read: "Ride a Mile and Smile the While - Only 5 cents." The streetcars were noisy on the rails. The high pitched sound from the horn made it difficult to sleep. My cousins and I amused ourselves by making up stories or making fun of passengers scurrying to get on the streetcar. Sometimes people lost their footing as they disembarked, but there always seemed to be someone there to give them a helping hand.

On Halloween, transportation inspectors watched for pranksters who may try to water down the rails with soap to cause the streetcar to lose traction. Twice we saw automobiles cross the tracks and collide with a streetcar. There never was a shortage of surprises to be witnessed on Main Street., especially on Saturday nights.

We saw a drunk, coming from the cantina nearby fall on the tracks while the approaching streetcar sounded its horn. We yelled, screamed and hollered until some good samaritans ran to pull him to safety. Then we hollered cheers.

Watching the streetcars on Main Street provided "reality"

entertainment for us kids, in lieu of television that my grandparents didn't own. Sometimes in the afternoon our adult relatives sat out on the terrace to visit with each other and often greet friends they saw on the street, as well as watch the streetcars go by.

A horrible experience relating to the streetcar and my family came in the 1950's when my grandfather, Jesus, was working as a maintenance mechanic for the Red Streetcar Company.

Streetcars are propelled by on board electric motors and require a trolley pole to draw power from an overhead wire.

While at the junction just a few blocks from our 'perch' on our grandparents terrace, Jesus had turned off the electricity in order to work on the overhead wire of one of the two streetcars that were not in service.

A new and inexperienced employee saw that the electricity switch was

not turned on. Instead of investigating the reason it was shut off, he simply pulled the switch on. Consequently, my grandfather was electrocuted. Miraculously he survived, though he was so severely burnt that he had to have his right arm amputated up to his elbow. He remained in the hospital for nearly a year.

The streetcar accident changed his life forever. He never returned to work again, he never complained... and he never sat out in the terrace to watch the streetcars go by.

Paging Dr. Frischer...

Glutenfree products have become enormously popular. I've seen glutenfree pizza, cookies, breads, candies, and



as well. There is quite a bit of confusion about gluten. Most Americans are privileged to have access to a huge variety of foods, and it can often be hard to tell which of those foods might be causing undesirable physical symptoms. (Of course, non-food related issues, like sleep, hydration, exercise, mental status, etc. can cause physical symptoms as well.) Nonetheless, many of my patients report that they are gluten sensitive. This means that they do not have celiac disease, but believe that gluten-containing foods cause them various kinds of distress.

So, what is celiac disease? Roughly 1% of people in the United States are diagnosed with it, which comes to about three million people. It is a really terrible autoimmune disease in which foods with gluten cause inflammation and damage to the small intestine. It can lead to diarrhea, gas, weight loss, weakness and fatigue, severe abdominal pain, headaches, joint aches, and thinning of the bones.

The big question is this: is there a group of people who do not have celiac disease, but nevertheless react negatively to gluten? Very little research has been done about the motives of the many who adopt a glutenfree lifestyle. One survey found that the most common explanation for selecting gluten-free foods was "no reason" (35%), followed by "healthier option" (26%), and "someone in my family has a gluten sensitivity" (10%). The least common rationale cited (8%) was "I have a gluten sensitivity."

Note that gluten sensitivity is entirely different from celiac disease. In a small 2011 study, Australian scientists put gluten sensitivity on the map. Participants who did not have celiac disease were given gluten and monitored for gastrointestinal complaints. The gluten appeared to cause a lot of gas, bloating, and fatigue. Next was a followup study a few years later. This time, those who claimed to be gluten sensitive were put on

a high gluten diet, but did not have a corresponding increase in symptoms. (Note that this was a small study.)

It is important to consider that those who believe they have gluten sensitivity might actually have a food intolerance or sensitivity to some other non-gluten food, such as lactose, dairy, sulfites, amines, or caffeine.

The danger in unnecessarily eliminating gluten from the diet is that we may consume too little folate, fiber, and thiamine. Gluten-free foods cost more. Socializing becomes more difficult. Packaged gluten-free foods often contain a greater density of fat and sugar than do their gluten-containing counterparts.

For those who do not have celiac disease, wheat allergies, or this possible non-celiac gluten sensitivity, there is simply no data supporting the health benefits of a gluten-free diet.


These are my recommendations: If you feel that you are gluten sensitive, it is critical to make sure that you do not have celiac disease, which has serious lifelong consequences. Please consult your doctor if you suspect a problem. Approach this together scientifically, in order to reach an accurate diagnosis and arrive at the very best treatment.

Downey schools planning for January reopening in hybrid/full distance model

DOWNEY — After considering all of the relevant health and safety information, and the regulations and reopening requirements from both the California and Los Angeles County Departments of Public Health, the Downey Unified School District is planning for students to return to an in-person Hybrid starting on Monday, January 4, 2021, with the option for a Full Distance Learning Model for those families who wish to have their student continue in that format.

This plan is completely dependent on the County of Los Angeles being in the RED tier in the state's color-coded matrix of a Blueprint for a Safer Economy. As of Tuesday, Los Angeles County remains in the PURPLE (widespread) tier, which is the most restrictive. As shared in our last District Update, for schools to reopen for in-person instruction, it requires a county to be in the RED tier for at least four (4) consecutive weeks or 28 days. Even if next Tuesday Los Angeles County were to have lower metrics to transition to the RED tier, which appears unlikely, the earliest school districts in Los Angeles County would be able to open schools would be in December. Given the trends in Los Angeles County, the Board of Education found the most reasonable option is to aim for in-person instruction, via a Hybrid Model, start the second semester on January 4, while maintaining a Full Distance Learning Model for those who choose.

To be clear, the start of January is a planning date and not a guarantee, as it is all based on the County Department of Public Health's numbers. There is considerable discussion at the national and state level as to the appropriate rules for reopening schools, and the rules could become more or less restrictive at any point.

The Board of Education, district administration, educators and staff have been continuously planning for reopening our schools in

days of the week and remain in Distance Learning the other days. As shared in previous communications, this model of return is due to the stringent health requirements for physical distancing in the classrooms, which limits the number of students in a classroom to approximately 15 at a time. There are a variety of different ways to accomplish this and our staff has been actively working to determine the best option for Downey Unified. Our staff is also actively communicating with districts in surrounding counties that are already in the Red tier to gain insight, explore options and hear the problems that have been encountered.

I want to reiterate that even though the district is planning for a return to a level of in-person instruction, students who wish to remain in a Full Distance Learning Model will be able to do so. Whether due to health and safety concerns or whether your family has found the Full Distance Learning Model better for your student, this option will remain available. While many students and families are desperately waiting for the ability to return to in-person instruction, others have found Distance Learning to be a good fit for their students.

As the district solidifies plans for a return to a modified in-person instruction, more details will be provided to families via the many avenues of communication the district now uses.



How much does it cost to sell a house?

A shortage of homes for sale in the U.S. gives sellers the advantage in most housing markets. But many sellers don't realize that this transaction likely will cost them thousands of dollars.

How much does it cost to sell a house?

Real estate commissions and other fees can consume up to 10 percent of the sale price of the home. Some expenses are negotiable and fluctuate with the real estate market. But sellers should expect to foot all or part of the bill for numerous costs to sell a house.

Here's an overview of the various costs to sell a house.

Realtor's commission fees

The real estate commission is usually the biggest fee a seller pays — 5 percent to 6 percent of the sale price. So, if you sell your house for \$250,000, you could end up paying \$15,000 in commissions. The commission is split between the seller's real estate agent and the buyer's agent. In the majority (77 percent) of cases, the seller bears this cost, according to a 2018 report from the National Association of Realtors.

You may be able to negotiate a lower commission. Real estate agents are more likely to accept a lower rate when the home is expected to sell quickly, the local market is strong or the home price is relatively high.

Many homeowners try to avoid these high fees by listing their home as for-sale-byowner (FSBO). If you do that, be prepared to assume the duties of a real estate agent, including showing the place to prospective buyers, negotiating, hiring a lawyer to draw up the contract, and taking care of the transfer of title. Just 7 percent of home sales in 2018 were FSBO sales, according to NAR.

Home repairs

If you're thinking about selling your home, it's likely there are things you could do to enhance the appeal of your place and potentially raise its value. If you've been putting off sprucing up the exterior of your property, painting the inside, or repairing a staircase or a leaky faucet, now's the time to make those changes.

"Getting the home ready to be sold can require minor cosmetic work, like painting and decluttering, or major upgrades," says Jorge Guerra, chairman-elect of the Miami Association of Realtors in Florida. "Sometimes a new kitchen and bathroom can raise the value a significant amount."

Also, if the buyer's home inspector finds problems, such as a damaged roof or bad plumbing, you might have to pay to fix those issues in order to close the deal.

Big repairs can set you back financially, so be prepared for them before you decide to sell, especially if you expect problems will be revealed during a home inspection.

Pre-sale home inspection

A presale home inspection is strictly optional, and it could cost around \$400 or more. So why would you pay for one? Some sellers make the investment because they want to find out about any structural or mechanical problems with the house before a potential buyer comes in with his or her home inspector.

Getting a pre-sale inspection allows you to make major repairs ahead of time, removing any possibility of a buyer demanding them later or asking you to lower the price. Discuss with your real estate agent whether a pre-sale home inspection is recommended. Keep in mind that if your inspection reveals material defects with your home, you'll have a responsibility to disclose them to a buyer, depending on your state's laws for disclosure requirements.

Home staging

Buyers like to envision what a house could look like after they move in. If you're a seller, it's worthwhile to spring for cosmetic repairs, like fresh, neutral paint and new flooring. Improving curb appeal with fresh plants or flowers can really appeal to buyers without costing too much, says Grant Lopez, chairman of the San

Antonio Board of Realtors in

Twenty-eight percent of seller's agents said they staged all homes before listing, spending a median amount of \$400, according to a 2019 NAR

"Staging is usually helpful when the home is vacant. Realtors use the furniture to show the possibility of what that space can be," Guerra says."Depending on the furniture and the price of the house, (staging) can be very costly."

Hiring a professional to stage your home might pay off. Stagers do what's necessary to enhance a home's best features while minimizing its worst attributes, and help prospective buyers imagine themselves living there. They rearrange furniture and accessories, declutter and depersonalize the home. They may even repurpose a room in a way you wouldn't have imagined.

The cost of a professional stager varies according to the size of the home, the extent of the work, the length of time the house is on the market and other factors. Expect to spend several hundred dollars, at minimum, and possibly thousands if you need a professional stager.

If you plan to move out before you sell your home, you'll want to continue to pay for water and electricity. A home without air conditioning/ heat and lighting can be difficult to show to buyers.

Your current bills will give you an idea how much it will cost each month to leave on the utilities until a new buyer

Mortgage payoff

The proceeds of your home sale will be used to pay off your mortgage, but it's likely that the payoff amount on your mortgage statement is a little less than what you actually owe.

You'll likely have to add prorated interest you've accrued to the total balance. Additionally, you might have to pay a fee if there's a prepayment penalty associated with your mortgage. Check your loan documents or contact your current lender to find out if your loan includes this condition.

Selling one house and buying another? Use a calculator to determine how much house you can afford.

Closing costs and additional fees

While the closing costs to sell a house are typically the responsibility of the buyer, don't be surprised if you are asked to foot the bill, especially if you are trying to sell your home in a buyer's market (one which has a lot of homes for sale).

Some of these costs may include homeowners association fees, property taxes, attorney fees, transfer taxes and title insurance. You also may be asked to pay an escrow fee, a brokerage fee and a courier fee. Altogether, closing costs can range from 2 to 4 percent of the home's sales price.

"Sellers sometimes forget to budget for a title policy, which ensures that the title is free and clear," Lopez says. It is usually included in the closing costs, but you may be able to negotiate who pays it.

In fact, many of these fees are negotiable, and it's unlikely that a seller will be responsible for all of them. Still, it helps to be prepared.

Capital gains tax

Don't forget to consider taxes. When you sell a home for more than you paid for it, that counts as a capital gain and might need to be reported on your federal tax return.

The good news is, many homeowners are eligible to exclude up to \$250,000 of profit (\$500,000 for married couples filing jointly) of their main

home from tax, as long as they haven't used the tax break on another home sale within the past two years. The tax break applies if it was your primary home for at least two out of the previous five years.

Property tax

Sellers also need to remember property taxes, which are dependent on if they are escrowing into their mortgage, Lopez says. Property taxes are usually paid in advance. The seller should pay the prorated share of property tax up to the closing date, with the money placed in escrow.

However, if you're selling your home and have already paid taxes for the year, you may actually get a rebate at closing. The buyer will reimburse the seller for the portion of taxes already paid that apply after the closing date.


