■ A 1983 Downey High grad, Dan Hurlock will take over as fire chief next month.

DOWNEY – Dan Hurlock will officially take over as chief of the Downey Fire Department next

Hurlock is no stranger to Downey, as he is a homegrown member of Downey's community already.

graduating from Downey High School in 1983, he would go on to Long Beach City College and get his degree in electricity before transferring

to Cal State Long Beach and earning a degree in Business Management.

His career in fire fighting would not begin until 1997 when he was invited on a Downey Fire ride-along.

"I went on a ride along; loved it," said Hurlock. "I saw how much he loved his job, and the other guys how much they loved their job. So, I found this is right up my alley.'

Hurlock

began at the academy. He would later be hired by Downey Fire in 2000.

"I got involved early with teaching community CPR and first aid," said Hurlock. "I got involved with the Community Emergency Response Team (CERT), teaching there, and became the coordinator for that program.

2012, Hurlock was In promoted to Captain. A subsequent promotion Battalion Chief came in 2014.

With the announcement of current Chief Mark Gillespie's retirement, Hurlock will now take the reins at an exciting and critical time for both the department and the city.

Hurlock inherits four newly remodeled fire stations, two of which are complete and already moved into.

"The city definitely has taken care of our facilities with their commitment to remodeling all four stations," said Hurlock.

"It's definitely exciting. I got hired by the fire department almost 21 years ago, and they were talking about replacing

"To live in those facilities for 20 years, it's definitely exciting to have brand new facilities... The new facilities have definitely addressed some long overdue needs that needed to be addressed, and I'm grateful and excited for it."

He also steps in at a time where the city looks to navigate its way through the COVID-19 pandemic.

"Our operations have changed since the pandemic hit," said Hurlock. "It's required us to stock up on hard-to-get supplies, and make sure that we're going to be covered for as long as this pandemic lasts."

Hurlock Hospitals exceed capacity as doctors, nurses plead for common sense

■ Hospital workers received COVID-19 vaccinations this week as hospitals dealt with an influx of patients.

DOWNEY – Hospital workers at two of Downey's largest hospitals received COVID-19 vaccinations this week as both medical facilities struggled with an influx of sick patients and Human Services Agency, and that exceeded hospital capacity

Staff members at PIH Health Hospital Downey and Kaiser Permanente Downey Medical Center received their vaccinations at a critical time with COVID-19 cases surging across the county.

At Kaiser, COVID-19 patients were being treated inside hallways, conference rooms, and outdoor tents.

The number of local residents infected with COVID-19 has surged over the past several weeks, as people continue to congregate with others outside month could be facing a oncetheir households.

"The virus has spread across the entire county and everyone, employers and residents, need to be extra vigilant in

Ferrer. "This is not the time to crowd at stores, to attend parties and gatherings, or to travel. If every person can find it in themselves to celebrate the meaning of the holidays by protecting each other from the virus, we have a chance to stop the surge."

In a joint press conference Tuesday, officials with some of the state's larger hospital systems, including Kaiser Permanente, Sutter Health and Dignity Health, as well as officials with California Health others, pleaded with Californians to continue to take precautions against COVID-19.

"As hospital bed count continues to dwindle, we will not be able to keep up if [coronavirus hospitalizations] continue to increase," said Greg Adams, the chairman and CEO of Kaiser Permanente.

As of Tuesday, 113 people were hospitalized at PIH Downey for COVID-19. That is up from 53 on Dec. 9.

Hurlock. "One of my goals is to and qualified." implement training that leads to that, so that we have qualified people that can back-fill all the ranks as people move on and retire, and that they be skilled

In fact, Hurlock will likely be spending much of his first few months as chief by manufacturing his own leadership team and chain of command.

"The fire chief is leaving. I'm going to be filling his spot, which creates a vacancy in the battalion chief rank," said Hurlock. "Our assistant chief is going to be leaving; he announced his retirement at the end of the year also. That creates another vacancy in the battalion chief rank. There's potential the other two battalion chiefs could retire...I don't know what their plans are yet, but I'm sure I'll be finding out soon."

"There's potential for four promotions in the Battalion Chiefs' rank. If that happens, the people who fill the battalion chiefs are captains, so that means there's going to be holes in the captains' ranks...I'm going to be busy filling a lot of vacancies that are created through attrition and people retiring."

On a personal level, Hurlock says his goal is to be "the same person I've always been."

Holiday Safety Tips

The holiday season is upon us, and many pet parents plan to include their furry companions in the festivities. As you gear up for the holidays, it is important to try to keep your pet's eating and exercise habits as close to their normal routine as possible. Also, please be sure to steer pets clear of the following unhealthy treats, toxic plants and dangerous decorations. Be Careful with Seasonal Plants and Decorations

- Oh, Christmas Tree: Securely anchor your Christmas tree so it doesn't tip and fall, causing possible injury to your pet. This will also prevent the tree water—which may contain fertilizers that can cause stomach upset—from spilling. Stagnant tree water is a breeding ground for bacteria, and your pet could end up with nausea or diarrhea should he imbibe.
- Avoid Mistletoe & Holly: Holly, when ingested, can cause pets to suffer nausea, vomiting and diarrhea. Mistletoe can cause gastrointestinal upset and cardiovascular problems. And many varieties of lilies can cause kidney failure in cats if ingested. Opt for just-as-jolly artificial plants made from silk or plastic, or choose a pet-safe bouquet.
- Tinsel-less Town: Kitties love this sparkly, light-catching "toy" that's easy to bat around and carry in their mouths. But a nibble can lead to a swallow, which can lead to an obstructed digestive tract, severe vomiting, dehydration and possible surgery. It's best to brighten your boughs with something other than tinsel.
- That Holiday Glow: Don't leave lighted candles unattended. Pets may burn themselves or cause a fire if they knock candles over. Be sure to use appropriate candle holders, placed on a stable surface. And if you leave the room, put the candle out!
- Wired Up: Keep wires, batteries and glass or plastic ornaments out of paws' reach. A wire can deliver a potentially lethal electrical shock and a punctured battery can cause burns to the mouth and esophagus, while shards of breakable ornaments can damage your pet's mouth and digestive tract.

Avoid Holiday Food Dangers

- Skip the Sweets: By now you know not to feed your pets chocolate and anything sweetened with xylitol, but do you know the lengths to which an enterprising pet will go to chomp on something yummy? Make sure to keep your pets away from the table and unattended plates of food, and be sure to secure the lids on garbage cans.
- Leave the Leftovers: Fatty, spicy and no-no human foods, as well as bones, should not be fed to your furry friends. Pets can join the festivities in other fun ways that won't lead to costly medical bills.
- Careful with Cocktails: If your celebration includes adult holiday beverages, be sure to place your unattended alcoholic drinks where pets cannot get to them. If ingested, your pet could become weak, ill and may even go into a coma, possibly resulting in death from respiratory failure.
- Selecting Special Treats: Looking to stuff your pet's stockings? Stick with chew toys that are basically indestructible, Kong's that can be stuffed with healthy foods or chew treats that are designed to be safely digestible. Long, stringy things are a feline's dream, but the riskiest toys for cats involve ribbon, yarn and loose little parts that can get stuck in the intestines, often necessitating surgery. Surprise kitty with a new ball that's too big to swallow, a stuffed catnip toy or the interactive cat dancer.

Plan a Pet-Safe Holiday Gathering

- House Rules: If your animal-loving guests would like to give your pets a little extra attention and exercise while you're busy tending to the party, ask them to feel free to start a nice play or petting session.
- Put the Meds Away: Make sure all of your medications are locked behind secure doors, and be sure to tell your guests to keep their meds zipped up and packed away, too.
- A Room of Their Own: Give your pet his own quiet space to retreat to—complete with fresh water and a place to snuggle. Shy pups and cats might want to hide out under a piece of furniture, in their carrying case or in a separate room away from the hubbub.
- New Year's Noise: As you count down to the new year, please keep in mind that strings of thrown confetti can get lodged in a cat's intestines, if ingested, perhaps necessitating surgery. Noisy poppers can terrify pets and cause possible damage to sensitive ears. And remember that many pets are also scared of fireworks, so be sure to secure them in a safe, escape-proof area as midnight approaches.

Will a Biden presidency finally end the death penalty?

Despite a shift by the American public against the death penalty, Americans favored life in prison while 36% preferred the death each of the 13 executions since then. the most federal executions ever in a single year.

Three more executions were scheduled before Christmas. President-elect Joe Biden, however, made eliminating the death penalty part of his criminal justice reform platform, marking a reversal from his past support for capital punishment.

How will a Biden presidency affect the death penalty, and what are the issues about it that continue to cause debate and controversy?

"Executions are a form of torture that violate the Eight Amendment, which prohibits the federal government from imposing cruel and unusual punishment," says David Dozier (www. DavidDozierBooks.com), a professor emeritus in the School of Journalism & Media Studies at San Diego State University and author of The California Killing Field, a novel about the death penalty.

"The death penalty is a barbaric and sadistic violation of human rights that should be eliminated in the U.S. and around the world. The U.S. has a disgusting record for a nation that sees itself as a beacon for human rights. But the momentum of states abolishing the death penalty, and the growing bipartisan consensus against it, make Biden's goal of ending capital punishment a stronger possibility."

A 2019 Gallup poll on capital punishment showed that 60% of

the U.S. government under President Donald Trump has carried out penalty when they were asked, "Which do you think is the better penalty for murder?" Public support for the death penalty has dipped near a 48-year low.

> Dozier explains some key points about the death penalty heading into the Biden presidency:

> Legislative possibilities. Biden supports ending the death penalty through legislation and incentivizing the remaining death penalty states to do likewise. There are conservative lawmakers on board with ending the death penalty, but Dozier says a 6-3 conservative majority in the U.S. Supreme Court means "it is unlikely the Court will reconsider the death penalty anytime soon."

> **Reversing recent party history.** "The Democratic Party leaders have been shameful cowards with regard to human rights in general and the death penalty in particular," Dozier says. "The Clintons, Barack Obama, and Biden were pro-death penalty when it was still popular in the 1990s. Vice president-elect Kamala Harris, on the other hand, refused to seek the death penalty for an accused cop killer when she was the district attorney of San Francisco.'

> High costs of the death penalty process. A study in California revealed that the cost of capital punishment in the state has been over \$4 billion since it was reinstated in 1978, or \$308 million for

Other financial facts about the death penalty show capital cases in some states costing far more than non-capital cases and being much more expensive than life imprisonment.

"The complexity of seeking the death penalty and carrying out the execution is a long and expensive process," Dozier says. "Many capital cases are appealed. Incarceration on death row can span 10, 15, or 20 or more years. Capital punishment costs are an economic burden on government budgets. It's more cost-effective to commute death penalties to life imprisonment sentences without parole."

Demographics of death row. "The death penalty is often a poor man's punishment, and it is systemically racist," Dozier says. "Underpaid public defenders often defend the poor. District attorneys are more likely to go after defendants with few resources to fight their prosecution.'

Black Americans make up 13% of the population but 34% of persons executed since 1976.

"The American public is moving away from the death penalty," Dozier says, "and it's time for a new administration to do away with

The need for new antibiotics

The end of the COVID-19 pandemic is finally in sight.

Both Pfizer and Moderna have received emergency FDA authorization to distribute tens of millions of doses of their vaccines across the country.

This is fantastic news. Unfortunately, the scientific community can't rest on its laurels. An even worse pandemic is already looming. And this time, developing treatments will prove much more

This coming pandemic may not stem from a virus, but from drug-resistant bacteria and fungi known as "superbugs." These microbes already kill 700,000 people worldwide each year and infect millions more. And unless scientists invent new, more potent drugs, superbugs could kill 10 million people annually by 2050.

Antibiotics normally kill the vast majority of bacteria they encounter. But sometimes, a few microbes survive, reproduce, and pass on their immunity to future generations. Over time, certain strains of bacteria can become largely or completely impervious to even the strongest drugs.

Drug resistance could spell the end of modern medicine. Without effective antibiotics, common operations like Caesarian sections and hip replacements may become too risky, since patients could heavily in R&D, and turn a profit by selling any successful drugs in

contract lethal drug-resistant infections in the hospital.

Public health experts almost universally agree that superbugs pose an enormous threat. But relatively few drug companies are investigating new antibiotics.

It's not hard to see why: the antibiotics market is fundamentally

Doctors liberally prescribe cutting-edge treatments for diseases like cancer, multiple sclerosis, and diabetes. By contrast, doctors only use new antibiotics in emergencies. They worry about overprescribing new antibiotics, lest bacteria evolve to resist them.

Consequently, manufacturers sell relatively few doses of advanced antibiotics -- and generate comparatively little revenue. In fact, many have abandoned antibiotics R&D. Just four major pharmaceutical companies still have antibiotics programs, down from 18 in the 1980s.

Small biotech firms have taken up that research burden but haven't fared well in recent years. Startup Achaogen, for example, released a groundbreaking superbug treatment two years ago, but didn't generate enough sales and ultimately filed for bankruptcy in 2019. At least three other startups have similarly gone belly up.

Simply put, the traditional biotech business model -- invest

heavy volume -- doesn't work for antibiotics. For the sake of patients worldwide, policymakers need to find an alternative.

Consider the potential of a Netflix-style subscription model, in which insurers -- whether public or private -- pay recurring fees for unlimited access to new antibiotics. A modified version of this model already proved successful with Pfizer's COVID-19 vaccine. The U.S. government pre-purchased 100 million doses, with the option to buy an additional 500 million, which gave the company the confidence and funding necessary to develop the drug.

Governments could take a similar approach with antibiotics. Senators just proposed a bipartisan bill, the PASTEUR Act, which would allow the federal government to pay companies up to \$3 billion to provide new antibiotics to doctors and hospitals. Experts think G20 countries will have to provide \$4 billion in subscriptionlike payments to sufficiently spur the development of lifesaving

Right now, the antibiotics market is fundamentally broken. And unless policymakers fix it, the death toll from superbugs could make COVID-19 look tame by comparison.

COVID's threat to disabled Americans

The second wave of COVID-19 has arrived with a vengeance.

But there's hope on the horizon. Vaccinations from Pfizer and Moderna proved more than 90 percent effective in clinical trials.

People in the highest risk categories -- namely, healthcare workers and those with chronic illnesses and disabilities -- are receiving prioritized access to these vaccines. That's as it should be. Putting them at the front of the line for a vaccine is a way to collectively acknowledge that their lives matter.

But unfortunately, when it comes to diseases other than COVID-19, society doesn't show nearly the same level of concern for people with disabilities and chronic illnesses. In fact, many selfstyled healthcare experts have proposed "reforms" that would limit these individuals' access to treatments. That's wrong, plain and

By now, it's well known that COVID-19 disproportionately harms people with pre-existing conditions and disabilities. Of the roughly 250,000 Americans who've lost their lives, 94 percent had another condition listed as a factor in their cause of death. COVID-19 patients with intellectual or developmental disabilities have died from the virus at roughly twice the rate of the general patient population.

These vulnerable patients could soon face even more challenges if health insurers listen to groups like the Institute for Clinical and Economic Review (ICER).

The influential non-profit has appointed itself as an arbiter of new drugs' cost-effectiveness. ICER recommends a "fair price" for By Jim Hightower medications based on the analyses it performs.

To conduct these cost-benefit analyses, ICER uses a controversial America's power elites for Christmas. metric called a "quality-adjusted life year," or QALY. A treatment that adds a year of perfect health to a patient's life provides one QALY. And the more QALYs a drug generates per dollar, the more

In theory, QALY assessments provide an objective way to quantify drug's effectiveness -- and ensure that patients, insurers, and taxpayers are getting a good bang for their buck.

But in practice, these assessments discriminate against patients with disabilities and chronic illnesses. That's because patients with certain chronic diseases and disabilities may never achieve a full QALY. A drug could completely alleviate the patient's symptoms but wouldn't deliver a full QALY.

In other words, ICER uses its QALY metric to devalue the lives and well-being of vulnerable populations. And ICER's clout cannot be underestimated. If it considers a drug to not be cost-effective, insurers may listen and deny the medication to those who need it

evaluations don't end there. By placing such a low value on these treatments, ICER discourages biopharmaceutical firms from

investing in drugs that disproportionately benefit Americans with disabilities.

ICER isn't alone in signaling that drug companies shouldn't waste their time on treatments for Americans with disabilities. The outgoing Trump administration is still pressing forward with its efforts to tie Medicare drug reimbursements to the artificially low price of drugs in Canada and Europe, where price controls have long restricted patients' access to new medicines. If the administration's changes were implemented, investors could pull the plug on research projects targeting rare diseases.

Americans agree that the most vulnerable patients deserve priority access to COVID-19 therapeutics and vaccines. It's time for people to recognize that these vulnerable populations deserve access to treatments for other conditions as well.

So many of my patients have become infected with the CO-VID-19 virus. If you have, I hope that it was a mild case and that you have fully recovered.

But there is a peculiar twist to this strange disease. 10% or more of those who were infected continue to suffer from long-term symptoms, and

are becoming known as "longhaulers.'

In theory, they have recovered from the worst of the disease and have had a negative test. While

they are most likely to be over 50, to have two or three chronic illnesses, or to have had a serious COVID case, many young and otherwise healthy sufferers are also considered to be long-haulers.

Long-haulers appear to include two groups: Those who experience some observable permanent damage to their lungs, heart, kidneys, or brain, and those who continue to experience debilitating symptoms despite no detectable damage. The list of symptoms is long and inconsistent, and it is interesting that their long-term symptoms do not necessarily look like their original illness. The most common longhauler symptoms include:

Cough

Fatigue

Body aches Joint pain

Shortness of breath

Loss of taste and smell

Difficulty sleeping

Headaches

Brain fog

The leading theories are that the virus remains in the body in some small form, or that the immune system continues to overreact even though the infection has passed. Dr. Anthony Fauci, director of the National Institute of Allergy and Infectious Diseases at the National Institutes of Health, has speculated that many may have developed myalgic encephalomyelitis/chronic fatigue syndrome (which can also be triggered by other infectious diseases, such as mononucleosis, Lyme disease, and SARS, another coronavirus disease). Scientists have, so far, been unable to predict who might become a longhauler.

is to resume employment, family life, etc. while continuing to deal with debilitating symptoms. There is currently no intervention or treatment. For many, online support groups have been helpful.

To date, over 17.5 million Americans have been infected with COVID-19, and the number may climb to as many as 50 million. That implies that we could ultimately be dealing with millions more long-haulers; a lasting and significant problem for our country.


Downey parents who reside within the district boundaries and wish to have their student(s) attend a Downey Unified school outside of their attendance area may apply.



How Manny Esparza went from professional boxer to ceviche caterer

■ Athlete turned entrepreneur Manny Esparza turned his grandmother's ceviche recipe into a popular catering service that recently won an award for "Best Business Plan."

DOWNEY – When former professional boxer and jockey turned entrepreneur Manuel "Manny" Esparza decided to introduce Chapitos Ceviche delivery and catering services to the city of Downey, in the midst of an economy crippling pandemic, he knew he would need at least two things: a sustainable product that could find a niche in COVID-19 times and insight on how to attract customers

The product was his Grandma Estelle's passed-on through generations "special recipe" for ceviche, a staple in Mexico and sought after in Hispanic and Latino communities worldwide.

The insight came through his enrollment in the Miracle's Entrepreneur Program (MEP), a free 3-month course of study, administered by the Entrepreneur Educational Center, Inc. (EECI). leading to the development of a marketable business plan, connection with potential investors and industry mentors.

"I felt the unique taste of our ceviche would find a place on the taste buds of my customers and the word of mouth would help build a base to grow on," Esparza said. "But it was enrolling in the Miracle's program that gave me the organizational tools and resources I needed to move forward," he continued. "I'm thankful EECI was able to respond to COVID-19 the way it did."

"Thanks to a great deal of support from our partners in the

financial community and others, we were able to offer the free program to 12 individuals and certify a Miracle's Class of 2020, now on the way to hopefully realizing their potential and enriching the economic base of the communities they serve," explained EECI Executive Director Barbara J. Stanton.

"As a result of this year's program, 9 small businesses (DBA's), and 3 non-profit organizations have been created. These COVID 19 business start-ups will have the history of knowing that during the most tragic pandemic to come to this country, they endured, they planned, and they are convinced that their new businesses will do well," Stanton said.

The three brothers, all raised in Pico by their parents, played organized soccer since they were very young, went to El Rancho High School and are now all in the professional

Cesar, the oldest, is the head athletic trainer for the Picon. L.A. Galaxy and both Cristian and Alex play for the Seattle Sounders of the MLS.

The first time the two teams played, it was a game Cesar, Sr. and wife, Ana will never forget.

"It was very exciting," said Cesar, Sr., of seeing all three on the field as professionals at the same time. "Every family is always thinking about taking the kids to a different level, as far as sports go. It was a dream come true. To be honest with you, she (Ana) cried and I got goose bumps when that happened. It's been non-stop since then."

The Sounders have won two MLS Cups (2016, 2019) and have been in the championship game four out of the last five years.

Ana comes from a soccer family from El Salvador and had a nephew play for the national team and her dad was a legend in his neighborhood. She recently showed some of the awards the boys have earned, including their various championship rings. "As for Alex, he was going to go to a junior college in Arizona, but a late opening at Seattle University led him to a four-year college career," Picon added.

Alex, who is currently in a graduate program, was proud to have a family like no other.

"It's a life unlike any other," At the time, Cristian was in Alex Roldan said. "We're blessed, we're privileged and we have everything that was given to us not taking for



"People are hurting," said Hahn. "Through no fault of their own, people have lost jobs and wages, and small businesses have been shuttered. We designed this program to get food on families' tables while at the same time supporting restaurants that are struggling

The funding is being distributed to 10 non-profit organizations across the Fourth Supervisorial District. The non-profits will use the funding to purchase gift cards from small restaurants in their communities and distribute them to local families in need.

"2020 has been a very difficult year for a lot of families and local businesses," said Oscar Hernandez, executive director of Whittier Boys and Girls Club, one of the participating non-profits. "I think this a great idea, that helps both families who are struggling while at the same time, helping local restaurants in our area.


College launches STEM program for teachers

WHITTIER - Rio Hondo College is creating a program to guide community college and K-12 students through an education pathway focused on science, technology, engineering and math (STEM) and back to local communities in much needed teaching roles.

Called the Community Partnerships for Teacher Pipeline (CPTP), the program is made possible by a three-year, \$9 million U.S. Department of Education Supporting Effective Educator Development (SEED) grant that Rio Hondo College will share with El Camino College, Cerritos College and the Center for Collaborative Education, which serves as the fiscal agent. Each college partner will receive about \$900,000 over the life of the grant.

Students will be provided with a certificated teacher mentor in K-12 or community college, a success coach, workshops and handson classroom while taking pre-credential coursework. The program also includes a focus on special education and early childhood education teaching roles.

The program intersects with the College's larger STEM strategy, which is aimed at boosting enrollment in the high-demand fields for a new generation of students. As a result, it will also address the shortage of qualified STEM teachers in the workforce.




