# Trujillo criticized for plea bargain

■ The Downey council member and deputy district attorney is accused of offering a murder suspect 7 years in prison as part of a plea deal.

**DOWNEY** – Mario Trujillo, Downey's newest-elected city council member who works as a deputy district attorney, is being criticized for allegedly offering a plea deal of seven years in prison to a gang member accused of helping to kill another man in a case of mistaken identity.

Rudy Dominguez, 24, was charged with murder for the fatal shooting of 26-year-old Fernando Rojo in South Los Angeles in 2016. Although he did not pull the trigger, authorities said Dominguez drove the vehicle in a drive-by shooting that killed Rojo, who was mistaken for another gang member.

Dominguez faced a maximum sentence of life in prison without parole. FOX-11 obtained transcripts from a Dec. 15 court proceeding in which it's alleged that Trujillo offered Dominguez a plea deal that consisted of seven years in prison.

The offer was later declared invalid at a subsequent hearing.

Wednesday, On Mayor Frometa invited physicians Dr. James T. Lee of Kaiser Permanente Downey Medical Center and Dr. Yasmeen Shaw of PIH Health Hospital Downey, along with incoming Fire Chief Dan Hurlock, to a video taping at the city's Emergency Operations Center.

The short video will be released in time for New Year's Eve as a call to Downey's 113,000 residents to rethink their holiday weekend plans.

With a background in emergency management and disaster response, Mayor Frometa, who has worked in healthcare for the last 15 years, is pleading with Downey residents to stay home and avoid gatherings to help stop the unrelenting spike in infection and hospitalizations crippling area hospitals, including Downey.

From Dec. 9 to Dec. 26, daily hospitalizations increased by 674%.



first of all, we never even heard of anything," the victim's sister-in-law, Amy Rojo, told FOX-11 of Trujilo's plea offer. "From what we knew, it was a preliminary hearing, them trying to get everything together, then all of a sudden, it's kind of like, 'Oh, there's a 7-year plea on the table.' Nobody even spoke to us. How is it that our loved one is worth seven years?"

Trujillo, who was elected to the Downey City Council last month, delayed retirement to work alongside new L.A. County district attorney George Gascón who also was elected last month.

A spokesperson for Gascón told the L.A. Times that no plea deal was offered.

In a statement to The Downey Patriot, Trujillo said he couldn't comment on the specifics of the case.

"Thank you for this opportunity to address the rumors and accusations circulating in the media regarding an alleged 'backdoor' plea deal in an open case currently being prosecuted by the Hardcore Gang Division of my employer the District Attorney's office of Los Angeles County," Trujillo's statement read. "I am not able to comment about the specifics of any case with pending criminal and legal investigations.

"These attacks against my professionalism, ethics and integrity are reminiscent of the various false narratives that were made against me during my campaign for Downey City Council.

"I recognize that public scrutiny comes with the territory of being a public servant and an elected official. Still I continue to be steadfast in my oath and obligation to the residents of Downey to make sure all families are safe and healthy, our community is protected and our small business owners are supported. Simultaneously I will continue to represent the in pursuing Justice for ALL.'

"Please do your part and stay home," she said.

During a DUSD Board meeting, Board member Martha Sodetani made comments against the Houston Astros Baseball club. #### March

Downey saw no change in its representation in Sacramento and Washington, D.C. Congresswoman Lucille Roybal-Allard, Assemblymember Cristina Garcia and L.A. County Supervisor Janice Hahn were all easily re-elected.

Los Angeles County called a state of emergency over the coronavirus. Downey Mayor Blanca Pacheco urged residents to remain vigilant and protect themselves from potential scams taking advantage of the heightened fear over COVID-19.

State Sen. Bob Archuleta was named Legislator of the Year for 2019 by the California State Commanders Veterans Council. The award is given in recognition for leadership and efforts on behalf of California's veterans, active duty military, reserves, and the California National Guard.

Downey Unified and the U,S Army partnered for Military Career Week, letting students explore and discuss potential careers in the military after high school.

A team from St. Pius X – St. Matthias Academy comprised of faculty, parents and alumni, and led by Principal Veronica Zozaya ran the L.A. Marathon in support of the Los Angeles Catholic Education Foundation.

After several reports of inappropriate behavior at events sponsored by the California Contract Cities Association, Assemblymember Cristina Garcia introduced legislation that will "provide accountability and transparency of taxpayer dollars that flow to associations of local agencies or districts." Contract Cities came under scrutiny in May 2019 after a fistfight between two city officials left one person unconscious.

Downey real estate broker Steve Roberson was awarded Century 21's Quality Service Pinnacle Producer Award in recognition of his ongoing commitment to service.

The Downey High School Thirst Project Club, a student-led organization whose aim is to bring safe drinking water to communities around the world where it is not available, hosted a "Walk for Water" event on campus. The organization asked residents to walk around the stadium track, simulating the miles that individuals have to walk to get water in resourcescarce areas. The event hoped to raise funds to install fresh water wells in impoverished communities around the world.

Wilfrido Rodriguez of Downey and Ruben Gutierrez of Huntington Beach were each sentenced to a year in county jail and placed on formal probation for five years for falsifying documents and providing fraudulent engineering services for more than seven years.

Tensions heightened in Downey after a decontamination tent was spotted outside of Kaiser Permanente Medical Center. The hospital said that the tents had been deployed as part of a drill, and reiterated that they were prepared to protect patients and staff should COVID-19 testing be warranted.

Gov. Gavin Newsom announced that California public health officials had determined that gatherings of more than 250 people should be postponed or canceled across the state until at least the end of March due to the spread of COVID-19. Many

of Downey's annual fundraisers and community events are put into question.

LA County Department of Public Health declares a stay at home order to help curb the spread of COVID-19.

Kaiser Permanente contributed \$1 million to 10 leading public health organizations and collaborated with the CDC Foundation to strengthen the United States' public health infrastructure and response systems to stop the spread of COVID-19.

Downey Unified announces that school campuses will close for at least two weeks in response to concerns over the spread of COVID-19.The District establishes a pick-up lunch program for meals to be consumed off-site by students.

Government buildings begin to close and / or operate by appointment only with safety measures. Downey Theatre cancels or postpones its calendar up until May 11. Youth Sports also begin to suspend games and practices. Meanwhile, the city urged residents to stop hoarding food and toilet paper.

Steven Knott and Jeremy Anthony Alvarez, both of Montebello, pleaded guilty to the murder of Downey Police Officer and Marine veteran Ricky Galvez and multiple charges arising from a seven-victim crime spree between September 17 and November 18, 2015 in the cities of South Gate, Montebello, Bellflower, Paramount and Downey.

Downey's two animal shelters asked pet owners to stop surrendering their pets as operations were scaled back due to the coronavirus

Downey's first handful of COVID-19 cases are confirmed.

Downey Unified School District announced that campuses will be closed through May 5.

# Beware George Gascón

At his swearing in ceremony, Los Angeles District Attorney George Gascón announced he would eliminate cash bail for certain offenses, not seek the death penalty and not charge children as adults. He also promised to undo sentencing enhancements retroactively.

Beware the progressive prosecutor like Gascón. He's not the answer to all of mass incarceration's problems. The hope for reform lies in reducing the power he used for these changes, not celebrating it when it's used in agreeable ways.

Just recently progressive prosecutors have banded together throughout California to create the policies that only they can implement. The movement to elect more of them has taken hold in a number of jurisdictions, moreso during the pandemic when public health interests favored smart decarceration. It's motivated by the recognition that prosecutors control the process; they have more power than judges. Their decisions to proceed with charges aren't reviewable and disciplinary forces rarely act on them when they engage in misconduct.

There's a difference between discretion and power. Power is the ability to do something and discretion is the choice to do it.

Indeed, the accountability for sworn law enforcement agents who kill civilians depends on prosecutorial discretion. From 2005 to June 2019, 122 agents have been arrested for murder or manslaughter for deaths they caused from an on-duty shooting. That's for about 1,000 officer-involved shootings per year. The Breonna Taylor case exemplified one way of using that discretion: keeping evidence from grand jurors so as to keep Louisville police officers from being charged with homicide. The Attorney General exercised his discretion in not presenting evidence. Alternatively, San Francisco District Attorney Chesa Boudin's choice to charge the officer who killed Keita O'Neill in 2017 with manslaughter is an exercise of the same discretion. Discretion is the direction but power is the hinge. It can swing where it likes

The problem with Gascón's actions is that they only reinforce the prosecutor as the most powerful person in the system. His are called 'reformist reforms" meaning they "subordinate its objectives to the

criteria of rationality and practicality of a given system." All carceral complications flow from the fact that the entire system is flawed, not change the trial dynamic. LA County District Attorneys could inform just the man or woman who gets elected.

Because the public is so used to a system that advertises itself as adversarial but is, in truth, overbalanced in favor of one side, it's hard to imagine what a world with disempowered prosecutors looks like. It includes jury instructions that openly offer the option of jury nullification: fact-finders return a not guilty verdict even when a finding of guilt is supported by the evidence if the acquittal would better serve interests of justice; right now courts don't have to disclose the option but they can. Serious consequences for professional malfeasance would work too, including removing sovereign immunity for prosecutors so they're civilly liable for their misdeeds.

The best and most complete way to level the playing field is to eliminate plea bargaining thus requiring prosecutors to prove every case they bring. The trial penalty — the probability that a defendant will receive a longer sentence if he tests the state's case with a trial - provides prosecutors with much of their power. In 2013, Human Rights Watch reported that federal prosecutors leveraged mandatory minimum sentences over federal drug defendants to extract guilty pleas from them.

Jettisoning the plea bargain is an extreme solution - 90% of defendants accept these agreements and plead guilty. Bronx County, New York, tried it at the height of penal populism in the 1990's with the expectation that judges would dole out longer sentences. Instead, judges became more lenient, plea bargaining dropped only 11%, and the dismissal rate —and the backlog — both increased by more than 20%. Any vacation from these agreements likely wouldn't last. Indeed, in the few jurisdictions that experimented with removing plea bargaining as an option to resolve a case, all reversed their bans.

Gascón can't undo sovereign immunity — even though it's entirely a judicial construct. Besides, making these lawyers answerable in civil court assumes that harmful tactics by prosecutors are all actionable; they're not — that's the problem. He can't rewrite jury instructions; that duty belongs to the Judicial Council.

The new District Attorney can institute one change that would sentencing bodies of what the proposed plea bargain was. Knowing exactly how much of a discount a defendant deserved in the state's eyes may cause sentence lengths to drop. Right now, sentencing judges can't know the proposed plea, a practice that must benefit the government otherwise prosecutors would have stopped it.

It's disingenuous to seek between five and 20 years when a defendant's initial offer was just probation. That's what happened to me. I don't know if the judge would have sentenced me to an effective sentence of nine years if he knew the state's attorney demonstrated that probation was appropriate through his plea offer.

Of course, drawing down prosecutorial power would end up preventing the good use of discretion. But evening out the power in the adversarial system would create a bigger, more wholesale change where defendants and constituents alike wouldn't look to the grace of one person to get justice. That's the problem of the progressive prosecutor. Benevolent or not, he's still king of the system.

It's essential to remember that these changes might not even realize; Gascón's revolution is a bit of a mirage. Dozens of "line prosecutors" who may not share his values and vision do most of the work. They're the ones who made the calls on most of the 303,363 cases that appeared in Los Angeles County in 2019; they'll resist losing that autonomy.

When a similar elimination of cash bail was headed to New York state in 2020, one assistant district attorney trained lower tier prosecutors on how to circumvent the new rules. The pandemic's effect on court proceedings prevents us from knowing how many even tried this, much less how many succeeded. They may try the same in Los Angeles. Sabotage lurks in the offices of many progressive prosecutors.

Gascón's goals are laudable and he has the cojones to implement them, but the imbalance and rot in the system remains the same after his announcement. In fact, it might even be stronger.





Members of Downey Girl Scout Troop #01173 that attend Our Lady of Perpetual Help School earn their Silver Award (the highest award a Girl Scout can achieve as a Cadette). They came up with a project they called "SEW 'n LOVE," where they made handmade sewn pillowcases. Each pillowcase contained personal notes of hope for local orphans at Niños Latinos Unidos in Bellflower. The girls also made their project sustainable, with other local troops volunteering to continue making pillowcases for the orphanage.

City Council begins discussions on a temporary moratorium on tenant evictions in response to the financial impact many were feeling due to COVID-19. The idea garners pushback from property owners who feared that such action would be taken advantage of by renters.

Restaurants are forced to adapt to take-out service only. The Chamber of Commerce encourages residents to support local businesses who may be struggling during the pandemic.

Downey City Council reluctantly approves a new Verizon cell tower to be placed at the city's public works maintenance yard. Verizon received a fair amount of criticism from Council notably Alex Saab - who felt the company had not been a good partner to the city concerning its previous towers.

Desert Reign Church pastor Alex Bernard dies one week after testing positive for COVID-19. He is Downey's first publicly identified coronavirus death.

#### April

Downey residents - including notable fashion designer Johana Hernández - begin making masks for healthcare workers on the frontlines of the fight against COVID-19.

Downey receives an \$18,000 grant from Los Angeles County Supervisor Janice Hahn to purchase senior meals for seniors unable or unwilling to leave their homes during the pandemic.

DUSD officially announces that campuses will remain closed, and that students would finish

more severe COVID-19; The ability of the hospital and health systems to handle surges; The ability to develop therapeutics to meet the demand; The ability for businesses, schools, and childcare facilities to support physical distancing; and The ability to determine when to reinstitute certain measures, such as the stay-at-home orders, if necessary.

A drive-up Covid-19 testing site opened in Bellflower, the closest testing site to Downey at that time.

Residents Kandy, David, and John Grzebyk decorated their van and cruised the Easter Bunny around town to help spread some Easter fun during quarantine.

Kaiser Permanente comes to an agreement with its unionized workers to ease some of the major burdens they face on the frontlines of the coronavirus pandemic, including assistance with child care and temporary shelter, and extra leave for workers who are tested or diagnosed with COVID-19. The measures provide support for 80,000 workers who are members of the Coalition of Kaiser Permanente Unions, including full-time, part-time and per-diem employees.

Brookfield Healthcare Center is listed as one of the over 250 skilled nursing facilities in California to have been impacted by COVID-19. More than half of the facilities listed are within LA County.

Downey attorney Ricardo Perez purchased and coordinated with local businesses to have delivered 200 lunches to Downey first responders. As a way to contribute to the local economy, all lunch purchases were made at local small business restaurants.

PIH Health Hospital in Whittier begins offering drive-up COVID-19 testing.

Downey and Warren high schools are named among the nation's best high schools, according to U.S. News & World Report.

The Downey City Council approved an agreement with Kanopy, Inc., opening up over 30,000 independent and documentary films, specializing in content of unique social and cultural value to library cardholders.

A three-year pay raise for Downey Police Department was given the go ahead by City Council. Homegrown resident and longtime realtor Carrie Uva announced her intent to run for the city's District 5 seat.

Robert Thome, a renowned artist who founded the Art of Rancho Exhibit at Rancho Los Amigos National Rehabilitation Center, passed away at the age of 65.

Longtime Downey resident Jose Rodriguez announces that he will be running for Downey's School Board. He is given the endorsement of Tod Corrin, who announced that he would not be seeking reelection.

Downey Mayor Blanca Pacheco makes history, installed as president of the L.A. County division of League of California Cities, representing 86 cities in Los Angeles County. She is the first Downey official to lead the League of California Cities.

The Columbia Memorial Space Center hosts its annual Rocket Fever event virtually. The always popular rocket launches are still included, with over 700 rocket kits being sent to kids all around Southern California, a fraction of which were able to be sent back to the museum for launch.



On-street parking conditions along the aforementioned portion of Newville Avenue have become more impacted from nearby uses, hence resulting in nuisances for the residents along the aforementioned limits of the street. In addition, a petition was received from the residents of the proposed preferential parking district on Newville Avenue showing the necessary contact rate and level of support for the establishment of the district and parking prohibition. Staff has also verified that the boundaries of the proposed residential preferential parking district represent a reasonably self-contained area and that the district and parking prohibition will be effective in addressing the on-street overflow parking issue on Newville Avenue.

Upon the conclusion of the public hearing and adoption of a resolution by the City Council establishing the proposed residential preferential parking district and accompanying parking prohibition and verification that a minimum of 50% of the residents parking p days of the passage of the resolution, signs establishing the residential preferential parking district and parking prohibition will be posted along the aforementioned portion of Newville Avenue. Up to two residential permits and one quest permit per household may then be purchased by residents residing within the district. If fewer than 50% of residents obtain permits, or if the number of permit holders falls below 50%, however, the City Council may repeal the residential preferential parking permit district during a public hearing noticed at least 10 days in advance

In addition, the preferential parking district may be terminated by resolution of the City Council through a noticed public hearing upon receipt and verification of a petition signed by a majority (50% plus one) of the property owners within the district. Such determination shall be based upon a finding that the conditions set forth in the establishing resolution no longer exist or have diminished to such extent that the continuation of the district is unnecessory






