Shutdown eases starting Friday

 Restaurants can resume outdoor dining, and nail/ hair salons can reopen with limited capacity. LA County will follow state's guidance.

DOWNEY – Restaurants can begin serving customers outdoors again starting Friday as the state moved this week to ease its stay-at-home orders.

Other industries can also with restrictions, reopen including:

nail and hair salons at 25% capacity

indoor malls and shopping centers at 25% capacity (food courts must remain closed)

miniature golf courses and batting cages at 50% capacity museums, ZOOS and

aquariums at 50% capacity

cardrooms at 50% capacity Fitness centers can open with outdoor operations, and all hotels can open for tourism and individual travel.

Outdoor private gatherings are allowed for up to three households and a total of 15 people.

Non-essential businesses must remain closed from 10 pm to 5 am

Construction begins on **Rives Mansion coffee shop**

• Owners of the historic property received approval to build a 1,200 sq. ft. coffee shop in the mansion's front yard.

DOWNEY - The sight of earth-moving equipment and construction fences around Downey's historic Rives Mansion has signaled that work has begun on a controversial coffee shop approved in 2019.

Officials with the city's Planning Department confirmed that work on a 1,200 square foot coffee and juice bar structure has begun on the property.

While nothing is certain due to the unpredictability of how Covid-19 will affect project progress, Community Development Director Aldo Schindler estimated that work could be finished within 18 months.

Construction of the coffee / juice bar is by and large a catch 22 for the city, who said they wished to see the property restored to its former glory yet has clearly stated that it is not in the financial position to do so.

DOWNEY – Growing up just southwest of Downey, Jose Rodriguez recognized the importance of education from a very young age. With this at the forefront, Rodriguez worked hard in school and ultimately was accepted into UCLA where he began to study Civil Engineering.

"My dad always told me that I was going to college. I was a super naive kid, but luckily I did well in school, got good grades, played football and got into UCLA," shared Rodriguez. "I was extremely fortunate."



The COVID vaccine is finally starting to roll out...but oh, ever so slowly. What does the vaccine mean for our return to a "normal" life?

There are so

many moving parts to this question. The first job is to simply get enough people vaccinated. We are just getting started; as I am



A second major issue will be to determine just how long immunity lasts from the vaccination. The Moderna and Pfizer-BioNTech vaccines could offer immunity against COVID-19 for months... or perhaps for up to two or three years. Only time and research will determine the exact duration of protection. Vaccinations will likely end up being administered annually (like the flu vaccine), and modified due to viral mutations.

The third issue is that those who are vaccinated can potentially still become infected. Full immunity from the vaccine occurs about one to two weeks following the second and final dose. Once you have been fully vaccinated, your own risk of getting symptomatic or severe COVID-19 drops dramatically. However, the studies looked at whether vaccinated people develop the symptomatic disease, and did not identify asymptomatic cases. A vaccinated person could still get infected and pass along the virus.

A fourth issue is that it appears that a significant proportion of the United States population does not currently intend to become vaccinated. This will keep the virus present and able to spread, and prevent or delay herd immunity.

Finally, this is an ever-changing/mutating virus. Our approved vaccines are absolutely effective. However, in time a new strain could conceivably spread a new COVID infection before new modified vaccines can be developed and distributed.

So, when will the masks come off? 2020 gave us all a lesson in how air-borne illnesses are spread, and masks are giving us, particularly the most vulnerable among us, some protection. Many may continue to wear them. (And, when will each of us choose to go back to handshaking, given that this is such a perfect way to spread germs?)

Those who become fully vaccinated will certainly enjoy a new level of freedom together. They will gather, carpool, enjoy a coffee together...indoors! Visiting vaccinated elderly friends and relatives will become safer.

However, these behaviors will still carry some risks. Theoretically, one fully vaccinated person could carry an asymptomatic case of COVID and spread it to others, even to those who are vaccinated. Any non-vaccinated person could then experience a serious illness. It will be wise for some time to restrict all unmasked gatherings to only those who are vaccinated, and to continue to mask and socially distance when with anyone who is not fully protected. The fully vaccinated person is unlikely to experience a serious illness, but could pass the virus on to someone who is not fully protected.

Does this mean that future gatherings should require proof of vaccination? I have certainly been reading about the possibility of concerts, commercial air flights, and sporting events requiring proof of immunity.

Looking into my own personal crystal ball, I predict that we will be moving to a new version of normal. Relatively easy, lowcost public health precautions like wearing masks, distancing, and keeping our hands clean will remain a part of our lives for some time. Stay safe...and please, please get vaccinated!

How to choose the right healthcare plan

Last month, HealthCare. gov's open enrollment period concluded. But consumers may still be able to sign up for coverage. People who have lost employer-sponsored insurance, moved, or experienced other significant life changes may be eligible for a special enrollment period.

Choosing the right health plan can be difficult in the best of times. The coronavirus pandemic has made shopping for health coverage even more challenging.

Health insurance agents and brokers can ease the process of finding the right health plan. Consumers should consider consulting with an agent or broker to ensure they select a plan that provides the coverage they need at the most affordable price.

In 2020, many people shopped for coverage on the exchanges for the first time. More than 20 million people lost their jobs -- and often, their employer-sponsored coverage

-- early in the pandemic.

Open enrollment was busier than expected, exceeding previous years. In the first week, nearly 820,000 Americans signed up for coverage -- over 170,000 of which were new consumers. The rate of new daily signups outpaced the previous year's by almost 15 percent.

Signups via special enrollment have skyrocketed because of the COVID-19 pandemic. Between the end of open enrollment in 2019 and May 2020, the number of people who utilized a special enrollment period because they lost their existing coverage increased 52 percent, compared to the same period the previous year.

A new report from the Centers for Medicare and Medicaid Services offers case studies of who some of those enrollees are. They're people like Rahul, a

31-year-old flight attendant who lost his employer-sponsored coverage when he lost his job because of the pandemic-fueled decline in air travel. He knows he needs basic coverage until he

can find a new job with health insurance -- but may not know where to start.

Or take Ava, the 26-year-old freelance writer who is no longer able to stay on her parent's plan. Because she's never bought her own insurance, she's unsure what the difference is between a deductible and a premium.

Rahul and Ava aren't alone. According to an October 2020 survey, 72 percent of Americans find purchasing or using health insurance confusing.

Agents and brokers are specifically trained to help people make decisions about health insurance. They're licensed by the states in which they practice and required to undergo continuing education.

They also work for their clients, not insurance companies. They advocate on behalf of those clients when billing or claims disputes arise.

Agents and brokers helped about 4 million people sign up for exchange coverage that took effect last year -- about 50 percent of the total. Further, agents and brokers are more effective at getting people covered than federally funded navigators. According to the CMS report, the average agent or broker enrolled 48 percent more people than the average navigator. And agents and brokers did so at lower cost -- about 9 percent less.

It's no wonder nearly 84 percent of marketplace enrollees who have used an agent or broker found them helpful. Indeed, as the CMS report concludes, "Health insurance agents and brokers put a local, friendly face on the often-stressful process of buying coverage, while also offering deep market and product expertise tough to find elsewhere."

The pandemic has made securing health insurance coverage more important than ever before. Agents and brokers can be crucial aides in that pursuit.

Larry King, talk show host

Larry King, the well-known talk show host who was the star of CNN's "Larry King Live" for 25 years, interviewing a wide variety of prominent people, died Jan. 23 in Los Angeles at age 87.

King presided over "Larry King Live" from 1985 to 2010. He also hosted the nationally syndicated talk radio show "The Larry King Show," featuring interviews and call-in segments, The Larry King interview from 1978 to 1994.

He wrote a column for USA Today from 1982 to 2001, and he wrote a number of nonfiction books on topics including baseball, his history in entertainment, and his experience with heart disease.

King was honored with Peabody Awards for both his radio and TV shows, won 10 CableACE Awards, and was ranked the best TV talk show host of all time by Talkers magazine.

Mortimer Dorris

December 19, 1923 - January 18, 2021

Mort passed away in his sleep on January 18th, after a long battle with Parkinson's and then a brief battle with COVID. He was born to Edwin Drake and Irene Bonnett Dorris and grew up in Riverside, California. He married Maurene Fife in 1946 and they recently celebrated 74 wonderful years of marriage. They moved to Downey in 1952 and still reside in the family home.

He was a member of the Greatest Generation, serving his nation in the South Pacific as an Army Air Corps B24 bomber pilot. After the war he entered USC and graduated in 1949 with a bachelor's degree in Civil Engineering. After 19 months more of graduate studies at USC, he was hired by The Bechtel Corporation in January of 1951, where he spent his whole career. He was located both stateside and abroad. While stationed overseas in London, England, and then in Jubail, Saudi Arabia, he was eventually in charge of The Jubail Project. It was the largest civil engineering project in the world, creating a city for 370,000 people, the infrastructure for 16 primary industries, and a dual port shipping center. He retired from Bechtel in 1988. He lived a life full of love, family and adventure. Many family trips were taken to the lake, beach camping and water skiing, as well as many weekends spent at the family beach house, swimming in the surf, building sand castles and yes, digging holes, and playing lots of cards. He was an avid golfer. He took up scuba diving when he was in his 60's, which led to trips to the Red Sea, Cozumel, Belize and the Cayman Islands with multiple family members going with him.

soft interview style, in which he typically asked questions perceived to be easy and lightweight. He was most likely to ask simple questions, like "What do you do?" or "How does that work?"

This led some to label his interviews unsubstantial, less useful than interviews that dig in on controversial topics and don't let up. But King maintained that by skipping the harder-hitting questions - ones he called "combative" - he encouraged his subjects to open up and be candid.

The strategy gained King interviews others didn't get, as when he interviewed the famously reclusive Marlon Brando in 1994 and televangelist Tammy Faye Messner just one day before her death from lung cancer.

"When I ask a question, it's almost like I'm saying 'help me,'" King told GQ of his interview style in 2015. "I think basically that's all we're doing: 'help me understand.' Help me. Explain that to me. 'Mr. President, you bombed Syria today. Help me understand why."

Hank Aaron, home run king

Hank Aaron. the Hall of Fame slugger for the Braves who held the Major League Baseball career home run record for 33 years, died Jan. 22 at age 86.

Born Henry Louis Aaron on Feb. 5, 1934, Aaron grew up in poverty and as a child had to fashion homemade bats and baseballs to practice the sport.

After excelling in the Negro Leagues and minor league baseball, Aaron made it to the



majors with the 1954 Milwaukee Braves. Though he had a respectable rookie season, it was in the following year that he began to hit his stride, batting .314 with 27 home runs and 106 RBIs.

In 1957, he led the Braves to a World Series win against the New York Yankees and was voted the National League's MVP. He hit 44 home runs in '57, a total he matched again in 1963 and 1966, the year the team relocated to Atlanta, Georgia.

Home run record

Already a Hall of Fame shooin after joining the 3,000-hit club in 1970, Aaron ended the 1973 season with 713 home runs, just one behind Babe Ruth's long-standing record.

Aaron endured racist hate mail and death threats throughout the offseason, though they were balanced by an outpouring of support from fans. He tied Ruth's record with his first swing of the 1974 season, and he hit his 715th home run April 8, 1974, at the advanced baseball age of 40, to take sole possession of the record.

He retired after the 1976 season with 755 home runs, a record that stood for 33 years until Barry Bonds broke it in 2007.

During his career, Aaron also racked up 3,771 hits while maintaining a .305 batting average and appeared in 25 All-Star games.

After retirement

Aaron was voted into the Baseball Hall of Fame in 1982, his first year of eligibility. In retirement, he worked as an executive for the Braves, becoming one of the first Black executives in high-level MLB management.

In 1999, Major League Baseball began awarding a yearly Hank Aaron Award for the best overall offensive player in the American and National leagues. He was presented with the Presidential Medal of Freedom

in 2002

On the racism he faced as he pursued the home run record, Aaron said: "That didn't bother me as much as you hear. Jackie Robinson had set the tone, and I was not about to fold the tent. I was there to perform my duty, and I knew that I had been given the opportunity to play. And just for a few people to write a few letters and all these other things, it didn't make any difference to me."

Jimmie Rodgers, rock and roll star

Jimmie F. Rodgers, an early rock and roll star who had a No. 1 hit in 1957 with "Honeycomb," died Jan. 18 at age 87.

After serving in the U.S. Air Force during the Korean War, Rodgers appeared on the popular TV program "Arthur Godfrey's Talent Scouts," winning a cash prize and boosting his burgeoning musical career.

The young singer and guitarist recorded a version of the 1954 pop single "Honeycomb," and his 1957 cover became a hit, soaring to No. 1 and staying there for a month.

His subsequent 1950s hits include "Kisses Sweeter than Wine," "Oh-Oh, I'm Falling in Love Again," and "Secretly." While the peak of Rodgers' career came in the '50s, he would chart a few songs in later decades, including "No One Will Ever Know" (1962), "It's Over" (1966), and "A Good Woman Likes to Drink With the Boys" (1967).

"It's Over," written by Rodgers, was later recorded by Elvis Presley for his "Aloha from Hawaii" concert.

Mira Furlan, **TV actress**

Mira Furlan, an actress best known for her roles on the TV shows "Babylon 5" and "Lost,"

died Jan. 20 at age 65.

Furlan began her acting career in her home of Zagreb, in the former Yugoslavia. She and her husband, director Goran Gaji, immigrated to the U.S. in 1991 amid the Croatian War of Independence.

There, she joined the Actors Studio and began getting U.S. acting jobs, landing a notable one when she was cast as Minbari Ambassador Delenn on "Babylon 5" in 1993. Furlan was among the central characters of the show's ensemble cast for its entire five-season run.

Several years later, she landed a notable recurring role on the hit series "Lost," playing shipwrecked scientist Danielle Rousseau, who was a key part of the island's weird mysteries. Furlan also appeared on an episode of "NCIS."

Later in her career, she frequently returned to Croatia to act in films and TV shows.

Randy Parton, country singer

Randy Parton, a country music singer and songwriter who was Dolly Parton's younger brother, died Jan. 21 at age 67.

Parton began his musical career in the 1970s, releasing singles including "Hold Me Like You Never Had Me," "Shot Full of Love," and "Roll on Eighteen Wheeler," which was later a hit for Alabama.

He also sang the song "Too Much Water" for the soundtrack to the 1984 movie "Rhinestone."

Eight years younger than his sister, Dolly, recorded duets with her including "Old Flames Can't Hold a Candle to You" (1980) and "You Are My Christmas," for Dolly's 2020 Christmas album.

Parton headlined a show at the Dollywood theme park for many years, and he was the former owner of a theater in Roanoke Rapids, North Carolina.

continued her education and enjoyed playing paper dolls, house, school, secretary, jacks skating, and many other childhood activities.



California lawmakers must address the issue of tort reform in 2021

It's time that California lawmakers take tort reform more seriously. Just this year, the Golden State ranked No. 3 on the American Tort Reform Foundation's Judicial Hellholes Report, which, according to the report, "focus[es] primarily on jurisdictions where courts have been radically out of balance." It's appalling to me that we've allowed our courts to get so out of hand that we've earned one of the top three spots on this list. It should appall every single one of us, particularly those of us who are employers or small business owners

You see, when a state is plagued by the level of lawsuit abuse that California is, the business community suffers immensely. And, given the damage that the ongoing COVID-19 pandemic has done to California's businesses in the past year, many local businesses do not have the capacity for the additional suffering that comes with operating a business in such a litigious state.

In evaluating the laws that are contributing to California's lawsuit abuse problem, several stick out to me. One of which is the Americans with Disabilities Act (ADA), a law intended to do good, only to be abused by greedy trial lawyers for years.

To put it into context, by mid-2020, California was host to more federal ADA accessibility lawsuits than any other state, with a whopping 2,702 federal claims filed by July. New York came in at a distant second, with nearly 2,000 fewer claims. While the law by its nature is very good, abusing this law hurts the very people it was

intended to help.

Part of the problem stems from California's Unruh Civil Rights Act, which enforces a fine of \$4,000 per ADA violation, on top of the attorneys' fees. This fine does not exist in any other state, making California an outlier. What's worse, it doesn't matter how frivolous the lawsuit is, the fine remains in place.

With that incentive in mind, trial attorneys continue to abuse the system by seeking out any minor, technical ADA violation they can find in order to make easy money at the expense of whatever unlucky small business they decide to target. These lawsuits range in ridiculousness, but common examples include lawsuits over a mirror being slightly too high on the wall or a recycling bin being an inch too close to the door.

Another problematic law is California's "Sue Your Boss" law, otherwise known as the Private Attorneys General Act (PAGA). To put it simply, PAGA allows any "aggrieved" employee to sue their employers on behalf of themselves, other employees, as well as the state of California.

Just as some ADA claims, PAGA lawsuits can be as trivial as they come. Common PAGA claims include typos in employees' pay stubs or suing an employer because they failed to print their address on the paystub even though it was printed on the paychecks themselves.

As you can see, PAGA is another example of a law intended for good – as it was originally meant to protect California workers – only

to be taken advantage of by trial lawyers looking to turn a quick buck.

These are just two examples of the many laws that must be addressed by our lawmakers in order to begin improving California's litigious reputation and make it the business-friendly state it once was.

It's also worth noting that it is not just employers and small business owners that are impacted by lawsuit abuse. It's everyone. In fact, The Perryman Group found that excessive tort costs have led to an estimated \$15.1 billion lost in direct costs to Californians each year, as well as 242,761 jobs and a \$594.74 "tort tax" per Californian.

Given the state of our economy, the ongoing COVID-19 pandemic and the destruction it brought with it, our lawmakers must take the issue of tort reform seriously, as it's draining precious resources, dollars and jobs that we simply can't afford to lose right now.

By meaningfully addressing tort reform, California can once again welcome new businesses, which will in turn create more jobs, allowing our great state to pick up the pieces that COVID-19 left behind a little faster.

U.S. should vaccinate its own first



The public needs a clear answer to that question.

There are powerful reasons to oppose COVAX's vaccine-sharing principles.

First, U.S. taxpayers poured billions into Operation Warp Speed to develop the vaccines with the understanding they'd get a large share of initial production. When Trump refused to join COVAX, The New York Times slammed the decision as "vaccine nationalism," but Americans desperate to get vaccinated are unlikely to be worried about political correctness.

Second, the U.S. is striving to reach herd immunity by summer, which scientists predict will require about 70% of the population to be vaccinated. Diverting some of the vaccine supply to COVAX would endanger that goal.

On Monday, the International Chamber of Commerce joined the call for equitable distribution of vaccines, arguing that helping poor nations will benefit the economies of wealthy ones. True in the long run, but vaccinating a quarter of the population of every country, as COVAX proposes, would necessitate the US and other developed countries giving up a return to normal this year.

Third, as new virus variants emerge, vaccination becomes even more a race against the clock. Otherwise a variant could appear that is not susceptible to the vaccine. Moderna announced Monday that its vaccine is somewhat less effective against the recently identified South African variant. People may need yearly boosters against emerging strains.

In the last two weeks, both the European Union and the U.S. have been hit with unexpected news about manufacturing setbacks. Monday the European Union actually threatened to ban Astra-Zeneca from exporting any doses until it meets its contractual obligations.

On Thursday, Anthony Fauci informed the World Health Organization that the Biden administration will participate in WHO's vaccine-sharing project. That reverses President Donald Trump's "America First" approach. Fauci says the goal is to ensure "equitable access" to vaccines for all countries in the world, rich and poor alike.

Americans scrambling to get vaccinated have a right to know how sharing doses with poor countries will affect their own ability to get vaccinated.

Biden is coming under pressure from the public health community to share the vaccine supply the U.S. has prepurchased before all Americans who want shots receive them.

The vaccine sharing project, with the acronym COVAX, raises money to buy vaccines for poor countries and asks the wealthier countries to donate actual doses. The COVAX dose-sharing principles, released Dec. 18, are causing controversy in France, England, Canada and other countries struggling to get their own populations vaccinated. COVAX wants countries to share their doses as they receive them, rather than waiting to see what's leftover. So far, Norway has agreed.

WHO Director-General Tedros Adhanom Ghebreyesus says it's unfair for younger, healthy adults in countries like the U.S. to get injections before the frail and elderly in poor countries. He calls it a "catastrophic moral failure."

Similarly, Kate Elder of Doctors Without Borders objects "if a

healthy 20-year-old in New Jersey is getting vaccinated before a front line health care worker in South Sudan.

Bruce Aylward, a WHO adviser, claims it's unacceptable for a country to vaccinate its entire population before offering doses to the highest risk inhabitants of poorer countries.

Duke University public health experts also argue that high-risk groups in poor countries should get the vaccine before the U.S. public. A report from the Duke Global Health Innovation Center complains that wealthy countries are monopolizing the initial supply.

U.S. will comply once there is "sufficient" supply here. What does "sufficient" mean? When just those at highest risk are vaccinated, as globalists propose, or when shots have been offered to all Americans?







I filled my pen and prepared to copy the written capital "A" from the blackboard in front of me. When I put the pen to the paper, it decided to burp. There was a big blob of ink on my paper.

Ah, but I had a blotter. I laid my pen down and attempted to blot the blob. Somehow I managed to set my pen too close to my paper and the paper began to drink the ink.

Now I had another blot and a much bigger one. I tried to cover up this blot with my arm and soon had a black cuff on my sweater. I glanced at my friend Bobby across the aisle to see if he had noticed my blunder. He was making this neat row of A's with such ease that even though I loved him since grade one, I suddenly hated him.

Now the boy behind me discovered how to shake his pen to make black polka dots on the back of my white sweater. I wadded up my paper, looked around to see if the teacher was looking, and stuffed it in the ink well hole in my desk. Finally, I found a use for that hole.

I started with a fresh sheet of paper only to find that my pen was now out of ink. My luck finally kicked in and the bell rang dismissing us from school for the day.

When I arrived home, my mother said, "I see you began penmanship class today. You had better go wash up." How could she tell?

I looked in the mirror, and could see a black smear across my forehead. Now I learned the definition of indelible. Indelible

went to the principal's office. It turns out that I had nothing to be upset about. The meeting was to show me my son's very high scores on intelligence tests and to let me know that based on his performance, Todd was capable of doing whatever he chose in this world. This conference helped to explain some of Todd's rather unusual behavior.

When he was in the sixth grade, I had another conference - this time with his teacher. I was again wondering what the reason would be for our "talk." Turns out, the teacher wanted me to know that Todd had an auditory retentive memory. I didn't know for sure what that was.

It turns out that a person with this ability remembers everything he hears. No wonder Todd did very little homework. Not only in school, but in many professions this is a very useful ability. Remember Johnny Cochran who was O.J.'s attorney? He had this gift.

Todd continued to achieve

high marks in all that he tried. He taught himself to play the guitar. He was a star athlete. He was an all-A student. He was a gifted writer, and he had many other accomplishments. His school performance gained him entrance to the University of California at San Diego.

I learned about the end of Todd's career at UCSD from a phone call that no parent ever wants to receive. Todd committed suicide by jumping off his dorm. We now know he inherited bipolar tendencies from me, his mother. We did not have any idea of this beforehand.

Todd wasn't famous to the world; he was the world to us!

The loss is valued to be approximately \$30,000.

The victim went to the kitchen and observed the female suspect standing outside the broken window with a small improvised Molotov cocktail that had been placed in the window sill.

The victim put out the fire and observed the suspect walk to the backyard. Officers were called and located the suspect in the backyard. She was found to be in possession of a loaded firearm and fully loaded magazine. The suspect was arrested for the arson and for possession of a loaded firearm.

Former Baldwin Park councilman arrested on corruption charges

BALDWIN PARK - A former Baldwin Park city councilmember has pleaded guilty to accepting tens of thousands of dollars in bribes - including \$20,000 in cash - from a Baldwin Park Police officer working at the FBI's direction, in exchange for the councilmember's political support of the Baldwin Park Police Association's contract with the city, the Justice Department announced Wednesday.

Ricardo Pacheco, 58, of Baldwin Park, who was elected to the City Council in 1997 and served as mayor pro tempore in 2018, pleaded guilty on June 15 to a federal bribery charge.

On Tuesday, federal prosecutors unsealed a criminal information against Pacheco, as well as portions of a plea agreement in which Pacheco agreed to fully cooperate in ongoing public corruption investigations. The unsealed plea agreement contains a redacted statement of facts to protect the integrity of ongoing aspects of those investigations.

In the documents unsealed this week, Pacheco admitted to soliciting and receiving a total of \$37,900 in bribes from a Baldwin Park police officer from January through October 2018 to support and vote for the Police Association's contract, which was worth at least \$4.4 million over three years. The police officer who made the payments did so at the direction of the FBI after another officer and he approached the FBI and agreed to assist in its ongoing corruption investigation. In exchange for the payments, Pacheco voted in favor of the Police Association contract in March 2018.

The payments to Pacheco included a \$20,000 cash bribe in October 2018, which the police officer provided to him in an envelope in a Baldwin Park coffee shop. Pacheco also solicited and received \$17,900 in checks that he directed be made out to his church and sham political action committees he had set up using other individuals' names but which he controlled.

City Council seat, which he did in June. Pacheco also agreed to forfeit \$83,145 in cash proceeds seized by the FBI, which included \$62,900 that Pacheco said he had buried in his backyard in two locations.

Pacheco pleaded guilty before United States District Judge Otis D. Wright II. Pacheco is scheduled to be sentenced on August 2, at which time he will face a statutory maximum sentence of 10 years in federal prison.

Bank manager accused of stealing from customer with dementia

NEWPORT BEACH – A former Comerica bank branch manager was sentenced Monday to 41 months in federal prison for stealing more than \$1 million from an elderly customer with dementia, and then using it for her own personal expenses, including gambling and buying luxury items.

Marie Fulle, 38, of Newport Beach, was sentenced via videoconference by United States District Judge Virginia A. Phillips, who also ordered her to pay \$1,091,230 in restitution. Fulle pleaded guilty in September 2019 to an information charging her with two counts of bank fraud.

Fulle formerly was a branch manager of a Comerica bank in Tustin. From February 2013 to April 2014, she targeted a vulnerable customer - an elderly man with dementia - and cultivated an exclusive banking relationship with him. Fulle then opened various bank accounts with the victim and used them to create a confusing web in which she could hide unauthorized transfers, and forged withdrawals with cashier's checks.

Between February 2013 and May 2013, Fulle embezzled approximately \$43,400 over the course of six transactions. After Fulle lost an anticipated promotion at work in May 2013, she began embezzling larger amounts of the victim's money, unilaterally changing the address for one of the victim's accounts, which prevented the statements from being delivered to the victim and his ookkeeper.

Fulle manipulated this account for her embezzlement and, after she changed the address, significant amounts of the victim's money began flowing through it. Fulle also conducted much of the victim's banking activities one-on-one in private, away from the view of other bank personnel or security cameras.

During the scheme, Fulle used the money she stole from the pleasing than to build more. As part of his plea agreement, Pacheco agreed to resign from his victim to pay for Tiffany jewelry, at least one Louis Vuitton bag, spa days for herself and her then-boyfriend, and trips to Las Vegas, where she gambled.

> Comerica fired Fulle in April 2014 for embezzling money from her cash drawer. When Comerica subsequently discovered the fraud Fulle committed against the victim, it reimbursed the victim nearly \$1.3 million for disputed transactions that Fulle processed, lost interest and attorneys' fees.

> The total loss that Fulle caused to the victim was \$1,057,230. The restitution amount includes the victim's attorneys' fees.

Downey extends moratorium on commercial evictions

DOWNEY - Downey's moratorium on coronavirus commercial tenant evictions was extended once again on Tuesday, now spanning through the end of March.

The ordinance has been in place since June and has been extended three times since.

Under it, commercial tenants are protected from eviction for inability to pay rent due to the impacts of Covid-19. It also establishes a rent payment period which allows two months per every month that a tenant is in arrears to their landlord.

It will now expire March 31.

This legislation is usually seen side-by-side with another similar moratorium for residential tenants.

However, Governor Gavin Newsom signed an Assembly Bill 3088 back in September, which gives some protections to residential tenants from evictions for COVID-19-related financial hardships, subject to certain requirements.

That moratorium was set to expire this Sunday, but was extended through June earlier this week.

Downey approves deal for 5G antenna on public poles

DOWNEY – The Downey City Council approved an agreement with New Cingular Wireless PCS, LLC on Tuesday, allowing for the installation of wireless communications facilities in the public right of wav

Street poles and other like structures found in public right of way spaces offer an ideal opportunity for 5G antenna placement, according to city officials.

Sanchez introduces legislation targeting Trump

NORWALK - Congresswoman Linda T. Sánchez (CA-38) introduced legislation to prevent federal projects, buildings, statues, or lands from being named after former president Donald Trump.

HR 484, titled The No Glory for Hate Act, would prohibit the use

of federal funds for any project commemorating a president twice impeached by the House of Representatives and would further restrict the benefits afforded them after leaving office.

"For years, Donald Trump poured gasoline on lies, encouraging racism and hatred, then lit the match on January 6th. A president who has been impeached twice does not deserve the honors bestowed on a former president," said Sánchez, who represents Norwalk in Congress.



"We should never glorify the hatred Donald

Trump personified as President. This bill ensures that there is no glory for hate - not a building, statue, or even a park bench."

The No Glory for Hate Act prohibits the use of federal funds for any:

- symbol,
- monument,
- structure,
- building, or
- public land...

...commemorating a former President twice impeached by the House of Representatives, or who has been convicted of a State or Federal crime relating to actions taken in an official capacity.

The bill also restricts the benefits given to former presidents who have been twice impeached by the House of Representatives, such as:

- pension,
- staff,
- office
- travel expenses, and
- burial in Arlington National Cemetery.

Congresswoman Sánchez started this bill the day of Jan. 6 when she was barricaded inside a locked office, armed with only the baseball bats she plays the Congressional baseball game with.

"I remember getting the horrifying news that no one was coming to help us - that the National Guard had not gotten approval - while police officers were being beaten and overrun. I thought, no one who stirs up this seditionist act should ever be held to the same high standards we hold for our former presidents who served with grace, said Sánchez.

Sánchez added: "Even though Trump is no longer in office, he should still be held accountable for his actions and the taxpayers should not foot the bill for his future actions. I can't imagine sending students in Southern California - or anywhere in America - to a school named in honor of a traitorous president.'

Biden plans to extend national eviction moratorium through September

proposal would halt evictions and foreclosures through the fall.

President Joe Biden is calling on lawmakers to extend the national eviction moratorium for another eight months — one of the many housing-related proposals he is making as part of his \$1.9 trillion stimulus plan.

Biden proposes extending the national moratorium on evictions and foreclosures until Sept. 30, while also setting aside funds to provide legal assistance to households facing foreclosure or eviction.

agencies to continue allowing applications for forbearance on federally-backed mortgages until that date.

Foreclosures were paused last spring early in the pandemic. The CARES Act included an eviction moratorium through late July 2020 that only applied to certain, federally-funded rental units. But last September, the Centers for Disease Control and Prevention issued a nationwide moratorium on evictions that covered the vast majority of renters nationwide.

The latter moratorium was set to expire at the end of December, but the stimulus package passed by Congress last month extended it until Jan. 31 of this year. Extending the national eviction moratorium even further was a priority for housing advocates, who have warned that the assistance provided by previous stimulus packages would not be enough to prevent a full-fledged housing crisis.

"There's been a threat of mass evictions (to the tune of 10 to 20 million or more taking place within just weeks) facing us since summer of 2020," Eric Dunn, director of litigation at the National Housing Law Project, said in an email. "The successive rounds of moratoriums and protections have largely staved that off, though unfortunately we still have seen lots of evictions. But we could really see that big
