Rent control proposal fails

■ A proposal to enact stricter rent control policies in Downey was voted down Wednesday.

DOWNEY – A push by Councilwoman Catherine Alvarez to bring stricter rent control policies to Downey failed to gain traction at this week's council meeting, being struck down unanimously in the early morning hours on Wednesday.

Rent control has been a hot stove item in Downey over the last few years, fueled in large part by Alvarez, who formed the Downey Tenants Union before campaigning on the platform and ultimately winning her seat on council during last year's election.

Last month, Alvarez requested a presentation to explore the possibility of bringing stricter rent controls and tenant protections to the city.

"I brought this up to you, to the city council members, and to the public because we're going through a hardship," said Alvarez. "A lot of families are going through a lot; right now they've lost their jobs.'

On Tuesday, council members presentations from heard Alvarez and staff members before fielding a large volume of calls and correspondence, spending around four hours on

DOWNEY – I left Los Angeles on Jan. 15 at a time when new cases of Covid-19 had continuously surpassed the 10,000 mark. More specifically, in LA county alone, cases had reached over 15,000 new cases in one day, meanwhile I was still seeing people participate in non-essential activities via social media.

The Covid-19 pandemic has altered the world in a multitude of ways and yet, people still continue to put their selfish needs before others. The night I left, I watched as my mother logged onto a Google Hangout for a group prayer she and her family were doing for her recently departed aunt who died from Covid-19. I was leaving LA and finally releasing myself from living in fear in my childhood home from people who perceived the threat of Covid-19 differently than I did, but I left fearing for the lives of my parents knowing that this virus was ravaging the city I grew up in.

Back in December, I wrote a personal essay on what it was like living in Downey with family members that took Covid-19 precautions differently than me and how that ultimately resulted in me moving 3,000 miles away back to Brooklyn. Now nearly a year into the pandemic I find myself feeling hopeless despite vaccinations being underway.

The apathy I have witnessed

not just my own. From friends who I would've never thought were selfish enough to travel across the country for birthday celebrations, to family members, who also are frontline healthcare workers, hosting parties with people in their homes

unmasked. During this pandemic I've been able to weed out the good seeds from the bad in my social circles. I also routinely post COVID-19 case data daily on my social media feeds to try to keep my friends and loved ones informed about the severity of the pandemic. I've called people out for traveling and partying with friends amidst the pandemic. I've kept this up for nearly the entirety of the pandemic.

"We've gotten tested. It's okay for us to gather," some say.

"We're all bound to get it sooner or later, I can't stop

member told me. "I can't live in fear," that same family member said.

But you should live in fear, fear is good. Growing up, my dad used to always say. 'Fear keeps you alive." Fear will keep you out of trouble. It's fear of dying that keeps me from jumping out into the street without looking both ways. Maybe if we all were a little more fearful and stopped acting invincible then maybe just maybe we could've kicked this pandemic's ass a long time ago. But who knows, because I've also grown too tired of living in the "shoulda, woulda, coulda' and am trying to actively be present in the now. Living with my family during the majority of the pandemic and being gaslit by them over my concerns of contracting the virus proved to me what I have felt my entire life. My parents don't show that they respect or value my opinion or think I have any credibility despite saying the opposite. If they truly did then they wouldn't say they agree with me, then turn around and allow my sister's boyfriend who travels for work and for non-essential reasons



like skydiving - yes skydiving - during a global pandemic to come over despite me begging them not to. Although I may not be at home, I still fear for their well being. As long as my sister lives in their home their risk of exposure is significantly greater due to her and her boyfriend's carelessness of seeing others outside of my parent's home. My parents who still work in-person at the manufacturing company they own, with only a handful of full-time employees, are still at risk, yet with my sister's lack of empathy and concern, their increased exposure is unnecessary. In reality, she could stay at her boyfriend's place if she wants to participate in non-essential activity without risking my parent's lives. I wish they wouldn't see my concerns and pleas for them to not allow this behavior in their home as a personal vendetta against my sister's boyfriend. I mean, it's not because I don't like him - I don't - but this is bigger than them. My dad is a cancer survivor of nearly 10 years and is now on a waitlist for hip replacement surgery as he can barely walk. He cannot afford to contract Covid-19 - I mean no one can - but much less while they are on a waiting list to be able to get surgery that will allow them to walk pain-free again.

numbers - those are people. As of this writing, 17,360 people have died from Covid-19 in LA county alone, and 466,465 people in the U.S. have died from Covid-19.

I still sanitize my groceries, stay home as much as possible, wear double masks with a surgical mask beneath my cloth mask, and socially distant see mv friends while wearing my masks. I haven't seen some of my closest friends in nearly a year, but knowing them and their families are healthy and alive is better than any bottomless mimosa brunch we could have right now.

My relationship with my parents has improved since moving back to Brooklyn, where

the item and carrying them past midnight.

During her presentation, Alvarez said that the percentage of tenants in Downey was "very high."

"We have to understand that tenants are not only the ones who have a contract," she said. "There are tenants living in the living room, paying for a room or a garage.'

According to her presentation, over 53% of Downey's 32,073 housing units were occupied by tenants in 2019. Alvarez argued that more than 53% of those tenants were "costburdened," paying 30% or more of their income towards housing costs.

Staff's presentation showed similar numbers but put the majority at slightly over 50% ownership in 2018, with similar trends in 2010 and 2000. It also highlighted a vacancy rate of 3.6% in 2020.

Much of Alvarez's argument for rent control centered around protecting low-income and vulnerable tenants - such as the disabled, veterans and elderly from exaggerated increases in rent or no-fault evictions, and preserving tenants' rights.

Alvarez also specifically took aim at California's AB 1482, the Tenant Protection Act signed in 2019, which Downey operates under.

"Rent control is different than a rent cap. We need to understand that AB 1482 is a rent cap, it's not rent protection," said Alvarez.

AB 1482 prohibits an owner of residential property from raising rent more than 5% plus increase in cost of living or 10% (whichever is lower), and from evicting a tenant without just cause.

Unfortunately for Alvarez, other council members did not share the same enthusiasm for stricter rent controls.

I still continue to advise them on the latest precautions they can take to keep safe. I send my dad vaccine updates so that he can prepare to make his appointment as soon as he's eligible.

My sister and I, however, may not be able to repair our relationship after the pandemic is through - if it ever is through - and I've learned that siblings are also just people who you grew up with, and sometimes you grow apart due to a difference in ethics and moral values.

The biggest lesson however, has been this: empathy over apathy always, and the golden rule still holds up too.

DUSD temporarily waives graduation requirements for eligible students


DOWNEY – It was unanimously decided during Wednesday night's Downey Unified Board of Education meeting that the school district would temporarily place an exception within the current local graduation requirements to support those students who have been most affected by the pandemic.

This exception would create a waiver process that could only be utilized based on a school counselor's recommendation with an administrator's approval.

This graduation waiver is temporary and only applies to this year's senior students who have experienced "significant difficulties" as a result of the pandemic.

Any student who is identified and recommended by their counselor as having been negatively impacted by the pandemic would have to navigate a process with their counselor to access this graduation waiver.

Students who have experienced extreme hardship should work with their respective school administrators and counselor to explore this option and any other options to support their path to graduation.

DOWNEY – It's a love story that began in the small town of Santa Ana, Ecuador.

A young Luis Mendoza would first see Ana in passing. She would see him too.

In those brief moments, both would leave an impression on one another; it might even be described as love at first sight.

"My mother used to see my dad walk on the road," said daughter Rosa Montelongo. "She liked the way he used to dress; he always looked fine and clean.



"My dad also liked her the first time he saw her."

Unfortunately, the courting process would not be easy. Ana's mom was extremely strict, meaning their budding romance would need to be kept secret, at least initially. The couple was forced to be creative.

"That's when the love letters came along," said Montelongo.

Luis would write the first in what would become a long train of passionate correspondence, often hidden under the rose bushes and amongst other plants and trees. Many times, their friends would serve as cupid, helping the couple hide and deliver each note.

"My mother says that every letter he would write, he would always say that he loved her, and he wanted to marry her," said Montelongo.



Paging Dr. Frischer...

Here's a news flash: Pandemics are stressful! Fear and anxiety about disease can be overwhelming.

Public health measures like

masks, social distancing, and staying at home make us feel isolated and lead to significant loneliness. Loneliness, in turn, results in yet more stress

and anxiety. The effect of the pandemic on the economy and jobs is unbalanced and unjust. Throw a higher level of drug and alcohol use into the mix, and we now face a mental health crisis.

On top of that, it appears that the physiological effects of the COVID-19 illness itself lead to mental health issues as well. Let's think of this COVID-related stress as having two sources: Psychological issues due to the pandemic, and physiological effects caused by the disease itself.

· Within 90 days of a CO-VID diagnosis, researchers at Oxford found that nearly 6% of adults developed a psychiatric

disorder for the first time ever. Conditions included anxiety, insomnia, depression, and post-traumatic disorder, and older adults with COVID also had two to three times the risk of developing dementia. Once ill, we have limited guidance as to how to manage the disease, lifestyle, and isolation. We experience fear about spreading a life-threatening disease to loved ones, and of course guilt should that happen. Battling the disease can be taxing and traumatic. Symptoms may persist for a very long time, resulting in a group of patients known as

"long-haulers." · COVID-19 is not only a respiratory disease, but also one that can reach other critical organs, including the brain. Patients frequently experience neurological complications, such as confusion, dizziness, delirium, and other cognitive impairments. There is no clear understanding as to the mechanism for how this happens; it's possible that the virus causes damage to the brain's blood supply, and leads to swelling of brain tissue. COVID also disturbs our circadian rhythms and

impairs sleep, which can lead to insomnia, making psychiatric symptoms even worse.

There is precedence for this impact on mental health. Other viral illnesses have been known to do this: SARS and MERS, two other life-threatening coronaviruses, have led to delirium, anxiety, depression, mania, insomnia, and memory loss. And, any virus that attacks the central nervous system can lead to hypoxic brain injury.

Conversely, those with preexisting psychiatric disorders may actually be more prone to developing COVID-19. Although there is as of yet no full explanation, being highly anxious and/or depressed could make us more susceptible to the physical illness.

This is a new disease, and we understand so little. Research is actively being conducted. In the meantime, pay close attention to both your physical and mental health. Make efforts to build a network of support for yourself, and don't hesitate to consult with your medical professionals for your physical as well as for your mental and emotional health needs.



How to prevent the next pandemic

President Joe Biden just delivered his inaugural address, calling for unity and bipartisanship.

One area crying out for cooperation is antibiotic resistance -- a health crisis that will last long after the COVID-19 pandemic.

Each year, 162,000 Americans and about 700,000 people globally die from antibiotic-resistant infections. Those numbers will skyrocket as existing antibiotics continue to lose their effectiveness. Rampant overuse is partially culpable but so is increased reliance due to an aging population. Each time a patient takes an antibiotic, it kills off some bacteria, but those that survive can evolve into treatment-resistant superbugs.

These superbugs threaten to send us back to the medical dark ages. Antibiotics are crucial to preventing infections during procedures ranging from elective surgery to organ transplants to the ventilation of COVID-19 patients.

California doctors are no strangers to the impending superbug crisis. While our state generally takes pride in staying ahead of the curve, leading the country in catheter-associated urinary tract infections -- a bacterial infection that's become increasingly resistant to existing medicine -- is not the kind of recognition we're after.

Scientists have known for years that we desperately need new antibiotics capable of attacking specific drug-resistant bacteria. This pressing information has resulted in some funding for research and development, yet the present commercial market does not support novel FDA-approved antibiotics.

That's because manufacturing and selling new antibiotics is a money-losing endeavor. The revenues generated from sales are ultimately much less than the cost of entering the market.

Why? In the early period of superbug spread, the most resistant infections are rare -- perhaps only affecting tens of thousands of patients per year. Additionally, antibiotics provide a rapid cure -often healing patients in 7 days or less.

And while there isn't a formal price cap for a novel antibiotic, the U.S. reimbursement system essentially functions as one. For many serious infections, antibiotics are prescribed intravenously in a hospital, which makes the hospital -- not a private insurer or Medicare responsible for the cost.

Hospitals lose money unless they choose older, less expensive

drugs over more appropriate -- but more expensive -- treatments.

Put plainly, any company that invents a new antibiotic will only sell a limited number of doses at too low a price, which dooms the products to fail. At least four antibiotic start-ups have recently shuttered their doors, despite medical breakthroughs.

The company I cofounded in 2004, Achaogen, was chief amongst them. Our California-based biotech firm spent 15 years and \$1 billion developing an antibiotic to fight the superbug CRE, or carbapenemresistant Enterobacteriaceae. But even after we won FDA approval and secured a spot on the World Health Organization's essential medicines list, the broken market made it impossible for us to sustain our ongoing business let alone return a profit to our investors. Our stock value collapsed and we declared bankruptcy a mere 9 months after FDA approval.

Fortunately, last year, House Speaker Nancy Pelosi allocated \$500 million towards antibiotic development in a Covid-19 emergency stimulus bill that passed in the House.

It was a step in the right direction. But in the long term, we need policies that transform the incentive structure for developing new antibiotics, and also encourage responsible stewardship

The bipartisan Developing an Innovative Strategy for Antimicrobial Resistant Microorganisms (DISARM) Act fits the bill. The measure would alter Medicare's reimbursement formula to let it pay hospitals more for using the newest antibiotics when medically appropriate. By helping hospitals afford cutting-edge antibiotics, it would encourage biotech companies to invest more in research and development.

Including the DISARM Act in any upcoming COVID relief bill or health policy legislation would help fundamentally fix the broken market -- and stave off a doomsday scenario.

The option stands to take no further action against antibiotic resistance. But we'd have to be comfortable with the ensuing deaths of 10 million people worldwide, each year, by 2050. And, as we've learned the hard way from COVID, these are not abstract figures -- these could be our family members, our friends, our neighbors.

Addressing racial health disparities

I've spent my career fighting for vulnerable patients, especially people of color. So I was ecstatic to hear about a new initiative from dozens of biotech companies.

These firms pledged to enroll more people of color in "clinical trials" -- years-long tests that show whether experimental drugs are safe and effective. Boosting diversity will tangibly improve the health of minority Americans.

White Americans are drastically overrepresented in clinical trials. Non-Hispanic whites account for 60% of the U.S. population, but roughly 86% of clinical trial participants. By contrast, Black Americans comprise 13% of the U.S. population but only 5% of clinical trial volunteers. Latino Americans account for 18% of the U.S. population but make up a measly 1% of trial participants.

Underrepresentation is a big problem for minority patients on an individual level. Clinical trial participants get lifesaving treatments years before those medicines become available to the public. That early access can -- and does -- save lives. When minorities aren't asked to participate in trials, or simply decline to do so, they lose out on these

approached about participating.

African Americans also die from cancer at higher rates than white Americans. And Hispanics are more likely to be diagnosed with late-stage cancer. Yet in clinical trials from 2008 to 2018, only 3% of oncology clinical trial participants were Black, and 6% were Hispanic.

As minority groups are more likely to be impacted by these illnesses, it's only right researchers keep them front of mind when developing new treatments. After all, they'll likely be seeking those very drugs. And yet, clinical trials continue to exclude them.

The biopharmaceutical industry's recently published principles on clinical trial diversity are a step in the right direction. Let's hope those firms to live up to these commitments.

Underrepresentation hurts minority communities as a whole, too. That's because medications can affect various ethnic groups differently. For instance, Black Americans might experience a side effect that only rarely afflicts whites.

These disparate reactions are surprisingly common. About 20% of all new drugs approved between 2008 and 2013 caused "differences in exposure and/or response" based on patients' ethnicity.

If minorities frequently had a chance to participate in clinical trials, researchers could detect these disparate reactions early. But when trials include too few patients from various ethnic groups, it's easy to miss these disparities -- with tragic results.

Take the Breast Cancer Risk Assessment Tool, which was created to estimate a woman's breast cancer risk and developed in 1989 using data from a majority-white study group. Due to its failure to account for differences between certain demographics, the Breast Cancer Risk Assessment Tool underestimated the risk to Black women, who report higher rates of breast cancer at younger ages.

It wasn't until 2015 that the tool was explicitly modified to account for Black women's unique circumstances. It's impossible to know how many preventable deaths occurred before this adjustment was made.

Clinical trial diversity would also reduce the disproportionately high rate of chronic illnesses in minority communities. As a longtime advocate for Black, LGBT+ and HIV-positive communities, it's disturbing to see these groups underrepresented in HIV clinical trials.

Between 2002 and 2016, nearly 75% of all new HIV cases in the United States occurred in minorities. However, only about 17% of clinical trial participants were Black or Latino. In many instances, Blacks and Latinos living with HIV reported they had not even been Capitol to let your voices be heard."

Get vaccinated

Dear Editor:

In my letter to the editor of Oct 22, 2020, I expressed misgivings about the Covid-19 vaccines.

Today I received the second shot of the Moderna vaccine at the VA Hospital in Long Beach.

I am not a hypocrite. My decision of getting vaccinated was based on solid research about the development, efficacy and safety of the Pfizer and Moderna vaccines that differ only in their delivery system.

Corona viruses have been infecting humans for about eight centuries. Dr. Barney S. Graham is Chief of The Viral Pathogenesis Laboratory and Translational Science Care of the National Institute of Health in Bethesda, Maryland. His experience includes work on viruses that include Ebola, Zika and Influenza. He was also at the forefront of research that figured out that HIV was a virus. At the vaccine evaluation clinic of the National Institute of Health he focused on vaccines for three categories of respiratory viruses: influenza, corona virus and respiratory Syncitial virus (RSV). This experience played a key role in the development of a Covid-19 vaccine.

Moderna had encoded a modified protein on strips of genetic material known as Messenger RNA, a very potent platform. After the Chinese posted the genomic sequence of the Covid-19 virus. Dr. Graham and his associates started developing a vaccine. It took them six weeks to go from formulating a vaccine to making a product ready to be tested, a process that typically takes years to accomplish. He is the chief architect of the first covid vaccines manufactured by Moderna and Pfizer. For this reason, Dr Anthony Faucci says that Dr Graham understands vaccinology better than anybody I know.

The vaccines have been tested in thousands of volunteers which expedited their development and tests for efficacy and safety.





Black Leaders that Inspire Us



Dr. Nadine Burke Harris

Dr. Nadine Burke Harris is an award-winning physician, researcher and advocate dedicated to changing the way our society responds to one of the most serious, expensive and widespread public health crises of our time: childhood trauma. She was appointed as California's first-ever Surgeon General by Governor Gavin Newsom in January 2019.

Dr. Burke Harris' career has been dedicated to serving vulnerable communities and combating the root causes of health disparities. After completing her residency at Stanford, she founded a clinic in one of San Francisco's most underserved communities, Bayview Hunters Point. It was there that Burke Harris observed that, despite the implementation of national best-practices for immunizations, asthma, obesity treatment and other preventive health measures, her patients still faced outsized risks for poor health, development and behavioral outcomes.

Drawing on research from the CDC and Kaiser Permanente, Dr. Burke Harris identified Adverse Childhood Experiences as a major risk factor affecting the health of her patients. In 2011, she founded the Center for Youth Wellness and subsequently grew the organization to be a national leader in the effort to advance pediatric medicine, raise public awareness, and transform the way society responds to children exposed to Adverse Childhood Experiences (ACEs) and toxic stress. She also founded and led the Bay Area Research Consortium on Toxic Stress and Health, to advance scientific screening and treatment of toxic stress

the test.

In 1960, Bridges' parents were informed by officials from the NAACP that she was one of only six African American students to pass the test. Bridges would be the only African American student to attend the William Frantz School, near her home, and the first Black child to attend an all-white elementary school in the South.

On the morning of November 14, 1960, federal marshals drove Bridges and her mother five blocks to her new school. While in the car, one of the men explained that when they arrived at the school, two marshals would walk in front of Bridges and two would be behind her.

When Bridges and the federal marshals arrived at the school, large crowds of people were gathered in front yelling and throwing objects. There were barricades set up, and policemen were everywhere.

Only one teacher, Barbara Henry, agreed to teach Bridges. Bridges was the only student in Henry's class because parents pulled or threatened to pull their children from Bridges' class and send them to other schools. For a full year, Henry and Bridges sat side by side at two desks, working on Bridges' lessons.

Indisputably the most acclaimed rap artist of his generation, **Kendrick Lamar** is one of those rare MCs who has achieved critical and commercial success while earning the respect and support of those

who inspired him.

After several years of development, Lamar hit his creative and chart-topping stride in the 2010s. "Good Kid," "M.A.A.D City" (2012), the Grammy-winning "To Pimp a Butterfly" (2015), and the Grammy- and Pulitzer Prize-winning "DAMN" (2017), his three proper major-label albums, have displayed an unmatched mix of inventive wordplay and compelling conceptual narratives, examining internal conflict, flaunting success, and uplifting his community.

The screenplay-level detail of Lamar's writing has been enriched by a collective of producers, instrumentalists, singers, and rappers, a high percentage of whom including inspirations and, and contemporaries Sounwave and -- represent Lamar's native Los Angeles. Lamar's cinematic and collaborative inclinations inevitably attracted the mainstream film industry. "Black Panther: The Album' (2018) was the source of three of Lamar's Top Ten pop hits.

Compton native Kendrick Lamar Duckworth grew up immersed in hip-hop culture and surrounded by gang activity. As a youngster, he gradually discovered an aptitude for writing stories, poems, and lyrics, which naturally led to rapping. He made a name for himself as K. Dot. At the age of 16 in 2003, he issued his debut mixtape, "The Hub City Threat: Minor of the Year." While it merely hinted at the potential of the then teenager, it was impressive enough to catch the attention of and led to a long-term association with the label that steadily propelled his career.

Mae C. Jemison is an American astronaut and physician who, on June 4, 1987, became the first African American woman to be admitted into NASA's astronaut training program. On September 12, 1992, Jemison finally flew into space with six other astronauts aboard the Endeavour on mission STS47, becoming the first African American woman in space. In recognition of her accomplishments, Jemison has received several awards and honorary doctorates.

Throughout her early school years, Jemison's parents were supportive and encouraging of her talents and abilities, and she spent a considerable amount of time in her school library reading about all aspects of science, especially astronomy. During her time at Morgan Park High School in Chicago, she became convinced she wanted to pursue a career in biomedical engineering. When she graduated in 1973 as a consistent honor student, she entered Stanford University on a National Achievement Scholarship.

After Jemison obtained her M.D. in 1981, she interned at Los Angeles County/University of Southern California Medical Center and later worked as a general practitioner. For the next two and a half years, she was the area Peace Corps medical officer for Sierra Leone and Liberia where she also taught and did medical research.

Following her return to the United States in 1985, Jemison made a career change and decided to follow a dream she had nurtured for a long time: In October, she applied for admission to NASA's astronaut training program. The Challenger disaster of January 1986 delayed the selection process, but when she reapplied a year later, Jemison was one of

the 15 candidates chosen from a field of about 2,000.

After more than a year of training, she became the first African American woman astronaut, earning the title of science mission specialist — a job that would make her responsible for conducting crewrelated scientific experiments on the space shuttle.

When Jemison finally flew into space on September 12, 1992, with six other astronauts aboard the Endeavour on mission STS47, she became the first African American woman in space.

During her eight days in space, Jemison conducted experiments on weightlessness and motion sickness on the crew and herself. In all, she spent more than 190 hours in space before returning to Earth on September 20, 1992. Following her historic flight, Jemison noted that society should recognize how much both women and members of other minority groups can contribute if given the opportunity.

Her work has been profiled in best-selling books including "How Children Succeed" by Paul Tough and "Hillbilly Elegy" by J.D. Vance as well as in Jamie Redford's feature film, "Resilience".

Ruby Bridges was six when she became the first African American child to integrate a white Southern elementary school. On November 14, 1960, she was escorted to class by her mother and U.S. marshals due to violent mobs. Bridges' brave act was a milestone in the civil rights movement, and she's shared her story with future generations in educational forums.

The fact that Bridges was born the same year that the Supreme Court handed down its Brown v. Board of Education decision desegregating schools is a notable coincidence in her early journey into civil rights activism.

When Bridges was in kindergarten, she was one of many African American students in New Orleans who were chosen to take a test determining whether or not she could attend a white school. It is said the test was written to be especially difficult so that students would have a hard time passing. The idea was that if all the African American children failed the test, New Orleans schools might be able to stay segregated for a while longer.

Bridges lived a mere five blocks from an all-white school, but she attended kindergarten several miles away, at an all-Black segregated school. Bridges' father was averse to his daughter taking the test, believing that if she passed and was allowed to go to the white school, there would be trouble. However, her mother, Lucille, pressed the issue, believing that Bridges would get a better education at a white school. She was eventually able to convince Bridges' father to let her take

County eyes expansion of Project Roomkey

 County leaders want to include smaller motels in Project Roomkey, which houses vulnerable unhoused people.

DOWNEY - After the Biden Administration announced plans to reimburse 100% of what counties and cities spend on non-congregate shelters, Supervisor Janice Hahn wants to explore expanding LA County's Project Roomkey program to use empty motel and hotel rooms to get more people indoors during the pandemic.

Project Roomkey was launched in March 2020 as part of the State of California and LA County's effort to protect vulnerable residents from Covid-19.

The program uses hotels and motels as short-term shelters for homeless residents over 65 or with serious health conditions.

Previously, FEMA policy was to reimburse cities and counties for 75% of the costs of the program. On Jan. 21, Biden issued an executive action increasing the FEMA reimbursement rate to 100 percent.

"Master leasing hotels and motels through Project Roomkey has been one of the most effective tools we have had to combat homelessness," said Hahn. "If this new FEMA funding means we can expand this program, get more Project Roomkey sites up and running, and get more people off the streets, we absolutely should. This was the right thing for the Biden Administration to do and we should take full advantage of it."

On Tuesday, the Los Angeles County Board of Supervisors passed a motion authored by

Supervisors Hahn and Hilda Solis that directs the LA County CEO and LAHSA to report back in 15 days with opportunities for extending, renewing, or expanding county-contracted Project Roomkey sites.

The motion specifies including hotels and motels with fewer than 100 rooms which had not been eligible for the program.

"Since the onset of the Covid-19 pandemic, Los Angeles County has taken many actions to reduce and prevent the spread of the virus among people experiencing homelessness, including rapidly standing up temporary housing at hotels and motels through Project Roomkey," said Solis, Supervisor to the First District.

"The program has served as a beacon of hope, enabling us to immediately bring some of our most vulnerable indoors to protect them from contracting Covid-19 and to set them on a path to permanent housing.

'We must continue to use every resource to protect the health and safety of our unhoused neighbors. This motion seeks to do just that."
