

Downey breaks ground on sports complex

■ The 5-acre facility on the south Rancho campus will feature three By Alex Dominguez multi-purpose fields.

DOWNEY – Supervisor Janice Hahn and members of Downey City Council broke ground on an over \$12 million sports complex over the weekend.

The 5-acre complex will be erected on Rancho Los Amigos National Rehabilitation Center's abandoned south campus, and will include three multi-purpose fields, lighting for nighttime play, a restroom, concession stand, equipment storage room, office space for staff and a surface parking lot.

It is budgeted for \$12.12 million, a majority of which is coming from Hahn's 4th District discretionary funding.

Downey is expected to provide \$2.12 million to cover synthetic turf, office space, and a multi-sport scoreboard.

Once completed, the county will lease the facility to the city - which will operate it - for one dollar a year.

DOWNEY - Downey Unified School District middle and high school campuses will reopen to students in a hybrid format as of March 29, following a unanimous Board of Education decision on Tuesday.

After more than a year of full-distance learning onset by Covid-19, parents will now have the option to send their students back to school in a hybrid format.

school The district's elementary campuses received similar news earlier this month, however, secondary schools were not eligible to follow suit until LA County had fallen to "red" tier level statistics and stayed as such for two weeks.

Once this occurred, schools would have a 21-day window to reopen. If schools reopen within that time frame, they may stay open. However, should that time elapse and cases rise to "purple" levels once again, schools not yet open would lose the opportunity.

LA County was assigned to the red tier on Monday, earlier than anticipated. This sets the end of the critical 21-day window on April 4.

Results showed a shift in over 1,942 students from a previous survey, with 1,091 changing from hybrid to distance learning and 851 from distance learning to hybrid. Overall, the stats presented on Tuesday reflected a 60/40 percent split with most opting to remain distanced.

Officials have expressed, however, that there is some flexibility for parents and students to change their minds and switch after students return.

In-person schedules look slightly different between elementary, elementary special ed, and secondary levels.

Elementary students will be split into groups "A" and "B." and "Grab N' Go" lunch at 11:30 am. Distance learning students and Group B will then have Zoom instruction from 12:20 to 3 pm.

Groups A and B will switch on Thursdays and Fridays.

Special Education will meet Monday, Tuesday, Thursday, and Friday from 8:30-11:30 am, with dismissal / "Grab N' Go" lunch at 11:30 am, and distance zoom learning from 12:20-3 pm.

Wednesdays will be full distance, consisting of two 45-minute blocks from 8:30-9:15 am and 9:30-10:15 am. From 10:30 am to 2 pm, students can participate in PE, math, and STEAM.

Recognizing women's critical roles within the U.S. military

Women's History Month

• Women have long been crucial to the U.S. Army, dating back to the Revolutionary War.

The United States Army has designated the 2021 Women's History Month theme as "Valiant Women of the Vote: Refusing to be Silenced." This theme honors the brave women who fought to win suffrage rights for women and for the women who continue to fight for the voting rights of others and serve in our military today.

Women have played vital roles in our Army since the Revolutionary War. Today women are Soldiers, Generals, Army Civilians, Veterans and family members who are critical members of our Army team. Women make our Army stronger.

The strength of the Army comes from its diversity. Developing and maintaining qualified and demographically diverse leadership is critical for mission effectiveness and is essential to national security, a fact we know and are fostering through an initiative called Project Inclusion.

Project Inclusion empowers a culture of trust and acceptance for the experiences, culture, characteristics and background each Soldier and Civilian brings to the institution, placing value on the wealth of diversity that we have in our Army and in our nation.

I would like to share with you the stories of some women who made our diverse nation what it is today. During the Revolutionary War, women served as spies, nurses, seamstresses, laundresses and cooks. Women also fought in combat alongside their husbands or disguised as men.

Deborah Sampson, a descendant of preeminent Pilgrims Myles Standish and William Bradford, disguised herself as a man and used the name Robert Shurtleff in order to fight in the Revolutionary War. Assigned duties as a scout, even leading a raid on a Tory house that led to the capture of 15 men, she evaded detection for a year and a half, despite being wounded twice - a sword gash to her forehead and a shot in the thigh, and she pulled the pistol ball out herself. She received an honorable discharge in 1783 and became the first woman to receive a full military pension when a court ruled that she had performed the duties of a Soldier.

Women continued to distinguish themselves with selfless service during the Civil War as well. For example, Harriet Tubman, born into slavery and best known for her work guiding dozens of slaves to freedom on the Underground Railroad, was also a scout and a spy for the Union Army. She helped John Brown plan and recruit for his 1859 raid on Harpers Ferry, and organized and led a group of freed slaves who sought out information about Confederate troops in the Beaufort, South Carolina area. Her work enabled Union troops to conduct a series of raids to acquire supplies and destroy enemy torpedoes, railroads and bridges.

Tubman is also the first woman to lead an armed expedition in the Civil War, guiding the raid at Combahee Ferry and liberating more than 700 enslaved people. Following the war, she remained active in the Women's Suffrage movement until being overcome by illness.

Dr. Mary Edwards Walker served as a surgeon with the Union Army. She was captured and imprisoned as a spy, and when released returned to work as a surgeon at a prisoner-ofwar hospital. Dr. Walker was awarded the Medal of Honor by President Andrew Johnson, and is still the only woman to receive this highest military honor. Dr. Walker knew well the importance of women in the military, once stating, "Let the generations know that women in uniform also guaranteed their freedom."

More than 35,000 American women volunteered for military service during World War I. The Navy and the Marine Corps were the first military services to recruit women for non-combat positions such as radio electricians, telephone operators, accountants and clerks. More than half of the women who served in the military during World War I were part of the Army Nurse Corps, and most of the switchboard operators were women. They worked close to or at the front lines, living in bunkers and makeshift tents.

Grace Banker, a switchboard operator who served as the chief operator of mobile for the American Expeditionary Forces in the Signal Corps, was awarded the Distinguished Service Medal for her extraordinary service assuring the success of the telephone service during the operations of the 1st Army during the Meuse Argonne offensive in 1918. Women had been fighting for the right to



vote for decades, without much real success. But with women serving overseas, it was hard to ignore the call for equality. The service of these women inspired change across the nation and helped to propel the ratification of the 19th Amendment in August 1920, guaranteeing women the vote.

During World War II, approximately 140 thousand women served as members of the Women's Army Auxiliary Corps and the Women's Army Corps. They provided critical services, such as military intelligence, cryptography, parachute rigging, maintenance and supply. More than a thousand women flew aircraft for the Women's Air Force Service Pilots and more than 60 thousand Army Nurses served, often in harsh conditions.

Mary Roberts Wilson was the first woman awarded the Silver Star for gallantry in combat for her action during the battle of Anzio. With her Army evacuation hospital under fire, Wilson continued to supervise her nursing staff of 50, allowing the hospital to continue functioning.

A search of the suspect vehicle revealed three catalytic converters in the trunk. A detective later interviewed the suspects.

• Detectives are investigating a robbery that occurred on March 4 at about 6:40 pm near the Rio Hondo River Trail, south of the 5 Freeway. The male suspect approached the female victim and brandished a knife. The suspect demanded the victim give him her necklace. The suspect forcibly removed the necklace from the victim's neck and fled on a bicycle northbound on the bike path.

 Detectives are investigating a carjacking that occurred on March 5 at about 9 pm in the 9400 block of Firestone Blvd. The victim drove to Rick's Motel where he lives and parked in the south parking lot. The victim left the car running with the keys in the ignition and walked inside the office. An unknown male suspect entered the vehicle and the victim ran out of the office. The suspect began to back out of the parking lot, striking the victim with the vehicle, causing minor injuries to his arms and legs. The suspect fled the scene and was not located. The victim was transported to the hospital for medical treatment.



Anna May McCabe Hays worked as an Army nurse overseas during World War II and Korea. She led the Army Nurse Corps at the height of the Vietnam War and in 1970 became the first female General Officer in the U.S. Armed Forces. She pushed to expand scholarship opportunities and education for Army nurses. She also supported policy changes, so married nurses who became pregnant were not automatically discharged.

Due to the exceptional service of women in the military during World War II, President Harry S. Truman signed the Women's Armed Service Integration Act into law on June 12, 1948. This bill authorized a permanent presence of women in the military.

Women continued to prove themselves over and over during the conflicts in Iraq and Afghanistan. In 2005, Sergeant Leigh Ann Hester, a military police officer in the Kentucky National Guard, became the first female Soldier awarded the Silver Star since Mary Roberts Wilson in World War II. When her convoy was attacked near Baghdad, Hester maneuvered her team through an enemy kill zone, where she assaulted a trench line with grenades and M-203 rounds, then engaged three enemy soldiers while clearing two more trenches, thus saving numerous American lives.

Specialist Monica Brown, a medic, is the first woman to receive the Silver Star during the War in Afghanistan, and the second to earn the Silver Star since World War II. Brown was riding in a convoy on a routine security patrol when the trail vehicle struck a pressure plate improvised explosive device - commonly referred to as an IED • the initiating event for a planned ambush.

As enemy fighters engaged the patrol, Brown ran through gunfire to provide medical care to wounded soldiers, at one point throwing herself over the wounded to shield them from mortar fire. Approximately 15 mortars impacted within close range as Brown continued to help her fellow soldiers.

As the platoon continued to return fire, Brown once again shielded the wounded from enemy fire and falling brass, ensuring all the wounded were stabilized and ready for MEDEVAC.

There are common threads that run through the stories of these women and our veterans. These individuals are willing to put the needs of their country above their own. They fight for equality and fairness. And it is this self-sacrifice and determination that ensures that our country not only survives, but thrives.

Today, women have more opportunities than ever in the Armed Forces. About 18% of the total Army is female and all positions in the Army are open to women. The Army has accessed and/or transferred more than 1,400 female Soldiers into Infantry, Armor and Field Artillery positions.

All Infantry, Armor and Field Artillery Battalions include female Soldiers and gender-integrated Infantry and Armor units are currently deployed. The Army wants female Soldiers assigned to positions that provide full and challenging career and promotion opportunities. We know from history and experience that the contributions and achievements of women make our Army stronger.

Congress uses Covid-19 as cover for fiscal recklessness

The "recovery rebates" that Americans began receiving this week supposedly have something to do with the economic damage caused by COVID-19 and the control measures it inspired. But like most of the so-called American Rescue Plan Act, these payments, which account for more than a fifth of the bill's \$1.9 trillion price tag, are only tenuously related to the pandemic.

The Democrats who championed the law hope those bribes will buy them votes in the midterm elections. But you really should be thanking your children and grandchildren, because they will ultimately pick up the tab for this package and the rest of the \$5 trillion spending binge that Congress claimed was justified by a public health emergency.

Individuals with adjusted gross incomes of up to \$75,000 will get \$1,400, while married couples earning up to \$150,000 will get \$2,800, plus \$1,400 for each dependent. That amounts to \$5,600 for a four-person family, on top of the \$5,800 that such households received under the coronavirus relief packages that Congress approved in March and December.

Congress distributed that money without regard to whether the recipients had suffered pandemic-related economic distress. A Pew Research Center survey conducted last August suggests that most of them have not: 42% of respondents said they or someone in their households had lost jobs or income due to COVID-19, less than half the 85 % of Americans who are expected to receive the latest round

Another survey found that just 15% of people who received the money distributed in April reported that they spent most of it; instead, they typically saved it or used it to pay down debts. Those findings cast doubt on the hope that such payments, even when they go to relatively well-off families, will stimulate the pandemicbattered economy by increasing consumer spending.

The package also includes an expanded, fully refundable child tax credit that will cost at least \$89 billion — more if the temporary change becomes permanent. Like the recovery rebates, that provision applies fully to households earning up to \$150,000.

Other major elements of the American Rescue Plan Act likewise have little or nothing to do with COVID-19.

The package includes nearly \$129 billion for K-12 education, which ostensibly is aimed at helping students safely return to school. Yet, most of the more than \$100 billion in education funding authorized by earlier legislation remain unused, and the Congressional Budget Office projects that just 5% of the new money will be spent this fiscal year, which ends on Sept. 30.

Congress allocated \$350 billion to "coronavirus state and local relief funds" for governments that generally have emerged from the pandemic in much better financial condition than expected. California, for example, will benefit from this largesse even though it is running a surplus.

Another \$86 billion will be used to bail out union-run pension funds that were already in dire straits before the pandemic. Obamacare premium subsidies for households earning as much as \$350,000 annually will cost \$34 billion.

Republicans, who last year supported massive, frequently ill-considered spending in the name of fighting COVID-19, have changed their tune now that Democrats control the executive and legislative branches. They uniformly opposed the latest bill in the House and the Senate, and they plan to make political hay by accusing Democrats of using the pandemic as an excuse for fiscally reckless spending aimed at achieving longstanding policy goals, rewarding their party's most dedicated supporters, and enticing voters with found money.

Blatant hypocrisy aside, the Republicans have a point. The





When asked if he wanted to create a platform to amplify work by people of color, Galindo said he hadn't really thought about creating such space.

"My goal is to enter spaces that are traditionally white and suffer through the microaggressions," Galindo said, "in order to make those spaces less white.'

In the future, Galindo wants to create a production company which creates content that is more representative of the modern mainstream, "which is a very diverse and inclusive space."

"I really want to reach white audiences. They need to see us as humans.'

Woodworking in healthcare: the unsung hero of occupational therapy

 Volunteer woodworkers help meet the specific needs of Rancho patients.

DOWNEY - In a world of increasing dependence on plastic, 3D printing, and mass produced items, it's easy to forget that custom, bespoke pieces of woodworking still hold a place in healthcare.

Rancho Los Amigos National Rehabilitation Center serves patients who have suffered a lifealtering injury or illness (spinal cord injury, stroke, brain injury, or other neurological disorders). As such, each patient faces unique mobility challenges in their recovery and it is often left to their occupational therapist to find the tools and resources that best fit their needs. Many specialized or custom fit items a therapist might use to assist a patient might be difficult to find commercially or be cost prohibitive. For this reason, the Rancho Los Amigos Foundation proudly funds a volunteer woodworking program to assist with the needs of Rancho's patients.

Karl Burger, an 85 year old Downey local and Bell Gardens Lions Club member, is the current volunteer in a long line of talented woodworkers that have taken it upon themselves to create, design, and build these resources for the occupational therapy department and the patients at Rancho. Judges choose Best Baseball Book of 2020 for Casey Award

Spitball, the literary magazine of baseball, will hold its 38th annual Casey Award ceremony in late March in Kentucky for the Best Baseball Book Published in 2020.

As one of three judges, I picked "How Baseball Happened" by Thomas Gilbert and it turned out to be the winner by a landslide. Another judge also voted it #1, out of 11 titles, and the third put it at #3. It's an important book and a good read.

How Baseball Happened tells the story of baseball's evolution in the 19th century into a truly American sport, not one derived from the English bat and ball game of cricket.

Gilbert does for baseball what acclaimed popular historian David McCullough does in his historical studies for regions and periods of our country when the United States was defining itself in terms of the rest of the world (as it is still doing today). We needed to separate ourselves from Britain and forge a new national identity, and that includes dispelling the myth that baseball is descended from cricket or the English game of rounders.

Brilliant and entertaining, How Baseball Happened weaves newspaper clippings, headlines and cultural events into a 19th century tapestry of the nows and whys of what made baseball became our national pastime. Hint: It didn't happen in Cooperstown. Or Cincinnati. Baseball started as a bat and ball game for amateurs played by teams of gentlemen of refinement. By the early1800's we Americans had added the three-strike rule, nine innings, with 3-outs, position players, the 9 man team, foul lines, and a rounded bat, all unique to baseball and not found in flatbat cricket. In the 1800's, gloves had not yet been adopted. Still a neighborhood attraction, baseball was then played by the middle class, fire companies and militias. The rowdy Bowery B'hoys played it in New York. The first athletes of the Professional Era with salaries and contracts, were the New York Mutuals in 1869, not the Cincinnati Red Stockings of 1870, though the latter had a formidable record,65-0, for their first national tour. The Philadelphia Athletics and the Brooklyn Atlantics followed close behind. The other top ten books in the running include Mutt's Dream: The Making of the Mick, the story of how Mantle's father drilled him as a small child into becoming the greatest of switchhitters. It's said that there are more baseball books about Mickey Mantle than even about Jackie Robinson This one ends when he is 18, before he gets assigned the iconic number 7 for his uniform

A well written re-creation, the book is written from the point of view of Mutt Mantle, the Mick's father, for a change. Mutt forces Mickey to become a switch hitter - that's his dream. Author's skill in presenting pivotal scenes and dialogue makes this a good read even for non-fans of the game. A new look at those formative years.

"Bouton": One third rehash of Jim Bouton's career as a starting pitcher for the Yankees; one third, he writes the book, Ball Four. It was no secret, everyone knew he was taking notes all the time. They just didn't expect what kind of book it would be.

Final third, his life after that. Did Bouton suffer? Mickey Mantle didn't speak to him for twenty years. Bouton went on to a career as a commentator and writer. "Ball Four" was one of the explosive books of the century.

"Seaver:" When Tom Brady tried two years ago to patent the name Tom Terrific, the U.S. Patent Office ruled that it already belonged to Tom Seaver. A fully documented story, this tells how much his wife's constant attendance helped his career.

analytical technique that has brought out a new era of home runs. Attention to the launch angle and exit velocity made Justin Turner a home run hitter again. The "swing under the ball" technique approach by coaches has helped turn around his career with the LA Dodgers, and make him the slugger he wasn't when he began. The secret isn't steroids. Well written and a good read.

"Issei Baseball:" Well researched story of how baseball came to Japan with commodore Perry and was taken up by university students in 1880 and eventually came back to California with immigrant workers - the Issei - in the 1890's-1920's, working men who formed semi-pro leagues in the early 1900's.

A piece of history that deserves to be better known. The conclusion – that baseball unified the local Japanese-American community here with a sense of identity and pride. The book would have been better if developed even more. A followup epilogue 20 years later, on the internment of Americanborn Japanese Americans after Pearl Harbor recounts a stain on America's conscience. Good period pictures.

"Dalko" is the true story of Steve Dalkowski, the fastest pitcher who never made it in the Big Leagues.

"All arm, no control," was he verdict. Throwers throv the ball. Pitchers think and then they throw." Dalko was a thrower. Albeit, of a very fast ball. Whiz, hiss, thud.

"Billy Ball" is the story of Billy Martin and the Oakland A's and how they were made for each other. Follows Billy Martin's career that led up to his by-then inevitable success with the Oakland A's.

"The Wax Pack" follows up on the lives of 15 random stars 35 years after they were featured together in a Topps bubblegum package with their pictures in it. The book tells how they dealt with fame after retirement.

"The Wax Pack" is a nostalgia trip that starts with the author buying a 35 year old pack of Topps baseball cards and bubble gum. It's the actual story of his follow-through, interviewing each of the card's subjects, whose fame has long since gone, and how they have adjusted to life after baseball, (all are alive except one). Semifictionalized, the book becomes less about baseball than about the author and his obsessive compulsive problems. He also hooks up online via a dating service in every town he visits. 





Buyer or seller: who pays for what

If you've bought or sold a home before, you know the financial details are much more complex than just the listing price. From inspections to agent fees and everything in between, both buyers and sellers hold financial responsibility for transaction expenses and closing costs — and knowing who pays for what can help ensure a smooth sale.

While some aspects of closing costs can be negotiated into the contract between buyer and seller, certain things are typically paid by one party or the other. Read on to learn which big bills you, the seller, should be budgeting for and which will be the buyer's responsibility.

Who pays real estate commission?

Sellers pay real estate commissions, which typically total between 5% to 6% of the sale price. This amount is paid to the listing agent, who then shares roughly half with the buyer's agent.

Cost: On a \$200,000 home, a full-service real estate commission would cost the seller \$10,000-\$12,000. Each agent would receive \$5,000-\$6,000.

In an attempt to cut down on commission costs, some sellers decide to sell for sale by owner (FSBO), which saves the 3% they would pay to their listing agent. While selling FSBO can be a lot of work, it can result in a cost savings. It's recommended that you still offer a buyer's agent commission when you're selling FSBO, as you'll want to attract as many potential buyers as possible, and some buyer's agents may be less inclined to show their clients your home if they won't receive a commission.

Who pays escrow fees?

Escrow fees are typically split 50-50 between buyer and seller. Escrow fees cover the services of an independent third party to conduct the closing and manage funds during the

Cost: Usually 1% of the purchase price. On a \$200,000 house, that's \$1,000 for the seller and \$1,000 for the buyer. Note that this does not include the actual money being held in your escrow account for closing. This is just the fee for the escrow company's services.

Who pays for the home inspection?

The buyer pays for a home inspection if they choose to conduct one. Inspections are meant to protect the buyer from any hidden defects in the home that could impact the home's value, cost a lot of money to repair or make the home unsafe to live in.

Cost: The average home inspection costs between \$250 and \$700.

Sellers sometimes decide to do a pre-inspection for a better sense of what the buyer's inspector will find and the chance to make any important repairs before listing. A preinspection costs the same amount as a buyer's inspection.

Who pays for the appraisal?

Buyers cover the cost of the home appraisal, which is usually required by their lender if they will be taking out a mortgage to buy the home. Even if it isn't required, buyers sometimes complete appraisals for peace of mind that they're making

a smart investment and not overpaying.

Cost: The average cost of a home appraisal nationally is \$350.

Who pays for a land survey — buyer or seller?

The home buyer pays for a land survey, if they request one. Considered due diligence (much like a home inspection), a land survey lets the buyer know the details of the exact property they're purchasing, including property boundaries, fencing, easements and encroachments.

Cost: The average price is around \$550, but it can vary depending on property size, shape and location.

Who pays for title insurance?


Both the buyer and seller pay for title insurance, but each type is slightly different. The seller pays for the title insurance coverage for the buyer, and the buyer pays for the title insurance policy for their lender. In general, title insurance ensures the home is "free and clear" and that no third party has an unknown claim to the property.

Owner's title insurance (paid by the seller for the buyer)

Owner's title insurance provides protection so that no one else can claim ownership over the property from a prior dispute or lien from a contractor, attorney or other third party.

It's important for the buyer to have, because it protects them from legal or financial damages if another party were to try and claim ownership over the home in the future, after they purchase the home.

Cost: Buyer's title insurance costs between \$1,000 and \$4,000, depending on the scope and coverage.

Lender's title insurance (paid by buyer)

The lender's title insurance is paid by the buyer, and it protects the lender's financial investment in the home. It's usually required for any buyer who is buying with a mortgage, and the coverage remains until the loan is refinanced with another lender or paid off.

Cost: Lender's title insurance coverage costs between \$500 and \$1,000.

Who pays for a home warranty — buyer or seller?

The seller pays for a home warranty. It's often offered as an incentive to attract buyers, but it's not required. Offering a home warranty gives the buyer assurance that they won't have to pay any huge repair bills soon after moving in — most policies are good for a year. They typically cover the home's major

systems, including plumbing, electrical and appliances.

Cost: A one-time cost of between \$300 and \$500 for one year of warranty coverage.

Who pays real estate transfer taxes?

The seller is responsible for paying any real estate transfer taxes, which are charged when the title for the home is transferred from the old owner to the new owner. Transfer taxes can be levied by a city, county, state or a combination.

Cost: Transfer tax costs vary dramatically in different parts of the country and can even vary from one city to its nearby suburbs. And rates can fluctuate over time based on levies and tax rate changes. In some areas, transfer taxes may only apply to homes sold over a particular price point. Ask your real estate agent or escrow company for the correct rate for your area.

In some parts of greater Phoenix, Houston, Portland and other areas, there is zero transfer tax on the sale of a home. But again, these taxes are designated by multiple municipalities making the tax breaks specific to each small region and difficult to summarize at scale.




