Meredith Perkins, two-time Downey mayor, dies at 84

■ A beloved civic leader, Meredith Perkins died at his home Tuesday, leaving behind a legacy of service.

DOWNEY Meredith Perkins, a former two-time mayor of Downey, died Tuesday after battling recent health struggles.

Perkins served on the City Council from 1998 to 2006, representing District 1.

He was a fierce advocate of Rancho Los Amigos National Rehabilitation Center and helped oversee renovation of the Rio Hondo Event Center.

He was also instrumental in bringing a skate park to Downey, which was named in his honor.

In a 2011 interview, Perkins said the skate park was important to him because "it's a place for young people to get together and enjoy the outdoors. The skate park is a great place to congregate and exchange ideas. I think it's a great outlet.'

Perkins was 84.

"We are saddened to have lost another great Downey servant," Mayor Claudia M. Frometa said in a statement. "Former Mayor Meredith Perkins was dearly loved and admired for his dedication to our city and his fierce advocacy for all that is good and honorable. His legacy of service to our city will always be remembered.

Perkins was heavily involved in the Downey community even after he left the City Council in

He was a past president of the Downey Optimist Club, a board member with the Downey YMCA, and also supported The Arc.

Mario A. Guerra, who replaced Perkins on the City Council in 2006, called the diminutive Perkins "the biggest man I've ever known."

"He called himself 'the little guy' to his friends but he had the biggest heart of anyone I knew," Guerra said. "He was a deeply faithful man that believed in the premise that we should always treat each other with respect and kindness. He lived his life that way and was an example to

grateful to him for. During his Mayoral term he finished the Rio Hondo Golf Course, and he liked to say, on time and under budget. He loved the YMCA and The Arc and was generous with his time and treasures for both. He loved our youth and was the driving contagious," Vasquez said. "I force in our city building the skate park. 

Meredith Perkins (known as Perk to friends, and self-named "The Little Guy") was born in Bauxite, Arkansas, a small mining town 30 miles Southwest of Little Rock. In the late 1940s, Young Perk's family decided to journey west and settled in Southern California. (This area just hasn't been the same since). Adolescent Perk graduated from Lynwood High School in 1955 and thereafter attended Cal State Long Beach. He has continued his friendship with countless high school and college friends.

Fresh out of college, Young-Adult Perk started his own business in 1960. In 1962, Perk and his wife Irene settled in Downey, CA and raised three wonderful children (Peggy, Greg and Jeff). Unfortunately, they lived on the wrong side of town and sent their children to Warren High School. All three have become successful adults in their own right and,

in fact, Dr. Greg Perkins is currently completing his medical residency in St. Louis, MO. Having had his son Greg attend USC Medical School, Father Perk became a very big Trojan Fan and has been known to hire the SC Band and Cheerleaders for special events.

Perk began a lengthy career in sales as the Regional Sales Manager for Eutectic Welding Alloys, where he sat atop in the national sales rankings for 15 years. He later joined Bowman Distribution (serving the West Coast of this Clevelandheadquartered company) and completed his stellar career after 27 years of service there at

So, "what else should we know about Mayor Perk?" Well, being involved in the community is what Mayor Perk has always been. Whether it be coaching DJAA sports, serving on the YMCA Board, active involvement with the Optimist Club, joining his sons in Boy Scout Fellowship and even his daughter with the Girl Scouts, or even serving as the very prestigious Vice-President of the Warren High School Bear Bingo Group, Mayor Perk has always jumped at the opportunity to be involved in his local community.

Now you may be wondering, "just how did our Mayor get his political start?" Running political campaigns is nothing new to our Mayor. It began in

middle school with a successful campaign for Class President, continued at Cal State Long Beach in the running for Student Body President, and culminated in two successive and successful campaigns on the Downey City Council. Our Mayor has never lost an election!

Mayor Perkins' first involvement with the City of Downey was as a member of the General Plan Advisory Committee in 1990. In 1992, he was appointed by Mayor Barbara Riley to serve on the Planning Commission, where he diligently served for six years until 1998, when he made his successful bid to the Downey City Council. In 2002, Perk was re-elected to a second and final term and now is upon his final days (in office, that is).

Mayor Perk's record of accomplishment is way too long to recount them all. He has well-served as a city liaison to the County of Los Angeles' Sanitation District, Vector Control (pests and bugs capable of transmitting diseases) and SEAACA (Southeast Area Animal Control Authority) and numerous city council committees and subcommittees. To those most close with him, we know that he is most proud of delivering the following to the Downey Community:

■ The undergrounding of the Edison power lines along

■ Roadway medians and improvements along Paramount

■ The delivery of the Downey Skate Park (even though it isn't in his district)

■ Protection of the Rancho Los Amigos Hospital and its property

■ The Downey Landing

Project and Kaiser Hospital

■ And, most notably, the successful sale (yes, the concept had to be sold to the public) and construction of the new and

improved Rio Hondo Clubhouse. Perk, I will miss the heart

and soul you put into this position for the eight years that you served. I was lucky to work alongside you for the last six. The Downey High vs. Warren High banter made even stressful times enjoyable.

Perk will be missed by all on this council and in this community. We'll forever remember his famous quote, "On to Victory!" And, yes Mr. Mayor, you have more victories ahead of you. You may call yourself "The Little Guy," but you've always been "The Big Guy" to us.

Paging Dr. Frischer...

It's no secret: our planet is suffering from extreme weather and warming. Let's not ignore

Climate change is considered

the biggest global health threat of the 21st century yes, a greater threat than this current pandemic.



of climate change include record temperatures and drought, melting glaciers, severe storms and floods,

fires, and the many health threats that accompany them: air pollution, disease-carrying insects, access to safe water and food, displacement, and mental illness. As is so often the case, the impacts of global warming disproportionately affect the most marginalized groups of people, including those with disabilities, low-income families, the elderly, and those who live in more remote areas.

How does this impact our personal health?

Hotter days are expected to become more common and severe. Rising temperatures in summer months can add many

thousands of premature deaths from heat stroke and exhaustion, and from the exacerbation of heart and kidney problems. In general, children and older adults are the most vulnerable to heat, along with those with chronic medical problems and those on certain medications.

Frost-free seasons will lengthen. Warmer weather allows mosquitoes to live longer, leading to increased disease transmission. In warmer climates, ticks experience longer periods of activity. This will increase the spread of diseases like Zika, dengue, and West Nile.

Increased ground-level ozone and smog will result in worsening air quality, which in turn will lead to more serious respiratory diseases. Larger and more frequent wildfires will continue to unleash dangerous particles and gasses into the air. Allergy seasons will last longer and be more intense.

88% of the world's population breathes air that does not meet the World Health Organization's air quality guidelines.

Crop yields and food security will be impacted. Floods, droughts, and storms occur in greater frequency with climate change, and any of these can wipe out harvests. Pest infestations are likely to increase. Elevated levels of carbon dioxide reduce the nutritional value of some crops like wheat and rice, and warmer summers affect many crops. Warmer temperatures also reduce milk production on dairy farms, and can reduce water quality by encouraging the growth of harmful algae.

Extreme weather like hurricanes and wildfires bring with them a decline in our safety and well being. It harms our health care infrastructure, making it more difficult for people to receive needed care. Heat causes mood changes and fuels aggressive behavior, and worsening air pollution leads to an increase in mental health issues like anxiety and depression.

How might an individual slow

global warming?

Use your energy: Install renewable energy sources like solar panels, or use a utility company that generates much of its power from wind or solar sources.

· Use your home: Weatherize to better retain both cooling or heating.

· Use your appliances: Choose appliances that are energy efficient.

Use your water: Reduce water waste, which reduces the amount of energy it takes to get water to you.

Use your food: Minimize food waste, and consume less meat. 10% of energy in the United States goes into growing, pro-

cessing, packaging, and shipping food. Approximately 40% of this food ends up in landfills. Note that livestock are among the most resource-intensive of all food sources.

Use your lighting: Invest in LED bulbs, which use up to 80% less energy than conventional incandescent bulbs. They are cheaper in the long run.

· Use your car: Drive a fuel-efficient vehicle. Save fuel by keeping tires properly inflated, and by keeping it well maintained.

Use your voice: Speak up for positive change.




The city encourages everyone to protect themselves and their families from COVID-19 by following all guidelines from public health officials.

• Detectives are investigating a shooting that occurred on 3/24/2021 at about 10:25 pm in the alley off the 8600 block of Stewart and Gray Rd. Several subjects gathered in the alley where a fight ensued. The suspect drove up to the group and discharged a firearm into the air. It appeared the suspect fired the gun with the intent to disperse the group. The suspect left the alley prior to officers' arrival. Officers were not able to locate the suspect. No one was injured in this incident.

· Detectives are investigating an assault that occurred on 4/2/2021 at about 8:25 am in the 9100 block of Brookshire Ave. The adult female victim was asleep inside her apartment when the suspect (a relative of the victim), kicked open the front door. The suspect attacked the victim as she laid in bed. He repeatedly struck her in the face and head with a closed fist, causing severe swelling and possible fractures to the left side of her face. The suspect fled on foot prior to officers' arrival. The victim was transported to Downey PIH.

Isamu Akasaki, inventor of blue **LED light**

Isamu Akasaki, a Japanese physicist who was part of the Nobel Prize-winning team that developed blue LED light, a breakthrough that led to the widespread use of LED today, died April 1 at a hospital in Nagoya, Japan of pneumonia at the age of 92.

Early LEDs emitted red light. They were useful in technological applications, but they only provided a very small amount of light.

Creating a blue LED was a challenge that many scientists worked on, including Akasaki and his graduate student, Hiroshi Amano. They successfully developed an LED that emitted blue light, and Shuji Nakamura further refined their process to create a blue LED that produced abundant light.

This was key to today's ubiquitous use of LEDs as efficient light sources, and the technology is also used in flatscreen TVs, automobile headlights, medical devices, and much more.

Akasaki, Amano, and Nakamura shared the Nobel Prize in Physics in 2014 for their work. Akasaki received hundreds of other patents for his work over the years, and he was awarded for his work with honors including the Kyoto Prize in Advanced Technology, the Edison Medal, and the Queen Elizabeth Prize for Engineering.

Martha Lou Gadsen, soul food cook

Martha Lou Gadsden, owner of the iconic Charleston, South Carolina soul food restaurant Martha Lou's Kitchen, died April 1 at her home in Charleston at the age of 91.

After years of cooking at

Gadsden opened Martha Lou's Kitchen in 1983 in a converted Charleston service station. There, she served a soul food that's specific to the Low Country region of the South Carolina/Georgia coast.

restaurants owned by others,

Gadsden's specialties included beef stew with oxtails, chitterlings, okra soup, and her best-selling fried chicken. Over the years, Martha Lou's Kitchen began attracting notice from foodies and tourists, and Gadsden's reputation as a top soul food chef grew.

The restaurant was featured in the New York Times and on TV's "Top Five Restaurants" and "The Zimmern List."

Gadsden continued her work at Martha Lou's Kitchen until the restaurant closed in September 2020 as the landlord sold the lot and the building was slated to be demolished.

"I work by air; I do not measure," she said in a 2013 interview. "I know what I want done but to give you the recipe I'll have to just make up one because I know how I fix my food. And see everybody don't do the same. See, I put a dash of this and a dash of that and a dash of that. And then I get it coming out my way."

Gloria Henry, 'Dennis the Menace' TV mom

Gloria Henry, the actress who became a household name in the late 1950s when she landed the role of Alice Mitchell, the title character Dennis' mother on the

hit sitcom "Dennis the Menace," died April 3 at her home in Los Angeles at age 98.

After a minor movie career in the 1940s and '50s, Henry landed her most notable role, playing Alice Mitchell in TV's "Dennis the Menace." She starred as the gentle, loving mother of the mischievous little boy from 1959 until the show's cancellation in

Later, Henry made appearances on TV shows including "Hazel," "Falcon Crest," "Dallas," "Doogie Howser, M.D.," and "Parks and Recreation." Her film credits include "Miss Grant Takes Richmond" (1949) with Lucille Ball and "Gang War" (1958) with Charles Bronson.

"Many of the fans say, 'Oh, I always wished you were my mom' and 'My mom was jealous of you, because I wanted you for a mom.' Which is pretty funny, because I don't think my own children felt that way," Henry said in an interview. "I have a daughter and two sons. All they knew was, I was off to work, and I wasn't with them as much as they would have liked me to be."

Lee MacMillan, social media influencer

Lee MacMillan, a social media influencer who shared stories of her "van life" travels, died by suicide March 26 at age

MacMillan became a popular influencer alongside her thenboyfriend, Max Bidstrup, as the couple traveled around the Americas in a van.

Their videos for their Max & Lee YouTube channel documented how they handled a minimalist lifestyle of tiny home living as they traveled and camped in the van, as well as sharing their many adventures.

After MacMillan and Bidstrup broke up in 2020, MacMillan continued to share her life via her Life with Lee YouTube channel and Instagram account. In addition to documenting her adventures, MacMillan candidly discussed her struggles with mental health.

A post to MacMillan's Instagram account on Monday confirmed her death was by

"After living an extraordinary life, and fighting a brave battle with depression, that Lee took her life on Friday," the post said. "She was the brightest light, a magnetic force of nature and was loved by so so many.'

The statement continued, "If we can do one thing for Lee now, in the midst of this soulcrushing loss, it's to spread the message that mental health is just as real as physical health,

they may seem. It's ok to not be ok, it's ok to ask for help, it's absolutely necessary to ask for help.'

Bibian Mentel, Paralympic gold medalist

Bibian Mentel, a snowboarder who won three gold medals at the Paralympic Winter Games after losing part of her leg to cancer, died March 29 at her home in Loosdrecht, the Netherlands of brain cancer at the age of 48.

Mentel was a Dutch snowboarding champion before her illness, winning the national championship six times. She was preparing to compete in the 2002 Winter Olympics in Salt Lake City when she injured her ankle.

An x-ray revealed a bone tumor, one that had initially occurred in 1999 and was now back. Mentel's leg was amputated below the knee and she was told she'd never snowboard again.

Instead, she was back on the slopes as soon as possible, and seven months after her surgery, she won her seventh Dutch championship, competing against non-disabled athletes.

The Paralympics initially weren't an option for Mentel, as snowboarding wasn't included in the games. But she lobbied for years, and the event was finally added to the 2014 Paralympic Winter Games.

Mentel won gold in the snowboard cross that year, and she came back to the 2018 Paralympics and won gold in both snowboard cross and banked slalom.

But Mentel's cancer continued to return over and over again. She had five more surgeries even as she continued to compete as often as possible.

"As an athlete, it's a funny thing — people look up to you, put you on a pedestal, think you're capable of doing anything," Mentel said in 2018. "A week later, suddenly you're disabled, and now people were telling me what I could not do. And this made me really rebellious. Because, let's be honest: The more people were telling me what I could not do, the more I wanted to prove them wrong.

Morris Dickerson founding member of War

Morris "B.B." Dickerson, the bassist and a vocalist for the classic funk-rock band War, died April 2 at a hospital in Long Beach after a long illness at the age of 71.

Dickerson was one of the founders of War in 1969. His distinctive bass lines helped give the band their unmistakable

funk-rock sound.

Dickerson co-wrote some of War's most enduring hits, including "Low Rider," "Why Can't We Be Friends?" and "Summer." He also provided vocals on some songs, including singing lead on 1972's "The World is a Ghetto."

Dickerson recorded 12 albums with War before his departure from the band in 1979. In the 1990s, he reunited with some members of War to form the Lowrider Band.

Alcee Hastings, long-serving Congressman

Alcee Hastings, a U.S. Representative from Florida who served from 1993 until his death, died April 6 after a battle with pancreatic cancer at the age of

Hastings began his career as a lawyer in Fort Lauderdale, Florida, taking on civil rights cases in an area where the rights of Black people were often threatened in the 1960s and

Hastings fought to desegregate Broward County schools and sued establishments that wouldn't serve Black people.

After building a reputation as a crusader for social justice, he made history in 1979 by becoming the first Black federal judge in Florida. But his term on the bench ended 10 years later in impeachment and removal after he was tried on charges of soliciting a bribe.

He became the first sitting federal judge to be tried on criminal charges. The impeachment ended his judicial career, but it didn't prevent him from seeking - and winning public office in the future.

Hastings had mounted several unsuccessful bids for various public offices, including the U.S. Senate, before his first win in 1992 – just three years after he was removed from the federal bench. He was elected to the House, representing Florida's 23rd district and later its 20th district. He would go on to mount another 14 successful campaigns, becoming the longest serving current member of the House. Serving on the Rules Committee, Hastings earned a reputation in Congress for speaking his mind.

"The most practical way of run," Hastings said after his cancer diagnosis. "The simple fact of the matter is that I have faced no challenge as considerable as this particular one, but I face it with the same courage that I've faced other challenges, and that is it ain't nothing but something to do."



When it comes to the water that flows from your tap, you rarely think about where it comes from before it reaches your home or business or how many rigorous rounds of tests it undergoes. We worry about that, so you don't have to.

In Downey, 100 percent of our water comes from our abundant groundwater supply. Our local supply also means that our customers enjoy some of the least expensive water rates in Southern California, as well as a trustworthy local supply that they

From time to time, organizations or individuals may make false statements that our water does not meet drinking water quality standards. Rest assured it does.

One of the substances in our water that our customers may hear about in our community, as well as nationwide, is per- and polyfluoroalkyl (PFAS) chemicals. PFAS has been used in many products, such as stain-resistant coatings on carpet, clothing and furniture; paper food packaging; firefighting foam and nonstick coatings on cookware. These substances may then enter groundwater supplies through the use of firefighting foam,

landfills, wastewater treatment plant discharge and industrial

We are pursuing legal action against several companies that manufactured the PFAS that is found in our groundwater supply. This action will protect our ratepayers and ensure that these companies compensate our City for past, present and future costs for testing, treating and removing PFAS.

To ensure that our water is ready for our customers and complies with state guidelines and the EPA's PFAS Health Advisory, we test it thousands of times per year. We proactively monitor for PFAS and other naturally occurring and man-made substances in our water. Only water that meets state and federal drinking water standards and regulations is served to our customers.

We protect our water at its source and work with state experts and scientists to immediately address any pollutants. Thanks to ongoing water testing, the City's Annual Water Quality reports show our water meets some of the most stringent water quality standards in the nation.

The City of Downey is located within the Central Basin Municipal Water District's 227 square mile service area and its

Board President Art Chacon has recently released a statement saying that Central Basin values the City of Downey as a customer and believes that our City is in full compliance with the established drinking water quality standards.

Communicating regularly with our residents on important City matters is a top priority to us. "In government, you always fail up," complains Tate.

The LA Times wrote that Biden wouldn't nominate California Labor Secretary Julie Su because "rampant levels of fraud scuttled (her) prospects." Biden then made her deputy secretary of labor.

"If we make America California," concludes Tate, "we are all going to be paying for it."

At least Californians can move to other states. But I don't want to leave America.

Leaving Afghanistan

The U.S. mission in Afghanistan is nearly old enough to buy a beer, having gone on since 2001. Two presidents, Barack Obama and Donald Trump, promised it would come to an end, but the war outlasted them

Trump's administration negotiated a deal with the Taliban that committed us to leave by May. That obligation was conveniently scheduled for after the 2020 presidential election, making it Joe Biden's problem. Biden said at his news conference last week, "It's going to be hard to meet the May 1 deadline." But when asked if our troops would still be there next year, he said, "I can't picture that being the case."

Really? He served as vice president under Obama, who campaigned on a promise to get out within 16 months. Running for reelection in 2012, Obama promised to end our involvement by 2014. Trump made similar promises, which were equally empty.

If Biden can't picture our forces staying into next year and beyond, his imagination is failing him. There are powerful reasons to think they'll be in Afghanistan in 2022. Also in 2023. And 2024. And ..

than staying. Our departure could lead to an expanded war between the Kabul regime and the Taliban, the defeat of the Afghan army and the Dear Editor: return of the Taliban to power.

No president wants to have to answer for what could be the grim aftermath of our departure. Biden can remember the 1975 debacle following our withdrawal from Vietnam, when U.S. embassy staff in Saigon evacuated in helicopters as desperate Vietnamese took to the sea in rickety boats to escape. For the time being, the easiest way to avoid an embarrassing outcome is to stay.





WrestleMania: Preview and Predictions

Like the rest of the world around it, it's been a weird year for sports entertainment.

Due to Covid-19, fans have watched as matches went from packed arenas to virtual "Thunder Domes." Matches, segments, and storylines have also changed, some of which taking on more theatrical narratives in lieu of the traditional collar and elbow tie-ups and smack talking.

Now, the world starts to crawl its way to a sense of somewhat normalcy, and at a perfect time for wrestling fans - WrestleMania.

After the biggest show of the year was held in an empty performance center last year, a limited number of fans will enter the Raymond James Center in Tampa for the "Showcase of the Immortals.'

Here is the list of announced matches (at the time of writing), along with predictions.

Night 1 **WWE Championship Match** – Bobby Lashley (c) vs Drew

McIntyre

It's important to stick to your budget and not overextend yourself.

Being unprepared for the mortgage process. Finding the right mortgage is complex and time-consuming.

Be sure to have all necessary financial documents and details ready to submit to your lender.

Documents you will likely need include tax returns for the past two years, bank statements, pay stubs, and any statements from retirement or brokerage accounts.

If you are a renter, you will likely need to show payments for the past 12 months and contact information for your landlord.

Also, you'll want to shop around and get multiple mortgage quotes. It takes time but could potentially save you big money.

Forgoing home inspection. Always pay for a home inspection. They cost up to \$500 but can uncover critical issues that may cost much more to fix down the line if they're not identified before your closing date.

Forgetting about closing costs. You saved for a down payment, but what about closing costs?

Don't believe these common bankruptcy myths

For consumers weighed down by debt, bankruptcy may sound like the perfect solution. But while it may seem like an easy fix, the repercussions can be steep. Add in the numerous myths about bankruptcy, and it can be challenging to know whether it's the right move.

"Bankruptcy should always be the last resort for people under financial stress," said Michael Sullivan, a personal financial consultant with Take Charge America, a national nonprofit credit and debt management agency. Sullivan breaks down seven common bankruptcy myths:

Bankruptcy offers a fresh start. Many people believe bankruptcy will cure their financial problems and eliminate all their debts. The truth isn't as rosy. Several debts cannot be discharged through bankruptcy including student loans, child support and alimony, criminal restitution and fraud debts. Additionally, a Chapter 13 filing requires some

repayment. Bankruptcy also isn't cheap, costing upwards of a few thousand dollars. You also must go through bankruptcy counseling before and after you

I'll lose everything even my job. Bankruptcy laws vary by state, but each one includes exemptions for assets like homes, vehicles, household goods and retirement savings. Additionally, federal law prohibits termination of employment because of bankruptcy.

Spouses must file, too. Depending on whose name is on the debt, spouses usually do not have to file together. However, if married couples have joint credit cards or debts, they will need to

file together.
