# **Docuseries paints picture** of combat sports during pandemic

 City and concession operator renegotiate contract after pandemic decimates revenue.

DOWNEY - The city of Downey amended its contract with Z Golf Food & Beverage Services, LLC ("Wedgewood Weddings") on Tuesday, for food and beverage service concessions at Rio Hondo Golf Club.

Downey initially entered into the 10-year agreement back in November of 2019. In January of 2020, Wedgewood Weddings began overseeing banquet services, restaurant operations, and golf food beverage services. Wedgewood began making rental payments the following month.

Since the onset of the coronavirus pandemic, however, the company has been forced to cancel more than 131 events at Rio Hondo, due to the county's prohibition of indoor events and limited restaurant capacity.

Restaurant service has also been crippled due to the venue's lack of outdoor space conducive to substantial food service options.

While regulations have started to ease, weddings and indoor events have yet to be given the green light by LA County Public Health.

Given the impact and anticipation of slow recovery, Wedgewood requested several amendments to its agreement, including:

**DOWNEY** - Three Warren High School graduates recently filmed a four-episode docuseries, giving insight into some of the struggles that the world of Jiu Jitsu faced after the onset of the pandemic.

"Non-Essential: A Jiu Jitsu/ COVID-19 Series" paints a picture of the real issues that combat sports faced once Covid-19 landed.

Its story starts at one such school found on Downey Avenue.

Academy Jiu Jitsu was continuing to gain momentum and find success before - like many of the other businesses on Downey Avenue - it was forced to close its doors due to COVID-19.

"We were doing really well until we took a proactive step on closing The Academy on March 12, before anything statewide had started to make us shut down," said co-founder Hector Beltran, 34.

Like many others at the time, The Academy was deemed a nonessential business.

"We were pretty much dead in the water," said Beltran. "We were trying to make videos from the Academy to provide some sort of current online content for our students so they could stay engaged with jiujitsu and stay active, but it came to the point in early May where we were still not aware of what was a future date that we were going to reopen and get back to teaching. We had a lot of free time and not much to do.'

DOWNEY City commissioners, committee and board members will be held to a higher standard of ethics, after the City Council approved a code of

conduct for them on Tuesday. While councilmembers have the ability to appoint and dismiss their representatives, the new language will offer a clear image of what is expected of each individual once sworn in.

This comes after several commissioners have argued with each other over social media.

aforementioned The representatives will now sign a two-page document that outlines five areas of conduct, including:

-Integrity / honesty

-Responsibility / protecting the public's interest

-Fairness and accountability

-Respect for fellow appointed officials, staff, and the public, and -Proper and efficient use of

public resources.

The code was passed 4-1 with Councilwoman Catherine Alvarez opposed.

A similar code will be brought back for the City Council at their next meeting.

# **Cerritos College will open at 50% capacity**

The college will transition to a hybrid instructional model for the fall semester, which begins Aug. 1.

NORWALK – Over the Easter Sunday weekend, Cerritos College President and Superintendent Dr. Jose Fierro announced in an email to staff and faculty that the college will remain online for summer sessions before transitioning to in-person learning in the fall 2021 semester.

"The college will offer 50%

of all class offerings for each department in a hybrid format," Fierro said, "As we return to public Monday through T campus, the district will continue to comply with mandates and guidelines from the state and local health officials.

The email references the latest update from the state, putting Los Angeles County into the orange tier on its COVID-19 monitoring system. This classification will allow restaurants, movie theaters, churches, museums, zoos and aquariums to allow guests at 50% capacity. The new rules were responded with another email implemented midnight on Monday, April 5.

The president's email also announced that all "regular" employees will be required to return to campus "at a minimum

Offices will be open to the public Monday through Thursday for at least eight hours a day.

Fierro then said that by the end of April, the college will work with department chairs to determine which courses will remain online and which will begin in person instruction to meet the 50% threshold.

Lynn Wang, president of the Cerritos College Faculty Federation, one of the school's faculty unions, to faculty stating that the union was not involved in the decision making and questioned whether faculty would have the right to refuse teaching on campus if they choose to do so

you, were under the impression that returning to campus in fall 2021 would be voluntary. This was the message that Dr. Fierro himself shared when asked by constituents."

Wang's email also encouraged employees to reach out to the administration and the Board of Trustees with their questions.

According to Fierro, the college will make some accommodations in preparation for this transition, including a walkthrough of campus facilities, which will determine where new sanitizing stations, trash cans and plexiglass barriers will be installed.

Knowing that the OT's could continue their therapy sessions in the garden where they would engage their patients in the nurturing, harvesting, and even cooking of the food, made Janet so incredibly happy. "The garden is a wonderful approach to experiencing rehabilitation in a way that most other hospitals cannot offer," said Janet.

Rancho's Restorative Garden, which is run by Occupational Therapy but made available for use by other departments such as physical therapy and recreational therapy, provides the perfect location for meeting a variety of patient needs.

From Tai Chi amongst the flowers for flexibility training, to building and decorating windchimes for dexterity, the garden's peaceful space accommodates an assortment of activities. On any given day, the garden might be used to help a patient learn to walk again, to navigate their wheelchair

on an uneven surface, or to help someone with PTSD come to terms with their injury as they start tending to their own section of the garden

Occupational Therapist Monica Becerril believes, "being in nature is very healing, as patients get to utilize all of their senses whether they are seeing the beautiful flowers, plants, and vegetables, smelling the bountiful lavender, or tasting the spearmint for relaxation. We even show them wavs to create a garden (or a miniature herbal tea patch) at home even if their space is limited.'

Family members of patients have shared that the Restorative Garden has helped their loved ones who may be experiencing depression, start to open up, smile, and laugh again.

Monica commented, "As therapists, we try to help and guide our patients to find ways they can engage in meaningful interaction in an adaptive or modified way, so they can live their life to the fullest.

# **Downey passes on hiring full-time interpreter**

 Citing lack of need and costs, council members decline to pursue hiring of an interpreter.

DOWNEY - Downey council members decided Tuesday to hold off on hiring a full-time interpreter for their council meetings, citing a lack of inherent need.

City Traditionally, Clerk Alicia Duarte has stepped in and interpreted for public speakers who wished to address the council but

If there is a higher need at a given meeting, the city offers on demand and advanced notice services.

The suggestion to hire a designated interpreter brought forth by Councilwoman Catherine Alvarez, who voiced concerns for Duarte.

"I hate the fact that Alicia has to take all the bullying from people that are speaking, and she cannot translate very well," said Alvarez.

When asked by Livas about how she felt about her abilities, Duarte expressed mostly confidence.

## FEMA offers financial help with funerals

**DOWNEY** – The Federal Emergency Management Agency (FEMA) began processing applications this week for assistance funding of up to \$9,000 COVID-19-related funeral for expenses incurred after Jan. 20, 2020.

processing FEMA is applications by phone to ensure that all applicants are able to speak to a contact and have their questions answered. Those who the following conditions: are seeking assistance can apply by calling 844-684-6333 from 9 a.m. to 9 p.m. ET, Monday through Friday.

Multilingual services are available. FEMA's call center has already received a high number of applications, and FEMA requests that applicants exercise patience through the process and have the required documents and information ready before calling. There is no deadline to apply.

To be eligible for funeral U.S. citizen, non-citizen national, American Rescue Plan Act of 2021. assistance, applicants must meet

The death must have occurred in the United States. The applicant must be a U.S. citizen, noncitizen national, or qualified undocumented individual who incurred funeral expenses after January 20, 2020.

The death certificate must indicate the death was attributed to COVID-19.

There is no requirement for the deceased person to have been a

qualified undocumented or individual.

For fastest service after calling, applicants are encouraged to submit documentation online through Disasterassistance.gov, or by fax to 855-261-3452. Documents may also be mailed to: COVID-19

After FEMA began accepting applications, U.S. Representative Lucille Roybal-Allard (CA-40), the chairwoman of the House Appropriations Subcommittee on Homeland Security, issued the following statement:

the overall number As of coronavirus cases trends downward, the virus is still infecting people in Southern California.

On Wednesday, health officials announced 57 new deaths and 411 new infections.

There are currently 493 people hospialized with Covid-19 throughout L.A. County; of those, 26% are in the ICU.

younger residents at all stages of the pandemic, with the highest rates among residents above 80 years of age.

With the decrease of hospitalization rates for people of all ages, and the large number of older people who are now vaccinated, the rate of hospitalizations for those over 80 years old has dropped by 96%.

Underlying conditions are strongly associated with deaths due to Covid-19. Since the beginning of the pandemic, 85% of people

Older residents have been who died as a result of Covid-19 hospitalized at higher rates than infection had an underlying condition.

> The most common condition was high blood pressure or hypertension, which was an underlying condition for 52% of those who died.

> Forty-one percent of those who died had diabetes, 26% had cardiovascular disease other than hypertension, 21% had neurologic disease, and 16% had chronic renal disease

Of the 57 new deaths reported Wednesday, 26 people that passed

away were over the age of 80, 16 people who died were between the ages of 65 and 79, 10 people who died were between the ages of 50 and 64, and three people who died were between the ages of 30 and 49.

Two deaths were reported by the City of Long Beach.

To date, about 1.5 million LA County residents between 16 and 49 have received at least one dose of the vaccine, which means 3.5 million residents in this group still need to be vaccinated.

## City donates \$2,500 to Rancho Foundation

DOWNEY - The Downey City Council on Tuesday approved a \$2,500 donation to the Rancho Los Amigos Foundation at the request of Mayor Pro Tem Blanca Pacheco.

The funds had initially been intended for a table at the Amistad Gala, a black-tie fundraiser that the Rancho Foundation holds each year. However, this year's event was canceled for the second year in a row due to the ongoing Covid-19 pandemic.

The city received a request from the foundation - submitted by Pacheco, who sits on the foundation's board of directors - to convert the initial table reservation to a straight donation, used to support patient programs and initiate a matching gift campaign with current donors and the community.

#### Joye Hummel, pioneering comic book writer

Iove Hummel, the first woman to write for Wonder Woman comics, writing anonymously for several years in the 1940s, died April 5 at her home in Winter Haven, Florida at the age of 97.

Hummel wasn't looking for a job as a comic book writer. She was 19 years old and a recent graduate of secretarial school. But one of her instructors approached her to ask if she'd help write some stories for his comic.

He was William Moulton Marston, Wonder Woman's creator, and he had noticed while teaching Hummel that she was a good writer. He wanted a young woman who believed in Wonder Woman's feminist philosophy and could also write using current slang.

Hummel happily took the job and wrote at least 70 scripts for Wonder Woman comics between 1944 and 1947, a time when the DC Comic already had an avid audience. She included fairy tale characters, like mermaids and winged women, in the stories she wrote.

Hummel stopped writing for Wonder Woman after Marston's death, when she became unhappy with the less feminist direction the comic was taking without his influence. She later worked as a

#### stockbroker.

Her name hadn't appeared on her work, so she remained largely unknown until she was profiled in Jill Lepore's 2014 book, "The Secret History of Wonder Woman."

In 2018, Hummel was honored at San Diego Comic-Con International with the Bill Finger Award, which recognizes unsung writers.

#### Charles Coolidge, Medal of Honor recipient

Charles Coolidge, a U.S. Army veteran of World War II who was the oldest living recipient of the Medal of Honor, died April 6 in Chattanooga, Tennessee at the age of 99.

Coolidge was drafted into the U.S. Army in June 1942, just months after the U.S. entered World War II. It was in October 1944 that he earned his Medal of Honor, the nation's highest military honor in recognition of valor.

A sergeant, Coolidge and his men were severely outnumbered by German soldiers in the Vosges Mountains. They fought for days to take Hill 623 as the Germans continued to drive them back.

Coolidge bravely led his troops as they held the line for four days of fighting, including dodging

five tank rounds that were fired directly at him. He received the Medal of Honor in 1945.

Never once injured in the war, Coolidge was also honored with a Silver Star, Bronze Star, and French Legion of Honor.

After the war, he worked at his family's business, Chattanooga Printing & Engraving.

#### DMX, influential rapper and actor

DMX, an influential acclaimed rapper and actor known for hits including "Party Up (Up in Here)," died April 9 at a hospital in White Plains, New York, after being on life support from a cardiac arrest.

He was 50.

DMX, born Earl Simmons, began rapping in the genre's early days. He beatboxed for another rapper before beginning to write his own lyrics and perform.

DMX's mixtapes helped build his popularity around New York, and he began being featured on other rappers' releases, including LL Cool J's 1991 single "4, 3, 2, 1." His raspy growl of a voice was distinctive and immediately recognizable.

By the late '90s, DMX had a recording contract with Def Jam Records, and he released his first solo hit in 1998, "Get at Me Dog. His debut album, "It's Dark and Hell Is Hot," entered the Billboard chart at No. 1, and so did his next four albums - he was the only rapper to have his first five albums debut at No. 1.

His third album, "...And Then

#### There Was X," included the 2000 Top-Ten single, "Party Up." DMX was nominated for Grammy Awards in 2001 for Best Rap Solo Performance ("Party Up") and Best Rap Album ("...And Then There Was X").

He earned another Grammy nomination the following year for his single "Who We Be," and he won the American Music Awards' Favorite Rap/Hip-Hop Artists award two years in a row, in 2000 and 2001.

DMX's acting career began in 1998 with a starring role in "Belly' alongside other rappers including Nas and Method Man. In 2000, he had a supporting role in Aaliyah's acting debut, "Romeo Must Die."

His other movies include "Exit Wounds" (2001), "Cradle 2 the Grave" (2003), "Never Die Alone" (2004), and "Beyond the Law" (2019).

In 2016, DMX starred in the BET reality series "DMX: Soul of a Man." He made other TV appearances on shows such as "Moesha," "Third Watch," and "Eve."

"Performing in front of people is beyond a high. It's beyond a high that any drug could duplicate," he told GQ in 2019. "Just being onstage, period, and knowing that there's so much love out there. I pray before I go onstage with everyone in the room. And I end my show with a prayer onstage. And I'd say maybe 65 percent of the time that I get offstage, I'm so emotionally overwhelmed, I just break down."

#### Joseph Siravo, actor on 'The Sopranos'

Joseph Siravo, an actor known for roles including Giovanni "Johnny Boy" Soprano on HBO's "The Sopranos," died April 11 of colon cancer at the age of 66.

Siravo was best known to many for playing the father of James Gandolfini's character. Tony Soprano, on "The Sopranos," appearing in flashbacks. But he also had other TV roles as well as movie and stage credits.

An early role was Vinnie Taglialucci in the 1993 film "Carlito's Way." Siravo's other movies included "Thirteen Conversations About One Thing," "Enchanted," "The Wannabe, and "Motherless Brooklyn.

On TV, he played Fred Goldman on "The People vs. O.J. Simpson: American Crime Story." He also made appearances on shows including "Another World," "Law & Order," "Made in Jersey," and "New Amsterdam.

Siravo played Angelo "Gyp" DeCarlo in the original U.S. tour of the Broadway musical "Jersey Boys." Though he often played mobsters on TV and in movies, Siravo was also a Shakespearean stage actor and led the acting workshop Shakespeare & Beyond.

#### Gerren Taylor, model and reality TV star

Gerren Taylor, a model and entrepreneur who starred on the BET reality series "Baldwin Hills," died April 11 at the age of 30. A cause of death has not been revealed.

Taylor signed with LA Models when she was 12 years old, becoming their youngest runway model ever. A few years later, she became one of the stars of "Baldwin Hills," which focused on wealthy Black teenagers living in the Los Angeles neighborhood of Baldwin Hills.

Taylor was one of only three cast members who remained with the show for its entire threeseason run

She was also featured in the 2007 documentary "America the Beautiful.'

Taylor was an entrepreneur, with ventures including Hush Dolls LLC and Miyoko's Closet. She spoke out about body image and unrealistic beauty standards.

#### Ray Lambert, veteran and D-Day hero

Ray Lambert, a U.S. Army veteran of World War II who was honored for saving many lives on D-Day, died April 9 at his home in Seven Lakes, North Carolina at the age of 100.

Lambert was serving in the U.S. Army as a medic when his unit was sent to Normandy on D-Day. As troops stormed the beach, many were injured by enemy fire and landmines.

Lambert located a protected area behind a large concrete block and began dragging injured men from the water to the block, so they could be assisted by medics. He was credited with saving at least 15 lives that day, even as he was severely injured himself, including a broken back.

Lambert was later honored by President Donald Trump at a ceremony in Normandy marking the 75th anniversary of D-Day. The concrete block he used to shelter the injured was named "Ray's Rock" and has a plaque affixed to it, honoring Lambert and his men.

After the war, Lambert attended the Massachusetts Institute of Technology and founded two electrical contracting companies with his brother. In 2019, at age 98, he published his memoir, "Every Man a Hero," which became a New York Times best-seller.

The title referred to his belief that he shouldn't be singled out every man in his unit was a hero of the war.

#### Lee Aaker, child actor

Lee Aaker, a child actor in the 1950s and '60s, best known for starring as Rusty on TV's "The Adventures of Rin Tin Tin," died April 1 of a stroke at the age of 77.

Aaker had been in more than a dozen movies before he got his role on "The Adventures of Rin Tin Tin," including "Jeopardy," "Arena," and a notable role in the John Wayne film "Hondo."

Later, he made TV appearances on "Rescue 8," "The Donna Reed Show," "Make Room for Daddy,' and "The Lucy Show." Among his final credits before leaving Hollywood was a small role in "Bye Bye Birdie."

Aaker had trouble getting work as an actor after he aged out of child roles. In later years, he was a carpenter and a ski instructor, working as an adaptive sports instructor for people with disabilities.

## **Privacy rights**

#### Dear Editor:

Over the last decades, the issue of privacy has been a trending topic of discussion in America. This is partly due to rapid advancements in technology that have led to globalization's acceleration and left our government to play a game of catch-up. To the citizens' ears, the policies that have been framed as parameters necessary to protect our society from the other have given the government unprecedented power over our privacy. Here I question the limitation imposed on the public by the government and the motives that allow the government to justify its mass surveillance of its citizens.

Last month, the question of privacy was once again brought into the spotlight during a Senate Congressional Hearing. Current FBI Director Christopher Wary took the senate floor to address his concerns regarding National Security. Wary opened by addressing the incident that occurred on Capitol Hill earlier this year. He assured the Senate that his institution is working diligently to prosecute those involved in the incident to secure the American People's wellbeing and uphold our nation's constitution. This served as a segue to address the FBI's Top Terrorist Threats, which Wary declared was most important to the Bureau.

Among the list of potential terrorist threat groups, both domestic and foreign, the Director declared Domestic Violent Extremist (DVE) as one of the FBI's top priorities. His statement was directed towards both the Capitol Hill Rioters and the protestors who incited violence during the series of protests in the summer of 2020. Wary blamed the lack of counter-measures taken due to "law enforcement agencies" inability to access electronic evidence," as technology companies are not working with agencies to provide them with information on their users

Wary depicted encryption software, like that of "user-onlyaccess" and "end-to-end encryption," as an obstruction to justice, as they prevent government authorities from the ability to gather the information that could potentially stop an attack. Wary attacked Apple for its uses "user-only-access" and the company's lack of cooperation, comparing it to that of Facebook, which ironically has been under fire over the past couple of years for its series of privacy violations and collection of user data. This message was not solely directed at Apple but directed at applications like the Signal messaging application, which uses "end-to-end encryption," only allowing the sender and receiver to view information.

Given the history of our nation's policy towards promoting privacy rights, Wary's cry for cooperation is laughable. The government has done far more than its fair share to undo its transparency and violate privacy rights.

Ironically, this year will mark the 54th anniversary of the Freedom of Informations Act (FOIA). The FOIA was put in place to promote the growth of our nation's democracy and government transparency. Later, the Privacy act of 1974 would be added as a clause that prohibited government agencies from disclosing the individual's Lawrence Christon t allowed citizens the right to review documents under their names. Although these provisions, enacted for the good of the citizens, were seemingly short-lived. In 2001, in the months following the 9/11 attacks, President Bush and Congress would pass the USA Patriot Act. The Patriot Act would dramatically increase government surveillance, allowing it to access information on its citizens without any legal restrictions or repercussions, all done as an effort to prevent future terrorist attacks. The passing of this act best illustrates the government shift in attitude towards privacy and its acceptance of massive data collection. Thankfully, as of June 2020, the Patriot Act officially expired and is no longer active. As a government official, one would assume that Wary would understand the importance of upholding our rights. Yet, Wary believes that companies should work with the government to provide the tools to access our information. The cooperation he is asking from tech companies is known as the "backdoor" tool. This software system is put into place by the company that allows a secondary user to access the primary user's information. Suppose Wary genuinely wants to uphold our nation's constitution. Why would he plead to Congress to encroach on our privacy rights? What is the future of privacy? And what obligations does the company have to the government? It is hard to say where the line should be drawn, especially when dealing with complex topics like national security and citizens' rights. On the one hand, Wary's argument for national security shouldn't be taken lightly, given the events earlier this year. However, in doing so, I fear that we run the risk yet again to be subject to mass surveillance programs that once again will violate our rights as U.S citizens.

## Standards for elected officials

Dear Editor:

If you're a practitioner of arts criticism and reportage, as I've been for many years, you learn that if you're willing to dish it out, you should be willing to take it. Still, I have to take exception to Alida Fernandez-Chacon's letter to the editor last week chiding me for quoting an example of mayor Claudia M. Frometa's awful syntax vis-à-vis her (Frometa's) uninformed commentary on the arts in Downey.

Ms. Chacon seems to think that pointing out bad grammar in a public official is akin to ridiculing people like Chacon's grandfather, Cuban immigrant who, despite the memorable and comic use of malapropisms in English, has been a business success in his long life in the U.S., much beloved by his family, whom he's generously helped along the way.

I agree that to make fun of someone because he (or she) has an imperfect grasp of a second language is as cruel as making fun of someone with a natural speech impediment. It's a harmful, immature, stupid thing to do.

That isn't the issue, however. The issue is, what should we legitimately expect of a public servant elected to represent us?

I do not know Frometa personally, and in fact am impressed by how assiduously she's worked to fulfill the responsibilities of her new job. Her refusal to back down to the verbal abuse of a mob of irate Tenant Union protesters during one council session is the single most courageous act I've seen in years of city-watching.

At best, even if we find them wanting, we still owe our public servants a modicum of civility. But what do they owe us? You would expect a level of experience and knowledge that would make good the promise of competency in office. You would expect that they don't misrepresent themselves in a way that compromises their function and embarrasses them, their colleagues and the city. You would expect honesty and good judgment. You would expect fairness and patience, with complex issues that take time to resolve, irate people vith personal agendas, and even whackos at the lectern.

You would expect a level of education that gives them the ability to find out what they don't know when confronted with something outside their comfort zone.

When it comes to remedying the near-collapse of culture and the arts in Downey—things that are vital to any civilized population--I've watched the city fail for over a decade. The council tried to do something about it around 2010. But each successive round of elections has produced a group that, when it comes to enabling a robust arts scene, has been more narrow, uninformed and incompetent than the last. There's local opinion gathering that the (mostly) newly elected group currently occupying the dais is the worst in Downey history.

That's why I, as an arts advocate, mindful of all the bone-rattling potholes effective advocacy can lead to, fear where this current crop is taking us. And that's why I highlight Frometa's atrocious grammar, literally quoted from reporter Alex Dominguez' recording of the recent city council meeting that took up the issue of the arts in Downey.

The Elizabethan poet, critic, playwright ("Volpone" ) and Shakespeare contemporary, Ben Jonson, famously said, "Speak that I may know thee." Every time we open our mouths, we reveal something about ourselves; our quality of mind, our temperament, our character, our values and priorities. Most of all, we reveal our capacity to organize our thoughts. That's what grammar in any language is designed to do, because most of the time our thoughts are an aggregate of spontaneous impulses, images, conflicting emotions, unformed flying references. Our capacity to cohere this inner jumble into systematic language represents our ability to organize ourselves.

I don't know if English is a second language for Frometa. It really doesn't matter. It's the one she's chosen to use in her role as a Downey representative. When she speaks, she doesn't just speak for herself. She speaks for Downey. She talks to other cities, to media, to state officials and representatives, and if called, to the nation. And, of course, to the official record of Downey civic life. In a word, history.

That's how we are and will be judged. And that's why, in my opinion, we should listen hard not only to what our civic leaders say, but how they say it. It speaks for all of us.

## **Climate change action**

#### Dear Editor:

Bravo to Dr. Alan Frischer for his important column on climate change in the April 8 issue of this newspaper.

Dr. Frischer is correct to state that "climate change is considered the biggest global health threat of the 21st century - yes, a greater threat than this current pandemic," and he is also accurate when he says that "the most marginalized groups of people, including those with disabilities, low-income families, the elderly" are most impacted by rising temperatures and extreme weather.

Because of our concern for future generations, including those in our family and those who are less well-off than we are, my husband and I devote much of our time to fighting climate change. We have changed our lifestyles, making many of the changes recommended in the doctor's article. We have solar panels on our home, any extra electricity is 100% renewable from Downey's CCE option, we drive plug-in hybrid vehicles, and we rarely eat beef.

Although we know our individual choices contribute to a better climate, we also understand that the climate crisis is so enormous that to achieve meaningful results will require a moonshot effort by all of us working as a team. We need to harness the innovative and creative genius of the American economy, with its scientists, entrepreneurs, and skilled workers, to move us rapidly towards a clean-energy future.

A good way to start is by pricing carbon: when something costs more, people use less of it. In addition, since renewable alternatives will become relatively cheaper, demand for them will skyrocket; this will stimulate a wave of climate-friendly innovation. We also need to help working families manage their budgets as they transition to clean energy.

A recently introduced bill in Congress, The Energy Innovation and Carbon Dividend Act of 2021, does all of this and more. It levies a fee on all fossil fuels at the coal mine, gas/oil well, or port of entry. To give the economy time to adjust, it starts low and increases yearly. Independent studies project that its approach will reduce America's carbon pollution by 30% in the first 5 years alone and that the bill is the single most powerful tool we have to reach net zero by 2050.

In order to help working and middle-class families transition to clean energy, all net proceeds will be returned to American families via a monthly dividend. Consequently, most low-and-middleincome Americans will come out financially ahead or break even.

Citizens' Climate Lobby - a nonpartisan group of which my husband, son, and I are members - strongly supports The Energy Innovation and Carbon Dividend Act. On April 1, the first day of Earth Month 2021, we were delighted to learn that Rep. Lucille Roybal-Allard, Downey's congresswoman, was one of twenty-five original cosponsors of this bill.

Solving climate change will not be easy, but it will lead to a better future for ourselves and future generations. In addition to individual lifestyle changes, we must enact effective government policies. Passing the Energy Innovation and Carbon Dividend Act will be an excellent start.

Thanks again to Dr. Frischer for calling attention to the importance of the climate crisis and to Congresswoman Lucille Roybal-Allard for being part of the solution.








## Huntington Park man charged with robbing 15 Trader Joe's

 Gregory Johnson allegedly robbed the markets during a three-month crime spree; he faces 40 years in prison.

HUNTINGTON PARK - A federal grand jury has named a Huntington Park man in a 21-count indictment that accuses him of robbing 15 Trader Joe's stores throughout Southern California during a three-month crime spree.

Gregory Johnson, 43, was

Johnson previously was charged via a two-count information on Feb. 8 in connection with the robbery of a Trader Joe's in Chino

#### week's indictment charges him with 19 additional felonies.

According to the indictment, from August 28 to December 4, 2020, Johnson robbed 15 Trader Joe's stores in Eagle Rock, Sherman Oaks, Chatsworth, Pasadena, Culver City, Rancho Palos Verdes, Agoura Hills, Simi Valley, Brea, Santa Ana, Tustin, Corona, and Chino Hills.

During many of the robberies, Johnson allegedly brandished a handgun. On two occasions, Johnson allegedly robbed stores in Rancho Palos Verdes and Brea, and returned weeks later to rob them again.

On Dec. 4, 2020, Johnson and his son, Gregory Eric Johnson, 20, of South Los Angeles, were arrested after law enforcement learned of the Chino Hills Trader Joe's robbery. A witness gave law enforcement a description of the Johnsons' getaway car and its license plate, according to court documents.

An indictment contains allegations that a defendant has committed a crime. Every defendant is presumed innocent until and unless proven guilty beyond a reasonable doubt.

If convicted of all charges, Gregory Johnson would face a statutory maximum sentence of 20 years in federal prison for each robbery charge, seven years in prison for each firearms use charge, and 10 years' imprisonment for the felon-in-possession of a firearms charge.

On March 15, Gregory Eric Johnson pleaded guilty to a twocount information charging him with interference with commerce by robbery for robbing Trader Joe's stores in Chatsworth and Chino Hills in December 2020.

His sentencing hearing is scheduled for July 12, at which time he will face a statutory maximum sentence of 40 years in federal prison.

## Ex-LASD deputy sentenced to 7 years in prison for leading \$2 million robbery

 Marc Antrim is accused of staging a drug bust and stealing \$2 million from a marijuana dispensary.

**LOS ANGELES** – A former Los Angeles County Sheriff's deputy was sentenced last week to 84 months in federal prison for orchestrating and leading a \$2 million armed robbery - staged as a legitimate law enforcement search at a downtown Los Angeles warehouse where more than half a ton of marijuana and over \$600,000 in cash was stolen.

Marc Antrim, 43, of South El Monte, who formerly was assigned to the LASD station in Temple City, was sentenced by United States District Judge Virginia A. Phillips, who said, "the seriousness of the crime could not be overstated." The heist, which "sounded like a movie script," was "tragic" for the victims and eroded "the public's trust (in law enforcement)," the judge said.

Antrim pleaded guilty in March 2019 to a five-count information charging him with conspiracy to distribute marijuana, possession with intent to distribute marijuana, conspiracy to deprive rights under color of law, deprivation of rights under color of law, and brandishing a firearm in furtherance of a drug trafficking crime.

During the early morning hours of October 29, 2018, Antrim and his co-conspirators dressed as armed LASD deputies and approached the warehouse in an LASD Ford Explorer. Upon arrival, Antrim flashed his LASD badge and a fake search warrant to the security guards to gain entry to the warehouse. To perpetuate the ruse that they were legitimate law enforcement officers, Antrim and two fake deputies sported LASD clothing, wore duty belts, and carried firearms. One fake deputy also visibly carried a long gun to further intimidate the guards into submission

At the beginning of the two-

hour robbery, Antrim and his co- to the department's narcotics unit, conspirators detained the three warehouse security guards in the cage of the LASD Ford Explorer. Soon after the guards were detained, a fourth man arrived at the warehouse in a large rental truck, and all four men began loading marijuana into the truck.

When Los Angeles Police Department officers legitimately responded to a call for service at the warehouse during the robbery, Antrim falsely told the LAPD officers that he was an LASD narcotics deputy conducting a legitimate search. To facilitate the sham, Antrim handed his phone to one of the LAPD officers so that the police officer could speak to someone on the phone claiming to be Antrim's LASD sergeant. The individual on the phone was not Antrim's sergeant, and Antrim did not have a legitimate search warrant for the warehouse.

After LAPD officers left the warehouse, other co-conspirators arrived and the robbery continued, allowing the fake law enforcement crew to steal even more marijuana and two large safes containing over half a million dollars in cash.

At the time of the robbery, Antrim was a patrol deputy assigned to the Temple City station, but he was not on duty, was not assigned was not a detective, and would not have had a legitimate reason to search a marijuana distribution warehouse in the City of Los Angeles.

Prosecutors have secured six convictions in this case for the coconspirators who took part in the raid alongside Antrim.

Christopher Myung Kim, 31, of Walnut, a disgruntled former warehouse employee, is serving a 14-year federal prison sentence after being found guilty by a jury for his role in planning the heist and making off with \$1.5 million in stolen marijuana after the raid. Antrim testified at Kim's trial, which the judge credited as a significant reason to reduce Antrim's sentence.

Kevin McBride, 45, of Glendora, and Eric Rodriguez, 35, of Adelanto, are serving federal prison sentences of six and nine years, respectively, after pleading guilty to felony charges in this case. In a related case, Antrim's other co-conspirators, Matthew James Perez, 44, of Ontario, Daniel Aguilera, 33, of Los Angeles, and Jay Colby Sanford, 43, of Pomona, are serving sentences of six years' imprisonment, two years' imprisonment, and five years' probation, respectively.
