

## Warren High hires new band director

■ Eric Villalobos takes over as leader of the school's band and color guard, which looks to rebuild after the previous director was ousted.

**DOWNEY** – The Warren High School Band and Color Guard will go through a period of rebuild in 2021. That starts with new band director Eric Villalobos.

Villalobos, 39, decided early on that he wanted to be a band director, after watching "Mr. Holland's Opus," a film centered around the 30-year musical teaching career of Glenn Holland.

"In 7th grade, after watching Mr. Holland's Opus, I was like, 'You know what? It'd actually be pretty cool to be a band director, a music teacher, "said Villalobos. "Just because of how you can affect these kids' lives, and stuff like that."

Primarily a brass player, Villalobos started his higher education at Fullerton college, spending six years while "making a living" in instructor and assistant band director roles at several different schools in the meantime.

things going on all at once," and he "needed something different." He joined the Army in May of 2007.

"Really it was because I wanted to join to pay for school," said Villalobos. "I could just do my four-year commitment, come back, get the GI bill and finish school, and focus on school."

However, Villalobos says that "there was more to the Army that it

"I was realizing that I was a member of the team," said Villalobos. "I realized it's not about me, it's more about what am I contributing, what story am I telling?'

Villalobos would perform with several ensembles within the Army, and while deployed, would aid in the teaching of the Afghan National Army Band.

His service would take him around the United States and into Germany, Kyrgyzstan, and Afghanistan. He would transition to the reserves – where he still performs – at the end of his active service.

Villalobos would go on to earn a Bachelors in Music Education and a Bachelors in Tuba Performance from Azusa Pacific University.

After a couple of opportunities as an assistant at California High School and Santa Margarita Catholic High School, Villalobos found himself as director at Valley Christian High School in 2019 and 2020.

Villalobos is no stranger to Warren's instrumental music program. Throughout his career, he's found himself standing across the competition field from the Bears.

"My program used to compete against [Warren] when I was at La Mirada and at Cal," said Villalobos. "I could already see that Warren was chomping at the bit to be successful, and they were."

"Watching it from the stands and just seeing how successful and how big the program has been getting, it's a lot to chew; it's a lot to digest.

Though having steadily grown in strength and accolades over the past decade - culminating in back-to-back gold medal wins at the Southern California School Band and Orchestra Association field championships in 2017 and 2018 - the program has faced recent backlash amongst reports of inappropriate behavior from the band's former director Dave Niemeyer and staff, forcing the change in

The transition also comes at a time where schools are still adjusting to a post-pandemic norm.

Villalobos asks that students and parents "give him a year," saying that the theme of the year is to "reconnect and rebuild."

"My vision for this year is really just to reconnect with everybody," said Villalobos. "I think the hardest challenge for me right now is reconnecting with the upperclassmen...having a new band director is always going to be a challenge, that's just kind of the norm.

"I think my vision overall though - and this has always been a vision of mine – is just being able to create good kids... teaching kids to be musicians can mean one thing, but teaching them to be good kids so they can learn those principles and ethics and things like that is going to be more beneficial. Seeing them be successful in their future will definitely warm my heart and be even more of a success

Villalobos lives in Orange County with his wife Maggie.

## Downey joins growing call for change in Cuba

■ Residents have been protesting outside Porto's Bakery, calling on the Biden Administration to provide military support.

**DOWNEY** - A large gathering of Downey's Cuban residents gathered outside of Porto's Bakery over the weekend in support of political revolution in

The call for the end of the decades-old Cuban dictatorship has rung loud and clear in Downey over the last couple of weeks, as a third rally in support of Cuban revolution took place at the intersection of Downey Avenue and Firestone Boulevard.

Hundreds of individuals, many of which were draped in Cuban flags, shouted and chanted, drawing supportive cheers and the honking of horns from the traffic nearby.

Of course, the cries for change in Downey are merely an extension of those already happening in Cuba itself, as the people on the island have grown increasingly frustrated and angry over shortages of basic necessities and lack of freedom, made even more dire against the backdrop of Covid-19.



Development extensive Rancho south campus redevelopment specific plan has been funded in part by the Metro Transit Oriented Development Planning Grant Program. The specific plan consists of four sub-districts, including areas designated for flex tech/ bio medical, regional public facilities, transit-oriented development, and community service.

The project is unique in that it encompasses approximately 172 acres of Los Angeles Countyowned land. Of that area, around 62.5 acres (37%) is currently uncommitted and available for potential development. This is planned and programmed for a mix of transit-oriented residential, retail, and office uses, and more specifically, would allow development of up to 700 homes and approximately 1,130,000 square-feet of new, nonresidential land uses.

While nothing has been officially decided yet, the city has made attempts to gain stakeholder feedback, specifically during two community workshops throughout the preparation of the Specific Plan.

### Arts groups awarded county grants

**DOWNEY** – Three Downey non-profit groups have been awarded grants by the Los Angeles County Department of Arts & Culture.

The Downey Foundation for Educational Opportunities was awarded \$16,300. The organization will use the money to pay music instructors at its after-school classes.

The Downey Symphonic Society, which operates the Downey Symphony, was selected to receive \$15,400. The money will be used to support the orchestra's Music in the Schools program.

Lastly, Japanese Culture and Traditions Inc. was awarded \$4,400 in support of its annual Coming of Age Ceremony, a Japanese cultural

The Department of Arts & Culture distributed \$4.518 million in Professors grants in total to 231 nonprofit arts organizations.

L.A. County Supervisor Hilda Solis called the grant program W1N Seats On "critical to helping the local arts ecosystem thrive through the inclusion of arts organizations that exemplify culture, traditions, and artistic creativity that celebrate the diversity of this county.



### Razorbacks open training camp Monday

**DOWNEY** - The Downey Razorbacks will open training camp Monday at Discovery Sports Complex, marking the official opening of the 2021 season.

The Razorbacks are returning after a 20-month hiatus due to Covid-19 restrictions. This season marks their 61st year of youth football in Downey.

Training camp is free and open to the public. The first game of the season is scheduled for Saturday, Sept. 11; all home games are played at Downey and Warren high schools.

The Razorbacks are part of the SCEYFL-AAU conference which is comprised of 27 member associations located throughout Southern California. The AAU Super Bowl will be held at Sofi Stadium on Nov. 26.

NORWALK - Dr. Robert Cancio and Narcis Brasov appear to have won seats on the Norwalk -La Mirada school board, according to semi-official results released by the Los Angeles County Registrar-Recorder.

Brasov, a law professor at Trinity Law School, collected 2,330 votes while Cancio, an assistant professor of sociology at Loyola Marymount University, received 2,259.

Election officials said there are "still many outstanding ballots to be processed and counted." Brasov and Cancio, however, maintain comfortable leads over their opponents.

### Hikers from Downey High rescued

**DOWNEY** - Two teenage hikers who had been missing on Mt. Baldy were found safe Tuesday.

The two teenagers were found by a search-and-rescue team at about 9 a.m. and were airlifted from the mountain.

The teens were among 51 students from Downey High school's soccer and lacrosse teams, along with two coaches and a teacher, who hiked Devils Backbone and Ski Hut Trail before breaking up into several groups Monday morning, according to the San Bernardino County sheriff's department.

A large group of the students eventually walked back to their vehicles and left the area. But at 7 p.m., several of the teenagers called for help and said they were unable to hike out safely, authorities said. During that rescue, 10 minors and three adults were airlifted from the mountain, but two hikers — a 15-year-old girl and a 16-yearold boy — remained unaccounted

Ground crews and the sheriff's helicopter continued searching for the last two teenagers throughout the night. They were found at about 8:40 a.m. and airlifted to safety.

Authorities say both hikers appear to be OK.

### College student earns fellowship

**DOWNEY** – Downey resident Nicole Jowett has been awarded an \$8,500 Phi Kappa Phi Fellowship, one of only 62 people nationwide to receive the honor.

Jowett received a bachelor's degree in film and electronic arts from Cal State Long Beach and will pursue a master's degree in television writing and producing at Chapman University.

Phi Kappa Phi is the nation's oldest and most selective collegiate honor society for academic disciplines. Its Fellowship Program allocated \$649,000 annually to outstanding students for first-year graduate or professional study.

## **DACA** ruling prompts calls for immigration reform

■ A federal judge ruled that DACA is illegal, putting a halt to new applications.

**DOWNEY** - Rep. Lucille Roybal-Allard called on the Senate to provide "Dreamers" a path to citizenship after a federal judge ruled DAĈA illegal last

Deferred Action Childhood Arrivals, or DACA, offers temporary protection from deportation and permission to work for about 650,000 young people who came to the U.S. as children. The U.S. Supreme Court ruled last year that the Trump administration's decision to stop the program was "arbitrary and capricious," and an estimated 300,000 people became eligible to apply for DACA for the first time in December.

This included some 55,500 people who turned 15, the minimum age to apply, since the government had stopped accepting new applications.

The Obama administration began DACA in 2012 after Congress failed multiple times to pass more comprehensive immigration reform. program offers two-year permits and protection from deportation, after which recipients must apply

Last Friday, U.S. District Judge Andrew Hanen sided with Texas and eight other states and decided that DACA was unlawful because former President Barack Obama did not have the authority to enact such a policy. He ordered the immigration agency to stop approving new applications.

"As the Member of Congress representing the highest number of DACA-eligible youth and as the original co-author of the DREAM Act, my heart shatters at this terrible news," said Roybal-Allard, who represents Downey in

"This decision reemphasizes the dire need for the Senate to pass H.R. 6, my Dream and Promise Act. And I urge the Senate to do so as quickly as possible to protect our Dreamers and provide them with a pathway to citizenship.'

Immigrants who already have protection under DACA will not be affected by the order and can still submit applications to renew their permits. The judge said in order to keep DACA in place, the Biden administration would need to ask for public comment on the policy, among other actions.

A path to permanent residency and citizenship for young people brought to the U.S. as children has broad support from Americans.

About three-quarters of respondents to a survey by Pew Research Center last year said they approve of a pathway to permanent legal status.


To be eligible for DACA, the U.S. before they turned 16 and have lived here since June 15, 2007, in addition to attending school or having graduated from high school and not been convicted of certain crimes.

The Biden administration is expected to appeal Friday's ruling.

"[Last week's] ruling is evidence that DACA is not enough. The program has always been temporary, leaving hundreds of thousands of lives vulnerable to the next attack," said Greisa Martinez Rosas, executive director of the immigrant youth organization United We Dream, in a written statement.

She also wrote, "Until President Biden and Democrats in Congress deliver citizenship, the lives of millions of undocumented people remain on the line. Democrats must pass a pathway to citizenship this year, no excuses!"

## Mayor's Corner

Hello Downey, while I am encouraged by the continuing climbing vaccination numbers in our city, I am concerned we are inching closer to experiencing a fourth surge of the Coronavirus. This fourth surge is due to the highly transmissible and aggressive Delta variant impacting the unvaccinated population.

A reminder to all of us that this pandemic is not over.
Over the past three weeks, the number of hospitalizations across Southern California has tripled, primarily impacting unvaccinated individuals. Deaths amongst seemingly healthy individuals who contracted Covid-19 are being attributed to their unvaccinated status.

Currently, there is great concern throughout the healthcare community that the rise in variants and the resurgence of the spread of Covid-19 will continue if people remain unvaccinated.

The latest figures released by the Los Angeles County Department of Public Health (update from 7/16) indicate the vaccination rate for Downey residents 16 years of age and older is now 69.3%. For adults 65 years of age and older, it is now 89.2%. I hope you will consider a vaccination. Our goal in Downey is to surpass 75% before the end of summer and the return to fall and flu season.

#### Update on Public Safety and Speed Enforcement

As your Mayor, Public Safety is one of my biggest priorities. Since taking office, I have been working closely with our Downey PD and have asked to increase speed enforcement and focus on street racing activities, including those doing donuts on various parking lots around our city. I'm happy to report that our 2nd quarter numbers are as follows:

Street Racing Detail, from April to June: the department issued 334 Citations. There were 11 arrests and 7 vehicles impounded. Those caught doing donuts have their vehicles impounded for 30 days.

Department-Wide Traffic Citations Issued: 3,678

At our resident's request, there was an Etched Catalytic Converter event, and 114 cars were assisted.

There was also a DUI Checkpoint: 997 vehicles were screened, resulting in 6 DUI arrests, 13 field sobriety tests administered, there were also 29 citations issued for unlicensed drivers, 7 citations for driving with a suspended license and, 13 vehicles were impounded.

If there is street racing in your neighborhood, please report it to Downey PD. If you must report a non-emergency issue, please contact the Downey Police Dispatch at 562-861-0770.

I'm also happy to report the Downey Police Department Coffee with a Cop events are back. They held their first event last week on July 14, Mayor Pro Tem Pacheco and I had the pleasure of attending. I encourage you to get involved and attend to connect with our officers.

Also, regarding Public Safety, many of you have contacted the City Council via phone, emails, and letters regarding Downey's stance on L.A. County's District Attorney George Gascon. Your messages have not fallen on deaf ears. We are aware 23 cities across Southern California have taken a vote of no confidence. Out of respect and consideration to one of our council colleagues currently working for D.A. Gascon, we will not be discussing this matter until sometime in the fall. As your Mayor, I want you to know I hear you, we hear you, and we are here to serve our constituents and answer your concerns. We are currently working with our Downey PD on a Public Safety Town Hall. More to come in the next few weeks. Please stay tuned.

#### Infrastructure Improvements, Street Rehabilitation, and Public Works Update

During the 2nd quarter of this year, we have rehabilitated 1.5 miles of pavement along Old River School Road from Arnett Street to Imperial Highway.

Additionally, construction of landscaped medians and pavement rehabilitation along Telegraph Road from east to west city limits is currently underway. This is a joint project with the City of Pico Rivera and Downey as the lead agency. The contractor has completed the installation of raised concrete medians and repaved the segment between Paramount Boulevard and the west city limit. The contractor is now working on the segment between Paramount Boulevard and Lakewood Boulevard.

Finally, during our last council meeting on July 13, the council awarded a construction contract to Hardy Harper, Inc. for the rehabilitation of 62 residential streets in the southeast part of the city. Aside from rehabilitating approximately 8.5 miles of asphalt pavement, this project will also replace damaged or uplifted sidewalks, curbs, and gutters and construct Americans with Disabilities Act (ADA) compliant curb access ramps.

#### COVID-19 Business and Rental Assistance

There is currently \$750,000 in CDBG (Community Development Block Grant) funding available. \$175,000 has been awarded. We have assisted 7 small businesses. Currently, there are 15 applications under review and 157 businesses on the waitlist.

We have disbursed \$60,000 in downtown restaurant parklet grants, 36 temporary outdoor dining permits processed, and 10 temporary outdoor business activity permits have been processed.

#### **For Our Renters**

There is \$950,000 in funding available; \$444,000 has been awarded. Currently, we have a 3-month subsidy, 191 households have been assisted, and 1,788 applications have been distributed.

New applicants that qualify and go through the process will automatically receive three month's rental assistance. Those that received one month of assistance previously, please contact our Community Development at (562) 299-6706 or visit our website at www. downeyca.org/rentalassistance.



#### Biz Markie, rapper known for 'Just a Friend'

Biz Markie, a rapper best known for his 1989 hit song, "Just a Friend," died July 16 at the age of 57, according to his

Markie had moderate success on R&B radio with his early singles "Make the Music With Your Mouth" (1987) and "Vapors" (1988). But it was "Just a Friend" that made him a star, reaching No. 1 on the Billboard Hot 100 and achieving platinum

The video was an MTV hit, and the song was later ranked among VH1's "100 Greatest Songs of Hip Hop.

Markie became known as the "Clown Prince of Hip Hop" for

his funny music and persona. Later singles were popular with rap audiences but didn't cross over to mainstream radio play, including "What Comes Around Goes Around" (1991) and "Young Girl Bluez" (1993).

In later years, Markie was a frequent guest on songs by other artists, including the Beastie Boys and Will Smith. He toured with Chris Rock in 2008, DJing as the opening act.

Markie made appearances on the early '90s sketch TV show "In Living Color." In 2002, he had a cameo in "Men in Black II,' playing an alien whose language sounded like beatboxing. He was in the 2014 SyFy Channel movie "Sharknado: The Second One," and he performed "Just a Friend' on TV shows including "Empire' and "Blackish." In 2005, Markie competed on the first season of

#### Robby Steinhardt, member of rock band Kansas

Robby Steinhardt, the violinist and co-lead singer for the classic rock band Kansas, died July 17 of complications of acute pancreatitis at the age of

Steinhart joined Kansas in 1972, when they were in an earlier, pre-fame incarnation, then named White Clover.

Within a few years, the band was rising in popularity, and in 1976, they had a hit with the enduring classic rock standard "Carry On Wayward Son." They followed it with the hits "Point of Know Return" and "Dust in the Wind."

Steinhardt's violin was a key part of Kansas' sound, particularly on "Dust in the Wind," and he was also the band's emcee when they performed live.

He left Kansas in 1983, though he returned in 1997 and toured with the band for several years before stepping aside again in 2006.

Steinhardt also formed the band Steinhardt-Moon and played with the Stormbringer

#### Gloria Richardson, civil rights activist in 1960s

Gloria Richardson, a civil rights activist known for her role in intense protests in early-1960s Cambridge, Maryland, died July 15 at her home in Manhattan at the age of 99.

Richardson became involved in the civil rights movement in the early 1960s, becoming a leader of the Cambridge Nonviolent Action Committee (CNAC), an associate of the

famed Student Nonviolent Coordinating Committee (SNCC).

She worked to survey the Black residents of Cambridge and determined they were most concerned about severe inequalities in housing, jobs, and education. Much of the city's Black community was impoverished, and a large employer had recently closed.

A series of protests in Cambridge in the early 1960s erupted into violent clashes and race riots, and martial law was imposed on the city. Richardson became controversial for her willingness to embrace violence as a tactic in obtaining equality. She was photographed at this time, pushing aside a soldier's bayonet in a photo that became one of the defining images of the

As the federal government worked to bring order to Cambridge, Richardson became one of the signatories of Robert F. Kennedy's "Treaty of Cambridge," which called for desegregation of the city's schools, housing, and employment.

In 1963, Richardson was among the civil rights leaders who sat on the stage at the March on Washington, though she wasn't given the opportunity

#### Mat George, popular podcast host and influencer

Mat George, the co-host of the podcast "She Rates Dogs" and a popular Twitter personality, died July 17 in Los Angeles in a traffic accident at the age of 26.

George and Michaela Okland co-hosted "She Rates Dogs," a podcast that debuted in 2020 with a focus on relationships and pop culture.

George was also known for funny takes on Twitter that often went viral, including a recent tweet, "I've been in LA for a year and haven't seen a single celebrity. My mom comes for a weekend and meets Snoop Dogg" – alongside a photo of his mother and a Snoop Dogg impersonator.

He also frequently tweeted about his experiences as an out gay man.

"My hopes for my Twitter account and SheRatesDogs the Podcast is to share my stories and make LGBTQ+ people all across the world feel like they're not alone," he said in 2020. "The most rewarding moments are when members of the LGBTQ+ community reach out to me and tell me what a difference I've made in their lives."

#### Shirley Irvin, winner of three consecutive majors

Shirley Fry Irvin, a tennis player who was ranked No. 1 in 1956 and won a career Grand Slam, died July 13 in Naples, Florida at the age of 94.

Irvin first competed in the U.S. National Championships in 1941, when she was just 14 and the youngest woman competing. By 1946, she was ranked in the world top 10, and she won the singles title at the French Open

In 1956 and 1957, Irvin won three consecutive majors - Wimbledon, the U.S. Championships, and the Australian Championships, completing the Grand Slam. She was one of only 10 women to do so. She was also one of only seven women to win the Grand Slam competing in doubles.

Fry retired from tennis in 1957, and she was inducted into the International Tennis Hall of Fame in 1970.

#### Paul Orndorf, 1980s professional wrestler

Paul Orndorff, a pro wrestler known as "Mr. Wonderful," known for his WWF feud with Hulk Hogan, died July 12 in Fayetteville, Georgia at the age

Orndorff joined the WWF (now WWE) in 1983, working with "Rowdy" Roddy Piper as his manager. Taking Mr. Wonderful as his nickname, he challenged Hogan for the world title in 1984, though Orndorff lost.

The following year, Orndorff and Piper took on Hogan and Mr. T in a popular match at the first WrestleMania. Orndorff later teamed up with Hogan before beginning another feud with the

After retiring from the WWF in 1988, Orndorff wrestled with WCW for several years. He was inducted into the WWE Hall of Fame in 2005.

In 2016, Orndorff was part of a class action suit against the WWE alleging that they failed to care for wrestlers as they suffered "long term neurological injuries" from the sport.

#### Jeff LaBar, guitarist in Cinderella metal band

Jeff LaBar, the guitarist for the glam metal band Cinderella, known for hits including "Don't Know What You Got (Till it's Gone)," died July 14 in Nashville at the age of 58.

LaBar joined Cinderella in 1985, replacing their original guitarist shortly before they recorded their debut album.

Their singles in the late 1980s and early 1990s included "Nobody's Fool," "Coming Home," "Shelter Me," and "Don't Know What You Got (Till it's Gone)." which was their top charting hit, reaching No. 12 on the Billboard Hot 100.

LaBar remained with Cinderella throughout the band's existence, as they continued recording albums through 1994 and touring until 2013.

He also played in Naked Beggars with Cinderella bandmate Eric Brittingham, and he released the 2014 solo album "One for the Road."



#### Charlsie Patricia Case March 1, 1922 - July 6, 2021

Charlsie Patricia Case passed away on July 6, 2021 at the age of 99. She was born on March 1, 1922 to Charles and Virgie Groff on her grandparent's farm in Amherst, Massachusetts. Within a few months, the New England family moved to Los Angeles. She met a soldier at a dance in 1941 while accompanied by her parents. They courted during his time on leave and regularly corresponded during the war. Charlsie married William J. Case Jr. upon his return

in 1945. The marriage lasted 63 years until his death in 2008.

After residing in Los Angeles, the Case family moved to Downey in 1950 and eventually they had five sons. Charlsie became a member of Our Lady of Perpetual Help Church, the Downey Women's Club, and the Downey Symphony Society. While she briefly worked as a Real Estate Agent, her primary occupation was being the greatest Mom five boys could ever have. 

## 8 hours a day, 5 days a week is not working

With more than half of American adults fully vaccinated against Covid, employers and employees alike have turned their eyes back to the office. They're locked in a conflict over when they'll return and, when they do, what the return will look like. But we shouldn't just be talking about the parameters of how we get work done in a postpandemic world. We should be pushing to do less of it.

In truth, the debate over the return to the office is fraught. Employers are used to being able to dictate when and where employees work, but we have now discovered that a lot of work can be done at odd hours between remote school lessons and from home offices or even the comfort of one's bed.

So now there's a tense push and pull over when and how much people should start commuting and how much power over the question employees can exert. Everyone is focused on how we will make work work after such a severe shock to the system for how things used to get done. But the ultimate answer won't be found in hybrid remote and in-person offices or even in letting employees shift their hours around. The way to make work work is to cut it back.

Nearly everyone went into overdrive when the pandemic hit, and we aren't showing signs of letting up. By April of 2020, during the first big Covid spike, homebound working Americans were logging three more hours on the job each day. As our commutes disappeared, we poured much of the extra time not into our own lives but into our Zoom meetings and Slack messages. Working on a primary job ate up the most of the saved time (35.3 percent of it to be exact); an additional 8.4 percent went to a second job. The line blurred between work and home, and we let work take over. No wonder a third of Americans now say they're burned out by working at home.

But as we start to fumble our way back to some sort of normal, it's not enough for employees to demand that our hours return to what they were. Prepandemic, nearly a third of Americans clocked 45 hours or more every week, with around 8 million putting in 60 or more. While Europeans have decreased their work hours by about 30 percent over the past half century, ours have steadily increased. We have long needed better work-life balance, but despite constantly trying to hack our lives by waking up before dawn or exercising during lunch, that can be achieved only by actually working less.

To Americans, who log 7 to 19 percent more time on the job than our European peers, that may sound heretical. But we should heed the other countries that have come to this realization. This year, the Spanish government announced a pilot program to entice companies to try out a four-day workweek without reducing anyone's pay. Last month, Japan released economic policy guidelines encouraging employers to do the same. Iceland just published results from an experiment with a four-day week in Reykjavik that ran from 2015 to 2019 and found that productivity didn't decline and in some cases even improved. The reduced schedule showed "that we are not just machines that just work," one Icelandic participant said. "We are persons with desires and private lives, families and hobbies." Employees reported being less burned out and healthier.

Working too long is bad for our health, associated with not just weight gain and more alcohol and tobacco use but also higher rates of injury, illness and death. A study that looked at long work hours across 194 countries found a higher risk of heart disease and stroke, leading to about 745,000 attributable deaths. Long work hours are "the largest

of any occupational risk factor calculated to date," the authors wrote.

There is a class divide in overwork in the United States, however. The demand to spend 60 hours at an office is one that depletes the lives of professional, higher-paid workers. What would appear to be an opposite problem plagues those at the lower end of the wage scale. In 2016, about one-tenth of American workers were working part time but trying to get more hours. Despite current hand-wringing that these workers are refusing to come back to the job, thanks to lucrative unemployment benefits, the problem is typically the opposite: People who work in retail or fast food often struggle to get enough hours to qualify for benefits and pay their bills, just

They also struggle to cobble them together into a predictable schedule. Sixteen percent of American workers' schedules fluctuate based on their employers' needs. The people who suffer from just-in-time scheduling that never quite adds up to a normal 9 to 5 aren't spending their off hours on leisure. They're working second and third jobs. They are hovering over an app to find out if they're

going to be called into work and are scrambling to piece child care and transportation together if and when they are. Employers are still usurping their time by forcing them to be available at a moment's

"The overlap between the overworked executive and the underemployed hourly worker," said Susan Lambert, a professor of social work at the University of Chicago, is "that they cannot fully engage in their personal or their family life." Employers steal both overtime hours spent in front of a computer and off hours spent piecing a decent income together.

If everyone worked less, though, it would be easier to spread the work out evenly to more people. If white-collar professionals were no longer expected or required to log 60 hours a week but 30 instead, that would be a whole extra job for someone else. That would allow more people into positions with middle-class incomes, particularly young people looking to put college educations to use. We could even guarantee everyone a floor, a certain number of hours, at the same time that we lower the ceiling. That would push low-wage employers to fully use the people they have and not treat them as interchangeable cogs to be called upon or turned away whenever demand necessitates.

The goal, Dr. Lambert told me, is "one reasonable job per person." Not "two for one and half for another."

A reduction in work doesn't have to mean a reduction in anyone's living standards. In 1930, in the midst of the Great Depression, John Maynard Keynes predicted that by 2030, we would need to work only 15 hours a week. Technological advances and increasing productivity and prosperity would mean we could have everything we needed by doing less. But while Keynes underestimated the jump in technology and wealth we would experience in the intervening years, instead of working less, we're working harder than ever.

That doesn't mean we're producing more. There's a point at which



we simply cannot squeeze any more useful work out of ourselves, no matter how many more hours we put in. Studies show workers' output falls sharply after about 48 hours a week, and those who put in more than 55 hours a week perform worse than those who put in a typical 9 to 5. Even during the pandemic, as work hours shot up, output stayed flat, which means productivity actually fell.

None of this is news. Henry Ford famously reduced shifts in his auto plants in 1914 to eight hours a day without cutting workers' pay and was rewarded with a boom in output. Years later, after mass strikes and mobilization and during the same depression that inspired Keynes, the 40-hour workweek became enshrined in law by the Fair Labor Standards Act. But there's nothing scientific or preordained about working eight hours a day, five days a week. It's just the norm we've accepted — and increasingly blown right past.

Keynes took the opportunity of a generational economic depression when millions were thrown out of work to look forward and imagine what the future could, and should, look like. Workers used the Depression as an opportunity to force through legislation that levies a penalty on employers that make people work more than 40 hours a week. The pandemic is our chance to do something similar. Employees hold a lot of power over employers scrambling to ramp production back up and negotiate over what the new office normal will look like.

This is an opportunity for us to seek more control over not only where we work but how much we work, too. Americans can't be content just to gain the right to work 6 to 2 instead of 9 to 5. We have to demand time off that lasts longer than Saturday and Sunday. We have to reclaim our leisure time to spend as we wish.

Secretary of State John Quincy Adams persuaded the Spanish to cede the "derelict province" they could not control — or Jackson might return, and we might just take it.

Madrid got the message. We got Florida.

When Pancho Villa sent a raiding party across the U.S. border in 1916 and killed Americans in Columbus, New Mexico, President Woodrow Wilson sent Gen. John Pershing and an army that grew to 12,000 into

In 1954, after a million Mexicans had crossed over into the United States, President Dwight Eisenhower sent Gen. Joseph Swing to send them back. In the vernacular of the time, the mission was named Operation Wetback.

Mission accomplished. Problem solved. And the point:

While at the concert in the park on July 7, I thoroughly enjoyed listening to the 1st Marine Band perform and lead us in singing our national anthem and pledging allegiance to our grand old flag.

When singing, I mixed up a few words in the national anthem, so upon returning home, I reviewed the song: "Oh say can you see by the dawn's early light, what so proudly we hailed at the twilight's last gleaming? Whose broad stripes and bright stars thro' the perilous fight o'er the ramparts we watched were so gallantly streaming? We pledge allegiance to one flag - that of the United (not divided) States of America, and for the republic for which it stands, one nation under God, indivisible, with justice and liberty for all. ### Paging Dr. Frischer...

We have all become so knowledgeable about COVID-19. We are aware of the illness that it brings. We are aware that perhaps as many as 30% of those who experi-

ence the acute illness continue to have longterm symptoms. And now... there is yet a new category of sufferers: Some of those who have had CO-VID-19 are now

experiencing brand new medical problems

A recent study tracked the health insurance records of nearly two million Americans who contracted COVID-19. It showed that from one to six months after infection, 23% sought medical treatment for a new condition. This amounts to hundreds of thousands of Americans who pursued care for a health problem that had not been diagnosed before they tested positive for COVID-19. All ages were affected, including children.

What types of health issues

were found? The most common new problem was pain, including pain in nerves and muscles, appearing anywhere in the body. Other new issues were breathing difficulties, high cholesterol, malaise and fatigue, newly diagnosed hypertension, a variety of intestinal symptoms, migraine headaches, skin problems, heart conditions, sleep disorders, brain fog, anxiety and depression.

The first question I would ask is this: How does this rate of newly diagnosed diseases for post-COVID patients compare to the rate of newly diagnosed diseases in people who never had COVID-19? It appears that between one and six months after becoming infected, patients who had COVID had a 60% greater risk of death and a 20% greater chance of needing outpatient medical care than did those who had not been infected.

Of course, note that it's possible that some of these newly diagnosed issues actually already existed prior to the COVID-19 infection, and only came to light because the person finally saw a

Did only those who had serious cases of COVID develop these new complaints? Consider this: Nearly half of hospitalized COVID patients experienced subsequent medical issues, 27% of those with mild to moderate disease experienced subsequent medical issues, and 19% of those who were completely asymptomatic experienced subsequent medical issues. While this data clearly implies that the sickest COVID patients are more likely to develop newly diagnosed conditions post-COVID, it also shows that anyone who was COVID-positive (whether or not they had symptoms) may find themselves with unexpected new health issues.

What does this new data tell us? We are dealing with a strange and new disease. It absolutely has lasting effects. This is yet one more reason to become vaccinated and continue to protect yourself and your community. The current significant surge in the Delta variant across the United States is a critical reminder that we are not yet through this pandemic. Please continue to remain vigilant in protecting your health, and the health of your loved ones.

## LA County reports 2,500 new COVID-19 cases, highest since February

County reported a major spike in regardless of their vaccination new COVID-19 cases across the area Wednesday.

Public Health reports 2,551 new COVID-19 cases, marking the 13th vaccination status - when day in a row the county saw more than 1,000 new COVID-19 cases. The county has not reported a daily case rate this high since February 2021.

Wednesday's test positivity rate is 5.2%; the rate was 0.7% a month ago, according to Los Angeles County Public Health. The county also reports 83% are among people under the age of 50 years old with 65% of new cases among people between the ages of 18 and 49 years old.

Los Angeles County is still on its first week of reinstating its indoor mask mandate. The mandate, which went into effect over the weekend, applies to

mandate means The Los Angeles County customers will again be required to mask up - regardless of entering any indoor public establishment, including retail shops, grocery stores, bars, clubs, restaurants and workplaces.

> County Health Officer Dr. Muntu Davis said indoor dining will remain open, but customers will have to remain masked while they are not eating or drinking.

Davis said the county is "not where we need to be" in terms of getting the population vaccinated against the virus.

"We in South Gate have worked in stride for many years to be able to afford a home with less density, less crime, adequate schools, and a decent quality of life," said Virginia Johnson, of South Gate. 



## Rancho debuts California public schools will begin art installation offering free meals to all students

**DOWNEY** - Through a grant funded by the California Arts Council to the Rancho Los Amigos Foundation, Los Angeles based artist Hataya Tubtim has been leading artistic workshops over the past year for patients at Rancho Los Amigos National Rehabilitation Center.

These workshops aimed to bring the power of art and expression to the Rancho campus through a series of collaborative efforts, which culminated three-dimensional art installation that is currently on display at Rancho.

To create this art expression, Ms. Tubtim, along with fellow artist Carlos Benavides, recruited patients to work Rancho collaboratively to envision and design the art installation that they titled, "Love and Kindness."

This spectacular art piece is a physical representation of the journey one goes through when faced with a life changing injury or illness. It is broken into two sections with one side showing the darkness, depression, and loneliness faced when recovering from such a traumatic experience and the other side shows the kindness, love, and compassion of those who help you to return to some sense of normalcy. This duality is one that many can relate to given the last year and a half of living through a global

When looking at the left side of the art installation, you will see a landscape of bright flowers, blue skies, and lush foliage. There stands a figure who offers their heart towards the figure on the right who sits behind a brick wall in isolation.

The 'loving' figure is painted in bright colors and is adorned with symbols that represent its love, creativity, and freedom. Though the figure shows signs of physical wear on its body, represented by a leg brace, it continues to exude positivity and

In contrast, the 'lonely' figure on the right is painted in neutral colors with symbols of heartbreak, despair, and shame, The figure sits surrounded by images of past joys that have become distant memories. Both scenes contain painted river rocks that offer messages of love and kindness from dozens of Rancho community members including friends, family, and staff.

Colton Bryant, one of the artists involved in creating the piece said, "participating in this project has opened up my mind to where I'm at in life. I loved seeing people come together in one accord, working together with the same mind, and then bringing their creativity forth to create this wonderful work of


