Downey council condemns Gascón

■ Council members cast a vote of no confidence in the Los Angeles District Attorney, criticizing his policies that decriminalize petty crimes.

DOWNEY – The City Council cast a symbolic vote of no confidence in Los Angeles County District Attorney George Gascón on Tuesday, joining 30 other cities in voicing their displeasure with the DA's controversial directives

A resolution placed on the agenda by Mayor Claudia M. Frometa criticized Gascón for implementing special directives that result in "undermining the criminal justice system's goal of protecting the general public and victim's rights.

However, the move has been criticized by some in the community for its timeliness, as the council has put off making any kind of such action until after Councilman Mario Trujillo retired from his position with Gascón earlier this month.

Before the vote, the mayor emphasized that the council had no power over the future of the district attorney.

"This is not something that cities should necessarily be bringing forth," said Frometa. "When people elect individuals into office, it is the people who need to take it upon themselves to remove an individual; it's not really cities or councils that need to be discussing this sort of situation."

Frometa went on to say that a vote against Gascon "doesn't mean anything.'

"It doesn't mean anything because it is a symbolic vote,' said Frometa. "Thirty other cities and other councils, in many cases a 4-1 or 5-0 vote has taken place; nothing has changed. As a council, we can't change the fact that DÁ Gascón will continue to be DA Gascón."

"The reason we have this matter before us is because I have been listening to the concerns of the residents of Downey."

Neighboring cities including Norwalk, Santa Fe Springs and Whittier have all cast votes of no confidence against the DA.

Gascón has drawn scorn from local communities for declining to prosecute lower-level crimes.

According provided by the Downey Police Department, Gascón has rejected more than 40% of criminal cases presented to the District Attorney's office for prosecution. Most of the cases were for misdemeanors such as larceny, public intoxication, and trespassing.

Narcotic violations have been rejected at a rate of 90.7%.

Councilman Sean Ashton voiced his displeasure with some of the moves taken by the DA but conceded that Gascón had delivered what he promised on the campaign trail.

"I have to think back on some of these issues, and I think as an elected official, he actually said what he was going to do, and then he got elected, and then he actually did what he was going to do," said Ashton. "When you think of elected officials, regardless of what that was, he actually said what he was going to do. I can think of a lot of elected officials that will tell you one thing and do something

Trujillo, who served as one of Gascón's special advisors, was largely deflective and defensive in his comments.

Downey author exposes TV business with latest novel

■ Shannon Capps' novel comes as public trust in the news media reaches an alltime low.

DOWNEY – Former Downey resident and journalist Shannon Capps is 'turning the camera around' for a scathing look at the TV news business. His new novel, Runaway Train, the story of a young reporter caught in a web of corruption, hits bookshelves October 5th.

"If Walter Cronkite was alive today," Capps, who writes under the name S.W. Capps, says, "he'd have serious questions: 'Who's telling the truth?'; 'What happened to unbiased reporting?'; and 'When did the news business run off the

Capps' novel (a re-imagining of his 2010 offering, Train in the Distance) comes on the heels of a recent Gallup poll stating that only 9 percent of Americans "trust the media a great deal", while 33 percent "don't trust them at all". An Edelman poll goes even further, reporting that 56 percent think "journalists are purposely trying to mislead"

"Polls like these forced me to revisit the subject," Capps says. "The new book is shorter than the original and much fasterpaced, with different plot twists and a timely new epilogue."

Runaway Train, published by D.X. Varos, Ltd. in Denver, Colorado, is set in 1987, shortly after the FCC killed the Fairness

Doctrine. It is the story of a wary first-time journalist, forced to confront the sinister forces behind the station he works for. But while fighting to expose the truth, he uncovers something far more powerful-the truth about himself.

"I don't love the term 'fake news'," Capps, 57, says, "but today's broadcast press corps has certainly earned the moniker. This book is a pull-nopunches, honest look at where it

And Capps would know. Prior to writing Runaway Train, he worked as a reporter for KXII-TV Channel 12, the CBS affiliate in Ardmore, Oklahoma, where in 1989, he was nominated for an Oklahoma Broadcasters Award. Since leaving the world of television news, he has spent much of his time on two wheels, exploring the country via motorcycle and writing about it. His features have appeared in Rider, RoadBike, and H.O.G. magazines.

"His new book is part coming-of-age tale, part whodunit," publisher Daniel Willis says. "And we're excited to be releasing it at this critical point in time.

Early reviews have been positive, with critics calling it "a solid, fast-paced action piece... compelling on many different levels, from social commentary to intrigue (Midwest Book


Capps lived in Downey for more than two decades, attending Roger Casier and Maude Price, Griffiths Middle and Warren High School. Later, he earned a Bachelor of Arts degree in Broadcast Journalism at the University of Southern California, where he graduated Magna Cum Laude in 1987. After lengthy stints in the media and video production industries, he moved to the Pacific Northwest to pursue a full-time writing career, where he makes himself available (via video conference, phone, or in-person) to book clubs that read his novels.

Capps hopes to make his home town a stop on his upcoming book tour. He spoke to readers at the Downey Library ten years ago, when his last novel was released.

"My goal is to entertain people," Capps says, "but if I can open a few eyes along the way, all the better. I think Runaway Train will do that."

Q&A with Shannon Capps

Q: What was the inspiration for this novel?

A: As a young reporter in 1988, I found myself in rural Oklahoma, on deadline, stuck behind another tractor, and wondering why I chose this career. An idea blossomed, one for a novel based on my real-life experiences in the news business. I began compiling notes on Steno pads, scripts, napkins, you name it. Thirty-plus years later, I put the finishing touches on Runaway Train.

Q: You've said this book is about 'telling the truth'. Can you explain?

A: As a one-time 'insider', I wanted people to see the news differently. News directors have agendas. And reporters don't always have time to check their facts. As a result, the truth can come in small doses on the evening news. So if someone really wants the truth, I suggest surveying multiple sources—and never taking one source's words as gospel.

Q: How did your work as a TV reporter prepare you to write novels?

A: Reporting the news helped me in lots of ways, the most obvious being that it allowed me to write every day. And with the deadline pressure, reporting forced me to think on the fly, ask the right questions, and organize my thoughts. But perhaps most importantly, it exposed me to all different types of people.

Q: What do you think of the media today?

A: Like in every industry, there are good, conscientious people and there are bad. The trick is knowing who's who. And as we've seen in recent years, there's a pronounced skew with today's press. Remember, news doesn't create itself. People create it. And then decide how much to share and how much to withhold. Or as Dick Wilhelm, the villainous G.M. in Runaway Train, says, "News is what I say it is!"

Restaurants allowed to keep outdoor dining through next summer

■ Downey will allow its restaurants to continue serving customers in outdoor patios through at least next summer.

DOWNEY – Downey officials voted to extend the city's outdoor dining program, which has allowed restaurants to serve customers outside during the pandemic, through 2022 on Tuesday.

Downey launched temporary program in June 2020 after the L.A. County Health Department reduced indoor occupancy limits.

The City Council had already extended the outdoor dining program once before in August 2020 for an additional 180 days, or until the state lifted its

limitations on indoor businesses, whichever came later. That came on June 11, 2021, when Gov. Gavin Newsom rescinded the state's stay-at-home order, along with indoor restrictions that applied to restaurants.

In Downey, 37 restaurants are currently utilizing the program to serve customers outdoors. Of those, 25 indicated they would like to continue and 12 plan to remove have already removed - their outdoor seating areas, according to a survey conducted by the city.

"Some restaurants expressed hesitation removing the temporary outdoor dining areas due to concerns over the current reports of the impacts that different variants are causing, despite the current availability of vaccines," deputy city manager Aldo Schindler wrote in a report to the City Council.

"This idea that murderers will be released in the State of California because George has issued directives is being exaggerated to the point where now we're saying he's releasing people, dangerous people, and serious people much earlier," said Trujillo.

"There's still a concept of danger that we consider in the office, and for anyone to believe that George Gascón or the staff is bent on releasing dangerous criminals is preposterous.

"There are different systems of checks and balances in this system. We still have three branches of government; Mr. Gascón only serves in one.


"Let's not forget that there are judges out there looking out for us, because they have a responsibility to look out for dangerous individuals and not release them."

Trujillo added that "we are strapped with budget concerns across the board," pointing to the Los Angeles Board of Supervisors over the shift in how drug charges are approached.

"The office did make a determination that we would not file on first time offenders in some misdemeanor areas. The narcotics charges... We're being asked to look at narcotics, addiction, through a public health lens," said Trujillo. "Most of these addicts are not dangerous; they're ill, and many of them are in our families, and you know some of them."

Horse and buggy, wagon train, automobile, train, airplane and spaceship -- Effie Élla Hinson, 100, has ridden in all but

Besides traveling west by covered wagon, the former Downey resident rode the Fort Worth and Denver Railroad from Greenville to Mansfield, Texas in 1890, took her first auto trip in a Lambert in 1909, traveled by air from Los Angeles to Amarillo, Texas in 1952, and toured the world at the age of 82. She also went to Cape Kennedy to watch the launching of an Apollo spaceship.

The centenarian recently shared her memories with family and friends at a party held at the Harding Community Center where she currently lives.

Born Aug 16, 1884 in Greenville, Texas, Hinson is the oldest of 13 children reared by Sterling Phillip and Virginia Ann Hamblen. The family moved to the plains of Texas in 1890, where the centenarian attended school. At age 10, she contracted pink eye, going blind until age 16.

While cooking for the threshing crew at her uncle's home, Hinson met her husband, Edward. Five children, 10 grandchildren, 33 great grandchildren and five greatgreat-grandchildren were the result of that union on September 26, 1905.

An avid reader, Hinson is a genealogist and at age 92, was the oldest volunteer in the Ford presidential campaign. She also studied taxidermy

Reflecting on my failed campaign

I want to thank the distributor of my articles, Creators Syndicate, for allowing me to take eight weeks off from writing my weekly column so I could campaign to recall and replace the governor of California. I also want to thank my readers for their patience and willingness to let me pursue that adventure.

The recall required 50% plus one of the votes be cast in favor of the recall. To replace required only that the replacement candidate receive more votes than any other candidate. Right now, ballots are still being counted, but the effort to recall Gov. Gavin Newsom has failed.

On the ballot to recall the governor were two questions. Question one, do you want to recall the governor? Question two, who do you want to replace him? For question number two, there were over 40 names. I finished first, by far, with more than 47% of the replacement votes. My closest competitor received 10%.

I entered the race late and campaigned for nearly eight weeks. One Republican rival, a two-term mayor of San Diego, campaigned a full year and got less than 9%. It appears that I raised more money than my Republican rivals combined — with the exception of a multimillionaire who pretty much self-funded.

As expected, the left-wing media were ruthless. A columnist in the Los Angeles Times called me "the Black face of white supremacy." Only in America can a Black person become president or a white supremacist.

Had Newsom been recalled, this would've been the second time Californians voted to recall their governor. But the electoral landscape the first time this happened in 2003, compared with today, is very different.

Between 2003 and 2021 there are 5% more registered Democrats, 50% more registered independents — who tend to vote for Democrats — and a whopping 33% fewer Republicans. To call an effort to recall a Democratic governor an uphill battle is a massive understatement.

In 2003, California Gov. Gray Davis faced a recall. The state voters' political party registration was:

Dems: 44%

GOP: 35%

Independent/Decline to state: 16%

In 2021, as California Gov. Gavin Newsom faced a recall, registration

Dems: 46.5%

GOP: 24%

Independent/Decline to state: 23%

Arnold Schwarzenegger share of votes in 2003: 48.6%

Larry Elder share in 2021 (votes still being counted): 47%

So, why bother?

Newsom's two-term record as governor is flat-out abysmal. During the first eight months of the coronavirus pandemic, Newsom oversaw the early release of 18,000 convicted felons. Crime is up dramatically. In 2020, Los Angeles homicides increased 40% over 2019. The increases were similar in San Francisco (17%), Oakland (36%) and San Diego (10%).

Homelessness is also up dramatically. When Newsom ran for mayor

Between 2003 and 2021 there are 5% more registered Democrats, 50% of San Francisco in 2004, he promised to end that city's homelessness re registered independents — who tend to vote for Democrats — and problem in 10 years. Have you been to San Francisco lately?

The quality of public education in California is abysmal. Despite spending an estimated \$20,000 per student per year, according to the California Policy Center, California public school students' test scores rank near the bottom of all 50 states. Newsom, beholden to the powerful California Teachers Association, denied public school students an entire year of in–school learning. Meanwhile, his own kids enjoyed in–person learning at their private school. Pre–pandemic, 67% of fourth grade public school students could not read at NAEP, or National Assessment of Educational Progress, levels of proficiency. The math scores are even worse.

Black and Hispanic parents in urban areas want school choice — the right to use the education money to put their student in a charter school, private school, religious school or to use the money for home-schooling — but Newsom and the teachers unions oppose true school choice.

California is facing a water shortage and experiencing "rolling brownouts" because of the failure to properly invest in our energy grid, and our fires are becoming increasingly more severe, in part because of Newsom's poor forest management.

So, why did the recall fail? More on this next week.

A new strategy to curb overdose deaths

A deadly plague continues to rage across America, and neither vaccines nor face masks nor herd immunity can stop it. The epidemic of drug overdose deaths has taken more lives than COVID-19 and is more intractable. But the Biden administration is showing a welcome openness to a new strategy.

That approach is known broadly as "harm reduction." The idea is that drug abuse should be regarded as a public health problem, not a crime or a sin. Prohibiting and punishing drug use doesn't work. A better option is helping illicit users modify their behavior to reduce their risks.

"I believe this administration is the first to use the term 'harm reduction' in its drug strategy," says Maritza Perez, director of the office of national affairs for the Drug Policy Alliance.

The risks of opioid use in particular are grave and growing. In 2019, the number of drug overdose deaths was 70,630, the highest ever, and most involved opioids. But in 2020, the total was 93,331, an increase of 32%. Since 1999, more than 900,000 Americans have died of drug overdoses.

The epidemic has its roots in the 1990s, when drug companies brought out new opioids such as OxyContin, which were marketed as safe for treating chronic pain. But many patients became addicted, and some died of overdoses.

You might think that the federal crackdown on pain prescriptions and the successful lawsuits against pharmaceutical companies would make a big difference, and you would be right: The number of fatalities involving

nonprescription opioids has soared.

For the past half-century, presidents of both parties have seen drug abuse as a job for police and prosecutors, relying on harsh punishment to deter buyers and sellers. But mass incarceration failed — and President Joe Biden, who helped bring it about as a U.S. senator, now recognizes it was "a big mistake."

Today, he's embracing something different: trying to keep drug users alive while facilitating their access to ways of overcoming addiction and avoiding death. The COVID-19 relief act enacted this year includes \$30 million for programs aimed at harm reduction.

Among these are syringe services, which let injecting drug users get free, sterile needles without fear of arrest. These are a time-tested method of curbing lethal diseases, including HIV and hepatitis C, but they have long been barred from federal funding. President Barack Obama got the ban lifted, but when Republicans regained control of Congress in 2011, they restored it.

Even former Vice President Mike Pence, however, was willing to allow syringe services when things got dire enough. As governor of Indiana in 2015, he approved a program in one county to combat a severe outbreak of HIV. "I will tell you that I do not support needle exchange as antidrug policy," he said then. "But this is a public health emergency." The program was a phenomenal success.

The White House has issued a long statement of its drug policy priorities, with an eye to reducing fatal overdoses. It promises to improve

access to drugs used to treat and overcome opioid dependence. It endorses efforts to promote the use of naloxone, which can reverse overdoses, and test strips to detect fentanyl, a highly potent opioid that suppliers often mix into heroin and cocaine — with sometimes tragic results.

The point is not only to save drug users from sudden death but also to give them a path away from addiction. Harm-reduction organizations, the White House statement says, "can build trust over time with patients and are in a unique position to encourage (drug users) to request treatment, recovery services and health care." This year's expansion of the Affordable Care Act has also made it possible for more people to get mental health and substance abuse treatment.

But the addiction to law enforcement is hard to break. Biden has proposed to make permanent the Trump administration's policy of classifying all fentanyl-related substances as Schedule I drugs, exposing users to stiff criminal penalties.

That's the opposite of harm reduction — adding the hazards of imprisonment to the risk of overdose. Not to mention that, as we've learned from decades of trying to eradicate cocaine, heroin and methamphetamines, locking up people for using drugs doesn't keep people from using drugs.

Biden has taken a big step toward a better future. But he still has one foot stuck in the past.

Democrats must be bold to save America from Republican attacks

In November, Democrats won the much-coveted trifecta – the House, the Senate and the White House. But the results could easily have been different. Only 90,000 votes separated us from four more years of attacks on our people and our democracy.

Many in the establishment would justify this razor-thin margin as a reason to avoid bold reforms or hew closer to the political center. That is a dangerous narrative.

If the Democratic Party is going to succeed in moving this country forward, we need to build the power necessary to govern for a generation, not just win a single election.

How do we do this? By talking to people and by listening. We call this deep canvassing.

When most candidates bother to canvass at all, they employ consultants in Washington to develop a single, poll-tested message. Their canvassers regurgitate a set of talking points scraped together from focus groups and abstract ideas about the opinions of the American public.

But our volunteers engage in long, difficult conversations – to learn from their fellow Americans, to listen more than they speak and to organize the unorganized.

At People's Action, we are focusing our efforts on swing districts. The conventional wisdom of the establishment tells us that these areas are hostile to a progressive agenda, that the only Democrats who could win are Republicans in all but name.

But when we talk to people from these districts, we've found something different. We hear stories from moms and uncles with conflicted feelings about their country and its future.

We share experiences with grocery clerks and hair stylists who are

tired of the status quo. And we find common ground with Americans who are eager for bold solutions to the crises that our country faces.

As U.S. representatives, we want to build movements in our districts and beyond to get the real change our neighbors are crying out for. We have focused our campaign energy on listening and organizing with people who are not already on board – while transforming supporters into volunteers and turning out our progressive majority at the polls.

In cities, suburbs and exurbs, we find that white and Black, Indigenous and people of color constituents unite around progressive values like universal health care and higher wages more often than Fox News and CNN would care to admit.

In the northern suburbs of Minnesota's 5th Congressional District, we are canvassing on Medicare for All. We're doing this to connect with people about the material issues that impact them every day. We're not asking them to vote for us; we're not asking them whether they like us; we're asking them to imagine a better world – a world in which they don't have to worry about how they'll pay for their doctor or about losing coverage if they lose their job.

We've had thousands of conversations, and we've made attempts to talk with almost half of all eligible voters in the suburban cities of New Hope, Crystal, Robbinsdale, Brooklyn Center, Columbia Heights and Fridley.

Americans support Medicare for All

And we've found that support for Medicare for All cuts across geographic, racial, economic and, yes, political lines. Even the folks we talk to who say they are least likely to support a progressive candidate support Medicare for All and our efforts to discuss it with the community.

We've found it doesn't matter whether they're Democrats or Republicans, progressives or conservatives, our supporters or our detractors. They want to hear from us, and they want to share their stories.

Because every working American knows that our health care system is unfair. It's based on luck. And winners and losers aren't divided by political ideologies.

We've listened to thousands of voters

In Michigan, we are engaging in Deep Listening. In the first six months of the year, we've spent time connecting with our district: contacting thousands of undecided voters from 2020's 13th congressional race.

We discovered that regardless of people's political beliefs, folks are particularly enthusiastic about sharing their stories with someone willing to listen. We spoke to an overwhelming number of residents and

It's clear we can't shy away from difficult conversations. We must engage with voters about the stories the right-wing media fed to them that demonize immigrants or peddle false, zero-sum trade-offs between the economy and the planet.

For too long, we've ceded the task of meaning-making to the right. We can do better, by bringing people together. We are organizing in our districts and supporting People's Action in organizing in Republicanheld swing districts across the country, all of which will be critical to Democrats to maintain our majority in 2022.

Change will not come through clever electioneering, or through timid, weak policies. It will take time and effort. It will take care and investment. We hope you will join us in our work. The future of our country depends on it.
