## Downey clamps down on protests

■ Protestors who target council members' homes now have to stay 300 feet away.

**DOWNEY** - Looking to avoid the protests they faced at their front doorsteps last year, the Downey City Council voted Tuesday to place a buffer zone between picketers and their targeted residences.

Protestors wishing to target a specific individual within their private residence will now have to stay 300 feet from the structure (not the property line). This follows several other municipalities that have taken similar action, including Los Angeles, Carlsbad, Huntington Beach, Santa Monica, Long Beach, Riverside City and County, and San Diego County.

This isn't the first time that the council has attempted to tackle the issue.

The council first entertained action against residential picketing last year, after a group of individuals armed with bullhorns and seeking more rent control, took to the homes of then council members Blanca Pacheco, Claudia M. Frometa, Sean Ashton, Rick Rodriguez, and

Specifically, both Frometa solicited through the school and Pacheco were concerned with the impact that the protests were having on their neighbors response from parents and and - in the case of Frometa teachers. and Saab - their young children, as demonstrations, although in the patio area on the north nonviolent, were ortentimes aggressive, profane. amplified, and

Those initial discussions failed to get off the ground, however, as Saab and Ashton both were reluctant to infringe on the first amendment rights of the demonstrators.

It was a different story this time around, however, as the move to establish a residential buffer zone passed on a 3-1 vote, with Ashton absent.

Frometa said that the city was "not aiming to silence anyone."

"With this ordinance, we want to safeguard both groups," said Frometa. "We want to ensure that the targeted picketing that occurs within our community does not force residents to become captive audiences to unwanted speech within their own homes.

Protestors are still liable to other laws and regulations, such as traffic and noise. A demonstrator who violates the buffer zone could also be subject to a private legal action by the targeted individual.

The sole objector to the ordinance was Councilwoman Catherine Alvarez, who took part in the aforementioned protests before winning her seat on the

The councilwoman – who is currently facing a potential recall in part for her involvement in the home protests - defended her actions, saying that "these protests started when constituents felt like they weren't being heard."

"They said the council didn't listen to them, so they went to our houses and protested. I was one of them. I was here constantly asking for something; it didn't happen," said Alvarez. "They were protesting about housing affordability, and moratoriums and evictions. The group that did this was mainly the Downey Tenants Union, and other groups in our city. Specifically, they wanted us to create an eviction moratorium prior to the holidays...Protestors had legitimate reasons to protest...

## Student art exhibit a special feature for Dia de los Muertos

■ A student art exhibit has been added to Downey's Dia de los Muertos Festival, happening this Saturday.

**DOWNEY** – Students and parents have an extra reason to be excited about the return of Downey's acclaimed Dia de los Muertos Art Festival to a live venue this Saturday, Oct. 30.

In addition to musical performances and extensive displays of fine art, crafts, and ofrendas (including a community altar), this year's festival will also feature a special exhibit of student artwork. This student exhibit was organized by the Downey Arts Coalition which has been managing the fine art exhibit inside the theater since the festival's inception.

"I'm excited to report that we have approximately 53 art pieces, one altar, and 25 ceramic skulls," says Eloisa Ball, curator of the student work. Entries come from Downey's three public high schools, four middle schools, and five of its elementary schools, as well as surrounding schools in Whittier, Bellflower, and Santa Fe Springs. There is also an entry from a student attending East LA City College.

Student submissions were districts and Ball recounts an overwhelmingly positive

Student work will be located side of Downey City Library, just across from City Hall.

Lewis Elementary School fourth-grader Charlotte Berhow explains she is excited to be participating because her grandmother celebrates this holiday. Charlotte's project is an image of a calaveras (skull) on canvas using varied media.

"My grandma decorates her house and we light candles to remember the people who passed away," says Charlotte. 'We eat the food that they liked." Some of her relatives liked ice cream and Dr. Pepper, she adds.

Sussman seventh-grader Jocelyn Rodriguez is exhibiting La Soledad de la Noche, a work she says was inspired by her research and "the Mexican dresses and Mexican culture and how colorful it is.3

Jocelyn says her creative process was not totally smooth sailing. "At first I was nervous because when I started the painting I wasn't really liking how it started but I told myself that I just needed to trust the process, and just finish it."

Her perseverance paid off. "Once I finished the painting," she recounts, "I was really happy with it and excited to be able to have this opportunity."

Jocelyn's mother Brenda says "We really enjoy the Downey festival as a family, so it's kind of a tradition for us." They have attended for three years, with the exception of its absence due

Gizzel Anaya that one of Anaya's pieces will be included with the fine art display ("Ofrendas") inside the Downey Theatre.

Anaya says she is self-taught, but always "had a passion for drawing and art generally." After graduation she plans to study psychology and child development.

"I hope to incorporate art into that career as a child therapist," says Anaya, "allowing children to express themselves through art."

Columbus High will be well represented at the festival with 25 students showcasing their ceramic work.

"I am so proud of my students," says art teacher Jennifer LaMar, who instructs five classes every day.

LaMar felt the opportunity for students to exhibit their work at an event with such visibility was a good antidote to the collective trauma" of the COVID pandemic with its isolation and

"You could see their faces light up when I told them about this opportunity," she reports. "They asked me, 'You mean I could be in an art show? Like, I'm good enough?' I told them, 'Absolutely you are good enough.'"

LaMar feels there is often an unfair image of Columbus students because they are attending a continuation school. "These are good kids," she affirms.

Senior Tzuri Perez, who plans to study nursing after high school, feels that participating in the festival "is a good experience mainly because you're creating a memory that you've never unlocked before."

Having his artwork on display "is a good opportunity," agrees senior Salvador Hernandez, who plans to start his own vintage clothing business, "especially after the pandemic to show that we are worth something here at Columbus.'

La Mar's students will be exhibiting clay calaveras (skulls) that have been fired and painted to reflect the theme of Dia de los Muertos. LaMar's instructional schedule dovetailed with the fall festival.

"I usually do the ceramics unit first in the year," she explains, "because it catches their attention, it's fun, it's hands-on. You know, you get them hooked and we can go into some drawing skills, some

painting."

Participating senior Fernando Munoz, plans to enter the pharmacist tech program at Downey Adult School after graduation. He explains, "I think [the art exhibit] is a good experience to open up that creative side of us and express ourselves through the class models that we made."

Senior Christopher Munoz, who plans to study inventory management after graduation and work in his family's business, concurs: "I think it's a good experience to try something new and it's definitely something interesting."

Principal Xochitl Ortiz explains that the school covered the entry fees for all of the students "because we don't want to put any student on the spot. We want them to stay safe, and the fee could mean the difference of having lunch one

While most of LaMar's students are not participating for various reasons, she is still happy with the number of students who are.

"I'm excited about the turnout," she explains. "It's the equivalent of one full art class."

#### **Woodruff Student Academy**

The Columbus High School campus also hosts the Woodruff Student Academy which serves

middle school and early high school students who need a more individual learning environment.

Teaching assistant Adriana Rojas is guiding her students to prepare paper masks for exhibit at the coming festival.

"This is a good opportunity for them," she observes, "because they don't always see themselves in a bright light.'

Some of her students will be helping the small group of transitional adult students who are also served at Columbus.

This cooperation contributes to a positive self-image, explains Rojas. They are showing "kindness, compassion, and patience, and it's honestly really nice to see these kids do just that. They remind me of why I am teaching."

With positive experiences for so many students, curator Eloisa Ball feels strongly about having a student art exhibit at future Dia de los Muertos Art Festivals.

'This is DAC's first ever," she declares, "but not last, Student Art Exhibition.'



### Paging Dr. Frischer...

I am astounded at the variety of sparkling water on the store shelves. Are they a healthful alternative to sodas and other drinks?



Healthier lifestyle trends are on the increase across all age groups, and people are gradually shifting to more healthful and innovative drinks, including sparkling water. The global sparkling water market was estimated at almost \$30 billion in 2020, and is expected to continue to grow rapidly.

Sparkling water is a refreshing alternative to soda. Is it truly any healthier? It depends. Soda and juice include considerable amounts of sugar or artificial sweeteners. However, some sparkling waters

ficial sweeteners. However, some sparkling water contain minerals like salt, or sugars, or artificial sweeteners.

To make water bubbly, it is infused with carbon dioxide gas under pressure. Different forms of sparkling water include seltzer (just water with the carbon dioxide), club soda (with the added minerals potassium bicarbonate and potassium sulfate, giving it a slightly salty taste), and sparkling mineral water (such as Perrier and San Pellegrino, which come from a mineral spring and contain naturally occurring minerals, such as salts or sulphur compounds). Tonic water is a carbonated water that contains quinine, which is bitter, along with sugar, high-fructose corn syrup, or artificial sweetener. So, if you are watching your sodium, be aware that many carbonated

waters contain salt. Others are high in sugar, which poses a risk for tooth decay, diabetes, and weight gain.

Sparkling water is as hydrating as still water, and staying well hydrated has so many benefits, including better kidney function and weight loss. Many people find that adequate hydration is difficult for them to achieve, and that alternatives to still water are helpful. Symptoms of dehydration can include thirst, fatigue, dizziness, confusion, headache, dry mouth and dry cough, rapid heart rate, low blood pressure, loss of appetite, muscle cramps, constipation, chills, and dark and infrequent urine.

It was believed that consuming carbonated water could harm the bones, due to its slightly acidic content. Studies have not shown this to be the case. What has been shown is that sodas, which are high in phosphorus, do indeed lower bone density.

Perhaps you are fed up with spending money on small bottles of sparkling water (and other drinks), and creating yet more plastic waste? A variety of products, like Soda Stream, make it easy, inexpensive, environmentally conscious, and fast to make carbonated beverages at home, in reusable bottles.

As I am writing this, I am drinking Hint sparkling water. It has no sweeteners, minerals or sodium added. I see on the label that the only additional ingredient is "other natural flavors." I encourage you to try a good pure sparkling water. It is enjoyable, calorie free, and a great substitute for soda. But don't forget to read the label, and avoid sugar, salt, or other chemicals.

As many know, at the beginning of the month, Governor Newsom announced

a future mandate that would require all students within the state of California to get the COVID-19 vaccination once it is fully approved by the Food and Drug Administration (FDA). With the projection of this approval coming in the next few months, this mandate is projected to be implemented no sooner than July 2022 and potentially take effect in the 2022-23 school year.

If and when this is enacted, it would require the COVID-19 vaccine in the same manner as the current 10 vaccines already required by California law for students attending K-12 schools.

We understand that families may have strong emotions and questions about COVID-19 safety measures, including vaccine and testing requirements. Unlike other districts in our region that have mandated COVID-19 vaccinations for their staff and students, we in Downey Unified have not.

That being said, our district has no control over the proposed State mandate put in

place to require the COVID-19 vaccine for students attending K-12 schools in person; however, as a district, we will continue to encourage those who are interested and eligible to get vaccinated.

Also, I want to thank The Mary R. Stauffer Foundation for their annual grants that were presented earlier this month that included 14 Principal Grants, 18 Teacher Grants and two Districtwide Grants. The **Stauffer Foundation Grants** have been presented to teachers and principals within Downey Unified for the last 21 years and this year's grants totaled

Even though Dr. Stauffer is sadly no longer with us, she continues to support our staff and students through her foundation, and for that, we are forever grateful. These grants will provide selected teachers and principals with additional funding for new innovative programs and creative projects, as well as renewals of existing programs. ## Teen girls had body image issues long before Instagram

When I was, like, 17, I didn't eat for three solid days. Ten pounds had to go — immediately. The period of starvation crowded out every other thought in my head. Of course, I lost weight, though it was mostly water. Of course, I gained it back.

My point is that teenage girls' angst over body image long preceded Instagram, the photo- and video-sharing app now being blamed for a spike in eating disorders. So it's hard to assess findings in a study in which 32% of teen girls said when they felt bad about their bodies, "Instagram made them feel worse." Instagram is owned by Facebook.

Young women still see dog-eared copies of Teen Vogue and InStyle at their hair place. They, too, feature pictures of the anorexic stars in bikinis — many digitally touched up as Instagram lets its users do. Ask today's teen girls whether photos of rake-thin model Gigi Hadid make them feel worse about their bodies. They might well say yes.

Which leads one to wonder exactly how much an apparent rise in teenage girls' emotional distress has been fostered by Instagram. A lot, according to The Wall Street Journal.

Unlike the wildly popular TikTok, which emphasizes performance, Instagram puts the focus on faces, bodies and lifestyle. That invites waves of "negative social comparison" with friends and acquaintances Instagram, I doubt things would have gone otherwise. contributing to one's internal turmoil.

for its Instagram audience. Over 40% of Instagram users are 22 or younger. They haven't been "aging" up to Facebook, now the province of older people. The report finds that young adults consider Facebook's content as "negative, fake and misleading." (Where else have we heard that?)

The problem of teens suffering social distress via Instagram could be assigned to most everyone on any social media. Facebook CEO Mark Zuckerberg likes to talk about the positive mental benefits the connecting with others — that social media offers. But what kind

of connections are these platforms promoting and, more to the point, replacing? While social media apps promote shallow relationships, more seriously, they crowd out opportunities for real intimacy.

I know two wonderful women pained by serious depression and racked by self-doubt. They're on Facebook all the time, posting several times a day about their allegedly carefree lives and happy marriages and, in the case of one, flawless children.

I love them both but know they are hiding their realities. All their friends" see, however, is the phony facade, and then they wonder why they, too, aren't having a grand time.

When these women and I speak one on one, it's an entirely different conversation. We share our fears and often laugh about them. Rather than respond to a Facebook post with a fake-sweet comment ("Looks like you're having so much fun"), a real friend hearing about an insecurity might respond ("I know how you feel").

## Supreme Court threatens freedom of the press



#### By Judge Andrew Napolitano

In a week, the Supreme Court will decide if it will consider diminishing long-standing protections for the freedom of the press. Here is the backstory.

In 1964, at the height of the Civil Rights movement, the Supreme Court unanimously reversed a jury verdict by an Alabama state court and in doing so changed the law of defamation in such a manner as to enhance substantially and materially the freedom of the press.

The case was Times v. Sullivan, in which the police commissioner of Montgomery, Alabama, sued The New York Times for publishing a full-page advertisement that, he argued, though it did not mention him by name, had defamed him.

The libel law in Alabama and all states at the time permitted an aggrieved plaintiff to recover damages from a publisher for a defamatory inaccuracy in a publication by showing simple negligence.

In the advertisement about which Commissioner L.B. Sullivan complained, there were some inaccuracies, and so the Alabama Supreme Court upheld his half million-dollar verdict. The Times appealed to the U.S. Supreme Court. In reversing, the Supreme Court ruled that when a public official is the plaintiff in a defamation case, the First Amendment is implicated since the press is the eyes and ears of the public, and the public has the right to know what the public



This was a radical and judge-made change in defamation law. The court held that, to safe-guard transparency about government and to protect free speech about public officials, a higher bar than simple negligence was needed. The court fashioned a bar called "actual

Actual malice requires that the plaintiff who is a public official prove by clear and convincing evidence that the offending piece was published with knowledge of its falsity or with reckless disregard for whether it was true or false. This bar is so high that it has rarely been met in any trial court, state or federal, since the Times v. Sullivan case.

Many of my colleagues in the constitutional law community, particularly those on the right, have criticized this decision because was crafted out of thin air by nine justices, rather than debated and legislated by Congress or state legislatures.

As a conservative law student in the mid-1970s, I was a harsh critic of judges creating laws. To me at the time, the Times v. Sullivan case was analogous to the court putting its thumb on the scales of justice on the side of a liberal press.

Today, as a libertarian legal scholar and commentator, and a former judge, I rejoice in this decision as perhaps the greatest defense of a free press in American history.

The Times case implicates two profound value judgments. The first is protection of a free press and the second is the role of the judiciary when liberty clashes with power.

The Times case and its extensive progeny recognize the Madisonian proposition that the whole purpose of the First Amendment is to encourage open, wide, robust, even caustic and unbridled speech about the policies and the personnel of the government. Its companion purpose is to keep the government entirely out of the business of speech.

In respect of these values, the Times case has worked to the fullest. It has removed the fear of criticism of public officials by the public and the press. It lets everyone, from the average Joe to the largest media companies in the world, think as they wish, say what they think and publish what they say.

Without this protection, the public discourse on everything from abortion to immigration, from taxes to foreign policy, from President Joe Biden's mental acuity to former President Donald Trump's character traits would be dumbed down and only whispered because of fear of litigation.

And the case cuts both ways. If, for example, one were to express a caustic opinion about Biden or Trump or any public official, they each have a huge megaphone, so to speak, with which to rebut their critics. In the give and take between critics and targets, the public watches, listens and learns if the target is a person worthy of its political support. Americans have benefitted immeasurably from this process.

The other value underlying the Times case is the Jeffersonian view that our rights are natural because they come from our humanity, which is a gift from God. The ratifiers of the Declaration of Independence and the Bill of Rights agreed. So, what to do when a legislative body or a jury tramples these rights — say, by punishing

This is where an independent judiciary comes in. The whole to think very clearly. purpose of an independent judiciary, to paraphrase Harvard's professor Laurence Tribe, is to be anti-democratic — to preserve the rights and property of the minority (it could be a minority of one) from invasion by the majoritarian government. Stated differently, since our freedoms are natural, freedom is the default position.

That means wherever there is a clash between liberty and power, because liberty is the natural starting point and power is artificially imposed by force, the benefit of the doubt — the judge-made rules of procedure — should favor liberty.

Regrettably, this bias for liberty over power only exists with respect to the First Amendment. Yet, whenever the government wants to take life, liberty or property from any person, or permit others to do so, that person should enjoy the benefit of the pro-personal liberty bias of the Declaration of Independence and the Bill of Rights.

Later this month, the Supreme Court will announce whether it will revisit Times v. Sullivan in an effort to undo it. If it does undo it, it will crush the freedom of the press as surely as any petty tyrant has done who can't stand the heat. It will dumb down our public discourse in favor of those in power. We will have a press afraid to be free.







Tommy was pleasantly handsome, he could play both leads and character parts, though his leads usually had a bit of the character actor and his secondary roles tended to make a bigger impression than the headliners.

He was named a Disney legend in 2006 and would show up for fan conventions. He appeared with Annette Funicell in several films -- one of my

favorites was "Old Yeller." A western drama about a good dog and the passing of the  $\bar{\text{dog}}$  -- it will have you weeping.

What fond memories I have of him and the pictures he starred in.

Another Mouseketeer is Dennis Day of Downey. The following is taken from the Southeast News dated April 17, 1981:

Dennis Day, a former Downey resident, was one of the original Mouseketeers and used to call Walt Disney "Uncle

Today, however, he's turned in his mouse ears for a monk's habit as an aspiring lay brother in the Oblates of St. Genesis, a monastic order of the Christ Catholic Church of San Francisco. Currently he's making delicacies for the Renaissance Faire in Agoura.

The Day family moved to Downey when Dennis was nine years old. Fred Day, Dennis' father, was the superintendent of the Rio Hondo Country Club.

"We lived between the 16th and 18th holes," quipped Dennis. "Us kids developed a permanent stoop as a result of walking to school and looking out for flying golf balls.'

After doing bit parts on the "Red Skelton Hour," the "Roy Rogers Show," and several commercials, young Dennis, at age 11, attended a cattle call, during which an estimated 5,000 child actors were auditioned for parts as Mickey Mouse Mouseketeers.

"They really didn't know what they were looking for -probably just kids who could cope," related Dennis.

Getting on stage with his sister, Nelda, for a tap dance routine, Dennis remembers putting the brakes to their act midway through.

"The pianist was playing too fast and I told him to hold it," he said. "I showed him the tempo we wanted and continued with the number. I guess that impressed them because I got the part."

Dennis described the Mouseketeers as a 1950s phenomenon.

"People in the 1950s grew up with us and idolized us," he said. "We were told that Walt Disney chose us out of all the children in the world to be Mouseketeers. We were supposed to show other children what they were supposed to be like.

"Even though we were Mouseketeers, we were still kids, and once caused him (Walt Disney) to get his hand caught in an elevator.'

Another time, said Dennis, he panicked the creator of Disneyland by getting into a makeup man's kit and

spreading blood all over his

"I saw him talking to Darlene Gillispie and I showed him my arm," remarked Dennis. "He took me halfway to the infirmary before he found out it was makeup.

However, one day it just all

"The show had ended and that was that," said Dennis. "Nevertheless, I kept seeing myself for another seven years on TV with all the reruns.





#### Duane Dewey, Medal of Honor recipient

Duane E. Dewey, a U.S. Marine Corps veteran of the Korean War who was awarded the Medal of Honor, died Oct. 11 at age 89.

Dewey enlisted in the Marine Corps in 1951. A year later, he earned his Medal of Honor, the highest decoration for valor, while serving near Panmunjom as the leader of a machine gun

Dewey was being treated for injuries sustained when a grenade exploded near his foot when another grenade landed next to him. He threw himself on the grenade to protect the members of his squad.

Dewey was severely injured but survived the large shrapnel wounds inflicted by the grenade as well as a bullet to his stomach.

He was presented with the Medal of Honor by President Dwight D. Eisenhower in 1953. The president remarked on his unlikely survival, "You must have a body of steel."

In later years, Dewey ran an office machine repair shop as well as driving a bus and working at a piano factory.

#### Mort Sahl, pioneer in stand-up comedy

Mort Sahl, a stand-up comedian who pioneered a conversational style of comedy that influenced generations of comics, died Oct. 26 at age 94.

When Sahl began doing stand-up in the early 1950s, comedy was still evolving from its vaudeville roots, and nobody was doing quite what he'd do when he first stepped on a stage.

Carrying a newspaper under one arm, Sahl offered a rapidfire, conversational patter that sounded utterly natural and unscripted (and it often was -Sahl frequently improvised). Focusing on political satire and commentary, Sahl's dark humor appealed to young humorists including Woody Allen and John Cleese, who were profoundly

influenced by him.

Sahl also found a fan in President John F. Kennedy, who asked the comedian to write political jokes for him.

Sahl's 1958 album, "The Future Lies Ahead," a recording of a routine in front of a live audience, is widely considered to be the first modern comedy

After President Kennedy's death. Sahl volunteered to be a part of New Orleans District Attorney Jim Garrison's team investigating the assassination. Sahl became obsessed, he admitted, with the various theories about the assassination, and he disbelieved the Warren Commission Report. obsession spilled over into his comedy routines, often taking over a show and turning off fans.

Sahl's career suffered as he chased the truth about Kennedy's assassination, his bookings and income drying up.

In the 1970s, as the audience for political satire increased, Sahl's career partially recovered, and he returned to stage and TV appearances. He continued doing stand-up well into his 90s, performing weekly until 2020.

#### Dorothy Steel, late blooming actress

Dorothy Steel, an actress best known for playing a tribal elder in Marvel's "Black Panther," died Oct. 15 at age 95

Steel didn't begin acting until long after her retirement from her career as a senior revenue officer with the Internal Revenue Service. In fact, she was in her 80s when she first appeared on stage, in plays put on by her Atlanta-area senior center.

There, she was discovered by an acting teacher and an agent, who were impressed by her authoritative stage presence.

Steel was 90 when she auditioned for "Black Panther" and was cast as an elder of the Merchant Tribe. Her other films include "Jumanji: The Next Level," "Poms," and "Daisy Winters." On TV, she had a recurring role in "Saints

At the time of her death, Steel had nearly completed her filming for the upcoming "Black Panther: Wakanda Forever."

#### James Michael Tyler, barista on 'Friends'

James Michael Tyler, an actor best known for playing Gunther, the barista at Central Perk, on "Friends," died Oct. 24 of prostate cancer at the age of 59.

best-known role was Gunther, the coffee shop worker who had a longstanding unrequited crush on Jennifer Aniston's Rachel character. He was a regular recurring character on the show. appearing in more than half of its episodes as the show's most frequent guest star.

Tyler also made appearances on TV shows including "Just Shoot Me," "Sabrina, the Teenage Witch," and "Scrubs.'

In a 2019 interview, Tyler spoke of auditioning "Friends."

"I went in with the white hair kind of by mistake," he said. "A friend of mine had bleached it, literally the night before I went in as an extra. He was practicing on my head because he wanted to be a stylist. So I went in with this bleached hair and they put me behind the coffee counter and I guess the producers liked it. They were like, 'this is what a New York barista looks like in 1994.'"

Jennifer Aniston has led the tributes to her "Friends" co-star, saying the show "would not have been the same" without him.

"'Friends' would not have been the same without you," she wrote. "Thank you for the laughter you brought to the show and to all of our lives. You will be so missed #JamesMichaelTyler."

Her post included a clip from the 2004 series finale when Gunther finally plucked up the courage to tell Rachel that he loved her as she prepared to leave New York for a new life in Paris.

David Schwimmer, played palaeontologist Geller, thanked Tyler for "playing such a wonderful, unforgettable role" and "for being such a big hearted gentleman and all around mensch off screen."

#### Jerry Pinkney, children's book author

Jerry Pinkney, a children's book illustrator and author known for books including the Caldecott Medal-winning "The Lion & the Mouse," died Oct. 20 at age 81.

Pinkney illustrated more than 100 books for children and teens, beginning with the 1964 "The Adventures of Spider: West African Folk Tales."

He often worked with author Julius Lester, including on "John Henry" and several books in his "The Tales of Uncle Remus" series. Pinkney also wrote his own books later in his career, including "Noah's Ark," "Little Red Riding Hood," and "The Lion and the Mouse.

Though he worked in a number of different styles, Pinkney's preferred medium was watercolor. He was widely honored, including winning several Coretta Scott King Awards.

He illustrated notable Black Americans for the U.S. Postal Service for the first Black Heritage postage stamp series in 1977. Pinkney also provided illustrations for publications by the National Park Service and National Geographic, both on the history of the Underground Railroad.

#### Jay Black, lead singer of Jay and the Americans

Jay Black, the lead singer for Jay and the Americans, who had 1960s hits including "Come a Little Bit Closer" and "Cara Mia," died Oct. 22 of pneumonia at the age of 82.

Born David Blatt, Black began his singing career with the doowop groups the Empires and the Two Chaps in the 1950s. He joined the Americans in 1963, when their first lead singer, Jay Traynor, left the band.

It was then that Black took the nickname Jay, for continuity with the band's name. They scored Top Five hits in 1964 with 'Come a Little Bit Closer" and in 1965 with "Cara Mia."

Other popular singles included "Let's Lock the Door (And Throw Away the Key),"

Jay and the Americans opened for the Beatles at their first U.S. concert, at the Washington Coliseum in February 1964.

The band broke up in 1973, though Black continued to perform as Jay and the Americans with a different group of backing musicians for decades. In 2006, the name was auctioned off after Black filed for bankruptcy, and another former band member purchased it and began touring with a new version of Jay and the Americans.

#### Halyna Hutchins, up and coming cinematographer

Halyna Hutchins, cinematographer who worked on films including "Archenemy" and "Darlin'," died Oct. 21 in an accidental shooting on the set of the film "Rust" at the age of 42.

Hutchins grew up in the Soviet Union, where she studied journalism. In her early career, she worked on investigative films before moving to Los Angeles to pursue a Hollywood career.

Hutchins began working in production while studying cinematography, and she quickly began gaining respect in the field. Her credits as cinematographer or director of photography include "The Mad Hatter" and "Blindfire" as well as a number of short films and the upcoming "Rust," on which she was working at the time of her death.

2019, American Cinematographer named her one of "10 up-and-coming directors of photography who are making their mark." The same year, Hutchins won the award for Best Cinematography at the English Riviera Film Festival for her work on the short film "Treacle.'

In Hutchins' memory, friends and colleagues established the Halyna Hutchins Memorial Scholarship Fund at the American Film Institute's Conservatory.

> Bisoglio's early movies include "No Way to Treat a Lady," "The Hindenburg," and an uncredited role in "Serpico." On TV, he made early appearances on "Mayberry, R.F.D.," "The Mary Tyler Moore Show," and "All in the Family."

In 1973, he took a regular role in the short-lived sitcom "Roll Out," and he went on to notable appearances on "Kojak," "Police Woman," and "Barney Miller."

A big break came for Bisoglio in 1976 as he was cast as restaurateur Danny Tovo on "Quincy, M.E.," a regular role spanning the show's entire eightseason run. Another notable role came in 1977's "Saturday Night Fever," in which he played Frank Manero Sr., father of John Travolta's character. It was followed by another big screen role, playing Chief Gray Cloud in "The Frisco Kid."

In 1981 and 1982, Bisoglio appeared on several episodes of M\*A\*S\*H" as Sgt. Sal Pernelli, also known as The Cook. After appearances on "Hill Street Blues" and "Miami Vice," Bisoglio's final acting role was in "The Sopranos," playing aging mob capo Murf Lupo.

#### Joanna Cameron, actress starred in own TV sitcom

Joanna actress best known for starring in the 1970s TV show "The Secrets of Isis," died Oct. 20 of complications of a stroke at the age of 70.

Cameron launched her acting career with a small role in the 1969 movie "How to Commit Marriage." She went on to have roles in movies including "B.S. I Love You" and "Pretty Maids All in a Row" as well as on TV shows including "Columbo" and "Marcus Welby, MD."

In 1975, she was cast as the title character in the Saturday morning superhero series "Isis," which was renamed "The Secrets of Isis" in syndication. The liveaction show featured Cameron as a high school science teacher who could invoke the powers of the Egyptian goddess Isis and use them to fight crime.

The series lasted two seasons and included crossover episodes with "Shazam!"

Cameron appeared TV shows and commercials throughout the 1970s, as well as hosting the show "Navy Network" for the U.S. Navy, before stepping away from as a nurse and in marketing.

#### Peter Scolari, co-starred in 'Bosom Buddies' with Tom Hanks

Peter Scolari, an actor who starred as Henry Desmond on "Bosom Buddies" and as Michael Harris on "Newhart," died Oct. 22 of cancer at the age of 66.

Scolari got his big break starring alongside Tom Hanks in the 1980 ABC sitcom "Bosom Buddies." Featuring its two stars as young men who dressed as women in order to live in an affordable women-only building, sitcom often improvisation from Scolari and Hanks.

Though it was popular with audiences, "Bosom Buddies' lagged after several schedule changes, and it was cancelled after two seasons. Scolari went on to star as the yuppie TV producer on "Newhart," starting in a recurring role but being added as a main character after a season.

The two 1980s sitcoms proved be the height of Scolari's career, though he continued to work regularly for the rest of his life. He starred in the short-lived sitcoms "Family Album" and "Dweebs" in the 1990s as well as in the syndicated sitcom "Honey, I Shrunk the Kids.'

won a Primetime Emmy Award for Outstanding Guest Actor in a Comedy Series for his recurring role as Tad Horvath on "Girls. He also had recurring roles on "Gotham" and "Evil" as well as in the miniseries "Madoff" and "Fosse/Verdon."

Thus, changes to the categories and redesignation of properties on the land use map







