

Downey hosting intimate blues concert

A trio of notable blues musicians is performing in Downey this Saturday night.

DOWNEY - "We're hoping to create another night of magic," says Alistair Hunter, referring to the Roots & Blues event scheduled at the Epic Lounge this Saturday, Nov. 6.

Hunter, who is the current president of the Downey Arts Coalition (DAC), and fellow blues fan Greg Miera brain-stormed about an evening of music now that many pandemic restrictions were lifted and performance venues were allowed to reopen.

Miera, a Downey resident for over fifty years, often serves as deejay or emcee at various blues festivals and has a podcast called "Reverend G Blues Hour."

"Many blues venues have dried up; there aren't as many as there used to be," says Hunter. "The pandemic has had an effect." Hunter hopes that DAC, a nonprofit group supporting the arts, will be able to schedule more music events in the future and "provide artists with opportunities."

Hunter and Miera describe Saturday's program as exceptional line-up of an performers: Nathan James, southern California roots and blues guitarist who toured as a teenager with James Harmon; TJ Norton, singer/songwriter and blues harmonica player from the UK; and R.J. Mischo, an ernationally

DOWNEY – It was a night for the ages at the annual Warren-Downey high school crosstown football game.

"So many of these boys played on the playground together and elementary school and now they get to take the field against each other."

blues harmonicist.

"This show is a very rare event," explains Norton. "To get the three of us each doing a solo act in one night is not likely to happen again."

"I hope people will come away with the experience of having seen something unique and that's more stripped down and rootsy than electric blues," says Norton.

These artists, says Miera, reflect "the core of the blues."

The Epic Lounge, known for its intimate, gritty atmosphere, is an appropriate venue for this music born in the deep South.

"This will be like playing in a juke joint," Hunter recalls Norton telling him after a tour of the venue.

Norton's personal story reflects the worldwide impact of American roots and blues music. Norton's grandfather was a "boogie piano player in the pubs and clubs of east London." His father and uncles "were very much into jazz and blues, and the British blues explosion in the '60s onward."

Norton's interest in the harmonica was particularly piqued when "I heard someone locally play a train impression on a harmonica, and I didn't understand how he could get that amount of sound out of that small, little instrument." Norton is self-taught and plays by ear.

Southern California musician Nathan James, who grew up in Fallbrook, also describes himself as self-taught. He has toured internationally, is known for his signature handcrafted washboard guitar, and often performs with his band The Rhythm Snatchers.

Robert J. Mischo, from Wisconsin, attributes his musical path to the impact of hearing a Muddy Waters concert. He has released twelve albums and his music has been aired on film scores, television commercials, and documentaries on the Discovery Channel.

It was the fourth consecutive year that Warren has defeated Downey and second league championship in a row for the Bears.

Warren opens the 2021 playoffs with a CIF-SS first round game in Division 2 at home Friday, Nov. 5, against Corona del Mar (8-2).

Downey will travel to play Glendora (10-0) at Citrus College in a Division 3 game.

"Just these guys coming together and playing the way they do, is just a beautiful thing," Warren third-year coach Kevin Pearson said. "When I first got here, I said it was the best kept secret in high school football in Southern California. Just the energy from the crowd and students is amazing and unbelievable.

"Downey is a good team and well-coached and they play hard. You can never count them out the way they play. Hats off to them.

"The city of Downey has something special here and it's been a hidden gem for a long time.

"(Nicholaus) Iamaleava is a special young man. He's a special talent, but he's a special young man. I love him so much and the sky's the limit for him. We have a bunch of great young men."

Warren was 6-6 junior five-Iamaleava (20 for 28) with 222 yards and a touchdown. The touchdown pass by Iamaleava was his 33rd of the season against only one interception. He also ran for a 12-yard score.

Warren totaled 425 vards overall, while Downey had 410.

Downey (8-2, 4-1) was led by senior quarterback Noah Paez (19 for 30) with 325 yards and touchdown pass. He also ran for 21 yards.

Senior running back Antonio Ruiz carried the ball eight times for 52 yards for the Vikings.

Downey senior Isaiah Blair caught five passes for a gamehigh 174 yards, while junior wide receiver Bryant Carey had eight catches for 106 yards and a 13-yard touchdown reception.

Keion Andrew (6 carries for 16 yards) rushed for a 2-yard score for the Vikings and junior kicker Isaac Madrid kicked a 23yard field goal.

On the Bears' first drive of the game, they started near midfield and marched right down the field, as Iamaleava opened the game with a 15-yard pass to Higgs and four rushes later he was in the end zone just barely two minutes into the game.

Downey opened the third quarter with a three-minute, 55-yard drive that stalled at the 6-yard line, ending with a 23-yard field goal by Madrid, to trail, 14-10, with 8:49 left in the quarter.

Foot Locker expands footprint in Downey with new store

The new store across from Stonewood Center is a newer concept for Foot Locker.

DOWNEY – After more than 20 years at Stonewood Center, Foot Locker has picked up and moved across the street, establishing its own footprint in Downey while also taking the opportunity to expand.

Ken Side, West Coast Vice President of Foot Locker, said that Foot Locker was formerly "a part of the Stonewood mall, not a part of Downey."

"What we've done, this is what we call a community store," said Side. "As a national brand, we have been primarily mallbased. As we look at the cities... the first thing we looked at in LA, we said, 'We're not where the people live.' We're making them drive to malls."

According to Side, moving from the mall into its own space allows Foot Locker greater opportunity to offer more to the community, both in product and local involvement.

In addition to the usual shoes and other street wear products, the store includes a "homegrown section," which features the brands of local creators.

"One of the things we do when we first come in... we set up a focus group. We reached out to the mayor, Claudia [Frometa], and some of her folks, and we said 'Hey, we want to meet with Firestone Blvd.

you.' We reached out to some local entrepreneurs, restaurants, businesses, and some local artists, musicians. We said, 'Before we come here, what should we do? We want you to tell us flavor.""

"The mural up top was done by a local artist [Daniel Antelo]. All these brands are local; some are from Downey, some are from Lakewood, but they're local."

Side added that the store hires locally as well.

"I quote that we're about 80% local; I think we're way above that here," said Side.

Side says that the store is for "the families of Downey, not the sneaker heads of Downey."

Rental prices climb 9.5%

DOWNEY - Downey rents have increased 1.3% over the past month, and have increased sharply by 9.5% in comparison to the same time last year, according to an analysis by Apartment List.

Currently, median rents in Downey stand at \$1,557 for a one-bedroom apartment and \$2,031 for a two-bedroom.

This is the seventh straight month that the city has seen rent increases after a decline in March. Downey's year-over-year rent growth lags the state average of 12.8%, as well as the national average of 15.8%.

Throughout the past year, rent increases have been occurring not just in the city of Downey, but across the entire metro. Of the largest 10 cities that Apartment List has data for in the Los Angeles metro, all of them have seen prices rise.

Irvine has the most expensive rents in the Los Angeles metro, with a two-bedroom median of \$3,579; the city has also seen rent growth of 31.3% over the past year, the fastest in the metro.

Long Beach has the least expensive rents in the Los Angeles metro, with a twobedroom median of \$1,932; rents increased 0.7% over the past month and 9.0% over the past year.

Texas' abortion ban is a roadmap to privatized oppression

Texas Solicitor General Judd Stone this week told the Supreme Court that people who object to his state's abortion ban would have a chance to challenge it — eventually. But as Justice Elena Kagan noted, the process that Stone had in mind could take "many years," during which time the law, S.B. 8, would continue to have a severe "chilling effect" on a right the Court has long said the Constitution guarantees.

That prospect clearly troubled the justices, including several who take a dim view of the Court's abortion precedents, because they recognized the broader implications. The strategy embodied by S.B. 8, which is designed not only to evade pre-enforcement review by federal courts but also to delay any definitive ruling on the law's constitutionality by state courts, can easily be adapted to attack any right that state legislators view as dangerous or inconvenient.

S.B. 8, which took effect on Sept. 1, prohibits abortion after fetal cardiac activity can be detected, which typically happens about six weeks into a pregnancy. Instead of charging state officials with enforcing its terms, the law authorizes "any person" to sue "any person" who performs or facilitates a forbidden abortion. It promises plaintiffs, who need not claim any personal injury, at least \$10,000 in "statutory damages" per abortion if they win, plus reimbursement of their legal expenses.

Although S.B. 8 is plainly inconsistent with what the Supreme Court has said about constitutional limits on abortion laws, its novel enforcement mechanism means that anyone who tries to make that argument in federal court will have a hard time identifying appropriate defendants. The Court grappled with that puzzle on Monday, when it heard oral arguments in two cases challenging S.B. 8.

Stone repeatedly noted that people who face S.B. 8 lawsuits can defend themselves by arguing that the law is unconstitutional. But even if a state judge agreed, the ruling would apply only to that particular case.

Under S.B. 8, such a decision would not stop lawsuits against

other defendants. It would not even stop lawsuits against the same defendant, who still could be sued in any of the state's 254 counties. And every one of those lawsuits would be a financial drain, since S.B. 8 does not allow prevailing defendants to recover attorney fees.

If a losing S.B. 8 plaintiff appealed, the case could ultimately generate a ruling with a broader impact. But for precisely that reason, anyone who supports the law would be disinclined to pursue an appeal.

The success of S.B. 8 does not depend on actually winning anti-abortion lawsuits, or even on filing them. The mere threat of expensive, unending litigation has been enough to dramatically curtail abortion access in Texas, where the number of abortions performed in September was down by 50% compared to the same month in 2020.

That reality explains why the Firearms Policy Coalition, which has no particular interest in defending abortion rights, filed a Supreme Court brief in support of allowing pre-enforcement challenges to S.B. 8. "Laws that deter or chill the exercise of constitutional rights violate those rights," it said, warning that state legislators could use similar laws to undermine Second Amendment rights, religious liberty or freedom of speech.

That fear was echoed by Chief Justice John Roberts and Justice Brett Kavanaugh, who are hardly fans of Roe v. Wade. If anyone who "sells an AR-15" or who "declines to provide a good or service for use in a same-sex marriage" were "liable for a million dollars to any citizen," Kavanaugh wondered, would federal courts still be powerless to intervene before such lawsuits make their way through state courts?

Stone conceded that his argument against blocking enforcement of S.B. 8 did not hinge on the nature of the constitutional right or the size of the bounty. Although he gets points for consistency, this invitation to privatized oppression should give pause to all Americans, no matter how they feel about abortion.

We're out of Afghanistan. Good. We should have gotten out before.

Our involvement there was America's longest war, longer than the Civil War, World War I and World War II combined. We accomplished little good and plenty of bad. Tens of thousands killed. A trillion dollars spent.

Now the Taliban wear American uniforms and fly American planes.

Hawks say, "If we just stayed a little longer ... "

It's not true.

Yes, there had been a drop in violence in Afghanistan. But that did not mean we were winning. The Taliban were just waiting because former President Donald Trump announced we were going to leave.

Now what?

Will we continue to try to police the world?

Probably.

Washington defines U.S. national interests so broadly, says the

At least in Afghanistan our government did try to limit American involvement. Instead of having U.S. soldiers fight ... forever, America would train and equip Afghans so they could defend themselves.

We spend more on defense than the next 10 countries combined.

But that didn't work either.

The U.S. spent \$200 million trying to teach Afghan soldiers to read. Five years later, half still couldn't read.

Corner curb parking

Dear Editor:

Corner-curb parking — that is, parking on the curve of street corner at an intersection — seems to be growing in prevalence in residential areas of Downey. I'm not sure when this became "a thing," but it is a fairly recent and, I think, undesirable development.

Of course, corner-curb parking is the result of the city's increasing population and a trend toward residences housing larger and larger extended families. There is just not enough parking for all of the additional cars, and so corner-curb parking — once considered unacceptable and some cases illegal — has become common place.

In today's overall scene of things, this might seem like a minor issue. Yet, corner-curb parking leads to at least three serious, real-world safety problems.

1. It can create dangerous visibility issues for motorists. Corner-curb parked automobiles—particularly high-profile vehicles such as vans and pickups—can block the normal lines of sight when it comes to cross traffic. It can result in a blind intersection in which a driver needs to ease out into traffic lanes just to see if any cars are approaching, especially from the left side. Auto collisions, injuries and even deaths are tragic byproducts of corner-curb parking.

2. It blocks the way for pedestrians trying to cross the street at corners. Adults and children alike must slide around the corner-curb parked car, a dicey practice that makes crossing the street at an intersection more dangerous than it already is.

3. Able-bodied pedestrians might walk around a vehicle blocking a sidewalk corner, but physically challenged individuals might not have that option. I regularly see parked cars completely blocking wheelchair-access ramps on residential street corners, and I find it abhorrent that any motorist would find it acceptable to park in such a manner. Wheelchair-bound individuals must turn around look for another, possibly more dangerous way, to cross the street.

With this in mind, I call upon the Downey City Council and Downey Police Traffic Unit to take two simple steps to minimize corner-curb parking, including:

A. Making all corner-curbs no-parking areas, and designating the curbs with red paint to alert drivers that each is off-limits to parking at any time.

B. Step up enforcement, issuing parking tickets to any vehicle found parked on a street corner, with even greater fines for those blocking handicapped access sidewalk ramps on corners.

In my new video, Cato defense analyst Eric Gomez explains why Congress never does anything about that.

"A lot of members of Congress don't want it fixed," he says.

Defense contractors cleverly produce weapons in different states. Lockheed Martin boasts that F-35 parts are made in 48 states.



As Christians say, please love thy neighbors. Let's not make this house rattling the new normal of life.



Downey's Dia de los Muertos Festival a visually stunning experience

■ Thousands attended Dia de los Muertos in Downey, celebrating the lives of those who have past on.

DOWNEY – A giant altar of marigolds greeted festival patrons at this year's Dia de los Muertos Festival.

As the artistic focal point and the first thing you see as you enter from the Firestone side, the Downey Community Altar, Ofrenda a la comunidad de Downey, sits in the newly designed plaza that fronts the Downey Theatre, labeled for the day the Plaza of Memories, or, Plaza de Recuerdos. Downey families, with babies in prams, seniors on walkers and even dogs pulled in carts, came to enjoy the sunny afternoon.

It's Downey's eighth Festival of la Dia de los Muertos, and marigolds are the signal flower. The fragrance of these bright orange and yellow flowers is said to lead souls on this day from their burial place to their family homes. And this day is above all a family time, to celebrate lives of ancestors, and to enjoy the life of today.

Cempasúchi is the Aztec name of the marigold native to Mexico, and they were everywhere. An art gallerygoer wore a hat brimming with marigolds, and artist Caroline Estrada-del Toro wore a long painted marigold metal necklace and earrings from Nyarit, her native state in Mexico.

The Plaza Altar was built by seventh generation altarista Rosanna Esparza Ahrens, the daughter and protégé of Ofelia Esparza, the grande dame of L.A. altar making. In it were placed family photos that Downey residents contributed, to make it a real ofrenda.

Presented by the City of Downey and the Downey Theatre, the Festival this year featured an art show at the Downey Theatre, put on by the Downey Arts Coalition. Involving the Downey Arts Coalition was the idea of Festival co-producer and Downey Theatre Manager Amber Vogel Shaver, who reached out at the first Festival to suggest a partnership. The theater lobby spotlighted three large ceramic pieces by Jorge del Toro, featured artist for the show

Downey's Festival is recognized as one of the Southland's most outstanding, due in part to the indoor/outdoor setting, and also to the overall presentation that includes color-coordinated booths and decorations. The sky had cleared to a bright blue after rain earlier in the week, and the temperature was in the 70's. The day that began with plumed Aztec dancers in the Civic Plaza would end with a ticketed performance in the Downey Theatre by the Mariachi Divas.

"I'm Jorge's greatest fan," said his wife Carolina Estrada-Del Toro, pointing to a Certificate of Recognition. "State Senator Bob Archuleta was here just an hour ago and presented this to Jorge, from the California Senate, for being 'an inspiration to all who view his creations.'" Alistair Hunter, also received a citation as president of the Downey Arts Coalition "on its 10th anniversary, for providing a place for artists to thrive."

We rode the swift new glass elevator neatly tucked into the wall up to the Theatre's balcony level and the Mezzanine Gallery, to see the rest of the art show. DAC Curator Andrew Hernandez assembled a wide variety of works, which includes Jorge del Toro's pastels and smaller sculptures, as well as works from newcomers Wendy Hernandez and Maricela Avina.

Pat Gil, project coordinator and vice president of the Downey Arts Coalition that presented the "Ofrendas" art show,

pointed out that Hector Silva, Pinchi Michi, Carolina Del Toro, and Polaris Castillo were also included.

Ofrendas are said to be a bridge between two worlds, and the walls were decked with paintings, and a trio of painted and hammered repousse tin portraits that shone in the light.

Jorge was standing beside a ceramic piece of a tiny skeleton jaguar carrying on its back its prey, a large fully fleeced sheep, one of his many more pieces and paintings. "I love to do this," Jorge said," and I'm glad the community can see so many of my pieces today."

Jorge was wearing a shirt printed with tiny skulls and a necklace of gray beads with a carved jade skull, in honor of the day. Some of his works were too big to be fired in one piece, and had been fired separately and fitted together. Bringing them and setting them up for the oneday show must have represented a lot of man-hours. Wife Caroline stood nearby, lightly repositioning the sculpture.

The Gallery was a busy place. Frank Kearns stopped by to chat. And a dog walked by on a leash, wearing a collar of marigolds as we descended in the same outside glass elevator with its view of the Plaza.

The theme of the exhibit was "ofrendas," a term meaning offering or gift, usually refers to a home altar with a collection of objects placed on display during the annual and traditionally Mexican Día de los Muertos. The tradition is said to originate with the Aztecs, on the night when the spirits of the departed can pass freely between realms of the living and the dead.

El Dia de Los Muertos is a family affair, a celebration of life and a time to honor those generations that have already passed. That dancing skeleton in black lace mantilla and roses? She could be your abuela. That skeleton in a black top hat and

cane? Tio Marco.

Altars are intended to welcome back the departed, and most have candles and pungent flowers like marigolds to help the spirits find their way, as well as their favorite food and drink and personal belongings. A glass of water, because they will be thirsty after their long journey. The artists in the show showcased a variety of imagined returning spirits.

The traditional icon, the Calaveras Catrina, comes from a skull caricature drawn about 1910 by the Mexican illustrator Jose Guadalupe Posada. Posadas's satiric version of high society, soon to be toppled by the Mexican Revolution, had figures, regardless of occupation, class or status, that were represented with skulls for faces. So skeletons are dressed in fancy turn of the 19th century finery.

In the Hispanic culture, children are not sheltered from the reality of death. Children attend funerals regardless of their age. Death is talked about openly. With these caterinas, youngsters are taught how to mock death.

The Theatre lobby was brightly decorated with its colorful posters. On the patio live music was playing, and a beer and wine garden was open. Outside on the plaza again, families strolled through the pedestrian area that had been created in the parking area of the Civic Center. One promenade was for speciality food trucks, and the Taco Cartel trailer stood next to pupusas, French Crepes Bonaparte, and The Only Puerto Rican Food Truck in Los Angeles. Music from the Theatre patio drifted over, and the city had thoughtfully provided picnic tables and benches.

In front of the newly reopened Downey Library, the Friends of the Library had placed carts of books, gently used, at bargain prices: 50 cents each, three for a dollar. Virginia Yoshiyama, president of the Friends, said the carts were filling and refilling. The bright tangerine-tiled façade of the Library fit perfectly with the colors of the day.

Another avenue with the banner Mercado was lined with bright white pavilions selling artisan jewelry and decorated tee-shirts. Calaveras y Diabiltos said another that sold skull masks. Most people dressed casually but many girls and women had caterina makeup, white face with sugar skull designs, and fancy floral gowns with ornate headdresses. Everyone was masked, except the tiniest.

A few children wore their Hallowe'en costumes, and Wonder Woman, Superman and Spiderman pranced around. But the Dia de los Muertos is far from being a "Mexican Hallowe'en." This same night before All Saints Day is also celebrated in northern Europe, as a time when spirits walk among the living, yes, but with faceless, formless and frightening ghosts, creatures with no name and alien to humans.

The altars are the heart of any Dia de los Muertos, and are composed with love, honor and respect. Walking beyond the food and the mercado area, we find some outstanding examples of a special kind. In the parking lot area around the Legacy Church (formerly the First Baptist), were car altars. Built in opened car trunks and growing out onto the pavement, these were more concentrated and personal, with the floral arches and photos of the departed in happy times with stuffed toys and live balloons. The mood everywhere was festive and happy and still respectful.

Back at the Embassy Suites side of the Theatre Plaza, families gravitated for picturetaking to a trio of giant caterinas made of papel maché.

The three glamorous skeletal

ladies, each easily eight feet tall, stood on a bed of marigolds, their skull heads wearing gracious hats, and one carried a black lace parasol. Toddlers were posing next to these extravagant figures, and one elderly lady was helped out of her wheelchair so she could stand beside them too.

These grand ladies of the afterlife, the emblem of Day of the Dead, tie together the times and their interpretation of death. It has been said that their elegant dress suggests celebration, the smile reminding us that there is perhaps comfort in an acceptance of mortality, and that the dead should be commemorated, not feared.

The marigold arches on the Theatre Plaza had little lights looped in them, and the scene would soon become enchanted in the evening. The stately palm tree trunks were festooned with garlands of marigolds and 5-ft. wide butterflies.

I left while there was still daylight, but the shadows were growing long over the Plaza of Memories, El Plaza de Recuerdos.

Downey Symphony's opening concert enthusiastically received

• Downey's professional symphony orchestra returns to a standing ovation.

DOWNEY – A live orchestra and a lively audience combined for a triumphant return of the Downey Symphony Orchestra on Oct. 23. On Saturday evening, under clear cool skies, the line for the box office extended out onto the Plaza in front of the Downey Theatre.

Symphony concerts were back, and an audience for hardcore classical music was there to hear it.

A remarkable number of six past presidents of the Downey Symphonic Society were there to mark the occasion of the concert: Nick Frankhart and his wife Mary, a Downey native, came up from Long Beach, and Ryan Keene and Larry Lewis both from Downey, arrived; Don Marshal, now in Fullerton, under whose lead the audience had grown considerably and the Symphonic was able to realize significant new grants and contributions. Beginning in the 1980's, when I was president, the line stretched for nearly 40 years ago to the present.

Bill Hare, president in the '90s, made a surprise appearance, having recovered from an unexpected and severe attack of COVID 19, in spite of being fully vaccinated. Bill's wife, Katie, used a slick triwheeled scooter to enable her to be mobile after foot surgery.

"It came all of a sudden," said Bill, speaking of the Covid. "One minute you're ok, and then pouf, and you're really sick."

"We tested negative twice before we came tonight," said Katie.

"I'll hold my breath and I take my mask off while you take



the picture," said Bill. The Hares' daughter, Janet Molinaro, was there, with buddy Christine De la Torre to represent South Gate.

Hard-working board members of the Downey Symphonic society were in full force, led by Joyce Sherwin managing the events in the lobby and sporting a white moustache imprinted on her black mask. Mary Stevens and JoAnne Gronley handed out programs at their table center lobby, and Bob Goldstein held the fort in one corner of the lobby.

Former Board member Carol and Frank Kearns never miss a performance, and daughter Amy and her beau attended too, as did Dorothy Pemberton, Jeff Parks, and many friends of classical orchestral music, many more whose names I don't yet know.

Ruth Hillecke, longtime member and donor of the Hillecke Matching Grant for the Music in the Schools program, mentioned that she had not received her renewal form for tickets until mid-October. "I came right down to the box office and got my tickets for my regular seats, Ruth said.

Ruth understood that putting on the season was in doubt until the latest possible moment, as the Downey Theatre could not be sure that audiences would be allowed, or under what terms until the County Health Department made their announcement. Everyone cheerfully abided by the masking request, and wore them during the musical program as well as in the lobby, when there was close contact with other patrons in the lobby.

I took the new glass elevator for a fast ride up to the balcony level, where the Downey Arts Coalition staged a show, "Key," curated by Pat Gil, that Downey artists came to see. Director of the Stay Gallery on Downey Avenue, Gabriel Enamerado and Juliana Canty, stopped to talk with Alistair Hunter, DAC president. Monique Pucciarelli stood beside her entry, Monique's russet hair matching the trailing plumes and feathers in the painting.

Among the many entries, featured artist Carolina Estrada-Del Toro and husband Jorge also gathered a group of admirers,

Caroline wore black with a bright red satin scarf: "I always put a touch of red in my paintings," Carolina said.

Before the concert began, DSS President Anthony Crespo greeted the audience from the stage, and announced the dates of the next two concerts, January 22 and April 9, 2022. Tickets are available now at the Theatre's box office. Lars Clutterham read the name of each artist in the DAC show and recognized them by asking them to stand.

The concert was about to start, and conductor Sharon Lavery gave the downbeat for a rousing National Anthem, heavy on the percussion. Then as we settled down again, Oscar Navarro's Downey Overture began, with a thrilling brass summons that sounded like an alarm clock starting the day. Then sounds of freeway traffic as Oscar commuted from Downey to the USC School of Music. But wait, the traffic music was dancing, and the violins sounded like mariachis. The syncopated beat carried the piece right to the ending.

The Bruch Violin Concerto Number 1 began with Strauss Shi performing its virtuoso cadenzas. The orchestral sonority was punctuated time and again by the rich song of the violin. The piece was scored for only one percussion, the timpani, but timpanist Danielle Squyres played all four of the kettle drums, each tuned to a different sound, to rousing effect.

How many shades of black there can be, I mused, from the sparkly sequin jacket of concertmaster Carolyn Osborn's jacket to the patent leather shine on the shoes of the first violin section. There was the quieter matte finish of most of the men's suits, but the transparency of a black tulle sleeve and the richness of a black brocade on the women gave different plays of light, just as the themes taken up by the instruments combined for a tapestry of orchestral sound.

At the end of the piece, Strauss received a standing ovation, three curtain calls and two bouquets of flowers from admirers in the audience. One floral tribute he gave to Concertmaster Carolyn, and the second offering to Principal Cellist Mary Anne Steinberger. Shi was obviously delighted to be back playing in Downey, and he exchanged elbow bumps with masked Carolyn, and conductor

Sharon, and then rewarded and delighted the audience with more fireworks, a solo encore.

Coming into the lobby for intermission, we greeted Mark Artusio, beloved but now retired principal bass player. Mark managed the orchestra under Dr. Tom Osborn, and then completed 12 seasons with Conductor Sharon. A heartfelt tribute to Mark was in the printed program.

Mark asked about the DSS's Music in the Schools outreach program, his special project for many years, where a quintet from the orchestra goes to each elementary and middle school in Downey, to perform a program that enriches their comprehension of music. Unfortunately, this year, as last, the schools don't feel it is safe yet for an outside group to come on campus. But the Downey Symphonic Society Board is still hoping there will be a way to perform the third grade and fifth grade concerts that take place in the Downey Theatre, with the School District bussing in the children.

Old and new names were also printed in the program as individual contributors. Corporate, Foundation and Foundations. Our thanks to all.

The handsomely produced glossy program also featured an In Memoriam page, where donors remembered those who had devoted themselves to the Symphony, faces we missed on this night: Karol Morrison, Harold Tseklenis, Joseph Sapia, and Pauline Hume. There was also a pictorial tribute from the Downey City Council Members. The City of Downey is a strong supporter.

The lights in the lobby flickered and the gong sounded, calling us back for the major piece of the evening, Dvorak's Ninth Symphony in E Minor, Coming to the New World. The richness of the opening sounds give way to the nostalgic melody known as the spiritual Goin' Home, and that theme with variations reappeared throughout.

This orchestra had not played together in a concert hall for over 18 months. Indeed, the members hadn't played anywhere for 18 months.

"At the first rehearsal," said Conductor Lavery, "I was stunned. The orchestra played with so much heart. I have never felt anything like that anywhere before " At the conclusion, Maestro Sharon, as usual, did not take credit personally for the applause. After gesturing for the entire orchestra to take several bows, she then pointed one by one to each brass instrument and wind, and the percussion section, for individual applause.

She then swept around, conducting the applause as well as she had the musicians. cuing in first the bass players, then the cellos and the violas, before finally indicating the outstanding first violins and then asking the audience to laud once again the ensemble. She stood with open arms, as if to say, "This is your symphony orchestra."

All the while Lavery remained, not on the podium but with the musicians and behind a music stand, so that the audience and the orchestra could face each other and bask in their mutual admiration. A professional oboist in the audience said to a Board member that it began with the warmth she felt among the musicians and the appreciation between players and Sharon.

"The love, she said, "was palpable and the performance excellent."



Downey candlemaker emphasizes importance of health checks

 Marcella Gomez was inspired to start a candle business after a cancer scare.

DOWNEY - Marcella Gomez was a "healthy 48-year-old." Sure, she wasn't running as well or far as she usually did on her jogs along the riverbed, but it was a stressful time. As a mother and a nurse in the middle of a pandemic, she was working hard, and was understandably fatigued.

Besides, it wasn't the first time she had ever found a lump.

Gomez, now 49, allowed herself every excuse in the book not to get checked.

"Shame on me because I sat on it for two to three months," said Gomez. "I put it aside because I took care of other things, there were other issues occurring. That could have cost me.'

She got the call from her doctor on Oct. 20, 2020. It's a day Gomez now says she will never forget.

"She said the words you don't want to hear: you have cancer," said Gomez.

Gomez counts herself as one of the lucky ones; her cancer was discovered early, and the process of dealing with it began swiftly

"Kudos to Kaiser...I went to a place called the Breast Center; they did the ultrasound and the mammogram that same day, and that's when they realized [the cancer] had spindles, and they got the process going. Oct. 20 they told me I have cancer. By the day before Thanksgiving, I already had a mastectomy."

"I feel I'm lucky because it's Stage 1, it didn't spread. Even though I sat on it, I'm lucky."

As she continued to face her cancer, Gomez found comfort in another endeavor: making candles.

Gomez started Oh Camadre Candles in her garage in 2015. She says that making candles is "like a therapy."

"I started making candles as a form of therapy for my nursing job," said Gomez. "It's with them because the candles



celebrate life."

"I want them to evoke emotion, maybe memory, comfort, even a laugh."

To her surprise, Gomez's candles would draw a whole new supportive community to her side.

"One interesting thing about the candles is I post them, and I developed a social media following," said Gomez. "Social media gets a bad rap... but in my a form of release. I have fun case, when I was diagnosed with cancer, these virtual people

that follow me, not only did they pray for me, they'd send me messages, they'd send me flowers, they'd send me cards."

Gomez, now in remission, wants to emphasize the importance of routinely getting checked.

"What I want to say, for my fellow women, men too, is to check themselves," said Gomez. "If you find it early, your prognosis is good. Don't be afraid."




