U.S. restricts overseas travel

■ Concerns over the new omicron variant prompt international travel restrictions.

The U.S. is enacting travel bans in an effort to limit the spread of the new omicron variant of the coronavirus, which the World Health Organization warns poses a "very high" global

Starting Monday, President Biden has imposed travel restrictions non-U.S. citizens from the following eight countries:

Botswana Eswatini Lesotho Malawi Mozambique Namibia South Africa Zimbabwe

The European Union, Canada, United Kingdom, and Israel have announced travel restrictions from southern African countries

Some health officials and public health experts caution that travel restrictions alone may not be effective in controlling the spread of infectious disease, and could even have harmful effects, like exacerbating xenophobia and deterring countries from being transparent about the state of the virus in the future.

The variant was first reported last week in South Africa, where vaccination rates are about 24%.

Cases of the omicron variant have since been confirmed in Botswana, the United Kingdom, Italy, Germany, Belgium, Israel, the Netherlands, Australia and Hong Kong.

Biden is encouraging children and adults to get vaccinated against COVID-19.

"This pandemic will not end until we have global vaccinations," he said last week in a statement.

In an address on Monday, he said the variant is "a cause for concern — not a cause for panic."

"The best protection against this variant or any of the variants out there is getting fully vaccinated and getting a booster shot," he said.

Biden said scientists didn't think that extra measures would be needed to fight the new variant, but he added that his administration was working with vaccine manufacturers to develop vaccines or boosters against omicron if needed.

He said he will also direct the Food and Drug Administration and the Centers for Disease Control and Prevention "to use the fastest process available without cutting any corners for safety" to get such vaccines approved and on the market.

He said that science adviser Dr. Anthony Fauci believes the current vaccines provide at least some protection against severe disease.

U.S. health regulators last week expanded the eligibility for booster shots of COVID-19 vaccines to all adults aged 18 and older either six months after their initial Pfizer or Moderna vaccine doses or two months after their Johnson & Johnson (JNJ.N) shot.

The CDC, however, stopped short of saying all adults aged 18 to 49 should get the additional

Amid the renewed emphasis, Pfizer and partner BioNTech are expected to ask the U.S. Food and Drug Administration (FDA) in the coming days to authorize their booster shots for those aged 16 and 17 years, the Washington Post reported on Monday, citing

Demolition looms for south Rancho buildings

■ L.A. County officials have set aside \$28 million to demolish more than 100 buildings on the former nospital campus.

The redevelopment of Rancho Los Amigos National Rehabilitation Center's abandoned campus pressed onward last month when the Los Angeles County Board of Supervisors greenlit the demolition of over 100 buildings at the location.

The county-owned 74-acre property is located at 7601 E. Imperial Hwy. Its buildings have remained abandoned and in a continued state of decay since medical-related services were consolidated to Rancho's north campus in the 1980's.

As they stand currently, the south campus and its current buildings are incompatible with any county use, and restoration would amount to a costly \$300 million, county officials said.

Despite its dormant state, the site continues to demand approximately \$1.5 million in resources annually, as the county continues to spend on security measures such as fencing repairs, securing/boarding up of abandoned buildings, brush clearance, debris removal to remove fire hazards, and fire and police protection services including 24/7 patrol.

The deteriorating buildings also present a hazard for security



potential personnel and trespassers as many are structurally unstable and contain hazardous materials including asbestos, mold, and lead paint, officials said.

Of course, the south campus is already in the midst of a multifaceted, multi-million dollar development.

The \$468 million project includes development of up to approximately 650,000 square feet of floor area of new buildings to serve as headquarters for the County's Internal Services Department. Department, County offices, as well as two parking structures and necessary infrastructure improvements. Several of the existing buildings and structures will also be reused or retained as well, including the Casa Consuelo, power plant, water tower, and shop and laundry.

The Administration building which is currently occupied by the Sheriff's Department - will be retained with no alterations to the building or changes to its use. The historic Moreton Bay Fig Tree

Probation will also be retained.

The demolition of the 103 buildings slated to be knocked down does mean, however, that the site will lose eligibility as a historic resource; a sacrifice deemed necessary by the Board in order to achieve its objectives for the campus.

Stauffer Middle School, on Old River School Road south of Stewart and Gray Road, has a new library and updated locker rooms and PE facilities.

"The original administration building was in the middle of the campus," said Dr. John, "too far away from the entrance. For safety's sake, when visitors come on campus, you want the office at the entrance to the school, close to the parking lot and curb. So we built a new one, with bright new landscaping to set it off.

Sussman Middle School, on Birchdale north of the Imperial Highway, has a new library and a two-story 10-classroom building, and the same pluses in the locker facilities and PE rooms. A contemporary bit of design is the ombré, a shade-giving arch extending from the buildings.

"We serve 22,000 children at our campuses," said Dr. John, "plus the adult school. Similar improvements have been made at all of them, the 13 K-5's and the three high schools.

After Measure O was passed, watchdog Citizens ersight Committee Oversight formed, to ensure bond proceeds

"In my 30 years in public education," said Dr. John, "I have seen that a school structure can symbolize hope, opportunity, and stability for students. Perhaps the greatest impact of clean, safe, and inviting schools is that they show our students and teachers that they are respected and valued individuals."

The "new" normal at DUSD is looking even better than the old.

Robert Bly, Silence in the Snowy Field, Wesleyan University Press, 1962



He petitioned against school mask mandates and turned refusal to get shots into a political statement, negatively linking them to President Joe Biden. His Facebook page then became a clearinghouse for attacks by vaccine supporters. Some insulted and mocked him. Others left heartfelt sermons on the insanity of risking one's life in return for partisan hugs.

Biden's comments on climate change don't match his actions

The Biden administration, to its credit, never misses a chance to emphasize the importance of dealing with climate change. President Joe Biden calls it an "existential" threat to humanity. John Kerry, his special envoy on the issue, said in April: "That means life and death. And the question is, are we behaving as if it is? And the answer is no.'

That was certainly true under former President Donald Trump, who championed coal, abandoned the 2015 Paris agreement on climate and dismissed global warming as a hoax. Biden has brought a badly needed shift on policy. But his policies sometimes are at war with his rhetoric.

One crucial part of his agenda is speeding the transition from gasoline-powered vehicles to electric ones. Cars and light trucks account for 16% of all U.S. greenhouse gas emissions, and Biden wants half of all autos sold in this country to be electric or plug-in hybrids by 2030. That transition would significantly reduce carbon output.

But let's not get the idea that the administration is laser-focused on whatever it takes to curb climate change. Its enthusiasm for electric vehicles, it turns out, is not unlimited. In Biden's eyes, some electric vehicles are good and some are bad, and the difference has nothing to do with greenhouse gases.

The social spending and climate package recently approved by the House of Representatives would encourage Americans to buy electric vehicles by providing a tax credit of as much as \$12,500 for each purchase, an increase over the existing \$7,500 credit. That indirect

subsidy is needed because these cars generally cost more to purchase the national transition away from gas-powered vehicles — a hugely than comparable conventional cars.

But Biden and his congressional allies are not enamored of all electric vehicles. They want to restrict the full tax break to those cars that are built by union workers in the United States and have batteries built by union workers in the United States. Buyers of other vehicles would get only a \$7,500 credit — a \$5,000 penalty.

That penalty would apply to almost all of the 50 electric vehicles currently sold here, including every model made by Tesla, the Ford Mustang Mach-E, the Nissan Leaf, the Rivian pickup, the Hyundai Ioniq and more. The only exceptions are two Chevy Bolt models. It would also harm workers in U.S. plants operated by foreign automakers, which are nonunion and produce nearly half of all the

The discrimination is a giant favor to the United Auto Workers, a stalwart of the Democratic Party that has been weathering a major corruption scandal. "The union has stressed to the Biden administration that the country shouldn't sacrifice union jobs to meet its climate goals," reported The Wall Street Journal. A White House spokesman insisted that "jobs taking on the climate crisis must also be jobs that build the middle class."

There are some obvious flaws in the administration's logic. One is that given the monumental size of the battle against climate change, it is imperative to enlist every automaker, including nonunion ones.

To exclude nearly all electric cars from the full tax credit will make

formidable undertaking under the best of circumstances — slower and more expensive. It's exactly the wrong strategy if you place a supreme priority on saving the planet from excessively high temperatures.

The UAW has repeatedly lost elections allowing workers at foreign-owned plants to decide whether to sign up with the union. Limiting the tax credit will hurt those workers. It will also encourage automakers to build electric cars abroad, where they can achieve lower labor costs — enough, perhaps, to overcome the tax disadvantage.

It will also be a boon to the internal combustion engine. As Jeffrey Schott, a senior fellow at the Peterson Institute for International Economics, told me, "If you raise the cost of electric vehicles too much, people will buy gas-powered cars."

The Trump administration refused to require any sacrifice from fossil fuel companies and their employees merely to avert the worstcase climate scenario. The Biden administration is willing to act against climate change, but it too insists on protecting certain groups at the expense of the broad American public — and all humanity.

Denying the full tax credit to the vast majority of electric vehicles will mean more carbon emissions and warming of the planet. But hey it's not like this is a matter of life and death, right?

Let's end the COVID-19 blame game

Over the summer, as Covid cases started rising from their midyear lows, it became popular to blame Republicans for fueling the pandemic. The argument was that Covid had become a red-state rather, once) the Omicron variant hits American shores. But here's scourge because of lower rates of mask-wearing and vaccination along with high doses of vaccine misinformation — in places that games. They're pointless, divisive and dumb. went heavily for Donald Trump.

It even seemed true for a while, with states like Florida, Alabama and Louisiana suffering from a huge surge in cases. But the virus has had a way of making fools of us all.

Take Vermont, which has one of the highest vaccination rates in the nation, and where Joe Biden took 66 percent of the vote. Because of the Delta variant's vigorous attack on even the relatively small number of unvaccinated Vermonters, the state has experienced one of the biggest recent Covid surges, with hospitalizations up by 24 percent in the past two weeks. In Santa Fe County, N.M., where Biden won with 76 percent and 74 percent of the population is fully vaccinated, hospitalizations are up by 40 percent.

You'll find similar trends in Hennepin County, Minn. (Biden, 70 percent), where vaccination rates are high; and in Wayne County, Mich. (Biden, 68 percent), where vaccination rates are relatively low.

Meanwhile, in Florida, Alabama, Louisiana and other red states,

cases have plummeted after earlier surges swept through, leaving many with immunity.

We'll see how long things will stay that way, especially if (or, a plea for when it does: Let's put an end to the partisan Covid blame

Consider the record of Covid score-settling thus far:

Covid is mainly a problem of the big cities! But then it became a tragedy for rural America. (And yes, this is me pleading guilty to a bad argument in the pandemic's early days, when I thought population density would be the main driver of transmission.)

The lab-leak theory is racist right-wing conspiracy talk! Um, except the argument is far from settled on whether or not it's true.

Andrew Cuomo is a model of crisis management! But then it turned out that the disgraced former governor was guilty of one of the worst political decisions in the early months of the pandemic, when he forced New York's nursing homes to take back patients who had been hospitalized with Covid, and later tried to cover up the blunder.

Ron DeSantis is a model of crisis management! The Florida governor did, in fact, do well in the early months of the crisis, when he focused state resources on protecting the elderly, only to later preside over a gigantic spike in cases.

Trump is responsible for hundreds of thousands of Covid deaths that might have been avoided if only someone else had been in the White House! But now Biden has presided over even more deaths, not that anyone should blame him for it.


Anti-vax myths are being driven by right-wing liars! But then people like Sean Hannity of Fox News and Christopher Ruddy of Newsmax urged people to get their shots, while the bulk of vaccine misinformation on social media came from characters like Robert F. Kennedy Jr., Rizza Islam of the Nation of Islam and other alternativemedicine quacks of mostly unguessable political views.

Germany is a model of intelligent consensus-driven action when it comes to public health! But vaccination rates among Germans are still relatively low, mistrust of government is depressingly high, and in a blizzard. cases are soaring.

Sweden is a model of good sense when it comes to lockdowns! Well, the Swedes, who avoided lockdowns, have fared relatively better than Spain or Britain, which locked down repeatedly. But, as Bloomberg's Justin Fox points out, the Swedes also fared considerably worse than their Scandinavian neighbors, who took stricter precautions.

The list goes on. There were those on the right who predicted an end to the pandemic based on expected herd-immunity thresholds. There were those on the left who foresaw an end based on vaccination rates. Nature — on the one hand viral and the other hand human embarrassed them both. If the Omicron variant is anything like the Delta one in its transmissibility, it will embarrass them again.







Things you didn't know about Downey

■ Remembering Hawkins Garden and the 101 Cafe, plus what life was like without modern conveniences.

By Bobbi Bruce **Downey Historical Society**

DOWNEY – The history of every community has included some colorful characters whose eccentricities left their mark in local memory long after their passing.

One such bellwether of the 1870s was a chap named Hawkins whose home, "Hawkins Garden" near Fulton Wells (now Santa Fe Springs), was renowned for its pools and sunken gardens.

Hawkins' favorite sport was driving spirited horses and he was master of the art of snaring chickens by the head with the lash end of his whip and jerking them into his wagon while going at full speed, much to the embarrassment of his wife.

Mrs. Hawkins was terrified of her husband's fast driving so when business took them to Los Angeles, he would drive her to the Downey depot and then go on alone while she rode the Southern Pacific trains.

Invariably when she arrived at the Commercial Street station in Los Angeles 45 minutes later, Hawkins would be waiting for her, having driven about equal distance over 12 miles of ungraded dirt roads.

On one of his whirlwind journeys, he lost their small son, who was riding in a basket in the back of the spring wagon. Later, when Hawkins discovered the loss, he backtracked and found the baby still in his basket and unhurt.

Life Before Cell Phones

The following story comes

from the "1873-1973 Downey Centennial Celebration."

Accustomed as we are to our modern conveniences, it is like looking into another world to peer back on the Downey that was with the life our modern utilities make possible -- and which we take for granted.

Downey today is served by 68,000 telephones in the General Telephone Company system, yet before 1884 there was only the telegraph, and for 13 years thereafter the entire community was served by one toll phone, first in a general store on Downey Avenue and later in a livery

The only gas in Downey before World War 1 came from a coal gas plant in Bellflower: In contrast, Southern California Gas Company today serves 28,600 connections in Downey, with a district headquarters here serving 228,000 customers in 18 cities covering 132 square miles.

The lighting in town was by kerosene or acetylene lamps until a string of electric lights in the central business section was turned on in 1900; Southern California Edison today has 102.8 miles of transmission and distribution lines spreading from five substations in town, serving 31,000 meter connections in Downey and representing a \$3.142 million investment within city limits.

Until Arthur Darby connected four windmills and water tanks to serve a tract of homes in the middle of town about 1902, the only water available came from hand dug wells in the yard, or by the old field irrigation system the long defunct Arroyo Ditch and Water Company had dug from the San Gabriel River for local

The first mutual water system in Downey started in 1925, serving 190 families. Four years later, the Downey County Water District was

formed with 600 water users, beginning the system which was taken over by the city in 1963 and today serves 12,000 connections over a grid of 200 miles of mains, covering half of Downey.

Today, 10 years after going into the water business, Downey has a long range goal of taking over the other six water utilities in the community to provide uniform water service throughout Downey. Negotiations have been underway intermittently for almost five years with the largest private operations, Park Water Company, which serves 800 connections. The remainder are relatively small, serving isolated pockets around the city's periphery, principally in the southern section of town.

The 101 Cafe

The following is from the Downey Eagle newspaper dated Oct. 22, 1993:

This December, the Downey Historical Society will have an open house which will include a tour of old Dismukes House.

In the house is a painting that hung in the old 101 Cafe. The 101 Cafe is just a memory now but to the boisterous survivors of the post World War II era, it was a home, saloon and even something of a chapel.


It was called the 101 because it was located at 101 Downey Ave., the lot at Firestone Boulevard that the Cardono Building now occupies.

Oldtimers will always remember the old bar's odor of stale beer and its shining steel bar rail.

After the bar's last gasp at the end of the roaring 1940s, it became a clothing store. Later, in 1986, the old building was torn down.

It was in 1949 the old

"I am the one who shot that man lying on the floor," bartender Edgar Gray told the deputy sheriff when he arrived. It was widely quoted in the papers.

On further questioning, the deputy said Gray told him he shot the customer because the man had repeatedly cursed at him.

Oldtimers nodded when they heard the explanation. It was right out of the Old West, and it fit the bar's aura, even to the Western painting of "The Night Watch" that hung on the wall.

Art Morris of Morris Photography remembers the 101 but said he was never

inside. "It was an eyesore to the community, sitting there on the main corner of town," said Morris. "There were a lot of drunks and people would just hang out there."

Morris said the cafe across the street was better and cleaner. In earlier years, the old town marshal's office was just up Downey Avenue next to where Johnnie's Salon is today.

That was convenient, Morris said, because the marshal had to make many trips to cool down the rowdies at the 101.

It was so seedy the nice girls in town wouldn't be seen there. There was almost constant trouble. It was a seedy saloon, oozing a certain charm created largely by its customers. There is nothing



Phil Saviano, exposed child abuse within Catholic Church

Phil Saviano, a survivor of childhood clergy abuse whose work to help other survivors and uncover predatory behavior in the church was featured in the Oscarwinning 2015 film "Spotlight," died Nov. 28 of gallbladder cancer at the age of 69.

Saviano was sexually abused by a priest at St. Denis Catholic Church in Douglas, Mass. It wasn't until decades later that he realized he hadn't been alone and became determined to help other survivors and work toward preventing further abuse.

Saviano began researching sexual abuse in the Catholic Church, uncovering evidence that priests with a record of abuse were simply sent to other parishes rather than punished and removed from the priesthood. He also founded a New England chapter of the Survivors Network of Those Abused by Priests (SNAP).

Saviano went to the Boston Sherif Zaki, Globe to tell his story; the newspaper initially declined to publish it but later used it as the **researcher** bedrock of a major investigative

The Spotlight report won the Globe a Pulitzer Prize as a team infectious diseases including of reporters dug into decades Ebola, SARS, and COVID-19, died of clergy abuse and coverups. The Globe's report led to a new

awareness of clergy abuse, including broader support for victims of that abuse.

The same year the report was published, Cardinal Bernard Law admitted that abusive priests in the Boston area had been reassigned with little effort to put a stop to abuse.

The movie detailing the investigation, "Spotlight," won Best Picture at the Academy Awards and featured actor Neal Huff as Saviano; the actor and the activist he portrayed became friends.

Sherif Zaki, a pathologist for the Centers for Disease Control and Prevention (CDC) who studied Nov. 21 of complications from an accidental fall at home at the age

Zaki began working for the CDC in 1988, founding the Infectious Disease Pathology Branch. There, he worked to identify and study the new pathogens that can lead to deadly outbreaks.

Zaki was the first to identify the hantavirus in the Southwest U.S. in 1993, and he helped prove that Zika virus can be transmitted during pregnancy in the 2015-16 outbreak.

Zaki identified anthrax included in a series of letters in 2001 that was deemed a bioterrorism attack. He studied Ebola and SARS, working to learn what made them so frequently

And in 2020, he and his team began their exhaustive study of COVID-19, working to learn more **contestant on** about the SARS-CoV-2 virus that causes the disease. Among the aspects of SARS-CoV-2 that Zaki studied were breakthrough infections and the virus's effects on pregnancy.

Lee Elder, first Black golfer to compete in Masters

who was the first Black golfer to compete in the Masters when he played in the tournament in 1974, died Nov. 28 at age 87.

Elder taught himself how to play golf by sneaking onto whites-only golf courses as a youth. In 1961, he started his pro career on the all-Black United in the 1950s Golf Association tour.

for the PGA in 1968. Elder won his first PGA tournament in 1974 at the Monsanto Open in Pensacola, Florida, which earned him an invitation to play in the Masters in Augusta, Georgia. He received death threats at the Monsanto Open and rented two homes for the Masters so people would not know where he was staying.

He won four tournaments in his career and finished in 11th place at the 1979 U.S. Open.

He was honored at this year's Masters tournament on the ceremonial first tee with fellow legends Jack Nicklaus and Gary Player.

Virgil Abloh, artistic director for **Louis Vuitton**

Virgil Abloh, the artistic director of Louis Vuitton's menswear collection and the founder of the Off-White fashion house, died Nov. 28 in Chicago after fighting cardiac angiosarcoma at the age of 41.

Abloh began to come to prominence as he worked with Kanye West; the two both interned at the Italian fashion house Fendi in 2009 and began collaborating there. Abloh became the creative director of West's Donda creative agency.

In 2013, Abloh founded Off-White, offering high-end streetwear including sneakers, hoodies, and t-shirts. Through Off-White, Abloh collaborated

with notable names including in place. Nike, Warby Parker, Levi, and Dr. Martens. He became known for his use of quotation marks in his designs.

As Abloh's star rose, he gained the notice of Louis Vuitton, becoming a finalist for their LVMH prize in 2015. He became artistic director of Vuitton's menswear line in 2018, the first Black designer in that role. That same year, Abloh was named one of the 100 most influential people in the world by Time magazine.

The celebrities Abloh dressed include Spike Lee, for the 2021 Cannes Film Festival, and Hailey Bieber, whose wedding dress was an Off-White original.

Thomas Wells, 'X Factor'

Thomas Wells, a singer who was a popular contestant on the talent show "X Factor," died Nov. 13 at the age of 46 in a workplace

Wells competed on the show in 2011. He also sang on the TV talent shows "The Voice" and "America's Got Talent."

Wells had a YouTube channel Lee Elder, a pioneering golfer that featured him singing and playing instruments on many cover songs including "I Want to Know What Love Is" by Foreigner.

Arlene Dahl, leading actress

Arlene Dahl, an actress He first earned his tour card known for 1950s movies including "Slightly Scarlet" and "Journey to the Center of the Earth," as well as the mother of actor Lorenzo Lamas, died Nov. 29 at age 96.

> Dahl's film debut was in "My Wild Irish Rose" in 1947. It landed her a contract with MGM, and she became a star in leading roles in movies including "A Southern Yankee," "Reign of Terror," and "Watch the Birdie."

> Dahl's greatest fame came in the 1950s, including her role as a kleptomaniac in the film noir "Slightly Scarlet" and as a widow on an adventurous expedition in "Journey to the Center of the Earth." She sang in the movie musical "Three Little Words," featured in the song "I Love You So Much '

> Her movie career slowed down in the 1960s, with only a handful of film roles in later years. Dahl was often seen on TV after her film career, with roles on shows including "One Life to Live" and "The Love Boat."

> Dahl was known for her fiery red hair and beauty mark, and her Technicolor looks led to a second career in the beauty industry. It began in 1951 with her column for the Chicago Tribune, "Let's Be Beautiful." The column was syndicated nationwide and ran for two decades.

Later in the '50s, Dahl expanded her reach in the beauty world by founding Arlene Dahl Enterprises, selling cosmetics of languages and literature. He and lingerie. Her products included the Dahl Beauty Cap, worn at night to keep one's hair

Marcella LeBeau, WWII battlefield

Marcella LeBeau, a nurse who served in the U.S. Army Nurse Corps during World War II and went on to advocate for Native American health, died Nov. 21 at

LeBeau served as an Army nurse in Belgium, England, and France, including treating soldiers at the Battle of the Bulge. She was later awarded a medal of honor by Belgium.

When she returned to the U.S., she worked as a nurse on the Cheyenne River Sioux reservation in South Dakota, serving for 31 years until her retirement as director of nursing at Indian Health Services.

She served on the Cheyenne River Sioux Tribal Council, where she worked to ban smoking from tribal chambers. The reservation became the first community in South Dakota to pass a clean air

In 2019, LeBeau worked with Senator Elizabeth Warren and Representative Deb Haaland on the Remove the Stain Act, a measure to revoke the Medal of Honor from the soldiers who participated in the Wounded Knee Massacre in 1890.

Justus Rosenberg, Holocaust survivor

Justus Rosenberg, a Holocaust survivor who worked with the French Resistance to help refugees escape the Nazi regime, died Oct. 30 at age 100.

A native of Danzig, in modern-day Poland, Rosenberg was sent by his parents to study in Paris in the years leading up to World War II.

As the Nazi occupation of Paris neared, Rosenberg fled to Toulouse, in the south of France, where he became involved with the French Resistance. He worked with Varian Fry's Emergency Rescue Committee, a network that helped Jews and other enemies of the Third Reich escape Nazi Europe.

With the group. Rosenberg worked to carry messages and provide forged identity papers to refugees, as well as escorting them across the Pyrenees to

Still in his teens when he began working with the Resistance, Rosenberg was captured at 21 and sent to a concentration camp. He faked appendicitis and was sent to a hospital for surgery, where he escaped during his recovery.


Rosenberg began working with the U.S. Army later in the war, and he was honored with a Bronze Star and a Purple Heart. His military service also gained him entry to the U.S., where he lived from 1946 on.

Rosenberg became a professor is believed to have been the last surviving member of Fry's network.



Dictionary company Merriam-Webster unveiled its word of the year for 2021, and it

That is a logical follow-up to its 2020 word of the year, "pandemic," and it matches the Oxford English Dictionary's word for 2021, "vax."

But "while other dictionary companies choose words of the year by committee," The Associated Press reports, "Merriam-Webster bases its selection on lookup data, paying close attention to spikes and, more recently, year-over-year increases in searches after weeding out evergreens.'

Searches for "vaccine" increased 601 percent over 2020 and 1,048 percent over 2019, Merriam-Webster said.

"This was a word that was extremely high in our data every single day in 2021," Peter Sokolowski, Merriam-Webster's editor-at-large, told AP. "It really represents two different stories. One is the science story, which is this remarkable speed with which the vaccines were developed. But there's also the debates regarding policy, politics, and political affiliation. It's one word that carries these two huge stories."

"Few words can express so much about one moment in time," Merriam-Webster said.

dictionary editors Merriam-Webster's editors definition of vaccine earlier this year to encompass the mRNA breakthroughs, but the word itself "is a relatively recent one in English, dating back to the 1880s," the company explained. "Vaccine comes from the Latin word for 'cow,' vacca, because the term was initially used to refer to inoculation using doses of cowpox that, it was discovered, protect humans against smallpox."

Merriam-Webster's runnerup for 2021 was "insurrection," thanks to the Jan. 6 siege of the U.S. Capitol by supporters of former President Donald Trump.
