Roybal-Allard retiring from Congress

■ Long Beach mayor Robert Garcia is considered a frontrunner to replace her in a newly-drawn district.

DOWNEY - Rep. Lucille Roybal-Allard of Downey, the first Mexican-American woman elected to Congress, announced Monday she will not run for reelection in 2022.

in Congress has been the single most distinguished honor of my life," the 80-year-old Roybal-Allard, a Democrat, said in a statement.

"Over my many years of public service, I have always strived to do that which is best to help improve my community and my country. After 30 years in the House of Representatives, the time has come for me to spend more time with my family. Therefore, I have decided not to seek reelection."

Roybal-Allard's Congressional District includes Bell, Bell Gardens, Commerce, Cudahy, Downey, Huntington Park, Maywood, Paramount, Vernon and portions of Bellflower, East Los Angeles, Florence-Firestone and South Los Angeles.

She was the first Latina serve on the House Appropriations Committee and to chair an Appropriations

Long Beach Mayor Robert veteran praised the representative's work.

"Congresswoman Roybal-Allard is a trailblazer and has been a fearless advocate for Los Angeles and the Southeast cities," Garcia said. "She has been an incredible national leader on immigration, equality and for working families. I am tremendously grateful for her leadership and service to our country and our community."

Garcia announced last week that he would run for Congress in 2022, though new districts have yet to be finalized.

Roybal-Allard did not disclose specific plans for the future, but said she would continue to support her district, which includes South and East Los

"While I will not be seeking re-election in 2022, I look forward to continue to work for the people of my district in the new year and long after I leave public office," she said.

did not mention redistricting as a factor in her decision, though she told the Los Angeles Times in November that she had concerns the new maps would dilute the power of Latino voters she currently represents.

"I am aware of the current draft map and I have concerns about the protections of Voting Rights [Act] districts and in particular the diluting of the vote in our Latino communities," she said, while urging the commission to address those issues before finalizing the districts.

Roybal-Allard was of three House Democrats to announce Monday they would not run again, bringing the total number of retirements before the midterm elections to 23, according to the Washington Post.

After public outcry, City Council chooses to keep city manager

■ Gilbert Livas will remain city manager after the public flooded a public meeting with an outpouring of support.

DOWNEY - Following an unprecedented show of support from the community last week, the City Council decided against firing city manager Gilbert Livas.

News of Livas's seemingly impending dismissal sent through shockwaves community when sources at City Hall, who spoke on the condition of anonymity, disclosed to the Downey Patriot that three of the city's council members - Mario Trujillo, Catherine Alvarez, and Mayor Pro Tem Sean Ashton were poised to vote to fire Livas as early as last week.

The scenario became all the more real when a special meeting was announced to evaluate and discuss the city manager's position in the city, which was

Council members discussed Livas in closed session, which is not open to the public. City Attorney Yvette Abich Garcia made the announcement that Livas was staying.

"Mr. Livas remains employed by the city," said Garcia. "The council continues to value his

After the decision was announced, emotional an Livas made his way around the chambers to a flurry of hugs and handshakes by staff and community members.

The community out in a massive showing of overwhelming support for Livas, spending almost two hours addressing the council.

Speakers included residents, community leaders, volunteers, former mayors, unions, and city employees.

Former Mayor Mario Guerra said that this decision would be the council's "legacy."

"Today, you're writing your legacy, you're writing a big part of your legacy; right here, right now," said Guerra. "...Doing what's right is always the right thing to do. Keeping Gilbert Livas is the right thing to do for the city of Downey. Don't do this. Be reasonable, responsible. Our city's legacy depends on it.'

Former mayor Roger Brossmer, like many who spoke, was visibly and audibly frustrated.

"I'm not sure how we're here today. I'm not sure how we're having a special meeting with 24-hours' notice on a Thursday at 3 p.m. before the holiday. I don't know how we're here right now," said Brossmer. "That's what I'm not sure about, because if we

want to be about community, input, and transparency, this doesn't feel right."

Brossmer was part of the council that would hire Livas, and was even sworn in as mayor the same night as him.

"I do know Mr. Livas. I do care for Mr. Livas. That's what I do know. I know that he is a man of honor and integrity. He is ethical," he said.

Kim Sodetani, an executive secretary for the city, suggested that morale was low at the city due to the situation.

"I have worked on all floors

of service to this community...I have been proud of the work that I see our city hall professionals accomplish every day," said Sodetani. "I now see those same professionals are worried and sad over the sudden potential loss of our city manager, Mr. Livas.

"We do not understand why man who has dedicated his life to public service would be terminated after doing so much good for the community that he serves.'

Another staff member, Lisa Fox, pleaded with the council to retain Livas.

"Everything said about Gilbert today has been said. Everyone here knows what an ethical person he is, what a moral person he is, and how good he is for our city. There's just no more to be said," said Fox. "What I can tell you, on a personal level that a lot of these people don't know, is city hall is full of heavy hearts, because you cannot find one employee here to speak an ill word about that man, and that speaks volumes.

Livas also had backing from six of the labor unions within the city, which had written a letter Wednesday in his support.

Ralph Diaz, president of the Downey Police Officers' Association, described the matter as "very concerning."

"In our dealings with Mr. Livas, he has always been fair and unbiased," said Diaz. "Mr. Livas has always put the interest of the residents, the City of Downey staff, and all officers first."

"Since 2011, the City of Downey has built upon the reputation as being stable, financially responsible, and has continued to grow even after the 2008 financial meltdown. Mr. Livas has been a leader, and has guided us through a recession, and the current global pandemic... The Downey Police Association cannot ask for a better city manager."

Council members retreated to closed session for nearly an hour, before reemerging with their decision.

Downey's Isaac De La Paz wins Muay Thai championship

■ The up and coming combat fighter from Downey is rising the ranks in Muay Thai.

DOWNEY - There is another champion in Downey, and his name is Isaac De La Paz.

De La Paz, 20, is still relatively new into the world of mixed martial arts, where he fights in the 130 weight class. An athlete during his time at Downey High School, he wanted to find something to keep himself active after graduating in 2019.

"I first played Volleyball at Downey High School. I've always been in sports; soccer, football, every sport you could think of," said De La Paz. "After high school, I graduated, I wanted to do some type of sport, try to keep myself moving."

"I did boxing for a little bit over in South Gate. I wanted to do some type of martial art, so I came to [King Cobra Mixed Martial Arts]."

De La Paz enjoyed training, however admitted that he did not take it too seriously at first.

"I wouldn't come every day; it'd just be to keep me active," said Paz. "I always expressed to Coach [Isaias Nambo] that I wanted to compete in the future."

Competing meant that De La Paz would start having to come in every night to train. Unfortunately, that's when the pandemic set in.

Lockdown was not enough to stop De La Paz, however.

"At home, I have a heavy bag," said De La Paz. "I'd train at home. I'd hit the bag, stuff like that. I thought to myself, 'Man, I really enjoy doing this type of stuff.'"

"I knew that once quarantine ended, I really wanted to

As quarantine ended and De La Paz was able to return to the gym, the intensity of his training amplified.


"It has to do more with the way of thinking," said De La Paz. "I watch the UFC fights; it's pretty crazy to think that these guys are going head-to-head, and they're trying to kill each other basically, in the ring."

"When I'm training, I like to think that I'm training to keep myself safe; like we're going to go into an arena, like gladiator type stuff."

His first competition was at the Arizona United States Muay Thai Open, where he faced and defeated three opponents before heading to the championship round the following day.

Unfortunately, a tough third fight left De La Paz's leg injured.

"Since I had three fights that day and I used my leg kicks a lot that third fight, my leg was like a balloon. It was crazy swollen,"

said De La Paz.

"His injury was real bad," added Nambo. "We were taping up his leg, just trying to do whatever we can."

"...He was injured, so he wasn't able to put weight on it. He's still new to the game, so he wasn't able to switch to southpaw or anything like that."

Unfortunately, De La Paz and his softened-up leg were unable to take away the victory that day. Still, he says he learned a lot from the fight.

"It taught me a lot about having heart as well, because I really wanted to win that gold belt; I wanted to come in first no matter what injury I had," said De La Paz. "I learned that I needed to have a lot more cardio, a lot more intensity, and to stop waiting because in this fight, you always have to be first, putting pressure on your opponent."


De La Paz was sidelined for a few weeks while his leg healed. Once he was ready to fight once more, there was more work to be

"I recovered, came back, started training with more intensity," said De La Paz. "I had the IFS (International Fight Showdown) fight."

The IFS fight would offer a new, intimidating challenge for De La Paz: the removal of shin guards and head protection.

"It's like a big jump for me," said De La Paz. "I went from

Paging Dr. Frischer...

Here we go again. Just as the COVID pandemic



What does this mean? Just how bad is it?

I must mention that just last Saturday, my wife and I planned to take my mother to the Ahmanson Theater for the first time since the March 2020 shutdown. That very morning, the show was canceled, along with the rest of the run. Why? The cast and crew experienced a major COVID outbreak. The Rams football game was postponed due to players with COVID. The UCLA basketball game was delayed due to COVID. Many other events, including Broadway shows, the Radio City Music Hall Rockettes, and numerous sporting events have been canceled or delayed as well.

Note that the situation is changing so rapidly that all that is certain is that by the time this column goes to press, the picture will surely look different. Still, here are some ominous numbers:

· New York City reported 21,027 cases on December 16, the highest single day count of COVID-19 cases since the start of the pandemic. Feel free to reread that last sentence. Cases in New York doubled in a fourday period.

There have been over 65,000 newly confirmed cases in London in the past seven days, with more than 26,000 cases reported in the last 24-hour period alone. Like New York City, this is the highest single day count since the start of the pandemic. The number of COVID patients in London hospitals rose by 29%.

· Paris will not have its traditional fireworks display over the Champs-Elysees due to this surge. All large outdoor events and gatherings will be banned on New Year's Eve as France faces its fifth wave.

· Locally, COVID hospitalizations in Los Angeles County continue to rise, due to this winter surge and a post-Thanksgiving uptick in infections, prompting California to impose a statewide indoor mask-wearing mandate.

Now, on to Omicron. This variant has been found in 89 countries as of December 16. The World Health Organization (WHO) informs us that Omicron cases in those countries are doubling every 1.5 to three days, and that Omicron spreads much faster than the Delta variant due to its large number of mutations. Moreover, Omicron is even spreading in countries where the vaccination rate is very high. In the United States, in just one week, the Omicron variant went from 3% of cases to 73% of all new COVID

How effective are our current vaccines against Omicron? Preliminary data from England shows that two doses of the Pfizer or Moderna vaccines are not nearly as effective against Omicron as they are against Delta. However, it appears that for those who have had the booster, protection is far better. This makes the booster shot even more important.

Our biggest hope is that Omicron does not cause as serious an illness as does Delta. Early data indicates that this may be the case, but much more information on hospitalization and death rates is needed. Regardless, Omicron will tax our workforce (health care workers in particular), fill up hospital beds, and cause yet more damage to the economy.

The numbers are serious. We were already heading into a winter surge, and on top of that we now have a far more transmissible variant. You have heard this before: The best defenses are to become vaccinated, get the booster, wear a mask, and despite winter weather, socialize outdoors. Virus mutations do not care that, after these many months, we are all suffering from pandemic fatigue. Please do your best to stay healthy, and be on the lookout for more information from the CDC and the WHO.

"It worked really good," said De La Paz. "My kicks were way stronger; I was putting people out with just kicks and the liver

Then, De La Paz would dislocate his arm again while swimming. This time, the fight was just over a week out.

"All these thoughts are going through my head: if I'm going to be ready, if my arm pops out and ruin my future," said De La Paz. "It's not good to have those thoughts going into a title shot fight; you want to be totally mentally prepared, physically prepared, thinking that you're going to win this fight no matter

Nambo gave De La Paz the option to pull out of the fight.

"At first, he kind of shook his head...but then something clicked in and he was like, 'Nah, let's do it,'" said Nambo.

The fight would be contested for two belts: The IKF and IFS Southern California Lightweight

De La Paz described the fight as "five rounds of just war."

"It was one of the most intense fights; constant elbows, constant knees, constant punches, and the guy didn't back down either," said De La Paz. "It was back and forth, just boom,

boom, clashing. The guy was really good."

De La Paz took the fight in a split decision.

"I thought like I did good. I honestly felt like I had won the fight. I wasn't really worried, I was just waiting for my belt," said De La Paz. "My whole family came there. There were about 40 people there to support me, I could see them in the crowd."

"I felt happy. The ring felt like it was my home, basically...I came with the win. I got my two belts - the IFK one and the IFS and hard work pays off.'

De La Paz also credits his success to Coach Nambo, Coach Adrian "Footsie" Gonzalez, and Prodigy Plumbing, who has been a major sponsor of King Cobra

As the saying goes, it's easier to win a title than it is to keep a title. De La Paz will put that to the test in March against the very same opponent he defeated to win the belts.

"Since it was a split [decision] he does have the right to contest and go right after it again," said Nambo.

While De La Paz already says that he's ready, he will have the added benefit of training time with reigning ONE Featherweight Kickboxing World Champion Superbon Banchamek, who held



Manchin gave Democrats a chance to save their agenda

Senator Joe Manchin of West Virginia seemingly dealt a terrible setback to President Biden's agenda on Sunday, when he told Bret Baier of Fox News that he could not support the version of the Build Back Better Act passed by the House last month. Although Democrats were rightfully frustrated by the way in which Mr. Manchin expressed his concerns, he was raising a valid critique: This bill was deeply flawed, and the "compromises" his colleagues made did nothing to address the concerns he has been consistently raising since this summer.

Other Democrats may not realize it, but Mr. Manchin may well have given them a gift. They should've gone back to the drawing board months ago, when it first became clear that their budgetary gimmickry was turning the bill into a confusing mess. Now, they will have to — and if they revise the bill to cut the number of programs they propose while making the ones they do propose permanent and easier for Americans to navigate, it could deliver Democrats both lasting policy change and the political victory they so desperately need.

Democrats had been trimming the bill for months in an effort to meet Mr. Manchin's demand that it cost less than \$2 trillion over the next decade. But rather than focusing on a few top priorities, they wedged almost every major social program Mr. Biden had proposed into the bill and relied on arbitrary expiration dates to make it seem less expensive. As a result, according to the Committee for a Responsible Federal Budget, these programs would cost more than \$4.7 trillion if made permanent, as every supporter of the bill clearly intends them to be.

This structure sets Democrats up for failure. Extending these programs without adding to the national debt would likely require raising taxes by an additional \$3 trillion over the next decade, which would be extremely difficult to do, particularly after Democrats incorporate all of the tax increases they could get consensus for into the Build Back Better Act. If Democrats cannot agree on how to continue paying for their major social programs, the only alternative — besides breaking their promise not to add to the deficit — would be to allow those programs to expire after a few short years.

dollars in benefits they would have gotten if they had had children only a few years earlier, many families may never receive these benefits in the first place. Many programs in the Build Back Better Act require state and local governments to implement them, and local officials in both parties have already said they may not commit resources to programs for which federal support may vanish just a couple years after being created.

Unlike those on the left now unleashing their righteous wrath on Mr. Manchin, I have long sympathized with his objections to this approach, as well as his concerns about inflation and the unsustainable growth of our national debt.

But I believe abandoning Mr. Biden's agenda would be a massive mistake. There is a clear path forward to deliver a historically significant, fiscally responsible bill that supports working families, expands access to affordable health care and combats the climate crisis. If the president wants this bill to be his legacy, he must urge Congress to stop playing games with expiration dates and do fewer things better — starting with making them permanent.

Progressives and centrists will both have to forego some items on their legislative wish list. Many worthwhile policy ambitions, such as creating a national paid family leave program or extending a recent expansion of the Child Tax Credit, which has already lifted millions of children out of poverty, will need to be dramatically scaled back or tabled altogether. But the policies that do get enacted will be more successful, more popular and more durable as a result, which can help lay the groundwork for building on them in the future. It would also leave Democrats with a bill that is more focused and easier to explain to voters than the current version, which Republicans are already portraying as a "progressive grab bag.'

In October, my organization, the Progressive Policy Institute, published a blueprint for such a focused package that prioritized expanding the Child Tax Credit, making preschool universally available, strengthening the Affordable Care Act and combating climate change That approach now has renewed interest from key Democrats on Capitol

Senator Ron Wyden of Oregon, who leads the Finance Committee in Not only would this scenario deny new families tens of thousands of the Senate and will be responsible for writing many of the final bill's key

provisions, released a statement on Sunday listing three top spending priorities: the expanded Child Tax Credit, subsidies for health insurance under the Affordable Care Act and incentives for reducing carbon emissions from all energy sources.

That same day, Representative Suzan DelBene of Washington, who presides over the 97-member New Democrat Coalition that will be crucial for passing the final bill through the House, released a statement embracing nearly identical priorities and reiterating her coalition's preference for "doing a few things well for longer," which is also the approach Mr. Manchin has demanded.

The only major sticking point now seems to be the expanded Child Tax Credit. Last week, Mr. Manchin reportedly told Mr. Biden he would support a \$1.8 trillion package that omitted the credit but included longterm versions of Mr. Wyden and Ms. DelBene's other top priorities, as well as a universal prekindergarten program. Those policies combined would cost roughly \$1.2 trillion over 10 years, which means that if Democrats can compromise on additional priorities that cost less than \$600 billion, whether that's a modified Child Tax Credit expansion or other permanent programs, they will have produced a transformative bill that fits within the parameters Mr. Manchin supports. Importantly, these permanent policies would not increase budget deficits or inflationary pressures because they can be fully paid for using only the tax increases and other offsets included in the Build Back Better Act.

Democrats have a once-in-a-generation opportunity to improve American society, not just for a few years, but permanently. Doing so would give them some clear victories they can point to with voters that lay the groundwork for future success. But to get such a package across the finish line, progressives and centrists — including both the White House and the senator from West Virginia — must stop pointing fingers, come back to the negotiating table, and compromise. America cannot afford for the Biden agenda to fail.

How to win over the unvaccinated

At this point in the pandemic, many Americans remain unvaccinated because they believe the coronavirus vaccine is unlikely to do them any good. They're aware of the virus and the damage it can cause, but for any number of reasons, they simply don't believe they should get a vaccine. We've spoken to patients like this in our practice, and we have observed in those conversations that providing more, frightening information intended to change their beliefs is ineffective for many or may even cause further entrenchment against vaccination.

Public health experts have tried many different methods to motivate behavior like vaccination. Our recent research shows even more clearly that providing additional information may not be one of the strongest

In a study published on Dec. 13, we examined data from about 750,000 children who were eligible to receive the human papilloma virus vaccine to prevent cervical cancer. Since the HPV vaccine was approved in 2006, it has experienced resistance from parents and religious and conservative groups who see it as promoting sexual behavior. Its politicization was a preview for what has happened with the coronavirus vaccines in the

Our research question was: Are mothers who themselves had cervical cancer more likely to have their children vaccinated against HPV? We

thought that for this group of mothers, a lack of information about the consequences of HPV couldn't possibly affect their decision to vaccinate would expect the rates among doctors' families to be especially high. their children against the virus. These women had personally suffered from cervical cancer, so, presumably, they would be especially well informed about the harms of this virus and the disease it causes.

What we found surprised us: The girls and boys whose mothers had cervical cancer were no more likely to be vaccinated against HPV compared with children whose mothers had no history of cervical disease. Children whose mothers had a cancer "scare" — a biopsy of cervical cells that ended up not being cancerous — were only slightly more likely to be vaccinated. But having cervical cancer or a cervical cancer scare did not result in the large increase in vaccination rates that we were expecting.

Motivations behind vaccination decisions are complex; they vary from disease to disease and across time, social groups, culture and geography. But if personally having cervical cancer doesn't seem to motivate mothers to vaccinate their children against HPV, we probably shouldn't be surprised when hesitant Americans are not motivated to get vaccinated after a family member is hospitalized or even dies from Covid-19. Emergency room doctors sharing devastating stories from the hospital may, unfortunately, not meaningfully impact vaccination rates.

Information about Covid-19 will continue to be valuable for people who are interested in being vaccinated and just need more data. But that may be only a small portion of the unvaccinated population now. If disbelief in the importance of vaccination is the primary barrier to reaching the country's vaccination goals, more information is unlikely

Our past research has also shown that more information often isn't enough to change behavior. A classic example is doctors who struggle to follow the same medical advice that they give to patients. Despite doctors' extensive training and access to medical information, as a group, they are barely better than patients at sticking to recommendations for improving their health. This includes vaccinations. Rates of chickenpox vaccination among doctors' children, for example, are not meaningfully different from the rates among children whose parents are not doctors.

What interventions might work? Behavioral science research suggests that one of the best ways to motivate behavior is through incentives, either positive or negative. Incentives work because they do not force people to change their beliefs. A customer might switch cellphone providers not because he believes the new provider is better, but because the new provider is offering a free iPhone to switch (a positive incentive). A teenager might come home before curfew on a Saturday night not because she believes it's dangerous to be out late, but because she knows her parents will take away her car keys if she stays out past midnight (a negative incentive).

While small positive incentives such as free doughnuts or entries into statewide lottery programs may have motivated some people, those and similar methods don't seem to motivate people to get vaccinated on a scale large enough to close the vaccination gap.

The incentive that seems to work especially well is the employer vaccine mandate, a negative incentive. "Get vaccinated or get fired" has shown to be an effective message. United Airlines, which mandated the coronavirus vaccination for its employees this past summer, reported in November that 100 percent of their customer-facing employees were vaccinated, and that only about 200 of their 67,000 employees had chosen termination over vaccination. Similar stories have played out among private and public sector employers that enforce mandates, with vaccination rates approaching 100 percent (including at our own

By now, it's clear that the public health system does not know how to change people's beliefs about vaccines. Until we do, America's leaders should focus on other strategies, especially the ones we already know are

Omicron should not dim our lights

The screaming headlines about New York City closing down again in response to the highly infectious new COVID-19 variant are premature. Sure, some things are dialing back, witness the cancellation of the Radio City Rockettes' "Christmas Spectacular." The reality is that the surrounding streets are clogged with celebrants viewing the store windows and the Christmas tree at Rockefeller Center.

December 2021 is not December 2020, when America's holiday season turned eerily quiet. This year, the governors of Colorado, New Jersey and Maryland — two Democrats and a moderate Republican, for those who keep score — are opposing renewed restrictions.

And for a good reason. The threat is not gone, especially with the highly infectious Omicron variant on the loose. But it's a lot less scary

In New York City, 83% of residents 12 years and older are fully vaccinated, meaning they've had two shots. They still remain at lower risk of serious disease. For those who've gotten the third shot, the risks appear to be no higher than they were before Omicron, when two iabs would do the job. As for those who haven't gotten any shots, they're on

Meanwhile, the Centers for Disease Control and Prevention reports that the U.S. supply of mRNA vaccines — that is, the highly effective Pfizer-BioNTech and Moderna versions — is "abundant." This is a far cry from last December, when the first vaccine (Pfizer) came out but was very hard for nonmedical workers to obtain.

Rather than coercing the public, the vaccine mandates are seen as freeing most New Yorkers to largely resume their lives with very little fear of hospitalization or death, even in the event of a breakthrough infection. It doesn't matter if they're now dining next to tourists from Idaho or Florida, states that refused to institute vaccine mandates. The people at the next table had to show their COVID-19 vax cards or they couldn't get in.

Early reports suggest that Omicron, while far more transmissible than other variants, tends to produce milder symptoms in the infected. Even though Omicron has exploded the COVID-19 infection numbers in South Africa, hospitalizations there are way down. Other factors could be in play, but evidence has yet to emerge that Omicron is as nasty as the

Omicron has raised the number of hospitalizations in New York, not because it's shown itself to be especially deadly but because it has spread wildly. The recent surge in the infected has fatigued hospitals, but thanks to the city's high vaccination rate, its number of COVID-19 deaths per 100,000 residents is less than half that of the United States as a whole.

There's other reassuring news. Moderna says it will soon have a booster shot tailored for Omicron (if it's needed). And new treatments are rolling out for those already infected. The most promising one, from Pfizer, has been found to work 88% of the time in preventing hospitalization.

Given these developments, it would behoove the authorities in states with high vaccination rates (and restrictions on the unvaccinated) to let young children, whom the virus almost never hospitalizes, stay in their classrooms. And they should desist in backing panicky moves to stop a pandemic that was unstoppable a year ago but not now.

Yes, they will have to deal with new strains on hospitals and their workers. But they will be sending the wrong message if they let the unvaccinated spoil another year for those who've done the right things. For most of us, Omicron remains a concern but not a good reason to dim the lights this holiday season.

Discipline has its rewards. Those who have done the hard part should enjoy the relief it has delivered.





Book follows boy through quarantine birthday blues

DOWNEY – It's a question many young boys and girls were faced with over the last two years: How do you celebrate a birthday during

Following the release of her first book last year, Jeannette Eseberre, a substitute teacher and interventionist at Gauldin Elementary School, recently published "My Quarantine Birthday," a story that follows a young boy as he ponders that very uncertainty.

"I think with everything going on with the pandemic, because it was something that no one actually lived through before, it was something brand new for everybody, it was a very emotional time," said Eseberre. Of course, Joaquin didn't go completely without, as he was thrown a drive-by birthday celebration.

"We were inspired by things we'd seen on the news," said Eseberre. "We're like, 'Let's do that for him this year,' because I want him to know that we're still here for him. So that's what we did."

Eseberre says that the situation made for a "really good story."
