**DOWNEY** – Several local political leaders have officially announced their intent to run for election to the Senate and State Assembly.

# Bob Archuleta eyes 30th Senate

Current State Senator Bob Archuleta will seek the 30th Senate District seat, which is a reconfiguration of the 32nd District, where he is the incumbent.

"It's been an honor and privilege to represent District 32 in the State Capitol, never taking for granted the responsibility faith the people have bestowed upon me," Archuleta said in a press release. "Now, I will continue that same enthusiasm in the new cities and unincorporated areas that make up the 30th Senate District."

elected in Since being 2018, Archuleta has been a advocate of several diverse issues, including the environment, military personnel and their families, veterans, homelessness, and public safety.

He became the first Latino Army Veteran named to Chair the Senate Committee on Military and Veterans Affairs, and serves on the Business, Professions and Economic Development, Governmental Organization, Transportation and Insurance committees.

In August 2019, Archuleta was appointed to the Governor's Military Council by Governor Gavin Newsom, which oversees 32 military bases in California. He was also selected to chair the Senate Select Committee on Hydrogen and Energy

If elected, Archuleta would maintain representation of the cities and unincorporated areas of Pico Rivera, Montebello, Whittier, Hacienda Heights, La Mirada, Bellflower, Downey, La Habra Heights, Norwalk, Santa Fe Springs, and Los Nietos, while also adding Walnut, Brea, La Puente, City of Industry, Diamond Bar, Valinda, Avocado Heights, South San Jose Hills, and Rowland Heights. He would no longer represent the cities of Artesia, Cerritos, Commerce, Hawaiian Gardens and Lakewood.

# 64th Assembly District

More than one official has thrown their hat into the 64th State Assembly ring, challenging Downey mayor Blanca Pacheco, who declared her candidacy last

The open 64th Assembly District seat represents the cities of Norwalk, La Mirada, Downey, Santa Fe Springs, Cudahy, Bell, Bell Gardens, La Habra, and the unincorporated area of South Whittier. It replaces the current 58th District seat currently held by Cristina Garcia, who is campaigning for a seat in Congress.

## Ana Valencia

Former Norwalk - La Mirada Unified School District Board member and current Norwalk City Council woman Ana Valencia officially launched her campaign in January.

"I am excited to launch my campaign for State Assembly and for the opportunity to represent our communities in Sacramento," she said in a press release.

# Political Steve Roberson releases sixth and final country music album

■ Real estate broker and civic leader Steve Roberson has dabbled in country music for years. At age 71, his latest album will be his last.

owney's realtor-byday-country-singerby-night has officially hung up his cowboy hat, having released his sixth and final album "Truth To

A broker in the city since 1986, Steve Roberson has been a known face in Downey's real estate community. However, from time to time, he's kept himself busy with another venture: country music.

Having started playing guitar at the age of 14, Roberson says he had wanted to go through the process of making an album. His first opportunity came in 2006.

"My friend Karen – her name is Karen Tobin, she's this famous songwriter that lives out in the Valley – her friend – his name is Brian Soucy, he's an engineer they helped me put the first CD together," said Roberson. "I did several of Karen's songs. It came out pretty good, it was called Radio Ranch.

A year later, he and Tobin were back at it again producing his second album, called "Getting it Right." Tobin would also assist in his third album, "Livin' on a Dirt Road."

By the time his fourth album started to come to be, Roberson was ready to get more involved in the creative process.

"Karen helped me with those songs and those CD's," said Roberson. "A little bit later, I went to Karen and I said, 'Let me help you work with the process of writing the songs.' So, Karen

and I and another friend of ours another singer / songwriter, his name is Paul Marshall - we started getting together and writing songs for the fourth CD. That CD is called 'What Used to

"On that CD I wrote a song for my grandson called 'Four Year Óld Cowboy,' which is one of my favorites. Then, my granddaughter, his cousin Madi who is older was upset with me, so we also wrote a song called 'Madi Maybe' on that CD."

Roberson worked on his fifth album, "It's a Good World," with Marshall. They would also work on Roberson's final and most recent album "Truth To Tell" together, although the pandemic would extend the process to over two years. After writing together over Zoom calls, Roberson says that he would drive to Marshall's home in Tujunga about once a

week to record.

"Truth To Tell" consists of 14 tracks. Though the songs are that of Marshall and Roberson, Roberson says that he only provides the vocals on the recordings.

"I've been playing a long time, but I am not a very good musician," said Roberson. "I can fake it - you know, when I play in the Kiwanis group, I can play the guitar - but the CD's that we do, those guys and girls are all professionals, and I can't play with them. They're just exceptional musicians, so that's out of my league."

Now 71, Roberson's age seems to be catching up to his musical career.

"I'm too old and the work's too hard," said Roberson. "It took two years to finish [Time To Tell] from writing it to recording

it and driving to my friend's studio for a period of time. Then once I record it, I've got to go back over and check it and a million other things.

"I enjoy it a lot, but it's very very time consuming."

You may still see the occasional hometown performance, however, especially if you attend any of the city's service club meetings.

"I won't quit that; I enjoy that," said Roberson.

# Downey alumnus elected first Latina president by Harvard Law Review

■ Priscila Coronado made history with her election and she credits her Downey teachers.

**DOWNEY** – The Harvard Law Review has named a Downey Unified alumnus and Californiaborn daughter of Mexican immigrants as its newest president, elevating a Latina to the top of one of the most prestigious U.S. law journals for the first time in its 135-year

Harvard Law School student Priscila Coronado, 24, attended Rio San Gabriel Elementary, Doty Middle School and graduated in the top three percent of her class in 2015 from Downey High

She is the first in her family to attend college and earned her undergraduate degree from the University of California Los Angeles.

According to an article published by Reuters, an international news organization, an email sent by Coronado last week shared that her experiences growing up as a Mexican American have informed her perspectives and that she wanted to "work hard to show how being

When she was asked by a

former Downey High School students at Harvard University. teacher what it means to be the first Latina president, Coronado replied that it was a difficult question to answer.

"On the one hand, I'd like to work hard to show how being a Latina is an important part of who I am," she said. " My perspective as an editor and as President is necessarily informed by the experiences I've had growing up Mexican American. On the other hand, I recognize the privileges I have benefitted from such as growing up in a great public school district and having supportive family and friends). There are countless other Latinas who won't hold positions like this but are just as intelligent - or more than - I am."

Her legal interests include education law and disability rights. She is known as a "rigorous scholar and a passionate advocate" both by her Harvard peers and during her time at Downey High School. Currently she is involved in La Alianza, an association for Latinx students and is a Board Member of First Class, an organization established to further support first generation and low-income

As a Downey Viking, Coronado

was a very well-rounded student. She competed and received a silver medal at the SkillsUSA State Competition in Quiz Bowl; was a California State Federation (CSF) Seal bearer for her academic achievements; participated in wind ensemble and jazz band for two years and concluded her senior year as a section leader in the marching band.

"Honestly, [I] couldn't have done it without you," shared Coronado in a recent email to her former Downey High School teacher, Bernie Glasser. "I am fortunate I was able to attend a great public school system and thank you [Mr. Glasser] for teaching us about college admissions.

When the academic year is done at Harvard Law School, it was shared that she plans to work as a summer associate at Munger, Tolles & Olson, a California-based firm known for consistently ranking among the most selective law firms in the United States that regularly tops lists of the country's elite law

# Barger calls for mask mandate reevaluation

■ Health officials are being asked to reconsider local policies on mask mandates.

LOS ANGELES - One day after Mayor Eric Garcetti and Gov. Gavin Newsom were caught posing for mask-less photos inside SoFi Stadium, a Los Angeles County Supervisor called Monday for state and local health officials to reevaluate COVID-19 mask mandates, saying it should be up to the individual to decide when to wear one.

"Let's do away with blanket COVID-19 masking policies --they don't make a difference when they're not consistently followed or enforced. We need to trust the public to make best personal decisions for themselves based on their unique risks and circumstances, Supervisor Kathryn Barger said in a statement.

Barger pointed to Sunday's NFC Championship game at SoFi Stadium, noting there was inconsistent adherence to the mask-wearing requirement.

Most notably, Laker legend Earvin "Magic" Johnson on Sunday night posted a series of photos on Twitter taken that day at SoFi Stadium with mask- less officials and celebrities, including Garcetti, Newsom, San Francisco Mayor London Breed and actor Rob Lowe. Some people in the photos with Johnson — including Garcetti and Lowe — can be seen holding a mask in the photos.

The photos sparked outrage from some critics who accused the officials of hypocrisy when the public is being told to follow state and county mask mandates. Los Angeles County requires all attendees to wear masks at outdoor mega-events, like football games at SoFi Stadium. The state's mask mandate requires people to wear masks at indoor areas of outdoor mega-

Garcetti's office told City News Service, "The mayor was

wearing his mask during the game and removed it for a brief moment to take a few photos.'

Newsom similarly said at an unrelated news conference in Los Angeles Monday that he was "very judicious" about wearing his mask at the game, and insisted he had his mask in his other hand when the photo with Johnson was taken.

He said he only took the mask off momentarily to take the

"The rest of the time I wore it, as we all should," said Newsom.

Jessica Millan Patterson, chair of the state Republican Party, was unimpressed by the explanations, saying in a statement, "While they force California children to wear masks in school, Gavin Newsom and friends get to enjoy a mask-free night of football in a packed stadium. His blatant and insulting disregard for his own COVID rules is a crystal-clear sign that it's time for his Draconian policies and state of emergency

The county's mask mandate and other COVID guidelines are set by the Los Angeles County Department of Public Health, with guidance from the Board of Supervisors. Along with outdoor mega-events with more than 5,000 attendees, people are required to wear masks in all indoor public settings, venues, gatherings and businesses. The rules allow people to take off their masks when they are actively eating or drinking, are alone in a separate space, showering or swimming or receiving personal care services that require a mask to be removed.

Barger -- the only Republican on the non-partisan Board of Supervisors -- said it's time for masking mandates to be re-

Newsom on Monday reiterated his call for the public to wear masks, but he said in the coming weeks the state will announce its "endemic plan" on Newsom practices for the state to live with the virus longterm.



# Villanueva visits Norwalk to defend hiring freeze



■ Norwalk residents voted to raise taxes to improve public safety but the sheriff's department instituted a hiring moratorium.

NORWALK - LA County Sheriff Alex Villanueva came to Tuesday's Norwalk city council meeting to discuss their opposition to his moratorium on the hire of LA County sheriff

The sheriff's action prevents the hire of Sheriff deputies in the city, despite residents' vote to increase the sales tax to fund public safety.

During their meeting on Jan.18, council members expressed their disdain for the moratorium. Councilmembers Jennifer Perez and Margarita Rios called for a "strongly worded letter" to Villanueva and notifying the county supervisors

"We are in crisis mode right now," said Sheriff Villanueva on Tuesday. "We do not have the fiscal ability to extend any contract just because we do not have the personnel."

He explained that the LA County Board of Supervisors has imposed a hiring freeze on the department and that sheriff stations across the board have a 29% vacancy rate.

"This has become ideological position from the Board of Supervisors," said Villanueva. "They've embarked



on this path of defunding the sheriff's department. It basically starves us out as people are leaving or retiring, we are not replacing them."

sheriff said desperately wants to provide service due to a bus operator more personnel and noted that shortage. Between Dec. 13 and LA County Sheriff's department remains the most understaffed law enforcement agency in the

Perez expressed frustration with the moratorium because the city had planned to increase public safety and that Norwalk continues to pay its contract in

"If the county has a problem and they are taking your funding away, take their officers and their sheriffs away and fund those that are actually paying their bill," said Perez. "Our residents are paying the bill for those additional deputies. So if the problem is not with our contract, relieve some of those deputies that are covering those positions in the county.

While Villanueva supports her position, he explained that they cannot take a body from an unincorporated station and move them to a contract city. However, patrol schools of 40 students from custody in training will be moved out to help cover the deficit in public safety.

Villanueva encouraged the council to continue voicing their thoughts to the Board of Supervisors to change their

# Metro to reduce bus service due to operator shortages

■ Among the lines impacted is 111, which runs through Downey from Norwalk to LAX.

**DOWNEY** – With bus operators leaving Metro at higher rates than they're being hired, the transit agency will temporarily reduce bus service beginning Feb. 20 to avoid more unexpected cancellations.

The Metro Board of Directors he voted last Thursday to reduce shortage. Between Dec. 13 and Jan. 12, several bus lines had 20% or more of their trips cancelled due to the shortage, including the 754, 207, 206, 204, 111, 150, 210, 108, 240, 40, 53, 117, 115 and 81, according to a staff presentation given to the board.

Metro officials said the cancellations disproportionately impact "equity focused communities," particularly in South Los Angeles.

Metro is working to "reduce service strategically throughout the network with (an) equity lens" using its NextGen Bus Plan as a framework, and working to have no change to the NextGen route network or operating days and times, they said.

The NextGen Bus Plan is Metro's re-imagined bus system that was implemented last year. The goals of the plan were to double the number of frequent Metro bus lines, provide more than 80% of bus riders with 10 minutes or better frequency, improve service and ensure a improve service and ensure a quarter-mile or less walk to a bus stop for 99% of riders.

As Metro aims to reduce cancellations during the operator shortage, service will temporarily be reduced based on a line's tier within the NextGen Bus Plan.

The first tier, which typically has service every 5-10 minutes on weekdays and 7.5-15 minutes on weekends, may be temporarily reduced to 5-15 minutes on weekdays and 7.5-20 minutes on weekends. Of the lines with high cancellations, 753, 207, 204, 111, 210, 108, 240, 40, and 53 are in the first tier.

Beginning Feb. 20, bus service will be reduced by 800,000 "revenue service hours" or the time per year that a vehicle is available for service. Metro aims to begin service restoration in June 2022 at the earliest.

Metro said the reduction of operators has occurred due to a "perfect storm" that includes the national labor shortage, attrition greater than hiring and employees contracting COVID-19.

Metro bus operators began to leave the agency at higher rates than they were being hired in July 2021. Since that time, 356 bus operators have left the agency and only 207 were hired. In December, 11 were hired and

According to Metro, reasons for people leaving include retirement, personal reasons, misconduct, new job acceptance and unsatisfactory performance.

2%, Metro reported.

To hire add operators, Metro is increasing their \$17.75 to \$19.12 at

The agency has about 3,119 bus operators, and needs to add an additional 448. It's also down 28 rail operators, with only 298 currently working.

The bus operator shortage has increased bus service cancellations to about 10%-15%, up from the pre-pandemic cancellation average of about 1%-


To hire additional bus operators, Metro is considering increasing their pay from \$17.75 to \$19.12 an hour as a six month pilot. It will also set up career kiosks at Rosa Parks/Willowbrook, East L.A. and Wilshire/Vermont stations in April

In order for full service to be restored, Metro said it will need to have no more than 30 new COVID-19 cases per month among operators, have at least

3,677 bus operators and 326 rail operators, and reduce systemwide bus service cancellations to 2%, down from the current 10%-15%.

The agency will also have to reduce its "mandatory call back" to 200 per week, down from the current average of 800. The call backs are a process in which Metro orders staff to work on their days off, which has been occurring during the operator shortage.

Unfortunately, the contributions of Black Americans to the birth of our nation were, for the most part, unrecorded and soon forgotten. After the Revolutionary War, Black After Americans were virtually excluded from the military forces until they volunteered to serve during the War of 1812.

When New Orleans was threatened, a segregated militia unit made up of Haitian refugees called the Battalion of Free Men of Color participated in a raid on the British camp and then held its portion of the line. After the battle, General Andrew Jackson addressed the troops and said: "You surpassed my hopes. The nation shall applaud your valor."

Despite the heroism of these units during the War of 1812, Black Soldiers were again barred from Army service until the Civil War. President Lincoln's Emancipation Proclamation in

Continental Army. In April of 1863 declared that former slaves 1775, Black Soldiers fought at the Battle of Concord, and on Christmas night, 1776, Black Soldiers crossed the Delaware Soldiers with Concord Course with C - about 10 percent of the U.S. Army at that time.

> As you may know, the 54th Massachusetts Infantry Regiment was one of the first official units of Black Soldiers raised by a state as "U.S. volunteer infantry" during the Civil War and one of the most celebrated.

> The 54th volunteered to lead the assault on Ft. Wagner in Charleston, South Carolina. The unit suffered enormous casualties before being forced to withdraw. In the end, the 54th lost two-thirds of their officers and half of their troops. The unit was widely acclaimed for its valor during the battle, which encouraged further enlistment and mobilization of Black Soldiers, a development that President Lincoln credited with helping to secure the final victory of the U.S. Army.

> Throughout the Civil War, Black Americans served as nurses and doctors caring for Soldiers regardless of the color of their skin, though they themselves remained oppressed.

'Reminiscences of My Life In Camp," Susie King Taylor, known as the first Black American nurse, documented her experiences with the 33rd U.S. Colored Troops Infantry Regiment and wrote of the service of Black Americans and her hope for the future, where, as she said, so many of our people have shed their blood with their white comrades, that the stars and stripes should never be

During America's expansion westward, Black Soldiers again westward, Black Soldiers again protected our national interests. The 10th U.S. Cavalry, nicknamed "Buffalo Soldiers," served long, isolated tours of duty in the Southwest, protecting settlers; serving as the first park rangers at Sequoia, Yosemite and Yellowstone National Parks; guarding the mail and protecting the engineers and laborers who built the railroads. Their presence was key to the growth of America in the west.

In World War I, more than 350 thousand Black Soldiers served in segregated units, mostly as support troops. The 369th Infantry Regiment - an all-Black National Guard unit commonly referred to as the "Harlem Hellfighters," shattered the lie that Black Americans were unsuitable for combat. The men of the 369th were attached to a division of the French army for 191 days on the front lines, at one point advancing almost nine miles through strong German resistance. For their actions, the Soldiers received the French medal for bravery in combat.

Black nurses also served with distinction in World War I. One historian wrote, "Although these nurses were required to live in segregated quarters, the strength and dignity of the Black women prevailed, and they served their country and practiced their profession with great skill and distinction."

During World War II, more than one million Black Americans served in uniform. Perhaps the most famous segregated unit was the 332nd Fighter Group of the United States Army Air Forces.

These airmen were part of the experimental Tuskegee Training program, which trained Black Soldiers to be aviators. This program turned out skilled fighter pilots who earned 96 Distinguished Flying Crosses for their fighting in Italy and throughout occupied central and southern Europe.



In World War II, segregation initially kept thousands of medical professionals from volunteering to serve their country. When Captain Della Raney became the first black nurse commissioned in the Army, the service had restricted the number of Black nurses who could join to 56 - and they were only allowed to work in segregated camps. As the casualty rate of service members increased and the demand for nurses rose, Black leaders across the country fought to lift the quota and allow the more than 9,000 Black nurses who had volunteered to finally join the fight. In the end, only 500 were able to serve.

Although Black Americans fought with distinction in World War II, this racism and segregation continued when they returned home. Accounts of this racism and physical violence against these veterans garnered national attention, and in 1948, President Harry Truman issued Executive Order 9981, which called for equality of treatment of the Armed Forces. Sanctioned segregation within the Army was no longer allowed. no longer allowed.

The Army simply could not accomplish its missions without the skill and dedication of ALL of its members. We find our true

# It's time to change the homeowners' exemption

This month I want to take moment of your time to visit about a property tax savings program my office offers that's ust waiting to reduce your budget. Moreover, I am going to be advocating for an increase in this tax-savings program.

I'm speaking about the Homeowners' Exemption that has been available since 1974 that automatically reduces your tax burden by \$7,000, if the home is your primary residence as of Jan. 1. That translates to an actual reduction of \$70 to a homeowners' tax bill. It's not much and in dire need of an

Let's say hypothetically, the assessed value savings was to increase modestly to \$20,000. That translates to an actual savings of \$200. Since the whole point of the Homeowners' Exemption is to encourage home ownership in the state, it should at the very least keep up with the rising costs of homes. In 1972 the median home price in California was about \$34,500, where now home prices come in about \$790,000 statewide, according to the latest figures from the California Assn. of Realtors.

For now, to get the existing savings, all the homeowner has to do is fill out the application assessor.lacounty.gov/ exemptions/homeownersexemption and they are good to go. The deadline is Feb. 15 to get the entire savings but if you miss the deadline, please file anyway and you will get it prorated this year and the full amount the following years. Homeowners need only apply once in order to receive these savings each year. The savings continue until a change (such as a sale) is

recorded.



However, nearly one in three homeowners in Los Angeles County do not take advantage of this tax savings' program, leaving \$30 million unclaimed each year. Across the County, an additional 435,000 families can be saving on their tax bills.

The Homeowners' Exemption is even more important now than ever before because of Proposition 19. Prop. 19 changes the rules that apply to transfers between parents and children and grandparents to grandchildren. It mandates that any property not being used as the primary residence will not be eligible for the transfer of the existing lower

Furthermore, the parent/owner of the home that is going to be left to the children should have the Homeowners' Exemption at the time of the transfer. The child receiving the home does have one year from the date of transfer to acquire the Homeowners' Exemption. If the home does not have the Homeowners' Exemption, the children will not receive the tax benefit, and they could get stuck with a huge property tax increase.

# Californians look to local leaders for relief ahead of swipe fee increases

As the holiday season comes to a close and Los Angelenos return to business as usual, one thing that remains is rising prices. Though retail sales spiked well before Christmas, Californians are still finding it harder to grapple with inflation and growing prices at the pump

One way lawmakers could help reduce the financial strain on Californians is by addressing the root cause of rising swipe fees that unfairly burden small businesses and raise the prices of goods for everyday Americans trying to afford the basic necessities. By promoting competition in the payments marketplace, our elected officials can help end the monopolistic control by the four major credit companies, Visa, Mastercard, American Express, and Discover, that has led to ever-higher

While businesses and the broader economy work to recover from the pandemic-induced recession, Visa and Mastercard, who together control an overwhelming share of the credit card market, are planning to saddle merchants with yet another round of swipe fee increases. The fee hikes were postponed during the pandemic after public and congressional pressure, but have been rescheduled for this April. Californians are now looking to their elected officials on Capitol Hill to stay vigilant and continue their opposition to these upcoming swipe fee increases.

Credit card companies initially used swipe fees to recoup the cost associated with electronically processing card payments by forcing

merchants to pay an additional fee for every transaction. Through technological advances, processing these transactions is now far less costly—though you'd never know looking at the ever-increasing swipe

Instead of keeping swipe fees reasonably priced and closely associated with the cost of processing these transactions, credit card companies have instead lined their pockets and expanded reward offerings for their credit card customers. In 2019, Visa and Mastercard alone raked in over \$67 billion from swipe fees, which is more than double what they earned nearly a decade earlier when there were more costs associated with processing transactions. Given the control these companies have over the payments marketplace, they can continue raising fees indiscriminately.

Swipe fees can range anywhere from 2 to 4 percent, depending on the rewards or bonus points associated with the credit card. Reward offerings are one of the biggest perks to using a credit card, but credit card companies often use a portion of swipe fees to enhance these benefits to attract new card users at the expense of working-class Americans who often do not qualify for the best rewards cards.

Adding a surcharge or banning the use of credit cards would alienate customers and cost more than the business would save on not paying the swipe fees. Therefore, this practice forces businesses like grocery stores and markets—where slim profit margins average around 1 to 3 percent to raise prices across the board. In California alone, experts say food prices are up an average of 5.3 percent from last year.

Meanwhile, high swipe fees remain hidden to consumers. But across-the-board price increases hit everyone, including under- and unbanked Americans who disproportionately include historically disadvantaged groups. These individuals are far more likely to pay in cash and demographically tend to be younger, poorer, and more diverse. Therefore, already overburdened communities are unknowingly being forced to help pay for credit card reward programs that many of them aren't able to take advantage of themselves. This is particularly true in Los Angeles County where almost one in five neighborhoods lack a bank or credit union, making it hard to cash a paycheck let alone benefit from premium credit card rewards.

In a recent survey, over half of the respondents said inflation was causing either major or minor strain on their financial situation. This increase in the cost of everyday goods paired with sky-high gas prices in Artesia and the surrounding area, which are breaking records, is too much for many families to afford. Credit card companies have acted to increase their own profit with little regard for how they affect merchants or consumers. Californians need their elected officials to keep up the pressure and find ways to increase competition in the payments marketplace to lower prices for everyone.

# A beauty queen's tragic death reminds us to always get help

Why did Cheslie Kryst, a former Miss USA with law degree, an MBA and an on-camera gig on "Extra," a celebrity TV show, leap to her death from a posh Manhattan apartment? As the cliche goes, she had everything to live for.

We've heard much about suicides as deaths of despair, with "despair" often defined as drug addictions, job losses and falling income. As far as we know, Kryst did not suffer those afflictions. But then again, neither much in people's heads. did fashion powerhouse Kate Spade or celebrity chef Anthony Bourdain, both of whom took their lives.

Despair comes in many forms. Trying to suggest a reason for Kryst's suicide, The New York Daily News landed on the anguish she apparently felt at getting older, a special concern for women who rely on their looks

young-beauty label. But what about her law degree? Lawyers in their 30s

For we who can't imagine turning 30 as a cause for despair, much less a reason to die, it may be illuminating to read Kryst's astounding words in a recent essay for Allure magazine.

"A grinning, crinkly-eyed glance at my achievements thus far makes me giddy about laying the groundwork for more," she wrote, "but turning

30 feels like a cold reminder that I'm running out of time to matter in society's eyes — and it's infuriating.'

Also, "Society has never been kind to those growing old, especially

Though by any standard of beauty, Kryst was still one, it's hard to deny that women getting older don't lose visibility that men of the same age retain. But that all-purpose villain, society, has no army. It is pretty

We must look at the nature of suicide. Kay Redfield Jamison, an authority on mood disorders, cites mental illness, especially untreated depression, as the most important risk factor for suicide. Downplaying the role of external problems, she quoted a suicide note written in 1931 by a very successful artist, Ralph Barton.

approbation. "I have had few real difficulties," he wrote, and "more than my Kryst was 30, perhaps a time when a woman starts aging out of the share of affection and appreciation." He said "melancholy" rather than problems in his life were his torment and that people looking elsewhere

> Suicide attempts are often impulsive, caused by passing crises, experts on the subject say. And that's why suicide rates among owners of handguns are especially high. The death is quick and certain. There's no calling 911 when someone administering a drug overdose has second

Marilyn Monroe was another case of a troubled woman who banked on physical attraction. Monroe was 36 when she probably intended to kill herself from an overdose of barbiturates. The Hollywood bombshell was found dead with a phone in her hand, leading police to speculate that she was trying to call for help at the time.

It is notable that Kryst did have other things going for her at the time. She had worked on reforming the American justice system. She did free legal work for prisoners believed to have been sentenced unjustly. And she produced a fashion blog, which enabled her to shine behind a keyboard instead of in front of a camera.

Jumping from a window does not allow for a change of mind, which made Kryst's death extra tragic. Intervention by a mental health professional might have reversed the deep emotional dive that pushed

That's the case among so many others suffering mental anguish, who, unlike Kryst, didn't have the financial resources to obtain help. How terribly heartbreaking that Kryst had no one there to pull her from the

# Three women tasked with lighting the supreme darkness

It's all good, to show and tell the American people that Democrats are the party that walks the walk and "looks like America." The phrase originally came from former President Bill Clinton.

The mandate is revealing an increase in tension among the public; segregation of those that comply and those that decided what is the best decision for themselves even if it is the unpopular decision.







The quake, with a preliminary magnitude of 3.3, struck at 9:26 a.m. less than a mile south-southwest of Cudahy and 1.8 miles northeast of Lynwood, according to the U.S. Geological Survey.

Southland earthquake expert Lucy Jones wrote on Twitter that the quake was "quite deep at 14 km," but said it was "probably felt around much of LA basin.'

Meanwhile, a 3.3 magnitude earthquake struck about a half mile southeast of South Gate at 2:15 a.m. on Wednesday, according to the

The earthquake was about 10 miles deep. It was 1.3 miles south southwest of Lynwood, 1.4 miles northeast of Cudahy, 1.8 miles northwest of Walnut Park and 4.3 miles east of Downey.

MAYWOOD - A man who was shot to death in Maywood was publicly identified Wednesday.



In February, we decided to have a family Christmas. Dad loved the holidays so much and we wanted him to enjoy another one. We strung lights all around the house, inside and out. We strung strings of Christmas cards from family and friends. We decorated a tall house plant with ornaments and lights. I still had a very small Christmas tree in a pot that was dead and brown because I kept saying that I was going to decorate it when Dad was well enough.

So in February we hit the switch. The house was completely lit up. The tree, the plant, the window, lights and all. The manger was set. Christmas music played in the background. Christmas sweaters and children in their fancy little clothes. It was Christmas. All of the unopened gifts that had gathered dust for two months were piled around the little dead, brown tree. It was beautiful.

# LA judge denies defense bid to have Huizar search results tossed

**LOS ANGELES** – A federal judge Monday denied a bid by Jose Huizar to suppress evidence that the former Los Angeles city councilman was removed from a Las Vegas casino after refusing to reveal the source of tens of thousands of dollars of gambling money he was using when he was identified as an elected city official.

During a lengthy hearing to discuss pending motions, U.S. District Judge John Walter rejected efforts by Huizar's attorney to show that an affidavit used to obtain a search warrant resulting in the seizure of more than three years of Huizar's emails and other documents was overly broad and otherwise faulty. It was one of several defense motions denied by the

In addition, Walter indicated he wants to extend the Huizar trial date from May to Oct. 18. Trials for certain co-defendants could take place earlier depending on the judge's ruling on severance.

Finding that the affidavit discussed in the first motion indicated "a fair probability of Huizar's corrupt intent," the judge determined that "it was more than reasonable to seek the evidence in the subject's email accounts." The results would be admitted, Walter concluded.

The judge quoted from the 36-page affidavit sworn to by an FBI special agent that details evidence from a variety of sources including several witnesses, hotel and casino records, flight records -- establishing that between 2014 and 2016, Huizar

made eight gambling trips to Las

Vegas with a billionaire Chinese

developer alleged to have

business in his council district.

Huizar, the central figure in a six-year probe of suspected corruption in City Hall politics, and his associates were allegedly involved in a \$1.5 million pay-toplay scheme in which real estate developers were shaken down for cash and campaign donations in exchange for help getting building projects through the city's approval process.

Defense attorneys contend that Huizar's only crime was acting as an "evangelist for robust development" whose representative mission as of Council District 14 was to bring hotels, apartments, jobs, tourism, and entertainment to the city's downtown, according to court filings.

public Huizar's federal attorney, Charles defense Snyder, alleged there were errors in the government paperwork used to obtain the primary search warrant, and asked Walter to schedule a special hearing to determine if the agent lied in the affidavit. The judge denied the

Huizar, who represented downtown L.A. and was the chairman of the Planning and Land Use Management Committee, has denied all allegations.

The affidavit states that on the ex-city councilman's fifth trip to the Palazzo casino with codefendant Wei Huang, president of a global development company headquartered in China, casino staff detected "suspicious activity between the two and provided evidence of that suspicious activity to the FBI."

evidence The included surveillance footage of Huizar gambling with Huang and two other co-defendants in a "highend gambling salon reserved for high rollers" and sharing Huang's casino chips, according to the affidavit.

Additionally, gaming records show that Huizar played and ultimately cashed in tens of thousands of dollars in chips that he did not purchase, and hotel records indicate that the developer gave Huizar private jet transportation and luxury accommodations, prosecutors allege.

documents include references to the observations of Palazzo employees, some whom described interactions with Huizar when they confronted him and asked him to sign documents intended to confirm that, as an elected official and "politically exposed person," he had an "independent

to demonstrate that he was gambling with his own money."

Huizar refused to sign the documents, giving the impression that he was trying to "stay under the radar," and was escorted out of the gaming area for failing to provide information "to allay the casino's suspicions that he was engaging in corrupt activity on its premises," prosecutors allege.

He left more than \$14,000 in chips on the table, which Huang then used to continue gambling, according to a witness quoted in court papers.

In addition to the Palazzo trips -- which the affidavit notes ended after the hotel's compliance staffers identified Huizar and asked him to certify the source of his gambling money prosecutors allege that Huizar accompanied Huang on three subsequent gambling trips to different Las Vegas casinos.

It is also alleged that Huizar used his mother's and brother's bank accounts to launder bribe payments that he received from Huang and another person, according to the government.

Attorneys for Huizar argued that 39 months of personal

> in July 2016, as part of the early days of the bribery investigation, the government applied for and received the warrant to search Huizar's personal emails, but the affidavit "lacked probable cause" and provided no basis for obtaining the emails.

> During the nearly four-hour hearing, Walter found no grounds to suppress the affidavit or the evidence that resulted from the search warrants.

Huizar's lawyers previously argued that the bribery case against the ex-councilman should be tossed because the alleged conduct does not violate laws cited in the 41-count federal Esparza, Huizar's racketeering indictment.

In the indictment, prosecutors confuse favors as bribes, deem that First Amendment-protected contributions are crimes, and "virtually everything that Huizar did as an `official act' no matter how informal or disconnected from government

motion.

The federal probe ensnared lobbyists, developers such as Huang, and political operatives, including former city official Defense lawyers said that Raymond Chan. Formerly the general manager of the Los Angeles Department of Building and Safety, Chan was, more recently, the city's deputy mayor of economic development.

> The defense argues that Huizar and Chan saw it as their responsibility to bring development and businesses to downtown Los Angeles. Partly as a result of their work, "the region became a livable and attractive destination for locals and tourists alike. During this period, nearly everyone in Los Angeles talked or heard about how much downtown had improved."

Co-defendants George former special assistant, real estate development consultant George Chiang, and fundraiser Justin Kim each pleaded guilty in 2020 to federal charges.


