MASK MANDATE NEARS END

■ Mask requirements are expected to be lifted soon for most indoor settings.

DOWNEY - The number By Alex Dominguez of COVID-19-positive people hospitalized in Los Angeles dropped County again Wednesday, helping move the county toward this week's anticipated lifting of its indoor mask-wearing mandate.

According to state figures, there were 907 COVID-positive patients in county hospitals as of Wednesday, down from 927 on Tuesday. Of those patients, 157 were being treated in intensive care, down from 174 the previous

The downward trend in hospital numbers is contributing to what is expected to be a major shift in COVID-19 response policy in the county. On Thursday, the U.S. Centers for Disease Control and Prevention is expected to release its weekly update of virus activity in communities across the country. Last week, that data -- which is based largely on hospital admissions and bed availability -- placed Los Angeles County in the "high" category of virus activity, meaning a continued recommendation for mask wearing.

But county Public Health Director Barbara Ferrer said earlier this week that when the CDC issues its updated numbers Thursday, the county is expected to fall into the agency's mediumor low-risk category, removing the federal recommendation for masks in most indoor settings.

If that occurs, Ferrer said the county will issue a new Health 365 days a year." Officer Order on Thursday -taking effect Friday -- that removes the county's longstanding mandate for people to wear masks indoors regardless of vaccination status. That move will put the county in alignment with the state, which dropped its mask mandaté on Tuesday.

Mask-wearing, however, will continue to be "strongly recommended," particularly particularly in crowded settings or while interacting with people at higher risk of severe illness from the

"Despite the encouraging unvaccinated, are immunocompromised or living in low-resourced communities continue to be at higher risk and are more likely to become seriously ill and die from COVID-19," Ferrer said in a statement Wednesday. "Along with the significant protection provided by vaccines and boosters, masks add an important barrier to transmission that protects those most vulnerable from the worst outcomes

"Therefore, Public Health, in alignment with the state, strongly recommends individuals keep their masks on in public indoor settings, regardless of vaccination status, until there is less risk for those at elevated risk.'

Masking will continue to be required in higher-risk settings, including health care facilities, transit centers, airports, aboard public transit, in correctional facilities and at homeless shelters and long-term care facilities.

Indoor masks also continue to be required on K-12 school although campuses, the county and state will lift that requirement on March 12.

County health officials also noted that people attending indoor mega- events of 1,000 or more people -- such as sporting events -- will still be required to show proof of COVID vaccination or a recent negative test to be admitted. Vaccine verification or a negative test will also still be required at health-care facilities and congregate-care facilities.

Downey to house nation's first H2 hydrogen home

■ The innovative home project will demonstrate resiliency and reliability of a hydrogen microgrid.

DOWNEY Southern California Gas Company along with local officials celebrated the start of assembly of its H2 Hvdrogen home, a state-of-theart clean energy project that is the first of its kind in the country.

Gas According to the the Company, modular, prefabricated home will show how carbon-free gas made from renewable electricity can be used to fuel clean energy systems of

Featuring a nearly 2,000 square-foot home, solar panels, a battery, and electrolyzer to convert solar energy to hydrogen and a fuel cell to supply electricity to the home, the H2 Hydrogen home will act as a miniature microgrid, demonstrating how such an energy system could be built on a larger scale to accommodate and power residential neighborhoods and businesses.

Maryam Brown, president of SoCalGas, said that the Hydrogen home would "feel just like a regular home."

"You interact with the appliances the same way you live your life now, and the appliances will be plug and play," said Brown. "The only difference is and it's a great difference - is that the Hydrogen Home will use reliable and clean energy 24 hours a day, seven days a week, fitting place for this project."

The home will draw power from solar panels on sunny the Apollo command modules days and convert excess energy into clean hydrogen, which can be stored and converted back into electricity with an on-site continue to benefit our entire hydrogen fuel cell when solar or population," said Frometa. transparency and responsibility.

Sosa expressed frustration with the current representation in his district.

"Honestly just being transparent - I feel like I'm very involved, I talk to a lot of parents, a lot of residents here in the community, we talk about the issues," said Sosa. "Here in District 2 I feel like we've had a lack of true, genuine leadership, of representation of the residents in our district.

"I'm not trying to bash Sean Ashton, but most of the residents I know feel he hasn't been present in the community. What we need is true representation; someone who genuinely loves Downey and wants to be a voice for the people."

Ashton was approaching the end of his second and final term at the end of this year when he unexpectedly announced his resignation last week, citing a job promotion.

If given the opportunity, Sosa plans to throw his name into consideration to fill the seat in the interim period, as well as run in November.

Sosa's platform is centered around support of public safety, collaboration with Downey Unified School District, support of small business, tackling the homeless problem, and fiscal

His campaign will be funded through campaign fundraisers and contributions, Sosa says. He has also already collected a humble start to his endorsement list, including five DUSD board members (Vice President Martha Sodetani, Clerk Giggy Perez-Saab, Jose Rodriguez, Linda Saloman Saldana, and Nancy Swenson), and former Downey Police Management Association President Captain Mark McDaniel (retired) and former Downey Police Officers Association president Cpl. Mike Pope Police

Sosa says that the current time is "an ideal time for someone like me to run."

"I'm here to - again - provide nonpartisan leadership, to be a voice in the community," said Sosa. "I'm not looking to enrich myself while in office or after I'm termed out; I want to be a true transparent voice for everyone, even those who don't vote for

"I serve no outside interests, no personal agenda. I represent Downey. I grew up here, I love this city, and it's a blessing to call this city home."

Stabbing suspect fatally shot by deputies

BELLFLOWER - A man who allegedly stabbed another man in Bellflower was fatally shot early Thursday by deputies who had gone to the area to investigate a report of a street takeover.

Deputies went to Artesia Boulevard and Downey Avenue about 12:10 a.m. after being notified that several cars had taken over the intersection and were doing "doughnuts," according to the Los Angeles County Sheriff's Department and reports from the scene.

"Detectives have learned that deputies assigned to Lakewood Sheriff's Station were at the intersection ... regarding a street racing call," a sheriff's department statement said.

deputies "While were handling the street racing incident, they were flagged down by a victim who said a suspect had just stabbed him with a garden claw. The victim immediately pointed to the suspect, a male Hispanic in his 30s, and identified him as the person who stabbed him," the statement said.

"Deputies attempted to detain the suspect, but he fled the scene southbound Downey Avenue on foot. When deputies caught up to the suspect, he turned around and advanced on them while swinging the approximately 3-foot-long garden claw with spikes on the end at them, and a deputyinvolved shooting occurred," the statement said.

The 32-year-old man was wounded multiple times, and he died at a hospital. His name was withheld, pending notification of

"The initial victim stabbed by the suspect was treated on scene by Los Angeles County fire paramedics," the statement said. "It appears the street racing incident is not related to the stabbing incident. No deputies were injured during the incident."

Montebello announces new police chief

MONTEBELLO - Los Angeles Police Department Capt. Paul Espinosa will succeed the retiring Brad Keller as chief of the Montebello Police Department as

Espinosa "brings a wealth of knowledge and insight from serving with 11 different LAPD stations and having worked in many specialized divisions including training, community policing, gang impact and narcotic enforcement," Assistant City Manager Arlene Salazar said at Wednesday's City Council meeting in announcing Espinosa's appointment.

Espinosa said he is looking forward to working to "find meaningful ways to enhance policing and public safety."

"I want to work collaboratively with all stakeholders to create a culture of protection and service that focuses on improving the quality of life here in Montebello," said Espinosa, who has spent 28 years with the LAPD and is assigned to the Southwest Community Police Station.

Espinosa grew up in the Northeast San Fernando Valley, received a bachelor's degree in political science from Cal State Northridge and is pursuing a master's degree in law enforcement and public safety leadership from the University of San Diego.

Keller is retiring after 31 years with the Montebello Police Department, including nearly four years as chief.

Keller said at Wednesday's council meeting it is bittersweet to be retiring.

"I'm excited for the city of Montebello and I'm looking forward to my retirement,' Keller said.

Councilman Salvador Melendez called Keller "an amazing person and an amazing and ABC Unified School District. individual" who has "brought so much stability to the city."

Downey could regulate uniforms

DOWNEY - Public outcry over the scantily-clad waitresses at the incoming Ojos Locos restaurant has caught the attention of the City Council, who say the city will explore regulating food service attire in the coming weeks.

According to officials, the city is looking into regulating the attire of waiters and waitresses at restaurants and bars across the city. Council is expected to discuss the matter at their March 8 meeting

This comes after the Planning Commission approved the arrival of Ojos Locos at their Feb. 2 meeting, drawing the ire of many community members over the restaurant's use of waitresses wearing lingerie.

Mayor Blanca Pacheco and Council members Claudia Frometa and Mario Trujillo all made social media statements regarding the controversial restaurant across various platforms and comment threads over the weekend.

The city quickly followed suit, releasing a statement on Tuesday,

"The City of Downey realizes that the future opening of the restaurant, 'Ojos Locos Sports Cantina,' has caused concern among residents in the community. The City would like to assure its residents that it values their input and takes concerns seriously.

In response to this, the Downey City Council will consider amending the Downey Municipal Code at its upcoming City Council meeting, scheduled for March 8th, to review and establish employee dress standards for all restaurants and bars in Downey.

Keeping our residents in mind, we will address their concerns to help regulate employee attire at this establishment," said Mayor Blanca Pacheco.

The City will continue to proactively engage with its business community to ensure that all Downey businesses operate in a safe and orderly manner."

Ojos Locos will take over the former Denny's restaurant on Firestone Boulevard.

LAPD officers now required to explain 'pretextual' stops

■ New policy requires police officers to explain why minor traffic violations escalate into criminal investigations.

LOS ANGELES – The Los geles Police Commission updated its policy on so-called "pretextual stops" Tuesday to discipline officers -- beginning with additional training -- if they don't articulate in the moment why a traffic or other minor violation escalates into a criminal investigation.

The Los Angeles Police Department defines a pretextual stop as one in which officers conducting a minor traffic or code violation escalate it into an investigation of a more serious crime unrelated to the initial

According to the Office of the Inspector General, there were "pretty substantial racial disparities" in stops, many of which were pretextual stops, conducted by the department in 2019, and "a fairly small number of them yielded evidence

of serious crimes or ended up characteristics," including race. resulting in any kind of arrests.

commission to request that the department update its policy, stop will result in "progressive according to Commission discipline beginning with President William Briggs.

"Those pretextual stops do not result in guns being taken off the streets, those pretextual stops do not result in curtailing murders and curtailing shootings ... there is no data that anyone can point to that establishes that pretextual stops curtail violent crime in our city," said Briggs, adding that data collected for the Racial and Identity Profiling Act "shows just the opposite."

Under the updated policy, officers making a pretextual stop will have to articulate on their body-worn video cameras the reason for the change.

"An officer's training, experience and expertise may be used in articulating the additional information the officers used to initiate the stop," the policy update states.

The policy also states that pretextual stops can only happen if officers "are acting upon articulable information" and not a "mere hunch or on generalized

Failure to articulate the Those findings led the information that prompted the officer to make a pretextual discipline beginning with counseling and retraining." The beginning policy adds that discipline will escalate as more violations of the policy are made.

> City Councilman Marqueece Harris-Dawson joined the police commission meeting and called the policy update a "huge step in the right direction." He noted that public trust in the police is "so easily degraded when a person is stopped and they can't figure out why they were stopped or that the reason they were given ist doesn't add up for them.

> He added, "I don't know of an African American male driver, (and) I know very few Latino male drivers, who don't have half-a-dozen stories about" being stopped by police for reasons that didn't make sense.

"It's clear to them, or at least leaves the impression, that: 'I am a person, I'm an individual in this space and for some reason, this officer has decided that I'm suspicious,"" Harris-Dawson

Several people called in to Tuesday's meeting to oppose the motion for allowing pretextual stops to continue at all. Hamid Khan of the Stop LAPD Spying Coalition called the policy update a "facade of reform.

"They still want to maintain their capacity to stop people because if this was truly, they wanted to change this, they would completely ban the pretextual stop," Khan told City News Service on Tuesday.

"... That pretext is about racial profiling, this is about targeting particular communities and this is about constant harassment and intimidation.'

Mona Sutton, who identified herself as the representative for the Community Police Advisory Board for the South Bureau and Harbor Area, said she opposed the policy update for limiting officers' ability to make pretextual stops, arguing against others' beliefs that it undermines public trust in the police.

Another caller also opposed changes to the policy, saying pretextual stops lead to officers finding firearms and drugs.

Police Chief Michel Moore responded to those concerns

Former Porto's employee drops discrimination suit

■ A former worker alleged she was fired after becoming pregnant in 2020 and requesting accomodations.

GLENDALE - A former Porto's Bakery Inc. employee who alleged she was wrongfully fired from the Glendale location in 2020 for getting pregnant -- despite having a stellar work record that earned her praise from fellow workers and management -- has dropped her lawsuit against the popular chain.

of her case on Wednesday with Wendy Chang. The two sides had agreed in November to put the case on hold and have the plaintiff's claims decided by an arbitrator.

Flores sued last July 30, alleging pregnancy and gender discrimination, failure to prevent and a number of violations of the state Labor Code. Lawyers for Porto's denied any wrongdoing by their client.

Flores was hired in December 2019 as a server and sales associate, and her job duties included greeting customers, boxing and bagging purchased items, assisting co-workers and performing other work required by her supervisors, the suit stated. She had no negative work evaluations, her job performance

Flores, filed a request for dismissal pregnancy and many fellow issues, management's attitude employees as well as managers Los Angeles Superior Court Judge commended her for her work, according to her suit. according to her court papers.

In late February 2020, Flores said, she began bleeding at work and asked to leave get immediate medical treatment. Her doctor issued work restrictions that disallowed her from lifting more than discrimination and harassment 10 pounds, forbade her from doing any strenuous exercise or prolonged sitting or standing and directed that she have frequent rest periods, the suit stated.

> Flores told Porto's management that she was pregnant and they in turn transferred her to their customer call center, according to the complaint.

During her pregnancy, Flores said, she became ill at work due to her pregnancy and she once again kept management informed.

Attorney Ronald Yoosefian, was never criticized during Although she did not have any on behalf of plaintiff Kimberly her employment prior to her attendance or job performance

"(Porto's) team grew weary of (Flores') requests and began a campaign to terminate (her) employment, the suit alleged.

Management cut Flores' hours, changed her schedule to times they knew she could not work and refused to provide her with meal and rest breaks, then fired her in April 2020, the suit alleged.

Flores believed she was against discriminated wrongfully terminated because of her pregnancy, gender, medical condition and requests for accommodations, according to her court papers.

She also alleged she was denied overtime pay.

Republicans forget to put America first

After her fellow Republicans booted her from party leadership last year, Rep. Liz Cheney posed a question: "Do we hate our political adversaries more than we love our country?"

Now, with Vladimir Putin's invasion of Ukraine, Republicans are answering that question — in the affirmative.

The dictator is betting that division within the United States will sap American resolve and thereby sow disunity between the United States and European democracies — allowing him to crush Ukraine's democracy and potentially others. And Republicans are giving him what he wants. They are so determined to see President Biden fail that they would let

Tuesday night's State of the Union address, coming six days after Russia started the biggest war in Europe since 1944, offered a timely opportunity to showcase national unity for Putin, and the world. During a similar address to Congress after the 9/11 attacks, President George W. Bush enveloped Democratic congressional leaders in bear hugs. But this time, a number of Republicans boycotted Biden's address, ostensibly because they objected to getting tested for the coronavirus.

Those in the chamber rose to applaud the Ukrainian ambassador, and many wore Ukraine's yellow and blue. But as Biden extolled national unity — "He thought he could divide us at home, in this chamber, in this nation. ... But Putin was wrong." — Republican lawmakers sniped at him

"Joe Biden sought to appease Vladimir Putin from the very beginning," wrote Sen. Ted Cruz (R-Tex.). "Biden is empowering our enemies."

"The United States is back to leading from behind under President Biden," tweeted Sen. Marsha Blackburn (R-Tenn.). "This is the second time Putin has invaded a foreign country while Joe Biden has been in the

How deep was the contempt? As Biden mentioned the cancers that kill many U.S. veterans, including his own son Beau, Rep. Lauren Boebert (R-Colo.) heckled the president.

GOP leaders had set the blame-Biden tone earlier in the day. Rep. Michael McCaul (Tex.), the top Republican on the House Foreign Affairs Committee, likened Biden's actions toward Russia to Neville Chamberlain's appeasement of Hitler, saying, "We have a weak president, and he's creating a very dangerous world.

Also Tuesday, Rep. Elise Stefanik (N.Y.), the No. 3 House GOP leader, said Biden "failed to engage in meaningful deterrence against Russian aggression," and asserted that "the war on Ukraine represents one of the greatest foreign policy failures in modern history.

House GOP leader Kevin McCarthy (Calif.) and Rep. Steve Scalise (La.), the House GOP whip, amplified the attacks on Biden over Ukraine. And Sen. John Barrasso (Wyo.), head of the Senate Republican Conference, said Biden's "policies from Day One have enabled, emboldened Vladimir Putin to do what he has done," adding that it's "as if Vladimir Putin were Joe Biden's secretary of energy.

Some Republican candidates have even been fundraising off calling Biden "weak" on Ukraine.

The relentless assault no doubt undermines Biden — but it also weakens America. Biden's response — the U.S. response — can be only as strong as Republicans allow. By sabotaging the commander in chief, Republican leaders have made it more difficult to rally the nation to accept wartime sacrifices (accepting higher energy prices or, potentially,

A poll released Monday by Yahoo News-YouGov shows how corrosive the Republican assaults on Biden have been. Though Americans overwhelmingly call the Ukraine invasion unjustified, Trump voters actually had a more favorable opinion of Putin than of Biden. Ninetyfive percent of Trump voters expressed an unfavorable view of Biden (including 87 percent holding a very unfavorable view), compared with 78 percent of Trump voters expressing an unfavorable view of Putin (60 percent very unfavorable). Only 3 percent of Trump voters said Biden is "doing a better job leading his country" than Putin, while 47 percent said the dictator, who has brought isolation and economic crisis to Russia, is doing a better job than Biden.

This shouldn't be surprising. Trump, while opposing the Ukraine invasion, has called "peacekeeper" Putin's actions "genius" and "smart," while "our leaders are dumb."

That's a bit rich, after Trump threatened to blow up NATO, unsuccessfully tried to persuade other world leaders to readmit Russia to the Group of Seven and infamously tried to condition military aid to Ukraine on the country's willingness to provide Trump with political dirt on Democrats. Republican lawmakers defended Trump by parroting Russian propaganda falsely blaming Ukraine for 2016 U.S. election sabotage, which Russia actually did.

But this isn't the time to point fingers at political opponents. It's time to confront the real enemy. Do Republican leaders know the difference?

In the official GOP response to the State of the Union, Iowa Gov. Kim Reynolds picked up the blame-Biden theme, accusing him of "focusing on political correctness rather than military readiness" before the Ukraine invasion. "Weakness on the world stage has a cost," she charged.

It does. And Republicans, by undermining Biden in a time of war, risk making America pay.

How wonderful it would be if nations would display camaraderie and support for each other, and would treat their citizens fairly!







Meet Lizzerd Kween, creator of the new musical genre 'wholesomecore'

■ The 24-year-old singer/ songwriter is creating music that helps her (and others)

DOWNEY – Long, slender fingers that, in palmistry, are indicative of an artistic and creative person, strum on a black acoustic guitar in the comfort of a bedroom lit with candles.

"Look in the mirror and all that I see is the person that I thought that I'd never be, it's not my fault, no I know how it goes, I was only 21 when he went under my nose and I wish that I could have been the person you wanted to see.."

These are the words that belong to a warm, friendly smile framed by dark autumn hair feathered into a trendy yet delicate shag haircut.

"Big Sur," "42," and "Getting High" are just some of the songs that have been written, recorded and produced by 24-year-old Kianna Znika.

"It was a click one day, I just bought my acoustic guitar specifically because I just wanted to play along with a lot of the pop punk songs that I was listening to, so I had no intention of making my own

"But there was one night where I was just strumming and playing with my guitar and I just made up my own song and when I finished it, it was like this big awakening moment where I was like 'wait a minute, can I make music? Do I get to be a musician in this life?" said Znika.

Under the name Lizzerd Kween, Znika pours herself into each song, using her music as a way to heal from "a lot of heartbreak that I went through, a lot of things that I needed to

"I listen to songs to help me cope with things and it's nice to make my own songs because I am listening to my own lyrics and I of course relate to it, of course it resonates, I wrote it, so it's nice writing the soundtrack to my own pain," said Znika.

With one voice memo cording at a time. Znika is contradicting the assumption that all independent artists must sit through a stuffy, three-hourlong weekly class about music production in order to get their music ready and streaming.

"So I know for a lot of independent artists, they'll use music software and stuff, like GarageBand and Logic Pro and to be fair, for my recent EP, 'The Journal Entries,' I did finally experiment with GarageBand but I actually don't know too much about music production so two of my top songs that I have produced were like 'Big Sur' and 42,' I literally just played into my phone, like I just recorded straight onto the voice memo, no mics or anything, it's just already on my phone and then I took the file from voice memo, I went to this free website that masters the audio for you and then that's what I submitted to my Spotify and stuff."

The music of Lizzerd Kween tugs at the familiar vein that is independent alternative but

is overhauled with healthy doses of emo, pop punk, folk punk and a little bit of Znika's own invention called,

Znika places an importance on having a safe space when creating her music, with many of her lyrics filled with themes of mental health.

For Znika, pop punk had great influence in her childhood resulting in her being "the biggest emo/scene kid in middle

Her love for pop punk resurrected during the pandemic and that love affair has since embroiled into her EP, "The Journal Entries," which became available for streaming on Spotify Feb. 18.

With 85,800 followers on TikTok, Znika uses the videodriven social media app as a platform to help promote her

Znika said, "I can not go on with my music stuff and not address TikTok because that was like the biggest thing. Once, I already had a little bit of a following, I started promoting my music and people started liking it, then they just wanted to support it because it was just me and they wanted to support this [my music]"

Although Znika says that she still hasn't "found a way to promote my music without feeling awkward," a quick browse at her TikTok profile, under the name Lizzerd Kween, and any sense of awkwardness can not be detected in the curated blend of Znika playing her music or her participating in a TikTok trend.

When promoting her music, Znika prefers to reinforce in her audience that she is a person, not a product.

"I always try to remind people that I don't want to pick a niche and I like to remind people that I'm a person, not a brand, not a product, so it's okay to be more than one thing and

that it's okay to branch out and stuff and I feel like honestly that brings me just logically more success, if I just continue to be myself and then people will just naturally listen to my music rather than saying 'Hey, here's a product which is my song," said

Having a public social media platform can be a doubleedged sword for content creators, one side can wield comments of inspiration and affirmation, while the other side can suddenly flash random comments fueled with negativity.

Znika has learned to read negative comments with a sense of patient grace, blocking negative comments that are unmotivated, not taking that energy with her and coming to terms that most negative comments are projections of the

It is with this sense of growing surety, that Lizzerd Kween confidently records and produces her music.

"It's pretty challenging sometimes, sometimes it can get stressful but it's really exciting, it's almost like I'm really surprised at how 'easy' it is, every time they say just do it, just start, you have to start somewhere, they're right.

"So I'm just starting off even though I don't have all the equipment and stuff, it's just exciting knowing that I'm releasing music but I'm still such the beginning stages so even if it's not the best quality it's only going to get better because I'm' going to invest in the equipment and my skills are only going to get better over time so it's humbling and it's nice knowing it's okay wherever you start,"

However, despite how effortless Znika makes selfproducing look, she does seek the help of a producer for particular tracks as the independent artist solely

funds and budgets her production time.

"There are a lot of times where I have to invest when I go to the producer and I have to save up money and I still have to pay bills and then I need food and everything so it's like literally whatever I have left then I can use it for music and if I don't have enough, then oh well," said Znika.

Initially starting her path in music in November 2020, Znika has a total of 1,820 monthly Spotify listeners streaming her music. Lizzerd Kween has been streamed by listeners in another continent, with one of Znika's top listeners being a 17-year-old named Phil in Germany.

"One of my biggest supporters is this little kid in Germany. I'm not lying, there's this 17-year-old kid in Germany, he comments on all my videos and stuff and they show me they have like countdowns for my song releases. They get notifications and they're like saying, 'you're genuinely one of my favorite artists' and they sent me screenshots of their Spotify. And, yeah, it's this point where I'm like, oh my god, like, I am genuinely this kid's favorite artist.

Znika's EP, 'The Journal Entries' and singles can be streamed on Spotify and SoundCloud and can be found under her artist name Lizzerd Kween on all social media platforms.

Znika said, "Lizzerd Kween was a nickname given to me by a friend in senior year of high school and it kind of just stuck, like my friend group would

always call me 'Lizzerd Kween' and there was always like a lot of elements and stuff in my life that made the nickname more and more suitable, it brought me a lot of confidence, so I made my socials that and everything. I never imagined that it would become my artist name but because it was on all of my socials and was my nickname already, I thought it was a good

"I was like, 'I was meant to release music as 'Lizzerd Kween.'"

Hollywood Bowl releases star-studded 2022 calendar

HOLLYWOOD – The Los Angeles Philharmonic Association this week announced the 2022 Hollywood Bowl season, offering a mix of beloved traditions and history-making innovations, tributes to legendary figures of the Bowl's past and great stars of the present, the best in jazz and popular music and 34 evenings under the stars with the Los Angeles Philharmonic, 10 of them under the baton of Music and Artistic Director Gustavo Dudamel.

Many of the biggest names in entertainment are scheduled to appear at the Hollywood Bowl during its centennial season. The historic line-up includes Kenny Loggins with Jim Messina (July 15–16), Ricky Martin with the LA Phil and Gustavo Dudamel (July 22–23), Boyz II Men and TLC (July 29), John Fogerty (July 30), a-ha with the Hollywood Bowl Orchestra and Principal Conductor Thomas Wilkins (July 31), Sheryl Crow and Keb' Mo' (Aug. 3), The Gipsy Kings featuring Nicolas Reyes (Aug. 19–20), Diana Ross (Aug. 26–27), Duran Duran with fireworks (Sept. 9–11), Pink Martini (Sept. 14), Lang Lang (Sept. 15), Grace Jones and CHVRCHES (Sept. 25) and Pentatonix (Sept. 29).

Annual traditions that light up the Hollywood Bowl include the popular July 4th Fireworks Spectacular (July 2-4), this year featuring Steve Martin, Martin Short, the Steep Canyon Rangers and Jeff Babko with the Los Angeles Philharmonic led by Thomas Wilkins.

The Tchaikovsky Spectacular (Aug. 12-13) will see acclaimed violinist Joshua Bell and the USC Trojan Marching Band joining conductor Bramwell Tovey and the LA Phil for the Tchaikovsky Violin Concerto, 1812 Overture, and fireworks.

The annual fully staged Broadway musical will be "Kinky Boots," the recent smash hit that was penned by Cyndi Lauper (music and lyrics) and Harvey Fierstein (book) and won six Tony Awards. The Bowl's production will feature an all-star cast (to be announced) and will be directed and choreographed by Tony-winning choreographer Jerry Mitchell (July 8-10).

Film presentations with live accompaniment by the LA Phil and Hollywood Bowl Orchestra will include screenings of "Harry Potter and the Deathly Hallows Part 1 in Concert" (June 30), "Back to the Future" (Aug. 5-6), and "Amadeus" (Aug. 23).

"Three Maestro of the Movies: Celebrating John Williams at 90" nights (Sept. 2-4) will welcome John Williams and David Newman conducting the LA Phil.

"Black Movie Soundtrack" returns for its fourth edition with bassist Marcus Miller leading a house band in the best music from the history of Black cinema, with Craig Robinson as host and the Hollywood Bowl Orchestra conducted by Thomas Wilkins (Aug. 24). The annual Sing-A-Long Sound of Music returns with host Melissa Peterman (Sept. 17).

Concerts paying tribute to musical legends from the Bowl's storied history will include: Billie Eilish and Debbie Harry among the many guest artists in a special concert saluting Peggy Lee and Frank Sinatra (July 27); an evening of Rachmaninoff Seconds—Piano Concerto No. 2 and Symphony No. 2—with soloist Nobuyuki Tsujii joining Bramwell Tovey and the LA Phil (Aug.16); and Itzhak Perlman as soloist and conductor in the Bach D Minor Concerto for Two Violins, joined by Randall Goosby, and Tchaikovsky's Symphony No. 4 (Sept. 13).

The world's greatest tribute band returns to the Bowl stage to perform some of the biggest hits of all time with ABBA The Concert (Sont 24)

The 100th season also showcases the range of Gustavo Dudamel's talent in every musical genre. Dudamel will lead an evening celebrating the legacy of Leonard Bernstein and his connection to the Bowl (July 12 & 14) and conduct the third act of Wagner's Die Walküre (July 17), collaborating with director Yuval Sharon and an all-star cast headed by Christine Goerke and Matthias Goerne.

Paying tribute to the history of dance at the Bowl, Dudamel will lead a program featuring stars of the Paris Opera Ballet on a program also featuring pianist Jean-Yves Thibaudet (July 20-21). Pianist Seong-Jin Cho will join Dudamel for a double program of Beethoven Fifths: the "Emperor" Concerto and Symphony No. 5 (July 26).

Soloist Jorge Glem will perform the world premiere of Gonzalo Grau's LA Phil-commissioned Cuatro Concerto under Dudamel's baton, and the Los Angeles Master Chorale will join the LA Phil and

Music in the Schools program returns

DOWNEY - It's back -- the Downey's Symphonic Society's outreach program for schools.

Like Christmas for the Grinch and the Whos in Whoville, the music just keeps coming and coming. In April and again in May, the yellow school buses will roll up all morning to the Downey Theatre, bringing children to hear symphonic music programmed just for them by Dr. Tom Osborn when he was the music director in the

"We've been away," said music director and conductor Sharon Lavery. "The children love these programs."

But challenges raised by the virus have turned out to be expensive when it comes to musical performances. In past years, the Theatre has been filled and refilled on a clockwork schedule starting at 9 am. Logistics call for three 45-minute performances, to seat all the children, filling the 750-seat auditorium each time. Same for the fifth grade concert.

But with COVID regulations, Downey Theatre staff has to wipe down and disinfect each seat between performances. That takes one hour between each performance, and that doubles the time that the musicians are on the Downey stage, performing. Anyone familiar with union regulations knows what this means. Time is counted "from the first down beat to the last note," Sharon said.

This additional time is referred to as "a double service," and the anticipated fee for each professional player is now doubled, adding \$8,000 for each day's event.

The Quintet that takes Music in the Schools to each K-5 and middle school is paid for by individual contributions, donations and a grant from the Hillecke Foundation, but these morning school concerts in the Theatre are special. The Downey Unified School District has volunteered to underwrite one, and the Kiwanis Foundation traditionally sponsors the other musical experience.

The Mozart effect shows that listening to classical music can improve children's scores in reasoning. Children definitely feel calm and relaxed while listening to live classical music, regardless of the piece being played, a study has found.

And so do we all. Welcome back, Music in the Schools.

With Covid easing, Santa Fe Springs man talks life on a Navy aircraft carrier

SANTA FE SPRINGS – Airman Robert Rodriguez, a native of Santa Fe Springs, serves the U.S. Navy aboard one of the world's largest warships, the U.S. Navy aircraft carrier USS George H.W. Bush.

Bush was commissioned in 2009 and is completing a predeployment work up cycle.

"Our sailors' hard work to return George Herbert Walker Bush to the operational fleet in 2021 was exemplary," said Capt. Robert Aguilar, GHWB commanding officer. "They represent the best principles of service to the mission and the nation that our namesake, President George H.W. Bush, embodied."

Rodriguez joined the Navy two years ago.

"I joined the Navy to serve my country, which I love dearly," said Rodriguez. "I also wanted to take advantage of the help for school."

Growing up in Santa Fe Springs, Rodriguez attended Santa Fe High School and graduated in 2016. Today, Rodriguez relies upon skills and values similar to those found in Santa Fe Springs to succeed in the

"I learned the importance of staying humble and working hard," said Rodriguez. "My hometown is a small city, so it's important to be kind to everyone."

These lessons have helped Rodriguez while serving in the Navy.

Rodriguez's service aboard Bush follows the example of the ship's namesake, the nation's 41st President, George H.W. Bush. Bush is the only U.S. president to serve as a U.S. Navy aviator. He was awarded the Distinguished Flying Cross for a daring bombing run over the island of Chichi Jima.

The ship bearing Bush's name is preparing for deployment amid ongoing strategic competition between the U.S. and its adversaries. In doing so, the ship and its Sailors continue the legacy of service to the nation that U.S. Navy aircraft carriers have provided for 100 years.

"I'm proud that I can take control of my future based on the experiences I gained in the Navy," said Rodriguez.

As Rodriguez and other sailors continue to train and perform missions, they take pride in serving their country in the United States

"Serving in the Navy makes me feel like I am a part of something greater than myself," added Rodriguez. "This is a life where I can contribute rather than just partake in luxuries. It's more of giving back for the opportunities you get in the civilian world.

a property when someone dies?

This month I'm going to share information about a delicate subject, but also a very important one - dealing with property taxes and what should be done upon the death of a property owner.

Needless to say, the death of a loved one is a traumatic event, to say nothing of putting their affairs in order - dealing with inheritance, insurance, finances, and property. The following information generally covers what needs to be done if they owned property in Los Angeles

Anytime a property owner dies, the County Assessor must be notified. This is done by filing the Change in Ownership - Death of Real Property Owner Form. The form must be filed in addition to any notification made to law enforcement, the Coroner, or even the Registrar-Recorder/ County Clerk.

The Change in Ownership -Death of Real Property Owner Form must be filed with the Assessor within 150 days of the date of death. If the estate is in probate, the Assessor must be notified at the same time that the "inventory and appraisal" is filed. Failure to notify the Assessor may result in penalties and can complicate other parts of the transfer process.

The executor (whether a family member or legal representative) should file the Change in Ownership Statement -- Death of Real Property Owner Form and mail it to the Los Angeles County Assessor, Ownership Services Section, 500 W. Temple St., Room 205, Los Angeles, CA 90012, along with a copy of the death certificate. Also, you will find the required forms and a checklist that will take you through each step at my website: assessor.lacounty.gov/ Real-Estate-Toolkit/death-ofa-property-owner. I encourage you to avail yourself of this useful information.

Furthermore, if the property is passed from a parent to their child(ren), there may be property tax savings available, called the Parent-Child Exclusion. However, that process has changed since the voter-approved Proposition 19 went into effect last year. Generally speaking, the parentchild exclusion allows a child to inherit property from their parent(s) without the property being reassessed: meaning they keep the parent's tax base.

Prop. 19 now mandates, however, that any property not being used as the primary residence will not be eligible to transfer the existing lower tax rate. The child receiving the home has one year from the date of transfer to acquire the

Homeowners' Exemption, if the home does not have it already. If the home does not have the Homeowners' Exemption, the children will not receive the tax benefit. The Parent-Child Exclusion is not automatic and must be applied for to receive the

A common point of confusion is when the property is in a trust. While trusts can have many benefits, they don't protect from reassessment. Whether or not the property is in a trust, the Parent-Child Exclusion must be filed to receive the savings. Similarly, property can be transferred from a grandparent to a grandchild, if the parent is deceased. The Grandparent to Grandchild Exclusion must also be filed. Applications for both Parent-Child Exclusions and Grandparent to Grandchild Exclusions must be made within three years following the date of death, (or other transfer) but prior to the date of sale or transfer to a third party.

Whenever you are considering filing documents that affect the ownership of your property, I encourage you to seek legal advice and assistance before filing those documents. The information provided here should not be construed as legal

What happens to County OKs settlement of lawsuit over Sheriff's Department records dispute

LOS ANGELES - The Los Angeles County Board of Supervisors approved a \$185,000 settlement Tuesday with a New York law school that sued the sheriff's department alleging a failure to adequately respond to a request for public records.

The Brennan Center for Justice at New York University School of Law filed is lawsuit in 2019, accusing the sheriff's department of failing to adequately respond to a request for public records involving the agency's use of "predictive policing" software. According to the lawsuit, the sheriff's department paid more than \$7.5 million in 2014-15 for such programs, which are designed to identify "locations where crimes are likely to occur."

The center submitted its records request to the agency in June 2016, asking for "10 targeted categories of public records relating to the LASD's evaluation, purchase and use of predictive policing technologies."

"After providing a partial response to the Brennan Center's request, the LASD multiple deadline claimed extensions before eventually ceasing communication with the Brennan Center," according to the lawsuit. "As a result,

more than two and a half report. years after the Brennan Center first made its request to the LASD, several categories of the original request still remain outstanding.

Last year, a Los Angeles Superior Court judge ruled in the favor of the center, and set a schedule for the sheriff's department to disclose the requested records.
