Hospitalizations climb as Covid spreads

■ Health officials say mask mandates could return as an increasing number of people are becoming sick with the coronavirus.

DOWNEY - The growing local spread of COVID-19 was evidenced Wednesday when Los Angeles County reported 4,384 new infections, and perhaps more troubling, the number of people hospitalized surged upward.

According to county and state figures, there were 363 COVIDpositive patients in county hospitals as of Wednesday, up from 327 a day earlier. The number of those patients being treated in intensive care was 55, up from 44 on Tuesday.

COVID hospital numbers had been steadily dropping in recent months, falling to as far as 219 on April 20, but the number has been inching upward ever since.

Health officials



keeping close watch on the hospitalization figures, because a sharp rise on top of widespread community transmission of the virus could lead to a renewal of mandatory indoor mask-wearing

Wednesday lifted the county's hospital beds occupied by COVIDoverall total from throughout the pandemic to 2.922.210. The average daily rate of people testing positive for the virus, while still relatively low, rose to 3.2% Wednesday, up from 2.6% on Tuesday.

Another 10 COVID deaths were also reported, raising the cumulative virus-related death toll in the county to 32,055. Health officials have noted that most people who die from COVID suffer from various underlying health conditions.

Similarly, hospital most patients who are infected with COVID were hospitalized for reasons other than the virus, health officials said. Many only learned they were infected when they were tested upon hospital admission.

Based on rising COVID case numbers, Los Angeles County on Thursday could be downgraded by the U.S. Centers for Disease Control and Prevention from the current "low" community risk category to

Public Health Director Barbara Ferrer told the county Board of Supervisors on Tuesday that the cumulative seven-day average rate of new cases in the county is about 185 per 100,000 residents -- above the rate of 176 from last Thursday. If that rate reaches 200 per 100,000 residents, the U.S. Centers for Disease Control and Prevention will shift the county from the "low" community $\ensuremath{\mathsf{COVID}}$ level to "medium."

The CDC updates classifications every Thursday.

For residents, the shift would not have any immediate impact, since the county has already implemented the CDC's recommendations for areas in the 'medium" category -- such as maskwearing on public transit, wide availability of vaccinations and guidance for improving ventilation in indoor settings.

But if the county experiences spike in COVID-related hospitalizations, it could push the area into the "high" risk category, meaning a return of indoor maskwearing mandates.

Under CDC guidelines, counties in the "medium" category will move to "high" if the rate of new virusrelated hospital admissions reaches 10 per 100,000 residents, or if 10% of the county's staffed hospital beds are occupied by COVID-positive

Ferrer said the county's current rate of new admissions is 3.1 per The 4,384 new cases reported 100,000 residents, and the rate of positive patients is just under 2%.

> She told the board the county is likely to move into the CDC's "medium" COVID risk category this week, but she remains confident the county will avoid sliding into the "high" category.

> "While we are disheartened that the pandemic hasn't ended, I am reassured that with the tools at hand, we can continue to enjoy our time with each other and our participation in those activities that we love," she said.

> On Wednesday, the county Department of Public Health noted continued increases in cases among school staff and students, with the number quadrupling in the past month. Health officials urged schools and students to take precautions, strongly recommending indoor maskwearing, although it remains optional.

DOWNEY - The Downey Adult School cafeteria was transformed into a magical graduation scene when Soroptimist International of Downey gave eight scholarships to local high school seniors, and Kaiser Permanente Foundation contributed seven more for nursing students.

Transformation is what Soroptimists hope will happen, "when the dollars Soroptimist raises turn into scholarships," said Linda Haines, past president and a past governor of Camino Real Region, as she welcomed guests. 'They are the means for inspiring, educating, and empowering women and children in our community."

After a buffet of lasagna, meatballs and pizza, guests sat at tables decorated with bud vases of tall white flowers, arranged by Mia Zimmerman, chair for the night.

"I'm a decorator and a florist," Mia said, "and tonight for the first time I'm in charge of awarding these Live Your Dream scholarships." A fantasy of gold and black balloons flanked a giant check for \$10,000, the scholarship total being awarded that evening.

Known as the "Club with the Mostest" because nobody gives a party like Soroptimist, these business and professional women follow their mission, to make the world a better place for women and children. One way to do that is through higher education, and all year the club finds ways to have fun and raise funds to create this opportunity. They embody the Soroptimist ideals of the joy of achievement and the dignity of

In February, Soroptimist gave the Follow Your Dream awards to women who have turned their lives around, and as single heads of households, want to get a chance to learn a vocation, a trade or a profession.

Tonight the emphasis was on young beginnings, for girls just about to leave high school and step out into a world of promise. "It's a scary time," said Leslie Murray, first woman chief of the Downey Police Department. "And it's an exciting time in your life too."

What advice did Chief Leslie have for these young people?

"Find out what makes you happy," she said. "And then go for it." The Chief said she hadn't decided what to do with her life

until one day in college someone asked her if she had ever thought of joining the police force. The more she thought about the idea, the more she liked it.

"Don't be afraid to fail," Chief Leslie said. "Make your decisions for yourself."

Lola Abrahamian, governor of Soroptimist Camino Real Region and also a police lieutenant with the Glendale Police Department, applauded in agreement. Cynthia Jarvis and Janice Kurihara, directors of CRR Districts 2 and 3, were on hand for this important occasion.

One of the scholarships is named for another first achiever too. The Della Doyle Award went to Maria Echeverria, a Cerritos College student who is continuing her studies in a business-related field. In the 1950's, Della Doyle was the first woman city clerk for the City of Downey and also a founding president of the Downey chapter of Soroptimist International.

"In today's world, being clerk is now usually a job taken by women," said Soroptimist Judy McDonnell, herself one of the Downey city clerks, following Della Doyle's lead. "Given the chance, they do it well."

The Marvel Dodson Art scholarships, named for that beloved Downey Soroptimist whose exquisite calligraphy enlivened so many programs and invitations, went to Litzy Loza of Downey High and Salma Noguera of Warren, who said, "This means so much to me." Litzy had brought some samples of her work, and coaxed by Mia, Litzy held up two of her

The Educational Achievement Scholarship went to students with outstanding academic achievement, or those who had instructional support services from the Downey Unified School

District. Emma Maturin, dressed in a black tulip skirted dress, won for Downey High. Young men appreciate empowerment too, and Samuel Lara won the award for Warren High. Samuel is an ambassador for the Special Olympics, and wore a tailored shirt and tie for the occasion.

Vocational scholarships for those continuing in a two-year school in pursuit of a trade were Berlyn Miranda from Columbus High, Dulce Vilchis from Warren, and Kimberly Wall from Downey High. Kimberly wore a raspberry crushed velvet dress, following young women wore white jeans with jackets, or dressy sweaters, or flowered prints. Footwear ranged from strappy high heeled sandals, and fitted boots, to flats or tennis shoes. In casual California, anything goes.

Principal of the Downey Adult School and host for the evening Blanca Rochin presented the Nursing Scholarships from Kaiser, designed to alleviate the severe shortage of nurses. Amelie Llausas, Gabriela Montalvo and Kimberly Asceno were the first to be awarded. They were followed by Latonia Pope, Shawna Moore, Wendy Urbina and Yendi Patina.

Shawna said she was excited to receive the award but when asked said she didn't have any other awards to help with expenses. Her father standing beside her nodded his encouragement and said, "We can do this." Many parents accompanied their young awardees, and smiles of pride were everywhere.

Amazing trays of chocolate cupcakes appeared for dessert, with thick black icing decorated to look like mortarboards and tagged with little signs that said Congratulations Class of 2022. As the invitations for the evening read, Soroptimists Investing in Dreams.

Volunteers are the stars at awards banquet

■ The Downey Coordinating Council's annual awards banquet returns after two years.

DOWNEY - It was a gusty day, when the wind blew flower pots over and tore down decorations, but the Downey Coordinating Council regulars braved the weather to meet for their Volunteer Recognition Banquet. Always a major social occasion in Downey, the traditional dinner was resumed for the first time after two Covid-clouded years.

"We have 119 people here tonight," said Lois Buchannan, coordinator of the evening. Holding the meeting was a triumph in itself, and the Woman's Club of Downey was the gracious host. The building on Paramount and Lubec seemed just the right size for friends to greet each other.

As DCC President Carol Kearns said, "So many people here tonight know each other, because in Downey we all cooperate in making each other a success. This group represents the people who make Downey a caring, sharing place to work and live."

Contrary to expectations, the Coordinating Council's purpose is not to produce a calendar of events for the year. Its 39 member groups made up only a part of the many organizations, large and small, that give Downey its flavor and variety. And with Covid narrowing their ranks, almost half of those who normally

participate could not attend tonight's celebration.

Tables for eight were set with violet and iris-lavender napery on gracious cream-colored tablecloths. Larry Sepulveda's guitar could be heard and enjoyed but was not so loud as to overwhelm conversation. Having music to accompany the evening, a touch, is a trademark of Lois Buchannan, who coordinated the evening for the Coordinating Council as she has for many years.

The buffet featured a delicious boned and skinless chicken served with three enticing sauces, strawberry cheesecake with generous dollops of strawberry coulis was served to each guest at the tables, as a dessert treat. King Catering brings its own professional wait staff, all women, and they served the salad, skillfully refilled glasses, cleared the places, and kept the evening flowing.

The Women's Club's own volunteer nominee was Anna Orozco, who makes sure the weekly bingo fundraisers at the club happen, to raise money for Rancho Los Amigos Hospital, and college scholarships for Downey students.

in the Schools Program for the Downey Patriot. The Downey Conservancy preserves and highlights classic period architecture in Downey, with special thanks to artistic promoter Gabriel Enamorado.

The Friends of the Downey Library, that runs an admirable gently-used book gift shop, nominated Karen Voight for producing the newsletter, the restaurant fundraiser flyer and event invitations.

Small new organizations like Citizens Climate Lobby, that works to reduce our dependence on fossil fuels, nominated Anita Rivero, who advocates writing letters to local newspapers, including the Downey Patriot, to raise consciousness of problems. Big groups like the Downey Rose Float Association, "that iconic symbol of Downey's pride," that has had an entry for many consecutive years, honored Jonathan Browning for his work with framing and plumbing the bathrooms for the float building, and donating material for special effects for Downey's spectacular float on New Year's Day.

The Exchange Club has been serving the Downey community for years, and it now runs a Family Support center. Volunteer, Wanda Iacovitti, sees that the fundraisers are well publicized and attended. Keep Downey Beautiful does just that by organizing litter cleanups throughout the city, and honored Daniel Frase for seeing that the job is done thoroughly. Daniel has been volunteering since 2005 when

he was a student at Downey High.

Each organization sent two representatives to the microphone, one the honoree as volunteer of the year, the other the presenter who read the citation. A few honorees could not be present. Dorothy Pemberton who gives so much time and energy to the community at the food distribution center for PTA Helps, was on an Alaskan cruise, and Rich Strayer, that tireless recruiter of new members for the Rotary Club, was out of town on family business. Rich's work in Guatemala for international literacy is an embodiment of the club's motto, service above

All of the awardees shook hands with President Carol, former Mayor Claudia Frometa and newly appointed Councilmember Donald La Plante. Each volunteer received a packet of colorful certificates and citations, tied with gold cord, six in all, with gold seals and red and blue ribbons.





COLOR GUARD WINS MEDALS



Things you didn't know about Downey: Downey's aviation history

Many are aware of the great strides in space exploration achieved during the years of the Apollo moon landing and Space Shuttle programs here in Downey, but this community also has a history of aviation development at the same site that dates back to the 1920's.

In fact, the history of aerospace in Downey dates back to E.M. Smith, a wealthy industrialist who founded the E. M. Smith Co. (EMSCO) in 1911 to manufacture transmission belting, rubber products, and hydraulic brake linings.

Smith's holdings included the EMSCO Asbestos products factory in Downey (on Dolan Avenue near the railroad tracks) and a newly purchased Albatross Company, a small aircraft company in Long Beach. Envisioning a landing field that could be used by both commercial and private pilots, Smith bought a 73-acre tract of Downey land from James



Hughan. The land was largely orange groves and castor beans with a few farm structures.

Smith organized and financed the EMSCO Aircraft Corporation in 1929 to manufacture a complete line of land and water aircraft, and hired W.A. "Billy" Williams, a World War I test pilot, as his sales manager. Williams landed the first plane at the new airstrip on May 3, 1929, but Charles Rocheville, an ex-stockholder of the Albatross Company, and the designer of the new monoplane that was known as the EMSCO Challenger, took the plane up for flight testing on August 7,

A 1929 EMSCO brochure described the new facility.

Its line of planes were described as the EMSCO Challenger (a super-powered eight-place cabin monoplane using three 170-horsepower Curtiss Challenger motors). It would take off with a full load using any two motors.

The EMSCO B-3 (practically the same as the Challenger, but powered by a single Pratt & Whitney Wasp or Wright Whirlwind j-6 motor of 300 horsepower).

The EMSCO Cirrus (two place, mid-wing monoplane for sport and training. Built to approximate pursuit performance with the economy of a runabout. Powered with a

90-horsepower, four-cylinder in Celebration, Downey Southeast line, air-cooled American Cirrus News October 5-13: Motor).

The EMSCO Amphibian (With a bi-motored cabin with accommodations for five passengers and a pilot).

Two months after Rocheville's first test flight the stock market crashed. EMSCO was sufficiently capitalized to continue building planes that pioneered new air routes. These included the first non-stop flight between Downey and Mexico City, and a special plane manufactured with sufficient range to complete a flight from Tacoma, Washington to Tokyo, Japan. The Cirrus also set a world's fuel economy record for

Due to the failing national economy, there were too few sales. Eight bombers were ordered by the Mexican government and a special stunt plane was built for Prince Lionel Ghica of Romania, but production had slowed by 1931. The company hired Gerard "Jerry" Vultee away from Lockheed as chief design engineer, but he stayed only one year, and in February 1932, the company leased the plant to **Champion Aircraft Corporation** of America and Vultee left to organize his own company in Glendale.

James Stamps

One man who has had a greater role in bringing about the development of modern-day Downey than any other living person is 83-year-old James L Stamps. He was the city's first mayor, and is the only member ever accorded the title "Councilman Emeritus." Long before that, Stamps had earned the name "Mr. Downey."

He might have never come to Downey if the price of lumber had not fallen so low in 1890 that his father, L.K. Stamps, closed out his business in Lewisville, Ark. And brought his wife, Eleanor, and his children

James L. Stamps was only a year old when the family arrived in the community in 1892, and the town of Downey was less than 20 years old. The elder Stamps took up farming, acquired substantial acreage, and within six years had become a leading farmer in Downey. Eventually, he retired from farming and became the area's leading realtor. He died in 1937.

Meanwhile, young James attended Gallatin School and Rivera School, graduated from Whittier High School in 1910, and studied at Woodbury **Business College.**

Stamps' family wanted him to become a professional man, but while in high school, he had saved up \$2,500 from his

orchard care business, which was a lot of money for any young man in those early days, and he set out to be a farmer.

He owned and farmed several hundred acres within the present Downey City Limits, raising truck crops, sweet potatoes, sugar beets, cauliflower, alfalfa, barley, and various fruits, and in the later years preceding Downey's incorporation he was principally an orange grower.

Almost from the beginning, Stamps realized that one day there would be no empty lots in Downey, let alone farming acreage. He bought part of what is now the Rio Hondo Country Club in 1919 when it was considered hopelessly far out, \$450 an acre. Six years later, he sold it for \$2000 per acre, and remained its major stockholder.

The 103-acre golf course continued under Stamps' guiding hand until rising taxes and competition with taxexempt public facilities forced him to dispose of it.

The golf course very nearly was sold for a new home development. Stamps and the purchaser, Maurice McAlister, voluntarily put the plan aside in order to allow the city to buy the property on Aug. 1, 1970 and maintain it as one of the few remaining green open spaces left in the urban area.

Stamps early on was a leader in the community and his interest in developing

local water resources in large measure were responsible for Downey's continued thriving growth. He was president and secretary of the Old Arroyo **Ditch and Water Company** in 1927, which provided the irrigation for the rich crop lands. He was its president 15 years and a director for almost 30 years. He also had been on the board of the old Downey County Water Company which had been built up to \$4.5 million valuation by the time the city acquired it in 1962, serving almost half of the city's population.

Stamps also has been a major supporter of Downey YMCA. He was director of the **Downey Community Hospital** Foundation for 10 years before the advent of the new hospital. He served on the Hospital Commission which presided over the development of the present 152-bed institution at 11500 Brookshire Ave. With his wife Mary, he is an active member in the First Baptist Church of Downey.

In his later years, Stamps has created the James L. Stamps Foundation to carry on his projects – for youth, schools, hospital and church after he is gone.

Public trust in the Supreme Court plummets

When Supreme Court member Justice Samuel Alito's secret plan for canceling the constitutional right of women to end their pregnancies leaked out to the public, Republican politicos went ballistic! Over the

Sen. Mitch McConnell, the perpetually sour old goose who heads the Senate Republican caucus, had a hissy fit when the news leaked out that American women are about to have their most fundamental constitutional right taken from them by a right-wing cabal of Supreme

What made Mitch twitch, of course, was not the bad news for women... but the leak itself. He huffed that revealing the court's scheme to the public was a "stunning breach," spewing that it's "an attack on the independence of the Supreme Court." Uh, Mitch... the so-called Supremes have been meeting behind closed doors specifically to plot an all-out attack on the independence of some 170 million women to control their own bodies. Why aren't you opposing that autocratic governmental secrecy, rather than supporting the court's subversion of women's

Perversely, the entire Republican leadership is outraged by the leak, rather than the attack on women's rights. Right-wing blowhard Sen. Ted Cruz, for example, yapped that informing the public "will do lasting damage to the integrity of the court." Uh, Ted... you and your ideological ilk annihilated the court's integrity — and its legitimacy — when you stacked it with a covey of corporate-coddling partisan hacks like Alito and justices Amy Coney Barrett, Neil Gorsuch, Brett Kavanaugh and Clarence Thomas.

Then came Sen. Mike Lee of Utah, a Trump acolyte, ludicrously blathering that the leak of the judicial plan is "despicable." Why? Well, he explained to us commoners, the court "is not a political body." If ignorance is bliss, Mike must be ecstatic! The GOP majority on this court is so immersed in its own partisan biases that it is routinely ruling against workers, the environment, women, voting rights, local communities...

and democracy itself.

No surprise then that public trust in the integrity of these "arbiters of justice" is crashing. If the court won't respect the people's democratic ideals, then the people won't respect the court.

The court's Republican chief justice, John Roberts, called the unauthorized disclosure an "affront" to the majesty of the Supremes. Likewise, Republican congressional leaders have furiously demanded to know whodunit and why! Way beyond their political screeching and posturing, however, a Pennsylvania woman quietly wrote a letter to The New York Times that calmly posed a couple of honest, more fundamental questions: "Why are Supreme Court votes and processes so hidden in the first place?" and "How did this grip on secrecy become so sacrosanct?"

After all, as important and enormously powerful as this tiny body is, it's still a governmental agency doing public business that affects every American. So, the legal work that the nine members of this ultimate judicial authority do — including their internal machinations to reach such a wesome decisions as nullifying fundamental human rights — ought to be transparent to all who will be affected.

The ugly truth is that today's third branch of government has needlessly, dangerously and rather ludicrously become a black-robed autocracy. Bear in mind that these nine individuals are enrobed for life, choose the cases they consider, make up their own rules of ethical conduct, operate almost entirely behind closed doors, can conspire to issue decrees — and the bare majority of only five of them can arbitrarily overrule presidents, congresses, states, other courts, voters... and your own personal life decisions.

And now comes a six-person GOP majority of supreme justices determined to entrench corporate plutocracy, right-wing theocracy and Republican sovereignty over all of us. That's why we must finally lift the medieval veil of secrecy the partisan judges are using to shroud their

When politicians use tragedy to justify

When politicians echo Justice Oliver Wendell Holmes' famous observation about "shouting 'fire' in a crowded theater," it typically means they are trying to justify unconstitutional speech restrictions. So it was with New York Gov. Kathy Hochul's comments after the racist mass shooting that killed 10 people at a Buffalo grocery store on Saturday.

Hochul was responding to questions from "Meet the Press" host Chuck Todd, who during Sunday's show condemned "a permissive culture on the internet" that allows "right-wing extremism" and "white supremacy" to run rampant. Given the role that such views played in Saturday's horrifying attack, Todd asked Hochul, shouldn't "internet companies" be "held responsible for the easy spread of this propaganda"?

Todd noted with dismay that critics of that proposition tend to cite "freedom of speech or things like this." Hochul shared his impatience with such objections.

"I'll protect the First Amendment any day of the week," the governor said. "But you don't protect hate speech. You don't protect incendiary speech. You're not allowed to scream 'fire' in a crowded theater. There are limitations on speech."

Hochul is right that the Supreme Court has recognized exceptions to the freedom of speech guaranteed by the First Amendment. She is wrong in thinking that "hate speech" is one of them.

As First Amendment scholar David Hudson notes, that provision "makes no general exception for offensive, repugnant, or hateful expression." To the contrary, the Supreme Court repeatedly has held that bigoted and outrageously inflammatory speech, including the sort that influenced the Buffalo shooter, is constitutionally protected.

Hochul, who has a law degree, should know that. But her allusion to the analogy that Holmes drew in the 1919 case Schenck v. United States tells you how little regard she actually has for the freedoms she claims she is prepared to defend "any day of the week."

In that decision, the Court unanimously upheld the Espionage Act convictions of two Socialist Party leaders, Charles Schenck and Elizabeth Baer, who had sent recently drafted soldiers "printed circulars" arguing that conscription violated the 13th Amendment's ban on involuntary servitude. While that argument might be tolerable in ordinary times, the Court said, it posed "a clear and present danger" during World War I and therefore was properly treated as a crime.

"The character of every act depends upon the circumstances in which it is done," Holmes wrote. "The most stringent protection of free speech

would not protect a man in falsely shouting fire in a theatre and causing a panic.

A week later, in two more unanimous opinions by Holmes, the Court applied the same logic to uphold the Espionage Act convictions of Socialist presidential candidate Eugene Debs and newspaper publisher Jacob Frohwerk. As the Court saw it, the First Amendment did not protect a speech urging resistance to the draft or articles criticizing U.S. involvement in World War I.

Within six years, however, the Court began to retreat from the "clear and present danger" test. The current standard for punishing allegedly crime-promoting speech, laid out in the 1969 case Brandenburg v. Ohio, asks whether it is both intended to incite "imminent lawless action" and

Under that test, it is clear that promoting racist and antisemitic ideas such as "replacement theory," which posits that Jews are conspiring to make whites a minority in the United States, is constitutionally protected. Yet Hochul seems to prefer the repudiated jurisprudence that allowed the government to imprison Schenk, Baer, Debs and Frohwerk.

Hochul's invocation of Holmes' analogy makes it clear that she is not just talking about voluntary moderation by social media companies. "I want to silence those voices now," she said at a Buffalo church on Sunday.

If "the social media platforms that allow this hatred to ferment" fail to suppress it, Hochul said, "I will use every bit of the power I have as your governor to protect you." Fortunately, Hochul does not have as much power as she thinks.

The City of Downey is going through its own turmoil and hoping these matters are settled soon, as Downey strives to be the shining star it once was.







Rosalie Sciortino and I became close friends and enjoyed a nurturing friendship for decades.

Until I met Rosalie. I thought people her age didn't know how to have fun and dwelt too much on their aches and pains, seemingly taking inventory of their body parts. Someone told me that was what I could expect when I got old. Since then, old people were a reminder of my fate. Rosalie taught me how to enjoy life with enthusiasm and be strong when facing health challenges.

I first met Rosalie in 1993 at a senior creative writing group at Apollo Park in Downey. At age 40, I was the youngest in the group and Rosalie may have been a little older than her contemporaries there. As I heard and watched her read her stories, I was not only entertained but inspired. Her creativity was not stagnant with melancholy. She put a smile on everyone's face, including her own, as she looked around the room like a child with a story to tell. I knew then I wanted to get to know her better.

She invited me to her Writer's West Workshop group where she was president, then secretary. Rosalie married later in life and had no children. After her husband Nick died, I invited her to my memoir writing group in Norwalk. She eventually joined and we got to know each other better through stories we shared.

Rosalie was younger at heart than I. I had to grow up fast having been married and a mother while in my teen years and the Vietnam War was a personal concern to our family. Vic, my teenage husband and father of our child, was a U.S. Marine deployed in Cambodia, in harm's way.

After Vic's time in the military ended in June of 1966, he went to work at Owen Glass factory, where he worked double shifts for four decades With now two daughters grown and Rosalie living alone, we began to have a gal's day out once or twice a week. We went to breakfast, lunches, movies. tea parlors, plays, shopping or just visited in the backyard, where we laughed, sipped, chatted and chewed.

like you. You were so charming to the intern at the E.R. when you sprained your wrist. You asked if he was Palermo, Sicily and he said, "Yes!"

You invited him to write about his love for the "old country" and to come to our Writers Workshop West. He must have been impressed by you also. No one was more surprised than me when he showed up!

I will never forget the incident at Olive Garden. You asked to personally compliment the chef on the eggplant dish you enjoyed so much. He came to our table to meet you. When we went to pay the bill the cashier told us it was already taken care of with the chef's compliments!"

I remember when she told me how she made contact in cyberspace with an old flame she was once engaged to who (safely) lived hundreds of miles away. I laughed till my stomach ached. Rosalie seemed to relish my reaction.

How hysterical was the time we went to the theater to see the musical "Chicago." I found her sense of fun and childlike abandonment influencing me because I was not even remotely embarrassed when we were told to hush by audience members after we began to sing along with Catherine Zeta Jones, Renee Zellweger and Queen Latifah to songs. If that were not bad enough, we got the giggles and had to leave the theater before the lights came on. We continued laughing all the way home. Who knew, so much fun could be so exhausting? I slept very well.

Of course, there were also times we cried together and comforted each other. Rosalie came to my beloved Uncle Brown's funeral in 1983, my father's in 1991 and my mother's in 2012. In the days, weeks and months to follow she helped me through the grieving process, of which she said she was all too familiar with.

I hope I paid it forward on that ominous morning two years ago when I came over to have coffee with Rosalie. The gate to the backyard was open. I could see the little table set out in front of the garage. It had a lace tablecloth and a small vase with two pink roses from her garden.

Rosalie came out and told me she had been calling my house wondering if I was late and that she had been sitting at the table waiting for me Then I laughed harder when she mused, "Luckily they all our table.'

She went up the back stairs and said "I'll get the coffee." As I watched her I thought she tripped on the carpet. She had a hand on the washing machine holding her up. I ran to help her but it was too late. She fell to the floor, her eyes wide open as was her mouth.

I remember thinking this couldn't be really happening. Time seemed to go by at warp speed and subsequently slow motion. I gave her CPR, knowing she was already gone. I picked up the phone, called paramedics and Carol and Frank Kearns who live nearby, along with Matthew, also a close friend, and my husband Vic. When everyone arrived, the nightmare felt real. It was a horrendous experience. I felt almost numb.

In time, I came to view it as a blessing. If I had not been there I forever would have wondered how long she lay on the floor, perhaps crying for help. Knowing she did not suffer and died instantly brought me peace.

When I came home I found a message from Rosalie on my answer machine asking me if I had left my house yet and that she had been waiting for me.

Thank you, Rosalie.

Downey Symphony puts on a Hollywood Bowl-worthy concert

■ The Downey Symphony Orchestra closed out its concert season with Beethoven's Triple Concerto.

DOWNEY - The lobby of the Downey Theatre buzzed with excitement as patrons greeted each other after two postponements of this special program. Long-time attendees Herb Stevens and Joe Commodore enjoyed the company of fellow long-time patron Hop Morrison. Jorge Montero was seen engaging Board Member Eric Pierce in conversation in the Lobby.

Jo Gronley and Mary Stevens at the program table were joined by Ruth Hillecke, whose Hillecke Foundation sets the pace for contributions to the Downey Symphonic Society's Music in the Schools program.

The DSS's commitment to their Outreach Program for Downey's school children has never faltered, and thanks to patrons like Ruth, the music is still thrilling the children.

Although the Music in the Schools quintet couldn't travel onto the elementary school campuses this year, the two popular morning concerts in the Theatre were resumed.

All third graders and fifth graders were bussed in by the Downey Unified School District on their respective concert days, projects supported by the Kiwanis Foundation and the City of Downey.

Recent baton-winner Dottie Nadalski, who conducted the Simple Song overture at the last concert, came with Carol and Frank Kearns. Bernice Mancibo Stumps, whose record-breaking bid won the baton for next season's spring concert, said she intended to give the baton to her grandson Christopher.

"He's so talented," Bernice said. "I bid for him once before, but he was engaged to be somewhere else when we had our concert in April 2019, so we chose Aaron Saldana, a Stauffer Middle School student, to conduct. But I wanted to give Christopher the opportunity again."

Alistair Hunter then announced from the stage the names of the artists who contributed to the Mezzanine Art Exhibit, and they each rose and stood till all the names had been called and the audience thanked them with their applause.

Board Member Pat Gil, who is president of the Downey Art Coalition, was with the artists on the Mezzanine level.

Five students from each of the two high schools, Downey and Warren, have been chosen to receive art scholarships for college. Chances were being sold to give patrons the opportunity to contribute to those funds. That's a big commitment that DAC makes to the community.

Among the many fine pieces conveying the theme, Reflections of Love, was a photographic study of a calla lily by Carolina Estrada- del Toro. It hung next to a pedestal holding a ceramic sculpture by her artist husband, Jorge del Toro. It was Carolina's birthday and her daughters had made a special Birthday-Mother's Day celebration for her.

The concert began with Mozart's Overture to Don Giovanni, that majestic yet rakish operatic rogue. Listening to Mozart's charm and brio, one thought of how the Opera House in Mariupol had been recently destroyed by Russian missiles. The Italian government in immediate sympathy pledged to rebuild the Opera House again for the people of Ukraine, once the hostilities are over. Music is that important.

At intermission, Don
Marshall said he felt both
honored and humbled with the
collector's item pen that Eric
Pierce on behalf of the Board
of Directors of the Downey
Symphonic Society had gifted
him with at the pre-concert
recognition, for Don's long and
deep involvement as President of
the Board.

"It's a left-handed pen," Don said. "I didn't even know they made them."

If you're a leftie, it's hard not to smudge the ink when you write from left to right. This one has fast drying ink that flows as smoothly and it needs low force so it writes quickly, eliminating smearing and smudging.

"Thanks to all of you," said Don. It feels so important to me to have the Downey Symphony performing again after such a painfully long absence. I'm very grateful for this outstanding orchestra for bringing such beautiful and soul-enriching music to the community."

Returning from intermission, the audience saw that the concert grand piano had been moved into place on center stage, with a chair for the cello soloist and a space for the violinist, who usually stands. The Orchestra's chairs were arranged for a smaller orchestra, typical of what the Symphony uses for its winter concerts, for variety in programming.

The winter configuration was because this program had been planned for January a year ago, while the world was celebrating Beethoven's 250th birthday, but the pandemic closed the Theatre. Then this January after a surge in Covid cases came a last-minute postponement. Fortunately, the Downey Theatre was flexible with its dates and was able to offer this May opportunity for the Symphony to end its subscription season with a flourish.

The trio of soloists entered, and lo and behold, Concertmaster Carolyn Osborn had changed from her black sequined jacket and long black pants to a stunning spaghetti strap chiffon dress with a handkerchief hem. Black and white, in keeping with the formality of the evening, the pattern was a riot of animal prints- giraffe rectangles and leopard spots, with the same vertiginous heels Carolyn had been wearing as concert master.

The dress sparkled with tiny brilliants, soft yet glamorous enough for performing at the Hollywood Bowl. It was surpassed only by the brilliance of Carolyn's playing.

"Carolyn played better tonight than I ever heard her play before," said Joyce Osborn, Carolyn's mother, and former violinist with the Downey Orchestra. "And I've heard her play all her life."

The Downey Symphony finally got to perform the twice postponed Beethoven's Triple Concerto, and the audience was enchanted. Called back for three curtain calls, the trio of soloists consisted of the Downey Symphony's own concertmaster Carolyn on violin, accomplished Dane Little at the piano and Kevin Fitz-Gerald playing the difficult cello part.

They gave a performance worthy of a much bigger venue. The music was brilliant and melodious, and it was hard to believe that Beethoven wrote it at the age of only 33 when he was already becoming deaf and knew he could not hear what he was composing. He considered suicide but decided to live instead and write the music he had welling up inside.

The Triple Concerto was one of the first great works Beethoven composed after this crisis, the

only concerto he ever wrote for more than one solo instrument, a first in the history of music. But instead of storm and drama, it was sweet melodies and exquisite light.

Beethoven's treatment of the trio is pioneering: he allows each instrument to play alone with the orchestra, finally bringing together all three instruments with the orchestra. It's a complex web, the orchestral, piano, violin and cello voices interplaying and entwining. And it's a long piece, almost forty minutes, but time disappeared in the emotional but brief second movement. Conductor Sharon Lavery's tempo kept the piece sparkling.

At the reception on the patio after the concert, the audience and orchestra were feted by the Board. Larry Lewis, Bill Hare and Board President Anthony Crespo poured the bubbly, and homemade cookies baked by the Board and fruit punch were all served in the balmy evening weather on the theatre's patio. Music lovers were able to congratulate the members of the orchestra in person on the evening's performance. Tom

Hutchinson, his son Charles, and several of their friends joined in.

Instruments slung over their shoulders in colorful form-fitting molded polyester cases, the viola and cello, clarinet and bassoon players enjoyed the hospitality as much as the patrons. Guild President Katie Hare served the homemade cookies that Symphony Guild and DSS Board members had contributed. Joyce Sherwin oversaw the reception and Adele Alexander Ambruso was heard to say she had never met a cookie she didn't like. Music Director Sharon Lavery was enthusiastic about the appreciative audience.

Fans will be able to hear the Orchestra again when they perform at the City of Downey's free Pop Concerts in the Park this summer.

The subscription season starts again next October. By then audience confidence in the safety of attending a live public concert will have been rebuilt, as the Downey Symphony Orchestra fills the theatre again with their sweet sounds.



DOWNEY - The City of Downey will spend over \$3,800 to support the "Mexico en el Corazon" scheduled at the Downey Theatre in just a few weeks.

The North American tour features mariachi music, folkloric ballet, and other representations of Mexican heritage, taking artists across the United States and Canada in an attempt to educate audiences unfamiliar with the culture and provide a semblance of home to natives of Mexico.

It is scheduled for June 1.

Trujillo described the show as "a great opportunity for cultural enrichment.'

"We have a very diverse city, especially when it comes to Latinos. We have Argentinos, Columbianos, Cubanos, Mexicanos," said Trujillo. "Any opportunity that we can give to our residents and our families for them to learn about not only their culture, but other cultures, I think would be welcome; especially if it's affordable.

Initially, it had been requested that the city pay over \$15,000 to cover theatre staff reimbursement, advertising, equipment, and hotel accommodations for performers.

According to Trujillo, the theatre subcommittee decided that the requested amount was "just too much," however was willing to pay \$3,831 to cover theatre staff, security, and ticket printing fees, and to make the event "completely available and free to the residents of Downey for their cultural enrichment."

The \$3,800 amount was approved in a 4-o vote, with Councilwoman Claudia Frometa
