■ Downey's projected fiscal budget is anticipated to grow nearly 10% from last year; Trujillo pushes for more spending on alleys.

DOWNEY - Downey is anticipating a nearly 10% increase in revenues and expenditures in fiscal year 2022-23, according to the proposed budget presented to the City Council on Tuesday.

General Fund revenues in the upcoming fiscal year are anticipated to be over \$103.3 million, representing a 9.8% increase from last year. A majority of those monies will come from sales and property taxes, which together make up 65% of the city's revenue stream.

Expenditures are projected to be at \$103 million, also a 9.8% increase from the previous year. As in previous years, the city will once again spend around twothirds of its budget on public safety, allocating \$41.5 million (40%) and \$26 million (25%) to the police and fire departments.

Proceeds from a \$13 million one-time sale of property off Bellflower Boulevard to Kaiser Permanente will also account for 10 capital needs expenditures, including city hall improvements, city maintenance yard work, and lighting at Furman Park. The sale will also notably help the city close out the book on Measure S in its entirety.

The budget includes funding for five additional employees, including one motor patrol officer, one safety dispatcher, and two school resource officer positions that will be funded by the Downey Unified School District. The city's current social media intern position in the city manager's office will be converted to a full-time position.

Overall, the city is projecting 430 budgeted full-time positions.

Downey anticipates ending the fiscal year with over \$32.5 million in reserves. At Tuesday's budget talks, Councilman Mario Trujillo suggested tapping into the reserves to address neglected alleys.

"I will not accept that I'm going to have to cut in streets to give to alleys," said Trujillo. "We have a \$30-something million-dollar surplus, and at some point we are choosing to provide less effective services, or services in general, for our residents because we want to save money in the rainy day fund."

Downey initially had \$300,000 allocated toward rehabilitation of two of the city's 26 alleys, located north and south of Stewart and Gray Road between Lakewood Boulevard and Patton Road. Trujillo suggested increasing that amount to \$1

The request received pushback from Councilwoman Claudia M. Frometa, who expressed caution over the city's reserves.

The council eventually agreed to have staff return with more details on the city's alleys that are most in need of repair before allocating additional dollars

The city council will consider formally adopting the budget at its next meeting.

The spending plan is the tenth consecutive - and final - balanced budget under current City Manager Gilbert Livas.

DOWNEY - Those who knew Café n Stuff likely knew Maria Trigo and her family.

Café n Stuff was a café turned catering business owned by Ebie Ghaneian that served the community for over 30 years. It was Trigo and her family, however, who would become synonymous with the company.

"I laughingly told people that we were a family run business,' said former general manager Rita DeBenedictis. "We were just run by her family...All of them worked

It began when Trigo joined the Café n Stuff team around 2004 as a waitress. Fifteen years into her time with the company, Maria would bring along one of her three sons, Angel, to wash the catering cars and focus some of his energy.

"The owner here saw me with a kind of sad face, and [asked]

'What's wrong," said Trigo. "'My son, I can't keep him sitting down,' and [he said] 'Bring him, I have something for him to do."

Angel would go on to work more with the company, along with his brothers Dadzahe Mier and Gino Trigo, and a host of other family members.

"Everybody was wearing different hats," said Mier.

However, things became more uncertain as the Covid-19 pandemic began to set in. Luckily for Café n' Stuff, the business was able to pivot; transitioning from running the sometimes 2-3000 person events their clients would book, to government contracts serving individually packaged meals for testing site workers and those in need.

Still, as the pandemic began to settle, those at Café n Stuff knew it would still be a slow roll to a full reopening, as there wasn't an immediate calling for the types of events that the company had become accustomed to accommodating.

"We survived [the pandemic] and survived it well, which was nice," said DeBenedictis. "The sad thing was we realized towards the end, we realized once the pandemic was over, we weren't sure what

was going to happen because our biggest client was going away, LA County, and our new clients weren't ready to come back."

DeBenedictis said that Ghaneaian started making plans to liquidate and close the company, before a new idea struck.

"[Ghaneaian] had this idea that Maria, Dadzahe and their family had worked for us, Maria for almost 24, 25 years," said DeBenedictis. "As he was deciding to liquidate, he had the idea that he wanted to see if Angel wanted to come back and own it.

"He kept asking for my son Angel," said Trigo. "[Ghaneian said] 'He always wanted a restaurant, his own business. This would be a good place for him."

Trigo's son had different priorities at the time, having settled in Hawaii with a family of his own.

"I called my son, and he said 'No mom, why didn't he tell me when I was there?," said Trigo.

Trigo, however, was very much

"Maria came over here one day and said, 'Ebi, Angel's in Hawaii, but I'm here; I want it," said

Ghaneian was hesitant to sell to Trigo. Ultimately it took a little persuasion, and a guarantee that she would have her family behind

Now, the family owns the business under the new name of Gathering's n Stuff, coming fullcircle and making it truly "family-

DeBenedictis says that the business – and the legacy of Café n' **1897:** Mark Twain was quoted by Stuff – is in good hands.

"For me, I grew the catering part of it up from a baby, literally, and so it would've broken my heart to give it to anybody who didn't take care of it and continue the way we had," said DeBenedictis. "...The fact that [Trigo] worked with us all the way along, so she knew the way we did things, and she knew how we took care of customers. That was important to us. They all did, but Maria especially.

"We just knew that she wanted it, and she loved it as much as we

Though ownership may be different, Mier says it's the same tradition and legacy.'

"People that know Café n Stuff, they're going to love Gathering's n Stuff because it feels like Café never shut down," said Mier.

Rapper DJ Quik's son charged with murder

DOWNEY - The son of rapper DJ Quik was charged Tuesday with wounds, died that day at a hospital, murdering a man after a fight at a according to records from the Los home in Downey.

Man wrongfully convicted of murder exonerated after more than 20 years

Metro ends effort to widen freeway

■ Metro has scrapped controversial plans to widen the 710 Freeway, which would have led to the destruction of homes primarily owned by minorities.

 $\textbf{DOWNEY-} The \, Metro \, Board$ of Directors voted Thursday to end its efforts to widen the Long Beach (710) Freeway and to use the \$750 million allocated to that project instead for improvements to southeast Los Angeles communities along the freeway.

"Widening this freeway and wiping out neighborhoods is not the pathway forward, and neither is the status quo," said board member and Los Angeles County Supervisor Janice Hahn, who represents communities along the 710 South corridor and coauthored the motion.

"We have an opportunity now to imagine something different and a better use for these funds. We should use the funding we already have set aside for this project on smarter ways to improve air quality, reduce congestion, improve mobility and address safety concerns for everyone living and traveling along this corridor."

Metro staff will report back in June with a new project plan and objectives for the funding. Staff will also draft an investment plan with short-, mid- and long-term initiatives, at least three of which will request funding this year.

"Our 710 communities are really looking for some qualityof-life improvements as soon as possible ... this motion will give us the opportunity to reimagine the 710 Freeway project. It makes clear we're no longer going to widen the freeway, we're no longer going to wipe out homes

and neighborhoods for a freeway project," Hahn added during the prohibiting meeting.

Several people called into the Metro meeting to voice support for ending the 710 widening

Climate Resolve Deputy Director Bryn Lindblad called to support the motion to scrap the effort, saying that studies show "that widening freeways really doesn't solve congestion, it only brings more harm."

A 2009 study by economists Matthew Turner of the University of Toronto and Gilles Duranton of the University of Pennsylvania found that between 1980 and 2000, cities that increased its road capacity by 10% in turn increased the amount of driving

Another caller, who said he was part of the 710 South Corridor Community Leadership Community and lives in Long Beach, said "I'm tired of breathing in toxic air. I want Metro to continue to invest and uplift community with alternative modes of transportation, improve our air quality and be an example to the rest of the world."

The project to widen the 710 Freeway has been in the works for decades, and local groups have fought to stop it, citing air and noise pollution on the already-busy freeway that trucks use to access the ports of Long Beach and Los Angeles.

Angeles County Supervisor Hilda Solis, who represented some southeast Los Angeles communities before the 2021 redistricting process, called the motion "a huge step and a victory, I think, for those people that live along the 710 Freeway, as well as the cities."

Meanwhile, legislation California from funding or permitting freeway expansions in poor neighborhoods or communities adversely affected by vehicle emissions passed the Assembly floor last week.

AB 1778, authored by Downey Assemblywoman Cristina Garcia, would make it so that neither state money, personnel hours, nor permits are allocated to freeway widening projects in disadvantaged communities.

"If we are truly going to govern with equity lenses we must stop the seizure of family homes in poor brown and Black communities and acknowledge that the freeway system, since the 1950's, has been used as a tool to further disenfranchise low income communities and communities of color like mine," said Garcia.

More than 200,000 people have lost their homes nationwide to federal road projects over the last three decades, according to a Los Angeles Times analysis of federal transportation data.

The actual total is higher because many states fail to report how many homes are taken

In large projects in California and four other states, the families that lost their homes were disproportionately residents in Black and Latino neighborhoods.

Garcia praised Metro's Metro Board Chair and Los decision to stop a proposed expansion of the 710 Freeway but said it didn't go far enough.

"While I wholeheartedly support this first step, we must act holistically and protect all disadvantaged communities in the state, not just those along the 710 freeway, starting with the communities along the 5



freeway in the city of Downey," said Garcia.

"While I applaud the focus and bold leadership along the 710 freeway, we can't have justice if we leave other vulnerable communities behind, which is why I will keep working to get this bill to the Governor's desk."

Evidence indicates expanding freeways isn't easing congestion problems. Experts have found that widening freeways can actually increase traffic, because it leads to urban sprawl and encourages more vehicle trips.

This leads to more pollution and further exacerbates the community's health problems, Garcia said.

AB 1778 was inspired by the threat of the proposed widening of Interstate 710 from the port of Long Beach to the railyards in Garcia's district.

"It is imperative that the resources, money and time, consumed by the discussion freeway widening are reallocated to completing public transportation projects," Garcia added.

"This creates jobs and helps make communities healthier homes. It is outrageous and feels choke and displace communities and displacing many low income like mine when the data and

research clearly show that this practice is just another example of the systemic racism in our policies and practices. Emission increases from freeway expansion raises the risk of health hazards for underserved communities along the corridor.

"I can no longer allow state dollars to fund expansion projects that kill all of us faster."

What America will and will not do in Ukraine

By President Joe Biden

The invasion Vladimir Putin thought would last days is now in its fourth month. The Ukrainian people surprised Russia and inspired the world with their sacrifice, grit and battlefield success. The free world and many other nations, led by the United States, rallied to Ukraine's side with unprecedented military, humanitarian and financial support.

As the war goes on, I want to be clear about the aims of the United States

America's goal is straightforward: We want to see a democratic, independent, sovereign and prosperous Ukraine with the means to deter and defend itself against further aggression.

As President Volodymyr Zelensky of Ukraine has said, ultimately this war "will only definitively end through diplomacy." Every negotiation reflects the facts on the ground. We have moved quickly to send Ukraine a significant amount of weaponry and ammunition so it can fight on the battlefield and be in the strongest possible position at the negotiating table.

That's why I've decided that we will provide the Ukrainians with more advanced rocket systems and munitions that will enable them to more precisely strike key targets on the battlefield in Ukraine.

We will continue cooperating with our allies and partners on Russian sanctions, the toughest ever imposed on a major economy. We will continue providing Ukraine with advanced weaponry, including Javelin anti-tank missiles, Stinger antiaircraft missiles, powerful artillery and precision rocket systems, radars, unmanned aerial vehicles, Mi-17 helicopters and ammunition. We will also send billions more in financial assistance, as authorized by Congress. We will work with our allies and partners to address the global food crisis that Russia's aggression is worsening. And we will help our European allies and others reduce their dependence on Russian fossil fuels, and speed our transition to a clean energy future.

We will also continue reinforcing NATO's eastern flank with forces and capabilities from the United States and other allies. And just recently, I welcomed Finland's and Sweden's applications to join NATO, a move that will strengthen overall U.S. and trans-Atlantic security by adding two democratic and highly capable military partners.

We do not seek a war between NATO and Russia. As much as I disagree with Mr. Putin, and find his actions an outrage, the United States will not try to bring about his ouster in Moscow. So long as the United States or our allies are not attacked, we will not be directly engaged in this conflict, either by sending American troops to fight in Ukraine or by attacking Russian forces.

We are not encouraging or enabling Ukraine to strike beyond its borders. We do not want to prolong the war just to inflict pain on Russia.

My principle throughout this crisis has been "Nothing about Ukraine without Ukraine." I will not pressure the Ukrainian government — in private or public — to make any territorial concessions. It would be wrong and contrary to well-settled principles to do so.

Ukraine's talks with Russia are not stalled because Ukraine has turned its back on diplomacy. They are stalled because Russia continues to wage a war to take control of as much of Ukraine as it can. The United States will continue to work to strengthen Ukraine and support its efforts to achieve a negotiated end to the conflict.

Unprovoked aggression, the bombing of maternity hospitals and centers of culture, and the forced displacement of millions of people make the war in Ukraine a profound moral issue. I met with Ukrainian refugees in Poland women and children who were unsure what their lives would be, and whether the loved ones who stayed behind in Ukraine would be OK. No person of conscience could be unmoved by the devastation of these horrors

Standing by Ukraine in its hour of need is not just the right thing to do. It is in our vital national interests to ensure a peaceful and stable Europe and to make it clear that might does not make right. If Russia does not pay a heavy price for its actions, it will send a message to other would-be aggressors that they too can seize territory and subjugate other countries. It will put the survival of other peaceful democracies at risk. And it could mark the end of the rules-based international order and open the door to aggression elsewhere, with catastrophic consequences the world over.

I know many people around the world are concerned about the use of nuclear weapons. We currently see no indication that Russia has intent to use nuclear weapons in Ukraine, though Russia's occasional rhetoric to rattle the nuclear saber is itself dangerous and extremely irresponsible. Let me be clear: Any use of nuclear weapons in this conflict on any scale would be completely unacceptable to us as well as the rest of the world and would

Americans will stay the course with the Ukrainian people because we understand that freedom is not free. That's what we have always done whenever the enemies of freedom seek to bully and oppress innocent people, and it is what we are doing now. Vladimir Putin did not expect this degree of unity or the strength of our response. He was mistaken. If he expects that we will waver or fracture in the months to come, he is equally mistaken.

A win for private rights

Social media is one of the main places where Americans engage in their ongoing dog fight over political differences. But anything that becomes important also becomes a target for control, and conservative politicians are doing their best to put a choke collar on Facebook and Twitter.

They suffered a setback Monday when a federal appeals court struck down a Florida law imposing heavy-handed restrictions on these communication platforms. Republican Gov. Ron DeSantis signed it last year, ostensibly to prevent tech companies from censoring conservatives.

But the court, in an opinion written by a judge appointed by Donald Trump, reminded everyone that the First Amendment protects individuals and companies from government action, not private action.

If you want to stand on a public sidewalk and spew lies, hatred and conspiracy theories, or hand out leaflets filled with them, the First Amendment says the government can't stop you. But if you want to do the same thing in a restaurant, department store or construction site, the owner, not being an agency of government, has every right to tell you to either stop or leave.

The Florida law says that social media companies have no right to make their own editorial decisions. The measure forbids them from removing anyone who is running for office and from blocking posts from "journalistic enterprises" because of their content. Failure to comply can incur fines of up to \$250,000 per day.

Texas enacted a similar law, which a federal appeals court has allowed to remain in operation while it is being challenged. Republican Gov. Greg Abbott said he signed it to "protect First Amendment rights in the Lone Star State."

But there is no way to square these laws with the First Amendment. Just as the Biden administration may not require Fox News to include liberal viewpoints and Democratic spokespeople on its programs, states can't require Twitter to provide a forum to Trump, Marjorie Taylor Greene or Mike Lindell.

A social media company, like any other media entity, may make its own rules for access. Elon Musk doesn't like the rules established by Twitter. If he buys it, he'll have every right to shred them, welcoming anyone he wants and banning anyone he doesn't.

The 11th Circuit Court of Appeals had no trouble spotting the fatal defects in the Florida law. "Social-media platforms exercise editorial judgment that is inherently expressive," it said. "When platforms choose to remove users or posts, deprioritize content in viewers' feeds or search results, or sanction breaches of their community standards, they engage in First-Amendmentprotected activity."

They are no different, in constitutional terms, from The Washington Post



or Breitbart News. Both publications choose what subjects to cover, what to ignore, and what viewpoints and writers to include. Without that discretion, neither could function. Without the same discretion, Facebook and Twitter would become a cesspool of bigotry, misogyny, lunacy, disinformation and

Anyone who chafes at the restrictions on Twitter or Facebook is free to migrate to other platforms. Trump furnished that opportunity when he started an alternative, Truth Social, to "stand up to the tyranny of Big Tech."

His commitment to wide-open debate is not a model of principled consistency. One user was informed, without explanation, that he had been banned "permanently due to Truth Social community guideline violations." The apparent violation? His account, @DevinNunesCow, was intended to make fun of former Rep. Devin Nunes, the CEO of Truth Social's parent

Trump's fans could also move over to the platform ProAmericaOnly, which brags of its "no censorship" policy — while proudly proclaiming that it "doesn't allow liberals."

Conservatives once believed that the government should not interfere with the content decisions of big, powerful media companies. In 1987, they persuaded the Federal Communications Commission to scrap the Fairness Doctrine, which required TV and radio stations to present competing views on controversial topics.

Its repeal facilitated the rise of conservative talk radio, because stations no longer had to balance right-wing voices with liberal ones. When a Democraticcontrolled Congress passed a bill to codify the policy, President Ronald Reagan vetoed it.

"This type of content-based regulation by the federal government is, in my judgment, antagonistic to the freedom of expression guaranteed by the First Amendment," he said. "In any other medium besides broadcasting, such federal policing of the editorial judgment of journalists would be unthinkable.

Unthinkable to Reagan, yes. But not to the people who have taken over his





PARAMOUNT - The LA Kings, AEG, and American Sports Entertainment Company (ASEC) have purchased the newly-named LA Kings Iceland at Paramount, the group announced Wednesday.

The transaction includes the acquisition of the land, building and historic business formerly known as Paramount Iceland.

In addition to being a mainstay in Paramount and serving the community in the greater surrounding area since 1940, LA Kings Iceland at Paramount (8041 Jackson St, Paramount) is home to the first Zamboni machine and part of the purchase agreement includes a new Zamboni museum to be established in honor of the late Frank J. Things you didn't know about Downey: When Lemuel Carpenter owned Downey

The following two stories come from John Adams and were first published in the Downey Eagle on Dec. 5, 1997:

The land that John Downey, former governor of Downey, subdivided to create Downey as we know it today had a history before the former governor got

It had belonged to Lemuel Carpenter, something of a mountain man whose roots lay in Kentucky.

Carpenter came here in 1832, after stopovers in St. Louis and New Mexico. He settled and founded a soap factory on the west bank of the San Gabriel River not far from Los Nietos (which later became known as Downey). His place was called

Carpenter later bought the Santa Gertrudes Rancho and lived on it until 1859. He didn't know it but his rancho was to become the site of one of the historic battles of California.

He had charm and his nature suited him to the easy life of the Spanish residents who accepted

Sadly, the transition of California from its Spanish landholders to an American holding, complete with political fights over land boundaries, proved too much for him. He was not acute in the world of business. He eventually lost everything and Downey purchased the land at a sheriff's sale.

Carpenter was so emotionally shattered after the loss of his estate that he committed suicide.

How had he acquired his lands? During his successful years as a soapmaker, Carpenter married a girl of Indian heritage named Espiritu. She died in childbirth and Carpenter, apparently seeking friends, moved his soap factory to the Santa Gertrudes side of the river to be nearer to Los Nietos. There were fiestas, horse racing and dancing there.

He met Maria de Los Angeles Dominguez, a niece of the widow who owned Rancho Santa Gertrudes. They soon married.

The union with Maria produced five children, and Carpenter found he had crossed a cultural barrier. He accepted the ways of early Spanish California. He bought the rancho in 1843 from his aunt by marriage. He raced horses and was known for playing cards.

He had barely established himself as an Anglo Don when a band of soldiers and sailors from the United States marched across his rancho. It was Gen. Stephen Watts Kearny's Army of the West, part of the force that claimed and won California for the United States.

One of the few fights of the brief war for California

was fought on the northwest corner of Carpenter's ranch. It was known as the Battle of San

A bronze plague and two cannons mark the spot today at Bluff Road and Washington Boulevard.

Following Carpenter's death, John Downey, who had ended up with most of the vast landholdings, showed concern for the welfare of Carpenter's widow and children. He gave them 100 acres with a house on the east bank of the San Gabriel.

She lived there for years, making a meager living by growing walnuts.

The diary of Carpenter's daughter, Mary Refugio Carpenter, is one of the finest historical chronicles of the

Her entry of Jan. 2, 1861, read, "After dinner I sewed most of the afternoon. I have been thinking so much of my father tonite. It made me weep."

Mary Carpenter

No history of Downey is complete without Mary Refugio Carpenter Pleasants, the daughter of Lemuel Carpenter who killed himself after

losing his huge Rancho Santa Gertrudes estate which included Downey.

Mary was born July 4, 1845, and the tragic death of her father in 1859 left a lifelong shadow over her life.

Lemuel Carpenter had borrowed \$5,000 from John Downey and James P. McFarland, a druggist, in 1852. At the exorbitant interest rates of the times, his debt was \$104,000 by 1859.

Four days before his land was to be sold at sheriff's auction, Carpenter put a bullet through his head.

Two months after her father's passage, Mary began a diary. She had spent Christmas 1860 at the home of her aunt and uncle, William and Maria Wolfskill, who lived on Alameda Street in Los Angeles.

In her first diary entry she mentions visiting the grave of her father that day. She was only 14 but kept a total of six diaries which ran through 1865.

Mary and other members of her family attended a private school maintained by her uncle for his own and his friends' children. This, and later schools, allowed her to earn a certificate to teach in the primary schools

of Los Angeles County in 1866.

Among them she met in the social whirl of the Wolfskill home was Joseph Edward Pleasants, a friend of Wolfskill from Solano County above San Francisco. Mary and Pleasants were married in 1868 at the Plaza Church in Los Angeles by Father Francisco Moro.

Her earlier diaries depict the love and loss she felt at her father's death Jan. 3, 1860. "The day was very clear but towards the evening the clouds began to gather," she wrote. "Last night I saw my father in my dreams. I was not happy."

On Tuesday, July 4, her birthday, she wrote a stirring

"How little do we think how kind our heavenly father is. We do not think that he could take our lives any moment he wished. Oh how ungrateful we are. Today I am 15. Will I be in the world next year, the 4th, only my heavenly father knows. Thy will be done. I was more sad than happy all day. After dinner they danced. I danced two times, then laid down on the sofa. Went to sleep. Woke up and found myself all alone.'

Things you didn't know about Downey

The Mussachia Ranch

The following article was written by John Adams, with assistance by Bob Thompson, and published April 1, 1994 in the Downey Eagle:

Few realize an old house on the 8700 block of Stewart & Gray Road is so rich in Downey history.

It was once the home of the Mussachia family, pioneers here in Downey. They first arrived in 1885 and a son, Tony, graduated from Old River School's Class of 1906. He later married a Downey girl, Anna Riemer.

For a wedding gift, the bride's father gave them 20 acres of land to which Tony later added 20 more. Those 40 acres of farmland are now the northern portion of Rockwell, bounded by Stewart & Gray to the north, Bellflower to the east and Lakewood to the west

Tony and Anna had four children: Carl, Frank, Anna Marie and Anthony, all of whom attended Downey High.

During the height of the Depression from 1934-38, Mrs. Mussachia opened a restaurant, the Airport Cafe, located where the old Rockwell lobby stands today.

The land was sold to Vultee Aircraft in 1938. The ranch house was then moved to Stewart & Gray but had to be moved again when that road was paved through to Lakewood Boulevard. The house still sits in the 8700 block of Stewart & Gray Road today, a monument to the pioneer family which built it.

Meanwhile, the restaurant was moved to Lakewood and Borton Street in Bellflower. Unfortunately, it later burned. The foundation can still be seen next to Frank's TV Shop.

As for the family, Carl worked for Vultee, North American and then Rockwell. Frank ran a parking lot across the street from Vultee from 1937-42. The old lot is now occupied by a rest home.

Frank then entered the Air Force, serving as a turret gunner in B-24 Liberators based both in North Africa and later in Italy. He was even shot down over Yugoslavia at one point but made his way safely back to Allied territory

When he returned to the U.S. he built Frank's Cafe in 1945. He ran the cafe until 1950. The location is now occupied by a chiropractic office in the 12100 block of Lakewood Blvd.

Carl and Frank are retired now but both can take pride in their family's pioneer history here. The old house is a testimonial to the generations of Mussachia who helped shape Downey.

Old River School

This story by John Adams was originally published in the Downey Eagle on Aug. 9, 1996.

The announcement that the new school to be constructed by the Downey Unified School District in front of West Middle School will be called Old River Elementary raises memories of the original Old River District schoolhouse which still stands.

Only the oldest Downey veterans may recall the original Old River School, built in 1889 and used as a schoolhouse for 50 years. The old building later became a church.

In 1946 it was moved to Quill Drive near Paramount Boulevard where it housed the congregation of the new Grace Baptist Church with Rev. Romey E. Black as pastor.

Today the old building at 7948 Quill Drive stands at the rear of the Jung Bu Young Nak Presbyterian Church. While it now bears a coat of stucco on its exterior, the original walls date to 1887. Those of a historical bent say that if you stand quietly beside it you can still hear the echoes of countless classes of young Downeyites who got their early education there, now our grandparents and greatgrandparents.

When first built, the old schoolhouse served a strictly rural area. The sons and daughters of farmers walked or rode horses to school there.

Just before World War II, a new school building was erected and plans to raze the old building were made. The need for housing necessitated by the war years saved it. In 1946 it was converted to a church.

Church officers of that Baptist post-WWII congregation included Mrs. J.L. Stalker, Mrs. A.E. Comstock, G.L. Fishel and Robert M. Davis.

Old River School superintendent was Roland Adams when the old building was sold and moved.

The sale was a blessing in disguise, as it actually saved the old structure, which outlasted the structures erected to replace it. In 1979, the "new" Old River School at 7547 Quill Drive had become the Ambassador (Pacifica) Christian School on 3.25 acres of valuable campus.

The religious school decided to ive and sold the land to hou developers who subsequently built 18 homes there. The "new" Old River School building came down to make way for progress.

The original elder structure is still with us today, a reminder of our rural days and pioneer origins.

Let's hope the latest Old River School lasts as long and has as illustrious a history.

Private Streets

Visitors to Downey might be mystified after turning down a shady tree-lined street to find

a well-weathered barricade spanning the roadway for no apparent reason –and obviously a permanent fixture.

Elsewhere, the inquisitive sightseer can ferret out, among the broad residential streets, quiet little byways scarcely more than a long driveway leading back between closely nestling homes.

Usually, these inobtrusive little asphalt corridors are marked with small hard-to-spot street signs, frequently not more than waist high. All of them tell the traveler he is entering a private road, and viewing a curious legacy of Downey's past travails under the paternalistic, often myopic eye of the county bureaucracy.

Depending on one's point of view, these rustic lanes help preserve the serene charm of Downey's long-faded rural heritage, or they are the product of flagrant disregard for proper planning, and frequently the byproduct of a system of patronage and favors.

In some cases, the legacy however arrived at - has been a happy one for the residents who cherish their cloistered "country

Others have been soured by the refusal of a bank to advance a loan on property which does not take access from a public street, or by the refusal of neighbors to cooperate in the upkeep of the road. When you own the street, you either do the roadwork yourself or you hire someone else. The city only cares for public, dedicated streets.

Property owners set their own speed limit of 20 mph on the private section of Brookmill Road, five miles below the rate for Downey's public residential

Of the dozen private roads which still exist in Downey, one remained a dusty unpaved route until just recently when the city was able to require half of it to be improved when a new subdivision of fives homes came in. The new half-paved strip is on Orizaba Avenue south of Orange Street. One now drives north on asphalt and returns southbound on dirt.

At the opposite extreme is Brookmill Road west of Rives Avenue. Were it not for the barricade midway between Rives and Old River School Road, one might not realize the roadway isn't a public thoroughfare.

The longest private street in Downey by far is Rivergrave Drive, which dips and curves for about 1,700 feet along what was once the eastern bank of the old Rio Hondo River, before the channel was straightened and lined with concrete. The low-lying roadway forms the western bulwark of Downey's Island at the northwest corner of the city.

One of the shortest - Rives Avenue north of Suva Street - also is among the most picturesque, ending in a circle before a barnlike garage surrounded by stately

Virtually, the only private


street erected under city aegis and the only one presently in use – is Rives Road. Little more than a wide driveway running east across three lots, it leads off Rives Avenue opposite Furman Park. The private street was permitted through a zone exception resulting from a lot split when three home sites were created from a long narrow strip of land. Had the city required dedication for a 30-foot wide residential street, there would not have been enough land left to meet the lot size required by existing

Other private streets in Downey which still exist include Primrose Land (off Downey Avenue), Valinda Drive (off Downey Avenue), Baysinger Street (west off of Paramount Boulevard), Leeds Street (east, off of Paramount Boulevard), and Lubec Street (west, off of Brookshire Avenue).
