

Downey city manager Gilbert Livas bids farewell to what he calls his "dream job."

DOWNEY - There is just over a week left before City Manager Gilbert Livas makes his exit from the city, but you might not be able to tell just by looking at him; there's still enough going on at City Hall to keep his mind occupied, and off of his impending retirement.

"I think in some ways that's probably a blessing in disguise that I've been so busy, I really haven't had time to think about what I'm going to do next, or what's going to happen after July 1," said Livas. "I've really been extremely busy the last six months trying to complete a budget, get a lot of things off my plate, and make sure the place is in the best shape it possibly can be for the next person who sits in this chair."

It's been an over 14-year run for Livas and the city, who came on board in 2007.

When I came [to Downey], I still remember thinking, 'This is a great place.' It felt like home, it felt like I had landed my dream job," said Livas. "It was professionally run, it had great council members, I was impressed by the staff that was here.



"It was certainly fast, but not too fast," said Livas. "Enough for me to get sort of a handle and get my bearings in terms of what was happening in the city."

It also just might have been one of the most difficult times for someone to take over the city manager position.

As he describes it, "there was no honeymoon period."

"From an organizational standpoint, it was really smooth. Smooth transition is one thing; assuming the job is quite another thing," said Livas. "I took over probably at the worst time you could take over, and probably in the city's history, probably the worst financial time.'

Livas took over at a time when the recession had forced the city to spend around \$12 million of its "rainy day" reserves over the course of three years just to keep its budget balanced.

"We had burned through almost half of our reserve in three years," said Livas.

He says it's the reason he is so protective of the city's reserve funds today.

"When I got hired, it was like 'No more deficit spending," said Livas. "I'm the new guy, I said 'No more deficit spending, we're done. We gotta balance our budget.

"At the same time, the State in January eliminated redevelopment agencies, so all our redevelopment money that we had was also gone."

The still new and very fresh city manager would have to contend with a near \$14 million deficit budget, forcing him to make extremely difficult decisions.

Over his tenure, Livas is credited with the rebirth of the city's downtown, expanded dining and shopping opportunities, expansion of the medical hub, the completion of Measure S projects and launch of an over \$30 million residential street improvement project, leading the city through the recession and the Covid-19 pandemic, the building up of the city's reserves, and - most recently - the completion of 10 consecutive balanced budgets.

Having worked with several different variations of the city council, Livas has also had to wrangle what potentially are five very different personalities and visions for the city at any given time.

"I think for most city managers, I think that's the job, is trying to balance expectations, personalities," said Livas. "I would say that a lot of my success in that realm was due to talking to folks, listening to them, engaging before problems arose. I think that as difficult as that may be, I also relied on them as well.

"Many of them came with some level of expertise, for example Dave Gafin was an accountant, a CPA. Alex Saab was an attorney, Roger Brossmer worked for the [school] District. public service and excellence." On and on. Claudia [Frometa] was in emergency preparedness. You had all these people that brought some level of expertise, it would be silly for me not to be able to tap into that; why let it go to waste?"

## School board votes to prohibit gum on campuses

Gum was previously prohibited only on select middle school campuses.

DOWNEY - The Downey Unified School District voted on Tuesday to prohibit chewing gum at its middle and high schools.

There was previously no official policy surrounding gum, though Warren and Columbus High and Sussman Middle schools prohibit the selling of gum, and Doty, Griffiths, and Stauffer Middle Schools prohibited it on campus.

The main concern over gum is mostly comes from the residue and stains it leaves on the concrete pathways, even after having been power washed by district maintenance crews.

President Bobbi Samperi later made similar remarks.



## Stay Arts offers half million-dollar proposal to keep gallery open

■ Stay Arts, the non-profit that operates Stay Gallery and its related programs, is asking the City of Downey for a \$519,055 investment over three years or risk losing the gallery.

**DOWNEY** - Stay Arts has submitted a new three-year, over half million-dollar proposal to the city of Downey that would see the city stop subsidizing Stay Gallery's rent and instead pay for programming outright.

Stay's newest proposal includes six admission-free art exhibits, one month-long residency for the Downey Arts Coalition, and 12 Stay Young: Family Paint Days per year, as well as the Stay Public arts incubator program (eight micro-grant projects per year awarded to creative professionals and community partners for the production of workshops and events in the gallery space), at the cost of \$167,930, or \$519,055 for three years.

They're hoping the city will agree to front that bill in lieu of the rent.

The city of Downey has covered the cost of Stay Gallery's downtown space since 2012, in exchange for Stay's community programming. The original two-year agreement has been extended several times over the years, most recently with the city agreeing in March to provide the gallery with \$28,000 to operate through July.

In total, Downey has invested over \$313,400 in Stay Gallery over 10 years.

Still, the gallery has struggled to make ends meet.

"Even though we have technically a year left in our agreement with the city where they're funding the space, it kind of leaves us in the same position that we've been in since 2012, of not knowing where the next steady source of revenue to continue operations [is coming from].'



## Why Watergate-era campaign finance laws haven't stopped corruption

The burglars who broke into the Democratic National Committee's headquarters at the Watergate office complex 50 years ago sparked coverups, investigations, constitutional crises, a presidential resignation, deep damage to Americans' faith in government and a raft of bipartisan legislation aimed at restoring that faith. One of those laws created a small federal agency to "follow the money," the Federal Election Commission, where I serve.

Those laws also triggered an almost immediate backlash at the Supreme Court, beginning with its Buckley v. Valeo decision in 1976 and accelerating in recent years. The court's decision last month in FEC v. Ted Cruz for Senate, which allows donors to slip money directly into an elected official's pocket, is the latest outrage but likely not the last.

The Watergate players' actions were brazenly corrupt. When President Richard M. Nixon's White House counsel, John Dean, told him that money would be needed to pay off the Watergate burglars' blackmail demands, Nixon replied, "You could get a million dollars. And you could get it in cash. I know where it could be gotten. I mean, it's not easy, but it could be done."

It is still shocking to hear a president plotting to raise hush money to cover up political crimes. But the amounts involved seem almost quaint compared with the mammoth sums now flowing into American politics, much of it either legalized or enabled by the Supreme Court.

The court has equated money with speech, struck down political spending limits and empowered corporations. It seems determined to entrench, and frankly celebrate, the might of big donors. That is stunningly out of sync with public opinion – a 2018 Pew Research Center poll found that 77 percent of Americans support limits on political

#### donations.

The Watergate scandal featured large sums of money, much of it in cash, clandestinely raised from individuals, corporate donors and foreign sources, and delivered to Nixon's political operation. People and corporations were successfully prosecuted for providing these illegal funds.

Today? The delivery of bags of cash to political campaigns remains illegal, as do direct corporate donations to candidates' campaigns. But in the past dozen years, there has been a proliferation of super PACs so closely associated with candidates that giving to the super PACs affords virtually the same benefits.

Thanks to the court's 2010 ruling in Citizens United v. FEC, corporations can legally give to these PACs. Individual donors who would be barred from giving \$3,000 directly to a candidate's campaign can legally give millions to a supportive super PAC. And the court insists that this is fine because "independent expenditures, including those made by corporations, do not give rise to corruption or the appearance of corruption."

In the 2020 election season, federal fundraising totaled more than \$14 billion. While substantial sums were raised from small donors, it is now also routine to see individual donors give millions of dollars. And those are just the ones we know about. Contributions to super PACs are required to be disclosed, but sophisticated and secretive donors know they can give to ideologically aligned nonprofit corporations that will pass along their money to the super PACs without revealing the donors to the public. (Politicians presumably know who their benefactors are.) This has contributed to more than \$1 billion in dark money flooding America's politics in 2020 alone.

The FEC has had some success in going after foreign donors, but I

remain concerned that foreign money can seep into the system through entities that are domestically incorporated but owned and influenced by foreign nationals.

The FEC bears some responsibility for this sad state of affairs. Lax enforcement and failure to update our regulations to deal with changing political practices have left the law disrespected and riddled with loopholes. The FEC's bipartisan structure (six commissioners, with no more than three of any political party) and increased polarization have often stymied efforts merely to investigate serious alleged violations.

What can be done? The Supreme Court is unlikely to revise its views on corruption, but solutions are still out there, if we can summon the political will to adopt them.

Congress should revive languishing bills intended to strengthen disclosure, which would help ensure the transparency that the Supreme Court has (so far) robustly endorsed, and enhance barriers against foreign spending in our elections. And the FEC must update its regulations (unchanged since before Citizens United) to meaningfully address the porous relationships between candidates and big-money super PACs. Stricter enforcement - by the FEC in civil matters and the Justice Department in criminal ones - is essential.

Watergate is not just a story about a bungled burglary. The corruption it revealed delivered a shock to the political system that brought government officials together across party lines to find the truth and try to restore trust. In these polarized times, a similar comingtogether seems unimaginable. The template is there – but it would require Republicans to work with Democrats, as they did 50 years ago.

## The U.S. door swings open to Ukrainians

The Biden administration has embarked on a sizable experiment in admitting Ukrainians who have fled Vladimir Putin's scorched-earth campaign to the United States. That tens of thousands of them have successfully sought refuge in this country over about three months, with relatively little fanfare – and even less controversy, considering the toxicity that attends most migration issues - is a reaffirmation of America's commitment to its values as a beacon to the world's most desperate people. That commitment must be sustained as the war in Ukraine drags on, which seems likely.

At least 71,000 Ukrainians have entered the United States, in nearly all cases legally, through airports in New York, Chicago, Philadelphia and elsewhere, as well as, in the war's earliest weeks, by crossing the southern border from Mexico. They have arrived according to various immigrant and non-immigrant categories, the most innovative of which has required U.S.-based sponsors to initiate their applications to travel here. Another 23,000 have been approved for travel; most are likely to arrive here in the coming few months.

through the regular refugee channel, a long-term process that allows for permanent resettlement in the United States.

Owing to Russia's aggression, Ukrainian refugees will be the world's responsibility, especially Europe's, for the foreseeable future. More than 5.1 million have flooded into Europe; over 3.2 million of them have applied for temporary residence there. The United States, as the largest Western country and leader of the NATO military alliance, must continue to bear a portion of the burden.

Under the most innovative program, known as Uniting for Ukraine, sponsors have applied to support more than 60,000 Ukrainians seeking entry to this country; they include relatives or friends of those fleeing the war, as well as groups including nonprofits and churches. New online applications to sponsor individual Ukrainians are continuing at a rate of as many as 1,400 daily. In addition, roughly 22,000 managed to make it into this country before the sponsorship program was established, in April. Still others entered with visas and green cards.

At the current pace, the administration may reach its goal to admit 100,000 Ukrainians, announced in April, as soon as this summer. Officials have stressed that that number is a commitment, not a ceiling; that means admissions can – and should – continue once the mark is reached.

Given what may become a war of attrition in Ukraine, the administration would be wise to prepare for a long-term commitment. Most Ukrainians who fled their homes, hoping to return soon, have waited so far in nearby countries - Poland, Romania, Moldova and others in Eastern Europe. As the war drags on, more are likely to take resettlement opportunities farther west - in Western Europe and Canada as well as the United States.

The Biden administration's sponsorship program is innovative - it frees the government from its traditional role in resettling and supporting refugees. That is partly a matter of practicality: officials inherited a refugee resettlement program, gutted under President Donald Trump, that is ill-equipped to absorb the tens of thousands of Ukrainians now arriving. It's a workable solution for now, but it only allows stays limited to two years. It should not preclude Ukrainians who lack U.S. sponsors from applying to enter the country going forward

## Lightning kills woman, two dogs in **Pico Rivera**

PICO RIVERA - A woman and her two dogs were fatally struck by lightning in Pico Rivera Wednesday as a storm front pushed across the Southland and led to power outages and beach closures.

The lightning strike in Pico Rivera occurred around 8:50 a.m. when the woman was walking along the San Gabriel River, according to the Los Angeles County Sheriff's Department. The woman and her dogs both died at the scene.

"There's a one-in-a-million chance of something like this happening, and it happened," Los Angeles County sheriff's Sgt. Patrick Morey told the Los Angeles Times.

According to the county fire department, the woman was struck near Mines and Rimbank avenues.

It was a tragic turn in a morning peppered by scattered thunderstorms that made for a damp morning commute in some areas, sparked at least one small brush fire and caused lighting strikes that forced temporary closures of Orange County beaches in Newport Beach and Laguna Beach.

All beaches in Long Beach were closed late Wednesday morning due to a "significant lightning strike

Diverticula are pockets of mucous membrane which have been pushed out through weak points in the muscle. Diverticulitis is when one or more of these pouches become inflamed, and in some cases infected.

Diverticulitis can lead to bleeding, abscesses, perforation of the colon, strictures, and fistulas. It can cause severe abdominal pain, fever, nausea and change in the stool. However, most of those with diverticulosis do not have symptoms.

The old traditional method of managing diverticulitis was to prescribe routine antibiotics for everybody. This practice is on the way out. The American College of Physicians has developed new guidelines which are based on evidence that diverticulitis is indeed a disease of inflammation, but does not always include infection.

Therefore, some patients can forgo antibiotics, recover just as well, and have less antibiotic exposure. (Of course, it's not always easy for a doctor to send a patient home without an antibiotic, when the longtime rule has been to prescribe one.)

We now look at diverticular disease on a spectrum, beginning with

asymptomatic diverticulosis. the symptoms worse. Diverticula without

inflammation are common. Next on the spectrum is mild diverticulitis, which involves inflammation of a small area of the intestine. More severe diverticulitis carries with it more intense inflammation and possible abscess formation, and comes with a risk of perforation and death.

Antibiotics should be used, per these new guidelines, when the patient has complicated diverticulitis, other chronic conditions, is immunosuppressed, or has signs of a more systemic disease process. Antibiotics may also be used if symptoms last for more than five days, or if the patient cannot eat without making

Diverticulosis is usually a result of consuming a lowfiber diet, and from straining when having a bowel movement. Lifestyle changes that may help prevent future attacks are highly effective and very straightforward:

·Cut down on red meat

·Consume more dietary fiber

·Increase physical activity ·Work towards a normal body mass index (BMI)

·Do not smoke.




