■ Many people are mourning the death of Vin Scully, including this lifelong Dodgers

DOWNEY - We all have a Vin Scully story.

Mine took place at an "An Evening with Vin Scully" event held in Pasadena in 2017. I had splurged on a VIP ticket, granting me the once in a lifetime chance to meet one of the few people I will audibly admit to being "one of my

My time allotted was brief. No time for an autograph, to pour my heart out or pick his brain, I had a few seconds to hopefully sneak in a handshake, maybe a few words of gratitude, and pose for a photo.

I don't remember what I said, just that he was humble in

That photo is one of the few of myself I consider to be the most authentic. Nothing forced, nothing awkward. My grin, ear-to-ear. My hand tightly clasped around his, never wanting to let go. A moment of raw, unfiltered bliss frozen in

I can't tell you everything he said that night during his talk. I remember bits and pieces, mainly about his thoughts on the controversy surrounding the NFL at the time, and that "It's hard to win a world series" (we were still pretty fresh off of the Dodgers' loss to the Houston Astros that year).

No, what I took away most from that night was a feeling of awe and amazement. It was miraculous albeit not surprising how Vin captivated the entire audience for that hour, like a grandfather perched in his chair with hundreds of grandchildren sitting attentively at his feet.

Vin was more than just the voice of the Dodgers, of baseball.

To many fans, Vin was a friend. An icon. A legend. A gentleman. A master storyteller.

His tones were melodical to the point of whimsical. There was comfort to be found in every anecdote, statistic, and bit of humor. He held a cadence that was unmatched, unparalleled, and unable to be duplicated.

He wasn't just the voice of the Dodgers; he was their very soul.

Vin retired in 2016, and has long been removed from his namesake press box. In the time since then, Dodger fans have learned to love and appreciate new, and other Dodger broadcasters: Joe Davis and Orel Hershiser, Rick Monday and Charley Steiner, John Hartung, Jerry Hairston Jr., Ned Colletti, Alanna Rizzo, and Nomar Garciaparra (just to name a few).

Jaime Jarrin and Fernando Valenzuela are already legends in their own right.

Still, there will never be another Vin Scully.

With just over 50 games left, this season will continue on and - inevitably - it will be time for Dodger baseball once again; Dodger Stadium will just shine a little less blue for now.

Goodbye Vin. Thank you.

And a very pleasant good afternoon to you, wherever you may be.

After long wait, Downey adds name of fallen Marine to veterans memorial

■ Lance Cpl. Joshua Whittle, killed in Afghanistan in 2009, had his name added to Downey's veterans memorial this week.

DOWNEY - Friends and family of Marine Lance Cpl. Joshua R. Whittle celebrated Tuesday morning when the fallen Marine's name was officially added to Downey's veteran's memorial outside of City Hall.

Whittle, who attended Warren High School and was a former Mr. Downey pageant contestant, was assigned to the 2nd Battalion, 3rd Marine Regiment, III Marine Expeditionary Force based in Kaneohe Bay, Hawaii.

He had only been in Afghanistan three weeks when he was killed by a landmine on June 6, 2009 in the Helmand Province. He was 20.

"Every Memorial Day we honor and remember those who have died for our country. We pray and recognize all those gold star families," said Mario Guerra, who was mayor at the time of Whittle's death. "Today we are doing exactly that, but with special purpose: to fulfill the promise our community made to Lance Cpl. Josh Whittle's mom 13 years ago; a promise that's rooted in the belief that he was and always will be one of our own, a promise to let future generations know how special those who gave their lives for us are, to make sure we never forget one of our own, and to also remind our city about a courageous young man who wanted to defend our country.'

Former mayor Dr. Roger Brossmer – who was also on the city council at the time of Whittle's death - made note of the promise that they had made to Whittle's mother, Crystal, who died last year and never saw her son's name on the memorial.

"We were very committed to be with the family and support them through that process, and while we had our banner program to represent all of our veterans, at the time we just didn't have anything significant or appropriate enough to really mark that ultimate sacrifice," said Brossmer. "That's what really started our veteran memorial, and then our ability to really remember Josh and everything he gave and that he gave it all for us.

"This is really just a kind of us as a city honoring that promise we made to the family."

In attendance Tuesday was Darlene Matson, Whittle's sister.

She said Whittle's inclusion the memorial was a "beautiful and amazing thing that the city is

"It's a huge ball of emotion in a positive way," said Matson. "Even more so, he's buried at Riverside National Cemetery; I live in Downey. I think the fact that I have something that I can go to that's local on those hard days is going to help with my emotional rollercoaster that sometimes I go through on those difficult days, in remembrance of my brother.

"It's a rollercoaster of emotions, but ecstatic would be one of them.'

There is some belief that Whittle's name should have been added to the memorial much

"I think we're a little slow on it, to be honest with you. I think we should've done it sooner," said Brossmer. "But as shared by some of our American Legion friends, it's never too late to do the right thing... I think we should have done it sooner; I'm glad it's getting finally

Guerra added, "It's always the right time to do the right thing."

Matson, however, told those in attendance to "not apologize."

Roybal-Allard votes to ban assault weapons

DOWNEY Democratic Congresswoman Lucille Roybal-Allard issued the following statement after she voted last week to pass H.R. 1808, the Assault Weapons Ban of 2022, legislation that if signed into law would make it a federal crime to import, sell, manufacture, transfer, or possess a semiautomatic assault weapon or large capacity ammunition feeding

'Twenty-eight years ago, I voted to ban assault weapons to make our communities safer. Since the assault weapons ban expired, mass shootings have risen dramatically, and we have seen terrible acts of gun violence in America's schools, businesses, and houses of worship,' said Roybal-Allard.

"These preventable are tragedies. We can no longer continue to do nothing as our children, families, and loved ones fall victim to these horrible crimes. The Assault Weapons Ban of 2022 will save lives and keep weapons of war off our streets.

The U.S. House Judiciary Committee late Wednesday passed legislation that would ban certain semi-automatic weapons, in a renewed push to ban the guns most commonly used in recent mass shootings.

Homeless housing \$1.4M over budget

DOWNEY - The cost to build transitional housing for the homeless at Rancho Los Amigos National Rehabilitation Center is \$1.4 million more than initially budgeted.

The L.A. County Board of Supervisors will vote Tuesday on the budget increase, which would bring the total project cost to \$4.8

In 2020, supervisors voted to convert Buildings 601-602 on the county-owned hospital into interim housing for up to 80 people.

The 15,000 sq. ft. structure was converted to dormitories, with entertainment space, outdoor seating areas, and other areas

services.

Officials with the county's Department of Public Works, however, determined that the construction exceeded cost the approved budget, blaming "unforeseen conditions COVID-19 material/equipment price escalation."

The "unforeseen conditions" included replacement of the entire electrical systems and HVAC ducts due to asbestos contamination and limited power availability requiring low power systems, which are more

Officials said the \$1.4 million increase will be offset by a corresponding increase in federal coronavirus relief funds received by the county.

Judge dismisses water district's suit against its own board member

■ The Central Basin Municipal Water District had sued Leticia Vasquez over a series of videos and letters alleging contaminated water, including in Downey.

DOWNEY – Citing First Amendment grounds, a judge has dismissed a lawsuit filed by Central Basin Municipal Water District against one of its board members who posted online videos and sent letters invoking the district's name, allegedly without the consent of its general manager or the entire board.

Los Angeles Superior Court Judge Michael L. Stern ruled

Stern's dismissal of the district's case was "without prejudice," meaning it can be refiled under appropriate circumstances.

Vasquez, a former Lynwood mayor, previously told City News Service that the lawsuit was "an effort to chill free speech and silence me about the toxic water being sold to our community. I stand by my

> According to the district's suit filed in April 2021, the district's administrative code prevents directors from posting videos or using its logo or stationery for business or non-district business, including any solicitation or other political activity, without approval from the general manager.

> In September 2020, Vasquez posted on YouTube.com a video about water quality in Pico Rivera in which she referred to the district, identified herself as a board member and stated she wanted "to encourage both the city of Pico Rivera and the Pico Water District to consider purchasing water from the Central Basin," the suit stated.

> Vasquez posted another video in March 2021, this time dealing with water quality, in which she once again referred to herself as a board member and placed the district's name into captions within

the video, the suit stated.

The video also was made in association with the Political Life group, the suit stated. The group's website stated that Vasquez appeared in the video after agreeing to an interview regarding the video's subject matter, according to the suit.

Vasquez allegedly posted a third video in association with the Political Life group regarding AB 1195, the California Safe Drinking Water Act, in which she also invoked the district's name.

The videos "give the viewer the impression that (Vasquez) is making authorized statements on behalf of (the district) or that (the district) was otherwise involved in the creation of, or associated with, the videos, particularly given (Vasquez's) direct reference to her position on (the district's) board of directors," the suit stated.

Although Vasquez and Political Life are free to express their personal views, the use of the district's name in public, political statements without the district's permission is contrary to its administrative code, the suit stated.

Vasquez also used district letterhead when writing in April 2021 to the cities of Santa Fe Springs, Lakewood, Downey and Signal Hill, the suit stated.

The district's general counsel advised Vasquez to stop her alleged unauthorized use of district materials, but the request was ignored, prompting the filing of the lawsuit, according to the district's court papers.

Legislation to ban assault weapons now heads to Senate

The party-line 25-18 vote followed recent mass shootings in which AR-15 style rifles were used - in Uvalde, Texas, where 19 children and two teachers were murdered, and Buffalo, New York, where 10 people were killed.

The chair of the committee, Jerry Nadler, said that the more than 100-page bill that would place a ban on assault weapons, H.R. 1808, is nothing new and Congress passed a 10-year ban on assault weapons in 1994.

If the ban were to be enacted into law, anyone owning the firearm banned in the bill would have their weapons grandfathered in, so they would not have to give up their firearms.

"As we have learned all too well in recent years, assault weapons especially when combined with high-capacity magazines - are the weapon of choice for mass shootings," Nadler said in his opening statement. "Quite simply, there is no place for them on our

The bill would ban all semiautomatic rifles that can have a detachable magazine and have a military feature such as a pistol grip, a detachable stock or grenade launcher, among other features. It also bans "all semi-automatic rifles that have a fixed magazine with the capacity to accept more than 10

It also bans high capacity feeding devices, such as magazines, strips and drums that are capable of accepting more than 10 rounds.

The bill has a chance of passing the Democratic-controlled House, but a slim chance of success in the evenly divided Senate, where it would need to reach a 60-vote threshold. Congress passed the most comprehensive federal gun safety legislation in nearly 30 years in late June.

Preventing future mass shootings

Democrats argued the ban would help prevent future mass shootings, adding that schools, places of worship, movies and grocery stores have become dangerous places.

"We are paying for these weapons of war on our streets with the blood of our children sitting in our classrooms," said Rep. Lucy McBath, a Georgia Democrat who lost her son Jordan to gun violence.

"Dangerous military weapons that were created to fight on the battlefield and slaughter enemies do not belong in the neighborhoods and schools and movie theaters where we live," Cicilline said.

Rep. Madeleine Dean, Pennsylvania Democrat, slammed Republicans for refusing to address the fact that there are thousands of victims of mass shootings, and that Congress has a duty to try to prevent future mass shootings.

'Weapons of war'

Republicans did not focus on the victims of mass shootings, but instead argued that the assault rifles that Democrats wanted to ban were not technically "weapons

Thomas Massie, a Kentucky Republican, said that Democrats were trying to ban "the most commonly sold sporting

"Democrats know this legislation will not reduce violent crime or reduce the likelihood of mass shootings, but they are obsessed with attacking lawabiding Americans' Second Amendment liberties," the top Republican on the committee, Rep. Jim Jordan of Ohio, said.

Jordan, along with other GOP members on the committee, argued that a ban on assault weapons would not lead to fewer mass shootings and that the previous 10year assault ban did not decrease

Research from a group of injury epidemiologists and trauma surgeons has shown that "between 2004 and 2017 - the last year of our analysis — the average number

Border dispute amendment introduced

Republican Rep. Chip Roy of Texas introduced an amendment to the ban that would exempt those who live within 10 miles of international borders, to protect themselves because the Southern border is "wide open and dangerous.'

Reps. Matt Gaetz, a Florida Republican, and Andy Biggs, an Arizona Republican, argued that the increase of migrants at the border posed a threat to Americans.

The comments from Biggs about the border caused a member of the audience, gun safety advocate and Marjory Stoneman Douglas school shooting survivor David Hogg, to interrupt the hearing. He yelled at Biggs that guns used in mass shootings in Parkland, Buffalo and El Paso, Texas, did not come from Mexico and that shooters were "inspired by racist, anti-Black, anti-immigrant manifestos" that the GOP is using as talking points.

Capitol Hill security escorted Hogg out of the hearing room.

Rep. Veronica Escobar, a Texas Democrat, said the language that Gaetz and Biggs were using to describe immigrants was similar to the beliefs that drove a white supremacist to murder 23 Latinos in her district in El Paso on Aug. 3, 2019. The racist manifesto from the gunman railed against a "Hispanic invasion."

"He confessed that he did that in order to slaughter Mexicans and

immigrants, and he used the same Archive. hateful language of the former president, and the same hateful language that my colleagues delight GOP amendments in using," Escobar said.

Escobar also said she "knew that it would only be a matter of time before our Republican colleagues pivoted to the border their mingling of xenophobia with guns was unfortunately only too predictable."

Escobar pointed out that she is the only member of the committee who actually lives on the border and raises her children there.

"This amendment and the language that they use is an invitation to violence," she said.

Republicans did not respond to her statements that their rhetoric could incite violence against immigrant communities.

The Department Homeland Security in issued a warning that "some domestic violent extremists have expressed grievances related to their perception that the U.S. government is unwilling or unable to secure the U.S.-Mexico border and have called for violence to stem the flow of undocumented migrants to the United States.'

Democrats spent most of the hearing arguing that a ban on assault weapons could have prevented mass shootings in Las Vegas in 2017, where 60 people were gunned down at a concert and another 413 shot; the Pittsburgh synagogue shooting in 2018, where 11 worshipers were murdered in an antisemitic attack; and the Aurora, Colorado, movie theater shooting that left 10 dead and another 70 injured; among others.

"For God's sake, parents in Uvalde had to identify their children by DNA sample because bullets ripped their children apart," Cicilline said.

So far this year, there have been 356 mass shootings in the U.S., according to the Gun Violence

Republicans submitted 11 amendments to the bill, but none

The amendments Republicans introduced touched on GOP talking points, such as an amendment from Roy to prohibit people living in cities that have decreased police budgets from owning assault rifles.

Another amendment, from Rep. Mike Johnson, a Louisiana Republican, would employees of pregnancy crisis centers from the ban. The pregnancy crisis centers are not certified health clinics and are aimed at dissuading pregnant patients from seeking abortions.

Repeal of Liability Shield

The committee was scheduled to mark up another gun-related bill, one that would allow civil lawsuits against gun makers, distributors, sellers, or trade associations in state or federal court, but ran out of time. The markup for that bill is not yet scheduled.

That bill, H.R. 2814, the Protection of Lawful Commerce in Arms Act, provides immunity in state and federal courts from civil liability for licensed manufacturers, distributors, and dealers of firearms, trade associations from

negligence and product liability

House Democrats also held a Wednesday hearing with several CEOs of gun manufacturers looking at their role in gun violence.

The chair of the U.S. House Committee on Oversight and Reform Carolyn B. Maloney of New York asked for appearances by Marty Daniel of Daniel Defense, LLC in Georgia, Mark P. Smith of Smith & Wesson Brands, Inc. in Massachusetts, and Christopher Killoy of Sturm, Ruger & Company, Inc. in Connecticut.

Things you didn't know about Downey: Vultee

■ Jerry Vultee reignited the aerospace industry in Downey, even if he didn't see the fruits of his labor.

DOWNEY – This story originally appeared in the Downey Eagle on Sept. 30, 1994.

There were smiles and handshakes and memories to share as the former employees of Vultee Aviation held a reunion and luncheon at the Los Amigos Country Club on Saturday, Sept.

Jerry Vultee (as anyone at Saturday's gathering would be glad to tell you) was the man with intense black eyes and a love of airplanes who bought the old Downey airstrip and production plant founded by E.M. Smith of EMSCO in 1936 and established Vultee Aircraft Corporation.

Vultee was not to enjoy his new production facilities for long, for he died with his wife, Sylvia, in an air crash in 1938. But Vultee lived on after him. He had brought together an engineering team of geniuses. The aircraft production plant where Rockwell stands

today became a key to American production of warplanes in World War II, and the home of the "Rosie the Riveter," women who joined the war effort by working on the production lines to build fighting machines for their men who were

The Vultee plant had designed the V-1A airliner in 1933, which set a number of point-to-point speed and distance records, and became the standard plane used by American Airlines in the 1930s.

The Vultee plant assembles more than 11,000 military planes during World War II, the most famous of which was the BT-13, a low-winged trainer that was politely called the Valiant but which was also familiarly known as the "Vultee Vibrator" by its harsher

During World War II, Vultee merged with Consolidated to become Consolidated Vultee, later known as Convair.

Some fine fighting machines rolled off Convair's production lines in Downey.

Following World War II, Consolidated Vultee pioneered American research in missiles, using the German V-2 as a model. It built a short-range navy missile called the Lark and in 1946 was awarded a \$1.2 million contract to study the possibility of a long range missile weapon. The project was identified as MX-774.

The company was concentrating on weight reduction (the V-2 was far too heavy) when the contract was pulled by the government in July 1946 as an economy measure. Consolidated Vultee pulled all operations back to its San Diego facilities. But the Vultee missile research was the foundation of the mighty Atlas missile that followed in the 1950's.

The plant was occupied in 1947 by North American Aviation (later to become Rockwell).

Joe McNamara

The following story appeared in the Southeast News's centennial edition dated Oct. 5-13, 1973.

The man who 25 years ago surveyed and recommended that his company take over the Air Force-owned industrial plant in Downey now heads that facility which for the past decade has designed and built all of this country's manned spacecraft.

He is Joseph P. McNamara, president of Rockwell International Corporation's Space Division.

A Downey resident and member of the board of directors of the Downey Chamber of Commerce, McNamara has prime responsibility for directing Rockwell's space systems programs which include design, development, and testing of the National Aeronautics and Space Administration's Space Shuttle Orbiter program.

In addition, McNamara's Space Division is a principal industrial contractor for NASA's Skylab program and the Apollo-Soyuz Test Project (ASTP). McNamara was named president of the Space Division in August 1970. During his 30-year career with Rockwell, he has had top executive assignments in all of the corporation's major space, missile and rocket propulsion activities.

Prior to being named president, McNamara served three years as executive vice president of the Space Division which built the command and service modules and the second stage of the Saturn V launch vehicle for NASA's Apollo lunar landing program.

From 1960 until 1967, McNamara directed production of America's largest liquid hydrogenfueled rocket engine at the company's Rocketdyne Division. These J-2 engines are used in both the second and third stages of the

McNamara, as vice president and general manager of Rocketdyne's Liquid Rocket Division, also directed production of the huge one and one-half million pounds of thrust F-1 engine used to power the Saturn V first stage booster.

In April 1973, NASA awarded McNamara the Distinguished Public Service Medal, the highest honor accorded to a nongovernmental employee for his direction in development and

testing of the Saturn V's F-1 and J-2 rocket engines.

As general manager, McNamara activated and headed the company's Neosho, Missouri plant from 1956 to 1960 where engines for the Thor, Atlas and Jupiter missiles were in production. The H-1 engines for Saturn 1B were also built at Neosho. Prior to that he organized and directed plant engineering activities of the company's Downey plant which was then known as Missiles and Control Operations.

He received his Bachelor of Science degree in (mining) engineering from UC Berkeley in

Prior to joining the company in 1943, McNamara was employed by the Empire Star Mines and Standard Oil Company of California as a petroleum engineer in California oil fields.

McNamara is a second generation native Californian born March 19, 1911 in Bakersfield. His father, Dr. Thaddeus M. McNamara, was born in Visalia,

McNamara is a registered mechanical engineer in California, is a member of Delta Kappa Epsilon and has frequently served on specialized industrial committees of the California Manufacturers Association and the Los Angeles Chamber of Commerce. He received the outstanding Citizens Award from the community of Neosho, Missouri, for his contributions to that area.

McNamara and his wife, Elizabeth Hillman McNamara, reside in Downey.

Supervisors set ballot measure allowing sheriff removal

■ Voters will decide in November if an elected sheriff can be removed by the Board of Supervisors.

Supervisors voted Tuesday to place a measure on the November ballot that would give the board authority to remove a publicly elected sheriff from office for cause.

The board made the move on a 4-1 vote, with Supervisor Kathryn Barger dissenting.

If approved by voters on Nov. 8, the measure would give the board the power to remove a sheriff "for cause" on a four-fifths vote of the five- member panel.

"Cause" is defined as "a violation of any law related to the

performance of their duties as statement or document; or beyond Villanueva. LOS ANGELES – As expected, obstruction of any investigation the Los Angeles County Board of into the conduct of the sheriff by the Inspector General, Sheriff Civilian Oversight Commission, or any government agency with jurisdiction to conduct such an investigation."

Although board members supporting the measure denied it was political in nature, the move is a clear response to repeated clashes with current Sheriff Alex Villanueva. Villanueva has accused board members of defunding his agency at the expense of public safety, and he has also rebuffed subpoenas to appear before the county's Civilian Oversight Commission.

Board Chair Holly Mitchell and sheriff; flagrant or repeated neglect Supervisor Hilda Solis introduced of duties; a misappropriation of the motion calling for the ballot public funds or property; willful measure. Mitchell said during a board's vote, saying, "Giving the falsification of a relevant official July 12 meeting that the issue goes

> "The issue of sheriff accountability before us is both urgent and systemic, having impacted past generations of Angelenos, but also with important consequences for the future," Mitchell said. "Unfortunately, the county has had long and troubling history with sheriff oversight and transparency.'

The motion by Mitchell and Solis referred to previous sheriffs Lee Baca, who was sentenced to federal prison on corruption charges, and Peter Pitchess, who "resisted any involvement in the first internal investigation of deputy gangs from outside the department."

Barger, the board's lone opponent of the measure, issued a statement Tuesday following the Board of Supervisors authority to remove an elected sheriff unequivocally takes away power from the public

"It's a move that has the potential to disenfranchise voters, she said. "It also overlooks the fact that a recall process already exists to remove elected officials who fail to perform their duties.'

Villanueva has blasted the proposal as unconstitutional. He sent a letter to the board last month saying the measure "would allow corrupt board members to intimidate sheriffs from carrying out their official duties to investigate crime.'

Monkeypox is about to become the next public health failure

When about 100 cases of monkeypox had been confirmed or suspected in Europe in May, it was clear the virus was spreading outside the areas where it was previously seen. Some on social media suggested it might already be spreading rapidly in communities in Europe and the United States. These reports should have been a code red for federal infectious disease response.

But it wasn't until late June that the Centers for Disease Control and Prevention expanded testing for monkeypox to large commercial labs like Quest Diagnostics and Labcorp for more capacity and access. The C.D.C. had gone through its standard playbook, ticking through its protracted checklist.

Compared with the agency's botched rollout of a test for the coronavirus, the monkeypox test came at warp speed. But the virus spread even faster. If American leaders wanted to quash the outbreak, the United States should have been testing all people who presented with what was presumed to be atypical cases of diseases like genital herpes and zoster infection; both can cause rashes that sometimes resemble monkeypox. That might have required 15,000 tests a week, by my rough estimate. From mid-May to the end of June, the United States tested only about 2,000 samples.

Our country's response to monkeypox has been plagued by the same shortcomings we had with Covid-19. Now if monkeypox gains a permanent foothold in the United States and becomes an endemic virus that joins our circulating repertoire of pathogens, it will be one of the worst public health failures in modern times not only because of the pain and peril of the disease but also because it was so avoidable. Our lapses extend beyond political decision making to the agencies tasked with protecting us from these threats. We don't have a federal infrastructure capable of dealing with these emergencies.

The failures that got us here fit a now familiar pattern.

Early on, similar to the early days of Covid, testing access for monkeypox was limited, despite ample evidence that monkeypox was spreading in the United States. The Strategic National Stockpile was meant as a hedge against viral contingencies, but when the coronavirus struck, it lacked adequate supplies of testing equipment, ventilators and masks. With monkeypox, the government hadn't stockpiled enough of the only vaccine, Jynneos, that was indicated for prevention of the disease and considered safe for use. The United States had on hand fewer than 2,400 doses in mid-May, mostly as a

hedge against the risk of smallpox, which was the vaccine's other indication.

There are more parallels between our failings to combat Covid and monkeypox. Each time, the reflex has been to blame political leadership for poor planning, lack of urgency and clumsy execution. It's true that both responses have been plagued by an absence of coordination among federal agencies like the Food and Drug Administration, which I led under the first two years of the Trump administration; the C.D.C.; and the components of the Health and Human Services Department that are responsible for different aspects of response. But systemic failings also rest with the bureaucracy charged with countering these threats.

The C.D.C. should lead America's response to viral exigencies. But the agency isn't a crisis organization. It lacks the infrastructure to mobilize a rapid response and is too hidebound and process driven to move quickly. Its cultural instinct is to take a deliberative approach, debating each decision. With Covid, the virus gained ground quickly. With monkeypox, which spreads more slowly, typically through very close contact, the shortcomings of C.D.C.'s cultural approach haven't been as acute yet. But the shortfalls are

Take the scant information available about the domestic outbreak and how it has spread. The C.D.C. has publicly complained that it can't compel sufficient reporting from states and that it lacks insight into the scope and nature of reported monkeypox cases. That's true. But the C.D.C. still possesses information from states that do share case reports, which the agency could have used to provide a better clinical mosaic on how the virus was spreading and presenting to physicians.

It's very hard for the agency to self-organize around a new mission in the setting of a crisis or lead an internal effort to reform longstanding processes. But it has proved equally hard for Congress to take meaningful action to reorganize the agency to make it more robust and quicker to respond. Proper reform would require empowering public health agencies with new tools, funding and authority, but from my conversations with congressional members and their staffs, I believe there's scant appetite for such a move not just on the political right but on the left as well. After Covid, there's a view among some that public health agencies used flawed analysis and miscalculated their advice. Securing a political consensus that the C.D.C. needs to be further empowered to complete its mission — for example, invested with the authority to compel reporting from states — is politically

unobtainable.

That leaves it up to the Biden administration. But its late stab at reform also falls short. It has effectively created an agency out of an office inside the Department of Health and Human Services that is charged with coordinating the federal response to bioterrorism, among other things. The reordering puts the new Administration for Strategic Preparedness and Response on equal footing with the C.D.C. It's a classic Washington response to a problem: create an agency around it. The move will only add to the muddle.

The pandemic mission must remain with the C.D.C., which has the requisite tools and expertise to respond to these crises. I know from my time at the F.D.A. that it's the agencies that have the operational know-how and capabilities. The C.D.C. has the boots on the ground that provide the frontline needs for attacking these kinds of outbreaks, with its sophisticated tools for detection and surveillance. What it lacks is the authority and a national security mind-set.

The Biden administration needs to get the C.D.C. back to its disease control roots, by transferring some of its disease prevention work to other agencies. The F.D.A. can handle smoking cessation, leveraging its regulatory toolbox. The National Institutes of Health can tackle cancer and heart disease. Focus the C.D.C. more on its core mission of outbreak response. And imbue the agency with the national security mind-set that it had at its origins. If the C.D.C.'s mission were more tightly focused on the elements required for handling contagion, Congress might be more willing to invest it with the robust authority to do that targeted mission well. Congress would need to reprogram budget lines to get it done, but someone needs to start that

Time is running out. Diseases like Zika, Covid and monkeypox are a dire warning that dangerous pathogens are on the march. The next one could be worse - a deadly strain of flu or something more sinister like Marburg virus. We've now had ample notice that the nation continues to be unprepared and that our vulnerabilities are enormous.

Brittney Griner's detention should prompt fixes to U.S. drug laws

Russia's detention of WNBA star Brittney Griner over alleged possession of hashish oil has strained U.S. diplomatic ties with Moscow and intensified international condemnation of Russia's authoritarian regime. Griner testified this week that when she was arrested in Moscow on Feb. 17, her rights were not read to her, as is required under Russian law. "I had no intention to break the law," said Griner, who was detained after customs officials reportedly found two cannabis vape cartridges in her baggage.

Whatever the outcome of U.S. efforts to secure Griner's release, it's clear that Griner, who says she was prescribed cannabis oil by a doctor, has not received due process. While rightly condemning Griner's detention, many have cited Russia's "draconian" drug laws and its imprisonment of "more people per capita for drug crimes compared with the rest of Europe." Rep. Colin Allred (D-Tex.), for instance, has said the Russian criminal system "is very different than ours and is very opaque."

But Americans should hardly throw stones. Griner's ordeal gives reason to scrutinize the U.S. legal system's treatment of drug offenses — and the tens of thousands of people languishing in American prisons for such crimes.

Despite \$182 billion in annual taxpayer funding for mass incarceration, the criminal legal system in this country falls far short of our nation's ideals. The U.S. system is plagued by over-prosecution, excessive sentencing, brutal prison conditions, lack of rehabilitation opportunities and limited reentry

Consider recreational marijuana, which has been legalized in 19 states and decriminalized in 18 others. It remains illegal in Allred's Texas as well as under federal law, including in transportation between states. Hashish, the substance at issue in Griner's detention, comes from the cannabis plant, as does marijuana, but is significantly more potent. Hashish-related offenses have often been punished more severely by U.S. courts. And even in states where marijuana has been decriminalized, the changes sometimes do not extend to cannabis concentrates.

Critically, the legalization wave has not benefited people who were convicted under previous laws that criminalized marijuana. Unlike most other countries, including Russia, the United States does not allow changes in laws to benefit people who were previously punished under the old laws. A 2020 ACLU report found that marijuana arrests account for more drug arrests in the United States than any other drug class; in 2018, the last year for which the report analyzed data, law enforcement made nearly 700,000

marijuana arrests, more than for all violent crimes combined as reported by the FBI. According to 2020 data from the Bureau of Justice Statistics, nearly a quarter-million Americans are behind bars for drugs: Some 171,300 people are incarcerated in state prisons for drug-related offenses (14 percent of the total number of state prisoners) and 67,438 in federal prisons (46.7 percent of all those in federal prisons).

Russian prosecutors argue that the 0.702 grams of cannabis reportedly found in the vape cartridges in Griner's baggage constitutes a "significant" amount and have charged her with "large scale transportation of drugs," which can carry a prison sentence of up to 10 years. However outrageous the charges sound — to any reasonable mind, the quantity was quite small, and Griner testified on Wednesday that she needed the oil to help with pain and inflammation of injuries sustained over her career — it's worth noting that U.S. prosecutions can be similarly harsh. The distinction between "using" and "dealing" usually depends on arbitrary weight thresholds that are selectively applied by prosecutors, leading many Americans to receive shockingly long sentences. Some 46,700 people in state incarceration were convicted of possession. But that is only part of the story, as some of the others incarcerated were in possession of drugs but found their charges elevated to "trafficking and dealing" because of the amount of marijuana present.

U.S. incarceration rates for drug offenses have long exceeded those of other Western democracies. In 2000, 70 percent of drug possession and 74 percent of drug-dealing convictions in the United States resulted in

have found U.S. prisons to be overcrowded and understaffed, with the

Many concerned about Griner's ordeal worry about prison conditions in Russia. Here, too, our country has little to gloat about: Numerous reports incarcerated exposed to violence, malnutrition, and other environmental and

While many seize on Griner's incarceration to criticize Russia's harsh drug laws, U.S. practices should not be ignored. Congress and state legislatures could take a major step forward by making drug legalization laws retroactive, such that they would allow for the early release of the tens of thousands of Americans who remain locked up for behavior that most states and most Americans - no longer consider to be criminal.

President Biden and all 50 state governors should also take immediate action on the countless clemency petitions awaiting review from people who deserve to be free as much as Griner does. Given her history of social activism and support for criminal legal reform, surely Griner herself would agree.



"If we go forward now, hopefully it passes because construction costs are only going to go exponentially higher the longer we move this out," said Morris. "What we could

"What we do know is that we have an incredibly supportive community," said Garcia. "Our community outreach efforts have yielded results, but what we need is a strong bond campaign, really making sure to get the messaging out as they did in 2014, and then let the voters decide at that time."

"What I do know is that we have pervasive needs within the district. We've done a lot of work within the last 20 years or so, but even in 2014 we identified \$450 million worth of work at that \$250 million, so there was no way we were going to cover all of our needs, and our schools continue to age. So, we feel we have a strong case for the community to consider this, and we're hopeful that they would be supportive."

The Board has until Aug. 12 to make their final decision. It is anticipated that they will vote on how to proceed at their next regularly scheduled meeting on Aug. 9.
