Residents urged to limit outdoor watering

■ Crews will begin making repairs to a 36-mile pipeline starting Monday; outdoor watering will be restricted for 15 days.

DOWNEY – More than four million residents in Los Angeles County were urged Tuesday to suspend outdoor watering for 15 days next month while the Metropolitan Water District repairs a leak in a water delivery pipeline.

The repairs will take place from Sept. 6-20, and will impact the cities of Beverly Hills, Burbank, Glendale, Long Beach, Pasadena, San Fernando and Torrance.

Residents in the Central Basin Municipal Water District, which includes Downey, along with the Foothill Municipal Water District, Three Valleys Municipal Water District and West Basin Municipal Water District will also be impacted.

Officials discovered a leak in the 36-mile Upper Feeder pipeline, which delivers water from the Colorado River to Southern California, earlier this year. The pipeline was running at a reduced capacity after a temporary repair while officials designed a more permanent solution.

"The temporary fix we have in place has allowed us to operate the pipeline at a reduced capacity over the summer, but it is not intended to last long-term," MWD General Manager Adel Hagekhalil said at a news conference at Burbank Water to take a hiatus, only just starting and Power's Ron E. Davis Eco back up around a year ago.

"We cannot delay this repair family have set their sights even any further -- doing so risks a failure and the potential for an unplanned, emergency situation."

Residents and businesses throughout the county were called on to temporarily suspend all outdoor watering, including drip irrigation and hand- watering. The MWD recommends trees and gardens be pre-watered before the shutdown and maintained using water collected from the sink and shower. Additional water-saving tips in preparation for and during the shutdown are available at mwdh2o.com/shutdown.

"During this shutdown, we'll be tapping into a very limited supply of water to deliver to these communities," MWD board Chairwoman Gloria Gray said. "So we must eliminate all outdoor water use and do everything else we can to conserve for 15 days. We want to thank residents and businesses in advance for their support and recognizing the water-supply challenges our region faces."

Officials provided tips to residents prior to the shutdown, including delaying new plantings until after Sept. 20, avoiding fertilizing lawns and plants and turning the sprinkler timer off on the evening of Sept. 5.

"This shutdown has been months in the making," MWD System Operations Manager Brent Yamasaki said. "Imagine you've got a bridge with a pipeline on it, it's 1,000 feet and it crosses a river. You don't want to do this in the wintertime when it's raining. We want to do this now ... rest assured we are going to be working 24-7 to get this work done."

Historical Society hopes youth can continue its work

■ Younger people are getting involved with the Downey Historical Society, offering hope for its future.

DOWNEY – As they continue to try and preserve the past, the Downey Historical Society may have found its leaders of the future.

The Historical Society has recently seen a modest influx of youngsters, beginning with 18-yearold Andrea Barajas.

Barajas's introduction to the Historical society came during unfortunately dissolved because the summer of her junior year at Warren High School, when she found herself needing information on Rancho Los Amigos for a documentary she was working on as part of an internship.

"I came down to the historical society, and [Historical Society President] Bob [Thompson] loaned me a book," said Barajas. "I used some of those images in the documentary. I told Bob, "I will give you the documentary, I'll give you a copy so you can have it for records."

"After that, he was really impressed with that so he invited me to come on down more frequently to the Historical Society."

Barajas would bring along Jesus Reyes, 19, who also had an appreciation for history. Zoelli

Ortiz, also 19, would join not long

Being the new generation of Downey Historians "can be a bit overwhelming" says Barajas.

"Just thinking about it all, like, wow, they (members of the historical society) know so much information, and just trying to save everything," said Barajas. "Even just trying to recruit people, you know? We've been coming up with different tactics - community service hours for high schools, programs for middle schoolers and stuff - so, I think it's great that we're actually able to still conserve it and work on that because I know a lot of historical societies have they don't have any members anymore."

Reyes added that there is an individual sense of responsibility to preserve Downey's history once it's been discovered. He feels that while Downey has always appreciated and celebrated its past, it hasn't done the best job in protecting it.

"To see external entities sort of erasing that in some sort of way, it kind of brings you more in; trying to find more history about the city, more ways you can try to preserve it to teach other people about that same history," said Reyes.

"Honestly, there have been a couple places where they've been irresponsible with preserving history, like Los Amigos that's been

Downey falls to Schurr, 3-0, in non-league match

■ Downey, now competing in the Gateway League, hopes to build on early success.

DOWNEY – After getting a quick jump in the preseason with some early success, the Downey girls volleyball team, which started off with a 5-2 start, fell to visiting Schurr in straight sets, 25-23, 25-21, 25-15 Tuesday afternoon (August 30).

The Vikings rebounded the next day with a 3-0 win over host Pacifica in non-league action to improve to 6-3 overall.

Results of the Thursday (Sept. 1) match at La Serna were not available at press time.

Before their first home crowd of the season, the Vikings (5-3) hung tough with Schurr (9-1) in the first two sets, but lost by 10 points in the

Downey lost to Schurr last year in the second round of the CIF-SS D5

"We played (Schurr) a lot in the summer and they're a solid team," Downey first-year coach Shawn Patchell said. "Good setter, good position player. We're close. We just got to make sure the confidence stays

The Vikings, who just came off a loss to CIF-DI, Laguna Beach, Saturday (August 27) are building off of last years' success, as they a perfect 10-0 record. Overall, the Vikings finished at 25-7 in longtime

previously coached for many years at Laguna Beach.

Downey will go down as the last SGV Champs, as a formation of a new conference begins this year.

Downey won a tourney with three wins to start the season.

The experienced Schurr team might have had a slight advantage over Downey, but the Vikings gave them a run for their money in two of the three sets.

The first set saw the Vikings get in a quick, 6-2 hole, and trailed by as much as seven points, 14-7, before they mounted a comeback.

Sophomore outside hitter Yaretzi Silva, who had a match-high 17 kills, started the comeback with a big kill to trail, 14-8, followed by a service ace from senior setter Aryanna Martinez (30 A), a kill by senior opposite Janay Robertson and a ball hit long by Schurr. That made the score, Schurr 15, Downey 10.

The Vikings came all the way back and two consecutive kills by Robertson brought them within a point, 24-23.

On an attempted kill by Downey into the net, that ended the comeback and the Spartans took the first set,

Schurr had a balanced attack from three players, all with double digit kills - Karina Talavera (13K), Jasmine Soto (12K) and Victoria Murillo (10K). Leading the way with assists was Leeya Rubio with 24 and

Soto added 11.

"It (comeback) did a lot for us, because it gave us at least some energy, because going into this we were really nervous," Robertson said. "Towards the end, we could see, 'oh ya, we can actually get points on them. It's not impossible.'

"You want to close it out and it's also important in the beginning," Robertson added.

Patchell was proud of his team for playing close.

"We played with a lot of heart," he said. "These girls, I think they just get a little nervous. It's our first home match and I wanted to play a home match in August and we got it out of the way and I think we didn't win any mini games to five (points). Once we start winning the mini game to five, we'll be rolling.

"We passed a lot better to finish, which was good, but we want to start a little better.'

Patchell had high praise for his sophomore, (Silva).

"Ya, she's learning the game and she's going to be very, very good," he said. "We need her to do a lot of stuff. Most sophomores only have to do one or two skills, but we're asking her to be a very skilled player right now. She's coming along nicely.'

Junior outside hitter Rebeca

Marquez, who is a captain along with senior libero Bailey Aguilar, had 10 kills in the game for the Vikings.

"(Marquez) was a libero last year," Patchell said. "Now, playing the front row is a big responsibility for her, she gets it done and she's going to be a very player for us. She's a very good defensive player and she passes very well. It's fun to have her.'

In the second set, the Vikings got into another quick, 6-0, hole but came all the way back again and tied the set, 15-15, on an ace by Aguilar.

The late-set comeback continued with only a two-point deficit, 23-21, after a big kill by Silva. But, the Spartans won the next two points to put Downey into a 2-0 hole in the

For the third straight set, the Vikings found themselves in that same early-set hole, trailing by as much as 13-3.

However, here they came again with another mini comeback highlighted by three consecutive kills from Silva (2K) and Robertson (K) brought them within three points, 13-10.

Multiple errors in the late stages of the set put the Vikings 10 points down, 23-13, and they defending Almont League Champions came away with the match before a nearly packed gym at Downey.

What they said:

Bailey Aguilar, libero: "I consider Schurr a rival. Their coach (Jorge Ortiz) is my uncle.

"When we started our camps in the summer it was completely different with coach Patchell. His past teams were way better than us and for him to come here and give us as much work as his other teams. He pushes us way more harder than in past years.

Rebeca Marquez, junior OH: "It came with a lot more adjustments and we had to adjust to more higher standards. (Patchell) comes from a high level of coaching.

"Playing the higher-level teams was a good experience. It was a good way to see our strengths and weaknesses. It was a learning experience. (Tournament champions) it felt good and having this new team and the chemistry throughout is complete.

Yaretzi Silva, sophomore OH: "It's very exciting and a new experience and his coaching method is a little different. I like the opportunity that we're getting to play with a coach of his credentials. I feel like he's taught me so many more things and correcting things that I didn't even think to correct.'

"I know for me, I didn't really learn anything about Downey history until maybe junior year...and that was just an offhand note," said Barajas. "I think that if we can try to get some more partnership with some of the elementary schools, starting them off young, having them come in here, seeing the Dismukes House...having them be excited about their city's history," said Barajas. "Ultimately, we do live here, so I think it's really important to try to learn a little more about their schools, or the streets they go on."

The arrival of Barajas, Reyes, and Ortiz comes as a welcome addition to more seasoned members of the Historical Society.

Roger Miller, who at the age of 68 used to be considered "the young member" of the organization, says it's "quite a relief."

"I heard that South Gate and Arcadia both folded their historical societies due to folks aging out and nobody walking in behind them to pick up the mantle and do something," said Miller.

Thompson expressed excitement for the new batch of historians, saying that he thought the history center "would be in good hands."

"I don't want to sound corny, but I always try to tell young folks who come in here, 'This is your city, please take care of it, love it, respect it, don't let it get destroyed;' Kind of like preaching to them a bit, but that's how I feel," said Thompson. "These folks seem like they fit that bill. They're excellent."

Oregon community rallies after Downey family struck by tragedy

Ryan Hodak died Aug. 18, only two weeks after he was diagnosed with leukemia.

DOWNEY – An Oregon family with Downey ties was on the receiving end of a generous outpouring of support, after the sudden loss of their patriarch sent them reeling.

Ryan and Laura Hodak met as students at Warren High School, during Ryan's senior year. They were high school sweethearts.

When Laura graduated in 2002 and went to college out of state, Ryan followed.

After a series of "off and on times," the couple reconnected and started their lives together.

Their first child, Derick, was born in 2007. The couple married in 2008. Daughter Kailynn followed in 2011.

The family had recently settled in Oregon, with aspirations of establishing their own family roots and future.

However, things unraveled quickly when a simple tickle in the back of Ryan's throat progressed to swelling and pain, prompting further investigation.



On Aug. 6, he was diagnosed with AML Leukemia. Two weeks later, on Aug. 18, Ryan died due to complications stemming from a bacterial infection and an immune system wiped out from chemotherapy.

Hodak says that her husband was "the center of their family," and that his passing "leaves a void"

"We worked so hard; we don't live by family. It was just me and him creating this new branch of our family...this beautiful life for us, and our children, and our grandchildren, and hopefully great grandchildren," said Hodak. "We worked every day for that."


Though they are still relatively new to their new community in Oregon, it hasn't stopped those around them from doing what they can to help.

At the time of Ryan's death, Kailynn was due to sell a lamb at the Clackamas County Junior Auction, which she had raised during her first year of involvement with 4-H.

Understandably still processing their recent loss and not feeling up to attending themselves, the family decided to send the lamb off to the auction with a family friend, who subsequently spread word of the family's circumstance.

Hodak and her daughter were hoping to "break even" at \$2000. The lamb instead drew much, much more.

"What ended up happening from my understanding is people started bidding, which because of the devastation of losing her father, it drove up the price in

a way to support because the money does go back to the child who's done the work," said Hodak.

Ordinarily, a lamb like Kailynn's would have fetched \$10-\$12 a pound. After initial bid and add-ons, it went for just under \$14,000, or around \$100 a pound.

"We were very humbled by that, a little not sure how to take that gratitude," said Hodak. "We live in a really small town... I think the story is that in rough times, small communities, or communities in general can come together and really make a difference in a child's life and a family's life when they're at their weakest."

Hodak intends to put the money towards a college fund for her daughter.

She says to "take every day

Why Trump will soon be indicted

It gives me no joy to write this piece.

Even a cursory review of the redacted version of the affidavit submitted in support of the government's application for a search warrant at the home of former President Donald Trump reveals that he will soon be indicted by a federal grand jury for three crimes: Removing and concealing national defense information (NDI), giving NDI to those not legally entitled to possess it, and obstruction of justice by failing to return NDI to those who are legally entitled to retrieve it.

When he learned from a phone call that 30 FBI agents were at the front door of his Florida residence with a search warrant and he decided to reveal this publicly, Trump assumed that the agents were looking for classified topsecret materials that they'd allege he criminally possessed. His assumptions were apparently based on his gut instinct and not on a sophisticated analysis of the law. Hence, his public boast that he declassified all the formerly classified documents he took with him.

Unbeknownst to him, the feds had anticipated such a defense and are not preparing to indict him for possessing classified materials, even though he did possess hundreds of voluntarily surrendered materials marked "top secret." It is irrelevant if the documents were declassified, as the feds will charge crimes that do not require proof of classification. They told the federal judge who signed the search warrant that Trump still had NDI in his home. It appears they were correct.

Under the law, it doesn't matter if the documents on which NDI is contained are classified or not, as it is simply and always criminal to have NDI in a non-federal facility, to have those without security clearances move it from one place to another, and to keep it from the feds when they are seeking it. Stated differently, the absence of classification — for whatever reason — is not a defense to the charges that are likely to be filed against

Yet, misreading and underestimating the feds, Trump actually did them a favor. One of the elements that they must prove for any of the three crimes is that Trump knew that he had the documents. The favor he did was admitting to that when he boasted that they were no longer classified. He committed a mortal sin in the criminal defense world by denying something for which he

had not been accused.

The second element that the feds must prove is that the documents actually do contain national defense information. And the third element they must prove is that Trump put these documents into the hands of those not authorized to hold them and stored them in a non-federally secured place. Intelligence community experts have already examined the documents taken from Trump's home and are prepared to tell a jury that they contain the names of foreign agents secretly working for the U.S. This is the crown jewel of government secrets. Moreover, Trump's Florida home is not a secure federal facility designated for the deposit of NDI.

The newest aspect of the case against Trump that we learned from the redacted affidavit is the obstruction allegation. This is not the obstruction that Robert Mueller claimed he found Trump committed during the Russia investigation. This is a newer obstruction statute, signed by President George W. Bush in 2002, that places far fewer burdens on the feds to prove. The older statute is the one Mueller alleged. It characterizes any material interference with a judicial function as criminal. Thus, one who lies to a grand jury or prevents a witness from testifying commits this variant of

But the Bush-era statute, the one the feds contemplate charging Trump with having violated, makes it a crime of obstruction by failing to return government property or by sending the FBI on a wild goose chase looking for something that belongs to the government and that you know that you have. This statute does not require the preexistence of a judicial proceeding. It only requires that the defendant has the government's property, knows that he has it and baselessly resists efforts by the government to get it back.

Where does all this leave Trump? The short answer is: in hot water. The longer answer is: He is confronting yet again the federal law enforcement and intelligence communities for which he has rightly expressed such public disdain. He had valid points of expression during the Russia investigation. He has little ground upon which to stand today.

I have often argued that many of these statutes that the feds have enacted to protect themselves are morally unjust and not grounded in the Constitution. One of my intellectual heroes, the great Murray Rothbard, taught that the government protects itself far more aggressively than it protects our natural rights.

In a monumental irony, both Julian Assange, the WikiLeaks journalist who exposed American war crimes during the Afghanistan and Iraq wars, and Edward Snowden, the former National Security Agency employee who exposed criminal mass government surveillance upon the American public, stand charged with the very same crimes that are likely to be brought against Trump. On both Assange and Snowden, Trump argued that they should be executed. Fortunately for all three, these statutes do not provide for capital

Rothbard warned that the feds aggressively protect themselves. Yet, both Assange and Snowden are heroic defenders of liberty with valid moral and legal defenses. Assange is protected by the Pentagon Papers case, which insulates the media from criminal or civil liability for revealing stolen matters of interest to the public, so long as the revealer is not the thief. Snowden is protected by the Constitution, which expressly prohibits the warrantless surveillance he revealed, which was the most massive peacetime abuse of

What will Trump say is his defense to taking national defense information? I cannot think of a legally viable one.


Desperate Biden stoops to buying votes

For that matter, competence is not one of the administration's strong suits either. For months, its members have told us not to worry about the prospect of inflation. Inflation is not going to be a problem. The administration came up with a magic word to accompany inflation. The word was "transitory." They told us inflation was a transitory thing. For months, they spent madly. It was trillions of dollars that we did not have. They spent on COVID relief, on contrivances of the welfare state and on other matters. One did not have to immerse oneself in the mysteries of higher economics to know that inflation is what one gets when too much money is chasing too few goods in an economy. The consequence is a higher inflation rate eating into the family budgets. Right now, the family budget is being consumed at a rate of roughly 8.2% a month. It is no surprise that this rate of inflation is intolerable.

Now the Biden government is going to wipe out millions of dollars in student loans, and things will pretty much continue as they have for years, ever since the days of the Great Society when the spending took off. What began as a loan program for students borrowing up to \$7,500 will continue to climb. And the universities of the country will continue to do what has been working for them for years: raise tuitions, raise fees, pass the expenses on to the students and their parents. The cost of a college education has risen exponentially with no test for the effectiveness of the education that the students are allegedly getting. One of the great jokes of this student loan controversy is that there is no recognized test offered after four years of college (or how many it might take) for discerning what a student has

In all this controversy about student loans, rarely have I heard of any university official complaining about the costs that the universities pass on to students. The cost of counseling, the cost of the phony programs such as anger management, the cost of how to write up a proper contract before a couple can properly engage in sexual commerce and, of course, the vexed question of race relations, to say nothing of the looming question over every college campus today of transgender intercourse. Then there is the cost of deans for special studies, of deans for this enthusiasm or that enthusiasm. And the ever-present question of the costs that the university must pass on? The cost of salaries. The cost of nervous breakdown analyses among the profs, the costs of maintaining the classroom between demonstrations

Let us face the facts. The universities of this country are some of the most poorly run institutions in the land. Most universities are organized scams. They lost the ability to educate years ago. Now they simply immerse students in ideological nonsense that has nothing to do with education. Look at a picture of students dressed for class. The students are dressed like 10-year-olds, and the profs are dressed like babysitters. I have no idea how administrators dress, though they might dress like con artists. It would be fitting.

Downey lags in environmental sustainability

Dear Editor:

So far California's new 2022 Senate Bill (SB 1383) requiring organic waste recycling has been more suggestion than edict. Many cities have been unable to follow through on this mandate due to lacking infrastructure, funds or, at worst, interest. Downey

As a long-time Downey resident, I'm proud to live in a city with a bustling economy and strong civic spirit; however, seeing Downey lag in the critical area of environmental sustainability is disappointing.

To the city of Downey's defense, the problem encompasses a broader scope than our own city. Los Angeles has only begun in 2019 a pilot program offering organic recycling set to expand to 750,000 households by January 2023. With a total population of about 4 million, this means that only about 20% will have access to this service by start of next year—far behind CA's mandated

Other cities like Santa Monica and El Segundo have been able to implement their respective organic recycling programs more quickly. El Segundo residents, for instance, have received green bins to recycle food waste. Compositing at home is also an option with materials provided by the city. Granted Downey houses more residents than both aforementioned cities, but given its strong entrepreneurial spirit and civic character, a swift implementation of such California laws should also be within reach.

A California website that directs residents to their respective trash disposal options shows that CalMet Services provides trash disposal services to Downey residents. A company based in Paramount, it describes itself as a "family-owned company" whose mission involves "environmentally responsible rubbish collection." Currently, it only offers 3 options for waste disposal designated by the traditional green (green-waste barrel), black (trash barrel) or blue (recycle barrel) bins. Reading these guidelines with no indication of future changes aligning with the new California bill naturally led to some compelling questions. How is this company helping residents align to the new state mandate? What are the reasons for any kind of delays? When can we expect to be able to follow through on these changes?

Upon contact and further inquiry, two possible solutions are offered by CalMet Services and the Downey Public Works Department. First of all, CalMet Services provided an email update to their waste disposal guidelines stating that organic waste, except meat and dairy, could be placed in the green bin. "Anything that grows, goes," they stated as a general rule for dumping in the green bin. Moreover, contacting the Downey Public Works Department, one representative responded that a new organic recycling bin should be available in November. Both offer distinct, yet not mutually exclusive explanations of how this issue is being addressed. However, both fall short in that the former does not account for all of organic waste recycling and the latter in that the changes mean a delay of another few months.

California, unfortunately, does not seem to be offering subsidies to companies to make the transition, which could pose a challenge for small family-owned companies like CalMet. Nonetheless, with enough financial incentive in terms of increased revenue on new bins and increased public pressure, the change should be feasible and desirable.

Food waste has a significant greenhouse footprint. As it goes to the landfill and rots, it produces methane—a greenhouse gas even more potent that carbon dioxide. Food waste thus accounts for 6-8% of human-caused greenhouse gases. Given the increasing adverse impacts of climate change felt worldwide from rising temperatures to melting glaciers, immediate changes, like proper food recycling, are a moral and natural prerogative for a sustainable, bright future that require holding ourselves and our local institutions accountable.



I can wholeheartedly say that it was such an amazing


time for me as a parent, so if I could share any advice as we head into this new school year, get involved and join your school's PTA.




