QUARTERBACK CLASH

DOWNEY - For the 65th consecutive year, one of the oldest and best rivalries - Downey-Warren - in Southern California, and maybe in the whole state, will fill the stadium at Warren High School tonight (Friday October 14).

It's finally here - the Bears versus the Vikings. Friday night lights. The Gateway League title is on the line. Two big time senior quarterbacks – Nico Lamaleava - Warren - (Committed to the University of Tennessee) and Aidan Chiles – Downey - (Committed to Oregon State University). All the pageantry, with an overflow crowd of over 9,000 fans expected. In addition, a Southern California television audience will be watching.

In one of the biggest crosstown games in California, it has it all. And it all began in 1958.

And it's all separated by just over a mile between the two schools.

Last year there was more than 8,500 fans at Downey, as Warren won 26-16.

One of the biggest games this season, St. John Bosco versus Mater Dei, was at the Santa Ana Bowl last week and over 9,000 fans were in attendance.

Downey and Warren have been nearly even over the years, with Warren having a slight edge at 35 wins to Downey's 29

Downey's biggest win was a 60-0 shutout in 2013, while Warren had won 47-0 in 1968. Warren has a slight edge in shutouts with six, while the Vikings have five.

Warren has won the last four in a row going back to 2018.

Before that, Downey had won seven of eight dating back to 2010.

The two longest winning streaks were by Warren, with two runs of eight in a row ('63-'70 and '72-'79), broken up by a Downey win ('71) in the middle.


The Vikings longest streak was five in a row from 2010-2014, including nine of 11 from '2004 to


Downey coaches - 12 coaches since 1958, with coach Grant Warhurst (14 years) with the longest stint. Jack Williams is second, currently in his 13th year.

"It's more than just a game," Warren Athletic Director Samantha Miyahara said. "Every year is special. It never loses power and it still takes my breath away. It is more than a normal football game.

"It's usually anybody's game, no matter what their records were

In the spring of 2021 (2020 season), only immediate family were in the stands, with Downey hosting that game. Downey was given the home field again in the Fall of 2021, because of that 2021 game with limited fans allowed.

'It's the most underrepresented rivalry in Southern California," Miyahara added. "It makes us an insulated rivalry.

"It is so community-based, with two high schools within a mile of each other. You can rank the rivalries in Southern California and it is not mentioned.

"It's just amazing," Miyahara said. "The spirit and energy is so amazing.

There is a night rally on Wednesday at Warren with the drum line playing and skits throughout the rally. There is also a lunch rally and many other functions throughout the week.

Warren coach, Kevin Pearson,

is in his 27th year as a head coach at three different high schools. Pearson is in his fourth year at Warren. Kevin Pearson's brother, Scott Pearson, is the current head varsity baseball coach.

"You have a proud city in Downey and two high schools that are really good in football and a great district who loves kids. You put all that together and you have this great event.

"Probably a league championship will come out of this game like it did last year," Pearson said. "It's not just bragging rights for some of these kids, there are family implications and CIF implications. It's much bigger than just a rivalry, which makes it even more exciting.'

Mark Rand has been at Downey High practically his whole life, from his freshman year until today. "We're Downey through and through," said Rand, who became a little emotional just thinking about his many years associated with the

Rand played basketball and

volleyball and was a part of the rivalry in those sports.

'This week, obviously the kids need their education, but there's that fun party atmosphere," he added.

"We're both tied for first place in league so far, but it's more the city bragging rights. At the Rotary Club luncheon on Tuesday, the Downey Unified School District Superintendent, John Garcia, was describing to the student athletes saying, 'embrace this because this is an event you will never forget. You'll be telling your grandkids about this one day.'

Garcia graduated from Downey and played in the Downey-Warren game for two years on varsity.

Rand continued, "There are a lot of high school rivalries, but for the scale of what this is, it's unique."

A few athletes from both schools, some of the cheerleaders, along with the head coaches and other dignitaries attended the annual Rotary Club luncheon, which is held at the Rio Hondo Country Club.

"It's a chance, I guess you can say, before the storm, we get together and break bread," Rand

Alvarez recall election set for Jan. 31, 2023

■ Voters will decide then if the Downey councilwoman should remain in office.

DOWNEY -The recall election of Catherine Alvarez will take place on Jan. 31 next year.

The city council scheduled the special election at their meeting Tuesday, following the successful collection and verification of the 3,471 District 3 signatures needed to send the recall to ballot. In total, more than 4,500 signatures were submitted.

January's special election will cost Downey taxpayers \$571,000. Should Alvarez be removed, \$571,000 more in the upcoming fiscal year will also need to be spent on an election to find her replacement

To try to circumvent these costs, there were calls Tuesday both by residents in attendance and for residents of District 3 to make a Councilwoman Claudia Frometa - more informed choice. for Alvarez to resign.

Recallers have said that they have pursued Alvarez's removal due to her failure to disclose her criminal history - which include welfare fraud, lying under oath, and shoplifting from the Michael's Craft store at the Downey Landing - when she ran for her seat in 2020. suggesting that voters should "do their due diligence."

"I think it's important, in light of all the controversy we've seen involving the 3rd District and the recall, that we inform ourselves of who the candidates are and what they stand for. And we should ask them all those questions like, 'Do you have a misdemeanor conviction if that's so important to many of you, even though many of us – or at least I do – believe in redemption," said Trujillo. "But if that's important to you, then ask people but later don't say 'Well, they never disclosed it,' when you never asked."

Though silent on the matter Tuesday, Alvarez has contested that the recall is instead over matters of rent control, of which she has been an outspoken advocate for and unsuccessfully attempted to bring into the city on several occasions. She claims that the recall effort is being led by Downey's landlords, specifically singling out former mayors Mario Guerra and Rick Rodriguez.

DOWNEY – This month marks the 10th anniversary of Stav Gallery, a community art gallery and creative space located in Downtown Downey.

Stay began as a group of local artists and arts advocates who recognized a need for more opportunities to enjoy, share and create art in the City of grassroots pop-up art exhibitions and performances in outdoor settings and in partnership with local businesses and city events including the Downey Theatre, Porto's Bakery, and the Taste of Downey – later formalizing into the 501(c)3 nonprofit Downey Art Vibe (now known as Stay Arts).



Yes on Measure K a much-needed investment in Downey schools

In addition to my duties at the Downey Patriot, I'm also a licensed realtor. And one thing I've learned over the years is that people aspire to move to Downey for two reasons:

- our safe neighborhoods
- our fantastic public school system

Combine safe neighborhoods with excellent schools and you have a desirable place to raise a family. As a result, Downey's property values exceed those of neighboring communities like Norwalk and South Gate. We pay a premium to live in Downey and are glad to do so.

Statistics show that Downey Unified School District is one of the best school districts in all of California. Downey teachers are well-paid and our children receive a quality education in return. Thanks to previous bonds, middle school and high school students are being instructed in modern facilities equipped with 21st century technology.

The same cannot be said for Downey's elementary schools. Nearly all of Downey's schools were built more than 70 years ago and most elementary schools don't meet modern building codes or safety codes. Some contain hazardous materials including asbestos and lead pipes, while others may need to be retrofitted for earthquake safety.

More concerning, Downey elementary schools lack basic security features that have become a necessity in today's world.

- Remove wood and support beams that have extensive termite damage
- Construct modern science labs and career technical facilities so students are prepared for college and in-demand careers in fields like health sciences, engineering, technology and skilled trades

The Cuban missile crisis was 60 years ago, but it's urgently relevant today

Next week marks 60 years since the Cuban missile crisis — the 13-day standoff between the United States and the Soviet Union widely regarded as the closest we ever came to global nuclear war. On this anniversary, as we veer terrifyingly close to the brink of Armageddon once again, we should look to that crisis to guide us in resolving our present one.

Last Friday, President Biden warned that in the Ukraine war, "for the first time since the Cuban missile crisis, we have a direct threat to the use of nuclear weapons." The warning is well founded. Top Kremlin ally Ramzan Kadyrov, head of the Chechen Republic, recently wrote that Russia should

consider "the use of low-yield nuclear weapons." Russian TV and military blogs echo such suggestions. And Russian President Vladimir Putin has stressed that he is willing to use "all means" in the conflict.

It's impossible to know whether Putin is willing to follow through on is threat. Harvard Kennedy School professor Matthew Bunn pegs the chances at about 10 to 20 percent. But we do know how to reduce the risk of catastrophe. The Cuban missile crisis proved that even in the face of potential nuclear devastation, de-escalation is possible and diplomacy can prevail.

Experts and scholars have relitigated the crisis for decades. But in recent years, archives and memoirs have clarified the picture of what happened during those 13 days starting on Oct. 16, 1962. The tale is clearly articulated in "Gambling With Armageddon," a 2020 book by Pulitzer-winning historian Martin J. Sherwin that the New York Times declared "should become the definitive account" of the event. The book offers urgently relevant lessons — both about the circumstances that can bring humanity to the edge of annihilation and how we can step back from that brink.

One chilling reminder of how crises are sometimes averted was first offered by former secretary of state Dean Acheson in 1969. Reviewing "Thirteen Days," Robert F. Kennedy's posthumous memoir, Acheson, who advised President John F. Kennedy during the Cuba crisis, strikingly contended that nuclear war was averted thanks to "plain dumb luck." Sure enough, it has since come to light that a nuclear missile came close to being fired not once but twice — once by the 498th Tactical Missile Group on Okinawa, Japan, and once by a Soviet submarine in Cuban waters. In both instances, the resistance of a single individual derailed a launch.

Of course, the world cannot rely on luck alone to prevent nuclear disaster. In 1962, according to political scientist Graham Allison, Kennedy put the odds of nuclear war "between one in three and even." If Kennedy's assessment was accurate, then after just a few more comparable confrontations, "the likelihood of nuclear war would approach certainty." Humanity cannot afford to spin the cylinder again in this game of Russian roulette; we must unload the gun. Our only path forward is de-escalation.

And de-escalation, as Sherwin makes clear, begins with dialogue. During the Cuban missile crisis, people such as Gen. Curtis LeMay argued that negotiation was tantamount to appeasement. But levelheaded discussion is essential to avoiding certain doom. To sacrifice it in the name of jingoistic posturing is not just absurd; it's potentially apocalyptic. As Soviet leader Nikita Khrushchev recalled, "The biggest tragedy, as [my military advisers] saw it, was not that our country might be devastated and everything lost, but that the Chinese or the Albanians might accuse us of appeasement or weakness. ... What good would it have done me in the last hour of my life to know that though our great nation and the United States were in complete ruins, the national honor of the Soviet Union was intact?'

Today, as the world faces the threat of obliteration once more, figures of all stripes are calling for dialogue to prevent doomsday. A small but growing list of progressive members of Congress (along with several peace advocacy organizations) are increasingly focused on how best to promote de-escalation and dialogue, inspired by a truth that Ukrainian President Volodymyr Zelensky has himself maintained: This war "will only definitively end through diplomacy." Pope Francis issued an unprecedented statement calling for global leaders "to do everything possible to bring an end to the war." Even former secretary of state Henry Kissinger has reiterated the importance of dialogue. As he recently argued, "This has nothing to do with whether one likes Putin or not. ... We are dealing, when nuclear weapons become introduced, with a historic alteration in the world system. And a dialogue between Russia and the West is important."

We cannot waver from the conviction that nuclear weapons must never be used again under any circumstances. We would be wise at this grave moment to recall the lessons of history — encapsulated in Sherwin's work and repeat, loudly and often, the November 1985 declaration of President Ronald Reagan and Russian President Mikhail Gorbachev, restated as recently as January by the leaders of the five nuclear weapons states: "A nuclear war cannot be won and must never be fought."





LOS ANGELES – Theater fans still have this weekend to see the world premiere of "Desert Stories for Lost Girls" now playing at the Los Angeles Theatre Center through Sunday, October 16.

This play by Lily Rushing, about family, identity, and colonialism in the Southwest, is presented through the collaboration of the Latino Theatre Company and Native Voices at the Autry.

The director is Sylvia Cervantes Blush, a Downey resident and frequent participant in the local southeast area arts scene.

Rushing drew on her own family history to tackle an aspect of colonialism and Southwest history that is gaining more exposure - the indentured servitude of indigenous

individuals who subsequently lost all family and tribal connections.

The disparate group of survivors, mostly from tribes of Apache, Comanche, Kiowa, Navajo, Pawnee, and Ute, became known as

"It's an important piece of the story of the American Southwest that needs to be heard," affirms Cervantes Blush. "I think the playwright has done an incredible job of creating a piece about a very haunting past in a beautiful, poetic

The practice of purchasing war captives from local indigenous tribes was exploited by Spanish colonizers who used those captured to work in households, herd livestock, and serve in the frontier Spanish militia. The Spanish, and

within her family when she and her mother began researching census reports. The women were able to trace familial ties back to Rushing's great-great-grandmother who had been enslaved as a young girl and forced to give up a child to adoptive

In Rushing's play, eighteenyear-old Carrie comes up against such family mysteries when she moves in with her grandmother Rosa, who seems to be suffering from dementia.

The family's story unfolds for the audience through dreamlike visitations, Rosa's efforts to explain her memories, and the appearance of Plácida-Carrie's great-great-grandmother, an unsettled spirit who was raped and forced to give up her son. This layered storytelling is well-served by Cervantes Blush's talent for evocative, theatrical staging.

While Rushing's play is rooted in the particular historical events of colonialism, there is a universality to its themes. Women everywhere are uniquely targeted as men wage war and seek to subjugate one another. Children who are abducted and lose their families are left with profound questions

of identity. The trauma of violent events often becomes generational. Given the current charged political climate throughout this country, and the world, these questions are, sadly, deeply relevant today.

Cervantes Blush grew up in nearby Bell Gardens and says she was immediately captivated by the

performance arts after a class in high school. She majored in theater as an undergraduate, attending Cerritos Community College and CalState Long Beach, and earned an MFA from UCLA.

Her myriad directorial credits include two productions at the Oregon Shakespeare Festival in Ashland, and a unique, collaborative production by the South Coast Repertory staged at the Santa Ana Civic Center, The Long Road Today/El Largo Camino de Hoy.

Cervantes Blush's professional work ranges from comedy to tragedy. Of all her projects, she recounts that the most impactful ones for her were two she did with family and friends.

The first was a series of one-act plays written by her husband Bill Blush, Bill's Shorts, and produced with actors in a 99-seat theater format at the local Epic Lounge.

"Bill's Shorts (both Part One and Two) was a lot of work in a short amount of time with people I respect and admire as artists," says Cervantes Blush, "and to do it here locally was great."

Theater During the Pandemic

Her other highlighted project was a virtual theater experience produced with family and friends, including children, during the pandemic: S.H.E.L. Silverstein News, a 30-minute video that can be seen on YouTube.

"It was a project to connect with people," explains Cervantes Blush, "to bring a little joy during the height of the pandemic when everything was so scary. How do we say Hi to our neighbors?"

Cervantes Blush explains that she herself was feeling the depressive effects when everything was almost totally shut down in 2020

"I was reminded about a play I did 10 years ago when I was teaching and I decided to reach out. I ended up collaborating with 27 households that included over 40 individuals, many of them children." Some of the participants had no experience as performers.

The group started in July 2020 with the idea of presenting some of Silverstein's popular poems as humorous news stories with

pseudo news dialogue in between the poems.

Her process involved a month of rehearsing individually with all of the participants online.

"Then I walked them through how to film themselves and they sent me footage and I edited it. We had families videoing each other. It was so much fun to watch the kids grow in that short amount of time."

For various reasons, the editing took almost a year to finalize. "I didn't realize how much footage I had," she recounts, "and I was learning how to edit because I had to make it seem that these people were in the same room." She also found herself devoting more time to other projects as groups developed ways to continue their core work online.

A virtual red carpet, with cast members being interviewed, was held on Zoom before the completed video was aired online.

In January Cervantes Blush will be in Dallas to direct a production of Native Gardens by Karen Zakarías at the Dallas Theatre Center. She is optimistic about the resumption of live theater and reports that some preview performances in Dallas have already been sold out.

She is glad to be participating in live theater once again. "The video project during the pandemic showed me how resilient we can be, and it really affirmed for me how much the arts have saved my life time and time again. And in the end, sharing it with the kids, we made a little tiny movie, and it was joyful, and good."

Cervantes Blush's current play, Desert Stories for Lost Girls, will finish it's three-week run this weekend. Performances are:

Thursday, Oct. 13, Friday, Oct. 14, Saturday, Oct. 15 at 8 pm, and Sunday, Oct. 16 at 4 pm.

Tickets range from \$22-\$48

The state Department of Justice released its annual crime reports in August, showing upticks in violent

crime and property crime rates in 2021 even as the total arrest rate

There were 2,361 homicides in the California last year, surpassing 2020's figure by more than 150 deaths, according to the reports. While the number remains far below the historic high - 4,095 homicides in 1993 — last year was the deadliest year since 2007.

Three-quarters of 2021's homicides involved a firearm, and more than eight in 10 of the victims were male. About 40% were killed by strangers, 40% by friends or acquaintances and the remainder by a relative.

Superintendent talks Career Technical Education, Apple in state of the schools address

■ Downey Unified will begin offering e-Sports to middle school students, Dr. John Garcia announced.

DOWNEY -Downey Unified Superintendent Dr. John Garcia announced expansion of the district's Career Technical Education (CTE) pathways and programs at this year's State of the Schools address.

The eighth annual event used as a way to update leaders, educators, business owners, and Downey residents on DUSD's recent achievements and upcoming goals- returned Friday morning to the Los Angeles County Office of **Education West Conference Center**

Covid-19 pandemic.

Garcia highlighted the growth that the CTE programs have seen since the 2014-15 school year, from 602 students to 2,657.

"One thing. Every kid needs just one thing that gets them to school every day, and it creates the motivation they need to continue to move towards graduation and pick their college and career of their choice," said Garcia. "I'm really excited about these numbers. A few years ago, you see they continue to grow, and as we add more CTE programs, we know they'll continue to grow as well."

Nine subjects are being added to the already 20 CTE options offered.

High-schoolers will soon be able to explore game programming, advanced manufacturing,

after a two-year hiatus due to the welding. Pathways for legal practices, law enforcement, manufacturing and production, and technologies of things are also in

> At the middle school level, drone challenges and e-Sports (which is already offered to highschoolers) is being added.

Garcia congratulated Gauldin, Imperial, Lewis, Old River, and Rio San Gabriel schools for their recognition as Apple Distinguished schools. He added that three more schools - Gallatin, Unsworth, and Williams Elementary Schools were also given the distinction just this week.

"When we talk about 'globally competitive,' what does that even look like? What does globally competitive look like, what does it mean?" said Garcia. "What it means is you have to measure yourself

against a global scale, and that's what we do in Downey Unified."

The school District also participated in Apple Digital Learning Day, in which over 200 educators across 12 states and nine countries were granted a peek into some of the ways Downey has integrated technology into student learning

Garcia expressed hope that all Downey schools would eventually earn the recognition.

"Our idea is to become the first Apple Distinguished School district in the entire world," said Garcia.

On the construction at the middle schools, Garcia announced that Measure O projects are set to conclude at Stauffer Middle School next fall.

However, the District is hoping that voters will pass Measure K next month; a new \$504 million bond measure earmarked primarily for modernization of the aging elementary schools.

Minimum wage proposal to wait unil 2024

DOWNEY – Downey will wait to decide on a proposed \$25 minimum wage for eligible healthcare workers until the next municipal election held on Nov. 5, 2024.

At their meeting on Tuesday, the City Council decided against scheduling a special election around the wage increase sometime next year, in order to avoid the around \$1 mil. price tag that would come attached.

Though no approximate cost is available at this time, waiting until 2024 and adding the item onto the regular municipal election was widely seen to be more cost-effective.

The ordinance, passed outright by the council in July and backed by the SEIU-United Healthcare Workers West Union, was one of several passed throughout Southern California that would increase the minimum wage to \$25 for eligible workers in private hospitals, clinics, and facilities.

Critics, led by the No on the Los Angeles Unequal Pay Measure Coalition, quickly filed a referendum petition against the ordinance, arguing that it was "flawed and inequitable," and that a majority of Downey's healthcare workers would not benefit from the wage hike.
