## **CHAMPS! PMA wins second CIF** title in four years

■ Tyrone Riley scores 33 points to lead St. Pius X-St. Matthias Academy past La Serna.

time in four years, the St. Pius X-St. Matthias Academy (PMA) High School Boys Basketball team has captured the CIF Championship.

This years' title was in dominating fashion, as the Warriors defeated La Serna, 79-48 in the Division 3 AA title game at Colony High Saturday (February 25).

In addition, the Warriors advanced to CIF State and won in a first round game Tuesday (Feb. 28) over visiting Westchester, 70-62.

St. Pius X-St Matthias played a CIF-State second-round game at Orange Lutheran (21-11) Thursday (March 2) but results were not available at press time.

Last season, the Warriors (30-4) lost to Bishop Diego in the CIF semifinals in Division 3A and were determined to go a step further this year.

"It was amazing to win and win as a family and as a group," PMA junior guard Tyrone Riley said. "That was our goal and now we have one more goal (to win state).

"It's a different environment than this (CIF-SS), but I think we're all ready. We're young and we have championship game experience under our belt now, so I think we're

Ready they were, as they raced out to a 20-10 first-quarter lead over La Serna (27-6) in the CIF D 3AA title game. Riley led the Warriors with eight first-quarter points.

After one of his layups, Riley looked toward his home crowd, which nearly filled one side of the gym and gave a fist pump.

"I feed off of the crowds' energy during the game. That's just what I need," Riley said.

Leading the way for the Warriors was Riley with a game-high 33 points, followed by Langford with 16 and Tylon Williams with nine

Sophomore guard Tyriq Bridges had six points.

"When we won Section 7 (summer tournament), that brought us closer and that's where we grew as a team," said Langford, who is from Belize. "State was a goal, and this was one step closer to our goal.

"Our coach told us that me and Tyrone had to step up this year. Once we locked in and came together, we saw what we could accomplish and did that."

La Serna was led by junior guard Gabriel Lewis with 13 points, while senior Marco Montano added 10 (3 **ONTARIO** — For the second 3-pointers) and senior guard Daniel Angulo had nine (2 3-pointers).

> By halftime, the Warriors had doubled their lead, 42-21. In the last 2:50 of the second quarter, with PMA leading, 31-20, they went on an 11-1 run to end the half.

Riley highlighted it with a dunk to end the half.

Riley and sophomore guard Shaun Fonoimoana had six points each to lead the 19-point third quarter for the Warriors and the 23-point, 61-38, lead.

Early in the fourth quarter, Langford had his moment with a dunk by the 6-8 forward and the 69-38 lead.

One player for PMA, Darrin Poland, Jr., was a member of the team during the first championship and will now have two rings.

"The turning point for this team was the Section 7 tournament in the summer in Arizona," PMA coach Donte Archie said. "It showed that we could win a game when it really matters in a do or die situation.

"We just had to drill in to our players to take nobody for granted. This week we had a full week to prepare. We went a little harder on them the first couple of days.

"In the beginning we weren't playing good defense and we let them (La Serna) get to the basket. That's what we wanted, because we didn't want them to shoot a lot of

On the play of Langford and Riley, Archie said: "As long as Doug keeps progressing and keep getting better and better, that's what we want from him," he said. "Tyrone is getting better too, but he is coming into his own. They all like each other and like being around each other."

#### PMA wins CIF-State firstround game over Westchester

In the opening round of state, Riley (12 rebounds) and junior guard Tylon Williams led with 19 points each, followed by Langford and Bridges (5 rebounds) with 15 and 13 points, respectively. Langford also had 20 rebounds. three blocks and three steals.

Westchester was led by senior Jonathan Choyce with 18 points, while senior Andrew Martin added

"We were always on the edge of going over the top," Archie said of the game against Westchester. "We controlled the game."

Archie complimented the play of Langford and Williams: "Doug was the catalyst on defense and controlled the game and Tylon (Williams) played big (Tuesday)."

After jumping out to a 20-13 first-quarter lead, the second quarter was virtually even, as Westchester outscored PMA by a bucket, 17-15 and were only five points down at the half, 35-30.

## Chick-fil-A design plans approved

■ Chick-fil-A's plans for a third Downey restaurant, this one replacing Frantone's and Wednesday by the Planning Commission.

**DOWNEY** — The Downey Planning Commission gave the green light on Wednesday for Chick-fil-A to take over the current

Frantone's Pizza site. Frantone's and neighboring Chris's Burgers, located at 9180 and 9148 Telegraph Rd. respectively, will both be demolished to make way for a 4,777 square foot Chick-

lanes and an outdoor seating area.

The fast-food chicken location Chris's Burgers, were approved is anticipated to operate similarly to others within the chain, Monday through Saturday from 6 am to 11:30 pm.

> Frantone's has been a mainstay in Downey since opening in 1964. Ownership confirmed in late January that the Downey location would be closing at the end of the summer, while the Cerritos location would remain open.

There were several somber comments from members of the Planning Commission expressing sadness to see Frantone's go.

Commissioner Mario Guerra said that "he'd rather have

## Cerritos College seeks funding to build student housing

**NORWALK** — To tackle the persistent problem of student homelessness, Cerritos College is seeking state grant funding to build affordable on-campus student housing through the Higher Education Student Housing Grant Program.

In addition to its request for nearly \$70 million in grant dollars, the flock to see the block-coordinated Cerritos College Board of Trustees is also contributing \$12 million to holiday decorations where entire ensure the District's bid for funding is competitive.

If accepted, the combined funding will be used to build an \$80-million student housing project that features about 400 affordable beds by 2026. The complex will be located along Studebaker Road, directly across from the college's Health Science Building.

Cerritos College is widely known for its pioneering efforts on affordable student housing. In 2020, the college opened The Village, California's first community college housing development exclusively for students facing

District can offer below-market-rate housing units at \$717 per bed, including utilities. "Home insecurity among students is increasing statewide, but above all, L.A. County's typical rent for a one-bedroom apartment is among the

highest, costing up to \$1,800 per month. We must eliminate the burden our students face of paying for expensive rent and provide them with a safe and secure living environment, which ultimately will lead them to complete their educational goals on time," said Cerritos College President/ Superintendent Dr. Jose L. Fierro. Cerritos College continues to offer innovative student support services.

In addition to The Village, the campus opened the Falcon's Nest, a centralized network of resources that provides students with basic needs support, including food, clothing, and hygiene. The College also launched its Metro GoPass program, which provides students with a free transit

"Addressing the basic needs of our students is a major goal for the Board of Trustees, and that includes housing students who face homelessness, echoed Cerritos College Board President Dr. Shin Liu. "Having more affordable student housing is crucial so students can focus on getting their education and building their future."

The following is a Westways article published in June 1957 after author Lucile Popenoe visited Downey:"

There is gracious living in Downey: proud of its 32 churches, one being a Moravian Church, said to be the only one west of the Mississippi.

Each Christmas, tourists neighborhoods combine in one unified theme of decorations. Young and old alike have their say, not only at Christmas but throughout the year.

Just like Miss Judith Hill, 87 years young, still keeps an eagle eye on the Marker Preserving Kitchen, where for more than a quarter of a century, prized recipes have been fashioned into worldfamous preserves in individually cooked portions, a product of the same home industry begun by the original Mr. Marker. A great fancier of flowers, he and Miss Hill devised a unique gift-packaging where true replicas of various flowers are fashioned in candy. Miss Hill even today shows up bright and early in the morning at the old Marker home on Lexington-Gallatin Road, where she supervises the output of this unusual establishment.

"What a delightful day of sightseeing," our guest sighed as we again drove onto the freeway. "Meeting such mentally alert and charming people who have long since passed their allotted span makes me, too, feel hopeful for a few years longer," she chuckled.

'They certainly are proud of their little city and just keep growing with it," I replied. "Maybe that's the answer to it all.'

► The following was taken from a clipping in the city scrapbook, dated June 30, 1963:

The Everlasting Flower has been accepted by the City Council as Downey's official flower,

Chamber of Commerce project.

A regal purple and white plant, the Everlasting Flower was described to the City Council by architect Robert W. Essig of the Chamber's beautification committee as "amazingly lasting." The botanical name is Statice, more commonly called Everlasting. A true Statice has small, evergreen leaves in basal rosettes, from which rises a rigid, stiff flowering stalk, at the end of which is a dense, globed-shaped head of chaffy flowers. Just below the head is a series of membranous colored bracts, two of them united into a sort of sheath. They are purple and white, lavender, or pink. They are long lasting, and very suitable for

► This article was published in the Press Telegram, April 5, 1989:

After the Civil War, many people fled the destruction in the South for the hope of a new and better life elsewhere. One of the emigrants was Texas farmerminister William V. Justice, who settled in the region known as Los Nietos, which is now Downey.

In January 1869, Justice organized a revival meeting at an old school building at the end of town and held the initial services for a new church. The denomination was for the First Christian Church of California. The congregation began with a membership of six and boasted among its many of the community's prominent families - Crawford, Rives, Pangborn, etc.

After the turn of the century, however, the membership dwindled, and in 1910 the church stopped services, allowing another congregation to use the facilities that had been built at 4th and New Streets. After about 11 years' occupancy, the latter group claimed ownership of the property, action. The matter was settled in court in favor of the original group, which then set about restoring its congregation.

In August 1923, the Rev. C. Edward Sewall was called from Oregon for the task of revitalizing and building upon what remained of the original membership. The Sewalls had two children, Monnie and her brother Arvey. She, now Monnie Keays, has remained

in Downey and is still active in First Christian Church. She has a treasury of stories about Downey in those earlier years, and about her own girlhood days in the parsonage.

She remembers that her father's meager salary was supplemented by produce grown in the then fertile farming community.

When the Depression hit, it was only moderately worse for the Sewalls since they were already accustomed to being poor. Of course, their income was reduced even lower, and for some time her father's salary consisted only of what remained from the offering after the bills were paid.

"But mother redyed our clothes and had our shoes resoled, and somehow we got through it," she said.

Monnie and Arvey were given \$5 per month to keep the church

All children, Mrs. Keays still believes, need a private place where they can be alone. Her hideaway was the church belfry.

"There," she says, "I could look out upon the town, daydream, and pretend that I was on top of the

Theirs was a musical family, and the teenagers often performed for lodge and service club meetings. Monnie "drew the funeral detail" as well, frequently playing for services at which her father officiated, and thus getting an early exposure to the sorrowful side of life.

Generally, those were happy times and she enjoyed her years at Downey Union High School.

Mrs. Keays recalls that there

was one thoroughfare in town at that time (Crawford Street, now Downey Avenue), one general store for groceries and dry goods, two drug stores and two doctors. There was no hospital.

There was no mail delivery, but at 3 pm each day everyone gathered at the post office where they would attempt to solve all the problems of the world while awaiting the distribution of daily mail.

A favorite family entertainment was simply to go for a drive through the countryside to enjoy the fragrance of the orange blossoms and the smog-less moonlit evenings.

"We never locked our doors in those days," she added. "And one could walk outdoors of an evening without fear."

When her father died in 1938, the church was in the midst of a building program, and the members felt they needed someone familiar with their plans to carry on the project. In a move nearly unprecedented for that day, the officials of the church asked the pastor's widow to assume his leadership responsibilities. She agreed to do so until a permanent replacement could be found. That took 13 years.

Mrs. Keays contrasted the pastoral styles of her parents, saying that while her father never hesitated to speak his mind, her mother tended to be more of a peacemaker and a calming, stabilizing influence. She was a source of great comfort, recalls her daughter, to families who faced the anguish of seeing their sons go to

## City delays decision on YMCA funding

■ The YMCA is seeking financial assistance from the City of Downey as it looks to build a new facility.

**DOWNEY** — No definitive answer came out of Tuesday discussions on whether or not the city would decide to financially aid the construction of the new YMCA

The Downey YMCA is currently in the midst of fundraising over \$14 million for a new building that will replace the current structure, which was opened in 1963 and already deteriorating at the time of its closure during the pandemic.

It was clear early on that members of the city council wished to support the Downey YMCA. Still, cost and timing would make it a difficult decision to make.

The new 20,000 square foot facility is designed to include an outdoor basketball court, pickleball courts, a child activity center, indoor pool, men's, women's, and family locker rooms, state-of-theart fitness center, holistic health community space, and dedicated parking with electric vehicle charging stations and a secured

## Supervisors back measure supporting job applicants with arrests, convictions

■ Proposed legislation would prohibit businesses from using criminal convictions as reasons not to hire.

LOS ANGELES - Most businesses in unincorporated areas of Los Angeles County would be barred from excluding job applicants with past criminal records during the hiring process under a proposal backed unanimously Tuesday by the Board of Supervisors.

The board voted unanimously to direct its staff to draft a comprehensive Fair Chance ordinance, which would codify and enhance a similar state law that was enacted in 2018.

County staff were directed to return to the board with a draft ordinance in 90 days for further consideration.

Supervisor Holly who co-authored the motion with Supervisor Hilda Solis, noted that many employers already adhere to regulations that prevent them from inquiring about applicants' criminal history or considering it in a long way to go making it real for every job seeker."

Mitchell noted that "more than a quarter of formerly incarcerated individuals are unemployed on average." Those people "are more likely to experience homelessness,

The board's vote Tuesday directed county staff to return in 90 days with a draft ordinance with similar protections that would apply to all employers with five or more employees in unincorporated

areas, or for employers with five or more employees with county contracts or leases.

Specifically, the county's proposal would require employers to make it clear in job solicitations and advertisements that qualified applicants with arrest or conviction records will be considered. It would also bar employers from asking applicants to voluntarily disclose information about their criminal history. Employers would also be barred from considering in hiring decisions an arrest that did not lead to a conviction, participation in a diversion program, convictions that have been dismissed or expunged, motor vehicle offenses, juvenile justice adjudications or convictions more than seven years old.


The proposal would include various other requirements for employers and would establish penalties of \$500 for a first violation, \$1,000 for a second violation and \$2,000 for a third and subsequent violations. At least half of those fines would be awarded to the affected job applicant.

Supervisor Janice Hahn also asked that the ordinance apply specifically to the county's own hiring processes.





## Helping Ukraine prepares us for a looming confrontation with China

U.S. military aid to Ukraine's self-defense, critics allege, is making America's military less prepared and less potent. In particular, the decrepit state of our defense industrial base, and its inability to produce replacement stores of even the most basic armaments, means that any ammunition, platform or system allocated to Ukraine's defense is one that becomes unavailable for Taiwan's.

But these critics are wrong. Russia's disastrous attack on Ukraine and the United States' still-too-timid military support for Kyiv will help, not hurt, efforts to deter a cross-strait Chinese attack. In fact, continued military aid to Ukraine might be the only thing that saves the U.S. military from its peacetime atrophy.

The critics' case is strong. A report from the Center for Strategic and International Studies estimates that it will take five years to replenish the supply of Javelin missiles we provided Ukraine. Some weapons systems that we've provided, such as Stingers and M-777 howitzers, are not in production at all. The Biden administration is supposedly not providing much-needed ATACMS to Ukraine partly out of fear that the United States might not have enough in reserve for its own readiness. There is a nearly \$19 billion and growing backlog of approved, but undelivered arms to Taiwan, just as a U.S. Air Force general predicts war with China could come in 2025. In an age of military resource scarcity, choosing to deal Russia a heavy blow, critics lament, is a luxury that is making a Chinese victory more likely.

But this argument conflates cause for consequence. Our constraints are real but are the product of policy choices — choices that have left us unprepared for a dangerous world that reemerged more than a decade ago.

Years of focusing on counterterrorism and counterinsurgency operations led our leaders to dismiss high-tempo, conventional warfare as archaic. As then-Secretary of State John F. Kerry

of Ukraine in 2014, "You just don't in the 21st century behave in 19th-century fashion by invading another country on completely trumped-up pretext." Well, apparently you do. The current conflict in Ukraine is the largest land war in Europe since World War II.

And it's not that we merely prepared for the wrong kind of conflict. After the end of the Cold War, many Americans convinced themselves that a peaceful, and permanent, liberal world order had arrived. This, in turn, has led to a 30-year decline in defense spending. When the Berlin Wall stood, the United States was spending 26.5 percent of federal outlays on defense; today, it is less than half that, a post-World War II low. And President Biden's proposed defense budget would take it even lower than in the isolationist 1930s.

Declining demand has led to a wave of industry consolidations; what was once 50 prime contractors has become five. Three decades ago, the missiles and munitions sector had 30 contractors working directly with the government; today, there are only seven. The United States has few manufacturing lines for even the most basic things. The Pentagon sources its ammunition from only six plants. The sole plant that produces tanks was nearly closed in 2018, and the Army plans on building a mere 22 tanks in fiscal 2023. The Navy has averaged 10 ships below procurement plans since 2017 and currently possesses only four public shipyards. When asked if it should open a fifth, Adm. Daryl Caudle, commander of U.S. Fleet Forces Command, replied, "I need six." As Lockheed Martin CEO James Taiclet recently said: "The U.S. defense industrial base is scoped for maximum efficiency at peacetime production rates.'

Paradoxically, the greatly expanded U.S. effort to support Ukraine might be our best chance at providing the necessary shock therapy to snap us out of our complacency. It has brought popular attention and political scrutiny to the problem. Just before the Russian invasion last year, the Defense Department issued a report titled "State of Competition within the Defense Industrial Base," in which it acknowledged the downward spiral caused by declining procurement. In the scramble to identify, update and transport

incredulously put it when Vladimir Putin launched his first invasion military materiel to Ukraine, the United States has taken the first – and most difficult — step of fixing the problem: acknowledging there is a problem in the first place.

> The Russian invasion has allowed the United States to conduct a dry run of exactly the sort of policies that deterring or defeating a Chinese attack on Taiwan would require: active defense industrial production lines, an efficient logistics network to get those arms into the field, a coalition of allies providing significant firepower and aid, an increase in energy exports to sustain our allies, and economic pressure to punish and degrade the aggressor. It is a fallacy to suggest that the \$30 billion in military materiel provided to Ukraine thus far would have gone to Taiwan deterrence scenarios instead. Had Beijing attacked Taiwan a year ago, the United States would have been just as unprepared to support Taiwan's defense as

> Despite some opposition in both parties, major, long-term investments in the defense industrial base could get sustainable bipartisan support. Military investment is the original industrial policy; it is a government effort to support the growth of a strategic part of our economy that is critical for national security. In 1985, the defense industry consisted of 3 million workers; today, it is 1.1 million. In the past five years alone, the defense industrial base has lost more than 17,000 companies. A major investment in our own industry, to supply the weaponry necessary to make Russia lose, could unite defense hawks and populists, labor and business, internationalists and nationalists alike.

What's lacking is the political will and imagination to make a comprehensive case. Defunding our military is a choice with consequences. Doubling our defense spending would still only put it in the lowest range of Cold War levels. Without doing so, we risk the possibility that — much like Pearl Harbor — only after the United States has been attacked will the arsenal of democracy roar.

## A PPP plan for East Palestine

East Palestine is a small town of about 5,000 in the northeast area of Ohio along the state border with Pennsylvania. Its median income is \$44,498, and 71 percent of its voters supported Donald Trump in 2020. Like many towns near Youngstown, Ohio, it has suffered substantially from the wave of deindustrialization that saw millions of jobs leave for China, Mexico and other countries.

Because of this, the concerns of residents have focused on economic development questions over the past several years. How do they lure back industry? How do they support the town's small businesses? How do they persuade some of their young people to return home after college or military service lures them away? How do they provide good jobs to those who never left at all?

Every one of those challenges has gotten much more difficult.

The catastrophic Norfolk Southern train crash this month, which led to the spilling and burn-off of highly toxic chemicals, has forced residents of East Palestine (pronounced "palace-teen") to ask altogether different questions. Given the chemical release, is the air breathable? Is the water drinkable? Can I still raise a family here? Will our small town survive?

The public safety concerns take precedence. So far, air and water tests performed by the Environmental Protection Agency, Norfolk Southern and local officials have been encouraging. Most people I've spoken to are highly skeptical of both the train company and

the federal EPA, but they are heartened by the fact that their friends and neighbors are testing the water, too. While many drink the city water, much of the surrounding area's residents rely on private wells. These folks will need consistent, timely testing for months or even years, and so far many have been frustrated by the wait times necessary to get their well water tested.

The lack of public trust means that many of East Palestine's residents will continue to doubt that their community is safe. We cannot just order them to believe the same public health authorities who — in their view, at least — bungled the response to the covid-19 pandemic. Even if air and water tests show little acute risk of exposure, residents want to know what could happen to those who breathe that air and drink that water for years. Indeed, chronic exposure to vinyl chloride and other chemicals present on the derailed train may be the most pressing public health issue facing East Palestine. And our public health and environmental authorities are, by their own admission, not well equipped to monitor and address chronic exposure.

But East Palestine has a longer-term perception problem, too. Residents must rebuild an already stressed local economy, in a media environment where every story about the health concerns of residents drives people and capital away from their town.

I spoke to one young couple who own a successful dog breeding and training business. The day after the train crash, four of their dogs began vomiting. They moved their dogs to a relative's home far away and don't plan to return. Another woman told me she's not

worried about drinking the water herself, but she is worried what a decade of drinking that water will do to her grandchildren. She hopes to leave town as soon as she can. A local farmer who raises chickens and hay on her property put the matter bluntly: "Do you think anyone wants animal feed from a farm in East Palestine? Do you think anyone wants eggs from me?

Unfortunately, she has a point. No matter how much independent testing shows the worst of the environmental catastrophe is behind us, East Palestine will be dealing with bad perception, and its economic consequences, for years.

The mayor, a good man with an impossible job, told me that about half of his constituents are terrified and half of them just want the media circus to go home so they can get to work rebuilding the community they love. We can help, not just tomorrow but months from now. East Palestine needs long-term investment, from both the federal government and Norfolk Southern Railway. Without special refinancing, homeowners will be underwater as flight from the community drives home prices lower, decimating the tax base on which local schools and public services rely. Farms will require direct support. Underfunded schools will need help. East Palestine will need its own version of the Paycheck Protection Program to protect workers and businesses who lost their livelihoods because of the decisions of others.

Otherwise, an entire town of good people will suffer mightily through no fault of their own.

## How Biden helped Congress cut Social Security 40 years ago

President Biden has pledged to oppose any and all cuts to restore the critically underfunded Social Security system to solvency. This makes for good politics for Biden and congressional Democrats. But it is bad for the Americans who will depend on the nation's retirement and disability program in the future. With most Democrats opposing benefit reductions and Republicans opposing

any tax increases, policymakers are at an impasse. Waiting to act until 2035, when the system's trust fund is projected to run dry, will only make the solution more painful.

Biden himself should know this — because he was directly involved with one bipartisan compromise that kept Social Security solvent for decades and another that failed to pass.

The successful compromise was reached in 1983, when Social Security was mere months away from insolvency. For two years, Republicans and Democrats had been engaged in heated rhetoric over what to do about it. The main players in this drama were a who's who of the era: They included noted economist Alan Greenspan, appointed by President Ronald Reagan to head a commission on the retirement program; House Speaker Thomas P. "Tip" O'Neill Jr. (D-Mass.); Rep. Dan Rostenkowski (D-Ill.), chairman of the House Ways and Means Committee; and Sens. Daniel Patrick Moynihan (D-N.Y.) and Bob Dole (R-Kan.), who eventually led the bipartisan compromise. They fought for their positions and then negotiated a plan that served the country's

The reforms they settled on reduced benefits in three important ways. First, the "normal retirement age" at which full benefits could be received was gradually increased from 65 to 67. This provision did not restrict the age at which benefits could be claimed, but imposed an effective 13 percent benefit cut on anyone claiming benefits before the normal age. Second, the reforms made Social Security benefits subject to income taxes, a de facto means test on retirees with incomes above \$25,000. And third, cost-ofliving adjustments (COLAs) for retirement benefits were delayed. Together, these benefits reductions accounted for more than twothirds of the reforms' improvement to Social Security's finances. Tax increases, which included an increase in the rate paid by selfemployed workers and the more rapid implementation of a payroll tax rate increase already scheduled to take place, generated most of the rest of the improvement.


Twenty-six Senate Democrats voted to support the agreement, including Biden. In April 1983, Reagan signed it into law. And Social Security remained solvent for decades.

In 2012, the Obama-Biden administration proposed a budget for the next fiscal year that would have reduced Social Security COLAs as part of a "grand bargain" with congressional Republicans to reduce budget deficits in general. The proposal would have adopted a new measure of inflation to calculate COLAs, the "chainweighted" consumer price index, which the Bureau of Labor Statistics considered to be an improved measure of the cost of living but would result generally in lower COLAs, including for seniors already taking their Social Security benefits. As vice president, Biden was the administration's point man in the bipartisan budget talks, which eventually broke down when Republicans backed away from tax-rate increases. But it's important for Democrats to note that the Obama-Biden administration had been ready to accept reducing Social Security benefits for current retirees as part of a compromise.

Congressional Republicans, for their part, need to banish any illusions that a bipartisan deal would not include tax increases, most likely on higher income Americans. Republicans don't have to like raising taxes any more than Democrats like reducing the growth of benefits. But accepting policies you don't like is the price of a bipartisan fix — the only possible solution to Social Security insolvency.

Social Security's financing hasn't gotten any better since 2012. In fact, the Congressional Budget Office predicted last year that over the next 75 years, the system will be underfunded by 27 percent more than double the shortfall the agency predicted 10 years earlier. Perhaps worse, both political parties' willingness to engage on fiscal issues has only declined as past concerns over deficits and debt are

Biden has an opportunity to be a president who — like Reagan — saves Social Security. His decades of experience on Capitol Hill, including previous efforts on Social Security reforms, are what is needed to get Democrats and Republicans in Congress to put aside their differences and make the difficult decisions needed to protect this important program for current and future retirees.



The city council approved the discounts unanimously at their meeting Tuesday.


Currently, the city's 10-week seasonal day camps are offered at a rate of \$150 per week for residents. Swim lessons are offered at \$64 per session.

With the new discounts, families with multiple siblings enrolled will only be charged \$120 per week for day camps and \$51 per aquatic session; about a 20% markdown.

In total, Parks and Recreation staff anticipate a \$2,000 loss in revenues associated with the day camp, as well as an approximate \$1,500 loss from aquatics.

However, Parks and Recreation director Jason Chacon said that "recreation is not a money making business."

"We are a people and service-providing business," said Chacon. "So it is not something that is detrimental to any bottom lines for us because it's a service to provide and we actually give families more resources who want to have multiple children be able to go to our classes.'
