Roger Bradley's 100 day plan

■ In an interview with the Downey Patriot, new city manager Roger Bradley discusses his early priorities.

DOWNEY — Just over a week since being sworn in, City Manager Roger Bradley says stability and setting a strategic plan for the city's future are his top priorities.

So far, Bradley's tenure as Downey's city manager has been "getting up to speed."

"The past week I've been spending meeting with all my department heads, trying to get an update of what projects they're working on, what issues they're dealing with and addressing, and basically just trying to download everything," said Bradley. "I had a chance to meet with the council as well, and really just get a good operational snapshot of what's going on with the organization."

He enters at a high-stakes time for the city, as the city is in the midst of working on its upcoming fiscal year budget while also needing to fill in the holes left from departed department heads and staff.

"We're in budget season, so we need to get the budget going," said Bradley. "I wish we were a little farther along than we are, but [the city] was very respectful of letting me come on board as new manager to help control the budget process, so we are in a little bit of a catch-up

mode to get going on that." On stability, Bradley said,

"Organizationally, I think there are a few things I'm going to focus in on with staff," said Bradley. "We talked about looking at filling in some of our vacancies, and that's really one of our immediate needs and biggest concerns," said Bradley. "I want to make sure that we can be more strategic internally. I'm really looking to build culture; I want this to be a great place for everybody to

"I'm really focused in on making sure that one, staff has the feeling that they can innovate and do new and exciting things, and they've got somebody to back them up because things sometimes don't go the way we expect – but they know that it's okay to try to innovate new things. That's what I'm going to try and foster here with our staff.'

He says that it's about "getting back to a sense of normalcy for

"Yes, things have been a little bit rocky over the last short term, but I think it's really just trying to build a feeling that the future is bright, and we're going to go to a good place," said Bradley. "We have good finances; we've been well managed on that front. So, really it's now trying to figure where are some of our deficiencies in our staffing, build up a little bit to make sure that we're strong and we continue to focus on the needs of the community."

"I think economic development, we continue to look at how do we not only attract, but retain the strength in our business community; how do we continue to make people when they come here to Downey feel like it's a special place and see all the great amenities that we have."

When asked about Downey's long track record of balanced budgets and his feelings on taking on the endeavor of continuing that trend, Bradley said "you want to make sure you're not the weak link in the process." He said he sells himself as "a financial person," making note of his background in business statistics.

Governor visits Downey to unveil plan for \$30 insulin

■ Manufacturing could begin later this year, pending FDA approval.

DOWNEY — Gov. Gavin Newsom has announced a partnership with Civica Rx to provide insulin to Californians for \$30 for 10 milliliters -- which he said was as little as one-tenth of the current cost.

Newsom visited a Kaiser warehouse in Downey on Saturday as part of his tour of California discussing his administrative policies in lieu of a traditional State of the State address.

praised the 10-year partnership as a way to lower the health-care burden for residents without "subsidizing costs or socializing costs" but to address the "underlying" costs.

The insulin program, which will be administered through CalRx, was characterized by the governor as "market disruption," which he hoped would prompt major drug companies to lower their prices for the drug.

"This a big deal for us. This is not happening anywhere else in the United States," the governor said.


"Diabetes has become an overwhelmingly expensive chronic condition, and it is heartbreaking that millions of people in California and across the U.S. are faced with the possibility of having to ration their care and put their lives at risk because they can no longer afford insulin," Civica President and CEO Ned McCoy said. "We applaud California for its missiondriven commitment to lowering the cost of insulin and look forward to our groundbreaking partnership on behalf of people living with

Newsom said manufacturing is set to begin later this year, and added that he anticipates "favorable treatment" from the FDA, and hopes to see delivery begin next

Also in attendance Saturday was Assemblymember Blanca Pacheco.

"Californians should not be forced to go into debt in order to obtain this life saving medication," Pacheco said.

The governor also announced product to bring to market --

namely Naloxone, or Narcan, the drug that reverses the effect of an opioid overdose and is credited with saving hundreds of thousands of lives. Newsom said the state's Health and Human Services Agency is working with Civica to identify a California-based manufacturing facility.

'We're starting with insulin, but we're not stopping there," said HHSA Secretary Mark Ghaly, who joined Newsom for the announcement along with Los **Angeles County Supervisor Janice** Hahn. Downey Mayor Claudia Frometa and others. "We are going to look for other opportunities, (for

Shake Shack opening in Downtown Downey

DOWNEY — Shake Shack, the popular fast food chain known for its burgers, hot dogs and shakes, is opening a location in Downtown Downey, city planning staff confirmed.

The restaurant has been approved to take over the former Legends Square Park in 2001. Board Shop at 8300 Firestone Blvd.

The project was recently approved by the Planning Commission and calls for the demolition of the existing building and construction of a new 3,624. sq. ft. restaurant with a 933 sq. ft. outdoor patio, drive-thru, and parking at the rear of the property along Downey Avenue.

Planning commissioner Mario Guerra, who voted to approve the project, expressed enthusiasm about Shake Shack's pending arrival.

"The revitalization of this corner in the heart of our city will continue to enhance our downtown," he said. "Our award winning Downtown Specific Plan, which includes our Downtown Downey District, is another example of businesses working together with the city to re-energize our community. Our Planning Commission saw this opportunity and enthusiastically worked to help facilitate this upgrade to our downtown. I'm excited and look forward to many other new projects in the works."

The Shake Shack in Downey will be the company's first location in Southeast Los Angeles County.

The New York-based company started out of a hotdog cart in Madison

In 2010, Shake Shack expanded its operations, opening up locations throughout New York City, including in the Theater District, the Upper East Side, and in the Chelsea neighborhoods. It also opened a location in Miami's South Beach, its first location outside of New York City.

Today, there are 440 locations worldwide.

Shake Shack maintains that partnering with local communities is important in its expansion plans.

"Every Shack is a reflection of the community it's a part of, from partnering with local artists and ingredient purveyors, to hosting fundraisers with local non-profit partners and school groups," the restaurant said.

How Downey marketed itself in 1897

■ An early newspaper article sheds light on the Downey community and how it attracted new residents.

Why eke out a miserable existence raising wheat at 50 cents a bushel when comfort, aye, opulence, may be obtained in raising fruits and other products that are so successfully cultivated in Southern California?

The people of Downey say, why not rear your children in a climate where they can be out of doors the greater part of the year, where their lives will be ennobled by views of grand mountain scenery, their natures cultivated by contact with birds and flowers and enjoy a climate where the diseases of children prevail in their mildest form? Where life to them is a continual holiday. Why not live in a climate where women can cultivate the esthetic side of her nature. In the midst of flowers and orange groves, and lose none of her womanhood in so doing.

If one wishes to better their financial condition, why not move to a country teeming with new enterprise - one offering constant and remunerative employment for both labor and capital? Why not seek a land where there are growing cities, towns and villages, needing the improvements of modern times - street, railroads, electric, plants and irrigating systems, not to mention the requirements of sugar factories, preserving and canning establishments, etc. Lands being freshly put under cultivation meaning increased suburban population and development



of the natural resources of the

Few countries offer such a combination of profits and comfort as Southern California, especially that portion of it in the immediate vicinity of Downey.

Downey is located about 12 miles southeast of Los Angeles between the old and new San Gabriel rivers, on the Southern Pacific railroad. It has about 1200 inhabitants and is one of the most important business centers in one of the richest and most attractive valleys in Southern California, known as the Ranchito or Los Nietos valley. The valley shipped the past season \$275,000 worth of walnuts, produced 700,000 tons of barley and alfalfa hay, and upwards of 375,000 bushels of corn. Los Angeles, a city of over 100,000 inhabitants, and destined to be the largest west of the Rocky Mountains, is the principal market through which these products are disposed of. Eight daily trains in and out of Downey to the city furnish the people with quick transport between two places. A number of people do business in Los Angeles and live in Downey. Many of the young men and young women of the town and vicinity attend the business college daily in the city, returning to Downey in the evening.

Downey is only 12 miles northeast of Long Beach, the most moral and finest-bathing resort in the world. Within a radius of seven miles of Downey there are 17 water companies, principally owned by the farmers. The remarkable fertility of the soil may be realized from the fact that it often yields 300 sacks of potatoes to the acre, 100 pounds to the sack.

If the newcomer wishes to know where he can settle on land where ample profile and pleasure are the sure rewards of the industrious farmer, the citizens of Downey can best give

the information, as they are surrounded on every side by the richest of all the rich lands of Southern California.

Downey has good public schools, churches and social organizations. Her lodges are the Masonic, Odd Fellows, Rebekah, A.O.U.W., Good Templars Foresters, etc.

Within a radius of 3 miles are seven public schools. Within a radius of 3 and one-half miles are upwards of 7,000 inhabitants.

Mr. B. M. Blythe has become interested in the cultivation of tobacco in Downey. Mr. Carl Grosekopf, recently from San Diego, is starting a new cigar factory in Downey. He thoroughly understands the business, and is certain to make a success of his venture.

The Downey restaurant, conducted by Mrs. Smith, furnishes one of the best 25 cent meals to be had in Southern California. All the delicacies of the seasons are served and all patrons are happy and contented.

Downey is blessed with a good newspaper in the Downey Champion, published and edited by Mr. C. H. Eberle. The Champion is loyal to Downey and vigorous, and able in its advocacy of the best interest of the place.

The concept for a museum was born in 1967 when Barbara Callarman became a member of the Historical Society's board.

"I always liked antiques and kind of said in an offhanded way I'd like to be the curator of the museum," she recalled.

The society had found a guardian for its historical treasures, and for eight years she ran the museum single-handedly until Mrs. Joyce Lawrence joined the group and began lending a hand with the museum.

After the Krueger building find, Mrs. Callarman would make weekly visits to the rickety old shed and take home the dusty remnants of former Downey Businesses. Barbara spent hours on her patio restoring the antique items now displayed in the museum. Then one day, Mrs. Callarman drove to the shed on one of her weekly visits and the building had been torn down.


The contents of the Krueger building had been moved to the former headquarters of the water department. On July 18, 1978, Barbara Callarman began the immense task of packing and moving the Krueger finds and a large collection of items donated to the Historical Society.

Although the museum has had four homes since its inception in 1967, Mrs. Callarman hopes for one last move - into the Rives Mansion, the majestic white mansion set back from Paramount Boulevard. It's current owners, so far, have been unwilling to sell the old home, built in 1911.

"The house is important to the Historical Society," Barbara said. "Most societies have a historical monument - an adobe or a teepee – something to give the city a focus. That's what the Rives Mansion would do for Downey."

The dream to obtain the Rives Mansion has been discussed for numerous years, and so far the home remains owned by a private

Since the city will be 150 years old this year, it is important to know how the Downey Historical Society / Museum started and know its purpose. If, in the beginning, people like Barbara Callarman, Joyce Lawrence, etc. had not loved Downey history and put the effort to save its collection of artifacts, people would not have a place to go learn, share, and donate their memories.



MAYOR'S CORNER

Hello Downey,

Our city continues to make significant progress. I am happy to report 32 (thirty-two) miles have been paved during the first quarter of 2023. Many of you continue to express concern over the condition of streets in and around your neighborhoods.

During my first year as Mayor in 2021, the council voted unanimously to invest over \$30 million on infrastructure improvements (street rehabilitation and repaving) over the next few years. I realize many streets have not been repaved in 25-30 years, and believe me, we will get to your street. I thank you for your patience in advance as there will be disruptions and intermittent street closures as these streets get rehabilitated. Certainly, the abundance of rain we have received this winter has made it challenging to complete some projects within the scheduled timeframes. How do we prioritize streets throughout our city you may ask? The city has a Street Repaving Management Plan that guides the prioritization of streets and neighborhoods throughout our

I had the pleasure of welcoming Governor Gavin Newsom to Downey last weekend as he announced California will take the lead in slashing insulin prices by entering a 10-year partnership with Civica, to manufacture insulin and reduce prices by 90%, to \$30 dollars a vial. This is good news for the people of California and

certainly residents of Downey.
People should not have to choose between providing for their families and obtaining life-saving

medication.

We also had a mayor's roundtable with our newly elected Assemblywoman Blanca Pacheco. Mayors representing her district met in Downey to discuss issues of concern and legislative priorities, including housing, fentanyl, and homelessness. I want to extend my gratitude to Assemblymember Pacheco's office and Cal Cities for bringing us together to discuss our priorities.

Update on Fire Station #4

I have continued to hear from residents of District-4 about their frustration and displeasure at the ongoing delays with the reopening of the fire station. The contractor is ready to install a new roof, unfortunately the heavy rains have continued to delay the project. We will need two weeks without rain for the roof completion. The new timeline for occupancy and reopening is end of April.

Community/Economic Development

Businesses and residential developments continue to flock to our city. Currently, there are thirteen (13) large projects in Planning and year-to-date, there have been 3,164 residential and commercial plan checks completed. As Mayor, I am engaged, collaborating with staff looking to attract new businesses and/or developments to empty spaces. It is an ongoing process, and I am grateful to have our new City Manager Roger Bradley who will be directing staff on several great

opportunities. We are pursuing Sprouts and staff continue to work with our business community to bring quality developments to our city.

Public Safety, Community Engagement & Speed Enforcement

The Downey Police Department continues to conduct speed enforcement activities throughout our city and look for illegal street racing and individuals utilizing empty parking lots/areas to do donuts. Drivers involved in street racing will have their vehicles impounded and will face steep fines. Year-to-date, seven vehicles were impounded because of street racing activities. I would like to encourage our residents to get involved with the Neighborhood Watch program. Currently, we have over 230+ groups throughout our city. "There's been some great management here in the past. We've done well financially; I hope I can add to that," said Bradley. "We want to make sure that obviously we keep balancing the budget; that's important to me.

"Throughout my career I've worked in big organizations managing half-billion-dollar budgets and other things, with 1,600, 1,700 employees, so, I think I can add to that. But right now, we're going through our first cycle with the budget, and we'll see kind of how it goes."

He has a first 100-day plan that he is following, focused primarily on learning, planning, and eventually execution.

"The first quarter of it is mostly looking at building knowledge of the organization and the community," said Bradley. "I do want to continue to work with the council, and we have a priorities workshop coming up here in the near future, which will really start setting the stage for what we want to do over the long haul."

Ultimately, Bradley says his job boils down to helping the council "execute their vision."

"That's really where I'm headed," said Bradley "That's the middle-term effort, I guess, is to try and build a strategic vision for the city and then from there we'll try to execute and turn that into a long-term plan."

He adds that he views himself as a "servant leader."

"My job is to, with staff, make sure they have the resources, the things they need to get the job done," said Bradley. "I think really the manager's role is to be aware of what's going on in the organization and figure out how to make the team successful...my job is to help them succeed."








NIMBYs threaten a plan to build more suburban housing

In an insult to New Yorkers suffering from spiraling rents and home prices, both houses of New York's Democratic-controlled Legislature rejected an ambitious set of proposals from Gov. Kathy Hochul last week that would begin to address the crisis in available

The legislators appear to be capitulating to the panic of their suburban members, as well as a smaller but persistent group of NIMBYs who oppose development in New York City. Lately, those voices have proven stubborn. Some of the backlash to the effort to build more housing in the suburbs has evoked euphemistic language that might have brought a smile to a Southern segregationist in the era of "states' rights."

"We see it as an attack on our suburban communities," State Senator Jack Martins, a Republican from Nassau County on Long Island, said in a hearing on the housing proposal in Albany on

Moments later, State Senator Pamela Helming, a Republican who represents the Rochester suburbs, said her opposition to the governor's housing plan was about "helping retain the unique character of our communities."

Donald X. Clavin Jr., a town supervisor in Nassau County, also a Republican, co-wrote a letter last week encouraging officials to protest the governor's housing plan, saying it was "imperative that local government retain the authority to act in the best interests of those they represent."

The proposal from Ms. Hochul, a moderate Democrat, would simply bring the state's housing policy into the 21st century, building crucially needed housing in the suburbs by slashing Jim Crow-era zoning laws. Under that promising plan, New York City and its suburbs would be required to increase their housing supply by 3 percent every three years, and towns elsewhere in the state by 1 percent every three years. More housing would be built in areas along commuter rail lines. The state would be able to override local zoning laws in areas that fail to increase their housing supply.

The knee-jerk alarmism over building more housing in the suburbs is embarrassing. It's also completely unnecessary. Other states, including Connecticut, Maine, Massachusetts and Oregon, have already enacted measures similar to the ones the governor has proposed. Some, like California, have essentially banned singlefamily zoning altogether. The purpose isn't to attack the suburbs but to help them grow, along with the rest of the state.

The housing crisis in New York State has locked out middle-class families and young people from homeownership, left hundreds of thousands burdened with high rents, and sent tens of thousands

of working people into public shelters. Of 3.43 million renters in the state, more than half, roughly 1.7 million, spend more than 30 percent of their income on rent. Yet instead of strengthening Ms. Hochul's housing plan, the State Senate and Assembly last week offered proposals that would gut it.

Just how out of touch is the State Legislature? Alternative proposals from both houses would keep the housing targets set by the governor, but give the state no authority to enforce them. They would scrap the plan's requirement for new housing along commuter rails. They would cut proposed measures for relief in New York City, including a plan to legalize basement apartments and make them safer. The Assembly proposal would also render moot the proposed expansion of a New York City program aimed at converting empty office space to housing.

Instead, the Legislature's plan would offer \$500 million in incentives to be distributed to localities that meet the housing targets, but impose no consequences for those that choose not to build new housing.

"We believe we can get there with incentives," Andrea Stewart-Cousins, the Senate majority leader, said last Thursday in Albany.

But there is solid evidence from other states, including Connecticut and Massachusetts, that incentives alone will not result in more housing. One reason, as noted by the Furman Center, a housing policy research group, is that wealthy towns generally prefer to keep their exclusionary zoning policies rather than receive unneeded funds from the state. Many of these communities have long histories of enacting exclusionary zoning laws and have shown that they will not produce the housing the region needs on their

A state in the throes of a housing crisis can't simply let them do as they please, all while they benefit from billions in state investment in commuter rail systems.

In one bright spot, the Legislature did signal some support for common-sense protections for renters in good standing. One such proposal, sought by housing advocates, would limit rental increases for market-rate apartments upon lease renewal to up to 1.5 times the Consumer Price Index or 3 percent, whichever is higher, except for owner-occupied buildings with a small number of units. (With current inflation, that would allow rent increases of about 10 percent.) Landlords may in some cases be able to charge more when they can show they have incurred additional costs, but could not evict a tenant except for violating the terms of the lease, a policy known as "good cause eviction."

The real estate industry is fighting hard against the proposal. Yet New Jersey enacted similar basic protections for renters years ago and continues to outpace New York in housing production. These protections are badly needed in New York, where price gouging is common and evictions are on the rise. Addressing the housing

crisis means keeping people in their homes as well as building more

But tenant protections alone will not solve the root problem of the crisis, which is the dire lack of housing supply. To do that, the Legislature will have to work with the governor to dismantle the single-family zoning laws that make it impossible to build new housing in the suburbs.

So far, the proposals from the Legislature are not serious. There is also evidence that they are out of step with some of their constituents. One survey of state residents, paid for by Open New York and other pro-housing groups and conducted last month by Slingshot Strategies, found significant support for building more housing in the suburbs.

More than two-thirds of respondents statewide, 72 percent, said they supported building more housing near train stations. Of a group surveyed in suburban Westchester and Putnam Counties, north of New York City, 56 percent said they would support giving the state authority to override local zoning laws in towns that fail to build more housing.

The poll, though small, reflects the intensity of the housing crisis in the state, where even middle- and upper-middle-class suburbanites have found that their adult children cannot afford to live or raise families in the communities in which they grew up.

New York has never fully reckoned with its history of racist housing policies, which have helped make the region among the most segregated in the United States. Even New York officials who acknowledge that history appear unprepared to remedy it.

"I couldn't agree more that there was redlining, exclusionary zoning — there's a lot of ills," said Mayor Mary Marvin of Bronxville, in Westchester, in an interview recently. "But I just think this plan is a disaster. We are so darn built out." Ms. Marvin said she would be open to building some "work force housing" to help police officers and teachers live in the community.

Whether they like it or not, New York officials fighting to maintain these exclusionary housing policies are on the wrong side of history, defending zoning laws written to keep Black, Hispanic, Jewish, Asian and other Americans from sharing in the prosperity and opportunity of the country's suburbs.

Governor Hochul and the many state legislators who are serious about addressing the housing crisis have a legacy-making chance to push hard to dismantle these policies. Millions of New Yorkers are counting on them.

Why authorities must expand deposit protections to restore confidence in banks

Over the past two weeks, we have seen the Federal Reserve, Treasury Department and Federal Deposit Insurance Corporation step in to guarantee all deposits at two banks and coordinate additional deposits at a third. This was sound policy, but further action is needed if the U.S. regional and specialist banking model is going to survive. That's why Treasury Secretary Janet L. Yellen's comments Tuesday that the U.S. government will back deposits at smaller American banks, if needed, are a move in the right

In the aftermath of the 2008 financial crisis, my mantra as president of Barclays was: How do we balance making banks safer and sounder, while also driving economic growth and job creation?

Asking myself this same question today, I see an obvious course of action: Restore confidence and stability in regional and specialist banks by expanding federal deposit protections and ensuring adequate regulatory supervision. This would do much to stem the flow of deposits out of these institutions and into the large banks, allowing well-run banks to thrive and providing security for U.S. depositors.

It is not simply a question of supporting banks, but of supporting consumers, small businesses and homeowners across the country. Smaller banks have knowledge and expertise that their larger peers do not. They are intimately familiar with the economic conditions and needs of their customers in specific regions or industries. A regional bank in a rural area might be more willing to lend to farms and agricultural businesses than a larger national

bank that might not have the same understanding of the local economy. In fact, roughly 40 percent of bank lending in the United States comes from those outside the largest 25 institutions.

Regional and specialist banks also play an important role in supporting small and medium-size businesses. These businesses often have difficulty obtaining financing from larger banks, which tend to focus on larger, more established corporations. Smaller, more focused banks, on the other hand, are more likely to lend to small businesses and are able to do so at a significantly lower cost. In addition to providing loans, regional banks can offer services tailored to the needs of small businesses, such as payroll processing and merchant services. By providing this critical support to small businesses, regional and specialist banks help to drive job growth and support local economies.

Critics will point to the potential consequences of deposit concentration risk. If a large depositor or group of depositors were to withdraw its funds from a smaller bank, it could cause a liquidity crisis and put the bank at risk of failure. Even if the bank does not fail, the sudden loss of deposits could severely limit its lending capacity, hurting the local economy and potentially leading to a decline in property values.

These risks are not new and have been effectively addressed by policymakers in the past. Expanding deposit protections would do much to mitigate the worst risks in the near term. Furthermore, the question of deposit concentration within individual banks must be weighed against the risks of concentration across the banking sector as a whole. After 2008, roughly half of all American deposits were held in just five big banks. This is an already remarkably high level of concentration, the result of consolidation in the industry that left depositors with fewer banks to choose from. Without coordinated policy action, there will be even less choice, and the share of

deposits held in just a handful of banks will rise further.

Were that to happen, the regional and specialist banking model in the United States would effectively be dead, with thousands of jobs lost and consumers, small businesses and savers left with a banking oligopoly unable to cater to their needs or give them the same attention and support.

What is to be done? Americans might forget that the reason we have so many banks is that we have deposit insurance. But at present, the \$250,000 FDIC cap on insured deposits is too low. At the very least, this cap should be raised considerably, and the specific guarantees given to depositors at Silicon Valley Bank and Signature Bank should be extended to other small and medium-size

The most effective option, however, would be for federal regulators to extend FDIC insurance to all deposits, at least temporarily. This would be in line with the recommendation made last week by a coalition of midsize banks.

It is important to keep in mind that such a policy would be funded by FDIC-regulated banks, not the taxpayer. Creditors, shareholders and company management would not be bailed out or enjoy any additional protections. The rigors of the market would remain in place.

This is a very different situation from the one in 2008. Banks have faced significantly more restrictive capital and regulatory actions and have increasingly become more and more like utilities. This was underlined during the pandemic, when banks effectively acted as agents of government fiscal support. Extending existing deposit insurance reflects this changed status and does so while allowing banks to fail without putting depositors at risk.







Downey holds on to beat Warren, 7-6

■ Trailing 5-0, Warren scored four runs in the fifth inning but fell short as Downey pulled away, 7-6.

DOWNEY — No matter what sport, it's just Downey-Warren. In one of the best rivalries in any sport in California, the intensity is ramped up when these two Downey teams meet.

Separated by only a few blocks, anything goes in this neighborly meeting

Monday March 20 was the latest chapter when the Bears and Vikings met in an early Suburban Valley Conference, Gateway League baseball game at Warren high.

Downey, with an early 5-0 lead, held on to defeat Warren, 7-6, in the first of three meetings between the two schools in league action. They met for game number two Thursday March 23. (Results were unavailable at press time).

"Winning league games are always good," Downey Baseball coach Jess Gonzalez said. "A win is a win. Our guys figured it out."

With the win, Downey improves to 7-6 overall and 2-2 in league in third place behind La Mirada (3-0) and Gahr (2-0). Warren is 8-4 overall and 0-2 in league.

A call by the umpire in the bottom of the seventh hurt Warren's chances to rally a second time..

A walk to senior first baseman Julian Angulo opened the inning. He moved to second on a single by sophomore designated hitter Brandon Ibarra. His brother, junior Marco Ibarra followed with a single to left field, potentially driving in Angulo.

Angulo was stopped rounding third by base coach Jose Nava, but Angulo grazed him on the way back to the base. After the Downey shortstop noticed that Angulo had grazed Nava, the umpires ruled him out and the first threat was squashed.

"I was rounding third hard and tried to put the brakes on and tried to stop myself and grazed coach," said Angulo, of the play. "It just

happened."

With Brandon Ibarra on second and Marco Ibarra on first, Brandon scored the sixth run from second on a failed back pick to first base by the Vikings catcher.

The Bears still had a chance to tie the game, loading up the bases a second time on a walk and hit batter, but a strikeout ended the

"That was a wild game," said Warren Baseball coach Scott Pearson, of the comeback and unfortunate ending.

Leading the way for Downey was senior shortstop Aaron Torres (2 for 3) and senior center fielder Matthew Garcia (2 for 3). Both players had an RBI.

Warren was led by junior third baseman Marco Ibarra (3 for 4) with a three-run home run, three RBIs and one run scored, while freshman right fielder Jayden Lujan was 2 for 3.

Warren had a chance to take an early, 1-0 lead in the first inning as leadoff hitter Branden Lepe singled and was sacrificed to second by Angulo but was left stranded.

Downey scored five early runs in the second inning, as the Bears committed a couple of errors and a wild pitch, leading to a 5-0 lead.

In the inning, senior right fielder Armando Sanchez led off with a walk by Warren starting pitcher Angel Cervantes, followed by a single by junior first baseman Ricardo Cortez.

Sanchez eventually scored the first run, followed by four more runs on three singles (Cortez, Matthew Garcia and Torres). Torres, who scored the fifth run on a fielding error by the Warren third baseman, also had an RBI single.

"I had to get out of the inning," said Cervantes of the five-runs by Downey. "I had to eliminate the walks."

Warren came back with a single run in the bottom of the third inning when senior outfielder Joaquin Gonzalez walked to open the inning, stole second and went to third on a wild pitch by Downey starter Michael Reyes.

Gonzalez came home with the

run on a sacrifice fly to center field by Angulo to trail, 5-1. Warren had two runners on in the inning but failed to score.

Reyes, who got the win, meanwhile had allowed only three hits through the first four innings before the Bears scored four in the fifth to tie the game, 5-5.

In that fifth inning for Warren, it only took two big swings of the bat to tie the game.

Angulo opened the inning with a solo home run, followed by a walk to Cervantes and Brandon Ibarra reached on catchers interference. That brought up his brother Marco Ibarra, who connected with a three-run tying home run to put new life into the Bears.

"We were down early and were still confident to get something going," said Angulo of the comeback.

After the home run by Marco Ibarra, senior shortstop Gabriel Lizarraga and Lujan both singled, but did not score.

"I knew that at least I had to get a hit," Marco Ibarra said. "He gave me a cookie and I hit it to left center. The more you hit, the more you hit."

Ibarra was referring to comments always made by his coaches.

"If you put in the work, you see the results," he added.

Cervantes added of the four-run comeback to tie the game by the Bears, "That was a big bounce back, especially by my team," he added. "They were hyped and still came up short."

Downey broke the 5-5 tie in the top of the sixth inning after Cortez was hit by a pitch to open the inning. Maddox Reyes pinch ran for Cortez, and scored on an RBI single by Matthew Garcia to break the tie with the sixth run.

Downey had 14th hottest real estate market of 2022

DOWNEY — Among all small U.S. cities, Downey had the 14th hottest real estate market of 2022, according to a report released Monday.

The report from Construction Coverage revealed that nearly 62% of Downey homes sold in 2022 closed above asking price.

The median sales price was \$798,509 and the median number of days on market was 33.1.

Only 18.3 percent of home listings in Downey saw a price reduction.

Downey's success in the real estate market comes despite rising interest rates and concerns about inflation.

Home prices exploded during the COVID-19 pandemic while interest rates were low, household savings and investment returns were high, and more people were spending time at home.

Construction Coverage compiled its report using data from Redfin's Data Center. To determine the locations that had the hottest real estate markets of 2022, researchers at Construction Coverage created a composite score, equally weighting the following metrics:

One-year change in median sale price (Dec 2021–Dec 2022)

Share of homes that sold above asking (2022)

Median number of days on the market (2022)

Average sale-to-list percentage (2022)

Share of listings with price drops (2022)

To improve relevance, only cities with at least 100,000 residents were included, and cities were grouped into cohorts based on population size: small (100,000-149,999), midsize (150,000-349,999), and large (350,000 or more).

Paging Dr. Frischer...

Like many of our mothers, I find myself telling my patients to eat more vegetables.



prevent some types of cancer, lower the risk of eye and digestive problems, keep our appetites in check filling us with high fiber foods, and lower our blood sugar.

Although all vegetables contain vitamins, minerals, and dietary fiber, and are low in calories as well, they differ. Let's take a look at a few.

Spinach happens to be my personal favorite. (Insert Popeye joke of your choice.) I eat it every day, in salads, sandwiches, pasta, scrambled eggs, soups, and particularly in my morning smoothie (read on for my recipe!). It is a great source of calcium, vitamins, iron, and antioxidants, and benefits the heart by lowering blood pressure. For those who are lactose intolerant and avoid dairy, it's a great alternate source for calcium

Kale has become very popular. Growing up, I remember it only as decoration on deli platters! It is a dark leafy green vegetable that is rich in vitamins A, C, and K. It can help to lower cholesterol, with some studies showing up to 10% in reduction of "bad" LDL, and a 27% increase in "good" HDL. It can lower blood pressure and blood sugar levels. Kale is great in pasta dishes, salads, smoothies, soups, kale chips, and sandwiches.

Broccoli contains the full daily requirement of vitamin K, and twice the daily recommended amount of vitamin C, in just one cup. There is evidence in animal research that chemicals found in cruciferous vegetables like broccoli can inhibit the development of some cancers, including bladder, breast, liver, and stomach. Try roasting, steaming, frying, blending into soups, throwing into salads...or just dip it raw.

Cauliflower is another cruciferous vegetable, containing plenty of vitamins C and K, fiber and antioxidants. Eat it baked or raw, buy it riced, or make a pizza crust.

Sweet potatoes are root vegetables. When baked in its skin, a medium sweet potato contains some 100 calories with almost no fat, more than a day's requirement of vitamins A, C, and B6, as well as potassium and beta carotene (for the eyes). They are great for diabetics because they are low on the glycemic index, and are rich in fiber. They can be eaten by simply baking them in the skin or roasting them in olive oil with a little salt and pepper.

Beets are also root vegetables, and contain potassium and folate. They are rich in nitrates, and can improve heart health and lower blood pressure. They contain antioxidants, which (among other things) may help to control diabetes. They can be roasted, juiced, or added to salads and sandwiches.

Carrots are so easy. A cup contains over four times the daily requirement of vitamin A (for healthy eyesight). Nutrients found in carrots are associated with a reduced risk of breast cancer. Carrots can be thrown into casseroles, soups, and stews; eaten raw by themselves or in salads; dipped in hummus or ranch dressing; or juiced.

Tomatoes are technically a fruit, yet most of us treat them as vegetables. They contain potassium, vitamin C, and lycopene, an antioxidant which may to help prevent prostate cancer. Other antioxidants in tomatoes, such as lutein and zeaxanthin, may reduce the risk of macular degeneration. They can be eaten raw or cooked, in soups and stews, and of course, in sandwiches.

Peas are sweet and starchy. They are rich in fiber protein, as well as vitamins A, C, K, and B, and saponins, which may help to fight cancer. Try keeping a bag of frozen peas on hand to be tossed into pasta, risotto, soups, and curry

Onions are closely related to chives, garlic, and leeks. They contain vitamin C and B6, and manganese. They are easy to incorporate into soups, stews, stir fry dishes, and curries. When raw they are extremely high in antioxidants.

Garlic is used in cooking, and in medicine as well. Although it is low in vitamins and minerals, it may have natural antibiotic capabilities. It can be eaten raw, cooked, broiled, or added to so many

Bell peppers are mostly green, yellow, orange, or red (green bell peppers are the least ripe and the most bitter, and red are the sweetest). They are rich in vitamins C and B6, folate, beta carotene, antioxidants, ascorbic acid, flavonoids, and carotenoids. Try them in pasta, scrambled eggs, and salads; or dipped in hummus or guacamole.

Seaweed is a sea vegetable and includes kelp, nori, sea lettuce, spirulina, and wakame. It has omega-3 fatty acids, which lower cholesterol and help to prevent stroke and heart attack; and iodine, antioxidants, and chlorophyll (an anti-inflammatory). I eat seaweed in sushi, miso soup, plain, and in salads.

Fermenting vegetables adds probiotics to our diets. Probiotics are beneficial bacteria that improve gut health, reduce symptoms of irritable bowel syndrome, and may help to prevent bowel infections. Cabbage turns into sauerkraut when fermented, and cucumbers, carrots, and cauliflower can be pickled. Add them to salads and sandwiches, or eat them as side dishes.

There are so many vegetables to choose from - I urge you to pick your favorites and eat them daily. My morning smoothie recipe? Blend together a very generous handful of baby spinach, four ice cubes, a handful of fresh or frozen blueberries, a half of a fresh or frozen banana, a heaping teaspoon of plain Greek yogurt, another heaping teaspoon of peanut butter, a third of a medium avocado, a splash of any kind of milk or milk substitute, and my "secret" ingredient: a half dozen semi-sweet chocolate chips. Bon appétit!

OPINION: No blank checks for non-profits

DOWNEY — The Downey YMCA and the Columbia Memorial Space Center are both preparing to start significant projects in the construction of a brand-new facility and the Inspiration expansion, respectively.

Both projects will be costly. Both have their merits. Both should be prioritized.

But when the Downey Y Board approached the city council last month to ask for assistance, something strange happened.

They were pitted against one another.

No one will argue the benefits and services that both the YMCA and the Columbia Memorial Space Center bring to the City of Downey. The proof is in the pudding.

The Y offers countless programs for the young, the old, and those in between. Be it through swim lessons, use of the fitness $facilities,\, camps,\, after\text{-}school$ child care, the Easter Caravan, scholarships, or any of its other community outreach, you'd be hard-pressed to find someone in Downey who hasn't been touched by the Y in some shape or form.

The nationally recognized memorial to the Columbia Shuttle disaster, the CMSC has established itself as a STEM hub; you need only look at its popular Girls in STEM program, attend the crowded Rocket Fever Festival, measure the wide footprint of City of STEM, or take note of the many busloads of kids on field trips (even beyond Downey Unified) to see that

The thing is, when considering their respective projects, it's apples and oranges.

First and foremost, the Columbia Memorial is a publiclyowned building and organization, as opposed to Downey YMCA which is privately owned by YMCA

of Metropolitan Los Angeles.

It makes natural and logical sense for the city to provide funding towards the Space Center and its projects, as it does so already as part of its yearly fiscal budget.

Beyond that, a majority of the CMSC's already procured fundraising has an expiration date.

The city has raised around \$11 million so far, and will likely need more than double that before the project's conclusion, per comments made by Mayor Claudia M. Frometa at the last council

The largest single chunk of that change, according to CMSC Director Ben Dickow, comes from a 2019 state budget allotment, which requires it be used by March

It's a use it or lose it scenario.

The Y in comparison has a conservative \$10 and a half million of the over \$14 million (potentially as much as \$18 million) it will need either pledged or in the bank, according to Board member Steve Roberson. Part of those funds came from former Assemblywoman Cristina Garcia, who pledged \$3 million, which must be spent by Jan. 31, 2025.

Still, if the city is worried that helping fund the new Y facility will set a precedent, they need not worry about doing so.

It's already there.

In September last year, the City Council agreed to donate \$30,000 to The Downey Rose Float Association. At the time, the sum was said to have been enough to "cover the cost of flowers" alone that year.

It wasn't a particularly difficult decision for the council; in fact, it was approved unanimously, and even discussed to potentially be a recurring expense added to the yearly budget.

Ultimately, the city council needs to make up its mind: does it want to fund non-city projects from nonprofits and service organizations, or not?

If the answer is yes, then it should still do so in a responsible, organized manner.

Budget out some sort of grant each year. Have each organization apply for what they need, and divvy out accordingly.

If the city council does not want to go that route, then they need to find creative ways to show their support indirectly, as they have done so before.

The city has traditionally waived fees, provided space, offered police support, etc., for groups who were putting on fundraisers and / or events.

For example, The Downey Symphony, The Downey Arts Coalition, and Downey Rose Float are all considered "legacy groups" at the Downey Theatre - receiving rental credits, stage availability, and other benefits - saving them thousands of dollars.

The city of Downey is fortunate enough that there are many service organizations and nonprofits who serve the community, and the city council is right in their desire to show their support in any way they

However, it needs to be done frugally and responsibly, and it should never come at the expense of the city's own facilities and programming.






