of the Downey Symphony Orchestra will also feature Marichitlan!, a work by Juan Pablo Contreras, and a Giovanni Santos world premiere. Both composers will be present.

"We'll open," said director and conductor Sharon, "with Andalusian Spanish composer Manuel de Falla's Ritual Fire Dance from El Amor Brujo."

With incantatory rhythm, a young Andalusian gypsy girl dances around the campfire at midnight with the ghost of her dead husband, whirling faster and faster to cast off his spell.

Marichitlan! brings the New World to the stage. **Composer Juan Pablo** Contreras is the youngest Mexican classical music composer to be nominated

for a Latin Grammy Award, and Juan Pablo will be in the house that evening. Hearing Marichitlan! (Mariachiland) is like being in a Mariachi Plaza with multiple mariachis interrupting each other and competing to win over the crowd.

"I wanted to celebrate my Mexican heritage," said Juan Pablo, "with a very positive and vibrant orchestral work, and felt that mariachi music was the perfect source of inspiration to do so. Mariachitlán is my favorite work in my catalog, and it is the best representation of who I am as a composer. It's an orchestral homage to my birthplace, the Mexican state of Jalisco, where mariachi music originated"

"Juan Pablo was a student of mine," said Sharon, "at USC Thornton School of Music, in my graduate instrumental conducting class. That's where we first met, and we've been friends and colleagues ever since."

Danzon! the next piece, by Arturo Márquez, born in Álamos, Sonora, is one of the most popular Mexican contemporary classical music compositions. The dance style named danzón has its origins in Cuba, with African origins, but is a very important part of the folklore of the Mexican state of Veracruz.

Similar to a tango, the

Mexican danzón has the syncopated rhythms and melancholy melodies. Composer Márquez wrote Danzon No. 2 for full orchestra, and the piece features solos for clarinet, oboe, piano, violin, double bass, French horn, trumpet, flute, and piccolo. Each instrument is highlighted with solo lines. After the intermission

orchestral suite based on lively Spanish folk melodies, will complete the program.

The Mahler songs will be sung by baritone Anthony Moreno, who is of Spanish Portuguese descent.

"I've always wanted to perform these Rückert Lieder," said Sharon, "so when Anthony suggested them, I was thrilled.

In Capriccio Español, Russian composer Nikolai Rimsky-Korsakov lets the whole orchestra contribute to recreating the Spanish countryside. In the alboradas (dawn songs) we hear the promise of heat later in the day, in blistering solos by the clarinet and violin, with tambourine and snare drum.

For the finale, Rimsky-Korsakov turns to the fandango, the most widespread of the Spanish dances. Every section of the orchestra takes its turn leading the dance famous for its sensuality before finishing in a riotous whirl of colors.



Titan Tow awarded police contract

DOWNEY — The city of Downey approved on Tuesday a three-year, non-exclusive franchise agreement with Titan Towing for its transportation and storage services.

Per the terms of the contract, Titan will pay the city a franchise fee equal to 20% of its gross revenues attributable to towing, storage, and impound services provided pursuant to the agreement with the city for vehicles towed, stored, or impounded when a storage form has been completed and a department case number has been essigned.

According to a report presented by Downey Police Chief Leslie Murray, the police impound approximately 1,300 vehicles a year, typically for parking in no stopping zones, expired registration over six months, five or more unpaid parking citations, arrest of driver (when necessary), and for evidence when the vehicle is involved in a crime.

Upon graduation from Compton J.C. she was employed at Alcoa from 1942 to 1950.


Ruth met and married William B. Rollins, Jr. in 1947. They settled in Compton and Bill began his educational career. They soon started their family and moved to Downey in 1952.

Margaret Jane Chelling October 15, 1923 - March 7, 2023



She was also named First Runner Up in the Miss Red Wing Pageant She played Lisa Doolittle in My Fair Lady and could recite lines with

a perfect cockney accent throughout her life. Jane left Minnesota and drove to Los Angeles with her family as a young lady during World War II. Mom supported her nation working at the Douglas Aircraft Company during the war. She became a teacher and shortly after coming to Los Angeles met a fellow Minnesotan, Edward, a U.S. Army Air Forces crewman, at the Hollywood Palladium. Jane married Edward shortly after the war and raised a family of six children. She enjoyed traveling with Edward and the family, was a Dodgers and Lakers fan and was an active member of St. Pius X and Our Lady of Perpetual Help parishes. What's wrong with drag queens?

A friend on Facebook posted a picture of Bob Hope in drag, entertaining the troops. No Republican legislators in sight. No protests. No problem.

Comedian Melissa McCarthy is right. In a viral post, she defended drag queens. Why not? We've all been entertained by drag shows all our lives.

Why all of a sudden is this a national danger deserving of legislative action?

The answer is not that children need protection from RuPaul.

It's about how you play wedge politics, how you find issues that divide people. That's what the culture wars are all about. It's not a matter of solving the nation's most pressing problems. It's about dividing people along ideological lines and using conscious and unconscious bias for political benefit. That's what is going on here, and it is for sure a dangerous game, not because drag queens are dangerous but because playing politics with prejudice is.

Drag queens pose no bigger threat to our communities than transgender women in sports do. These are issues right-wing extremists have gotten hold of because they work politically, not because they've suddenly taken an interest in women's sports or children's story hours, much less because there's some crisis demanding attention in these arenas.

But it's an effort whose impact is not limited to cross-dressing entertainers or competitive women athletes.

Wikipedia defines a drag queen as "a person, usually male, who uses drag clothing and makeup to imitate and often exaggerate female gender signifiers and gender roles for entertainment purposes. Historically, drag queens have usually been gay men, and part of gay culture."

Banning drag shows, as Tennessee has now led the nation in doing, is banning what has been a part of gay culture and entertainment for decades. It is not a "neutral" act. It is plainly discriminatory along gender lines, and it raises all kinds of gender issues.

Activists are right to see such efforts as the tip of the iceberg of discrimination and to be concerned about the message that is being sent. Because there is indeed a message that is intended — a message about who and what is acceptable and tolerable, and who will not be accepted and tolerated.

Because it's not just about drag queens. It's about recognizing and accepting people who are different and about taking on gender roles rather than being bound by them. Drag queens make us laugh as they take on gender issues. They explode stereotypes. They use laughter as a weapon against ignorance. It's not just about falsies

and fancy makeup. They challenge us at every level. We laugh with them, at ourselves. "La Cage Aux Folles." Acceptance is the ultimate act.

And it's not just about transgender athletes who are being banned. It's also about recognizing that not everyone fits squarely into the binary system, that human sexuality takes more forms than traditional heterosexuality. It's about acceptance as opposed to rejection.

Drag shows are, at their core, political speech in the sense that they challenge our perception of gender and gender roles and force us to reexamine familiar stereotypes even as we laugh at the exaggerated representations of femininity. To prohibit them is to send a message that gender roles are sacrosanct and cannot be challenged. That is the iceberg. Drag shows are the tip.

This country is failing its children

The formal clothes of children are endearing. Take a suit or a dress and shrink it down to a size appropriate for elementary school kids and the cuteness factor is undeniable. This is because we all know that ties, button-down shirts and stately dresses are not really the province of the young. Children belong in things that can get dirty, splashed by mud or ripped by sliding into second base or tussling with a classmate.

But tiny caskets? Of course, we revolt. Death is not supposed to visit the lives of our daughters in pigtails or stalk our sons who still have gaps in their teeth.

The parents of three young children at the Covenant School in Nashville now have to choose final outfits and caskets for their children because a shooter entered a school with assault-style rifles and a handgun.

The killer, who also took the lives of three adults at the school, was another in a long line of murderers whose ideologies vary as much as the objects of their violence: Asians, African Americans, Black church attendees, members of the L.G.B.T.Q. community, former classmates, moviegoers, grocery shoppers and Christian school students and staff. The one thing that unites these killers is the easy access they had to weapons, owing to the laws that exist in our republic.

There are many ways to judge the success or failure of a country. We can look at its economy, the strength of its military or the quality of its education. We can examine the soundness of our bridges or the smoothness of our highways. But what if we used a different standard? We should judge a nation by a simple metric: the number of weeping parents it allows, the small caskets it tolerates.

The debate around gun control is not new, of course, and each tragedy brings a fresh wave of calls for common sense gun regulation. The adversaries of reform will rebuke us for turning a tragedy, the deaths of six innocent people, into an occasion to debate politics. We will be urged to offer prayers for the victims and their families while we await the appropriate time to discuss the more difficult issues. But too often it seems that rather than waiting for the right time, politicians are simply trying to wait out the news cycle

I am a son of the Black church, so I am well versed in such delaying tactics. We have not had the luxury of time to mourn. When domestic terrorists bombed the 16th Street Baptist Church in Birmingham, Ala., in 1963, murdering four of our little girls, Martin Luther King Jr. used the eulogy he delivered in the presence of the children's caskets to challenge the church and the government to change.

He said: "These children — unoffending, innocent, and beautiful — were the victims of one of the most vicious and tragic crimes ever perpetrated against humanity. And yet they died nobly. They are the martyred heroines of a holy crusade for freedom and human dignity. And so this afternoon in a real sense they have something to say to each of us in their death. They have something to say to every minister of the gospel who has remained silent behind the safe security of stained-glass windows. They have something to say to every politician."

The deaths of the children spoke to the state of anti-Blackness in America. In death, their blood cried out for justice and transformation. Similarly, every single young body riddled with bullets from guns that we could control preaches a sermon. They issue a word of condemnation, a Jeremiad.

Do not misunderstand: I believe in the power of prayer. But the Christian response can't be limited to it. That assumes that all activity on behalf of the innocent lies in the hands of the almighty when the Christian Scriptures themselves suggest that God will judge us according to how we treat the most vulnerable. We should not be accountable for only the fervency of our intercession but also for the relentlessness of our actions.

Taylor Schumann is a shooting survivor, wife, mom, Christian and advocate for gun reform. The author of the book "When Thoughts and Prayers Aren't Enough: A Shooting Survivor's Journey Into the Realities of Gun Violence," she says that some people who resist gun reform do so out of fear, but they are looking at it the wrong way. "The desire for gun control does not come from a place of wanting to take away something, but rather to save something else: fellow human beings," she told me. "We've tried so many things to reduce gun violence, everything except widespread gun reform. If there were another way to do it, I believe we would've found it by now." Ms. Schumann is right. We have not found another answer and so we are left with a question, which is: Whom do we love more, our guns or our children?

My wife and I had occasion to visit Edinburgh, Scotland, last summer. Strolling along its cobbled roads, we wandered into one of the many old churches. Carved into the cool stone walls were names of those long dead.

All that we could know about them was the year of their birth and the day of their passing. The life that took place in the middle was lost to history. We noticed that a few lived very brief lives, dying as children. My wife and I wondered what had befallen them — illness, accident or some other tragedy? The disquiet around the death of the young echoes through the centuries.

Years from now, when those of us alive today have gone the way of all flesh, others will wander through our graveyards. They will see the waves of tombstones commemorating children with not enough years between the first number and the last. But unlike those children in Scotland, the cause of those tragedies will not be a mystery. The undeniable testimony of our actions will be that our children kept dying because some of us did not love them enough.

How to save patients money by ending one type of insurance coverage

Even if they have health insurance, Americans routinely face surprisingly high charges at the pharmacy counter. A radicalsounding solution would drastically curtail this experience and save billions of dollars in the bargain: End insurance coverage for low-cost generic drugs, which represent on percent of all prescriptions.

These medicines, which are identical copies of brand-name drugs whose patent protection has expired, can be profitably produced at a 99 percent discount from the brand-name price.

This explains why generics account for only 18 percent of total drug spending. What's more their average price has been falling, from

billions of dollars in the bargain: End insurance coverage for low-cost generic drugs, which represent 90 percent of all prescriptions.

Spending. What's more, their average price has been falling, from \$22 in 2009 to \$17 in 2018.

Yet insurance coverage has enabled middlemen to feast on billions of these prescriptions each year, keeping prices higher than they need to be. Consumers see the result in a crazy-quilt of price

tags that vary from pharmacy to pharmacy and in insurance copayments that often exceed the entire retail price of the drugs.

In 2018, Medicare paid 21 percent — \$2.6 billion — more for generics than their cash prices at Costco, our research found. And

Health insurance once made essential medicines affordable and,

for expensive brand-name drugs that can treat cancer or control

rare diseases, it still does. But as insurance and intermediary

practices have evolved, they have made generics pricier.

Eliminating insurance for generics might make patients nervous at first, but the payoff would be stable and affordable prices. An opaque, profit-generating structure that provides no value for patients would be stripped away. Premiums could be reduced to

that was for just 184 of the most common generic drugs.

account for the narrower coverage that results.

Insurance provides real value only when there is the chance of substantial loss, and that isn't the case with cheap generics. A good analogy is auto insurance. A typical car-insurance plan doesn't cover oil changes, because they are predictable and inexpensive. As a result, they are readily available from mechanics and express oil shops, and prices are transparent, comparable and kept low by competition. But car insurance is needed when accidents happen and repairs are expensive. In medicine, the insurance extends down to the equivalent of the oil change, making something that should be simple and cheap complicated and more expensive.

Insurance companies stay in the generics game through subsidiaries called pharmacy benefit managers. PBMs are middlemen that manage drug benefits for health insurers, employers, unions and government entities, and they contract with pharmacies to deliver the drugs to beneficiaries. PBMs capture profits from each prescription sold, and this artificially raises the costs of generic drugs. Their contracts commonly require pharmacies to give the PBM their lowest price when accepting

reimbursement for a prescription. As a result, most pharmacies are careful to set cash prices higher than their negotiated PBM rates, which means they don't offer competitive cash prices to customers at the counter.

What's worse, PBMs sometimes take money directly from patients. Commercially insured patients' co-payments for generic prescriptions exceed the total cost of the medicine 28 percent of the time, a practice known as a "copay clawback," a USC Schaeffer Center study found. PBMs can also reimburse a pharmacy one price while charging health plans a higher one and pocket the difference, a tactic known as "spread pricing." They also control formularies — the lists of drugs that their clients will cover — which can exclude cheap generics if higher priced brand-name drugs provide more room for PBM profits.

All these practices subvert the Hatch-Waxman Act, a 1984 bipartisan law that jump-started production of low-cost generics. Rep. Henry Waxman (D-Calif.) and Sen. Orrin Hatch (R-Utah) brought drug industry leaders together to agree on a strategy to provide brand-name drug makers longer monopolies (to encourage innovation) while giving generic drug makers an abbreviated approval process (to encourage access and affordability). Now, a market that is being gamed to inflate generic prices threatens that

Cash-only pharmacies such as Blueberry Pharmacy and Mark Cuban's Cost Plus Drug Company are already demonstrating the benefits of cutting out the middlemen in generic drug sales. But to establish a truly robust and transparent cash market in which consumers could decide whether to fill their prescriptions using insurance or cash, pharmacies nationwide would need to be protected against retaliation from PBMs. An important first step is to outlaw the anticompetitive "best price" contracts that PBMs impose on pharmacies and that keep them from offering competitive cash prices.

Saying goodbye to insurance for generic drugs might also mean that pharmacies would need to establish new systems to track prescriptions to check for drug interactions and other elements of care coordination. But the cost and difficulty of such efforts on behalf of patient safety are minuscule compared with the needless expense of middleman profiteering involved in generic sales today.



Warren stays in first place with 3-0 win over Downey

DOWNEY — In the early going of the Gateway League action for boys volleyball, it looks like a Downey-Warren show until the showdown in the last match of the

Coming into Tuesday's match, both teams were undefeated in league with 3-0 records. The nearest teams in the standings (Lynwood, Paramount and Dominguez) all had a combined three league wins between them.

Downey tax preparer pleads guilty to filing false returns

DOWNEY — An Orange County man pleaded guilty last week to knowingly preparing nearly 400 fraudulent federal income tax returns that caused a loss of more than \$750,000 to the IRS by inflating his clients' tax refunds without their knowledge and then pocketing the difference between the clients' true refunds and the inflated ones.

Raudel Sandoval, 48, of Placentia, pleaded guilty to two counts of aiding and assisting in the preparation of false and fraudulent tax returns.

According to his plea agreement, Sandoval is a licensed tax preparer and owns RSE Sandoval España Inc., a Downey-based tax preparation company. Sandoval willfully prepared hundreds of false federal and state income tax returns for clients for the tax years 2015 through 2018. On these returns, he claimed false or inflated amounts of the child tax credit, business losses, short-term capital losses and other items to which the taxpayer clients were not entitled.

Sandoval falsified the tax returns with deductions and credits that his clients did not incur or had not informed him about. He also inflated the amounts of deductions and credits that his clients were entitled to claim.

When he finished preparing a tax return, Sandoval gave his clients copies of their returns that were true and correct, but falsely told them that he would file their true-and-correct copies with the IRS on their behalf.

Then, Sandoval inflated his clients' returns with false and fraudulent deductions and credits and filed these false tax returns with the IRS. The false returns showed a larger refund than on the true-and-correct copies Sandoval had given to his clients.

Sandoval then directed the inflated refunds to himself. He did so by changing the bank account and routing numbers on the filed returns to a bank account he controlled. Sandoval controlled more than 100 bank accounts with several different banks and opened many of the accounts in his clients' names. But he was the accounts' only authorized signor. Several of the Sandoval-owned bank accounts had the name "Federal Tax Refund Processing.

Sandoval directed the IRS to send the inflated refunds through a thirdparty refund processor to be deposited into an account he controlled. Other times, he caused the IRS to mail a check of the inflated refund to his business address. He then would deposit the check into one of his accounts.

After receiving the inflated refund, Sandoval transferred a portion of it - the amount his clients were expecting to receive based on the true-andcorrect tax return copies - to one of his "Federal Tax Refund Processing" accounts. Sandoval then transferred that money to his clients' bank accounts, causing them to believe their refunds were from a legitimate government source.

Sandoval kept the difference between the true refund and the inflated refund.

For the tax years 2015 through 2018, Sandoval willfully understated his clients' tax liabilities and caused a loss of \$758,550 to the IRS, caused by the filing of at least 389 fraudulent income tax returns.

United States District Judge Sherilyn Peace Garnett scheduled a September 6 sentencing hearing, at which time Sandoval will face a statutory maximum sentence of three years in federal prison for each

IRS Criminal Investigation investigated this matter.

Arrival of spring also brings allergy season

For many people, as spring arrived on Monday, March 20, it brought feelings of renewal, new beginnings, budding leaves, blooming flowers, and – yes – those dreadful allergies!

Except for this year, experts say allergy season actually arrived earlier than expected and will only intensify. That's primarily due to the wet, rainy weather Southern California is experiencing, resulting in more vegetation and consequently - more pollen.

"It appears that more people are already struggling with their allergies," said Dr. Salima Thobani, an allergy, asthma and immunology physician with Kaiser Permanente Southern California. "Things are likely to get worse before they get better, mainly due to the weather conditions we've experienced that have resulted in more pollen in the air."

According to the Asthma and Allergy Foundation of America, more than 50 million Americans experience various types of allergies each year. Additionally, allergies are the sixth leading cause of chronic illness in the U.S.

With the arrival of spring, Dr. Thobani noted allergies are likely to increase as the weather gets warmer and drier. That's because trees, grasses and weeds will release tiny grains into the air to fertilize other plants, and as we breathe them in, those who have allergies are likely to suffer, she explained.

According to Dr. Thobani, symptoms of seasonal allergies include:

- Runny, stuffy or itchy nose.
- Sneezing.
- Itchy, watery eyes.
- Headache and fatigue.
- Sore throat or coughing.

conditioning system can be helpful.

Dr. Thobani notes you can reduce your allergy symptom and exposure to pollen by:

Limiting the time you spend outside when pollen counts are high (during mid-day and afternoon).

- Rinsing your eyes with cool water or saline eyedrops to remove clinging pollen after you come indoors.
- Keeping your house and car windows closed; using your air
- Wearing a pollen mask or dust mask if you need to mow the lawn or when pollen counts are high.
- Taking a shower and changing your clothes after you work or play outside.

Wearing sunglasses when outdoors to avoid getting pollen Regional Branch on Yale Avenue. in your eyes.

Although there's no cure for seasonal allergies, Dr. Thobani Eduard exposed himself and noted there are several medications, including antihistamines and nasal steroids, which can provide relief and help you breathe a little easier. Over the counter antihistamines that can be effective include loratadine (Claritin), fexofenadine (Allegra), or cetirizine (Zyrtec).

The benefit of these medicines is that they cause less drowsiness compared to other common antihistamines such as diphenhydramine (Benadryl) or chlorpheniramine (Chlortrimeton), she noted.

Dr. Thobani advised those with allergies to take their 24-hour allergy medication before going to bed to maximize the effect when they need it the most. "That's because allergy symptoms – such as a runny nose, weepy eyes and sneezing – typically peak in the morning hours," she explained.

If you have a history of moderate or more severe allergy symptoms, Dr. Thobani recommended that you start a steroid nasal spray and continue it through the allergy season. These medicines are available over the counter without a need for a prescription, and include other crimes. fluticasone (Flonase) or triamcinolone (Nasacort).

Seven CHP officers charged in man's death

■ A registered nurse was also charged in connection with the death of Edward Bronstein in

LOS ANGELES — Seven California Highway Patrol officers and a registered nurse were charged for the 2020 death of a man who was being restrained on the ground and repeatedly said he could not breathe, Los Angeles County District Attorney George Gascón announced in a news conference.

Edward Bronstein, 38, was killed in police custody in March 2020 after officers pulled him over in Los Angeles County after suspecting he was driving under the influence.

Officers obtained a warrant to get a blood sample from Bronstein, who initially resisted but then agreed as officers restrained and was later pronounced dead.

Seven CHP officers were charged Wednesday with one count of involuntary manslaughter and one count of assault by an officer, while the nurse who took a sample of Bronstein's blood was charged with one count of involuntary manslaughter, according to the complaint.

In body camera video released last year as part of a federal lawsuit against CHP and those allegedly involved, Bronstein is heard repeatedly telling officers, "I can't breathe," while pinned on the

Those same three words were echoed by George Floyd less than two months later before he was killed when he was restrained by Minneapolis police in May 2020.

Floyd's

Bronstein became unresponsive police brutality and racial injustices, and individual officers who were on spurring a national reckoning over the way law enforcement treats Black Americans. The officer who killed Floyd, Derek Chauvin, was convicted of murder in April 2021.

> "These officers had a legal duty to Mr. Bronstein," Gascón said. "He was in custody. We believe that they failed their duty and their failure was criminally negligent, causing his death." He added that "police accountability is essential to public safety.'

Bronstein's father, Edward Tapia, said Wednesday he is "glad we came to this point where they can prosecute so they can't hurt nobody else."

The Irvine Police Department said 53-year-old Christopher Eduard was arrested Tuesday for a 2021 case in which he allegedly groped an 11-year-old girl inside a Target store on Jamboree Road.

As of Wednesday night, he remained jailed without bail.

Eduard was initially arrested on March 21 for the alleged sex assault at the OC Library - Heritage Park

In that incident, police said assaulted the 9-year-old after asking her if she could help him film a video.

The 9-year-old was at the library with her mother, who later alerted police. Police said "evidence" was found at his home linking him to

In that case, Eduard is facing charges of child molestation, production of child pornography and false imprisonment of a minor during the production of child pornography.

Meanwhile, investigators believe Eduard is responsible for


