# Library system earns national award

■ The Downey-based L.A. County Library was chosen to receive the 2023 National Medal for Museum and Library Service.

DOWNEY-The Los AngelesCounty Library is one of two Southern California institutions that will be honored this summer with a 2023 National Medal for Museum and Library Service.

It will join the Riverside Art Museum among the eight recipients of the nation's highest honor for museum and library

The medals have been presented for the past 29 years by the Washington, D.C.-based Institute of Museum and Library Services (IMLS) to celebrate institutions that are making a difference for individuals, families and communities.

This year's recipients were selected from among 30 national finalists "that provide dynamic programming and services that exceed expected levels of service," **Institute Director Crosby Kemper** said. "Through their community outreach, these institutions bring about change that touches the lives of individuals and helps communities thrive.

"LA County Library meets the needs of one of the most complex and diverse communities in the nation."

The Downey-based library system, which was founded in 1912, serves more than 3.4 million residents with 86 branches in cities and unincorporated areas throughout the county and a 15-vehicle mobile fleet.

provides culturally responsive and dynamic collections, programs, and services to meet the literacy, information, personal enrichment, and entertainment needs of all residents across Los Angeles County.

"It is a profound and humbling honor to be selected as a winner of the 2023 National Medal for Museum and Library Service from among so many vital cultural institutions across the nation," Library Director Skye Patrick said. "I am proud of our extraordinary team here at LA County Library, who embody outstanding customer service, help make our libraries the welcoming community hubs they are, and routinely inspire residents to learn and grow throughout all stages of their lives.

"We accept this award on behalf of the communities of Los Angeles County that we have the privilege to serve every day by removing barriers to access and increasing equitable opportunities for all."

The awards are usually presented in August, but no date was announced for this year's ceremony.

"IMLS is delighted to announce the eight worthy recipients of the 2023 National Medal for Museum and Library Service, including LA County Library." said IMLS Director Crosby Kemper.

**1794:** The first great naval engagement of the French Revolutionary wars, the Battle of the First of June, was fought between England and France in the Atlantic Ocean.

# At scholarship night, Downey invests in its young people

■ Soroptimists award \$16,000 to students working hard towards their goals.

**DOWNEY** — There's something special about Soroptimist Scholarship Awards programs. It's the smiles of encouragement on the faces of the Soroptimists, who love what they are doing. It's the pride in the eyes of the family members, and the contagious excitement and joy that the award winners share.

On Thursday evening at the Downey Adult School auditorium, Soroptimist International of Downey put together a \$16,000 basket of prizes, from their own fundraising efforts, and from two special community supporters, the Sarofeem family of The Olive Restobar, and Kaiser Foundation.

"Transformation is what Soroptimists hope will happen, when the dollars Soroptimist raises turn into scholarships," said Linda Haines, president and a past governor of Camino Real Region 3. "They are the means for inspiring, educating, and empowering women and children in our community."

Spotted in the gathering were Nancy Swenson, past president of the DUSD Board of Education, and Linda Saldana, also a newly named Woman of Distinction. More SI Downey members, and Cynthia Jarvis, the Camino Real Region Governor-elect from Alhambra also joined in.

Displayed at the podium was a "big" check for \$16,000 to be given out during the evening. After SI Downey and principal of the Downey Adult School Blanca Rochin welcomed the guests, President Linda Haines invited everyone to the buffet. A special churros station was set up for dessert, and I chose mine rolled in cinnamon sugar.

Rebekah Ruswick, Doctor of Education and Downey Unified School District's Director of Special Education Services, gave the keynote speech, intended as advice for the awardees. The Soroptimist

Attributes of Success was Dr. Rebekah's theme, and she began with self-awareness and goalsetting. All the tuition fees in the world can't help you if you don't have perseverance, and productivity as your means to your goal. A strong support system helps, and there was evidence everywhere of that, with mothers and fathers and sisters and brothers there to cheer. Refining your coping skills is what puts a winner over the top, Rebekah said.

The night's awards ranged from the Marvel Dodson Art Scholarship for a talented high school student, named for beloved member Marvel, to the Della Doyle Scholarship, given to a young woman continuing her education in a business-related field. Della Doyle was a founding member of Downey SI, and in the 1950's, the first woman city clerk for the City of Downey.

The Marvel Dodson grants

went to Damian Santoy, Downey High, and Marko Mihajiov, Warren. The Della Doyle prize went to Brianna McDowell.

The Family Sarofeem gave three scholarships each worth \$500, which were allocated among the Vocational and Educational Achievements Awards.

Vocational Scholarship winner Ezra Jiminez from Columbus High School plans to use his prize to become a firefighter in Los Angeles. Elaine Abbigail Barraza from Downey High wants to be an elementary teacher. Other winners were Victoria Elaine Covarrubias, Ruby Garcia, and Fatima Melody Villalobos from Columbus; Jaqueline Lopez, Downey; and Indiel Motton, Warren.

The \$10,000 donated by Kaiser Foundation will go to vocational nurse aspirants Susana Hidor, Sophia Garcia, Nicole Mesa, Jennifer San, and Kyla Scranton.

# Bill would hold car rental companies accountable for overbooking

introduced the "Vehicle Rental Order Obligation Mandate (VROOM) Act," which would require rental car companies who cannot fulfill a confirmed reservation to compensate the customer.

Rental car companies are currently under no obligation to compensate the customer when they cannot fulfill a confirmed reservation, unlike when an airline overbooks.

> "There is nothing more frustrating than getting off a long flight, showing up at the rental car counter and being told the company has no cars for you despite you having a reservation, and they don't owe you a thing," said Garcia. "American consumers are sick and tired of junk fees and broken promises from billion-dollar corporations. The "Vehicle Rental Order Obligation Mandate (VROOM) Act," is a common-sense solution to ensure rental companies don't just take a reservation, but actually hold a

> The bill has been endorsed by Consumer Reports, Public Citizen, Consumer Action, American Economic Liberties Project, and former FTC Chairman Jon Leibowitz.

According to USA Today, car rental companies run out of vehicles almost every day.

About 1 percent of car rentals aren't honored because a car isn't available. Part of the reason is that they accept more reservations than they can handle, anticipating some drivers won't show up.

Another part of the reason is that the car rental industry, unlike many hotels and almost all airlines, still allows you to cancel or miss a reservation without paying a penalty.

**DOWNEY** — It's likely that sometime in the future, Isaac Donado will be asking for your vote; whether it be for Downey's city council or president of the United States remains to be

On the outside, the 17-yearold St. Pius X - St. Matthias graduate seems like a typical, highly-motivated student.

He is a Christian Service Award recipient, having logged the most service hours (over 500) amongst his peers. He interns at JWCH Wesley Health Center. He boxes in his free time. He is a former class president. With graduation now complete, he plans to study political science and law at Loyola Marymount University, with aspirations of becoming a family or immigration lawyer.

But beneath all the achievement lies possibly an even greater passion: a desire for public service.

"I've had that passion since a really young age," said Donado. "My aunt [Daniela Rodriguez] really helped me with that; she would take me to city council meetings, I know she was part of the Rotary Club. So I would go to city events and I kind of got the feel. Starting fourth grade, I got into student government, getting that feel of what government is like."

Donado serves on the city of Downey's Youth Commission. Though his initial application was not selected his sophomore

year, he would come onboard later when an opening became available.

"I got involved; I volunteered for every event that I could," said Donado. "Starting my senior year, I ran for head chair, and I won."

His city involvement undoubtedly won't stop there, as he already has desires for planning commission and beyond.

"I hope to one day run for city council," said Donado.

"I see myself within local government, me giving back. I plan to build myself up within the city, and within the state. I have a crazy dream, one day I

want to become the president."

With such ambitious goals, Donado says he has had a ton of support from his parents.

"I have my mom and my dad; they're such great supporters," said Donado. "I feel like sometimes I have these wild dreams, and they're always like, 'Okay, we'll help you."

He says his mom is his biggest inspiration.

"Both my parents are hardworking, but my mom, in high school, her parents were both immigrants so she kind of had to figure it out on her own," said Donado. "I see my mom and she's stubborn but in a good way. Whatever she sets

her mind to, she perseveres. Through anything, any challenge or obstacle, she goes over them and finds a way.'

When his swearing-in day finally does come, Donado plans to improve upon the strengths he feels Downey already has.

"Volunteering with the events, I did notice that Downey has a very strong community," said Donado. "I think that is great, communities that are together are very strong."

"I feel Downey is pretty safe and clean. Keeping it that way, keeping it a city that's strong."



# How a Maude Price teacher changed my life

■ Before Steve Toay embarks on a well-earned retirement, he should know his positive impact on my life.

One of the benefits of working for a newspaper in the city I grew up in is getting to keep tabs on some of the people I grew up around. Naturally, this includes some of my former teachers.

It's always bittersweet when I see a familiar name on Downey Unified's list of retirees each year; I find that the joy I feel that each individual is reaching this milestone balances with the sadness that I may not see them around campus anymore, or that future students won't have the same blessing of their tutorship that I did.

That said. I have dreaded the day that Steve Toay's name entered that conversation.

Mr. Toay has been a teacher for 25 years, 24 and a half of which at Maude Price Elementary. In that time, he has taught Kindergarten, first, third, and fourth grades, and earned recognitions including the Honorary Service and Continuing Services awards.

What he is probably most known for, however, is his afterschool chorus program for fourth and fifth graders, where he introduced song, dance, and performance to hundreds of students for over 20 years.

Nelson Mandela said that "Education is the most powerful weapon which you can use to change the world." It's his favorite quote, and it's befitting.

A good teacher can effectively teach us our ABC's and our 1-2-3's. A special teacher leaves a profound impact on our lives.

In the 2001-2002 school year, a shy, insecure fourth grader joined Mr. Toay's chorus program. This

student had a history of being bullied, struggled to make and maintain friends, and was often too scared to stick up for himself, or take ownership of who he really

Mr. Toay taught him songs like "When Johnny Comes Marching Home," "There's No Business Like Show Business," and "Singing in the Rain." For the first time in his life, this fourth grader found himself as something he'd never been before: the star of the show.

That does a lot for a kid who never felt like he belonged.

Years later, that same fourth grader – now a college junior found himself frustrated and disillusioned with the world of journalism for which he had been studying. On the recommendation of a counselor, he began to explore the possibility of a career in elementary education.

When that student needed some in-class exposure, Mr. Toay welcomed him into his classroom

with eager, open arms. And while that student eventually reignited his love of journalism after all, it's Mr. Toays guidance, tutelage, and confidence in him that causes him to keep being a first-grade teacher "in his back pocket."

If you couldn't already tell, that student was - of course me. Whether he knows it or not, Mr. Toay has saved my life on more than one occasion, and I am confident I am not the only one. I can say with a high degree of certainty that he has left a lasting impression on the lives of many of his other students.

To me, Mr. Toay is not just a teacher at Maude Price Elementary School; he is Maude Price Elementary School. While his retirement is more than well earned, his departure is a significant loss to both the Panther family, and the school District as a whole.

Ron DeSantis, the 44-year-old governor of Florida, has entered the presidential race, establishing himself as the most formidable Republican rival to Donald Trump.

Mr. Trump, an inveterate liar who tried to overturn the last election, is alienating to a wide swath of voters, and many establishment Republicans have been happy to hunt out alternatives, particularly in Mr. DeSantis. After a rough midterm for Republicans that included the defeat of several Senate candidates endorsed by Mr. Trump, the former president appeared vulnerable.

But since then, it has grown clear that counting him out as the likely Republican presidential nominee is foolhardy. Several factors — among them, the intense support he draws from a sizable chunk of the Republican base and his singular talent for commanding media attention — help explain why Mr. Trump holds a commanding position in the primary. History offers at least one parallel for why it will be so difficult for Mr. DeSantis and other G.O.P. contenders, like Nikki Haley, 51, the Trump administration's ambassador to the United Nations, and Senator Tim Scott, 57, a South Carolinian like Ms. Haley, to take him

There was, more than a half-century ago, another de facto leader of the Republican Party who reeked of failure. Pundits mocked and dismissed him as a has-been. Rivals across the ideological spectrum no longer feared him and cheered on his slide into irrelevancy.

By the end of 1962, few believed there was a future for Richard Nixon, a former vice president. In 1960, he lost one of the closestever presidential races to John F. Kennedy, and members of the liberal Republican establishment, including Dwight Eisenhower, were glad to see him fall.

After losing to Kennedy, Nixon tried to regroup, entering the 1962 California governor's race against the well-liked Democratic incumbent, Pat Brown. Nixon, who had served as a representative and senator from the state, was initially expected to triumph and use the governorship as a steppingstone to the presidency. Instead, Brown swatted Nixon away after the former vice president had to endure a bruising primary battle against open disdain for Johnson's landmark civil rights agenda, a Republican who was popular with the sort of movement the burgeoning antiwar movement and the emerging hippie conservatives who would, in the coming years, seize control of

On the morning after his loss to Brown, Nixon famously told the assembled press at the Beverly Hilton Hotel they wouldn't

have him to "kick around anymore." That November, the want separation of the races." journalist Howard K. Smith titled a television segment "The Political Obituary of Richard M. Nixon."

In the wake of these humiliations, Nixon's tenuous comeback hinged on persuading both Republican voters, who could find more attractive warriors for their cause, and influential party and media elites that he wasn't completely finished. In 1964, Nixon flirted with running for president but backed away. (Mr. Trump, of course, did not feel chastened for supporting weak and beatable candidates in the midterms last year and instead waited roughly a week to announce another presidential run.)

Nixon decided to support Barry Goldwater, the far-right Arizona senator who lost in a landslide to Lyndon Johnson, the Democratic president. Nixon's attachment to Goldwater won him some plaudits with the base of the party — he was one of the few prominent Republicans to stick with the senator — but didn't help alter the perception that he was a serial loser. To complete his rehabilitation, in the 1966 midterms, he strategically stumped for anti-Johnson Republicans who were poised to ride the white backlash to the Great Society and civil rights programs.

By 1968, Nixon had established himself as a foreign policy maven, having undertaken many world tours in the 1960s, and cast himself as an arch, erudite critic of the Johnson administration.

His period of vulnerability was briefer, but Mr. Trump today, like mid-'60s Nixon, has reasserted himself as a party kingpin. Now he, too, is contending with a popular governor from a large swing state.

In the 1968 G.O.P. primary, Nixon had to outflank three prominent Republican governors — George Romney of Michigan, Nelson Rockefeller of New York and Ronald Reagan of California who could offer, in the immediate term at least, more allure.

Reagan, who had defeated the formidable Brown in 1966, was older than Nixon but had the swagger and ease of a much younger man, marrying the sort of sunny optimism Nixon could never muster with the raw appeal to a growing reactionary vote that Nixon craved.

Just as Mr. DeSantis, with his wars on critical race theory, "woke" Disney and Covid restrictions, is trying to outmaneuver Mr. Trump on the cultural terrain that's always been so vital in Republican primaries, Reagan outshone Nixon with his counterculture. He railed against the "small minority of beatniks, radicals and filthy-speech advocates" upending California and successfully demoralized Brown, who remarked, shellshocked, after Reagan's triumph that "whether we like it or not, the people

Nixon rebuffed Reagan and the others in one of the last primaries in which delegates and party insiders, rather than the will of voters, played a significant role in determining the

Here the present diverges from history. Nixon was far more introspective, methodical and policy-minded than Trump. He was, by 1968, a significantly stronger general election candidate, winning the most votes — Trump has twice lost the popular vote - despite the segregationist George Wallace's third-party bid, which ate into Nixon's support.

But just as a divided primary field worked to Nixon's advantage, so it may for Mr. Trump, especially if several other candidates become viable. In such a scenario, Mr. Trump may need only pluralities in pivotal early states to take the nomination. His core fan base might be enough. Though Mr. Trump's 2016 campaign was often shambolic, it managed a finely tuned nativist, antifree trade and anti-globalization message that cut through the noise of a chaotic primary season. In Nixonian fashion, Mr. Trump tapped into his party's reactionaries and delighted the grass roots.

The question is whether Mr. Trump can do it again. One of Nixon's great political strengths was to assume, even at the height of his powers, the position of the aggrieved — to convince a palpable mass of voters that they, and he, were the outsiders. Genuinely self-made, this posture came naturally to Nixon. Mr. Trump, though the son of a millionaire real estate developer, has nevertheless effectively adopted it throughout his political career, once boasting of his love for the "poorly educated."

Mr. DeSantis enters the fray hoping that Mr. Trump's many flaws, continuing legal troubles and political baggage ultimately render him weaker than he appears today. But looking at the historical parallel, even Reagan, a once-in-a-generation political talent, could not dislodge Nixon. As Mr. DeSantis's Twitter announcement debacle suggests, he will need to quickly, and considerably, improve his standing. Perhaps then, with the help of a Trump implosion, can he hold out hope for 2024 — or even, as Reagan's example suggests, a future presidential run.

If 1968 is any guide, Mr. Trump will be tough to beat. In a crowded field, among a hungry younger generation of contenders like Mr. DeSantis, he will have to manufacture anew this kind of populism. He might just do it.

# It's time to build a museum to honor Asian-Americans' contributions

Elaine Chao was the first Asian American woman to be appointed to a president's Cabinet. She served as U.S. labor secretary and U.S. transportation secretary.

I was 8 years old when I immigrated to the United States. My father had arrived in America three years earlier, leaving behind his pregnant wife and two daughters. My mother, my two sisters and I traveled from Taiwan on a cargo ship because it was all my father could afford.

The early years were difficult. We didn't speak English, and we were overwhelmed by the new world we found ourselves living in. But with love, faith and hard work, my parents turned their one-bedroom Queens apartment into a loving home for their daughters and enabled us to access the opportunities in this country.

Our immigrant story — a distinctly American one — mirrors that of millions of other families who have made immense sacrifices to come to this country in search of a better life.

How many are aware that Asian Americans fought for our independence in the Revolutionary War and sacrificed their lives during the U.S. Civil War? How many know about the thousands of Chinese immigrants who labored to construct the transcontinental railroad? And how many appreciate the patriotism of Japanese Americans who fought courageously to defeat the Nazis in World War II, despite their families being interned stateside? Our story is inextricably linked to America's

story.

Yet our history is too often overlooked, our contributions to this nation are sometimes forgotten, and our right to be here is too often questioned. Asian American, Native Hawaiian and Pacific Islander (AANHPI) history is American history. And it is time for it to be recognized as such. That's why I am advocating for a National Museum of Asian Pacific American History and Culture on the National Mall — a place where our contributions can be displayed alongside other monuments to the story of our country.

There are about 24 million Asian Americans living in the United States today, about 7 percent of the national population. We contribute to every aspect of American life. Public servants such as Jonny Kim — who previously served as a Navy SEAL and earned an MD from Harvard Medical School — will help lead the United States back to the moon as part of NASA's Artemis project. Business leaders such as Advanced Micro Devices CEO Lisa Su, Google CEO Sundar Pichai and Nvidia CEO Jensen Huang oversee companies that are developing the breakthrough technologies of tomorrow. Entrepreneurs such as Zoom CEO Eric Yuan and DoorDash CEO Tony Xu are creating products and companies that continue to revolutionize the way we work and live. Meanwhile, even Hollywood is starting to open its doors to Asian American actors, actresses and directors after decades of disgraceful discrimination and lack of opportunity.

Yet, unfortunately, the events of the past few years have cast a disconcerting shadow over our community. The pandemic hit everyone hard, but Asian Americans were especially vulnerable, as many are small business owners who were forced to shutter their operations. In addition, reports that the coronavirus originated Dear Editor: in China and the rising tensions in U.S.-China relations raised fears within the Asian American community. There has been a litany of news stories about Asians and Asian Americans women especially — being harassed, spat upon, threatened and even killed over little more than their ethnicity.

The vitriol directed at the AANHPI community is so unsettling
