

DOWNEY — In a program first for Downey High School, the boys and girls water polo team is the recipient of the Male and Female Athletes of the Year for the 2022-23 season.

Seniors Diego Campos and Alexsa Gimenez were honored at the school's Baccalaureate Ceremony on May 30 in the stadium.

"We are very proud of Diego and Alexsa at Downey High School," Downey Athletic Director Mark Rand said. "To have two athletes from the aquatics program is a testament to coach Uriel Villa and the programs he has developed and continues to

"The success of these two athletes specifically shows their commitment to doing the job in the pool as well as the classroom. We are proud to have them representing the Vikings as multi-sport athletes and great students."

Campos was a big part of the CIF champion Vikings, as they won their third title ever and first in 50 years.

Campos, a goalie, helped Uriel Villa win his first championship as a head coach after winning three as a player at Montebello and one as an assistant coach.

"It's an honor to be decorated," Campos said. "It feels good, and all the hard work paid off with a little bit of luck here and there.

"It was a huge honor, and everybody was really proud. It was a cool moment. I had a lot of help with the team, coaches and parents and a lot of support. It's pretty crazy."

Gimenez was just as shocked as her friend Diego was when the names were announced.

"It was surprising for me," Gimenez said. "When they called my name, it was a total surprise.

"We were sitting there, and they called Diego (Campos) up. We were congratulating him, and my friend told me, 'Do you think you will win the female athlete of the year award?' It was super surprising. It was also heart warming that my hard work was honored."

Campos - All-CIF Goalie

Highlighting the year for Campos, in addition to his athlete of the year award, was leading the team in goal and winning the CIF Division after the last Downey Water Polo IV Championship last November.

The Vikings, who also finished as CIF runners-up on five different occasions through the years, defeated Yucaipa, 10-5. Campos had eight saves in the game for Downey.

The Vikings led, 7-2, at halftime and Campos said after the game he had a feeling of a title. "Our defense really stepped up," said Campos,

There was even a connection to the girls athlete of the year, as Ayelen Gimenez was on the staff of the boys team that season. Ayelen is the older sister of Alexsa Gimenez.

Campos' accomplishments through the years were: Freshman - He started as frosh-soph goalie, moved up to junior varsity and then was promoted to varsity backup for league and CIF. He finished with 48 saves in eight

Sophomore - It was a shortened season by COVID with no CIF

Junior - He was named to the First-Team All-CIF. He led the team to the CIF D 5 semifinals, losing to eventual CIF Champion Carpinteria.

Senior - Led his team to a championship and was named CIF Player of the Year.

He finished with 320 saves in 30 games. A big turning point in the playoffs came in the semifinals. Campos had 16 saves against Schurr and had a crucial steal in the final minute of the game to seal the win.

Water Polo coach Uriel Villa said of Campos: "Diego is one of the most decorated water polo players in the team that advanced to the D 4 the history of Downey Water Polo. Downey won CIF in the 50s and again in 1972. We won CIF 50 years

CIF championship, and we couldn't have done it without the dominant performances by Diego.

Campos, who came into high school only learning the basics of water polo in a recreational class at Cerritos College, had high praise for a coach that sees more than the average person in the water.

"It's a big accomplishment for the sport of water polo," said Gimenez, of the dual winners from the sport. "Out of this program comes a lot of hard workers. It's a big accomplishment for coach Villa.'

Alexsa began swimming at nine vears old and liked swimming better and didn't connect to water polo until she was in high school. "I didn't fall in love with water polo until I was in high school," Gimenez said. "Now that I'm going to UCLA, it's what helped me at Downey.'

Coach Villa, who in seven seasons at Downey has had 12 players earn All-CIF honors, said of Gimenez: "Alexsa is one of two players to receive All-CIF three times," he said. She's the only player to be a two time First-Team All-CIF player. She has the most goals in a season, most goals in a career and has helped establish Downey as one of the premier girls water polo programs in Southern California.



Hate group opposes wellness center at Norwalk high schools

■ Opened in 2019, the facility offers teens resources related to sex, mental health and substance abuse.

NORWALK — The Norwalk-La Mirada Unified School District board of education listened last week as Arthur Schaper, the California Mass Resistance field director, expressed unfounded claims about wellness centers at John Glenn and Southeast Academy high schools.

"These wellbeing centers, your staff, have been trained by said. "You have these counselors who teach kids they can change their sex like flipping a switch, it's unacceptable."

California Mass Resistance, an organization the Southern Poverty Law Center labeled a hate group, arrived at the Norwalk-La Mirada Unified School District board meeting on June 26 to oppose the Wellbeing Center and called for its removal.

The centers have been in operation since 2019.

The organization spread the are reminded to include parents unfounded claim on social media in their care, as expressed in that Planned Parenthood trained the district's memorandum of the staff at the center. Schaper understanding with the Los claimed, without evidence, that Angeles County Department of Planned Parenthood pushes an Public Health. agenda of "sex mutilation" on students and influences them to become transgender.

Torrance continued to call the LGBTQIA+ ideology a "cult and an illness," as his California Mass Resistance supporters applauded. Schaper also accused the school board of hiding information on the center from parents and vowed to go door-to-door to spread his beliefs to the community.

NLMUSD superintendent Planned Parenthood," Schaper John Lopez explained the district addressed most of Mass Resistance's concerns of the Wellbeing Center with a fact sheet of frequently asked questions in February.

> Wellbeing Center staff are trained by the Los Angeles County Department of Public Health.

> Lopez said he was confused about how Schaper and Mass Resistance tied LGBTQIA+ into the Wellbeing Center.

> "It's disappointing that we have an opportunity to help our community by giving them resources they need and groups are putting a spin on things that aren't happening," Lopez said. "LGBTQIA+ wasn't even addressed in any of our frequently asked questions because that never came up until now."

Wellbeing Center The provides health education, information about substance abuse, mental health and stress reduction groups. Masters Level Health Educators from the LACDPH are present to support students, teach sexual health and provide sexually active young people with counseling, according to the FAQ.

A registered nurse is also available for on-site testing school students in LA County and treatment for sexually currently drink alcohol. Among transmitted infections, condoms, sexually active students, one over-the-counter

contraception, pregnancy tests drugs before their last sexual and sexual health information for intercourse, according to the talked about puberty blockers, students.

The FAQ emphasizes that Wellbeing Center. Classes at the center teach parents about teen health, how to discuss alcohol and drugs with their child, and how to effectively explain sexual decision-making.

Brenda Lebsack, a pastor at the Assembly of God Church in Norwalk, alleged she used a Planned Parenthood chat number and pretended to be a child confused about her gender.

"They took me to a site that saying that if you're confused about your gender, don't worry, because the Q in LGBTQ means queer or questioning," Lebsack

The pastor accused Planned Parenthood of promoting sexual pleasures to children. However, she was referring to the Planned Parenthood glossary, where the definitions of such words must be looked for and searched.

As Schaper said California to the district to oppose the Wellbeing Center, encouraged community members to navigate the district website for accurate information.

"We encourage parents to get in touch with their school principals or district staff and we'll provide them the information," Lopez said. "We'll send out information as well and reach out to our community."

After Supreme Court ruling, Cerritos College pledges 'equitable access' to education

■ College officials called the Supreme Court's decision to end affirmative action 'deeply upsetting.

NORWALK - In responseto the Supreme Court ending affirmative action in higher education, Cerritos College released a statement stating it "stands in support of equitable access to education for students of all backgrounds.

The U.S. Supreme Court ruled June 29 that the race-conscious admissions systems used by Harvard University and the University of North Carolina at Chapel Hill are unconstitutional, illegally violating the Equal Protection Clause of the 14th

"[The] Supreme Court's ruling on Affirmative Action is deeply upsetting," said Dr. Jose Fierro, Cerritos College president and superintendent. "For more than four decades, Affirmative Action policies have helped equalize the college admissions process, considering a student's racial background as one factor in their overall experience and qualifications.

"Despite the Supreme Court's decision, we, at Cerritos College, are committed to creating access and opportunity for all



students, including those from racial stereotyping and had no interests of the military marginalized backgrounds."

Board president Dr. Shin Liu called the Supreme Court's ruling "quite unsettling."

"The Justices are on the wrong side of history and have rolled back years of hard work for equity and access to higher education for Black and Latino students," Liu said. "This ruling makes our work even more focused as joined by Justice Elena Kagan and we continue the fight to ensure Ketanji Brown Jackson, issued a our students receive the best education possible regardless of their background.

We reaffirm our strong diversity among faculty, students, 2019. staff, and programs."

Chief Justice John Roberts Supreme Court's decision. wrote the opinion for the conservative majority, saying the Harvard and University of North Carolina admissions programs violated the Equal Protection Clause because they failed to offer "measurable" objectives to justify the use of race.

He said the programs involve

specific endpoint.

The opinion claims the court was not expressly overturning prior cases authorizing racebased affirmative action, and suggested that how race has affected an applicant's life can still be part of how their application is considered.

Justice Sonia Sotomayor, dissent, saying the opinion "rolls back decades of precedent and momentous progress."





Expulsion of female pastors will only speed the Southern Baptists' decline

Amid an unprecedented decline within the Southern Baptist Convention (SBC), the nation's largest Protestant denomination has elected to expel several churches for their interpretations of Scripture. That action has fueled a larger conversation about the future of the denomination to which I have belonged my entire

I was not surprised by the vote of the SBC to expel Saddleback Church, the congregation my wife, Kay, and I founded 43 years ago, for giving three longtime female staff members "pastor of" titles. There are now perhaps nearly 2,000 other SBC churches around the United States worried they will be next.

The SBC executive committee's unprecedented decision has opened a Pandora's box of unintended consequences that will fundamentally destroy several tenets of the Baptist faith upon which the Convention was founded.

The SBC has been in decline since the Baptist Faith and Message confession was revised in 2000 to add a prohibition against female pastors. Then in 2015, just eight years ago, an amendment to the SBC constitution weaponized that confession, turning it into an enforceable creed.

For 400 years, Baptists have been anti-creed — but not anymore. Sadly, I think the decline in the SBC's size and influence will continue as the Convention suffers one self-inflicted wound after another. These problems have weakened the identity,

structure, mission and strategies for cooperation that once made the SBC a powerful force for the kingdom of God and for good in our society.

Some SBC leaders seem unable to admit it or talk about it, but denial is dishonesty. This is not a glitch or the result of a pandemic; it is a trajectory on which we have been for a while, and we should recognize the accompanying hypocrisies. No longer can we afford to avoid admitting our faults.

Those who care about the SBC should be concerned: Why would leadership want to further reduce a dwindling denomination? If ever we needed more believers operating in their God-given gifts and teaching abilities, it is now.

The SBC representatives — they are called "messengers" who voted not to reinstate Saddleback and two other churches could have avoided a costly decade of inquisition and infighting that now looms. They could have avoided the inevitable and painful purging of the roughly 2,000 SBC churches that have already designated female staff as pastors. Instead, they have helped ensure that the once great SBC will be known as the Shrinking Baptist Convention.

That grieves my heart. Many SBC churches have given women the title of "pastor" for various tasks, such as children's pastor, youth pastor, associate pastor or missions pastor. However, to remain "in friendly cooperation" with the SBC, none of that will now be allowed. The debate is over an English word — "pastor" - that is not even in the Bible, though "pastors" (plural) appears once, in a list of spiritual gifts of service but not in the context of an office or title of status. Not a single man or woman is called a

"pastor" in the New Testament in any English translation.

Recognizing that the SBC's executive committee consists of mostly male members, I should note that men treat this as a theological issue. Women, however, see it as an existential issue, because it denies the gifts, talents and skills they were sovereignly given by God. It thwarts their identity. We'll never get 100 percent of Baptists to agree 100 percent on 100 percent of doctrine, but we should be able to agree on the common mission to which we have been called.

The SBC's decision is disappointing to me, given my family's four-generation history as Southern Baptists. I spoke out at the SBC meeting in New Orleans this month to support the frightened pastors and frustrated women in service around the country. But we need to get back to the main thing.

In some of his last words on Earth, Jesus commanded his followers to "go and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, and teaching them to obey everything I have commanded you."

These marching orders are known today as the Great Commission. Nearly 2,000 years have passed since Jesus assigned to us the most important task of all time, and yet there are still people and places across the globe who have never once had the opportunity to hear the good news of the Gospel.

To fulfill the Great Commission, we need everyone in the church using all of their gifts. We cannot finish the task with 50 percent of the team forced to sit on the bench. We need everybody

The Supreme Court made generational poverty more difficult to break

For my whole adult life, debt and financial hardship has dictated my path, first through a cycle of generational poverty and now in the form of student debt. With Friday's Supreme Court decision, it looks as if I have many years ahead of student loan repayment. It could take, quite literally, the rest of my working life before my student loans are paid off.

Last week, the Supreme Court blocked President Joe Biden's student loan forgiveness plan. In a 6-3 ruling, the Court found that the Department of Education "doesn't have the authority to cancel \$430 billion of student loan principal." This is devastating news.

I was elated when I first heard about Biden's student loan forgiveness plan which seemed designed to help someone just like me – dedicated and hardworking but without much in the way of assets or savings. My profession, teaching, wasn't exactly what one could call lucrative.

The odds were always against me going to college. I grew up in central Georgia in a low income household, the eldest of three children. I was the first of my family to attend a four-year university. My family had no experience with the college application process. We also were not familiar with the complicated financial aid loan application form, known as the FAFSA, that all students need to fill out when applying for financial assistance.

After submitting my FAFSA forms, I applied for aid from my college and to my disbelief, I was told that I had an expected family contribution of zero dollars. Naively, I assumed this meant that almost all of the costs of my education would be covered by my college. I discovered later just how mistaken I was.

I received two types of grant funding during my time in college: A program called the HOPE scholarship, funded by the state lottery, which apportioned grants on the basis of academic achievement; and a federal Pell Grant, for students who demonstrate financial need.

Funding for the HOPE scholarship, which never came failed to collect the same loan forgiveness after nearly 30 close to covering my college expenses, ended shortly after years of teaching. I began school. Once it ended, I was left with my Pell Grant as the only way to pay for tuition and fees, room and board, books and incidentals. It didn't come close.

So even though I was a full time student, I still had to work a full-time job to make ends meet. Working sometimes took a toll on my grades but I persevered and managed somehow to graduate with a degree in English, with a 3.4 GPA.

To this day, I find it baffling that these programs, which are put in place for people like me who come from families with no personal assets or financial security nets, still like I did.

After college, I took a position as a teacher at a nonprofit preschool in my community, where I was employed the interest on the loan, my debt today stands at about for the first decade of my working life. I then got a job as a classroom teacher and eventually moved into the role of reduced it to \$3,000. I would have been able to envision, studio arts teacher at the same school.

The school where I worked was an incredible community of dedicated and innovative educators, hardworking, curious children and committed families. I felt lucky to be working with them. LA Metro is currently working on a project called the LA River Path Project, in which they plan to connect the missing 8-mile portion of the upper and lower LA River Bike Paths in Vernon, Downtown LA and Elysian Valley. They plan to be done by 2027. If Downey built a bike path concurrent to Metro's LA River project, one could easily bike from Downey all the way to Downtown LA, Dodger Stadium, or even Griffith Park without encountering a single car or riding on the street. How awesome would that be?

But it wouldn't just be awesome for cyclists. Think of all the walkers, joggers, runners, rollerbladers, skaters, and families walking their dogs who would enjoy the trail!

Activists accuse SEAACA of inhumane animal treatment

■ Downey-based SEAACA, which provides animal control services for 14 cities, is accused of putting down an excessive amount of dogs and cats.

DOWNEY — Animal rights activists, led by Lynette Whiteside-McCalnes, protested against the Southeast Area Animal Control Authority (SEAACA) in Downey last week after accusing the organization of inhumane animal treatment and demanding changes in their animal care procedures.

"They've put way more effort into finding a way to kill the animal than to actually vet them and adopt them," Whiteside-McCalnes said. "I've taken animals from other shelters where I got a dossier of their medical history, and we're lucky if we get a release sheet from

Foster groups and activists expressed their frustration with SEAACA's animal care protocols during their demonstration on June 24. They accused the animal shelter of miscommunicating with animal rescuers, euthanasia procedures, inaccurate statistics and inaccessible operating hours.

In her petition, Whiteside-McCalnes elaborates that select animals are excluded from SEAACA animals saved statistics. She accused the shelter of touting a 99% live release rate while excluding animals based on owner surrenders, animal behavioral issues, sick animals and unweaned kittens.

Denise Woodside, the executive director at SEAACA, responded to the allegations and said misinformation has circulated through social media platforms, but the organization is committed to serving the community.

"SEAACA takes animal cruelty very seriously and regularly responds to animal cruelty calls within our service area," Woodside said. "SEAACA abides by applicable federal and state mandates and any concerns of animal cruelty should be brought to the attention of SEAACA immediately so it can be investigated."

Activists continued to advocate for better animal treatment.

An account they continue to refer to occurred on June 13, when Marissa Gomez transported 17 kittens to SEAACA, but were euthanized soon after arriving.

Woodside explained the kittens were sick and not going to survive and were humanely euthanized.

Unweaned kitten euthanasia has decreased between 2013 with 4,356 kittens, and 2022 with 306 kittens, according to Woodside.
