Downey man accused of killing Tijuana sex worker

■ Mexican authorities requested the arrest of Bryant Rivera, 30, the prime suspect in the killing of a Tijuana sex worker.

DOWNEY — A Downey man who was arrested in connection with serial murders targeting strip-club workers in Mexico will remain behind bars throughout his extradition proceedings, a judge ruled Monday.

U.S. Magistrate Judge Karen L. Stevenson ordered Bryant Rivera jailed without bond while extradition proceedings take place in Los Angeles federal court. Rivera appeared in court, but said nothing, according to the U.S. Attorney's Office.

Rivera, 30, of Downey, was arrested Thursday at the request of Mexico on a femicide charge, authorities said. Femicide has been used to describe the current spate of violence against women in Mexico.

Rivera is accused of murdering at least one sex worker in Tijuana. Mexico may add additional charges when prosecutors submit a formal request for extradition, according to a criminal complaint.

Rivera allegedly beat and strangled Ángela Acosta Flores to death on Jan. 24, 2022, in a room at Hotel Cascadas, next to the Hong Kong Gentlemen's Club in Zona Norte, a red light district in Tijuana, the complaint says.

unidentified killer of Flores and at least two other Tijuana sex workers as displaying "violent psychopathic behavior" comparable to serial murderer Ted Bundy.

Flores, 20, had been working as a stripper and occasional prostitute at the Hong Kong bar for about five months, her mother told investigators.

On the night of the murder, the victim texted her mother that she was going with a client to a room at the hotel for 30 minutes. Security cameras caught a man and Flores together before entering the room, according to the complaint.

When the mother began to to the bar to look for her. He could not find her, but one of the workers said Flores had been with "a male client with a light brown complexion, an acne-scarred face," who stood about 5-foot-5 and had brown hair, according to the document.

"The woman added that next month. she knew the victim's client as `Bryant Rivera,' and that he was a `gringo,' the complaint states.

Flores' mother and boyfriend went to the hotel seeking until learning that a woman had Determined. been found dead in room 404, the Brave. complaint says.

A dancer at the bar told investigators that she had met with a man matching the suspect's name and description hours before the murder and went to a hotel room with him. She said that at about 10 p.m. that night, she saw the man she knew as Rivera leave the bar with Flores, according to the complaint.

Just after midnight on Jan. 25, 2022, Rivera returned to the United States on foot at the San Ysidro port of entry, the document states, citing border control records.

The complaint and provisional arrest warrant for Rivera was placed under seal June 29 by a federal judge in downtown Los Angeles due to the possibility that the suspect "is likely to flee if he learns of the existence of a warrant for his arrest," prosecutors wrote. It was unsealed after Rivera's arrest one week later.





Mrs. Talbert's fruit cart

DOWNEY — This story came from the Los Angeles Times (1923-1995), October 31, 1926 ProQuest Historical Newspaper

Roadside market stands are common enough now, but an average traveler on the public highways would probably call them an institution of comparatively recent origin. It is true they have sprung up like mushrooms in the last few years.

Downey folks, however, were introduced to the roadside market as much as twenty years ago. They believe, in fact, that the plan originated here. Back in 1905 or 1906, Mrs. Eliza Talbert, a thrifty and energetic farm woman living with her husband and small children on a four-acre ranch, began to wonder what she could do with a lot of good pears and apples going to waste on the place. The ranch, she realized, often produced more fruit than the market demanded and, being a thrifty housewife, the waste worried her. Canning was not then so conveniently managed. She had watched the travelers go past, looking at the luscious fruit on the trees, and she conceived a neat and simple method of satisfying the longing of the dry and thirsty ones, of eliminating the waste, and of adding to the family exchequer.

Wherefore, one hot, dusty afternoon out under an apricot tree beside the road now known as Twelfth Street, she set up the first roadside stand. She had piled her choicest pears and apples on an old cart, wheeled this under the apricot tree, and the first roadside stand awaited customers. Team after team toiled along the dusty road - for the smooth boulevards of today were only a dream then - stopped at the cart under the apricot tree and bought Mrs. Talbert's pears. Nine dollars' worth of fruit she sold during the first half of the day. The Talberts are still selling fruit from their roadside market.

Mrs. Talbert was not only the pioneer roadside fruit and vegetable merchant hereabouts at the least, but she ran the pioneer cold drink stand. With the apple season drawing to a close, she made cider made herself with a hand press – and sold it from her stand. The cider business grew and prospered, and cider is still sold both wholesale and retail from the same place, though not of the same vintage.

In the early days the business was personally conducted in every sense of the word. Mrs. Talbert constructed her stand herself - the stand which speedily supplanted the cart of the initial experiment. Taking lumber she found loose about the ranch, she made the counter, picked the apples herself, and herself toted them to the little roadside market. Like most folk who succeeded in any farming venture, she has never been afraid of any form of hard work.

Today on the same site, her son, P.J> Talbert, carries on a flourishing business. The Talbert cider mill is run by electricity, and more than fruit and vegetables are sold - four hundred turkeys are vented there, and the venture which was housed in the little old cart becoming increasingly difficult to tell the candidates has become a goodly sized wholesale and retail market.



DOWNEY — There are certain things that most – if not every faux pas, if you will.

With an election just around the corner and having interviewed and analyzed my fair share of previous candidates, I thought it might be fun (albeit nauseating) to point out some of Downey's most notorious old political chestnuts, perhaps in hopes that our current candidate crop may avoid one or two.

And before anyone says anything, yes, I know a lot of these are in later. how you play the political game; it doesn't mean I'm not going to roll my eyes at you anyways.

BEING WISHY-WASHY

You've seen me write about this before: I hate when candidates toe the line on their stances, trying too hard to please everyone and not lose any voters with what they say.

Election season is the residents of Downey's chance to really get to know who may be representing them in just a few short months; it's critical to get as crystal clear of a picture as possible before casting our ballots.

New taxes. Giving tax dollars to non-profits. Spending more or less on police. Rent control and affordable housing. Yes or no? This, or that? We want to know where you stand firmly, and why. Voters aren't dumb; we can tell when you're just trying to please the room and / or save face.

Coming off of the last few years, I (and I'm sure, most other constituents) would prefer to hear something we don't like from a candidate now, rather than later from the dais.

"I SUPPORT LAW ENFORCEMENT / I BELIEVE IN TRANSPARENCY"

You can count on almost every candidate to say one (if not both) of the above sayings; it's probably part of their official platform.

they're constantly used almost like a free space on a bingo card; like something to check off on a to-do list.

You back our police? Fantastic. What do you plan on doing for them once you're in office? How do you plan on making their job easier, more efficient, and more effective?



You're an open book? Prove it. Be accessible, and not just when others are looking.

Instead of just saying that public safety and transparency are your schtick, it'd be nice for once to hear new, fresh ideas on how you plan on following through.

BEING PART OF EVERY PHOTO-OP YOU CAN FIND

You know that kid in high school who wasn't (or was just barely) part of the extra-curricular activities, but somehow managed to make it into every picture of the yearbook? I've seen my fair share of candidates do the same.

Too often I see would-be electeds show up to an event (oftentimes alongside their favorite city councilmember), smile nice and big for the camera, then almost immediately leave; you wouldn't know they had been there if it weren't for the Facebook post they'll be tagged

You really want to show that you're there? Get involved. Get your hands dirty. Stay more than thirty minutes. If you're looking for a picture, an action shot is much better than a posed one anyways.

ENDORSEMENTS

I am numb to endorsements; they're repetitive, boring, and often about as long as your receipt at CVS.

But the worst thing about endorsements is the icky feeling they give of a candidate being hand-picked, or a seat being gate kept; especially when it seems like everyone is on board with the same person, with nothing more than "They've been involved in / they know the city" to say for it.

It's not a bad thing to have the green-light from a respected member of the community, but that can't be all a candidate has to offer. Candidates have a tendency to lean back on who supports them, and the last thing Downey needs is a "Good Ol' Boys and Girls" club. Let's pick our candidates based on virtue, value, position, and work, and not just because a former mayor, a current school board member, or a collective group or organization says so.

USING DOWNEY DOODLE-ICIOUS IN YOUR **CAMPAIGN PHOTO**

Congratulations, you found the most popular mural in Downey.

I'll admit this is probably the most nitpicky on this list, but Look, my issue with it isn't with the ideas themselves, its that Doodle-icious campaign photos make me cringe just as much as those posed pictures where a candidate is "out in the community speaking with residents" (We all know that's your Aunt Theresa and Uncle Joe standing next to you).

Paging Dr. Frischer...

Recently I've mentioned my morning smoothies. They're a delicious way for me to increase my consumption of fruits and vegetables. Smoothies blend ingredients together, and every part of the ingredient remains in the drink, including the pulp. Now I am getting questions about a different, but related, topic: Juicing.



Juicing machines extract the liquid from fruits and vegetables. The pulp is typically discarded. The juicing trend had some early beginnings in the 1920s and 1930s, but it really took off in the 1970s. Since the 1990s, juicing has gone mainstream.

The upsides of juicing?

The juice contains most of the vitamins and minerals found in the whole fruit or vegetable.

- It can be a delicious, healthy snack or even a meal replacement.
- It makes it easier to consume the daily recommendation of five servings of vegetables and three servings of fruit.
- Too often, when fruits and vegetables become very ripe, we toss them. Juicing is a great way to use them.

The downsides?

- What are the consequences of discarding that fiberrich skin and pulp? Without the fiber, it is easier and quicker for our body to absorb the fructose (sugar). This can be disruptive to our blood sugar levels. Discarding the fiber means throwing away some of the vitamins and minerals. Fiber helps to normalize bowel movements, lowers the risk of colon cancer and hemorrhoids, lowers cholesterol levels, and helps to maintain a healthy weight.
- Juice that is heavy in fruit has a high calorie and sugar content. Snacking on an apple yields about 10 grams of natural sugar, but a glass of apple juice might contain three to six apples, and 30 grams of sugar or more.
- Juicing can be expensive, especially when organic produce is used. (Add to that the cost of a good machine.)
- Although juices have a lot of vitamins and minerals, they are carbohydrates, so most fruits and vegetables are low in healthy fats and protein. If you juice, I suggest that you include in your diet Greek yogurt, peanut butter, nuts and seeds, etc.
- If your juicing is in addition to meals, keep an eye on those added liquid calories.

For most of us, I like to recommend that instead of drinking a glass of apple juice, simply grab an apple. Still, drinking fresh juice is one good way to consume more vitamins and minerals. Do keep in mind that the ingredients make all the difference. To make your drink nutritious and far lower in sugar and calories, limit the fruit content: Instead of fruit, use mostly vegetables, like spinach and celery. Include great proteins like yogurt, peanut butter, non-fat milk or milk substitute. Enjoy!

Childhood cancer diagnoses are more common than 15 years ago

to a study published Tuesday in the Journal of the National Cancer Institute.

There were 14,381 new childhood cancer diagnoses in the US in 2019: about 177 new cases for every 1 million children and teens up to age 19. Incidence rates have dropped since reaching a peak in 2016 but are still about 8% higher than they were in 2003, when there were about 165 new cases for every 1 million children and teens.

'Overall, cancer is very rare in children and adolescents, and the increases were small," said Dr. David Siegel, a pediatric oncologist and an epidemiologist with the US Centers for Disease Control and Prevention's cancer

The researchers gave a detailed look at incidence rates by cancer type, age group, geographic region and other demographic breakdowns. Siegel says that this detailed data could be helpful to direct resources where they are needed most, particularly in terms of clinical trials for treatments and supportive care, and improve the lives of these patients.

Leukemia was the most commonly diagnosed childhood cancer, with new diagnoses increasing from 43 cases for every

carcinomas also increased.







Ron DeSantis is losing popularity

Dean Obeidallah, a former attorney, is the host of SiriusXM radio's daily program "The Dean Obeidallah Show."

This past week saw a wave of media coverage about Florida Gov. Ron DeSantis struggling in his quest for the 2024 GOP presidential nomination.

He currently trails the front-runner — twice-indicted former President Donald Trump — by more than 30 points in one recent Fox News poll. The New York Times detailed how the "DeSantis Campaign Continues to Struggle to Find Its Footing," while The Wall Street Journal and Politico ran articles on the "DeSantis

Even over at Fox News on Sunday morning, anchor Maria Bartiromo asked DeSantis to his face about his flailing poll numbers: "There was a lot of optimism about you running for president earlier in the year. ... What happened?"

(Nevertheless, DeSantis' campaign touted raising \$20 million during the second fundraising quarter that ended June 30, calling the haul "the largest first-quarter filing from any nonincumbent Republican candidate in more than a decade.")

People have debated what's behind the governor's "failure to launch" (as Politico put it), but his challenges can be blamed on one person: Ron DeSantis. That may seem obvious to some, but on paper DeSantis is damn impressive. He graduated from Yale University and Harvard Law School with honors. He served in the US Navy as a lawyer, being awarded the Bronze Star Medal for meritorious service.

From there, he was a federal prosecutor. And while he won his 2018 race for governor by only .4%, DeSantis was reelected in 2022 by nearly 20 points — an impressive margin in a statewide

race in Florida — and he raised an eye-popping \$100 millionplus for that campaign.

With this impressive resume — coupled with Trump-backed candidates losing in key battleground states in 2022 and the former president being dubbed the midterms' "biggest loser" DeSantis began surging in the polls. For example, a February Quinnipiac University poll showed Trump with just a six-point lead on DeSantis.

But as Politico noted in its article Saturday, Trump soon stepped up his personal attacks on DeSantis. In late January, penned a CNN column urging DeSantis to "punch back" in response to Trump's attacks because the GOP base values strong leaders, not punching bags.

Instead, DeSantis tried to take the high road with comments in February about how he delivers results for the people of Florida, adding, "I don't spend my time trying to smear other Republicans.

Trump launched even more barbs against DeSantis on everything from his handling of Covid-19 to his long-running feud with Disney - with the former president predicting DeSantis would be "absolutely destroyed" by the company.

DeSantis' response was muted at best. Despite Trump's onslaught of attacks, DeSantis is "still not hitting the 45th president with any bare-knuckle punches," The Hill reported

To be blunt, many of his critics must be asking themselves if DeSantis can't (or won't) stand up to the twice-impeached, 77-year-old Trump, how can anyone believe he will take on our nation's enemies?

DeSantis also comes across as cold, flat and bordering on

whiny. For example, asked about his lackluster polling last week on Fox News, his low-key answer was to blame the "corporate media" and — oddly — the president of Mexico. "I think if you look at the people like the corporate media, who are they going after, who do they not want to be the nominee? They are going after me," he said, repeating pretty much the same line again Sunday on that network.

DeSantis added, "Who's the president of Mexico attacking because he knows we'll be strong on the border and hold him accountable in the cartels? He's going after me." (President Andrés Manuel López Obrador has urged Latino voters not to support DeSantis, given his state's tough immigration policies.)

Does either point hold up to scrutiny? Hasn't the media been critical of Trump, too, especially after the January 6, 2021 insurrection? And wouldn't the Mexican leader's criticism likely help DeSantis with GOP voters, given their views on immigration?

Let me add this caveat about DeSantis' polling challenges, as others have: It's still early in the 2024 race for the GOP nomination. At this point in the 2016 race, former Florida Gov. Jeb Bush was leading among Republicans in many surveys. And in the 2008 race for the Democratic nomination, at this point, many pundits were saying Hillary Clinton was inevitable, yet Barack Obama eventually won the nomination — and the presidency.

To that point, DeSantis said last week, "I'm running to win in January and February. I'm not running to juice polling now."

But as each day passes and he doesn't seem to be changing tactics, DeSantis threatens to become just another good-onpaper candidate who may not have what it takes on the national

The economy is key to Biden's re-election

President Joe Biden's recent adoption of "Bidenomics," an economic theory based on using the power and resources of the federal government to help generate jobs and economic growth, has become fodder for the Republican presidential candidates competing to run against him. Recently, Florida Gov. Ron DeSantis' campaign released a memo tying the term to higher prices and inflation, while South Carolina Sen. Tim Scott took to the airwaves with a similar critique.

Biden's embrace of the term, which is reminiscent of former President Barack Obama's doubling down on the term "Obamacare" to describe his then-controversial health care law, might leave some scratching their heads — and for good reason.

After all, Americans are generally dissatisfied with Biden's handling of the economy. Recent surveys from the Associated Press-NORC Center for Public Affairs Research, Gallup and others concluded that many more Americans (in the case of the AP survey, about two-thirds) disapprove of how Biden is stewarding the nation's economy. Meanwhile, an April CNN poll found that few resources to tell the story of the president's economic record, shape.

The actual economic data has been mixed. While the unemployment picture remains favorable for Biden, the pace of recent job creation has lagged behind estimates. And Americans' views of Biden's handling of the economy may still be influenced by the significant inflation the US economy experienced in 2022 or the widely held belief that recession is on the horizon.

So why is Biden looking to talk about his record on and plans for the economy, when it would seem as though campaigning as the alternative to former President Donald Trump would be the clearer route to reelection?

In most presidential elections, public perceptions around the incumbent's handling of the economy have been influential in his success or failure. When former President Bill Clinton ran for reelection in 1996 and Obama in 2012, both directed the public's attention to their policies and made the case that they were responsible for any gains that had been seen in the country's economic condition.

For Biden, therefore, the goal is to persuade voters with his economic record at a time when most voters are either unaware of the policies he has advocated for or frankly don't see the economy as being in great shape.

Whether it's the Inflation Reduction Act, which will pour hundreds of billions of dollars of government spending into the US economy, the CHIPS Act, which invests public dollars to promote US leadership in the semiconductor space, or the

bipartisan infrastructure law, which will spawn new construction "little or nothing" since taking office. The same survey found projects throughout America, the trick for Biden is to emphasize that 60% of voters did not believe that Biden had made progress his accomplishments while not appearing to declare prematurely that the battles against inflation and recession have been won.

Biden's focus on the economy serves two political purposes. awareness around his economic record is likely driving Biden's First, it arms Democrats with information about why he deserves reelection and perhaps, more importantly, galvanizes them to turn out. The importance of this base partisan turnout in a time of hyper-partisanship is obvious. Without Democratic turnout in key swing states such as Pennsylvania, Georgia and Wisconsin, Biden's path to reelection becomes exceedingly difficult.

Second, Biden needs an argument to convince wary independents that he deserves four more years in office. For these voters, Biden's argument that he is "not Trump" may simply not be compelling enough the second time around.

Biden's support is weak in Pennsylvania, where a Quinnipiac University poll recently found that independents support Trump over Biden by a 14-point margin, with the overall race in the state a dead heat. Similarly, in Arizona, Biden's lead over Trump is just three points, both among independents and overall. And, there is also the possibility that someone other than Trump may be the Republican nominee.

Biden's team doesn't want to be left with too little time or too about 70% of those surveyed think that the economy is in "poor should Trump not emerge with the Republican nomination. They understand that trying to explain Bidenomics and its benefits next summer or fall may be too late.

> But, more significantly, some voters — particularly those who don't strongly affiliate with one party or another — will assess incumbents based on what they've done in office. In his July 6 editorial decrying the Southern Baptist Convention (SBC) for its enforcement of male-only pastors, Rick Warren commits several fallacies.

First, as would be expected of someone hugely successful voters — believed Biden has accomplished "not very much" or in running a seeker-friendly megachurch, he applies the top metric that matters: size of membership. In bemoaning the shrinking of the SBC, he regrets how it will become smaller.

> Someone from the SBC might respond that they put a higher premium on faithfulness to God's Word, as they interpret it. The Gospel is indeed inclusive: to those who are faithful. While Warren and I may share a more expansive view on the role of women in church leadership, faulting those who wholeheartedly and sincerely hold a different scriptural interpretation for enforcing a standard goes too far.

> This brings us to Warren's second fallacy, the appeal to SBC's non-credal tradition. The assignment of the "credal" label may prove a clever argumentative device, yet strikes me as specious. Is there no other standard in the Baptist Faith and Message confession that, if violated, Warren would consider grounds for dismissing a given church? Any association, including the SBC, has the right and responsibility to set standards for membership and to enforce said standards.

Thirdly, the "one word" argument presents us with yet another clever semantic trick. "Pastor," as we assign it to a profession in our cultural context, has no equivalent in the original Greek. There, always, the word is "shepherd," successful recall campaign, I feel that her running to fulfill the a quaint term we tend to avoid, but which conveys the key meaning of what it means to lead a congregation (yet quaint again, "flock") of believers. That word, "shepherd," is used interchangeably with the words "overseer" and "elder" in Peter's epistle. He claims an examination of scripture led him there. Cynics might point out that growing a megachurch in liberal Southern California might have had something to do with it.

> Either way, regrettably, his change of position goes unmentioned in his letter, an acknowledgment that might have stretched out a hand of fellowship rather than a wagging index finger of accusation.

State gives OK to reopen **Los Padrinos** Juvenile Hall

DOWNEY - State regulators have officially approved the reopening of Los Padrinos Juvenile Hall in Downey to serve as a replacement for two other county facilities deemed to be unsuitable for housing youth, county officials said Friday.

According to the county Probation Department, the Board of State and Community Corrections has notified the county that Los Padrinos passed its pre-opening inspection, clearing it to house up to 317 "predisposition" youth -- those whose criminal cases are still pending. Probation officials said they plan to house no more than 275 to 300 youth at the 26-acre campus.


Construction and probation crews have been working furiously for the past two months to get the facility up to speed in response to the BSCC's ruling in May that Barry J. Nidorf Juvenile Hall in Sylmar and Central Juvenile Hall in Lincoln Heights are both unsuitable for housing pre-disposition youth. The board ordered all detainees to be relocated within 60 days.

The board cited a laundry list of ongoing violations of state standards at the facilities, including sanitary conditions of the housing units, detainees' access to school and other programs and staffing

Prior to that decision by state regulators, the county Board of Supervisors on May 2 approved a plan to relocate all pre-disposition youth to Los Padrinos. Under that plan, Central Juvenile Hall will be used solely as an intake unit and medical and diagnostic/assessment hub for youth, and only post-disposition Secure Youth Track Facility youth will be housed at Nidorf.

Renovation work completed at Los Padrinos included new paint, new flooring, new furnishings, mattresses, fixtures, cameras, interior and exterior lighting upgrades, intercoms, plumbing and partitions for restroom privacy, according to the county.

Los Padrinos was originally opened in 1957. It includes 37 30 years. I endorsed him when buildings, including 19 living units and nine dormitories, along with he ran for Pico Rivera City a kitchen, classrooms, recreation areas, library, infirmary, laundry, chapel, gym and pool.


