Downey teen kidnapped from park found dead

WHITTIER — A 20-year-old man pleaded not guilty Wednesday to murder and other charges stemming from the kidnapping and death of a young Downey woman who was attacked at Penn Park in Whittier and whose body was found a day later in Riverside County.

Gabriel Sean Esparza of Whittier is charged with one count each of murder, kidnapping to commit another crime, kidnapping and assault with intent to commit a felony, and two counts of attempted forcible rape -- all involving Andrea Vazquez, along with an attempted murder charge involving the 19-year-old woman's boyfriend.

of murder during the commission of a kidnapping and murder during

the commission of an attempted rape, which could make him eligible for a potential life prison sentence without the possibility of parole.

All seven charges include an allegation that Esparza personally used a rifle.

"Today was the beginning of fighting for justice for Andrea Vazquez -- a beautiful to create a \$30,000 annual 19-year-old daughter, sister, cousin, friend, girlfriend that was murdered by the person accused today in court," said Moses Castillo, a budget. retired Los Angeles Police Department detective who is representing the woman's family.

He noted that the victim's family met with Deputy District Attorney Beth Silverman before the downtown Los Angeles court appearance and were advised that the charges included attempted rape, which he said "just ripped their hearts all over again."

"I want justice for my daughter," the victim's mother, Ana, told reporters outside the courthouse. "She just started her life. I don't

The woman's sister, Edlyn, said she was "here to get justice for my sister and to be a voice for her."

The family's spokesperson said there is "no connection whatsoever between the accused killer and the victims, none whatsoever."

Castillo said he wants the public to know that Vazquez's boyfriend "is a true victim" and "is not anyone who was involved with this."

"We're just thankful that we don't have two dead homicide victims. At least one is able to tell us the story as to what happened and for that we are thankful," Castillo said.

Superior Court Judge Kimberley Baker Guillemet ordered Esparza to remain jailed without bail pending his next court appearance Oct. 25, when a date is scheduled to be set for a hearing to determine if there is enough evidence for him to stand trial.

Esparza was arrested Monday afternoon at his workplace in Lakewood, the Whittier Police Department said Tuesday.

The 19-year-old woman's remains were found late Monday night in Moreno Valley.

Whittier police said they recovered a weapon believed to have been used in the crime, and Esparza's vehicle, a 2013 White Toyota Tacoma truck, was also impounded.

According to police, the shooting occurred early Sunday morning, shortly after midnight, at the parking stalls area of Penn Park at 13950

"An adult male witness reported that while at the park with an adult female companion, an armed suspect approached their vehicle and fired a weapon in their direction," police said in a statement.

'The male witness ran from the location and upon his return, discovered blood near his vehicle and his female companion was missing," police said.

On Monday, police sought the public's help to find Vazquez and excess traffic. then announced the arrest Tuesday afternoon.

"Throughout the investigation, an ongoing search for Andrea Vazquez took place in large open land areas of Moreno Valley," police

"At 11:50 p.m. on Aug. 21, 2023, detectives located the body of Andrea Vazquez in a vegetation field off Alessandro Boulevard and Merwin Street in Moreno Valley," police added. "At this time, it appears that Andrea Vazquez and her male companion were randomly targeted by the suspect at Penn Park.'

Vazquez attended Fullerton College and was a fashion design student as well as an employee at a shopping mall in Cerritos.

The Downey Police Department assisted with the investigation, to residents, drivers often use along with the Riverside County Sheriff's Department, Los Angeles County Sheriff's Department and La Habra Police Department.

DOWNEY – Seven Downey students were honored as winners of the Caring for Others scholarship awarded by Risher Mortuary and Cremation Service.







Downey couple narrowly misses Maui wildfires

■ Pablo and Reggie Donahue escaped Lahaina as deadly fires devastaed the Hawaiian resort town.

DOWNEY supposed to be a celebration of their 35th wedding anniversary.

Reggie Donahue and husband Pablo arrived on the island of Maui on Aug. 4 to kick off their 8-day long festivities. Four days into their trip, on Aug. 7, they visited Lahaina.

A day later, it was on fire.

Over 115 lives were lost. thousands displaced, and as many as 1,100 remain unaccounted for after a devastating wildfire tore through the historic Hawaiian town of Lahaina

The Donahue's were staying at the Napili Surf, around six miles north and out of harms way, although that wasn't completely clear at first.

As the tragedy unfolded, information was scarce.

"Initially we were told one power pole went down, and so on Tuesday night we lost power," said Donahue. "They said, 'Oh, it'll be fixed in the morning."

It wasn't until the following morning that the Donahue's knew anything "officially."

"The general manager [of the resort], his name is Tano, he got in his truck... and went the back roads [into town], and came back upset," said Donahue. "We had a generator. We had no power, so he had a generator, so we were listening to a transistor radio."

Still, the Donahue's received more details from their family back home.

"Wednesday night is when we

spoke to our kids," said Donahue. gone. Lahaina is gone.'

"We knew it was bad, but we heard from our own kids from California.

In fact, what the Donahue's were receiving from their kids back home was often better information than what was available locally.

"The lack of information was really horrendous... All we kept hearing was the power was out, not that Laheina was gone," said Donahue. "I was literally just sitting at the radio, and they because I think a lack of information all around."

Knowing that evacuation might be difficult and not guaranteed immediately, the Donahue's made the decision to stick things out for the remainder of their planned trip.

"We went three and a half days without power, without electricity," said Donahue. "We had peanut butter and jelly, we played 20 Questions; we were

In the meantime, their resort began taking in locals who had lost their homes - and some family – in the fires.

"A lady shows up [with her 8-day-old baby], knocks on the door, and says to [Tano], 'You're related to my cousin," said brings her baby and the diaper bag. Following her was her husband and two grandparents."

Another family also arrived; the son, Junior who was back from college, having had to rescue his four siblings from the fire.

Before leaving, the Donahue's tried to help where they could, helping collect food and supplies and convincing several other travelers to leave their clothes behind for those who had lost everything.

Now, they're hoping to support even more.

Donahue is encouraging others to donate to Maui's Mana, were not giving any information which was established by a couple who frequent Napili Surf to support the families who have been impacted. Many of those families - some upwards of 10 people - are currently living out of the small resort.

> "I think my biggest takeaway: it was a minor inconvenience for me and my husband; we will always remember our anniversary," said Donahue. "It's a lifetime of pain, and loss, and heartache for these families.

"That's why I don't want it to be about me, but I want Downey to directly help these families, because this is real, this is so real.'

Donahue says she "hasn't slept" since coming home and seeing the true level of destruction.

"Getting home, watching Donahue. "[Tano says], 'Yeah, the things, made me realize, Yeah, I know. Come in.' She wow, I was blessed and missed all that, but did not know the destruction," said Donahue. "I was at Napili Surf, and literally we didn't do anything from the point it started."

> She said that providing further help is going to be part of her recovery.

> "I feel I know enough people. People have said, 'Reggie, what can I do," said Donahue. "... Tano and his wife, they know everybody's level of need. There might be people there who didn't lose their home, didn't lose anything and they're okay, but the bulk of these people did. So that's

The big story behind the police raid on a small-town newspaper

hat happened to a weekly newspaper in Marion, Kansas, on Friday can be viewed as one unpleasant incident in a small town: the police raiding a local newspaper and the home of its owners and confiscating the digital equivalent of the paper's printing presses by seizing computers, cell phones and reporting materials containing the names of confidential sources.

But the proper perspective is a much broader one. This is about a police force essentially shrugging off the law and the Constitution. It's about an intrusion into newsgathering that almost never happens because it so profoundly violates one of our deepest American values - the primacy of the public's right


Society of Professional Journalists. It happens that our national board is giving up to \$20,000 to the newspaper in question, published online, and your public statements to the press, there the Marion County Record, to help with its legal fees. But my appears to be no justification for the breadth and intrusiveness views don't represent my organization. Rather, they are deeply personal. I'm writing as a citizen who became a journalist to ensure the public's access to information out of a conviction that good reporting is the best way to ensure a functioning democracy.

The news story at the center of this raid was so responsible and honest, and the reaction of local law enforcement was so over the top, it would be funny if it weren't true.

The day before the raid, Eric Meyer, co-owner and editor of the Record, wrote an article laying out the state of affairs. His paper had received a private message on Facebook from an anonymous source sharing a government record indicating that a local restaurateur had had her driver's license suspended because of a DUI. According to Meyer's reporting, under state law, this could have jeopardized her ability to get a liquor license.

The Record checked the information on a public website and confirmed its accuracy. But Meyer said the paper declined to publish it, worried that the source may have had an agenda. Instead, the paper reported the incident to law enforcement out of fear the paper was being set up.

Then, Meyer reported, police apparently told the restaurateur about the information the newspaper had. Later, at a public meeting of the Marion city council, the restaurateur wrongly accused the paper of illegally obtaining and spreading private information about her, in the process making public by herself her DUI. The paper covered the meeting and spoke to the restaurateur following the event while refuting her accusations



Does this sound like the making of a crime? Or is this anything but solid news reporting, something you'd expect from Meyer, a longtime journalist at the Milwaukee Journal Sentinel who then went on to teach journalism at the University of Illinois? According to the publicly available information, there is no sign the newspaper did anything wrong.

Yet four days after the council meeting, the police raided the newspaper's offices. Marion police chief Gideon Cody reportedly pushed for the warrant for the raid in order to investigate whether the paper illegally obtained the DUI information, thus potentially committing identity theft.

Cody also had a personal connection to the Record. The paper had investigated the police chief himself over "serious" allegations of misconduct in his previous job with the Kansas City Police Department, Meyer told the Kansas City Star.

Cody retorted that the paper had never published that Anita Rivero to know.

The event stirred journalists to their core. But it also alarmed the White House. White House press secretary Karine Jean-Pierre

That raid was groundless, according to the Reporters I'm the vice president of the Washington, DC, chapter of the Committee for Freedom of the Press. In a letter to Cody it wrote, "Based on public reporting, the search warrant that has been

> The letter also warned that the raid "may have violated federal law strictly limiting federal, state, and local law enforcement's ability to conduct newsroom searches," which "are among the most intrusive actions law enforcement can take with respect to the free press, and the most potentially suppressive of free

> While the Kansas Bureau of Investigation has not closed its probe of the publication, the paper is now getting back all its seized equipment and records. Even more important, the Marion County Attorney said Wednesday the search warrant was being withdrawn, concluding that the search shouldn't have been permitted to begin with, saying it was based on "insufficient evidence" that any crime had been committed.

> This plot could have the makings of a Frank Capra film – the noble newspaper editor standing up for truth and the rule of law and (hopefully) ultimately prevailing - except for its tragic, un-Capra-like elements. Joan Meyer, 98, who owned the paper with her son, had trouble eating and sleeping after her home was raided, asking, "Where are all the good people to put a stop to this?" Her anger and upset were, her son believes, a factor in her death the following day.

> And contrary to Capra's formula, there hasn't been an overwhelming outpouring of public community support for the paper from churches, civic leaders, anyone. Meyer said that some people in the community were offering their support, but only privately. They tell him they're afraid, he said. What if the police go after them?

> Indeed, just because this raid had received lots of publicity and even drew the attention of the White House, it doesn't mean that the Marion Record or anyone else who cares about democracy should breathe a sigh of relief.

> We have seen so many laws broken and rights trampled over the last few years. Each time these boundaries are crossed, democracy is a little weaker, and people a little less empowered.

> This time it was law enforcement seizing a newspaper's property. Next time, a governor may decide to arrest a blogger for saying unkind things about him. In Florida, a bill pending in the legislature would require bloggers who write about state elected officials to register with the state and file reports about how much they earn from their work or face fines.

> Librarians are quitting their jobs, fearful of intimidation by the book banners. Election workers are leaving in droves because they can't stand the threats from people who believe, mistakenly, that they are rigging the vote. Teachers are growing weary of the harassment by parents who want to dictate what public schools may teach.

> Marion may be a small town. But there's nothing small about what happened there. Just ask Maria Ressa, the Nobel laureate Filipino journalist who was hounded by her government for years and became a symbol of press freedom. When news of the Marion police raid began to trickle out on Friday, Ressa responded, "It's happening to you now ... death by a thousand cuts.'

Playing politics with this legislation or the climate issue may be tempting with an election year approaching. But any efforts to roll back or redirect this critical climate investment would be a mistake. Voters want the fight against climate change to continue and for these benefits to continue to flow

Our legislators must look beyond the next election to the future of our nation, state, and local communities. They should strengthen clean energy efforts, which will bring even more good jobs and financial benefits to the people of California.

This summer's climate disasters remind us that climate change endangers us no matter where we live, but there is hope. The 2022 Inflation Reduction Act, with its investments to protect our climate, is taking big steps towards a better economic and climate future.





- 1. Tire Pressure Gauge: Keep a tire pressure gauge in the glove compartment. Check tire pressure with a tire pressure gauge before departing, as changing temperatures can affect tire performance.
- Spare Tire, Jack, and Lug Wrench: Ensure you have a spare tire or run flat tires and that they are in good condition. Check to make sure your jack is in your vehicle and tire-changing tools are easy to use.
- Paper Maps or Road Atlas: Be sure to pack "old fashioned" road maps that are available on Amazon. com and at many bookstores or convenience stores.
- Owner's Manual: Be sure to keep in the glove compartment or other easily accessible location in your vehicle.

Police academy director lauded for anti-hate work

WHITTIER - Rio Hondo College Police Academy Director Walter Allen III has worked to combat prejudice and stamp out pro-hate tactics during his more than four decades in law enforcement, an effort that has earned him the Huff Strategies - ACT Against Hate Alliance (AAHA) - inaugural Leadership Award.


The first-ever Huff Strategies-AAHA Leadership Award was presented to Allen and eight others during an Aug. 17 ceremony in Rowland Heights. Allen has fought against implicit bias throughout his personal life and storied career in law enforcement, which includes his tenure at the Rio Hondo College Police Academy and across California's criminal justice and correctional systems.

The AAHA has engaged in statewide collaboration to make identifying solutions against hate crimes in California an immediate priority since it was established by former California State Senator Bob Huff and Mei Mei Ho Huff in August 2022. Allen has shared his expertise as a speaker at AAHA's monthly media events, which focus on solutions to stop the rise in hate crimes.

"Walter has articulated a vision for selecting, training and retaining police officers that helps ensure they will be effective advocates for the communities they serve," Bob Huff said. "He has made a difference in law enforcement programs in California and has identified education as one of the most important factors in stopping the rise in hate crime.'

Allen has also served as a state-wide leader in law enforcement, with more than 46 years of experience in the field. He is the former California Youth Authority director and chief of the State Department of Corrections and Rehabilitation Law Enforcement Office of Correctional Safety. He has participated on the Commission on Peace Officer Standards and Training and served as deputy commissioner for the Board of Parole Hearings.

Allen has spent the last 10 years as the Rio Hondo College Police Academy Director, and was a graduate of the Academy's Class No. 36 in 1976. The Academy follows a teaching philosophy

known as Principled Policing, which addresses cultural diversity, prejudice, discrimination, hate crimes, investigative profiling vs. racial profiling, as well as the tenets of procedural justice.

"As I continue serving in this role, we will continue utilizing cutting-edge cultural diversity and procedural justice training to ensure that we are producing the guardians of society, who will be our champions of fairness, transparency and impartiality.'

In addition to his law enforcement background, Allen is currently fulfilling a fifth term on the Covina City Council, including his fifth stint as mayor of the City of Covina.

He has also sat on numerous boards and currently holds positions on the Ettie Lee Youth and Family Services board and the League of California Cities Public Safety Committee.




