COUNTY STILL STRONG, HAHN SAYS

 Supervisor Janice Hahn detailed her plan to address homelessness, public safety and mental health in her State of the county address.

On Thursday, the San Pedro Chamber of Commerce hosted my State of the County address at Crafted.

I talked about everything LA County – the role our 38 departments play in our residents' lives from the day we are born, with birth certificates issued by our Registrar-Recorder, to the day we die, with the work of our County Coroner.

But the bulk of my speech focused on how we are going to meet the challenges we face in public safety, homelessness, and mental health.

Public Safety

Ι talked about the investments we are making in the Sheriff's Department, falling into the wrong hands.

Working Smarter to Create Housing

T talked about the humanitarian crisis on our streets and how we are creating a desk. And because we know housing faster by taking that mental health is not a advantage of empty county nine-to-five problem, we are buildings and converting motels offering incentives to people that have seen better days who agree to work night shifts into apartments for formerly and weekends. We are going unhoused residents.

This year we transformed the former Best Western in San Pedro into temporary housing for formerly homeless veterans with the addiction services, mental health support, and job training they need to put their lives back on track. Every week, between five and 10 veterans are graduating from the program and moving into their own apartments. In fact, a veteran who attended the event just moved into permanent housing this week.

Hiring an Army of Mental **Health Workers**

My address closed with a story that I think illustrates so much of the good in Los Angeles County. Last year, a woman dropped off her baby girl at a fire station in my district. Under LA County's Safe Surrender got the baby to a local hospital, where County doctors made sure the baby was healthy and taken care of.

And just last week, one of the firefighters who was there that fateful night Battalion Chief Wade Kelsey and his wife Tonya officially adopted Baby Isabella.

The State of LA County is strong and resilient. It is so much more than budget figures and data. It is made up of generous, dedicated people who are working to build a better life for their families and for our entire community -- all 10 million of us.

After 2 escapes, county beefing up security at Los **Padrinos**

County supervisors want security measures addressed at Downey's Los Padrinos Juvenile Hall.

DOWNEY – Following the second escape of a youth from Los Padrinos Juvenile Hall in Downey since the facility reopened in July, the Los Angeles County Board of Supervisors Tuesday directed probation officials to provide a report in two weeks on corrective actions and increased security measures being implemented at the facility.

"It is unacceptable that two young people have managed to escape from Los Padrinos Juvenile Hall in the last four months," Supervisors board Chair Janice Hahn said in a statement after introducing emergency the motion Tuesday. "Luckily, they were apprehended almost both immediately after their escape, but this cannot happen again."

The motion calls for the report by probation officials in two weeks to include "descriptions of additional

security measures and policies being implemented by the Probation Department to prevent any future escape from the facility.'

It also directs the county's chief probation officer to meet with Downey and South Gate officials to brief them on additional security measures. It also calls on the Office of the Inspector General to investigate the most recent escape, which occurred Saturday when a youth detainee allegedly assaulted a staff member, managed to obtain a set of keys then climbed over a fence.

That youth was detained within about 10 minutes, according to Hahn's office and probation officials.

Another youth escaped briefly from the facility about two weeks after it reopened in July.

Los Padrinos was renovated and reopened to replace Barry J. Nidorf Juvenile Hall in Sylmar and Central Juvenile Hall in Lincoln Heights, both of which came under fire by state regulators for conditions that rendered them unfit to house pre-trial youth detainees.

Let's be clear: Earwax in our ear canals is completely normal and good to have. Actually not wax at all, cerumen is a natural cleanser for the ears; moving from the inside of the ear canal to the outer part. Along the journey, it picks up dead skin cells, dirt, and even hair. It may have antibacterial and antifungal qualities.

Normal earwax varies it can be dark brown, light brown, orange, yellow or off-white, and the texture and quantity vary from person to person. As with so many things, genetics plays a big role. Earwax can be wet or dry (the dry form is common among those with East Asian ancestry), and some of us have little or no earwax, causing the ears to be dry and itchy.

When a buildup of wax causes symptoms, including aching in the ear, fullness or ringing, impaired hearing, an odor, dizziness, or a cough, it needs to be cleaned out. Impacted earwax can even lead to an ear infection, which requires medical attention. Hearing aids, earplugs, or earbuds may

lead to excess earwax buildup. As we age, we tend to make more. The shape of the ear canal may make it more difficult for it to exit the ear canal naturally. If the earwax does get impacted, most health care practitioners can clean it out easily and quickly.

So, why shouldn't we use cotton swabs, or (shudder!) small objects like bobby pins or paper clips? Objects like these can push wax deeper into the ear canal, or even damage the ear canal or tympanic membrane. Many of us have heard the rule; nothing smaller than your elbow in your ear! Another idea to discard: Ear candles. Please don't. They can (obviously) cause injury from the lit candle or from the hot wax.

So, how should we clean our ears at home? Use cotton swabs only on the outside of the ear or, better yet, try wiping the area with a warm, damp washcloth. Pharmacies sell over-the-counter ear drops like Debrox, which may contain mineral oil, baby oil, glycerin, hydrogen peroxide, or saline. You place the drops in the ear, wait for a few minutes, and then rinse with a bulb syringe. If that doesn't take care of it, I urge you to visit your health practitioner.

DOWNEY - This past week, Downey Unified School District's Musical Theatre Conservatory (MTC) presented "Legally Blonde JR." at Stauffer Middle School with a diverse double cast of 44 middle school students from throughout DUSD.

Stauffer Principal Dr. Allison Box greeted an audience of all ages, including students, families, community members, DUSD Board of Education Vice currently in rehearsals for "Elf President Nancy Swenson, along with former Board Member and City Council Member Donald La Plante. It's quite remarkable that all DUSD middle schools have drama departments.

Director and Stauffer drama teacher Andrea Pyle welcomed the audience, encouraged them to have fun, and take pictures. We can do with more teachers like Mrs. Pyle. More about her later.







Tax-saving benefits for veterans Veterans

As we prepare to give thanks this November on Thanksgiving Day, it's also important to remember those that have served our great nation in the military and honor their courage and valor this Veterans Day.

Veterans Day is a federal holiday and is celebrated Nov. 11. Veterans Day, as most of you know, is a tribute to military veterans

November 11 was originally named Armistice Day after World War I, then Veterans' Day. It honors those who have served in the military, in wartime or peacetime, with parades and a ceremony at the Tomb of the Unknown Soldier. Poets try to measure the human effects of war. who have served in the U.S. Armed Forces. It's not to be confused with Memorial Day, which honors those who died while in service. Veterans Day honors all military veterans, including those still with us.

As a quick reminder, Veterans Day evolved from Armistice Day, which was proclaimed in 1919 by President Woodrow Wilson, celebrating the signing of the Armistice that ended World War I. That occurred on Nov. 11 at 11 a.m. and formally recognized the '11th hour, of the 11th day, of the 11th month" in 1918 that ended the war.

In 1954, the holiday was changed to Veterans Day to honor all veterans in all wars. We still celebrate this day, recognizing the tie with WWI, meaning we celebrate Veterans Day the same day every year - Nov. 11 - regardless of the day of the week it falls. If Veterans Day falls on the weekend, it can be celebrated on the Saturday or Sunday and on the following Monday.

Since it's a federal holiday, a bank holiday and a state holiday, federal and state employees get the day off from work.

Not only am I visiting with you about Veterans Day but to remind you that we have tax savings' programs available for veterans and if pending legislation passes, the exemptions could be expanded.

Here's how it works: If you are a single veteran with assets of less than \$5,000, a married veteran with assets of less than \$10,000, or an unmarried surviving spouse of an eligible veteran, you may apply for the Veterans' Exemption of \$4,000, which is applied to the assessed value of your property.

If you are a disabled veteran the exemption is even greater. If a veteran is blind in both eyes, has lost the use of two or more limbs, or is 100% disabled as a result of injury or disease incurred in military service, you may be eligible for a Disabled Veterans' Property Tax Exemption. You may be eligible for an exemption of up to \$150,000 of the assessed value of your home. The Veterans Administration must certify the veteran's disability. Unmarried surviving spouses of certain deceased veterans may also qualify.

Now to the legislation, Senate Constitutional Amendment 6 (SCA6), which would allow veterans to claim both the Homeowners' Exemption and the Veterans' Exemption or the Disabled Veterans' Exemption. As a reminder, the Homeowners' Exemption reduces your assessed value on your primary residence by \$7,000. That translates to an actual reduction of \$70 to a homeowners' tax bill. As of now, a veteran cannot claim the Veterans' Exemption or the Disable Veterans' Exemption and the Homeowners' Exemption. If SCA6 continues to move through the legislative process and becomes law that will change. I will keep you posted on any developments.

We owe a tremendous debt to our veterans and I say thank you for all that you've done, all that you do and all that you will do. Our Democracy is built on your service.

and **PTSD**

This Saturday, Nov. 11, America will observe Veterans Day to honor the men and women who served our country in war or peace, and recognize them for their sacrifices to protect our freedoms.

For many veterans who served in military conflicts, however, their service came at a high price, as many continue to experience nightmares or flashbacks caused by Post-Traumatic Stress Disorder, or PTSD. Those veterans often have flashbacks, and many relive traumatic events experienced on the battlefield that have become seared in their memories and often negatively affect their mental health.

In one major study of 60,000 Iraq and Afghanistan veterans, 13.5% of deployed and non-deployed veterans screened positive for PTSD, while other studies show the rate to be as high as 20% to 30%. As many as 500,000 U.S. troops who served in those wars may have been diagnosed with PTSD, according to the study.

'Veterans with PTSD are affected in a variety of ways," said Dr. Ashley Zucker, a psychiatrist with Kaiser Permanente Southern California. "They often share one thing in common, however. Those with PTSD often experience significant challenges when it comes to managing daily activities such as work, going to school or having healthy relationships with your spouse, children, friends and loved ones. That can often lead to social withdrawal, anxiety, shame, sleep disorders, or even suicide."

Dr. Zucker noted the simplest triggers can make someone with PTSD feel like their nervous system becomes hijacked by a panic reaction, and that can cause you to fight (get angry), flight (avoid) or freeze (feel numb).

She noted certain factors increase the chances of someone developing PTSD, including having directly experienced or repeatedly witnessed the aftermath of a very intense or longlasting traumatic event, which is common among many veterans.

According to Dr. Zucker, doing the following may improve a person's path to recovery from PTSD:

In times of anxiety, reassure and comfort yourself.

Always attend scheduled counseling sessions and doctor's appointments.

Avoid alcohol, caffeine, nicotine and illegal drug use, as they can raise your anxiety level and cause problems with sleeping.

Make sure you get sufficient rest.

Exercise.

Use proven relaxation techniques.

Get involved in your community.

Because there are times when PTSD can cause severe anxiety and other mental health challenges, Dr. Zucker emphasized the importance of knowing when to seek help.

commissioned as an infantry officer and was assigned to the 3rd Brigade, 1st Infantry Division at Fort Hood. In 2008, Sam was deployed to Kandahar, Afghanistan.

Only four months into his deployment, Sam was on a mission when he received word that another nearby platoon had been ambushed.

So, he led his team into battle to provide support for his fellow soldiers.

Upon entering the engagement area, a roadside bomb detonated under the fuel tank of his vehicle, leaving him drenched in diesel and covered in flames.

He told me that as he laid there screaming in pain and calling for God and his mother, he finally gave up. He said he thought to himself, how long it would take to burn to death?

By the grace of God, Sam's gunner was able to extinguish the flames before they took his life. He said all he remembered hearing was the gunner saying to him, "Sir, I've got you now."

He woke up months later at Fort Sam Houston in one of the best Army burn hospitals in the world. His road to recovery was painful, both physically and mentally.


Following the injuries he sustained, Sam was medically retired from the US Army as a captain

One year later, Sam was accepted to the United States Military Academy at West Point.

After graduating from West Point, he was

In the three years following the explosion in Afghanistan, Sam underwent intense physical rehabilitation and over a hundred surgeries to give him a new face. During this process of recovery, Sam recognized that God had given him a new life. A life that was intended to be dedicated to the service of God and country.

During the three years he spent in recovery, he wondered who would want him in this condition. He was a young, single man with a lot of disfigurement over most of his body.

But as he told me, God had other plans. Since he couldn't feed himself for six months, an Army dietitian in the burn unit, 1st Lieutenant Amy Larsen, fed him almost daily. And she could see further than his skin.

Sam fell in love, but just as importantly, she did too. They ended up getting married and today have been married 14 years and have three beautiful kids. He went back to school and got a Masters from SMU and today is running his own successful company providing medicines for veterans in hard to reach areas of our country.

I smile every time I think of him and his family. I give thanks for his passion and love for our country. I am inspired by veterans like him and so many others.

Our nation's veterans throughout our history have kept us free, returned home and continued to serve our nation in a multitude of ways. Today, we say thank you to them all.




